INDICTMENTS OF YOUTHS RETURNED

Charge He Was In On Liquor Deal Denied By Mellon

Mellon Denies Charges Made Gaston Means

Treasury Secretary In Letter Senate Daugherty Committee Enters Formal Denial That He Was Connected With Whiskey Transportations

Washington, June 6.—Secretary Mellon today entered formal denial to charges leveled against his conduct of the Treasury Department by Gaston B. Means in recent testimony before the Senate Daugherty investigating committee. The denial applied in part to the conversation which Means said took place between himself and former under Secretary of Treasury Gilbert but as soon as the Secretary's letter was entered into the record Thomas W. Miller, Alien Property Custodian, was placed upon the stand testified that he himself had been present when such conversation was held.

Colonel Miller said he had brought Means and Gilbert together in his office. It can't say exactly what was discussed, he said, but it concerned Rex Sheldon. Means was then an agent of the Department of Justice. In his letter to the committee the secretary denied in detail Means' story about the investigation of the report that Mellon had agreed to issue whiskey withdrawal permits to Rex Sheldon, of New York, in return for money to help make up the deficit of the Republican National Committee.

G. O. P. Convention To Open June 10

Cleveland, June 6.—More special trains will arrive in Cleveland for the opening of the Republican national convention June 10 than have come to the city in many years, said Colonel Carmi A. Thompson, chairman of the local committee on arrangements.

Already arrangements have been completed for six special trains and several more are expected. The New York delegation will arrive here Sunday, June 8. The Massachusetts delegation augmented by 300 of the President's closest personal friends, will arrive on the same day. The Connecticut and California delegates also will arrive on Sunday, the latter in a special.

C. H. March, chairman of the Minnesota delegation, has arranged for a special train for his delegates. Newspaper specials will leave Washington on the nights of Friday, June 6 and Saturday June 7, according to James D. Preston, superintendent of the Senate Press Gallery. Pennsylvania and New Jersey delegates also will come in special trains, according to Senator George W. Pepper and Hamilton F. Kean, respectively Republican national committeemen of Pennsylvania and New Jersey.

FARM BLOC MEMBERS SUPPORT BURSUM BILL

Washington, June 6.—In a final attempt to secure farm relief legislation at this session of Congress the farm bloc in both Senate and House have pledged to support the Bursum bill authorizing the Secretary of Agriculture to pay an export bounty of 35 cents per bushel on wheat and wheat products.

JAPANESE CABINET EXPECTED TO RESIGN

Tokio, June 6.—The cabinet today agreed to meet in extraordinary session on June 9. This action is understood to mean that Prime Minister Kiyoura means to tender the resignation of his cabinet on that date.

CONVENTION SEEKS PROHIBIT BRANCH BANKING IN STATE

Resolution Requesting Enactment of New Banking Law Presented to North Carolina Bankers Association

Asheville, June 6.—Sidetracked at the Pinchurst convention last year, the fight on branch banking in North Carolina broke on the convention floor at the final session of the North Carolina Bankers Association convention here today.

The fight was precipitated by the introduction of a resolution by M. G. Mann, chairman of the resolutions committee, for a vote of the convention to request the state legislature to enact a law prohibiting the establishing of branch banks in North Carolina.

Under the resolution such branch banks already in existence would not be interfered with.

Speaking against the resolution, G. P. Hood, Elizabeth City, declared that a member of the Corporation Commission had told him that no branch bank had ever failed in North Carolina and that he (the corporation commissioner) knew of 20 banks that would have failed in the state in the past three years but for the support of the branch banks. Joseph B. Ramsey, Rocky Mount, declared that this was the biggest issue before the bankers of the United States today. He said that the American Bankers' Association has twice gone on record as opposing branch banking in any form.

Woman Arrested On Charge of Selling Narcotics in State

Fayetteville, June 6.—Following a telephone call from Federal Narcotic Agent J. W. McDonald in Raleigh to the police of this city, a woman given her name as Mrs. Evelyn Barlow was taken from a Raleigh bus on the edge of town and arrested on a charge of selling narcotics. Carried to the police station she was found to have in her possession 40 grains of morphine concealed in powder boxes.

It is alleged by the Raleigh officers that the woman has been buying narcotics from Dr. T. F. Jones of that city, who was arrested last October on a charge of violation of the Federal narcotic law and released on a bond of \$1,000. The police it is said, allege that Dr. Jones has been selling narcotics and shipping it to other peddlers such as Mrs. Barlow. One of the police it is said saw the woman buy narcotics

Berlin, June 6.—The Reichstag today approved by a vote of 247 to 183 the position taken by the government of Chancellor Marx in favor of the Dawes report.

70 Witnesses Take Stand; Leopold's Confession Made Public; State Will Urge Early Trial

Chicago, June 6.—Two indictments charging Nathan Leopold, Jr., and Richard Loeb, post graduate students and sons of millionaires, with kidnapping for ransom and the murder of Robert Franks, schoolboy, to which they confessed, were returned by the county grand jury today. Both youths were ordered held without bail by Chief Justice Caverly, of criminal court.

PROHIBITIONISTS SEEK CHANGES IN STATE BALLOT LAWS

Platform Prohibition Party Submitted to National Convention at Today's Session

Columbus, Ohio, June 6.—Modification of the restrictive ballot laws in various states and reaffirmation of the party's support of the Eighteenth Amendment and Volstead Law are the principle planks in the platform prepared by the resolutions committee for presentation today to the Prohibition National Convention in session here. The committee worked until an early hour this morning putting the finishing touches on the various planks.

Kidnapping for ransom and murder are each a capital offense in Illinois the minimum penalty being five years imprisonment for kidnapping for ransom and 14 years for murder. The youths were indicted jointly. The murder indictment contained 11 counts and the kidnapping for ransom charge 16 counts. 70 witnesses gave testimony before the grand jury.

With the state prepared for an early trial the prosecution may ask for the trial to be set for July 15. The next step in the prosecution will be the arraignment of the two youths which will probably be next Monday. The confession which was presented to the grand jury yesterday was made public last night by Robert E. Crowe, State's Attorney.

"We planned as long ago as last November, I guess," the confession said. "The process of getting the money was the most difficult problem. We had several different plans and all were good for one reason or another. Finally we hit on the one to throw the money from a moving train after we had the given point marked.

"The next problem was the system of notification. We had a plan of a number of relays. The thing was to tell the man that his son was kidnapped and was being held for ransom.

Mrs. Johnson Smith Donates \$100,000 to Smith University

Charlotte, June 6.—The Johnson C. Smith University of this city has been presented with a gift of \$100,000 by Mrs. Johnson C. Smith of Pittsburgh it has been announced by Dr. H. L. Gregory, president of the institution. Mrs. Smith is one of the outstanding contributors to the institution, it was said, having already donated \$200,000 to the school. The latest \$100,000 will be used for the erection of a \$70,000 dormitory and two cottages costing \$7,000, it was explained.

Gubernatorial Candidates Confident

Raleigh, June 6.—Each claiming that victory will be theirs at the close of the voting hours Saturday, campaign managers for J. W. Bailey, Raleigh, and Angus W. McLean, Lumberton, gubernatorial candidates for Democratic nomination in the primary tomorrow have issued their final statements of the situation.

C. L. Shuping, campaign manager of Bailey, declared that his candidate would win because, he said, everywhere throughout the state the tide has been turning to him "as a man whose record is in keeping with his profession" and "whose pledges hold out to the people of the state hope for the future. Mr. Bailey is fighting the battle of the people, Shuping said, and the people will not let him fail.

Mr. Bailey's manager claimed that McLean supporters had reduced his estimated majority by 80 per cent in the last 30 days. Instead of hired workers, he said, volunteers have flocked to the aid of Bailey's campaign.

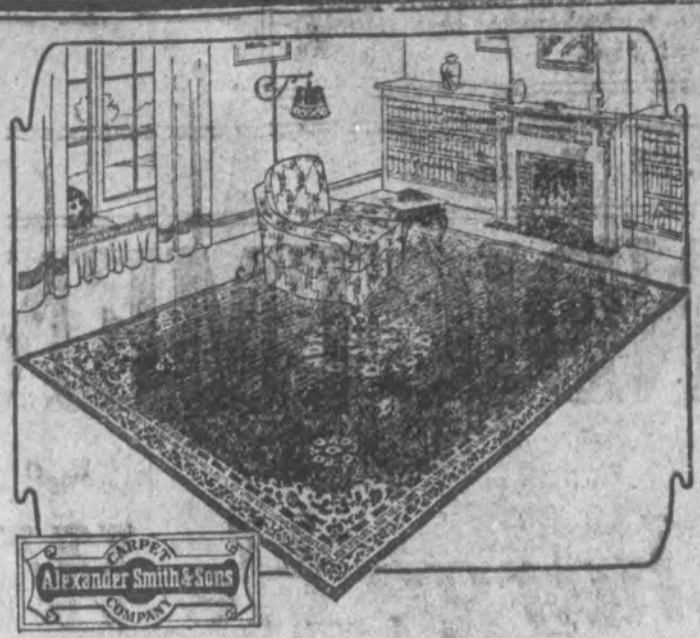

Aydlett's Reply To Warren

TO THE VOTERS OF THE FIRST CONGRESSIONAL DISTRICT:—

The statement of Mr. Warren that the letter of W. T. Ward, who is a brother of our Congressman, Hon. H. S. Ward, was inserted in the papers by me, is untrue. I knew nothing of the preparation of any such letter, or nothing of its publication until my attention was called to it last Saturday evening at Greenville, when I saw it in the Greenville Reflector. I had never heard of anything being done towards the preparation of any paper by Mr. Ward, or anyone else. The statement made by Mr. Warren that I was causing Mr. Ward's letter to be circulated throughout this district is absolutely false.

I have never appeared before the committee in the Legislature regarding any legislation, or in behalf of any client, or clients, except some local matters in Currituck and some in Elizabeth City.

The Independent, week after week, since the beginning of the campaign, has been attacking me and my character as a lawyer and as a man, and the "Friends of Mr. Warren," with his connivance, if not consent and approval, have been circulating extra marked copies of these issues throughout the district.

It seems that the Independent, in its eagerness to attack me, went out of its way to attack Mr. W. T. Ward, and Mr. Ward struck back, and Mr. Warren is now complaining that I am the cause of it. From what I have heard of Mr. Ward, he is as honorable a gentleman as Mr. Warren or myself, and when the Independent, in its zeal to injure me, went out of its way to attack Mr. Ward, he saw proper to retaliate. Mr. Warren probably has heard that "Chickens come home to roost," and when his friend, the Independent, goes too far in the attack upon others, he ought not to complain because they struck back. If I had desired to make any statement against Mr. Warren's record, I would have signed my own name to it. I am not conducting my campaign in the dark. Mr. Ward is able to take care of his own matters. Mr. Ward did not confer with me, nor did he give me any intimation, that he was going to reply, or that he was going to make any answer whatsoever to the attack upon him in the Independent, Mr. Warren's special advocate.

I say this, as I have said before, that I have made no attack upon Mr. Warren, have counselled my friends not to; have not even examined his records,—and don't want to know it, because my purpose is to win this nomination on my own merits, and without seeking to injure my opponent. Mr. Warren's attack upon me is unjust and untrue.

I am sorry Mr. Warren feels anyone is stabbing him in the back. If he is suffering in this way, I can sympathize with him, as I have been receiving stabs in the back at the hands of his friends and supporters, with his knowledge and seeming approval, since the beginning of this campaign.

Evans Replies to Moonshiner Mills.

TO THE MEN AND WOMEN OF PITT COUNTY:

LESS ZEAL FOR SPEED

Perhaps you haven't thought of it, but will readily recognize the fact that railroads no longer are seeking to break speed records. It was in 1903 that the record of 112.5 miles an hour speed was established and it has never been equaled. It has never been approached even and now no effort is being made to that end.

No longer do the fastest trains between New York and Chicago traverse the distance in 18 hours; they take 20 for the job, because it has been found that the longer time is fast enough and is far safer. The average speed of trains has been increased, but it has been found to be in the interest of successful operation of railroads to preserve near and even rate for all rather than have some excessively fast trains, because guarding the safety of such makes other trains slower than they otherwise need be.

Locomotives are larger and stronger than when records were made and probably could go as fast as anything in the past, but in the interest of safety they are not let out. The design now is to know not how fast they can go, but how fast will safety permit them to go. The taking of chances on speed are left to other forms of locomotion. Thus 100 years of experience in railroading has taught that it does not pay to go too fast, that there is a mean speed which makes for economy of operation as well as safety.

However, the railway locomotive has ceased to be a synonym for speed. The airplane has recaptured the distinction. The record of 102 miles an hour for a plane is so far ahead of anything possible on the earth that there are no contestants with the aircraft for the honor of being the speediest vehicle built by men. It may be possible to exceed that record in air travel, though it would seem to be rapid enough to meet the demands of the most ardent speed fiend. Yet it may prove true that there is a limit in air travel beyond which it is not safe to go and that a mean speed is fast enough.

Moderation in any form of travel is wisest, and it is to be hoped that the examples of the railroads in being satisfied not to attack records already established will be imitated by others, whatever the manner of their vehicle, whose present ambition is to punch holes in the air at a faster rate than has hitherto been done.

HARD TIMES

Across the editorial desk from some unremembered source came a little bit of French allegory.

A portrait painter sat in his favorite cafe sipping his wine. His first small bottle finished, he was about to order more when his eye fell on a headline in the Fiaro, "Hard Times Are Coming," so instead of ordering his usual second bottle he called for his check.

"Is there anything wrong with the wine?" the landlord asked.

"The wine is good, but I did not order a second bottle because hard times are coming and we must economize," explained the artist.

"Hard times," said the landlord. Then my wife must not order the silk dress we planned, but must take one of cotton."

"Hard times," repeated the dressmaker when the order was cancelled. "That is no time to expand. I must not make the improvements I had planned in the place."

"Hard times, eh?" said the builder when the dressmaker cancelled the building plans. "Then I cannot have my wife's portrait painted."

So he wrote to the artist and cancelled his order.

After receiving the latter the artist went again to his favorite cafe and ordered a small bottle of wine to soothe him. On a nearby chair was the paper in which he had read of hard times two days before. He picked it up to read more closely and found it was two years old!

WARD REPLIES TO WARREN

Dear Sir:

I have noticed in the press your letter denouncing me as a liar and your amazingly feeble defense of your activities before the North Carolina legislature. I, being long familiar with the habits of politicians, must confess that neither have affected my previously expressed opinions and I feel constrained to point out if I lied, you likewise lied and that your so-called denial is nothing more than an admission of being a paid representative of rich men and corporations of the state, which, in the common speech, is lobbying.

Your statement that Mr. Aydtett possessed any knowledge, or had any thing whatsoever to do with my letter to the Elizabeth City Independent was an error.

Your attempted denial of lobbying for the Southern Power Co. is indeed laughable. Mr. Warren, do you think that the people of this district will believe that Mr. Duke and the Southern Power Company, who have in their employ the ablest lawyers of the United States, would come to little Washington to retain you unless it were a question of buying political influence rather than legal ability? Your denial is nothing more than an admission in substance of being the paid representative of a rich man's corporation, which is the reason, as I stated in my letter to Mr. Saunders, that I support Mr. Aydtett rather than you.

Do you think that the people believe that you were paid a large amount by the banks to go to Raleigh to correct a typographical error in a bill? This would have been done by the Department in charge of this bill without any cost to the banks of the state. It seems to me that you presume too much upon the ignorance of the people in thinking that they would believe that a typographical error, which is merely an error of the printer, would require the special services of a lawyer to correct it.

Again your explanation of your opposition to the State Water Transportation Bill is weak, inconsistent and misleading. The News and Observer of May 24, 1924, printing the report of the State Ship and Water Transportation Commission and reviewing the history of the bill, states that you, leading the opposition, had made doubtful the passage of the bill in any form. I am glad, even though you have had to pursue an inconsistent course, that you now admit the Water Transportation Bill to be a splendid thing for the development of eastern North Carolina and

not the vicious bill that you once represented it to be.

I am forced to remind you that this controversy was forced upon me by your friends through the Elizabeth City Independent and that my defense can in no way be considered as an eleventh hour attack

Cotton Letter.
New Orleans, June 6.—Prospects for showery weather in nearly all sections of the cotton region was the sustaining feature of the market today.

Sentiment in the north and in Liverpool appears to be rather bearish probably due to the stagnation in the spinning industry in New England, the political crisis in France, this year's large acreage, the use of more fertilizer and because of the hope entertained that a good crop will be made this year with fairly good weather in the future.

Crop observers who have covered the southern half of Texas report little or no improvement in crop prospects that important section claiming fields grassy, stands irregular, labor insufficient.

Notwithstanding more unfavorable wet weather being indicated for nearly all districts of the cotton belt, the disposition of traders to sell on bulges in the absence of any outside support of consequence.

Compared with last season exports from the U. S. this week were 57,000 bales against 40,000 since August first 5,250,000 against 4,293,000, while spinners takings for week were 158,000 against 154,000 thus far this season 10,290,000 against 11,354,000.

World's Visible supply today.
American 1,363,000 against 1,234,000. Other kinds 1,526,000 against 1,446,000. All kinds 2,889,000 against 2,680,000. Practically every bale of last year's crop including linters has come into sight as the movement to market to date is 10,820,000 bales against 10,677,000 last year, leaving only about 184,000 bales which was carried over at unaccounted towns and plantations at the close of last July to come in.

However, the trade has 1,368,000 bales in the world's visible of American against 1,234,000 last year to draw against, pending the arrival of new crop cotton in quantity which may serve to tide the trade over until new crop arrives in quantity.

Therefore, the future of the market will likely depend mainly on future weather conditions and prospects for the next crop.

came our way. It just happened to be Robert Franks. Richard was acquainted with him and he called him over and introduced him to me and then he asked Robert to go for a ride.

Trapped Boy.
The Franks boy demurred, Leo-

old's confession said, and Loeb told him to show him a tennis racquet, upon which Robert got in the car. "I got in the car then," the confession continued, "and stepped on the gas and we proceeded. As we turned around the corner Richard put one hand over his mouth and beat him on the head. He did not succumb as readily as we expected and Richard pulled him to the back seat and forced a club or gag into his mouth. I guess he was instantly suffocated."

"The boy was covered with an automobile robe which we brought along for the purpose. We drove up and down on the road and then proceeded on the path toward Hegewisch. We had previously removed the shoes, stockings and trusers. We left the shoes at the side of the road in the grass. When we reached our destination we put the body down on the grass and removed the rest of the clothes and poured acid on the face of the boy to make identification more difficult. We put the body in the drain pipe and pushed it in as far as we could. We gathered up the clothes and placed them in the robe and apparently at this point the glasses fell from my pocket. "We carried the robe with the clothes to the automobile, which was about 300 yards [distant and the sock must have dropped from the bundle."

After describing the route they took back to the city, he said:

Called Frank's Home.
"I called Frank's house. I told Mrs. Franks that I was George Johnson and that her son had been kidnapped and was safe and that instructions would follow. In passing Fifty-Fifth street we mailed a special delivery letter which had complete instructions except the address. After that I returned to take my Uncle Nat home. I returned to my home then and after my father returned, Richard and I proceeded to his home, where we burned the remaining clothes."

"We wrapped up the robe and washed the blood spots from the car and parked it near my home. The next day we went to the Illinois Central and Richard bought a ticket for Michigan City, and deposited the letter in the telegraph blank box. In the meantime I called Mr. Franks and told him to proceed immediately to a drug store and to wait at a telephone booth for a definite call. I told him that a cab would come to

the door to take him. I repeated the number twice and he asked if he could not be given more time to reply and I said "No," it must be done immediately. By the time I got through telephoning Richard returned and started south. We chanced to see a paper on a stand and we deliberated for a few moments to plant what to do, and Richard said the game is up, but I insisted that it would do no harm to call the drug store and see if Franks was there. I did and was told he was not there."

He then told of another call made late and continued:

Gave It Up.
"We got the same reply and gave it up as a bad job and returned to the car which we had rented."

He said the original plan to place instructions in a waste box on the street corner was discarded when they found it difficult to make the letter stick to the side of the box.

"Thursday after dinner," the confession continued, "we went to the garage to wash the blood stains and our chauffeur, Sven Englund, came out and asked to help and Richard told him the spots were merely red wine that had been spilt."

Under questioning, the confession then recited that the youths had gone out on the day of the kidnapping with the deliberate intention of kidnapping some one, and had tried a car to divert suspicion, having previously established credit by having one of the boys register at a hotel as "Mr. Ballard" while the other boy gave "Mr. Ballard" as reference, his companion giving the boy a high financial rating. The con-

fession also related that the youths had opened bank accounts at various banks under assumed names in order to divert suspicion in case they were forced to flee and needed to travel under fictitious names.

How They Chose.

On the afternoon of the kidnapping, the confession continued, the boys watched some children playing in a field through field glasses for some time to try to determine who should be their victim. They contemplated taking a youth name Levinson, son of a wealthy attorney, the confession said, adding that the Franks boy happened along first and they decided to abduct him instead. After going home the night of the slaying, the confession related that the boys enjoyed several games of cards before going to bed. The next day they threw the chisel with which they beat Franks over the head into the street as they drove about in the death car and also went to a lonely prairie, where they tried to burn the automobile robe used to cover their victim, the confession said.

The ransom letter, the confession related, had been prepared several days in advance and was complete except for the name of the person to whom it was to be sent, which could not be written on the envelope until the victim was selected.

The confession also declared it had been the intention of the boys from the first to kill their victim because they feared he would expose them and that they intended to hide the money for a year and then spend it carefully.
