Explosion Aboard Battleship Causes Heavy Loss Life

Three Officers and 45 Men Killed by Explosion in Gun Turret of Mississippi; Naval Board Begins Investigation

San Pedro, Cal., June 13.—The U. S. Mississippi, self wounded giant of the Pacific fleet in front of whose forward gun turret 48 men died from an explosion yesterday, lies anchored outside the harbor break-water today.

Trained by their calling to face death unexpectedly and suddenly the officers and men were today removing traces of the terrific blasts of TNT that swept their comrades into eternity.

There is still another unexploded charge reported to be lodged in one of the 14 inch rifles but naval officers ashore today say that virtually all danger of a repetition of yesterday's tragedy has passed.

Naval traditions of the kind that cluster about the names of Decatur, John Paul Jones and other American sea fighters of the past, courage, devotion to duty and modesty, flared brilliantly in the midst of yesterday's smoke and carnage.

San Pedro, Cal., June 13.—The lives of three officers and 45 enlisted men have been snuffed out aboard the dreadnaught Mississippi in the greatest peace time disaster which yesterday brought to a tragic climax a week of sham battles and target practice.

Aboard the hospital ship, Relief, today lay the dead killed by a premature explosion in the Mississippi's turret Number 2, and the injured. Aboard the U. S. New Mexico, flagship of division four of the battle fleet, members of the Naval board of inquiry prepared to open their investigation of the disaster.

Aboard the Mississippi, anchored outside the breakwater, officers and men watched the flame shattered turret where a 14 inch gun with an unexploded charge jammed in its breech meant that danger of still another explosion had not passed.

Of the injured there were strangely few. With the death list nearly reaching the half hundred mark, only eight men were among the hurt and the injuries were comparatively slight consisting of minor burns and lacerations.

Just how the fatal explosion occurred was still undetermined early today though from witnesses aboard the Mississippi and another vessel, nearby when the explosion broke up target practice, a fairly comprehensive picture of the accident was obtained.

The dead list included: Ensign M. Erwin, Jr., Asheville, N. C.; James D. Holliday, seaman first class, Mena, Ark.; Vernon Brumfield, coxswain, Norfield, Miss.; Doyle N. Shaw, seaman first class, Clayton, Texas; Carl C. Caldwell, seaman first class, Dover, Ark.; and George Eugene Magill, seaman first class, Waco, Texas.

Inhalation of flame, gas and poisonous fumes rather than the violence of the explosion caused the death of the men, witnesses pointed out. The explosion itself did little damage. The flames that followed the explosion created the inferno in which 48 perished. Many officers and men aboard the ship did not know of the disaster until several minutes after it had occurred. The blast came at a time that other guns were roaring at the target and was unnoticed.

The three officers who were killed were stationed in a booth immediately behind the breeches of three rifles and their chance of escape was even smaller than that of the men.

Cleveland, O., June 13.—William V. Hodges, of Denver, Colo., was today elected Treasurer of the Republican National Committee.

President Coolidge's selection of William M. Butler, of Massachusetts, for national chairman was ratified and selections of other officers was as forecasted.

Ralph Williams, Oregon, was re-elected vice-chairman. Two new vice-chairmen were added, Charles D. Hillis, New York, and Mrs. A. T. Hurt, of Louisville, Ky.

Roy O. West, of Chicago, was elected secretary. Mr. Butler after being elected as chairman unanimously proposed the remainder of the slate which was also unanimously accepted.

Robert H. Toddy, representative on the national committee from Porto Rico and oldest member of the committee from the point of service retained his seat today in a contest brought by Juan Soto.

Russians Preserve Aurochs.

Moscow, June 13.—About 200,000 acres in western Caucasus, where the auroch or European bison still survives, have been declared a national preserve. The purpose is to afford these animals adequate protection.

DOUMERGUE ELECTED PRESIDENT OF FRANCE

Versailles, France, June 13.—Gaston Doumergue was today elected president of France by the National Assembly here. M. Doumergue received 515 votes, Paul Painleve, president of the Chamber of Deputies, 309 votes with 29 votes for various other candidates and eight blank ballots. The figures were officially announced in open session of the assembly.

FAFOLLETTE SAYS COOLIDGE TO BLAME FARMERS' PLIGHT

Wisconsin Senator Declares Argument Against Special Session Congress Unfounded

Madison, Wisconsin, June 13.—present national administration has literally turned its back upon the farmer, Robert M. LaFollette, Senator from Wisconsin, declared in a statement made public today. He further declared that the responsibility for the failure of the Sixty-Eighth Congress to meet the righteous demands of the farmers for necessary and effective legislation will rest upon President Coolidge.

The statement in part reads: The Sixty-Eighth Congress has adjourned after voting down a resolution providing for the House and Senate to reassemble after the national convention in order to give immediate consideration to measures providing relief to agriculture.

Those interests demanding ship subsidy, tax reduction, profiteers, railroad guarantees fat oil and land grabs and other special privilege legislation make the argument that the farmer must pull himself out of his difficulty by his boot straps and nothing that the Federal government can do by law would prove of the slightest assistance. This in substance is precisely the argument addressed to Congress by President Coolidge in his first message.

The truth is that the farmer is suffering chiefly from artificial disadvantages that have heretofore been saddled upon his back by acts of Congress or executive branches of the government.

The Esch-Cummings law in 1920 brought gigantic freight rate increases unprecedented in history and has since made it impossible for the farmer to make it possible for the product to market and make a profit.

Rocky Mount Endorses Morrison's Plan to Call Special Legislature

Rocky Mount, June 13.—The Merchants' Association of this city at its annual barbecue supper endorsed the action of Governor Cameron Morrison in calling an extra session of the legislature and pledged their support to him in carrying out the fight to have the recommendations of the State Ship and Water Transportation Commission adopted by the state through the vote of the people at the overrider election.

The resolution favoring the calling of the extra session of the legislature to consider the report of the State Ship and Water Transportation commission and pledging the support of the local organization to the provisions of the report, was introduced by G. R. Hales. The resolution was enthusiastically received and passed the body by a unanimous vote.

Four Autos of Bandits Hold Up Fast Mail Train Between Chicago and Milwaukee; Loss of Registered Mail May Exceed Two Million Mark

Chicago, June 13.—In one of the most daring robberies in railroad history, four automobile loads of bandits last night held up the Chicago, Milwaukee and St. Paul mail and express train and escaped with registered mail valued close to \$2,000,000.

The train enroute from Chicago to St. Paul was stopped near Randolph, Ill., 32 miles north of Chicago. Consisting of eight mail coaches and two express cars the train left Chicago at 9 p. m. Central Standard time, 50 minutes later it was in the possession of bandits and 55 minutes more they had gathered up between 42 and 45 pouches of registered mail and sped away into the darkness. The only casualty was that of one of the robbers shot by a fellow robber who mistook him for a trainman.

The loss early today was estimated at \$2,000,000 but Federal Reserve Bank officials said that a careful check up might show it to exceed that figure.

The train was carrying more than 70 mail clerks and guards all of whom were armed. Only those on three of the cars were compelled to face the guns of the robbers. Those cars carried registered and first class mail. The robbers forced their way into the cars by breaking the windows and throwing bombs filled with chlorine gas forcing the clerks to open the doors which allowed the robbers to enter.

Officials were certain that the holdup was arranged by men thoroughly familiar with railroad and railway clerks work. At least robbers concealed themselves aboard the mail special before it left Chicago. The train had just gone through Randolph and traveling at a rate of about 60 miles an hour when the holdup took place.

DEMOCRATS ARRIVE FOR THE CONVENTION

Governor Al Smith Was Among First of Pre-Convention Crowd to Reach New York

New York, June 13.—Governor Smith has led the pre-convention influx of Democratic leaders for the Democratic National Convention. He arrived here last night and will remain until the close of the convention. Today he made plans for a conference with Franklin D. Roosevelt, chairman of the committee seeking to nominate him for president.

George E. Brennan, Democratic leader of Illinois will arrive Monday. It is expected that William G. McAduo will arrive next Wednesday. His campaign manager, David L. Rockwell, who has been in Cleveland as an observer at the Republican National Convention, is on his way here. Cordell Hull, national Democratic chairman, arrived yesterday and took charge of national headquarters.

T. JARVIS SUGG DIED WASHINGTON TODAY

Was Former Resident of Greenville; Funeral Services Will Be Conducted Saturday

Thomas Jarvis Sugg, 48, died at his home in Washington this morning at 7:30 o'clock after an illness of only a few minutes. Services will be conducted from his late home tomorrow afternoon at 4:30 o'clock by the Rev. H. B. Searight, interment following in the Washington cemetery. The Elks will have charge of the services at the grave.

Mr. Sugg was born in Aurora, Nov. 17, 1876, being a son of B. F. and Mary Sasser Sugg. For several years he made his home in Greenville. In early manhood he moved to Washington where he entered the real estate business. He was held in high esteem in business circles throughout the state and was popular with a host of admiring friends. About five months ago he was married to Miss Mamie Burbanks.

Mr. Sugg's death was a shock to the entire community. He arose about seven o'clock today apparently in the best of health. After walking around the room awhile he went to the side of the bed and sat down telling Mrs. Sugg that he was suffering from a pain around his heart. A physician was immediately called but upon arrival he found Mr. Sugg dead.

Republican Convention Nominates "Hell and Maria General" After Lowden Had Been Nominated and Had Declined

Cleveland, June 13.—The campaign for the election of President Coolidge, to succeed himself, and Charles G. Dawes, of Illinois, got under way today with organization of the Republican National committee.

The Republican National Convention which started with almost depressed calm waked up suddenly after three days sessions to a roaring precedent setting climax last night and ended amid scenes that soothed the hearts of the old timers.

Frank W. Lowden, Illinois, had been nominated by an overwhelming vote and had declined. Such had never happened before in the history of the party. Then after a recess the "Hell and Maria General" from Chicago was swept into nomination and that too had not been planned by the leaders.

The nomination and acclamation of Coolidge was accomplished at the morning session with noisy enthusiasm. Everybody knew what was going to happen and it did. Then came the business of the selection of the vice presidential candidate. Nobody knew what was going to happen.

In a brief and spectacular fight in which William M. Butler, President Coolidge's campaign manager had said to Senator Reed, of Pennsylvania, "It must be Hoover," and Senator Reed had replied, "It can't be done, it must be Dawes," the Dawes supporters, after the declaration of Former Governor Lowden, of Illinois, marshalled their forces and put the "general" across for the nomination.

Early in the day Mr. Butler's forces had passed the word that the administration men desired the nomination of Theodore E. Burton, of Ohio, and in the voting which followed the supporters of Frank O. Lowden, of Illinois, ran away with the nomination for their man, only to have him decline it.

The nomination of Dawes came as the climax to one of the most spectacular scenes in Republican party history in which the convention once having nominated a candidate was obliged to undo its work and find another.

Peach Shipments From State Begins

Raleigh, June 13.—In spite of spring freezes and wind storms the movement of peaches is about three weeks earlier this year than in 1923, says a statement issued from the State Division of Markets. Twenty-six cars were shipped from George in May and according to Gorrell Shumaker of the Division of Markets of State College, North Carolina will begin shipping within the next week.

Special care has been taken this year in thinning the fruit so as to increase the quality and quantity and reports large peach growing states indicate a bumper crop. Georgia growers are reported to have ordered one third more crates this year than they did last year.

Federal inspectors will be at all main shipping points to inspect and assist in maintaining a standard pack of good quality. Certificates of Federal and State inspection will be issued on all shipments.

With a shipment in 1923 of only 176 cars this state was far down the list but the present indications are that we will regain the ground lost last year with a shipment of 2,500 cars in 1924. According to estimates figures this will put North Carolina in fifth place among the main peach growing states.

SUMMER ADVERTISING

There are some business firms that make it their practice to let up somewhat on their advertising in summer. Sometimes they may argue that a good many of their townspeople are away.

But if that is the case, it is also usually true that a good many visitors are in the region at the time and carefully looking over the newspapers, and making such purchases of things as they need. When people are away on vacations, they have considerable time in which to shop, and often buy more than they do at home.

Frequently they like to carry some articles home as a kind of souvenir of their trips. The firms that keep their advertising up through the summer must draw in a lot of transient trade of people who are visiting in the locality or who pass through it as tourists.

A great many firms have goods in stock at this time that will be a source of expense if carried over to another season. Styles may change, money has to be borrowed to carry goods that do not sell readily. A great many enterprising firms find that they gain the best results by cleaning up their stock very largely as they go, and getting fresh goods on their shelves. They accomplish this result by advertising freely through the summer.

It is a tremendous help to a firm if it can give the impression that it is pushing for trade every day and week in the year. The firm that advertises constantly gives that impression. It makes the public feel that it is alert all the time to pick up good goods at a bargain, and pass its good values on to the public.

Metropolitan department stores know the game of merchandising, and it is noticeable that they keep up a great deal of advertising through the summer. If it pays for them, it will pay for the stores in Greenville.

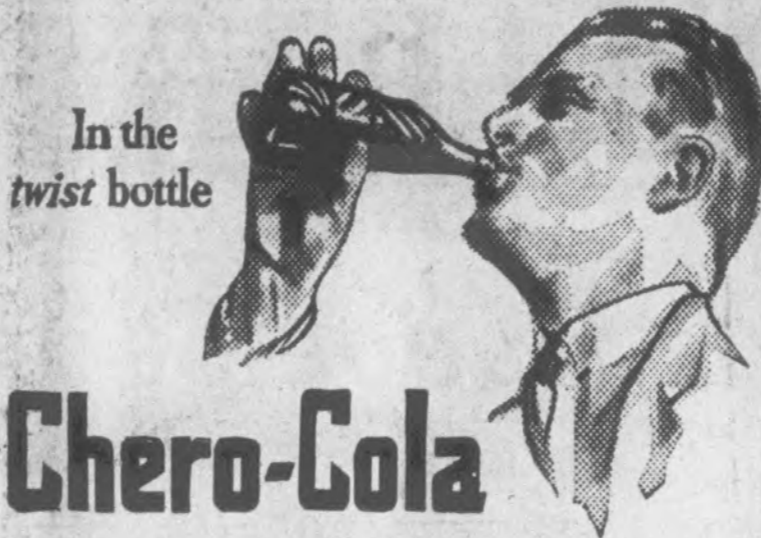
