

## WAY ALMOST CLEARED FOR BALLOTING

### Three Negroes Hold Up W. N. Peele And Rob Store

## Convention Unites Tribute To Fighting Leadership Of Past

**Newton D. Baker Places Name of James Cox for Nomination; Cox Accorded Long Demonstration; Ku Klux Klan and League Nations Delaying Platform; Balloting Expected to Begin Tonight or Saturday; Governor Bryan's Name Also Placed in Nomination**

Madison Square Garden, New York, Jan. 27.—Pausing in the midst of bitter contention of its favorites of the hour the Democratic national convention united in colorful tribute to its fighting leadership of the past while the state stood on their chair and cheered the name of James M. Cox, of Ohio, the party's standard dealer in the desperate and disastrous battle of four years ago. It was a personal tribute unorganized and unguided conveying the tradition of Democracy for aggressive fight of former Ohio Governor to stem the mighty Republican tide of 1920. Ohio led the demonstration which lasted for quarter of an hour after Cox's name had been placed in nomination for the presidency. Newton D. Baker, President Wilson's war time secretary of war who himself received a warm hearted welcome as usual repeated applause by his praise for Wilson policies and league of nations, but a moment later delegates returned to their rivalries over McAdoo and Smith with more demonstrations and counter demonstrations. As speakers from a dozen states proceeding with long string of seconding speeches. Nominating speeches also were delivered for candidates not reached on yesterday's roll call and the way cleared to be in balloting tonight or tomorrow. During the afternoon Cox's demonstration had a counterpart in one that followed the nomination of Governor Bryan, of Nebraska, brother of Great Commoner.

"A vote for Coolidge is a vote for chaos," the plank concludes. "Dishonesty, extravagance and inefficiency now exist in the government."

New York, June 27.—Edmond Moore, national committeeman, from Ohio charged that the McAdoo force were attempting to delay the report of the platform committee in order if possible to try to have their candidate nominated for the presidency before the adoption of the platform. Moore declared that if successful of nomination, McAdoo would then be in strong position to dictate the platform.

### Sanitary Survey To Be Made Towns In Pitt County

A representative of the Bureau of Sanitary Engineering and Inspection, North Carolina State Board of Health will begin making inspections here July 1st. All closets which are not connected with the sewer system and do not meet with the requirements of the plans and specifications as provided for in chapter 71, Public Laws Act 1919, will be condemned and required to be constructed and maintained according to the rules and regulations of the act.

Much work will need to be done here and the Health Department solicits the co-operation of the people in carrying out the requirements of the provisions of the statute for the protection against disease which comes from unsanitary, non-fly proof privies.

A number of typhoid cases have already been reported in the county and delay in properly sanitating the home may be fatal and the cause of more cases.

### McAdoo Declines To Deliver Another Address New York

New York, June 27.—Proposals by his adherents that he deliver a public speech some place in New York further outlining his policies and answering questions raised by his opponents, was vetoed late yesterday by William G. McAdoo.

The candidate from California for the Presidential nomination in the Democratic National convention spent most of the day in his hotel rooms receiving friends and delegations.

David L. Rockwell, of Ohio, his campaign manager, announced tonight that this had been a very decided "McAdoo day" and that quite a number of delegates heretofore counted as belonging in opposition camps had called to declare their allegiance to the candidate from California.

Although they opposed the motion for the convention to recess until tomorrow morning, McAdoo adherents tonight claimed that the first roll call vote of the convention was very pleasing to them. They claimed that while it did not show their full strength, it gave the convention some idea of the number of votes behind the McAdoo boom.

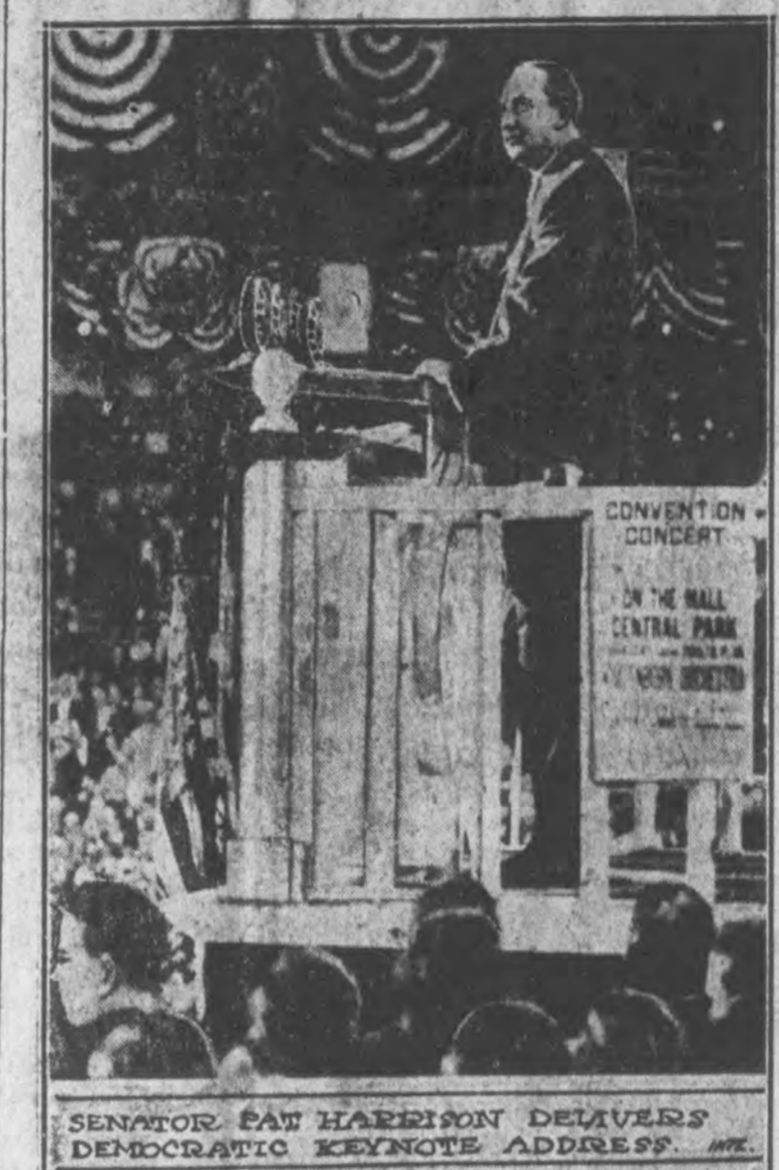
This "Special" is for all Pitt county. Every body is invited and urged to go. The round trip ticket will only be \$1.10.

### NEWTON D. BAXTER PLACES COX'S NAME IN NOMINATION

Declares James Cox, of Ohio, a Great National Figure; Comments on Fight He Made in 1920 Without "Hesitation or Wavering"

New York, June 27.—Declaring that Former Governor James M. Cox, of Ohio "became a national figure at that moment in 1920 when only a few had the vision to see or the courage to follow the new faith—the new political religion of Woodrow Wilson," Newton D. Baker, secretary of war in President Wilson's cabinet, today again placed Cox's name in nomination for the presidency before the democratic national convention.

"Without hesitation or wavering he fought the long 1920 campaign debating without debt, appealing to our higher emotions, battling back the tide of ills which, rising out of the chaos of the world, finally included us with the peoples of Europe as the children of despair," Mr. Baker told the convention.

"Since that campaign, his dedication to the cause has remained complete," Mr. Baker said. "He has devoted the intervening years to serious study in the old world and this. He has sought for those reasons, historic, traditional, permanent or temporary, which brought about our act of discouragement at the moment of our might. With pen and might with growing power of enthusiasm and of knowledge, he has as a private citizen, sought to inspire us to better and higher thinking, and juster and more enduring policies. Thus Ohio feels that her son, once her only favorite, has become the nation's favorite."

"In her name, I present to you Ohio's three-time governor, her successful executive, her constructive leader, her son who bore the banner of our principles bravely and blamelessly in a national contest, her son who has had the vision to see where America's opportunity now is and has the courage and character to lead us to that realization."

"I present you the name of James M. Cox."

### Republicans Plan Invasion of South

Washington, June 27.—Republican party will direct an attack on the Democratic Solid South in the approaching campaign, Representative Wood, of Indiana, chairman of the Republican Congressional campaign committee, said today after a conference at the White House.

The campaign in the South will be centered, he said, on Texas, Alabama, Tennessee and North Carolina.

## Cotton's Store Robbed Early This Morning

At noon today, Officers Hobgood and Pierce of Farmville, and Mr. Holland, of Bruce, brought Ernest Allen, white, and a negro to Greenville and placed them in the county jail, charged with being members of the party who robbed Mr. Cotton's store at Bruce today. Allen claims that four negroes forced him to carry them to the store, while the negro declares that Allen went to New Bern and made arrangements with them to come and rob the store.

Officers are making every effort this afternoon to capture the other negroes.

One of the boldest robberies perpetrated in this county for several years took place this morning at Mr. R. R. Cotton's store, at Bruce, when Mr. W. M. Peele, the manager, was held up by three unknown negroes and the store robbed of nearly one hundred dollars. The negroes succeeded in making their get away.

Mr. Peele opened the store early this morning and was alone at the time of the robbery. The negroes entered together and asked for a Coca Cola. Mr. Peele complied with their request and turned to attend to some duty which needed his immediate attention. When he turned around he found that he was facing three pistols with the command, "hands up." One negro searched Mr. Peele to ascertain if he was armed, while the other two searched the store. Mr. Peele was then ordered to turn over the cash, which he did. The sum amounted to nearly one hundred dollars.

After securing the money and making sure that they had it all, the negroes removed the telephone and cut the wires.

Just as soon as the negroes left Mr. Peele rushed to his office and secured a pistol. When he reached the front of the store, however, the negroes who were running had passed out of sight. Negroes working on Mr. Cotton's farm stated that the robbers were going in the direction of Farmville.

Mr. Peele came to Greenville and notified officers. An effort is being made to apprehend the negroes.

### Aged Woman Falls To Death From Room

Greensboro, June 27.—The body of Mrs. Julia A. Windham, aged 80, who was killed by a fall from a window of a second story in a house here, was carried today to Siler City, where she was born and reared, for funeral services and interment. She had been here about three months with a daughter, Mrs. S. J. Marley.

Mrs. Windham fell from the window late last night, and death was nearly instant. She had been unwell for some time and some member of the family had been with her almost constantly, but had left her a few minutes. Mrs. Windham was preparing to retire for the night and it is supposed that she went to the window to adjust the shade. Her skull was crushed, right jawbone broken and she suffered injuries to her chest.

In addition to Mrs. Marley, she leaves another daughter, Mrs. Mary Saunders, of this city; a brother, J. R. Stephens, of Richmond, Va., and a sister Mrs. Joseph Dickens, of Haywood.

Vienna, June 27.—Thirty miners were asphyxiated by explosion in colliery at Hartlogggnitz, rescue work was found impossible because of defective gas masks and some of the rescue party lost their lives.

### Beats Wife Fatally, Commits Suicide

Spartanburg, S. C., June 27.—After fatally beating his wife with a shotgun, Louis Thompson, 70 years old, prosperous farmer of near Switzer, cut his own throat with pocket knife and then hanged himself.

### Norfolk Army Base From War Dept. to Shipping Board

Washington, June 27.—President Coolidge has issued an executive order transferring Norfolk army base a sister Mrs. Joseph Dickens, of Haywood from war department to the shipping board.

New York, June 27.—The platform committee of the Democratic National Convention adjourned about 3:20 o'clock this morning after approving all of the 35 or more planks submitted to it by its drafting committee except those relating to the Ku Klux Klan and the League of Nations.

The sub-committee of eleven which submitted the preliminary draft was instructed to meet at noon today to attempt to whip into shape planks on the Klan and league and the entire committee was called for 2 p. m. to receive its report. Little change was made by the entire committee in approving the other declarations.

New York, June 27.—Republican "inefficiency and corruption" forms the subject matter of the first and principal plank in the Democratic platform as presented last night to the resolutions committee by the 11 men who have labored for more than twenty hours on national party declarations for 1924.

Asserting that never had an administration so thoroughly failed as the Republican administration, the platform arraigns the Republican party for "attempting to impede and stop the Senate" investigations.

It is asserted that these investigations showed the immoral nature of the naval leases; the unfitness of the Attorney General to hold office and corruption in the Veterans Bureau. Reference is made also to charge against Republican members of congress growing out of the Chicago grand jury inquiry into the Veterans' Bureau.

"If only three Cabinet officers are disagreed, the Democratic party asks how many more men are guilty," the platform adds; "This nation cannot afford to have in office men of this character."

# TWO AND FOUR YEAR WELFARE PARTY COURSE MAY OBTAIN AT TUFTS COLLEGE TO VISIT MEN IN SEVERAL PRISONS

Medford, Mass. June 27.—A proposal for a radical change in the educational scheme of Tufts College has been laid before the faculty members by President John A. Cousens. It would do away with the present four-year college course and institute a two-year introductory college course to be followed by courses of two years or more in the Tufts professional schools.

"The introductory college," President Cousens informed the faculty, "would serve two purposes, general training in liberal arts for all, but so designed as to constitute pre-professional training for some. As to curriculum, it should be such a one as would widen the student's knowledge of the world and of himself, and would stimulate him by precept and example to make the utmost use of his power for self-development and for service to his fellows."

A student completing the two years course would receive the degree of Associate in Arts, with all the rights and privileges of an alumnus. The departments of medicine, law, dentistry, theology, teaching, chemistry, engineering, business administration and general research could be organized into schools each with its own dean, giving courses covering at least two years and leading to the bachelor degree and to special professional degrees.

"In the professional schools," he said, "numbers would be small and strictly limited. The effort would be to set and maintain the highest possible standards of scholarship. The point of view would be the development of the individual rather than the group.

"There is present in the university system of America some danger of too great paternalism. There is far greater danger of neglecting the individual student. I would have the ratio of teachers to students not greater than one to fifteen would have each member of the staff a teacher in the art of living to his special group of students.

"I would have endowment to provide the plant and maintain it. I would have student tuition sufficient to pay adequate salaries to the staff. I would have special endowment for research. Given all these I should expect results now not attained by any other institution in America."

Philadelphia.—Bearing good cheer and doughnuts to convicts in penitentiaries from the Atlantic to the Pacific coast, a gospel car will leave here July 7 with a party of welfare workers, some of whom helped brighten dark days for the soldiers in the trenches in France. On the front of the car will be a brass plate with the inscription "In the Service of the King."

The automobile tour was planned by some of the workers following a visit to a convict camp, where they made doughnuts for the men and talked and prayed with them. The prisoners seemed so cheered by the unexpected visit that it was decided to spread the work to every prison to which admission could be gained. With 35 cents as capital, the workers set out. Their doughnut-making, with doughnut cutters made from captured German shells and the appeal of their idea soon brought aid to them, and recently they were presented with a large automobile, fully equipped, in which to make their journey. The first five gallons of gasoline also was presented. With this as a basis, the party plans to dedicate the car at special services here July 6, before leaving on their trip, with Seattle, Wash., as the ultimate destination.

Letters have been sent out in advance to the governors of the various states asking that the workers be admitted to the state prisons, while a permit has been obtained admitting them to all Federal prisons.

The personnel comprises Miss Clorissa Aiken, who made doughnuts for the soldiers in the Argonne; Barney Roth, and Lynn W. Parsons of this city; and Mr. and Mrs. Harry M. Bean, of Columbus, O. Mr. Bean, an electrical engineer, volunteered as chauffeur for the trip.

Church Plans Memorial To Missionary Bishop

St. Louis.—A national memorial to the late Daniel Sylvester Tuttle, Episcopal Bishop of Missouri for almost 40 years, and presiding bishop of the United States for more than 20 years, is to be erected in St. Louis in connection with Christ Church Cathedral, Bishop Tuttle's church for many years.

The Bishop Tuttle Memorial building will replace the old parish house which has proved inadequate for the large program of church and community work of the cathedral.

The memorial will not be limited to community and diocesan service. As the old parish house was used for various national conferences of the church, so will the new building, with its large auditorium, be offered to the National Council for convention and conferences when desired.

The memorial will be connected with the first Episcopal church established west of the Mississippi River, and in a parish which is more than 100 years old, in the heart of St. Louis. It will also contain conference rooms, a large gymnasium, swimming pool, library and a radio station for broadcasting.

Bishop Tuttle, although a man of wide learning and one upon whom many honors had been bestowed, was a man of great simplicity, beloved by all those with whom he was associated.

A fine response to a "big gifts campaign" has come from the west, especially from Montana and nearby states, where, at the age of 30, Bishop Tuttle was consecrated in 1867 the first Missionary Bishop of the Episcopal Church of Montana, and for 20 years was a strong and loved force of law and order in those rough days.

**INDIANS MUST LEARN FASHION NEW TYPE TOURIST SOUVENIRS**

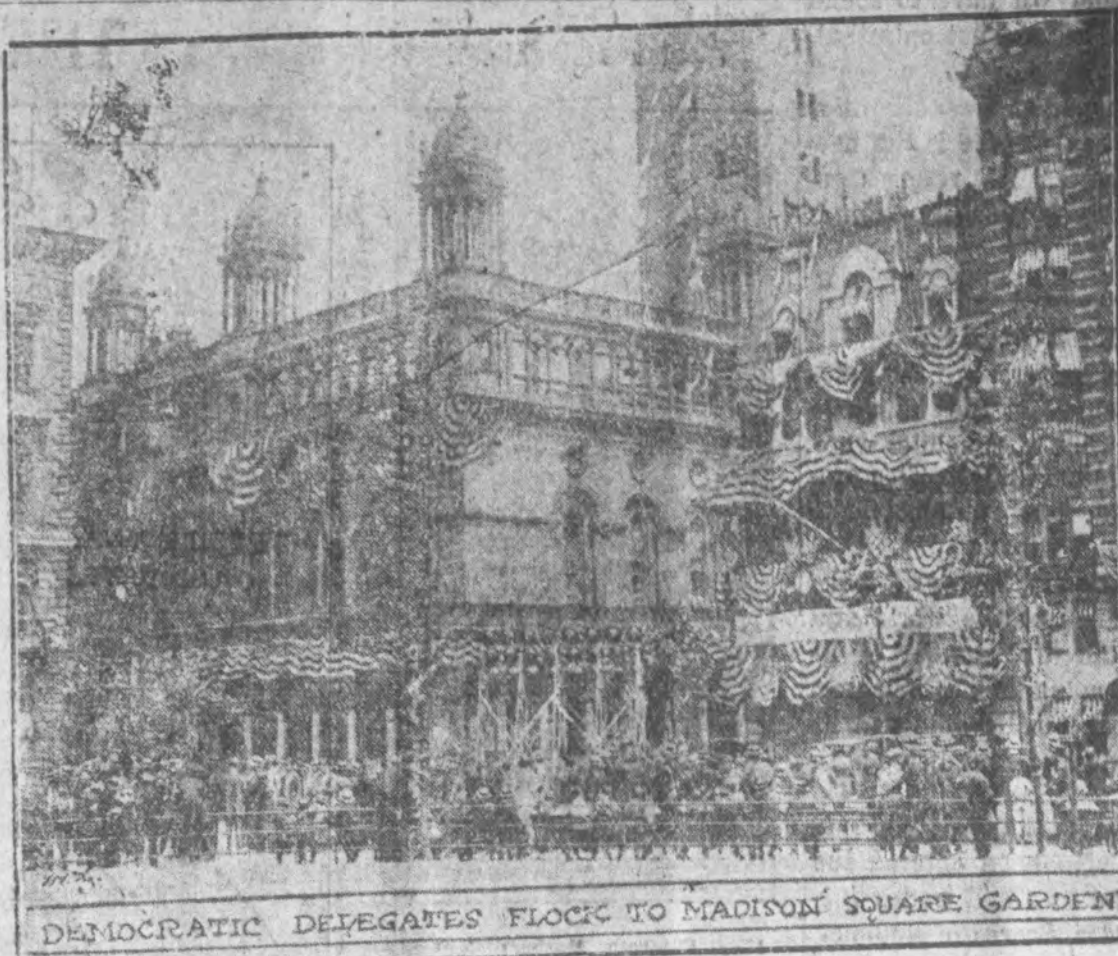
Cass Lake, Minn., June 27.—Dame Fashion who, ever since the Indians relinquished their land, has smiled upon the red men, making their characteristic creations popular with the white brethren, now is frowning upon the offerings of the dexterous tribesmen.

Dr. W. B. Heagerty, superintendent of the Ojibway Sales Agency, says that the Indian's contributions to such collections such as beaded things, beads,

sets, lace handkerchiefs and miniature birch-bark canoes, must be revolutionized to further capitalize the modern white man's passion for novelties.

The superintendent blames fashion alone for the complicated situation which the agency, promoted by the Episcopal Diocese of Duluth, now is attempting to solve by teaching its Indian proteges that, to continue in the bloodless fight against the high cost of living, they must enter to the fantastic whims bestowed by custom upon their white neighbors.

In the past, according to Dr. Heagerty, the Indian or rather his squaw, found a ready market for the waste paper baskets, work baskets, miniature canoes and other trinkets, which they made with their own hands. But now fashion decrees that it is no longer correct to have these articles in

sigh around the house so sales have fallen to virtually nothing.

Ojibway women also make exquisite point lace handkerchiefs which formerly brought fancy prices, but custom holds that they are no longer in style, so these one-time popular ornaments go begging, says the superintendent.

"Another conflicting angle," Dr. Heagerty continues, "concerns the headwork on lags, moccasins and chains done by Ojibway women. The cost of glass now is so high that the quality so inferior that head work cannot be done at a profit.

"And the worst of all the Indian deprived of his tribal costumes by the advance of civilization, cannot understand all of this. It is especially difficult for them to turn their talents to other channels."

The problem was revealed to mission workers during the first year's operation of the Ojibway Sales Agency. This agency was established to help the rapidly diminishing tribesmen to bridge the gulf between themselves and the white man's civilization by effecting "an economic and moral reformation."

The church would abolish the old trading posts, whereby the Indians received, in exchange for his offerings, merely food, tobacco and the necessities

of life, and would obtain cash for their products. This it is hoped, will enable them to learn the true value of money so that 16 years later when they according to law, are no longer government charges, they will be able to provide for themselves.

During the period of transition special attention is being directed to the large field for harvesting wild rice and making maple sugar, for which there always is a ready market.

"But this work has been hampered by cruel obstacles for last year the maple sap was scarce—in fact there was not enough for the Ojibway family—but the wild rice crop was ample and a record harvest was affected," Dr. Heagerty declares.

Hammond, engineer, Frank Minor and W. Yamana, who were charged with conspiracy to defraud the United States by causing persons who were non citizens or ineligible to American citizenship to be employed in the construction of army buildings at Schofield barracks.

The defense filed a demurrer and a motion to quash the indictment on the ground that the labor clause was unconstitutional because it denies the right of a man to labor. Judge De Bolt overruled the demurrer, and denied the motion to dismiss the indictment.

**LIGHTHOUSE KEEPER'S RABBITS UNDERMINE GOVERNMENT PROPERTY**

Seattle.—Rabbits, which have defied the United States government by "digging everything except plans" and undermining "everything except the lighthouse" on Smith Island, a small lone island in the Strait of Juan de Fuca at the entrance of Puget Sound, will soon have a hard time to exist. Poison bait is to be scattered about the island in an effort to bring the rodent pest under control.

Several varieties of rabbits were brought to Smith Island 25 years ago

by a lighthouse keeper who raised them for Seattle markets, but the island later was made a bird refuge, barring all firearms, and the rabbits multiplied to thousands.

Braces have been installed on a water tower and other government structures to keep them from toppling as a result of the burrowings.

**JAPANESE INDUSTRIES RECOVER FROM EARTHQUAKE PARALYSIS**

Tokio.—The rapid recovery of industries in the Tokio area, which suffered from the earthquake and fire of September 1, is indicated in employment figures published by the government. The best barometer of recovery is the absorption of unemployed labor.

The figures show that nearly 6,000 workers in Tokio were taken back by the factories in March, while the April figure is expected to approach 7,000.

Printing houses and candy factories have had the greatest revival, and are working now on a production scale higher than that before the earthquake and employing more labor. Last metal work industries,

which languished for months after the disaster, are approaching normal conditions again.

**MUNICIPAL HOUSING SCHEME FAILS IN THIS IRISH VILLAGE**

Dublin.—Various Irish local bodies have carried out schemes for the housing of workers. In Craignamagh ten houses have been erected at a cost to the ratepayers of about \$19,000. Applicants were sought at a rent of \$1.50 weekly, but they refused to pay more than 50 cents and threatened that they would permit no body to pay a higher rent. The council refused to let for less, and has asked permission of the government to sell the houses at public auction.

One is at loss to explain the source of the millions of workmen who have entered the automobile industry and its allied trades during the last two decades. Scores of automobile factories employ many thousands of workmen. Additional thousands are engaged in the manufacture of automobile accessories. Thousands of men and women are engaged throughout the nation in the business of selling automobiles and their accessories and supplies, while automobile repairing is attracting the best mechanics of the country. Many of the people thus employed were drawn from other occupations, but could the nation's industry, commerce and agriculture absorb this labor again if the automobile industry should cease functioning? It is from the angle of labor that the value of the automobile industry to America is most fully approximated.

The United States owes its position of world predominance to its industry and one of the predominating industries in the United States is the automobile industry.

## CONSIDER OUR ADVANTAGES

The number of telephones in use in each of the fifteen largest cities in the United States is graphic evidence of the important place that the telephone fills in American life. New York City, with over 1,186,000 telephones, Chicago, with over 690,000, Boston with over 370,000, enjoy telephone facilities far in advance of those in foreign cities of comparable size.

In fact, great nations—even whole continents—have fewer telephones than some American cities. There are more telephones in New York City, for example, than in the entire Kingdom of Great Britain,—more than in the whole continents of Asia, Africa and Australia, combined. Chicago has more telephones than France; and the telephone exchange area of Boston contains more telephones than are in operation in the entire continent of South America.

Miss Elisabeth Marbury, New York delegate to the National Democratic Convention and one of the foremost women political leaders in America, is a lady of ample proportions and a keen sense of humor. But when Miss Marbury saw the tiny, hard chairs placed in Madison Square Garden, New York City, for the delegates, she balked. Instead, she had her own spacious, leather-covered chair carried into the Garden and made herself comfortable.

## JAP EDUCATOR SEEKS FULL ACCORD WITH AMERICA

Los Angeles—Friendship between America and Japan would be enhanced by the spreading in Japan of the information that the majority of American people are not prejudiced against the Japanese, according to an opinion expressed here by Dr. Danjo Ebuna, president of the Doshisha University at Kyoto, Japan.

"If America, through her official and unofficial representatives in Japan, fails to broadcast this desirable information among the Japanese," said Dr. Ebuna, "then it is probable that my people, in view of recent events, will imagine that America is against them and will seek to unite the entire orient in a sentiment unfavorable to the occident. I regret the new difficulty that has arisen because of a possible misunderstanding between the American people and the Japanese."

Since Japan forsook the customs of the orient 70 years ago, the educator said, she has been following the ways of America as much as possible, politically, socially, economically, and even religiously in spite of the fact that Japan's attitude toward western civilization was rewarded by the suspicion and hatred of China, Korea and other oriental countries.

"When Japan turned her face toward the occident, ill feeling sprang up between Japan and China," Dr. Ebuna asserted. "China considered Japan an imitator of the west, and Japan began to look upon China as a hopelessly reactionary nation. I am happy to say, however, that this ill feeling has largely disappeared and that China and Korea are adopting the ways of Japan."

"In their social life, as well as in other respects, I find that your American civilization has tended to elevate greatly the Japanese people and your criticism, as well as your sympathy, has contributed to their improvement."

## GERMAN OBSERVER APPROVES AMERICA'S GROWING MORALITY

Berlin.—Alice Solomon, for many years identified with social work in Germany, believes that the American people have solved the problems of alcohol and dancing in a way that will make for a better generation. Writing of her recent experiences in America, Miss Solomon expresses the belief that, while in the big cities there are evasions of the prohibition laws, yet, on the whole, the country is growing "dry," and that the number of opponents of prohibition is constantly decreasing.

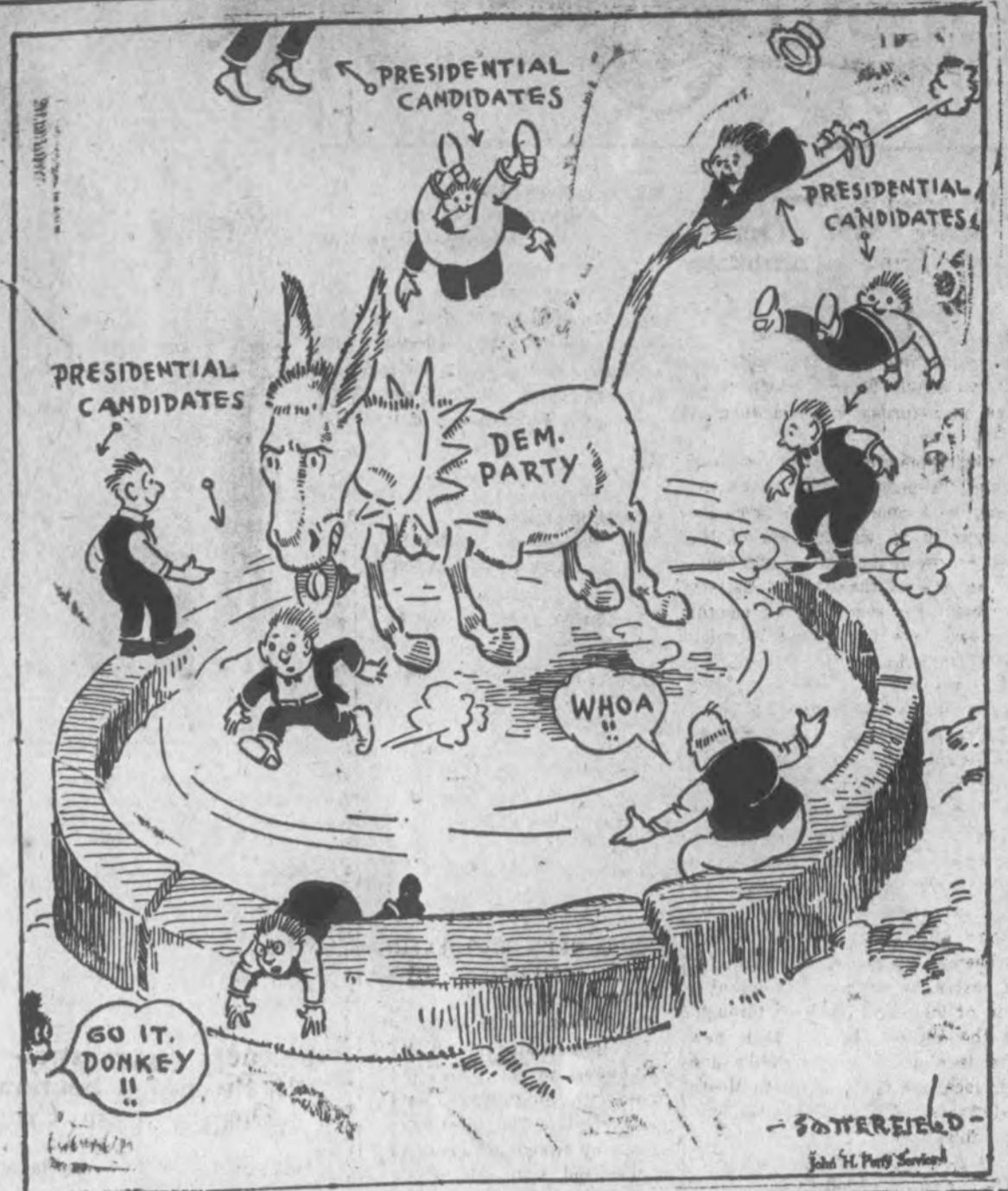

## Farmers Optimistic In Piedmont Section Despite Late Crops

Raleigh, June 27. — Optimism is prevalent among the farmers of the Piedmont section of the state, though due to their inability to get started on account of the wet fields, most of the crops average from ten to twenty days late, according to W. H. Rhodes, Jr., Assistant Statistician of the North Carolina Department of Agriculture. Several counties, he asserted, have experienced some severe storms with hail and wind, notably Iredell, where a strip several miles wide extending through the entire county practically obliterated everything in some fields, making it necessary to plant other crops.

"Several farmers stated that they had replanted their cotton," the statistician said, "and more would no doubt have done so if they could have recovered the seed." The grain and cotton suffered most from these storms, he added.

"The majority of the wheat crop is unusually good," Mr. Rhodes stated, "The stands in some fields were thin and the plants small, but in the main, the heads seemed well filled and the yield is expected to be unusually good. Most of the crop has been cut and is in the shock. Reapers are still busy, however. There is a noticeable scarcity of the old-fashioned cradle in the wheat fields

these days. Many farmers state that they have decreased their wheat acreage on account of the low price and cotton is being planted instead. There is an abundance of idle land throughout the Piedmont counties and much of it shows evidence of having been worked last year. There are few idle in the southeast Piedmont counties centering around Hoke, where fruit, truck, and cotton, farms are numerous. Winter oats were so badly frozen out that the yields this year will be much below the average and many fields will not be harvested. The spring oat crop is fair, though the average yield will probably be somewhat below normal. Rye looks good in most sections.

## PEKING DEPUTIES GET NERVOUS AS EX-RULER SIGHS FOR THRONE

Peking.—Four million dollars a year is the pension guaranteed by the Peking government to the Manchu emperor, Hsuan Tung, who abdicated in 1912 when the republic was established. He lives in retirement in the Imperial City, within the walls of Peking. He retains his imperial title and the formalities of the Manchu court, although virtually a prisoner.

A bill was introduced recently in the lower house of the Chinese parliament to abrogate the imperial title. It is supported by some 50 delegates, who allege that Hsuan Tung is planning a movement to restore the monarchy.

## Miss Kelly Returns From Western Town Survey of Schools

Raleigh, June 27. — Mrs. Elizabeth Kelly of the Department of Education of North Carolina, has just returned from a tour of the western part of the state where she has been making surveys of various counties and completing the preliminary work for the establishment of a county-wide consolidated school system. She reports a very successful trip and says that while it will be some time before the system can be placed in every county, the preliminary work now being done helps to the extent of interesting the people in the system and in presenting the question of new buildings for school purposes in the wrong locality, thereby saving a great expense for the future.

On her trip Miss Kelly surveyed in whole or in part the following counties: Madison, Swain, Cherokee and Haywood.

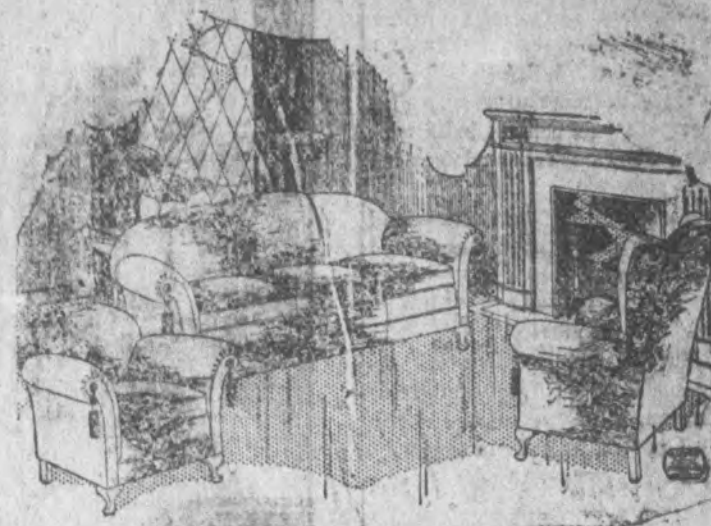
## KING OF ITALY UNDERSTANDS TEMPERAMENT OF HIS PEOPLE

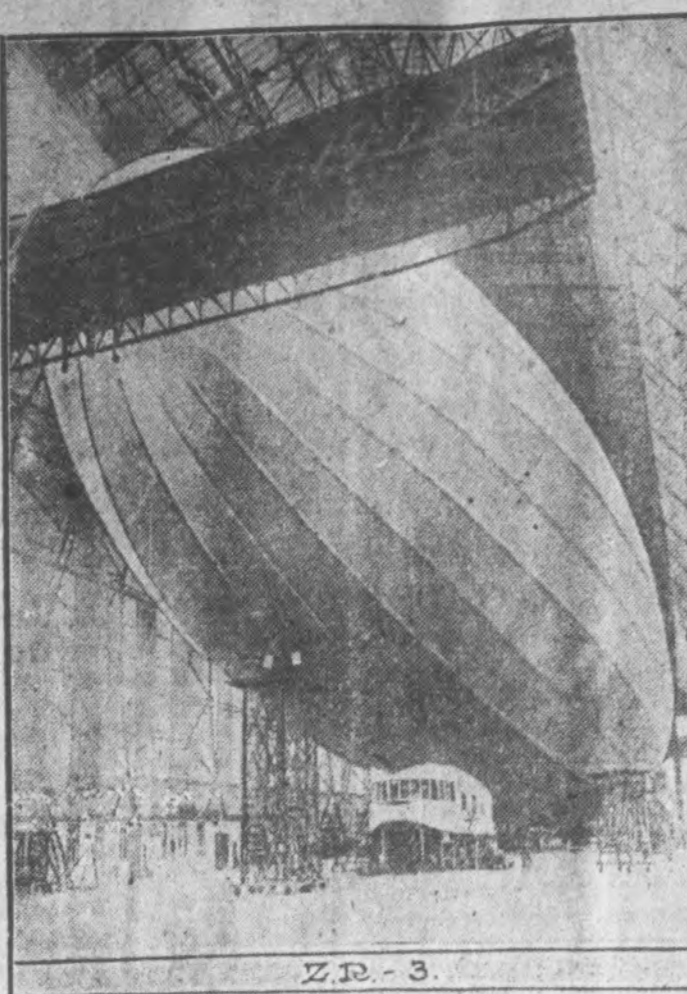

 "For three terms as her governor, this son of Ohio demonstrated his capacity as an executive, without turmoil or confusion, the business of a great state was dispatched. He was our war governor. Under his eager, patriotic leadership the people of Ohio gave their quota in men and money to the national effort, and sustained the national cause with sacrificial fervor. The constitution of the state was remodeled under his leadership, engrafting modern and liberal principles and political agencies in response to new conditions. A great body of wholesome legislation was enacted by his co-operation with legislators not always of his own political faith, until, in many of those new problems, which have come with increasing congestion and the development of an industrial society, men search the Ohio statute books for the laws which he caused to be enacted as examples of same solutions, which, in practice, have proved wholesome and helpful.

"The past is safe with Washington, Lincoln and Wilson. The challenge lies in the future—the immediate future. Our task is to search out the opportunity, state the cause and choose a leader. The leader must fit the cause.

"Nationalist aspirants have been nursed as promising a relief from internal hardship as the only safe

defense against aggressions, European cynics and reactionaries have conjured, as they have for centuries conjured with the fears and miseries of peoples and counseled that imperative armed readiness which all history touches as apt to the provocative of the very disaster which it pretends to avert.

"On the other hand, even in such a world, the first great experiment in international co-operation has been making and succeeding."

The league at Geneva has gathered to it the great liberals of the old world. It has yielded nothing to force, it has defied skepticism and dared to believe, as liberals always believe, in the power of good will. It has fought diseases and vice, lifted Austria and Hungary back into the possibility of orderly national life repatriated the war prisoners, established a world court, prevented four wars and stopped one, set on foot the only promising plan of disarmament yet devised and never moved a single soldier.

"Between these two sets of forces the conflict is on. There the battle rests now. Throughout the world the forces of militarism and imperialism are arrayed against the forces of liberalism. Within the next four years one of the other of these philosophies will prevail—which, we are probably determining here today.

"The present administration has transferred our sympathy in this contest to the wrong side. Under the inspired guidance of Woodrow Wilson, America won the faith of the world to submit understanding for misunderstanding, to foresee and prevent causes of hostility, and by engaging together in great constructive work for the common good, to build up an asset of good will, which in the hour of crisis, would enable the conscience of the world to compose threatened conflict."

## Smith Confident Jury Will Return Favorable Verdict

New York, June 27.—My case has been committed to the jury. I await the verdict, confident that it will not be an acquittal.

This statement was made last night by Governor Alfred E. Smith, of New York, candidate for the Democratic Presidential nomination and was concurred in by his campaign manager, Franklin D. Roosevelt.

"The verdict when returned by the convention," Mr. Roosevelt added, "will look toward four years in the White House in Washington.

The Government was pleased with the day's developments. Both the events in the convention hall where he was placed in nomination by Mr. Roosevelt and elsewhere about the city where Smith workers went in furtherance of his candidacy were characterized as particularly pleasing.

The Governor did not hear himself nominated, although there was a radio in the club he visited during the time Mr. Roosevelt spoke in convention hall.

He heard the deafening roars from the demonstrators in the hall, but even that was not enough to keep him attentive throughout the hour and a half that passed before order could be restored and the noise quieted.

"I had read the speech and was too busy to listen to the radio," Governor Smith said later, explaining as
