

77 BALLOTS---NO NOMINATION IN SIGHT

Convention Adjourns Until 11 O'clock Monday Morning

Effort To Move Convention Kansas City Was Snowed Under This Morning

Deadlock Still Continues When Convention Quits

Madison Square Garden, New York, July 5.—Following the 77th unsuccessful ballot to nominate a presidential candidate the Democratic National Convention this afternoon adjourned until 11 o'clock Monday morning. During the recess between now and Monday morning officials hope that some agreement will be reached whereby a nomination can soon be reached early after the convention reassembles.

Madison Square Garden, New York, July 5.—Having lifted their candidate to a new high record and failing to bring him within striking distance of nomination, McAdoo managers in the Democratic National Convention interrupted the balloting for nomination today with several futile attempts to change the parliamentary situation to the advantage of their candidate.

On each succeeding proposal the anti-McAdoo forces operated with surprising solidarity and in some cases the McAdoo forces were unable to muster more than a small part of their own voting power for the proposals submitted by their leaders.

One resolution voted down by a overwhelming majority, provided for adjournment of the convention and re-assembling of same in Kansas City on July 21. The McAdoo ranks broke right and left when the attempt was made to muster them to support the plan and the opposition was predominant that when New York was reached on the roll call they asked to be relieved the necessity of casting their 90 votes for rejection of the proposal. The request was denied under the rules.

Previously the convention had divided more evenly and with McAdoo delegates voting in the affirmative had refused to adopt a resolution under which the low candidate on each of the succeeding ballots would be dropped from the list until the field had narrowed down to the leaders.

Efforts were also started to organize a steering committee with one member from each state to smooth out the situation satisfactorily to two-thirds of the delegations. George E. Brennan, of Illinois, at first seemed well disposed to the plan but opposition immediately arose among leaders and Smith cohorts and there seemed little chance for progress. It was pointed out by the Smith leaders that McAdoo having control of a majority would exercise a dominating power over any such committee.

In the meantime the convention was voting down another proposal for the elimination of favorite sons and after a time to abolish the unit rule and the two-thirds rule.

Madison Square Garden, New York, July 5.—Smith reached a new high water mark in the balloting for a presidential nominee in the Democratic National Convention today when Ohio broke up its block of 48 votes which have been going to favorite sons and gave Smith 20.5 and

McAdoo none. Another handful of votes was taken away from McAdoo in Michigan and given to Smith.

Madison Square Garden, New York, July 5.—A resolution proposing that the Democratic National Convention adjourn and reassemble on July 21 in Kansas City, was snowed under on a roll call vote in the convention today.

The totals on the motion to adjourn to Kansas City were: All votes cast 1090; Necessary to carry 546; "Ayes", 82.7; "Nays", 1007.3.

Madison Square Garden, New York, July 5.—Still obdurate to peace proposals the Democratic National Convention struggled on with its nomination deadlock today without any material change in the standing of the leaders.

COOLIDGE'S SON SERIOUSLY ILL

Physicians Announce That Lad's Condition Is Serious But That He is Holding Own

Washington, July 5.—Anxiously awaiting some sign of improvement in the condition of Calvin Coolidge, Jr., son of the president, who is fighting against acute septic poisoning, members of the White House were reluctant to announce at noon no improvement during the night and morning and that his condition continued very serious.

Washington, July 5.—The condition of Calvin Coolidge, Jr., son of President Coolidge, who is seriously ill with septic poisoning remained serious today although reports said that he held his own during the night.

The boy, who is 16 years old, became ill Thursday and late Thursday night his condition became alarming.

Five physicians were called in for consultation and it was determined that poisoning resulting from a local blister on the right foot brought about during a tennis match had spread throughout his system.

The southern conference accepted the proposal only after three days of strenuous debate centered around two important questions. Four of the thirteen bishops were doubtful of the legality of the call for the special session and a day and a half were devoted to arguments in which numerous legal experts and authorities on church law participated. EDITOR FIGURES U. S. HAS NEARLY 25,000 POETS ABOUT 22 REAL ONES

Oakland, Cal.—Williams W. Ellsworth, a magazine editor, offered, in a recent lecture at Mills College here, these observations on poetry in this country:

"There are 25 poets to every 115,000 persons. One in 5,000,000 is a real poet.

"One person in every 6,000 in the United States publishes a book of poems. Two hundred volumes of verse appear annually, and 25 of these live.

"The quality of verse in the United States has improved greatly in the last decade."

Long Branch, N. J., July 5.—Baseballs were thrown at an effigy of Governor Smith, of New York, during a Ku Klux Klan celebration here yesterday.

"Keep Al Smith out of the White House; three shots for five cents," read the banner above the effigy which had a whiskey bottle in one hand.

Second Primary Is Being Held Today

Raleigh, July 5.—The nominees of the Democratic party for one state office, one district office, and 32 county offices will be decided in the second primary of the party for the years 1924 today. Chief among them is that of the race for Commissioner of Labor and Printing in which H. L. Shipman, incumbent, led Frank D. Grist by a vote of 11,000 but did not have a majority. Mr. Grist by the primary laws of the state had the right to demand a run-off which he did.

Two other candidates for state offices were entitled to run-offs but declined to request such and withdrew in favor of their opponents. These were Fred Latham who withdrew in favor of Commissioner W. A. Graham in the race for Agriculture Commissioner and Charles Ross who conceded to Dennis Brummitt the office of Attorney-General.

In the Third Judicial District interest is centered in the run-off of race between H. R. Parker and E. R. Tyler, who was runner-up, in the contest for solicitor.

The races in the 32 counties are for various offices.

July 4th Celebrated At Teachers College

The first part of the program was presented by the Junior-Senior College group and centered around the theme of liberty, using the Liberty Bell as the symbol. Miss Mary Baggett opened the program.

The Model School had charge of the second part of the program. The whole school marched out on the rostrum waving flags and in concert gave the pledge of allegiance to the flag, and sang "America." Then grade by grade paid tribute to the flag by giving a poem or a song, and all sang "America, the Beautiful." The entire school took part in singing "The Battle Hymn of the Republic," "The Flag is Passing By" and "The Star Spangled Banner."

Washington, July 5.—Alvey A. Adee, second assistant secretary of State and patriarch of American Diplomatic Service, died at his home here today.

Cleveland, O., July 5.—With difficulties ironed out with an agreement to thresh out the differences of opinion behind committee room doors the conference for Progressive Political Action went into session today prepared for a rapid wind up of its work culminating in the formal endorsement of Robert M. LaFollette's independent presidential candidacy. The program was furthered when advocates of the third party idea decided not to carry their fight to the convention floor.

The largest group of Farmer-Laborites contented themselves with the issuance of a statement of their position. Socialist advocates for the immediate organization of a new party decided in their caucus to turn their interests over to Morris Hillquit, their member of the organization and campaign committee.

William Mahoney, of St. Paul was definitely barred today from the conference. The report said that Mahoney's organization the Farmer-Labor Federation, of Minnesota, was entitled to representation but that his action at the St. Louis session of the conference in February and his promotion of the June 17 convention at St. Paul had made him obnoxious to this organization.

Postponement of the selection of a vice presidential nominee was agreed upon by conference leaders. The convention will be asked, it was learned, to entrust the selection of such a candidate to the committee which will confer with Senator LaFollette after the Democratic situation has worked itself out.

Cleveland, July 5.—Senator Robert M. LaFollette, of Wisconsin, formerly announced yesterday that he would be an independent candidate for president.

He disclosed this intention and opposition to immediate formation of a new party in a message to the Conference for Progressive Political Action, in session here.

Immediately after the Senator's statement had been read to the convention by his son, Robert M. LaFollette, Jr., a motion was offered by Herman Wilts, a vice-president of the Brotherhood of Locomotive Engineers, to endorse the candidacy. With delegates yelling "Let's go," opposition to this procedure developed from Socialist sources.

Morris Hillquit, New York, begged the convention not to act until it had fully organized. Amid confusion, Judge Jacob Panken, of the New York municipal court, made a point of order that until the convention was organized it could not act. This was upheld by William Johnston, chairman of the gathering, and the attempt to rush through the LaFollette endorsement was dropped.

Friends of LaFollette were convinced by the demonstrations that accompanied mention of his name throughout the day that approval of his candidacy would be given today before adjournment.

IMMIGRATION BARS UP

July first, nineteen twenty-four, marked a new milestone in American national policy. The new immigration law which went into effect on that day cuts down negroes of people of other lands to a point that would have been considered impossible a few years ago. It marked definitely this country's adoption of a plan of limited immigration—to become more limited with the passing of the years.

The immediate effect of the new immigration law is to cut immigration in half. The number of immigrants entering the United States last year was 750,000. Under the new law, it is estimated, the number will be cut down to 350,000 annually.

At the end of three years a new premium will be placed on American citizenship when total immigration is limited to 150,000 a year, divided among the various nationalities according to the percentage of those already resident here who have become American citizens.

Thus this nation is now dedicated to the principle of rigid restriction of immigration, and future changes in the immigration law are more likely to be in the direction of reducing the number of entrants than to tend to lower the bars. The day when Uncle Sam kept open house and welcomed all comers is past.

SIGNS WITHOUT END

All of the countless signs and sign boards encountered along the motor highways detract from the beauty of the scenery, but not all of them are without advantage to event the tourist sightseer.

There is a valuable message as well as homely wit in the following specimens from the official signboards of our highways:

"This is a road. It will cost you money to burn it up."

"Drive slow and see our city. Drive fast and see our jail."

"Slow down. Look before you weep."
"Don't covet your neighbor's side of the road."
"Stop-Look-and Live."
"Don't speed. It is 'Good Morning Judge,' here or hereafter."

Unfortunately, these signs are for those motorists who habitually drive too fast to read them or to be annoyed by the more unsightly advertising poster boards. To the careful driver these enumerated signs are as the "word to the wise" and a protection against accident and speed cops.

Highway advertising signs have become a problem. They mar the natural beauty of the roadside, obstruct the vision of drivers and detract attention from the roadway. Index boards or direction signs are invaluable but generally absent when most needed. Speed signs and "drive cautiously" warnings are not hard to find. But the unsightly and vision-obstructing advertising poster boards are ubiquitous.

State and federal highway departments, public officials and automobile associations are to be commended for steps they have taken recently toward the provision of more and better direction, mileage and warning signs and the curtailing and regulation of roadside advertising signboards. Limiting the size and distance from the highways of these latter signs was a step forward.

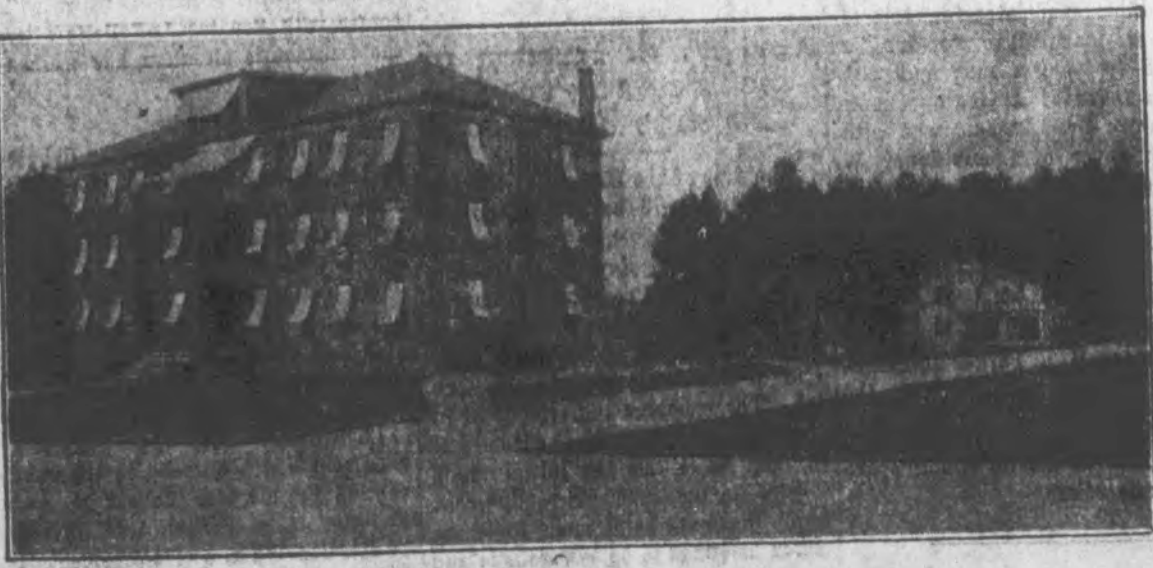

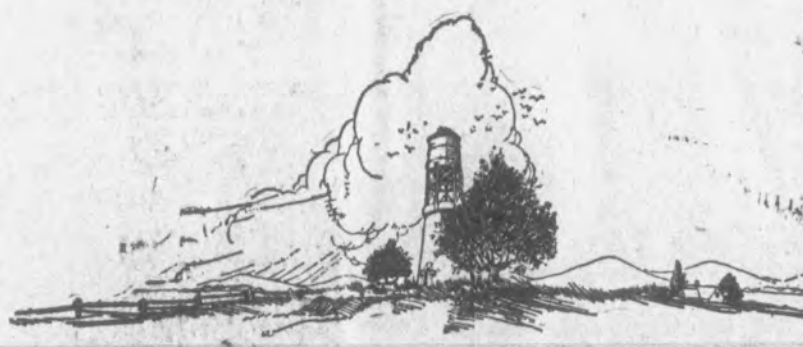

DEADLOCK STILL CONTINUES WHEN THE CONVENTION QUILTS

(Continued from page 1)

Integrate a compromise were at work but were making feeble progress. Overnight conferences among leaders appeared to have gone for nothing. Like two fighters in the ring weary almost to the point of exhaustion who tumbled with blind and dogged resistance after more than 70 rounds the Smith and McAdoo forces went dreadingly along with the balloting before an audience long since tired and inattentive. If either had a real punch they reserved it carefully for the supreme moment which each side seemed to think is somewhere in the indefinite future.

After two ballots this morning the convention received and promptly rejected a proposal that thereafter the favorite sons given the lowest vote on each ballot be dropped each successive ballot until only two remained in the field. It was laid before the convention by Ed. M. Seaman, of Oklahoma City, but interpreted by many Smith delegates as in reality a move to eliminate each of the two leaders and was voted down without a roll call.

Unanimous consent first sought by Seaman's resolution was refused by George E. Brennah, of Illinois. McAdoo and Smith people seemed to believe that if the favorite sons were eliminated one after another and the two thirds rule remain in effect that the time would come when McAdoo and Smith would face each other alone with each side able to lock up more than a third of the total convention strength and thus there could be no nomination. It was then argued that both leaders would have to get out and let the convention have a deal around.

The effort to eliminate the favorite sons elimination movement was renewed in a formal resolution presented by former Senator Hitchcock of Nebraska, which provided that after the 75th ballot the low man on each ballot withdraw. This process of elimination under the Hitchcock resolution would continue until there are five candidates left in the field and the withdrawals would be effective for the current day only. When the question of suspension of the rules and adoption of the resolution was put the chair was left in doubt and a roll call was ordered.

Madison Square Garden, New York, July 5.—Two Fourth of July sessions of the Democratic convention failed to produce a nominee for the presidency and last night, at the end of 70 ballots, the party leaders began seriously to consider the administration of heroic measures to break the deadlock.

During the day two favorite sons had been eliminated, McAdoo had reached a new high record within 20 votes of a majority of the convention. Smith again had touched his high water mark, and a series of maneuvers on the convention floor had re-kindled the animosities of the warring groups and apparently made a compromise more difficult.

Boundary Dispute Cannot Involve the Treaty, Irish View

Dublin.—Appointment of the judicial committee of the British Privy Council to examine the legal aspects of the naming of the Irish Boundary Commission, has brought forth the statement from the former Free State attorney general, Hugh Kennedy, now a member of the Supreme Court, that "no question of interpretation of the treaty has been or can be referred to the judicial committee to far as the government of the Free State is concerned."

The work of the commission, it is pointed out, will in reality be an attempt on the part of the British government to anticipate any difficulties which might arise after the Boundary Commission has made its award, which will have the force of law and will probably automatically transfer various populations from one jurisdiction to another. Thorough investigation by the committee is expected to obviate any claim that the commission was not legally constituted, with a consequent demand for nullification of its award.

Numerous legal questions are involved. As Ulster refused to appoint a member of the commission, the committee, which will represent the highest court of appeal in the empire, will be called upon to a decide in advance whether the British government may nominate an Ulster representative, either directly or indirectly, and what legislation is necessary to thoroughly legalize the proceedings.

CHARTERS GRANTED

Raleigh, July 5.—The Young Men's Advancement Association is the name of a non-stock corporation of Durham which has been issued a charter by the office of the Secretary of State. The corporation was founded and is fostered by a group of leading citizens of Durham, among them being H. T. Green, Frank L. Byrd, T. H. Beaman, Alex. Hammon, and Roberts all of Durham.

The purpose of the association, as set out in the charter, is the development of Christian character and usefulness, and the improvement of the spiritual, social and mental as well as the physical condition of young men, who have been denied the advantage of good environment during their boyhood and who fail in securing and education, see to the necessity of their going to work at an early age.

The method to be pursued in carrying on such work, the charter states will be the creation and maintenance of libraries, wherein the best of literature and educational books shall be kept; the operation of social and recreational rooms and lecture halls; and the providing for the physical development of these young men.

The association, it was pointed out is to be conducted especially for the benefit of those boys who would ordinarily spend their time loitering about the streets or lingering in places of worthless amusement.

It specifically designated that the organization shall be non-profit making and that only one person in the personnel shall receive pay, that person being the full time secretary, who must be a man of middle age, if not elderly.
