MISS ELIZABETH WHITE ELECTED BEAUTY QUEEN RALEIGH FALL FESTIVAL

Governor Cameron Morrison Places the Crown Upon Head of Greenville Girl as the Most Beautiful in This State

Raleigh, Sept. 19.—Competing with a group of contestants from all over the state Miss Elizabeth White, daughter of Mrs. Nannie F. White, of Greenville, was yesterday elected Beauty Queen of the Raleigh Fall Festival. She was crowned last night by Governor Cameron Morrison at the coronation ceremonies in the city auditorium which brought the three day's celebration to a close. Miss White, succeeds Miss Alice Cheek, of Henderson, and will reign as Queen of the Raleigh Festival until the closing day of the 1925 celebration.

Coronation Ceremony.
The City Auditorium had been transformed into a great throne room all gold and white for the coronation. Except for the stage, the great depths of the hall were in darkness and there in a light that gleamed in the gold and white and against the darkness of the room, Governor Morrison took his seat with H. H. Brimley, president of the Festival Association, standing beside him.

From entrances at the side of the hall couples came, girls in bright dresses and young men in somber black and white, the spot light following them to the stage where they took their places on each side of two tremendous chairs. From the same side doors came the beauty queens of towns, in varicolored gowns, walking under the bright lights to the stage.

Down a passageway through the crowd at the rear of the great room and walked, self-possessed and beautiful Master Louis Connor, Jr., bearing a satin cushion upon which rested the crown of the Queen. Behind him came her majesty, all in white with a long silver white train. She walked in regal beauty to the throne while five thousand people who packed the auditorium admired without affectation, calmly and in dignity, she proceeded to the platform while ten thousand hands paid vociferous tribute to her loveliness.

Governor Morrison placed the brilliant crown on the blonde hair of the Queen. He put in on backwards first and the audience laughed delightedly until he turned it around Young Louis Connor, Jr. pleased the humor of the audience, too, when he lifted his foot almost as high as his youthful head as he stepped over the royal train to get out of the way of the Governor. Then, after a little laugh, everything was quiet again. Emily Rose Knox stepped to the stage and played living music on her violin. "Believe Me If All Those Endearing Young Charms," "Drink to Me Only With Thine Eyes," and "The World is Waiting for the Sunrise." She played and the audience kept an unbroken silence until the last chord was ended on the strings of her Stradivarius.

Mr. Brimley in a few brief humorous remarks in which he traced the history of Queens from the Queen of Sheba to the Queen of Clubs presented a silver loving cup to Miss White.

TRIAL OF CHARLES R. FORBES WILL BE SET ON OCTOBER 14

Counsel For Former Head Veterans Bureau Declare Conspiracy Indictment Vague

Chicago, Sept. 19.—Federal Judge Carpenter today overruled the demurrer of Colonel Charles R. Forbes and John W. Thompson, Chicago and St. Louis contractors, to indictments charging them with conspiracy in connection with Forbes' administration as Director of the Veterans' Bureau.

The trial date will be set October 14. The defense had objected that the indictments charging the defendants with conspiracy to defraud the government were vague. Judge Carpenter in ruling in favor of the government said the law provides due safeguards for accused persons and that there is no indictment that astute students could not criticize. He added that the indictments are sufficiently clear to understand what the government had in mind, conspiracy to defraud.

Civil War Continues Despite Army Revolt

Shanghai, Sept. 19.—Revolt of the third Chekiang army defending Shanghai has thrown the bulk of the battle today upon the first army under command of Ho Fing-Lin, whose army is holding the lines west of Shanghai against the Kiangsui forces fighting for the possession of Shanghai.

Raleigh Primitive Baptist Church In Hands of Receiver

Raleigh, Sept. 19.—The Primitive Baptist Church of Raleigh set an unusual precedent in church annals of this state, if not of many others, when it went into the hands of a receiver on Wednesday, pending the outcome of litigation now under way by the two rival divisions of the congregation, who each claim ownership of the building. Both sides claim to have expelled the other side for immoral conduct. The first action led by W. A. Simpkins has been using the church all along but the other faction led by J. P. Temple has worshipped in chapel of the Old Soldiers' Home.

ENGLAND STILL GUARDING THE TWO GERMANS ARRESTED AS SPIES

London, Sept. 19.—Stories of the sometimes romantic exploits of spies are recalled by the release from Dartmoor prison of Courtenay Hen slot, de Rysbach, who in October, 1915, was sentenced to penal servitude for life as a spy in Germany's service.

De Rysbach, a vaudeville actor and the son of one-time Austrian subject who was naturalized in England, was arrested after the postal censor had stopped two songs mailed by him to an address in Switzerland. One was "The Ladder of Love" and the other was "On the Way to Dublin." When they were chemically treated, an account of conditions in England written in invisible ink appeared. After imprisonment De Rysbach divulged German espionage methods.

At the Home Office it is stated that only two spies now remain in prison in this country.

SENATOR PAT HARRISON SCORES REPUBLICANS IN ADDRESS LAST NIGHT

DRAIN IS ELECTED NATL. COMMANDER AMERICAN LEGION

With Election of Officers American Legion Brings Sixth National Convention to Close Today

Saint Paul, Minn., Sept. 19.—James A. Drain, of Washington, D. C., was elected National Commander of the American Legion at the closing session of the 6th Annual Convention here today.

Mr. Drain's election came on the first ballot and he had a majority of all accredited votes before the roll call was two thirds completed. As the roll ended his total had swelled considerably. Only two other names were presented to the convention, John McQuigg, of Ohio, and E. E. Stafford, of New York.

Minnesota presented the name of Drain to the convention, State Adjutant Stafford King making the nominating speech. Peyton Hogue, national committeeman of Kentucky, seconded the nomination. When the roll call was completed the election of Drain was made unanimous on motion of King, of Minnesota, and amid a rousing demonstration Drain was escorted to the platform as the band played "The Gang's All Here."

The convention, on motion of the Missouri delegation, voted to make General John J. Pershing a permanent distinguished guest of this and every other National Convention of the American.

The following were elected vice presidents of the Legion without opposition: Eugene Armstrong, of Connecticut; Frank McFarland, of Kansas; A. L. Perry, of Panama; William Sterns, of North Dakota; Peyton Hogue, of Kentucky.

Saint Paul, Minn., Sept. 19.—Political fires flared higher today as the American Legion entered into the last stage of its sixth annual convention for the election of officers and transaction of other business. Several men had been suggested as successors to John R. Quinn of California, National Commander, before today's session was called to order. Of these J. A. Drain, of Washington, D. C., and John R. McQuigg of Ohio, were most prominently mentioned.

The speed with the convention accepted preparedness, Americanism and other resolutions yesterday cleared the way for quick disposition today of business other than the election of officers as only the report of the International Organization remains to be heard.

Special "Flower" Service at Free Will Baptist Church Tonight

There will be a special service conducted in the Free Will Baptist Church tonight for everybody, under the auspices of the Girl's Circle.

Rev. M. L. Hollis, of Vernon Alabama, president of the Alabama State Convention of Free Will Baptists, and a leader in the young people's work of the denomination, will deliver a special address to the young people, but of interest to all ages on the subject "Going Away From Home." Mr. Hollis is a very earnest and forceful speaker, and will interest all. He is one of the leaders among the younger ministers of the Free Will Baptist Church.

Dr. Hollis makes but one request, and that is that all who attend this service bring one flower, any kind, and he promises to tell why he makes this request tonight.

Speaker Declares Republicans Know Only to Serve Moneyed Interests and Privileged Classes

Raleigh, Sept. 19.—Calling President Coolidge a "Sphinx" and deriding the Republican administration for its corruption and inefficiency which he said were uppermost in actions and comparing the catering of Republicans to the special privileged classes to the work of the Democrats for all the people, Senator Pat Harrison, who Governor Morrison said in introducing him was the most eloquent champion of Democracy in the South, told approximately 5,000 people crowded in the city auditorium last night that John W. Davis was sure to lead the Democrats back into power in November with the ideals of Woodrow Wilson. At every mention of the name of Woodrow Wilson the building sounded and resounded with applause.

Mr. Harrison said that the Republicans had dropped much of the Wilson proposed legislation because it did not want the Democrats to have credit for such good work. He pointed out that what little worthwhile legislation the present administration had put through was identical to the proposals of Mr. Wilson which the Republican had originally blocked. The Dawes Reparations Plan and Budget System were both ideas of Wilson, declared the Senator.

Senator Harrison called the Republican party one that played to the moneyed interests and special privileged classes and said it had won its last presidential election through appeals to an impassioned people just out of war through promises of reduced cost of living, which were never fulfilled, and by arguing themselves with the moneyed interests.

He declared that Senator Reed Smoot owned 432 shares of stock in the sugar industry in Idaho and Utah and after securing a high tariff on sugar had then writing to the president of Cuba offering to reduce that tariff if Cuba would curtail its sugar production. "And yet," Senator Harrison added, "Calvin Coolidge sits like a sphinx never lifting a finger to put the unscrupulous corruptors in jail."

"The Republican party has had an administration useless to the common man because it knows nothing but to work for the special privileged, but that will be corrected by the people in November," Mr. Harrison declared.

The Senator concluded by saying that the Democrats who went astray four years ago and voted for the Republicans were going to return to the fold by divisions this year.

Kiwanis Club Will Celebrate Constitution Week This Evening

The Kiwanis Club will on this evening at its regular meeting observe the annual celebration of Constitution Week. Every Kiwanis Club in the United States will observe the occasion with a special service tonight.

Dr. R. H. Wright will deliver the principal address before the local club. A special musical program will be rendered in addition to a program which will be featured by short talks by members of the club on the significance of constitution week.

Local Market Sold 813,238 Pounds Thursday

The Greenville tobacco market on yesterday sold 813,238 pounds of tobacco for \$169,782.68 at an average of \$20.88.

The largest break ever recorded in the history of the Greenville market was on the floors of the six warehouses. Three sets of buyers started with the sales at 8:30 o'clock and followed them until 5 o'clock. Had there been an additional set of buyers it is believed that the market would have sold its breaks which consisted of nearly 1,000,000 pounds. The sales today will completely clear the floors having everything in readiness for the Monday's sales.

OPEN FORUM

The Editor of The Daily Reflector,
Dear Sir:

In your fine editorial of Wednesday, September 17th, entitled "If Congress Elects," there is an inaccuracy which I believe you will be glad to correct.

It occurs in the statement: "It is just 100 years since congress was called upon, in the only instance of its kind in history, to name a Chief Executive, following a deadlock in the Electoral College."

I have italicized the words "in the only instance of its kind in history," because if you had left that clause out your statement would have been perfectly correct.

Mr. J. M. Turner, who is one of the best informed historians in Pitt county, called my attention to the fact that there have been two such occasions, and that you are referring to the second.

The first occurred in the year 1800 when there was a deadlock between the candidates, Aaron Burr and Thomas Jefferson, in the Electoral College, each receiving an equal number of votes. The House of Representatives elected Jefferson as president and Aaron Burr was made vice-president.

It is interesting to note, in this convention, that if the Electoral College this year fails to elect a candidate, and should the House of Representatives also become dead-locked in the selection of a president, the matter would go to the Senate. In the case of the House the voting would be by states, not by the number of Representatives, each state casting only one vote. As we have 48 states, twenty-five votes would be the minimum number to elect a president under these conditions. If the decision has to be made by the Senate it would vote as a body, and the majority would decide which of the vice presidential candidates shall become president. This has never yet occurred in the history of our country.

The hapless pirates were arrested while trying to carry out a conspiracy to seize the flagship of Admiral Wen.

**WOULD MAKE LIFE EASIER
FOR BRITISH PENSIONERS**

London, Sept. 19.—Roland Bourne is endeavoring to create communal settlements in South Africa for Englishmen with small incomes who can no longer live in England in accordance with the standards to which they are accustomed. He says that England abounds in retired army and navy officers, and others with practically no capital but with small fixed incomes varying from \$1,500 to \$4,000 a year.

England has too forbidding a climate for such people, but in South Africa, on holdings of from two to five acres, they could be very happy.

**Say Scotch Tax
Collectors Are Out
After Delinquents**

Aberdeen, Sept. 19.—The burden of taxation which has depopulated England of the country squire and the lord who owned large sections of counties is beginning to be felt in the Highlands.

Because their highland estates are largely unproductive and their extent somewhat doubtful, the owners have heretofore not been held strictly to account by the tax-collector. Recently, however, the tax surveyors have been busy in the northern Scottish counties and large tax bills have been sent to the lairds, representing to them a dead loss. Now scores of castles and manors with centuries of historic connections and thousands of acres of land are offered for sale.

One of the most famous is the Fin-gask Castle with 13,827 acres of land, which was built in 1594 and has been connected with all the important events of Highland history, particularly the escapades of Bonnie Prince Charlie.

Despite many inducements the owners cannot find a market for their estates.

Rye Produces 900 Fold.

Virchow, Pomerania, Sept. 16.—From a single seed of rye, planted this spring by the village school teacher and nursed with fertilizers, 19 stalks were grown, and from these heads 900 grains were harvested. This is said to be a record in Germany. Agricultural experts consulted the schoolmaster as to what kind of fertilizer he used.

**PARSONS MUST ACQUIRE
BETTER PULPIT VOICES**

London, Sept. 19.—The comedy parson, one of the standing jokes on the England variety stage, is threatened with extinction. With the enthusiastic support of the Archbishops of Canterbury and York, a scheme is to be launched in October whereby all theological students preparing for Holy Orders in the church of England will be trained in the right producer and management of voice.

Already the sum of \$10,000 has been secured to meet the expenses of instruction. Teachers will be assigned to train in voice production and elocution to the end that all clergymen be taught to read and preach with "clearness, sympathy and reverence."

TIRED OF TOLERANCE

An anti-jazz ordinance, presented by the mayor of the city of Wilkes-Barre, Pa., was defeated by the council of that municipality in secret meeting. The law would have prohibited the playing of jazz music in public halls and on the streets.

It took only 24 hours for the Wilkes-Barre council to find out that an "eighteenth amendment" for jazz music would be very unpopular with the populace. Evidently the people did not agree with the mayor that jazz music was bad for them.

Political observers have noted a growing aversion on the part of the public to repressive laws. There is also exhibited a general distrust of reformers and politicians sponsoring such prohibitory legislation.

The people are coming to the belief with Thomas Jefferson that "the best government is that which governs least." They no longer submit to having their lives ordered by those zealous ones who know what is best for them. They are awakening to the fact that many small minorities have had more say in the government of the masses than have the masses themselves, although the majority is given the right to rule in the United States.

Hereafter American public opinion will tolerate only such legislation as does not conflict with its mode of living and the so-called personal liberties. Those who have a taste for opera will not be permitted to deny others their jazz. Already those who prefer tea to coffee have learned decisively that the coffee-drinkers will not be deprived of their cup or dozen cups regardless of the harmful effects the drink may have upon the human body. The anti-tobacco movement, which was given an impetus by the eighteenth amendment, has been forced into oblivion by public opinion.

The nation (excepting the disciples of reform) is in accord with Clarence S. Darrow, Chicago criminal lawyer, that "No society can hold together that does not have a broad tolerance for minorities," and that although "it is a popular idea that the majority should rule this does not mean that the people should vote on every question affecting human life and that the majority should then pass penal statutes to make the rest conform."

DANGER OF CORRUPT GOVERNMENT

Thoughtful men and women of both parties must view with deep concern the convincing evidences of corruption in the conduct of our national government. Errors in administration can be overlooked and excused when no bad motive is apparent and when those who commit the errors make prompt and sincere efforts to correct them. But when corruption appears in Government and the responsible administrative heads are indiff-

erent to it or by silence or specious declarations attempt to condone it, Democracy is confronted with a real danger.

Official corruption is a menace which can not be temporized with or condoned without jeopardizing every principle of free government and every right of its citizens. Corruption in government is not a matter to be ignored nor treated lightly nor evaded nor excused. Whether it exists in the form of a corrupt policy like a high protective tariff or whether it is manifested in the individual acts of officials, it is an insidious and dangerous thing, which, if permitted to exist, will spread contagion not only throughout the government but likewise to the body politic. It contaminates government; it contaminates business, which underlies everything in our national life; it contaminates the electorate, and saps the moral fibre of our youth. To what extent its destructive effects will be felt in this country unless there is a complete change in the national administration can only be conjectured, because those now in authority whose duty it was to eradicate it and cleanse the government have proceeded only when action was demanded by the legislative branch of the government and then proceeded reluctantly and tardily. Worse still, those in authority, reinforced by party leadership, have sought to conceal instead of having sought to reveal the facts in order to perpetuate the reactionary element in the Republican party in power for another four years.

The course of the Democratic party in this matter is plain; it is to marshal all the moral forces of America in behalf of clean government, and, when intrusted with power, to use every resource of the administration to so thoroughly cleanse the government in every department and bureau until not a taint of contamination remains.

The duty of honest men and women in all parties is equally plain; it is to join forces with the Democratic party to bring about this result, and by restoring honest government to restore the confidence of the people in their government, which John W. Davis has righteously declared to be "the supreme need of the hour."

COTTON LETTER

New Orleans, Sept. 19.—The continuance of unfavorable climate conditions in the interior is the sustaining feature of the market. There was much rain overnight in inland, especially in Oklahoma and Arkansas and prospects are for more moisture in nearly all sections of the belt, except west Texas. The rains have tended to lower the grade, harden the basis, restrict picking and receipts in the interior where there is some improvement in the spot demand.

Meanwhile the market is coming under the influence of the next government crop forecast reported September 23rd. Three additional private mid month crop reports were issued today ranging from 12,800,000 to 12,945,000. The average of 8 private reports issued so far as to condition is 57.8 indicated crop 13,014,000. Returns to the government as of Sept. 1st, report on which was issued Sept. 8 averaged the condition of cotton at 50.5, pointing to a yield of 12,767,000. If the government next Tuesday indicates a yield of 12,800,000 or larger markets will likely decline probably advance temporarily if 12,600,000 or less.

Meanwhile, weather developments inland will have to be reckoned with. Owing to the uncertainty of the government, it may be advisable to realize on long contracts with the market is ruling as a result of unfavorable weather conditions, because if the bureau points to a production of 12,800,000 or more or if there is the return of fair weather to the cotton region values may decline again.
