NEW YORK GIANTS WIN THIRD GAME OF SERIES AGAINST WASHINGTON

Today's Victory Gives Giants Best Two Out of First Three Games of Series

New York, Oct. 6.—The Giants defeated the Washington Senators this afternoon in the third game of the world's series by a score of six to four.

The battering were: Washington—Marberry, Russell, Martina, Speece and Ruel. New York—McQuillan, Ryan, Jonnard, Watson and Gowdy.

The game as played was as follows:

First Inning Washington—Liebold out second to first; Harris flied out to right field; Rice gets base on balls; Goslin out second to first.

New York—Lindstrom strikes out; Frisch flies out to left field; Young singles to left center field; Kelly out second to first base.

Washington—Judge singles over second base; Bluege hits into double, pitcher second first. Peckinpaugh out first.

DEFENDING FORCES SHANGHAI DRIVE BACK ATTACKERS

Japanese Patriotic Association Urges Intervention by Japan

Shanghai, Oct. 6.—Kiangsu forces representing the Peking government undertook a flank attack today southwest of Shanghai and attacked the village of Chuking 40 miles southward from here. The place was defended by 200 Chekiang troops.

Tokio, Oct. 6.—Patriotic agitation that Japan intervene in the Chinese war on the side of General Chang Tso Lin, the Manchurian leader, was brought to a climax today when three members of the Taisho Patriotic Association, all Ju Tsu experts, invaded the foreign office and forced their way into the private quarters of Baron Shidehara, Foreign Minister. When the trio demanded an interview with the Foreign Minister he was absent. They then denounced the Foreign Minister for what they termed his spineless policy toward China. In their rage the visitors attacked and severely beat the private secretary of the minister and other secretaries. Police were called and arrested the trio but not before they had scattered handbills over the floor and desks of the foreign office. The circular demanded a more positive policy for protection of Japanese rights and interests in China. The invading Kiangsu forces then continued their attack upon the village of Mazdo when they were driven back by the Chekiang forces. Kiangsu soldiers in the retreat fell back to their positions on the Whang-poo river. During the fighting shells and bullets fell in the vicinity of Sungkiang resulting in numbered casualties.

According to information from the State Highway Commission, light traffic, one way at a time is now allowable across Tar River. This is especially applicable to carts, wagons, etc.

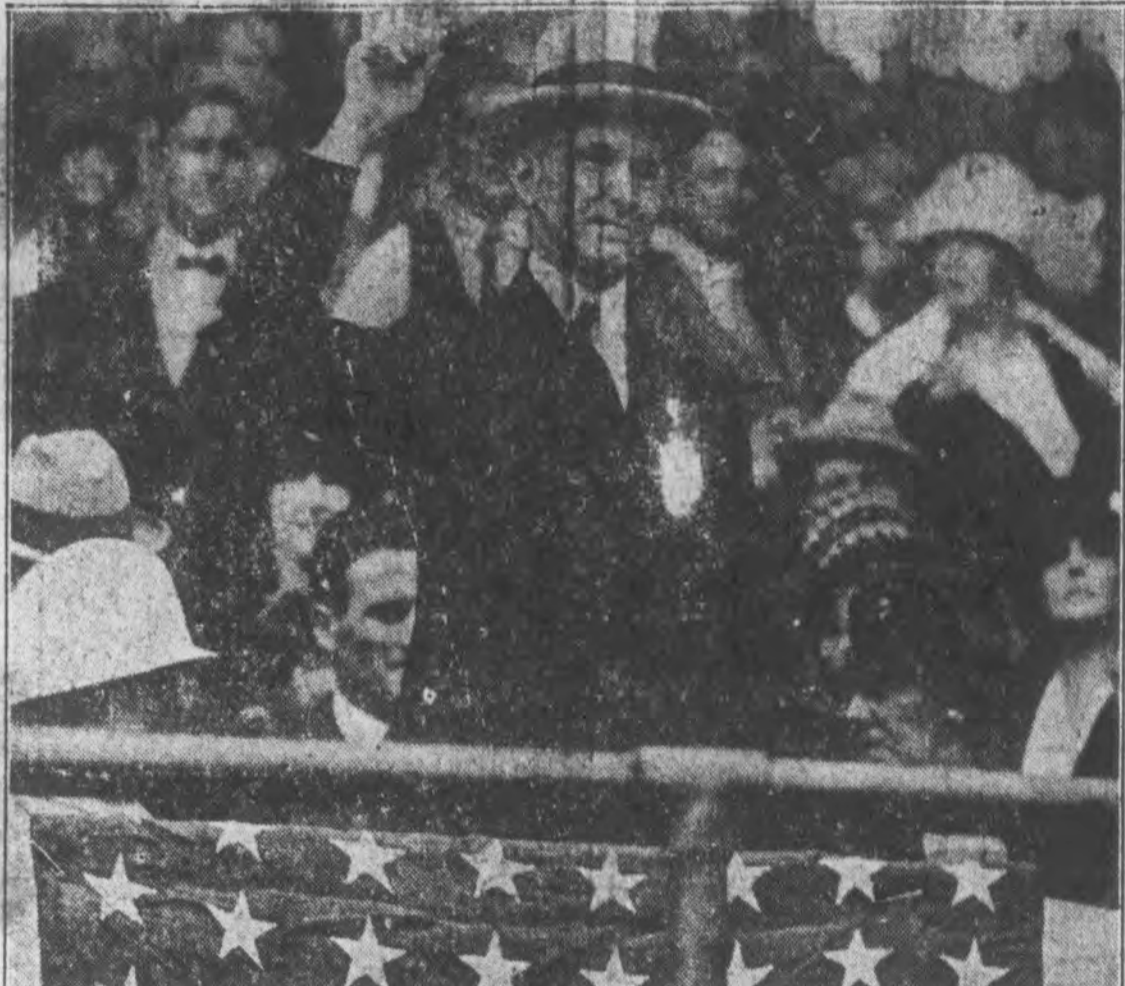
Night Schools In Durham Will Open Monday, October 6

AMERICAN WOMAN ROUGHLY HANDLED BY CHINESE POLICE

Dragged to Police Cell and Prevented From Communicating With American Consul

Hong Kong, China, Oct. 6.—Mrs. Harvey L. Decker, American wife of the manager of the Canton City Telephone Company, on Saturday was subjected to rough handling, jostling, jeering and finally detention in a police cell by 20 policemen at Canton, according to word received here.

Mrs. Decker, who is in delicate health, had gone to the police station in connection with the demand for payment of a police tax alleged to be due by her husband for engaging in business in Canton. Mrs. Decker was arguing that she and her husband should be exempt from the tax because the Canton City Telephone Company was a foreign corporation, when some of the police thrust revolvers to her side, dragged her out of her motor car and carried her into a barred cell. Mrs. Decker endeavored to communicate with the American Consul General but was prevented by police officers.

After two hours of molestations her husband received information of her plight and with the aid of the American Consul went to the police station and obtained her release.

Windsor, Ont., Oct. 6.—The bodies of Mrs. Dorothy Crather and Mrs. John Gersuch, both of Detroit, who were drowned in Lake Erie last week when their launch capsized, have been recovered.

Italian Parliament Building Suffers Fire

Rome, Oct. 6.—Fire broke out last night in the loft of Parliament building, used as a depository for documents, and blazed freely threatening to spread to the lower floors of the building. After two hours' struggle the fire was extinguished without serious damage.

Cotton Suffers Great Damage From Rainy Spell

Raleigh, Oct. 6.—Much damage has been done to the cotton and cotton seed in North Carolina by the long spell of rainy weather, it was declared today by Director B. W. Kilgore, of the North Carolina Experiment Station and Dean of Agriculture at State College. The situation now facing North Carolina farmers and marketers of farm products, he said, is one of the most serious with which they have had to cope.

Cotton picked since the rains where it has not dried out thoroughly should be spread out, so as to dry completely before ginning. It was emphasized, otherwise the lint is likely to be badly cut and the value correspondingly reduced.

"Where seed are damaged, they should be kept separate from good seed, from cotton gathered before the rains, or from good seed which may come from cotton which opens later," the director explained. "If damaged seeds are mixed with good ones they will reduce the price of the whole lot and the meal will be of poor quality. It may not be good enough for feeding men. Meal from damaged seeds is as good for fertilizer as meal from good seeds, but care should be taken not to have the price of a large lot of seed reduced by the mixture of poor seed with them."

"The matter of planting seed for next year is going to be a rather serious question, and it is suggested that all really good seed from early pickings be saved for this purpose, and that good seed obtained from later pickings also be saved for seed purposes, using the best that come from these later pickings."

"Much loss in the value of lint and seed for meal purposes and for planting next year's crop may be avoided by giving careful thought to those matters at this time."

COOLIDGE SPEAKS ANNUAL MEETING OF THE RED CROSS

President Pleads for Truly Civilized World Founded on Principles of Red Cross Spirit

Washington, Oct. 6.—Thanking the American Red Cross for its "practical humanity" and inspired by its charity, President Coolidge addressed the opening of the annual meeting of the society here today, pleading for a truly civilized world where the costs of armament, pensions and fortification were not required to be borne. "Where resources could be used," he said, "to promote, not destroy happiness—Such a world—what mighty work might be accomplished under leadership of the Red Cross spirit. Poverty, ignorance, prejudice and all uncharitableness might be completely relieved and remedied."

"Toward such an ideal," President Coolidge declared, "the race is making progress. It will be achieved not by some magic formula at some inspired moment but because men and women are more and more demanding it."

"In the Red Cross," the president said, "the nation has opportunity to capitalize and direct the finest most appealing tribute to human nature—Charity. It is the strong support of the government and reliable guarantee of civilization," he said. "It will show the way to more complete real truth and justice through mercy."

Emphasizing the practical idealism President Coolidge recalled the accomplishments of the Red Cross in relieving the distress resulting a year ago from the earthquake in Japan.

MORE THAN MILLION FACE FIFTH JOBLESS WINTER IN LONDON

London, Oct. 6.—Great Britain's army of more than a million jobless people is the fifth winter of unemployment. The permanent solution of this post-war problem is as far away as ever in the opinion of economists.

Inasmuch as three different governments—Coalition, Conservative and Labor—have dealt with the question, which still awaits solution, it would appear to the detached observer that the problem is one of after-war economics rather than partisan politics.

For five years the unemployment question has been a sort of urchin's joy to whatever political party happened to be in opposition. In fact it seems to be a problem that is more readily grasped by an opposition than by whichever government happens to be responsible for the conduct of affairs.

The Labor government, notwithstanding, points to the latest unemployment figures available—1,119,190 as about 120,000 less than for the corresponding figure of a year ago. This, however, leaves the minimum at well over a million where it has been for the past five winters and where in the view of not a few economists it is to remain permanently.

The edux of the question, according to a spokesman for the Labor government, lies in the ship-building, cotton, and engineering industries which have never recovered from the disarption in which they were found at the close of the war.

This spokesman declared that Britain's army of more than a million jobless can never be put to work until the solution of the problem of German reparations has restored the economic equilibrium not only of Germany but of Europe and the world. Closely akin to this problem, in the view of economists of the Labor party, is the question of trade relations with Russia. As the Dawes plan has just been launched and the House of Commons, when Parliament resumes at the end of this month, will debate the treaty which the MacDonald government negotiated with Soviet Russia, the future alone will determine how these latest international agreements will affect world trade conditions.

The unemployment dole, is regarded by both philanthropists and economists as a necessary evil — inadequate to take care of the needs of its recipients and demoralizing because payments are made without any return in labor.

A family consisting of father and mother and four children, if eligible to the unemployment dole will receive 31 shillings a week this winter, as against 24 shillings a week last winter.

WOMAN SOUGHT TO ENCOURAGE FOOTBALL TEAM BY CURSING POPE

Dublin, Oct. 2. — In Northern Ireland the rigid fine for use of the use of party expressions is 40 shillings and costs. Cursing the Pope comes under the head of party expressions.

At Lurgan a woman charged with this offense argued that it was at a football match, and that she thought it the most effective way of encouraging the team she favored. This was received with laughter, but she had to pay the 40 shillings.

Pranks of The Parana Keep the Skippers Guessing

Buenos Aires, Oct. 6.—The eccentric behavior of the Parana river, at its delta, is a constant source of expense to the Argentine government. It has to maintain a fleet of dredges to keep channels open. Little peninsulas, islands and bars which a ship bound for Rosario encounters, on one trip are often gone the next one, and new ones have been formed at other places. Deep water becomes shallow almost over night, and ships are continually going aground. Sometimes the river suddenly drops one or two feet without any seeming reason, and large vessels loaded to a supposedly safe draft may have to wait in port several days before proceeding.

Some years ago a schooner sank in midriver and now there is a considerable island at her stern. Once a farmer cut a small channel for his motorboat through the neck of a peninsula. The river took up his work and before long big ocean-going steamships were using the channel for a short cut. Few ships go permanently aground, for the river usually helps them off in its own good time.

Also the Parana every year adds a square mile of territory to Argentina. This is formed by river deposits washed away from Brazil and Paraguay. No country protests for nothing can be done about it.

American Consuls Calm Toward the Eager Immigrants

Hamburg, Oct. 6.—America's new restrictive immigration law is restricting with a vengeance, and applicants for admission to the United States are beginning to realize that a visa to enter the United States is a rare privilege and not a right, as many had previously believed.

The burden of proof is now on the applicant for admission to the United States, and consular officials sit as judges upon the fitness of the applicants and the reliability of credentials.

As only slightly more than 5,000 German emigrants can be passed monthly, and this number is divided among ten consular offices, the old days of rush and shove about in consular offices are largely over.

One of the striking results of the new law probably will be that hundreds of foreign men who have not become citizens in America will be compelled to return to Europe if they want to rejoin their families. This means the wives and children of non-Americans in the United States are not given special treatment, and many of them will not be able to get permission to go to America for years because of the small quotas.

It is not clear whether the law was framed intentionally to produce this effect, but scores of distracted women are now besieging the consulates seeking advice about what action to take. They can only be told, if they desire a speedy reunion of their families, that their husbands had better return to Europe.

CITY OF BALTIMORE SEEKS TO PRESERVE HISTORIC LANDMARK

Baltimore, Oct. 1.—The Shot Tower, which has stood as a landmark at Fayette and Front Streets in Baltimore for about 100 years, will be purchased by the city of Baltimore and preserved, if efforts of a number of citizens and organizations are successful.

When the owners of the tower announced last June that unless the city took over the structure it would be demolished, Mayor Howard Jackson said that if the public showed genuine sentiment for preservation of the shaft the city would buy it.

Following the lead of the Daughters of the American Revolution, numerous patriotic and other societies and many individuals appealed for the preservation of the old landmark. Representatives of these societies held a conference with the mayor and it was decided to acquire the tower by public subscription.

Late in August, when the owners of the tower and the mayor failed to agree on a purchase price, an ordinance was passed by the city council providing for condemnation of the tower in case the committee seeking funds had not raised the necessary amount within a certain time.

With this time limit approaching expiration, and the committee still in need of several thousand dollars, the tower seems likely to come down.

The tower is the highest of its kind in the world and is regarded as the oldest munition factory in the United States. From a base forty feet in diameter the shaft rises to a height of 240 feet. The column tapers as it ascends, so that the diameter at the top is only twenty feet. It was built in 1828, Charles Carroll, signer of the Declaration of Independence, laying the cornerstone.

The interior of the structure was destroyed by fire in 1878, but was rebuilt and shot dropping continued until 1892. Then the tower was abandoned for shot making because of the advent of improved methods of manufacture.

Farmer Given Four Years for Puncturing Automobile Tires

Greensboro, Oct. 3.—J. Early Malpass, white farmer of Pender county, will spend four years on the road after conviction of having been the author and manufacturer of certain "puncture-sure" devices found on the highways near Currie, N. C., and reported by official of the Carolina Motor Club. An offer of ten dollars reward for the arrest and conviction of the guilty party caused Z. L. Hunt and E. M. Vernon, both of Currie, to investigate. The investigation led to Malpass' arrest and conviction. An additional reward of \$50 was given by the county commissioners and \$25 by an individual.

A sample device sent to the offices of the Carolina Motor Club some months ago by H. E. Parker, in charge of the Goldsboro office and reported to him by E. W. Vick of that city, caused the Motor Club to offer the reward. A photograph reproduction of this device was published in the "Carolina Motorist," official publication of the Club.

Judge Lyon, who tried the case in Superior Court of Pender county, stated that this was the first case he had tried in which there appeared to be no excuse for the crime. The defendant was given two years for obstructing the highways and two years for injury to personal property.

Malpass lived along the highway and witness testified that it was a common thing to pick up as many as five "tacks or nails in one trip. One man stated that he had taken 17 nails in his tire and nine punctures. Sheriff Arthur W. King of Burgaw, reports that the young men who convicted Malpass had the thanks of the entire section.

O. W. Roberts, general manager of the Carolina Motor Club immediately forwarded the reward check to Sheriff King to be turned over to Mr. Hunt and Mr. Vernon. "The reward will be gladly paid wherever an instance of this type is reported. Destroying tires and time of motorists is the most wanton form of vandalism. Organized motoring will not and should not condone it."

American Passports Lure Europe's Expert Thieves, Report Says

Hamburg, Oct. 2.—American passports and foreign passports vised for the United States are now worth their weight in gold in central Europe, and passport thieves are busy on trains, in hotels and on steamers and wharves.

Scores of stolen passports are reported weekly to American consular officials. It is a frequent occurrence for a foreigner who has obtained a vised document for America to have his papers stolen before he sails.

Americans are warned by consular officers to keep the numbers of their passport, and make speedy reports of theft to the nearest consul so that the papers may be cancelled from Washington and steps taken to prevent imposters from reaching the United States. Travelers are warned not to leave their passports in their luggage, even if it is locked, and advised to carry them in inside pockets beyond the reach of sneak thieves.

The situation has become particularly bad since the new American immigration law went into effect. There are evidences that organized gangs are dealing in papers supposed to guarantee entrance to America. Forgers can easily change names and photographs and descriptions. While purchasers of altered passports will probably come to grief sooner or later, there are so many persons clamoring for admission to the United States that sharpers find a ready market for their stolen wares.

IRISH POLITICAL PRISONER, FREED, SEEKS HIS OLD COUNTY POSITION

Dublin, Oct. 2.—Art O'Connor, who was agricultural minister in the De Valera government and who was imprisoned as a result of the conflict between the Free State and the Republicans, has applied for reinstatement as assistant county surveyor for Kildare. He held that position before the split between the two factions.

O'Connor's application, filed upon his release from prison, has been granted by the Kildare county authorities, but to be made effective will have to be approved by the Free State government.

Alleged Rum Runner Faces Death for Piracy

Max Jerome Phaff, a German American alleged bootlegger, is under arrest at Havre, France, on a charge of piracy, the penalty for which is death. The French declare he is the "master mind" in the gang of pirates who boarded the French steamer Mulhouse off the coast of Long Island and stole her entire \$200,000 whiskey cargo. Phaff asserts he was in Canada at the time and knew nothing of the piracy.

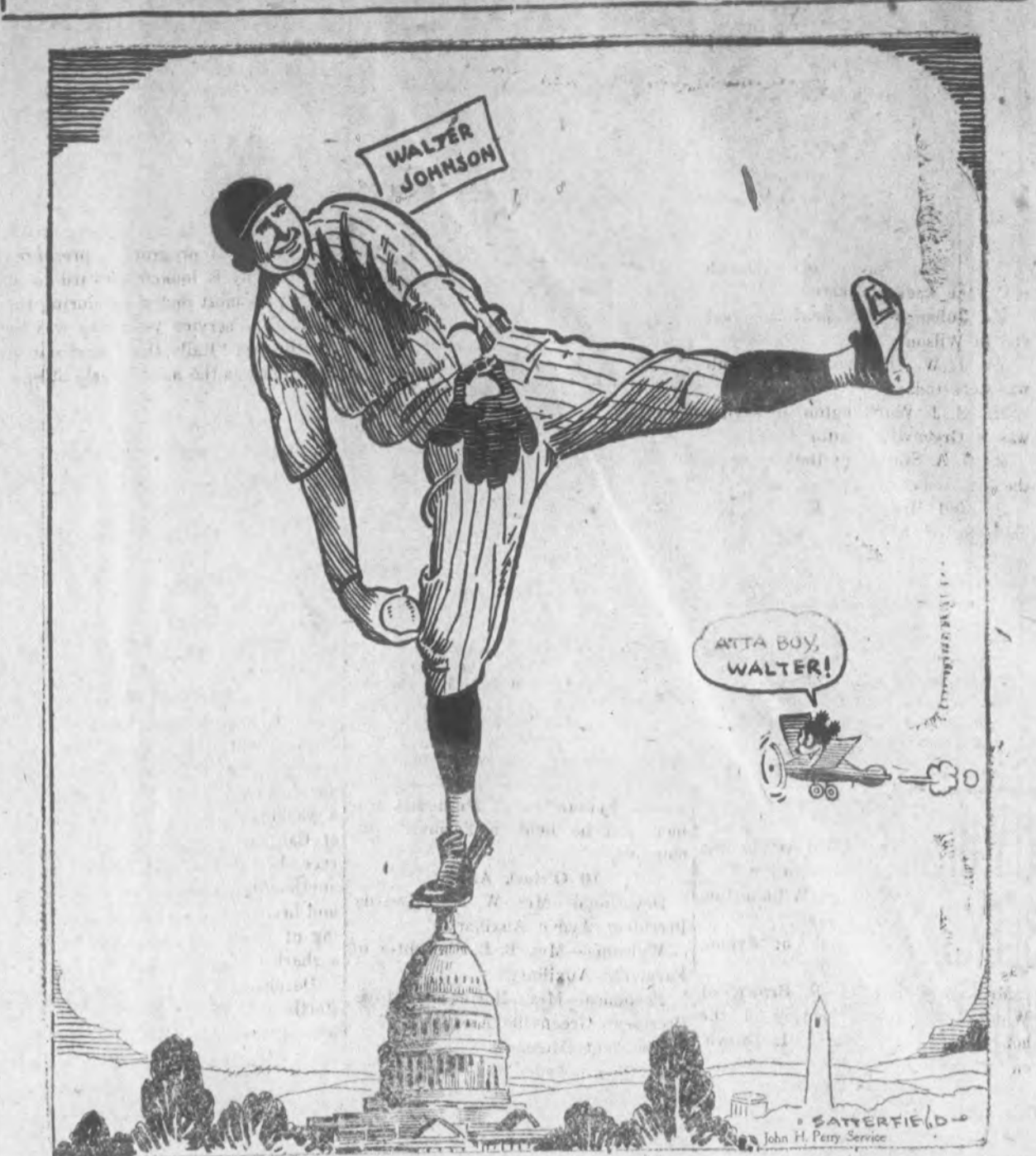

COTTIN LETTER

New Orleans, Oct. 6.—Failure of much rain to occur cotton over the week-end influenced liquidation and a lower market today. The weather map however indicates rather unsettled weather in the interior, probably showers for the southwest, especially Texas. Four addition private crop reports were issued today indicating a yield ranging from 12,400 to 12,025. The average of 10 private reports as to condition is 54.1 and the average 20 private reports as to crop is 12,422 bales.

Liverpool cabled: "Spinners extending time unofficially." Manchester cabled: "Inquiry more extensive but advance in cotton checks business."

In addition to reporting on condition and indicated crop the report on October 8 will make report as to the quantity of cotton ginned to October 1 this year. Ginned to Sept. 16, 2,968,000 vs. estimated 2,400,000. Ginned to Sept. 25 no report vs. 3,236,000. Ginned to Oct. 1, question vs. 3,600,000. Note: Estimates for Sept. 16 and October 1 last year are based on average ginnings per working day. As stated in our previous review an indicated yield of about 12,400,000 has been about discounted. There fore it is likely that if the Government next Wednesday is a production of 15,500,000 or more market will likely decline, perhaps advance if 12,300,000 or less. Prospects are that ginnings will likely be heavy, probably be around 4,000,000 bales, perhaps larger but ginnings at this early in the year is no criterion as to ultimate size of the crop. In 1922 ginnings to October 1 were 4,000,000 but final crop was only 3,720,000 bales. If this crop is to be 2,000,000 larger than last year's ginnings should commence to show much heavier than last season. Next Wednesday report will be released at 10 a. m. New Orleans.

NOTICE

Town of Greenville, North Carolina, Be, and it is hereby ordained by the Board of Aldermen of the Town of Greenville, in regular session assembled on the 2nd day of October 1924:

Section One. That it shall be unlawful for any person, firm or corporation to sell and deliver or deliver coal in the Town of Greenville, without complying with the requirements as hereinafter set out.

Section Two. That all deliveries of coal in bulk, by cart, wagon, truck or vehicle, in less quantity than railroad car load lots, and of a greater quantity than what is commonly known as tub deliveries, shall be accompanied by a bill showing the

gross, tare and net weights of each load delivered.

Section Three. That all deliveries of coal to one party, firm or corporation, in car load lots, shall be governed by railroad weights, which may be accepted in lieu of the requirements of the preceding section of this ordinance.

Section Four. That all tubs or containers used for the deliveries of coal in small quantities, shall be of the bushel unit, and shall have plainly marked thereon, the figure representing the capacity of said tub or container, and that when deliveries are made in said manner, it shall be necessary to furnish weights as required in section two of this ordinance.

Section Five. That any person, firm or corporation, violating this ordinance by failing to have deliveries of coal accompanied by bill showing weights, etc., as hereinbefore set out, or whose delivery at any time in transit or after delivery, shall be found to be fifty pounds short in the said weights as shown on accompanying bill, or who shall fail to comply with the requirements of tub deliveries or who shall use short measure tubs or containers, or otherwise violate this ordinance, shall upon conviction pay a fine of \$50.00 and the cost of the court, together with any incurred in testing weights, containers, etc., for each and every offense.

Section Six. That for the purpose of enforcing this ordinance, the police officers of the Town of Greenville are hereby authorized and given full authority to seize any deliveries of coal in transit, at the coal yards or at point of delivery, and have the driver or party in control thereof, convey same to some convenient weighing scales where both the net and tare weights thereof shall be tested by weighing the loaded conveyance before delivery, and having the unloaded conveyance return and weighed after delivery, and that for the purpose of testing the capacity of tubs or containers, police officers shall have full authority to direct and supervise the measuring of same.

Section Seven. That any person, firm or corporation, failing or refusing to comply with orders received from the police directing the testing of weights or measures, as set out in this ordinance, shall upon conviction, pay a fine of \$50.00 for each and every offense.

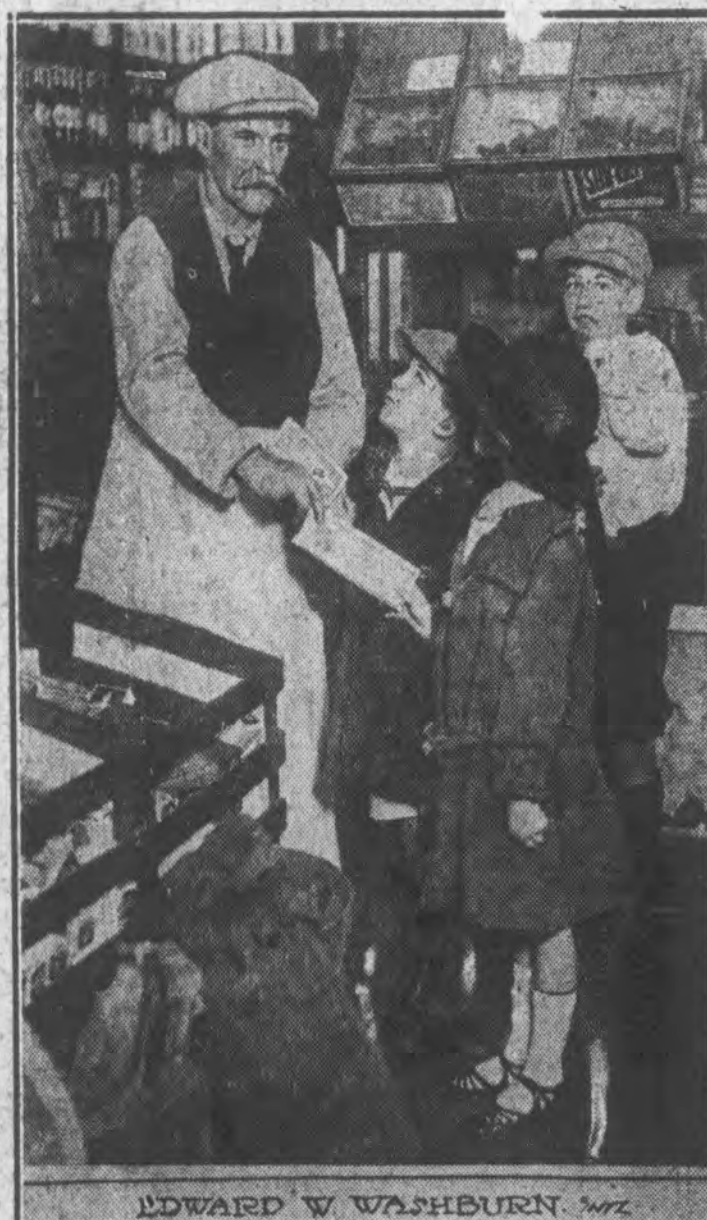
