WORLD SERIES GOES TO SEVENTH GAME

Great Britain To Hold General Election October 29th

WASHINGTON'S VICTORY OVER THE GIANTS AGAIN DEADLOCKS THE SERIES

Zachary Wins Second Victory Over Giants. Score 2 to 1—Final Game of Series Tomorrow.

Washington, Oct. 9.—The World's Series was forced into its seventh game when the Washington Senators today defeated the New York Giants by a score of two to one.

The Giants scored one run in the first frame and held that lead until Peckinpaugh, of the Senators, singled, Ruel sacrificed, the fifth inning when McNeely walked and Harris singled scoring Peckinpaugh and McNeely.

The batteries were: New York—Nehf, Ryan and Gowdy. Washington—Zachary and Ruel.

The game in detail follows:

First Inning. New York—Lindstrom out third to first; Frisch hits to right field for two bases; Zachary took Young's flash and Frisch was run down. Zachary to Bluge to Harris. Young went to second on run down; Kelly singles to center scoring Young; Rice leaped up into air and took Muesel's long drive from the bleachers. One run, two hits, no errors.

Washington—McNeely gets base on balls; Harris forced McNeely out at second; Harris caught off first base; Rice singles to left field; Kelly muffed Goslin's grounder and latter safe on first; Rice going to second base; Judge strikes out. No runs, one hit, one error.

Fourth Inning. New York—Muesel out short to first; Wilson singles to center field; Jackson hit into double play Harris to Peckinpaugh to Judge. No runs, no hits, no errors.

Fifth Inning. New York—Gowdy out short to first; Rice robbed Nehf of a hit by coming up back of first base and catching ball near foul line; Lindstrom out pitcher to first. No runs, no hits, no errors.

Washington—Peckinpaugh singles into left field; Ruel sacrificed pitcher to first; Peckinpaugh going to second; Zachary out at first unassisted; Peckinpaugh going to third base; McNeely gets base on balls; McNeely steals second; Harris singles to right field scoring Peckinpaugh and McNeely; Harris going to second on throw in; Rice strikes out. Two runs, two hits, no errors.

SHENANDOAH WILL MAKE SECOND LEG OF FLIGHT TODAY

Giant Navy Dirigible Makes Successful Trip Lakehurst to Fort Worth in Approximately 34 hours

Fort Worth, Texas, Oct. 9.—The Shenandoah delayed 45 minutes this morning on account of taking on supplies, sailed westward at 9:45 o'clock. The big ship sailed for 20 minutes over Fort Worth and the suburbs before heading west. It is expected that the vessel will reach El Paso at 6 p. m.

Fort Worth, Texas, Oct. 9.—Favorable weather conditions were promised today for the second leg of the transcontinental flight of the big navy dirigible Shenandoah which was moored to her 140 foot mast here last night after a hop from Lakehurst, N. J. This is the first time a dirigible has landed west of the Mississippi.

Today's course is charted along the route of the Texas and Pacific railroads to San Diego, Cal., the route, traversed by the army around the world fliers. The next stage will be the terminus of the history making flight, Camp Lewis, Lake View, Washington. The return will be made over the same route so as to take advantage of the mooring masts here and at San Diego. The jumps measure approximately 1,400 miles.

"The first leg of the flight was unusually successful," Rear Admiral W. A. Moffett, chief of the bureau of Naval Aeronautics, and chief observer on the flight, declared. The ship sailed from Lakehurst, N. J. to Fort Worth in approximately 34 hours arriving about 8 hours ahead of schedule time.

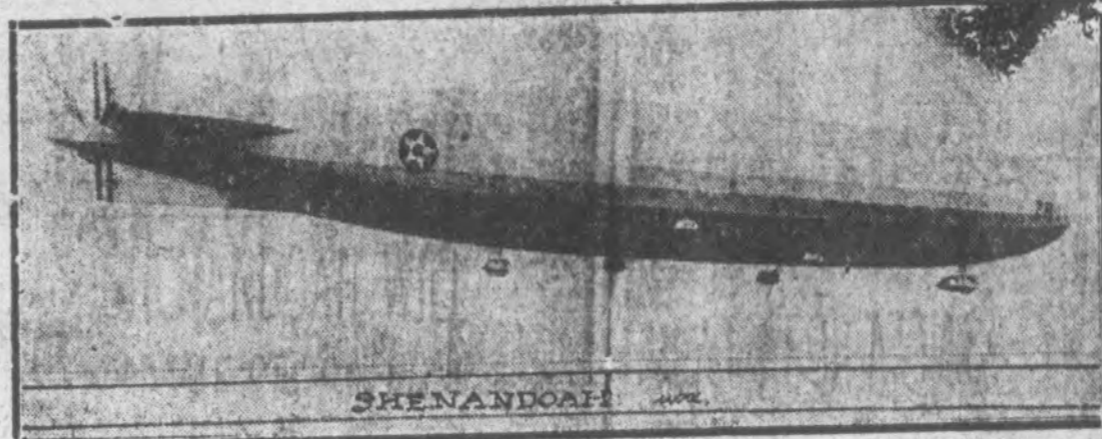

SHENANDOAH SAILS ON HER LONGEST AIR VOYAGE.



The U. S. S. Shenandoah is shown as she left her station in Lakehurst, N. J., on a 7,500-mile voyage to Washington, Atlanta, Fort Worth, the Pacific Coast, Seattle, Wash., and return, the longest flight ever attempted by a dirigible. Admiral W. A. Moffett, head of the navy's air service, was a passenger. The ship, commanded by Commander Zachary Leland, carried a crew of thirty, with 3,000 gallons of gasoline and food for five days.

KING GEORGE ORDERS THE DISSOLUTION OF BRITISH PARLIAMENT

NEGRO BEATEN TO DEATH FOR ATTACK UPON WHITE GIRL

Hundreds of Chicago Police Patrol Districts to Prevent Clash Between Whites and Blacks

Chicago, Oct. 9.—William Bell, 33 years old negro, was beaten to death in a Jewish quarter of the city last night by a band of 200 men and boys attracted by the screams of two young women who said Bell accosted them.

Police reserve seized 20 persons in dispersing the crowd but released all except Otto Epstein, who is accused of striking Bell with a base ball bat. Epstein denied the accusation saying it was he who summoned the police. Several hundred police are patrolling the district today it was stated to prevent a recurrence of the trouble although race feeling was running high recently because of the influx of a great number of negroes into the neighborhood populated by white foreigners.

Epstein was accused by George Bell, brother of the dead negro, and another negro of unprovoked assault upon Will Bell although Miss Betty Greenblatt, 18 years old stenographer, told the police that Bell had spoken to her, been repulsed and then had seized her by the arm and attempted to pull her across the street. Her statement was corroborated by her companion.

In July 1919 clashes between the negroes and whites growing out of the slaying of a negro at a Chicago bathing beach cost upwards of a score of lives.

Quarterback of Trinity College Football Team Able to Leave Hospital

Trinity, Oct. 9.—Ed Bullock, quarterback on Trinity College football team, is again back on the campus after spending two weeks in a local hospital where he underwent treatment for an injured spine and an abrasion of the kidney. Physicians say that he will be unable to play again this season.

Ed Lagerstadt, who was burned on the back by lime on the gridiron in the game with State College, is reported to be rapidly recovering from the burns and it is thought likely that he will be able to play in the game with the University of North Carolina at Chapel Hill on Saturday, October 11.

Strenuous practice has been put upon the Bluedevils for the coming game with Carolina and secret practice has been held several times. Coach Jones stated that he was endeavoring to perfect the playing of his men and that he expected them to show up well next Saturday.

Following Defeat of the Labor Government in House of Commons Premier MacDonald Requests Dissolution; Election October 27

London, Oct. 9.—The House of Commons will be dissolved tonight and a general election will be held on October 29 it was announced this afternoon when King George held a conference and signed a proclamation proroguing parliament.

London, Oct. 9.—King George, waited on by Premier MacDonald this morning following the government's defeat in the House of Commons last night, agreed to the dissolution of Parliament. Premier MacDonald left Buckingham Palace after the audience which began at 10 o'clock had lasted an hour. It was officially announced that the premier had asked the king for a dissolution of Parliament in line with his previous announced policy of appealing to the country through a general election to approve the course pursued by the government.

It is understood that the question of the resignation of the Cabinet did not enter into the discussion at the conference at the palace. In informing representatives of the press after he had left the king that dissolution of Parliament had been decided upon, Premier MacDonald said:

"I am sorry that events have turned out as they have but everyone knows the situation is not one of the governments seeking but has been forced upon it. Personally I should have been very glad if the labor government had been allowed to carry on its policy which I maintain was being carried on in the interest of the commonwealth." The Premier said the government would have preferred to save the country the expense of another general election, but with shrug; of his shoulders added, "That is the situation and there it is."

House of Bishops Episcopal Church Is Now In Session

New York, Oct. 9.—The election of a Bishop for northern Texas and Nevada and Suffragan Bishop for Hankow, China, will occupy today the attention of the House of Bishops of the Protestant Episcopal Church in session here.

There will be a joint meeting of the Bishops with the National Council of the church to discuss other affairs for the coming three years.

With 90 Bishops from all parts of the country in attendance, the House yesterday voted 43 to 45 against the proposal to elect a new Bishop for Mexico at this time.

Fire Cautions

- 1. DO NOT allow children to play with matches. Teach them the danger of playing with fire.
2. DO NOT throw lighted matches, cigars and cigarettes into waste-paper baskets. Do not use a match to light your way into dark closets or cellars. Use a flashlight.
3. DO NOT fill a lighted lamp with oil, or use oil to kindle a fire.
4. If you must use gasoline for cleaning, take it out of doors. Do not hang garments that have been cleaned with gasoline near an open fire to dry.
5. USE METAL CANS for hot ashes, and do not empty them near a fence or wooden house. See State law.
6. PROTECT all woodwork under and around stoves with metal.
7. AVOID hanging lace curtains and other draperies near gas-jets.
8. DO NOT place lamps or candles near draperies or curtains.
9. Permit only experienced persons to install or repair electric fittings and appliances. See State law. Turn off current after using electric pressing iron or curling iron.
10. Instead of wax candles, use small colored electric bulbs to light the Christmas tree.
11. BE CAREFUL in the use of articles made of celluloid, pyralin, fiberloid and similar materials.
12. PLACE A SCREEN before an open fire. Children are thoughtless about passing near fires in outing nighties and light skirts.
13. DO NOT LET RUBBISH ACCUMULATE on your premises.
14. READ THE STATE LAW in regard to setting fire to grass, brush, and woodlands; also the law in reference to camp fires.

MUCH NEW BUSINESS BEFORE SUPREME COURT THIS WINTER

Washington, Oct. 7.—The Supreme Court began its new term yesterday, extending into next June, facing an accumulation of 700 cases, or 115 more than it found on reconvening a year ago.

Fortunately for the court in its desire to reduce the number of cases on the docket, more than one-half of those filed during the recess are motions for writs of certiorari in unimportant issues which will be quietly dealt with as soon as the court can consider them.

When the last term adjourned the court had under advisement 27 cases fully submitted and ready for decision. In these opinions may be expected early during the new term.

To economize in time the court, upon assembling abandoned its ancient custom of adjourning to call upon the President to settle down to business. Its visit to the White House will be made out of office hours.

To end as far as possible the practice of keeping cases on the docket merely to prevent final adjustment of controversies, the court will enforce a new rule under which cases passed at the request of counsel, when reached for argument, will not be reinstated for consideration at the same term except by order of the court after a showing has been made under oath of good cause.

A material change is noted in the character of the business coming up. Not long ago the most important cases to reach the court were brought under the anti-trust laws. These gave way to railroad reorganizations and labor disputes, followed last term by prohibition and Japanese immigration. Now questions arising out of recent congressional investigations promise to occupy the center of the stage. Already the government has appealed the M. authority of a congressional committee to compel the production of bank S. Daugherty case challenging the books and records.

Another phase of the controverted power of Congress to delve into the accounts of business concerns is before the court in three cases in which the Federal Trade Commission acting under a resolution of the Senate, sought to compel Baltimore grain houses to furnish data desired in connection

with the formulation of a policy to aid wheat farmers. In the Claire Furnace case the court will determine to what extent manufacturers and others can be compelled to make reports which would disclose their business secrets. In all of these the lower federal courts decided against the government.

An important case involving congressional authority probably will reach the court in the appeal of the proceedings instituted against Harry F. Sinclair, voted by the Senate to be in contempt for his refusal to answer questions, while a witness before the oil committee. It is expected that during the term cases now pending in the federal courts of Montana and California for the recovery of naval oil reserves leased by Secretaries Fall and Denby to the Sinclair and Doheny interests also will reach the court.

Among the more important cases under advisement, in which decisions may be expected at an early day, are those contesting the constitutionality of New York and Ohio statutes imposing a franchise tax upon outside corporations doing business in those states; the right of prohibition agents to stop and search automobiles without a search warrant, in a case from Detroit; the validity of the New York criminal anarchy law raised by Benjamin Gitlow, who was convicted under it, and who now is vice-president

of the communist workers party; the right to take property in the hands of the Alien Property Custodian to satisfy judgments; the right of strikers to jury trial when charged with contempt of court, and the right to compel bankrupts to disclose concealed assets in a case against Jules W. (Nicky) Arnstein.

On the original dockets are a number of boundary disputes, including those between Arkansas and Tennessee, New Mexico and Texas, New Mexico and Colorado, and between Michigan and Wisconsin. Massachusetts has pending a claim to land in Rochester, N. Y.; New York and New Jersey separately have attacked the federal water power act.

The right of the President to pardon in contempt cases is challenged in an appeal brought from Chicago by Phillip Grossman. Wisconsin joined by other states on the Great Lakes, would restrict the amount of water which the Chicago Sanitary District may take from Lake Michigan, but that controversy is likely to be decided in the appeal now pending of the case which the federal government won in the lower courts.

On the appellate docket, cases awaiting consideration include whether railroad employees can be prosecuted for delaying the mails and obstructing in-

terstate commerce when they go on strike, coming from California, where Atchison, Topeka and Santa Fe employees refused to move trains during the shopmen's strike of 1922; whether the ship owners association of the Pacific Coast and the Pacific American Steamship Association are unlawful monopolies because of rules relating to the employment of seamen; the validity of the compulsory education law of Oregon requiring children to attend public schools; the right of the federal government to examine records of banks in connection with the enforcement of the income tax law; the validity of Pennsylvania's tax on anthracite coal, and whether Henry Ford owes 11,000,000 as royalty to an inventor of magnetos.

Others involve the authority of the Interstate Commerce Commission to fix tentative valuation of railroads; the right of Japanese in California to purchase agricultural land to be held in trust for their children born in this country; the validity of Milwaukee's minimum scale wage as applied to city employees; the liability of the city manager for plan for Cleveland, Ohio; the jurisdiction of federal courts in admitting aliens; the obligation of railroads to adopt improved mechanical devices; the right of states to impose inheritance, estate and income taxes under certain conditions; the jurisdiction of the Interstate Commerce Com-

mission over interurban electric railways, and a large number of other cases.

Missouri Ready to Open \$4,500,000 New Capitol

Jefferson City, Mo., Oct. 7.—The largest crowd of distinguished American and native Missourians that has ever been seen at a public gathering in Missouri is expected to come here Oct. 6, to attend the formal dedication of the new Missouri state capitol building.

Governors of eight states at least will be present to make addresses, as well as four former governors of Missouri. Parades, speeches, band concerts, a gigantic historical pageant and a fireworks display on the Missouri river will make up the program.

The main feature will be the pageant. More than 1,000 participants will depict the history and growth of Missouri. Each epoch will be presided over by the wife of the governor who served during the period of the new building's construction.

The new capitol was built at a cost of approximately \$4,500,000

and was constructed of Southwest Missouri marble and limestone. It was erected to replace the structure destroyed by fire February 5, 1911. Actual work began May 6, 1913, and ended September 8, 1917. Since that time, however, much additional work has been done.

The building covers three acres, has 500,000 feet of floor space, is

Moscow, Oct. 9.—The International Malaria commission of the League of Nations, which has been visiting Russia to investigate the

malaria epidemic, has completed its work and approved generally the efforts of the Russians to combat the disease.

One of the commissioners said recently that the epidemic seems to have passed in most of the affected areas, but there are a number of localities where it still prevails due to the shortage of quinine.

MR. COOLIDGE'S CULPABILITY

The principal defense made in behalf of candidate Coolidge is that the scandals and known corruption which have disgraced the Republican national administration took place in the early part of the administration before Mr. Coolidge became president. The refrain of the Republican defense chorus has been: "Blame it on Harding."

It is admitted however that Mr. Coolidge was a member of Mr. Harding's cabinet, and that the naval oil transfer was discussed at cabinet meetings. It is a matter of record that as presiding officer of the Senate Vice-president Coolidge listened to discussions of the Newberry case, and the naval oil scandals; that the exposure of Slomp was made on the floor of the House long before his appointment as Secretary to the President was made by Mr. Coolidge. It is a matter of record that President Coolidge retained in his cabinet Secretary Denby and Attorney-General Daugherty long after the United States Senate and public opinion had demanded their expulsion; that he retained assistant Secretary of the Navy Roosevelt, the lightfooted messenger boy of Secretary Fall in connection with the transfer of the naval oil lands to Mr. Fall's Department, and who testified that he approved all that Secretary Denby had done in the matter, until Mr. Roosevelt's nomination as the Republican candidate for Governor of New York. He still retains Slomp. He long maintained political and social relations with Edward B. McLean who became the voluntary "goat" for Fall. The henchmen of Daugherty are still in the De-

partment of Justice; the henchmen of Forbes are still in the Veterans Bureau; the henchmen of Fall are still in the Interior Department, and Admiral Robison who was active in the naval oil transfer is slated for promotion. Neither as Vice-president nor as President, nor as a candidate has Mr. Coolidge ever uttered a word in condemnation or denunciation of any of these people or their acts. To what extent then can he be justly charged with culpability. Let a dispassionate, unbiased writer, who will be accepted by a great many people as competent to deal with the logic and the ethics of the situation, say: In his book "The Contract," Hilaire Belloc says: "A man does not go in for professional politics without some idea of advantage to himself. He desires to be talked about or to have power, even if he does not desire to purloin public money. He cannot see what goes on around him as a member of these little political oligarchies without denouncing their corruption, or winking at it. If he denounces it, he cannot long remain a member of the assembly he thus betrays. If he winks at it he is a partner in the guilt of his fellows."

Mr. Belloc's further comment would seem to apply to Mr. Coolidge's cabinet associations and the retention of certain members in his own cabinet. Mr. Belloc continues: "I say that men who associate with and tolerate the corruption of their fellows are in an absurd position when they protest their private innocence of a public evil which they have shamefully condoned. They must have known its effect upon the state. It was their duty as patriots to prevent it and to punish it."

If candidate Coolidge and his supporters can get any consolation out of this relentless logic they are welcome to it.

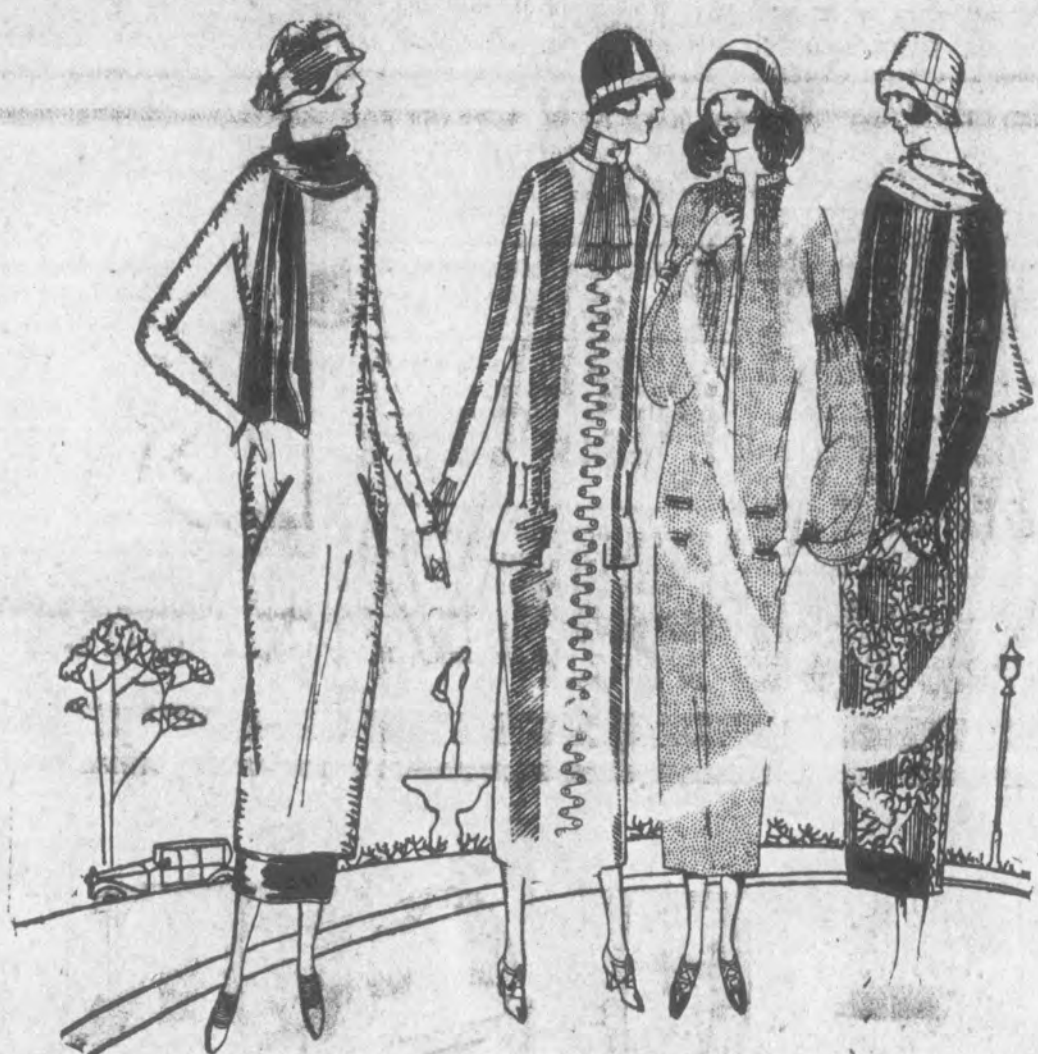

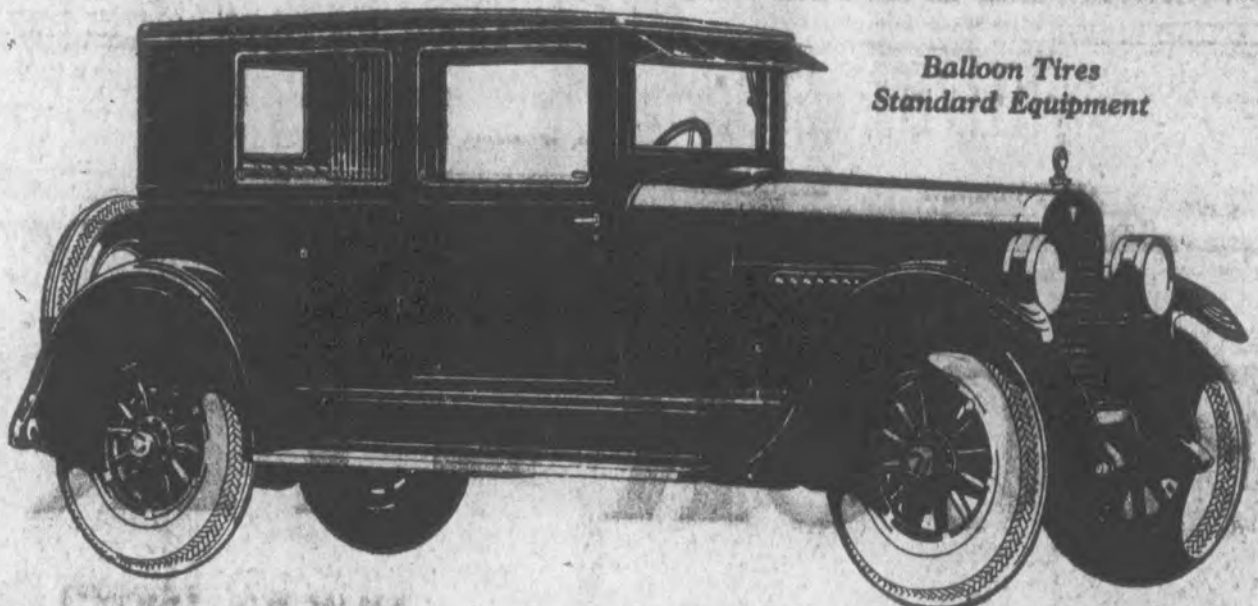
