LEW DOCKSTADER FAMOUS MINSTREL DIED YESTERDAY

Veteran Minstrel Succumbs After A Two Year's Illness Caused by Fall

New York, Oct. 27.—Broadway today checked its gay course to mourn for Lew Dockstader famous minstrel and comedian who died yesterday at the home of his daughter Mrs. Warren Palmer. Dockstader's death was the culmination of two year's illness resulting from a fall.

Dockstader who was 68 years old had been on the stage for half a century. Funeral services will be held tomorrow.

A generation or more ago, when many of the sure-fire jokes that are bringing laughs today were young and beardless, the dressing room of Lew Dockstader, world-famous minstrel, was one of the main founts from which the choicest humor flowed, and the big, jovial, rollicking comedian himself—laugh purveyor to the millions—was author as well as distributor of a goodly part.

Dockstader's success was attributed chiefly to his knowledge of what the public wanted in the way of amusement, and his ability to meet the demand. In early life he became a student of the lighter side of human nature, and for years kept a mental ledger in which his most successful quips were catalogued.

Jokes about the Ark, Jonah, Congress and Hoboken were always sure of a laugh, he once said, because the public liked a new joke on an old subject better than an old joke on a new subject. An old joke was easier to "get over," he maintained, "because the audience knew just when to laugh."

Lew Dockstader, whose real name was George Alfred Clapp, was born in Hartford, Conn., August 7, 1856. He learned to play several musical instruments in his boyhood, and for 17 years was a member of an amateur minstrel band before making his professional debut. In 1873 he signed the Earl, Emmett and Wild troupe for a tour of the eastern states, and later transferred to the Bloodgood Comic Alliance of Springfield, Mass.

The following year he joined the Whitmore and Clark minstrels, and after a tour lasting several months, made his way to San Francisco, where he appeared in a song and dance skit at the new Adelphi Theater, under the management of Cogill and Cooper. The famous old song, "Peter, You're in Luck this Morning," was one of his own choosing, and made Dockstader the headliner.

Joining Sargents Minstrels, he returned to New York and formed a partnership with Charles Dockstader, who, despite the name, was no relation of Lew. The Charles and Lew Dockstader Minstrels prospered for a time, but were disbanded when Charles became ill and was forced to retire. Lew Dockstader immediately formed another company, and for the first time became sole owner of his own attraction. He was 22 years old at the time.

DECLARES SLUSH FUND \$16,000,000

Walsh States That Further Investigations Reveal Greater Total Than First Estimated

New York, Oct. 27.—Frank P. Walsh, chief counsel for Senator Robert M. LaFollette, who appeared before the Senate campaign fund investigation, at an Independent rally here last night declared the Republican party was raising a slush fund of at least \$16,000,000 to elect Coolidge and Dawes. At the time the first statement was made regarding the slush fund by LaFollette it was estimated to be between \$4,000,000 and \$5,000,000. At that time the surface of the investigation had scarcely been scratched, declared Walsh and it now appears that his former estimates of \$10,000,000 to \$12,000,000 would not cover the total.

American Bottlers Carbonated Beverages to Hold Convention

Statesville, Oct. 27.—North Carolina will be well represented by a large delegation at the annual convention of the American Bottlers of Carbonated Beverages to be held in Louisville, Kentucky, during November 10 through 14, it has been announced here. The delegation will be headed by Frank L. Johnson of this city, who is a member of the national executive board and secretary of the North Carolina Association.

Chester Brown, of Asheville, president of the state association of bottlers, is assisting Mr. Johnson in the arranging of the trip. A number of the delegates are planning to make the trip by motor while many will go by train for which special rates have been made. On the return trip, the delegates will stop over in Asheville where they will be entertained at luncheon, and at several other functions.

Fire Causes Half Million Damages

Rochester, N. Y., Oct. 27.—Fire today caused damage of \$500,000 to the plant of the American Laundry 1903, when Dockstader again became Machinery Company here. Firemen sole proprietor of the aggregation, fought the flames for more than three hours. Since that time he has been continuously upon the stage, either as owner of a minstrel troupe or as a single attraction.

U. S. TROOPS ARE LANDED IN CHINA

DAVIS PREPARING FOR LAST ADDRESS

Democratic Nominee Will Close Campaign in New York Saturday

New York 27.—Entering upon the final lap of his race for the presidency John W. Davis, Democratic nominee, worked today at his home at Locust Valley, preparing his wind-up address scheduled to be delivered Saturday night in Carnegie Hall. He contemplates making a general restatement of the campaign issues at this meeting and the drafting of the speech for that occasion is requiring painstaking care. At no time since Mr. Davis prepared his speech of acceptance delivered at Clarksburg, W. Va., has given himself over completely to the task of speech writing. His work today will be interrupted only by the engagement which is to take him tonight to Jersey City for an address there.

Mr. Davis has been requested to speak regarding his attitude toward labor and a contrast of the records of the Democratic and Republican legislative bodies in labor matters. Reference to Senator LaFollette's offer to labor also has been suggested for inclusion tonight in the Jersey City remarks. Mr. and Mrs. John Stator of Bethel were here today.

Raleigh, Oct. 27.—With a full ticket nominated by both Republican and Democratic parties and with voters brought out by the active campaigning made in behalf of the Port Commission Bill, prospect for a heavy vote at the election on November 4, were seen here today. The state, however, is normally Democratic and nomination on that ticket is usually equivalent to election. In addition to the active campaign made for the Port Commission Bill, both candidates for governor, Angus W. McLean, former Chairman of the War Finance Corporation, and Isaac Meekins, Republican, and former attorney for the alien property custodian, have made exceedingly active campaigns. Besides the gubernatorial candidates, a number of others have made active campaigns throughout the state. The candidates on the two tickets are: Democrats: Governor Angus W. McLean; Lieutenant-Governor, J. Elmer Long; State Auditor, Baxter Durham; Secretary of State, W. N. Everett; Attorney-General, Dennis Brummit; Commissioner of Agriculture, W. A. GOV. MORRISON TO SPEAK HERE NEXT WEDNESDAY NIGHT

Will Deliver Address in Court House at Eight O'clock in Advocacy of Port Terminal Bill

Governor Cameron Morrison and Mrs. Morrison will come to Greenville Wednesday afternoon and the governor will speak to the public in the court house at 8:00 that night.

The governor is convinced that North Carolina's Commerce is unfairly burdened with discriminatory freight rates. He has thrown his great force into a campaign to secure for the people of his state the same fair rates enjoyed by the other states. Laboring with him to accomplish this object are Senators F. M. Simmons and Lee S. Overman, Hon. J. W. Bailey, Dr. J. Y. Joyner, Dr. E. C. Brooks, Hon. C. L. Abernethy, Dr. E. C. Branson, General Albert L. Cox, Ex-Judge W. S. D.B. Roberson, Mayor George Butler, Hon. R. O. Everett, Mr. W. A. Hart, and others. These are wise leaders, of sane and safe thought, and they too are convinced that fair freight rates, saving millions of dollars annually to the people of this state, can be had by the adoption of the proposed port terminals and water transportation act.

PROHIBITION NAVY SCATTERS RUM ROW

Cutter Tampa's Operations During Week Results in Eight Prizes and Score of Prisoners

Boston, Mass., Oct. 27.—Rum rows off Cape Cod and Cape Anne were scattered today as the result of their first major engagement with the prohibition enforcement navy and eight prizes were tied up at docks here, at Gloucester and New London, Conn., and more than a score were prisoners.

The coast guard cutter Tampa yesterday brought to the Boston harbor the New Foundland two masted schooner Marjorie E. Bachman, rum laden and five American motor boats. Another motor boat was taken to Gloucester and one to New London. The eight prizes and their crews and contraband liquors valued at \$100,000 represented a week's operations of the Tampa assisted by several fast rum chasers off Black Island, Cape Cod and Cape Anne. The captured vessels were taken in a running battle Friday in which the Tampa used its three inch guns in pursuit of the scattering rum fleet for more than an hour 27 miles off the coast at a point halfway between Capes Cod and Anne. The officers said none of the rum vessels returned the coast guard cutter's fire.

Philadelphia Resumes Fight Against Vice

Philadelphia, Oct. 27.—Ninety-three raids of alleged disorderly houses and gambling establishments and speak easies over the week-end netted approximately 1,000 prisoners. The majority of those arrested were discharged and the alleged proprietors were held in bail for court. Charges for drunkenness were lodged against 406 prisoners. Directors of Public Safety, Butler said the raids marked the resumption of the week-long round-ups of suspicious characters.

MRS. BECKWITH CONDUCTS Y. W. C. A. SERVICES AT COLLEGE SUNDAY EVENING

Mrs. Beckwith conducted the Y. W. C. A. service at East Carolina Teachers College Sunday evening. A brief review of certain portions of the Bible used at different stages of the individual's development were given. She urged the young women to read and carefully study the scriptures and apply it to every day life. She stated that it is by getting control of the mind and body under God's guidance that every person can be of greatest service to humanity. "Do not be satisfied until the best is given God, for He requires interest on every talent." The special music was a vocal solo by Miss Helen Mattocks.

FUNERAL SERVICES SECY. WALLACE WERE HELD TODAY

Government Pays Last Respects to Cabinet Member Who Died Saturday Night

Washington, Oct. 27.—Funeral services for Henry C. Wallace, Secretary of Agriculture since 1921, were held today in the East Room of the White House where government officials including President and Mrs. Coolidge gathered with foreign diplomats and friends of the family to pay their last respects. The services today also represented the governmental official tribute to the late cabinet member and government offices were closed until 1 p. m.

Immediate members of the family were here for the services including Mrs. Wallace, her two daughters and three sons. Another daughter is abroad. Secretaries Mellon, Weeks, Wilbur, Davis, and Work, Attorney General Stone, Postmaster General New and Assistant Secretary of Agriculture Gore served as honorary pall bearers. The active pall bearers were selected from officials of the Agriculture Department.

The funeral services were conducted by Dr. Wallace Radcliffe, pastor emeritus of New York Avenue Presbyterian Church here. He was assisted by the pastor of the church Reverend C. E. Hawthorne.

The body will be taken to Des Moines, Iowa, Wallace's home, for burial the funeral party leaving Washington at 3:30 this afternoon. Beside members of the family the body will be accompanied by Secretary Work, designed as personal representative of President Coolidge, Acting Secretary Gore, Major James P. Coughlin and Mr. Joel T. Boone, White House physicians.

Roosevelt's Birthday and "Navy Day" Will Be Observed Tuesday

Washington, Oct. 27.—The purpose of the American navy and its record during the course of the nation's history will be carried to the most isolated corner of Continental United States tomorrow in the double observance of the birthday of the late President Roosevelt, and of "Navy Day."

With more than 1,000,000 active workers enrolled and radio broadcasting facilities pressed into service Navy League officials declared today the celebration would be more universally observed than since its institution. While there will be ceremonies at tombs of naval heroes, it was emphasized that the basic purpose was to commemorate the service, rather than to in any way stress the navy's part in national defense.

The American Legion, Veterans of Foreign Wars, Daughters of the American Revolution and Daughters of 1812, with scores of civilian organizations have co-operated actively in the plans.

Parades and memorial ceremonials will be staged in many cities, while naval units will keep "open house" in every port. The fleets on either coast have been distributed in the larger marine cities, with orders to officers in charge to receive the public as special guests, affording every opportunity for personal inspection of the ship and her equipment.

Definite programs have been arranged in 19200 localities, according to preliminary reports to the League, the ceremonies having special formality in Washington, New York City, Boston, Philadelphia, Charleston, S. C., Galveston, Little Rock, Chicago San Francisco, Los Angeles Portland, Seattle and San Diego. As in the past, notice has been given that most of the Central and South American admiralties will utilize the occasion to decorate American graves and monuments within their jurisdiction.

Florida Man Is Killed By Accident

Ocala, Fla., Oct. 27.—C. B. Root, of Crystal River, died in a hospital here yesterday from an accidental gun shot wound received when his pistol fell from the sea to the floor of his automobile and was discharged.

ern Sugar Company and the Spreckles Beet Sugar Company of California, was a delegate; C. W. Waterman, counsel for the Great Western Sugar Company and candidate for the U. S. Senate from Colorado, was a delegate-at-large from Colorado; Wm. V. Hedges, counsel for the Holly Beet Sugar Company, and treasurer of the Republican National Committee; William L. Petrikin, President of the Great Western Company, and H. C. Giese, superintendent of one of that concern's factories, were delegates from Colorado; Charles B. Warren, president of the Michigan Sugar Company and the Toledo Sugar Company, was a delegate from Michigan and chairman of the Committee on Resolutions which wrote this year's Republican platform; Joseph W. Fordney, co-author of the Fordney-McCumber Act, which put the present heavy tariff on sugar; William H. Wallace, vice-president of the Michigan and Toledo companies, and Gerrit J. Diekema, president of the Holland-St. Louis Sugar Company, were delegates-at-large from Michigan; Senator Smoot, E. O. Howard, director of the Utah-Idaho Sugar Company, and Arthur Wooley, an employe of that corporation, were delegates-at-large from Utah. Clarence H. Cook, of the firm of Castle & Cook, agents for various Hawaiian sugar interests, was a delegate from Hawaii.

While the Tariff Commission was studying the effect of the duty on sugar on the retail price, William V. Hodges, Treasurer of the Republican National Committee, appeared in his capacity as general counsel for the Holly Sugar Company and filed a brief opposing any reduction. Within six weeks after the Republican convention, the Tariff Commission recommended to President Coolidge a decrease of slightly more than half a cent a pound in the tax. Since July 20 this recommendation has been before him, but he has taken no action. Only a few days ago it was announced at the White House that the President had postponed consideration of the Tariff Commission's recommendation until after election.

The saving to consumers through the decrease in the duty on sugar, if the President had followed the Tariff Commission's recommendation, would have been about \$145,000 a day since August 1, or about \$11,000,000 from that date to October 20. His failure to make this reduction has been worth that much, or at the rate of \$53,000,000 a year—to the Beet Sugar Interests. In the light of these facts the activity of the representatives of these interests at the Republican convention and their contributions to the Republican campaign fund are pretty generally understood.

## CONTRIBUTIONS TO G. O. P. WAR CHEST

William Wrigley, of Chicago, donor of \$25,000 to the Coolidge campaign fund, Ikie A. E. Carlton, who gave \$10,000, and William V. Hodges, Treasurer of the Republican National Committee, has a selfish interest in continuing the tariff of approximately two cents a pound on sugar. Wrigley is the principal owner of the Gunnison Valley Sugar Company, which he and his associates purchased last April, just about the time the U. S. Tariff Commission was concluding its investigation of the Republican duty on sugar.

In addition to his gift of \$25,000 to the campaign this year, Wrigley contributed heavily to the extinction of the Republican National Committee's deficit of several hundred thousand dollars last year. He is now to be a beneficiary not only of the removal of the tax on chewing gum—through which chewing gum manufacturers saved over a million dollars a year—but also of the tariff on sugar. This tax on chewing gum was eliminated by the Republican Congress in 1921, immediately after the Harding-Coolidge administration came into power.

The Gunnison Valley Sugar Company operates a factory at Gunnison, Sanpete County, Utah (Senator Smoot's State). This plant has a slicing capacity of 800 tons of beets daily. This year it had contracts for about 5,000 acres of beets.

Representatives of the Beet Sugar interests have played a large part in the present Republican campaign. Officials of the most powerful beet sugar corporation in the country were conspicuous as delegates and delegates at large at the Republican National Convention in Cleveland last June. John D. 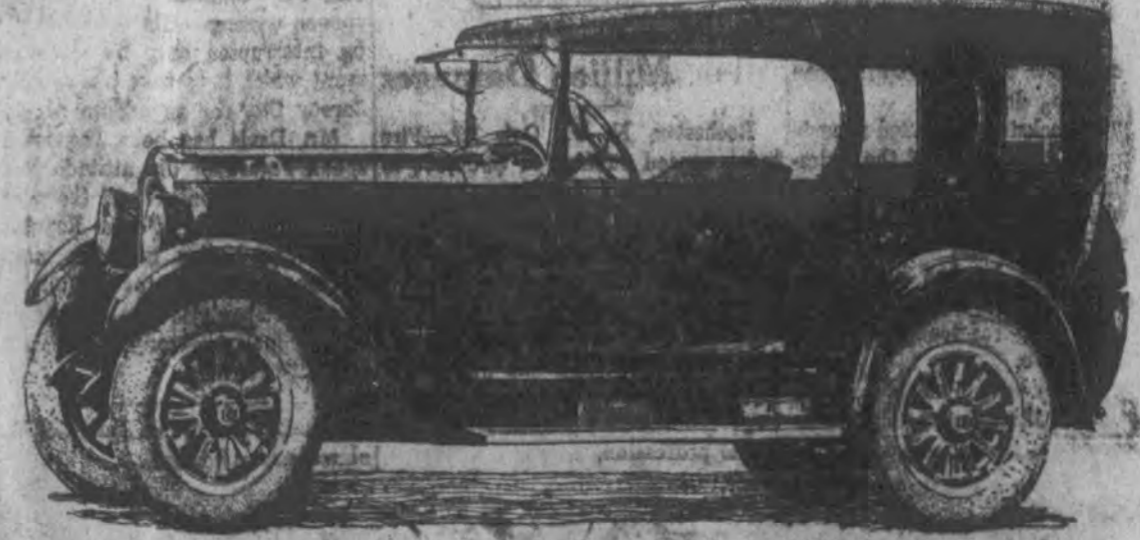

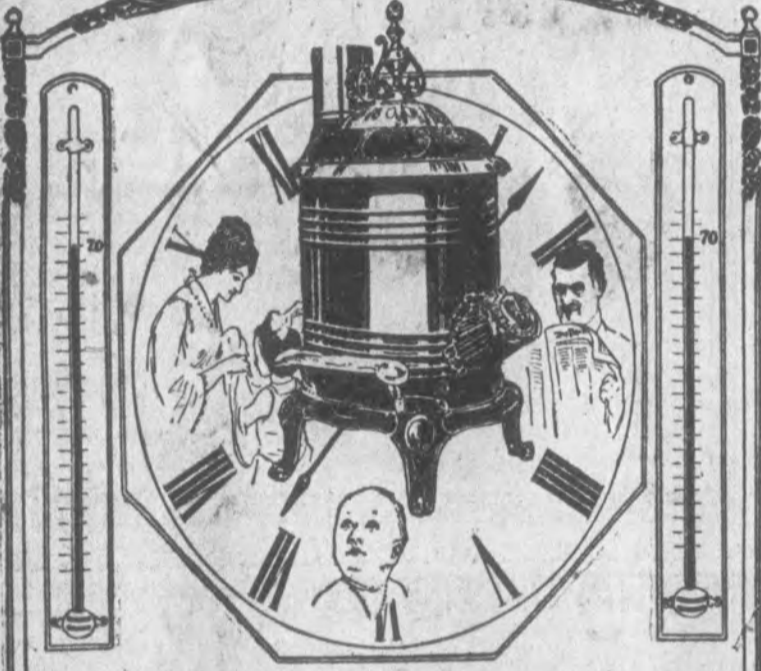
