PARENT TEACHER ASS'N. HOLD MEET DURHAM THIS WEEK

Several Prominent Speakers Included In Program for the Three Days

Durham, Nov. 11.—Parents and teachers from all over the state and a number of educators from other states of the union will be present at the North Carolina Parent-Teacher Association which will be in session here Tuesday, Wednesday and Thursday, according to an announcement made here today by those in charge of the arrangements for the meeting.

Dr. Howard W. Nudd, director of the Public Education Association in New York City, will be the principal speaker of the out of state visitors. His address will mark the opening session Tuesday night in the county court house.

While the opening session will be on Tuesday night, a pre-convention meeting of the Board of managers will be held at 10 a. m. Tuesday in the Chamber of Commerce Committee room.

The formal meeting will be called to order by Mrs. Howard A. Fourshee local chairman, and the invocation will be by Dr. S. J. Porter, pastor of the First Baptist Church of this city. J. M. Manning, mayor of Durham, will deliver the address of welcome and other greetings will be extended by Mrs. W. S. Brogden, Civic Clubs of Durham; F. M. Martin, superintendent of Durham Public Schools; and Mrs. H. A. Fourshee, president of Durham Parent-Teachers Association. The response will be made by Mrs. A. W. Honeycutt, of Hendersonville, for the North Carolina Congress of Mothers and Parent-Teacher Association of the State. A reception at which the Durham Civic Clubs will be hosts will follow the meetings.

Reports will also be had at time from the recording secretary, Mrs. Raymond Binford; executive secretary, Miss Catherine Albertson, treasurer, Mrs. A. A. Kree and auditor, Mrs. J. I. Singletary.

Luncheon will be served at 12:30 at the Durham High School tendered by the local P. T. A.

The afternoon session will be held in the High School and will be featured by a pageant "Our National Strength" directed by Mrs. L. G. Oldham and an address by Miss Daisy Magge on "Parent-Teacher Associations in Churches." Much interest is being manifested in the election of officers that will take place at this session.

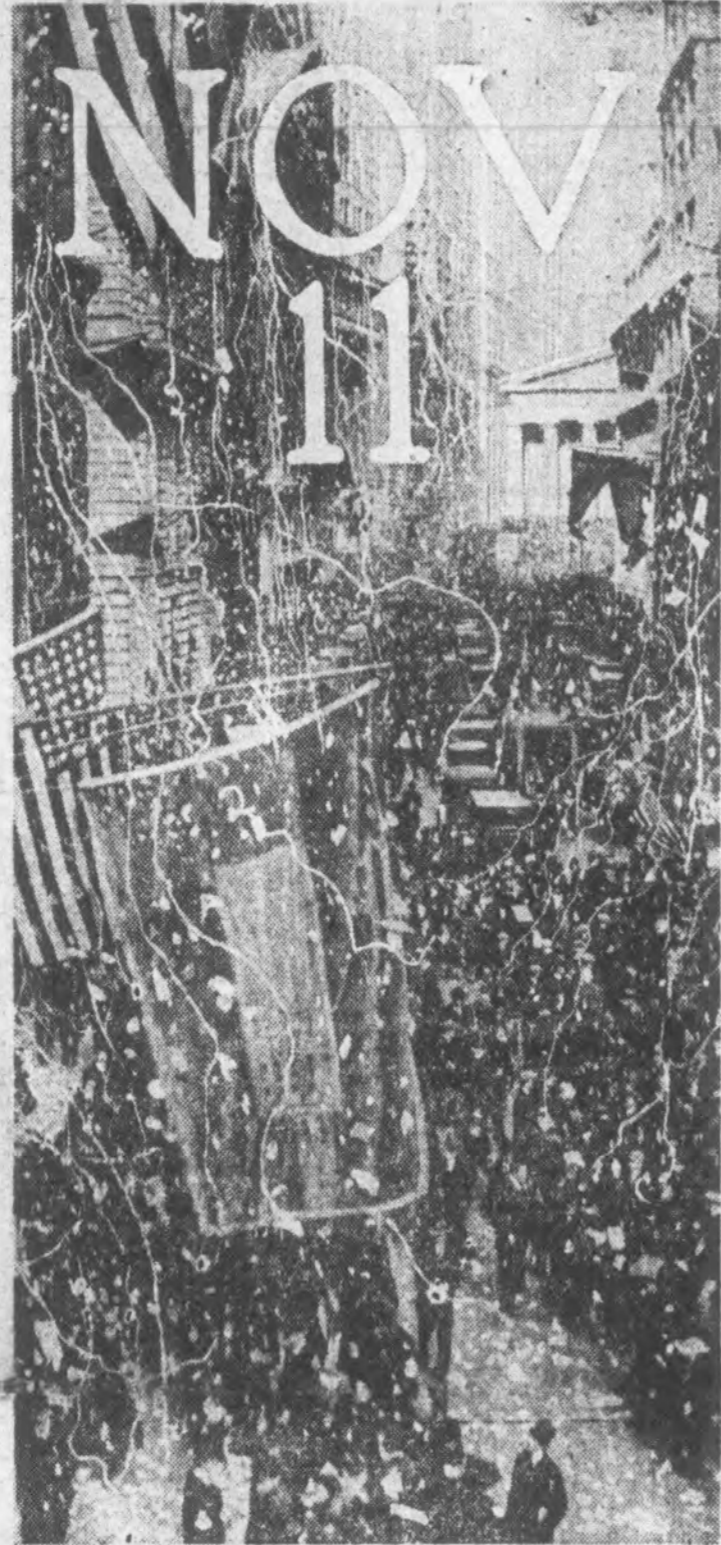

TWO GENERALS URGE PEACE MOVEMENT

Declare Armistice Day Is Time to Establish World Peace in Minds of Americans

Washington, Nov. 10.—Messages from Maj.-Gen. Jas. E. Harbord and John F. O'Ryan urging international co-operation for establishment of peace were made public today by the commission on international justice and good will of the Federated Council of Churches which is offering nationwide observance of Armistice Day tomorrow to further its objectives.

General Harbord, who retired recently from active service and is now head of the Radio Corporation of America, said in his message that the sixth anniversary of the cessation of hostilities should be the occasion for indelibly establishing in the minds of all Americans the wastefulness, horrors and immeasurable destructiveness of wars.

General O'Ryan, war commander of the famous 27th Division of New York, in commending the Armistice Day program declared that for the first time in history the world is organizing for peace and when the organization is complete the world will secure peace.

Dean D. W. Kilgore Scheduled to Speak Washington Nov. 12

Raleigh, Nov. 11.—Dean B. W. Kilgore, director of the North Carolina Experiment Station, will be one of the principal speakers at the thirty-eighth annual convention of the Association of Land-Grant Colleges, to be held in Washington, D. C., during November 12 through 14, it is announced in a program of the convention that has been made public here.

"The Responsibility of Extension Service in Developing a Co-operative Marketing Enterprise" will be the subject of Director Kilgore's address, which he will make on Wednesday, November 12 before the Extension Division of the Section on Agriculture of the Association. The director was instrumental in having the cotton and tobacco associations organized in this state, the program says, having put to good use the actual work as well as influence of the workers in the Extension Division of North Carolina.

Leading educators of the nation including presidents and deans of land-grant colleges of agriculture will attend the convention, the program shows. Director L. O. Schaub of the North Carolina Extension Division will also attend.

The Association of Land-Grant Colleges has a section of agriculture, economics, and engineering and before these bodies special subjects will be discussed, it was explained, while before the general sessions, college presidents and deans will discuss the financial and fiscal policies of land-grant colleges.

ARMISTICE DAY IS BEING CELEBRATED THRU-OUT NATION

Today Marks Sixth Anniversary of the Cessation of Armed Hostilities Between Allied Nations and Imperial German Empire

Raleigh, Nov. 11.—Throughout the length and breadth of the nation Armistice Day will be celebrated today, the sixth anniversary of the cessation of armed hostilities between the Allied Nations and the Imperial German Empire. North Carolina will play her part in that nation-wide observance of the memorable day in 1918 when the sword was sabbered and replaced by the pen.

In the cities, towns and villages and rural districts civilian, soldier, former soldier and Child Star Mothers will gather and take part in planned celebrations. Some will be simple and some will be elaborate but all and each will be enacted with the patriotism that prompted the youth of the nation to go forth to defend democracy in the early days of belligerent 1917.

Raleigh, the capital city, will be one of the leading celebrators of the day. Here plans have been completed for what those in charge say will be the greatest demonstration since the Armistice Day in 1918. Cooperating in the activities of the day and especially in the parade will be the American Legion and the Reserve Officers' Association and the National Guard.

Approximately one thousand children of the Raleigh schools will participate in the parade along with civic organizations.

A concentrated effort will be made on the part of the Reserve Officers' Association in cooperation with Reserve Corps headquarters here to have all former World War officers enter the Reserve Corps by midnight at which time the special privileges of entering without mental examination and with their former rank which has been extended to them by the War Department will terminate. After midnight of Armistice Day, all those who enter the Reserve Corps will be required to take an examination and will be commissioned only as second lieutenants. Reserve Corps headquarters here, under command of Col. James M. Little, will feature Armistice Day extending the former World War officers courtesies of the office for the making an entrance application by letter, phone or wire until midnight.

Grande Voiture North Carolina La Societe 40 Hommes of 8 Chevaux will hold a meeting in Raleigh this afternoon. This meeting will be presided over by Dan W. Terry, Grande Chef de Gare. It will be the first gathering of the executive department since the new administration went into office following the annual convention of the American Legion in Asheville Sept. 1, last.

Durham, Asheville, and Charlotte have planned extensive parades and celebrations in which the Gold Star Mothers will be among the main participants. In these cities and in Raleigh, Greensboro, Winston-Salem and High Point the American Legion is taking part in making the day a success. There will be addresses, social gatherings, get-together meetings and parades.

The gathering of the former soldiers in the rural communities is expected to swell the tide of celebrating citizens of the state well into the thousands.

Negro civilian communities and the former negro soldiers will also have their share in the observing of the day as they had their share in the carrying on of the part that America played in the World War. In Raleigh following the parade, they will be guests at a barbecue at Shaw University while in other towns and communities of the state they will gather to parade, hold meetings and pay tribute to those buddies who went with them to the front but did not come back.

TOBACCO MARKET IS SHOWING STRENGTH

More Than Half Million Pounds Sold Yesterday for Average of About 33 Cents

The Greenville tobacco market has been showing more strength from day to day and yesterday's sales were highly satisfactory to those who brought their offerings here. The market this year has sold from a wider territory than ever before and has made many new and lasting friends.

The sales yesterday totaled about 600,000 pounds and consumed practically the entire day. It was noticeable however, that the market was as strong and prices just as good when the last row was offered to the buyers as was the first row. The average for the day's sales was approximately 33 cents per pound and the farmers were more than pleased.

New Bridge Over Carney Creek Has Been Completed

According to announcement of the Pitt Highway Commission the new bridge over Carney Creek, on the Stokes road has been completed and construction work on the approach to the bridge will be completed within a short time. The new road is now open for traffic and is in good condition for travel there being only a short detour around the bridge. According to the announcement the paving construction on the road will begin early in the spring after the fills in the road have properly settled.

The sand clay road from Bruce to the Wilson county line via Fountain has also been completed and is in excellent condition for travel. At present the county road force is working in Swift Creek township.

Highway engineers stated that all roads in the county were now in excellent condition and every effort will be made to keep them so during the coming winter months.

Judging Contest for Club Boys Be Held Asheville, Nov. 12

Asheville, Nov. 11.—A judging contest for club boys and vocational agricultural students will be held here Wednesday, November 12, in connection with the Annual Meeting of the Livestock Association. This contest, it was explained, is open to any boy or girl who is regularly enrolled in an agricultural club, or vocational agricultural school, except those boys and girls who took part in the club or vocational judging contests at the state fair this year.

Under the plans of the directors, all judging will be on an individual basis and there is no limit to the number of contestants that may enter from any one school or club. Each contestant will be required to place one class of each of the following kinds of stock: beef cattle, dairy cattle, sheep, swine and poultry. The contestants will be allowed fifteen minutes to place each class and ten minutes to write the reasons on each class.

GREENVILLE WILL HOLD ARMISTICE DAY CELEBRATION

Parade of Ex-service Men and Barbecue Dinner Will Be Features of Day's Exercises

Greenville and Pitt County will today take part in the sixth annual celebration of Armistice Day beginning with a parade at 10:30 followed at noon by a barbecue at the Pitt County Fair Grounds and concluding with a foot ball game between the eleven of the Greenville High School and the Tarboro High School.

All business houses in the city will remain closed throughout the day and everyone will take some part in the exercises. The parade which will form on second street below Evans will be participated in by veterans, of all wars together with Boy Scouts, Police Department, School children, Gold Star Mothers, Legion and other auxiliaries and Daughters of the American Revolution and like organizations. Various civic organizations will be represented by floats. The parade will proceed down Evans street to Five Points thence Dickinson Avenue to the Atlantic Coast Line Railroad where it will disband and cars will take all ex-service men to the fair grounds, where a barbecue dinner will be served for them. All service men have been requested to wear their uniforms for the parade but they are wanted in the parade whether or not they wear their uniforms.

It is the hope of the Pitt County Post of the American Legion under whose management the celebration is being staged that everyone will join in making it the best ever held here.

Employers of Deaf Speak in the Highest Terms of Their Work

Raleigh, Nov. 11.—In an effort to remove any prejudice that may exist among employers against the employment of deaf and mute persons, J. M. Robertson, chief of the Bureau for the Deaf of the North Carolina Department of Labor and Printing, has compiled a list of letters from employers of deaf mutes from all over the country, in which they speak in highest of terms of the ability and earnestness of the deaf mutes in their work. Mr. Robertson is sending out letters to employers over the state and enclosing these statements of other employers.


In part Chief Robertson says, "We do not advance the claim that deaf workers are more proficient than hearing ones, but we do insist that they are proving efficiency in many line of endeavors.

"As a general rule, propaganda which seeks to establish superior excellence of deaf workers over those who are in possession of all five senses, is sweetness wasted on the desert air. It is true, nevertheless, that some of the deaf workers are more skillful in a number of occupations than those with the sense of hearing, and that deafness is not always a handicap, in either business or industry.

"Deafness has its compensations as well as its handicaps, and some of the deaf workers are more capable than others, a condition which applies with equal force to the workers who hear. The ratio of efficiency is about the same among the hearing and the deaf, the result being about evenly balanced when the necessity of using the telephone and like considerations are eliminated."

The letters which Mr. Robertson has received from the managers of various kinds of businesses from all over the United States, tell of the efficiency of their deaf and mute workers and recommend them highly. Many managers say that the deaf mute "seems more eager to do his work well and better continuous worker, than do those who hear.

## Employment During October Very Brisk According to Report

Raleigh, Nov. 11.—Employment during the month of October was brisk, according to the monthly report of the State Federal Employment Service issued here today by Director M. L. Shipman, Commissioner of Labor and Printing. During the month of October the Service placed 2,566 men and 733 women in employment, a total of 3,289 the report shows.

Early in October the employment situation improved and continued to increase the brightness of the condition with the exception of a few days around Fair Week, the tabulations show.

As usual unskilled labor led in placements with 1,542. The others were skilled 529; Domestic 613; clerical 199 and industrial 6.

Charlotte led the cities in number of placements with 668 while Wilmington was second with 535 and Asheville third with 633. Other city placements were Greensboro 581, Winston-Salem, 440 and Raleigh 332.

Reports from the various branch offices say that the outlook for the coming month is also good if building of structures and roads continue. It was also expected that work along clerical and sales forces will also increase as the Christmas holidays draw near.

Domestic help continues to be in demand at practically all points and the offices seldom experience any difficulty in placing such class of workers.

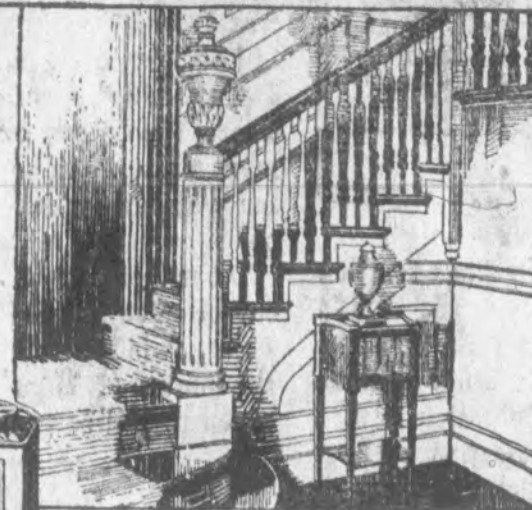

## Armistice Day

Six years ago the din of battles was hushed! Men taxed almost beyond human endurance, laid aside the armament of devastation—glad to return to their families and former occupations.

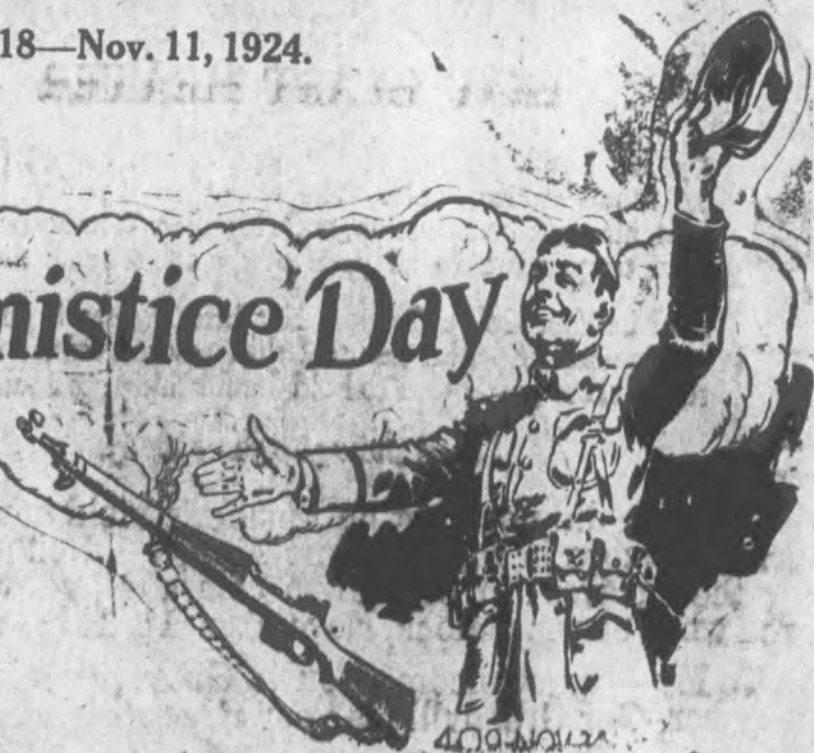

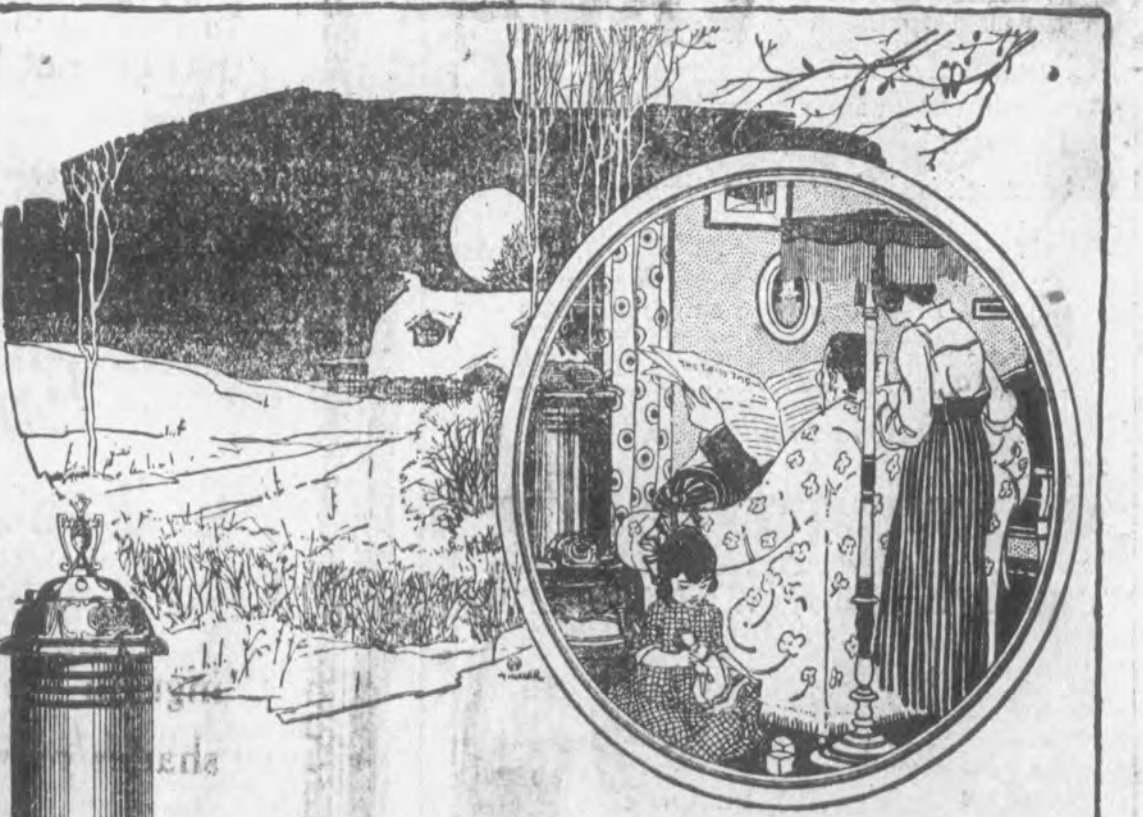
