NORTH EASTERN DISTRICT EDUCATION ASS'N CLOSES A SUCCESSFUL SESSION

Washington Selected As Meeting Place for 1925; Leon R. Meadows Delivers Closing Address; Officers Are Elected For Ensuing Year

The teachers of the North Eastern District selected Washington as the meeting place next year, elected officers for the coming year and adjourned the two day's session today with an address by Leon Meadows of East Carolina Teachers College on the problem of the non-standard teacher.

Mr. Meadows made four definite suggestions for the elimination of the teachers who hold certificates below the standards set by the State of North Carolina for licensing teachers. He thought all of these teachers should be eliminated. He called attention to the fact that the period of preparation necessary for a person to teach children, to minister to the minds, the souls and the bodies of our only real asset, was lower than the standards set for the practice of medicine, for the practice of law or for the practice of any other profession.

Mr. Meadows did not want to see the 2000 non-standard teachers of the state thrown out of work or out of the schools. He believed they should be saved to the profession. He therefore suggested four definite remedies for this situation. These suggestions were:

Do not issue any more non-standard certificates after three years' time. Do not issue non standard high school graduates certificates after this year.

Give high school work for three twelve weeks terms to the non-standard teachers in the state who have as much as 12 credits towards high school graduation, and when a person has completed this work issue them a high school diploma or its equivalent in credits. Create a sufficient number of additional normal schools to train a sufficient supply of teachers able to secure standard certificates.

The Spelling Contest. AUTHORITIES UNABLE TO DETERMINE CAUSE OF JERSEY CITY FIRE

Chief Boyel Announced This Morning That Loss Would Not Exceed \$1,000,000

Jersey City, Nov. 15.—Doubt that the cause of yesterday's million dollar fire in the heart of the industrial section of the city could be determined was expressed today by Chief Roger Boyel. Flames still raged today in the ruins of the 11 story frame structure formerly used by the Atlantic Sugar Refining Company. The blaze spread to this building from the six petre plant of the Batelle and Hanwick Company. Small explosions of acid tubes, in the six-petre plant hampered the firemen all night. Boyel said today the loss would not exceed a million dollars.

Most of the 18 firemen overcome by smoke and fumes had left the hospitals today and the condition of none of them was considered serious. Eighty families driven from their homes the fire, were sheltered in the armory last night by the Red Cross and kindred organizations. Two city blocks were razed by the flames.

PRESIDENT SEES NO NECESSITY FOR SPECIAL SESSION

Declares Tax Question Cannot Be Considered Effectively Until All Data is Available

Washington, Nov. 15.—President Coolidge is convinced that the question of further tax reduction cannot be considered effectively by Congress until all figures for the current fiscal year ending June 30, are available to show the actual amount of reduction possible. In consequence of pressure thus far brought upon the administration to have a special session of the new Congress called immediately after March 4, has failed to alter the opinion that such action is unnecessary and inadvisable unless unforeseen developments bring some other and very urgent reason.

It was made clear at the White House yesterday that the president was not booked as opposing the assembling of the new Congress prior to the first regular session in December 1925 if developments should make an extra session necessary but that he sees no reason now for such a call. He expresses confidence of enactment of necessary farm legislation at the concluding session of the present Congress and is of the opinion that further tax reform as set forth at the time of signing of the tax bill of 1924 should be held up until a scientific basis for such reform has been provided.

COX BOOSTED AS THE NEXT SPEAKER

Conference Endorses Candidacy of Forsyth Representative as the Speaker of Lower House

Winston-Salem, Nov. 15.—At a conference of a number of prominent political leaders from this and other sections of the state here last night it was determined to promote the candidacy of R. M. Cox, Forsyth farmer representative, as the next speaker of the House of Representatives of North Carolina. It was pointed out that Forsyth county has never had a speakership and that the rank and file of the county Democrats was a unit behind Mr. Cox, who has served in live regular and three special sessions of the legislature.

H. G. Connor, Jr., of Wilson, and Clayton Moore, of Martin county, are among the Democratic leaders who are directing the Cox campaign in the eastern part of the state while W. W. Neal, of Marion, and State Senator A. F. Sams, of Forsyth county, are looking after his interests in the western part of the state.

The Dreadnaught Washington Is To Serve As A Target

Philadelphia, Nov. 15.—With the last effort to save her from destruction dismissed by the Supreme Court, the super dreadnaught Washington, three fourths completed, was today towed from the East Philadelphia Navy Yard by five tugs for a point 50 miles off the Virginia Capes where she will serve as a target in naval experiments.

Mrs. Harding's Condition Critical

Marion, Ohio, Nov. 15.—Mrs. Warren G. Harding was holding her own this morning Dr. Carl W. Sawyer said in a bulletin issued from her bedside at 8:15 after a critical night during which she was near death.

Dr. Sawyer's bulletin was as follows: "Mrs. Harding slept very little last night but is holding her own this morning. Heart attack less in severity. Her condition is just about the same as on yesterday."

Presidential Party Week-Ends on Patomac

Washington, Nov. 15.—Despite inclement weather President Coolidge arranged to leave the city late today for a week end trip down the Patomac aboard the Mayflower. He and Mrs. Coolidge have invited presidents of several of the land grant colleges attending the meeting here to accompany them. The guests list also includes Commissioner Blair of the Interior Department.

Officers Capture 120 Gallon Still In Chicod Section

Officer Whitthurst, accompanied by other officers, visited Chicod township Thursday and captured a 120 gallon still in full operation. The officers knowing that they could capture the still in operation hid in the bushes and waited awhile for things to be working nicely. When they approached the still they found it in operation but the operators had "departed for other parts." Upon investigation it was ascertained that a cow bell hanging over the still had warned the operators of the nearness of the officers. The clapper was held in place by a rock with ropes fastened in the bushes and by shaking the bushes the bell made just enough noise to warn the operators without the officers hearing the sound.

The operators evidently thought that they were wise but the officers will in the future know how to handle just such a situation.

The officers captured in addition to the still, 200 pounds of meal and 400 pounds of sugar.

Local Tobacco Market Averages \$ 31.43 During Last Week

The local tobacco market for the week sold 1,827,266 pounds for \$574,815.16 at an average \$31.43. This is the highest weekly average made for the reason. During the season the market sold 21,018,272 for \$5,058,558.97, at an average of \$24.06. This is 2 cents higher than last year's average at this time.

The market continues to show strength and the farmers appear well pleased.

Mistake Made In October's Average Market Corrected

Mr. K. W. Cobb, secretary of the Greenville Tobacco Board of Trade is in receipt of a letter from Mr. Frank Parker, agricultural statistician, stating that due to a slight error a mistake was made in the October report of the Greenville tobacco market's average. The report stated that the average was \$24.97 when it should have been \$26.18. The total sales for October were 8,252,816 pounds which sold for 2,160,909.07, at an average of \$26.18.

Head of Counterfeit Plot Is Arested In Cleveland, Ohio

Cleveland, O., Nov. 15.—J. V. Zettarelli, prominent attorney here, was arrested today by federal agents on a warrant charging possession and publishing counterfeit war savings stamps. He has been the ring leader, according to federal officers, of the Cleveland headquarters in a nationwide plot that has aimed to circulate millions of dollars worth of securities so cleverly forged that even Treasury Department officials were misled by them for months.

DEATHS POISON CIDER TOTAL 11

Another Aged Inmate of Elks National Home Succumbs to Effects of Poisoned Cider

Lynchburg, Va., Nov. 15.—W. C. Baker, retired railroad man of Auburn, N. Y., died last night from effects of poisoned cider served last Monday to aged residents of the B. P. O. E. National Home at Redford. His death brought the list of those who succumbed to the cider, which had been put into a barrel which previously had contained a plant spraying poison, to 11.

Charles Mosby, superintendent of the home, said today that three of the aged Elks are in a precarious condition but the other 11 now ill from the poison were much improved.

"Little Black Satchel" Plays Dual Role in Elk Hill Lease Suit

Los Angeles, Nov. 15.—The "little black satchel" of the Senate oil investigation still loomed prominently on the stage of the government's Elk Hill lease cancellation suit as arguments were resumed in Federal court today but it was playing a double role.

Because it once contained \$100,000 in currency loaned by E. L. Doheny to former Secretary of Interior Albert B. Fall, the little satchel became a symbol of the government's allegation that the leases and contracts it is seeking to cancel were obtained from Fall for Doheny's Pan American Petroleum and Transport Company by conspiracy and fraud.

But yesterday Frank J. Hogan, opening the argument for the defense, dragged the much discussed satchel into court as a battering ram to demolish the government's case. Picturing the friendship between Doheny and Fall during the hardships together as prospectors Hogan pictured the loan as the national symptom felt by the more prosperous later for the less fortunate. The loan was a personal transaction, declared Hogan, impelled by impulses as fine as any that ever actuated a human action.

"Does a bribed official give or send to the briber a promissory note in return for the bribe?" he asked. "Or if the note given by Fall to Doheny was evidence of guilt is there any reason why Doheny should have preserved it when a match from a penny box could have obliterated forever this evidence of the bribe?" Hogan will likely conclude his argument this afternoon.

To Provide Military Service for Women

Washington, Nov. 15.—The War Department has put into motion changes intended, when completed, to give American women a recognized place in the American army in all branches of the military service in case of future emergencies involving maximum effort.

MINISTER'S WIFE IS MORTALLY WOUNDED BY BOOTLEGGERS

Shot Down When She Frustrates Attempt of Mob to Abduct Her Husband

Atlanta, Nov. 15.—Shot as she lay on the ground after firing into a group of men who were attempting to abduct her husband Thursday night at their home in Harroson county, Mrs. Robert Stewart, wife of the "Raiding Parson" of the North Georgia Methodist Conference, died this morning in a hospital here.

Her husband was not at her bedside when she died, having returned to his home in Draketown Friday evening to assist the sheriff in apprehending the men responsible for the attempted abduction ending in the death of his wife.

Mr. Stewart is quoted as saying he recognized five of the men in the attacking party and that he would swear out warrants for their arrests.

Rev. Mr. Stewart is known throughout the community as the "Raiding Parson" as a result of his activities against violations of the prohibition law.

Atlanta, Nov. 15.—Following a relapse early last night Mrs. Robert Stewart, wife of Rev. Robert Stewart, Methodist minister of Draketown, a village near Dallas, Ga., is near death in a hospital here from bullet wounds received Thursday night when she interfered with a band of men who attempted to abduct her husband. Mrs. Stewart is in the hospital paralyzed and is unable to speak. Little hope is held for her recovery.

THOMAS E. COOPER ON WITNESS STAND IN OWN DEFENSE

Prosecution in Case Against Wilmington Bankers Rested Case Yesterday Afternoon

Wilmington, Nov. 15.—The trial of Thomas E. Cooper and Joseph Rourk, president and cashier respectively of the Liberty Savings bank of Wilmington, charged with violating state banking laws by making loans in excess the prescribed per cent of the capital and also making loans when the reserve funds were below the amount required by law, was continued in Superior court before Judge Henry A. Grady here today.

The defense was to make its last stand this morning before rebuttal testimony of the case, the prosecution having rested its case yesterday.

Taking the stand in his own defense yesterday afternoon, Thomas E. Cooper, former president of the Liberty Savings Bank, testified as to conditions leading to the failure of that institution, for which he and J. C. Rourk, former cashier, stand jointly indicted for the violation of the state banking laws.

The state rested its case shortly after noon and W. F. Jones, of defense counsel, immediately moved that the indictment charging the making of excessive loans be stricken out, contending that the state had failed to produce sufficient evidence to warrant this charge.

This motion was over-ruled by Judge Henry A. Grady, as was another by Herbert McClammy, of the defense staff, which aimed at the elimination of certain evidence produced by the state earlier in the trial.

The state's final fling at the two accused bankers was in the form of technical evidence brought out by R. E. Keir, state bank examiner, and S. S. Lawrence, an auditor, aimed at showing the bank made excessive loans when the reserve fund of the institution was below the legal requirements.

The state contended that on a certain day when the reserve fund was short \$14,000 the bank extended a loan of \$3,051.25 to C. W. Las (Continued on page 4).

ADDRESSES FEATURE FRIDAY'S SESSION OF EDUCATION MEETING

N. C. Newbold, Director of Negro Education, A. T. Allen and Dr. T. Alexander, Deliver Informative Addresses On Important Subjects

While North Carolina is doing a great deal for the education of the negroes there is still much left to be done if we live up to the doctrines of equality of educational opportunity for all the children of the state, as provided for in the constitution and as that provision was interpreted by Charles B. Aycock, N. C. Newbold told the teachers at the second annual session of the district meeting of the teachers of the North Eastern District. Mr. Newbold spoke to the teachers on Friday afternoon at the opening session of this convention, which has an attendance of about 1500.

The director of negro education in North Carolina gave statistics showing that great progress had been made during the past four years, and said that North Carolina at the present time was employing more people in the division of negro education than it had in the whole department a few years ago. He cited this together with the growth in the number of negro normal schools, the high schools, and the value of school plants devoted to the education of the negro to show that the state is taking some steps looking towards the education of the negro race.

Mr. Newbold made a plea for the education of the negroes not only for themselves, but also for the good of the state as a whole. He called attention to the fact that the nation judges North Carolina by the total figures in illiteracy in infant mortality in vital statistics, in prevalence of tuberculosis and in many other important ways. Here in the state we segregate the whites and the blacks and congratulate ourselves when the showing for the whites is good. The general public, the national organizations and the federal government, charged with the duty of gathering statistics does not make such a distinction. The result is that when figures are prepared for the nation, North Carolina does not show up well.

Some time ago there was a feeling that when you educated a negro you destroyed a good cook or a good farm hand. Mr. Newbold thought the same thing might be said of whites and Indians as well as of the negroes. That, he did not believe, was sufficient ground on which to refuse to give the negro child the privilege of getting an education. He called attention to the statistics which have been gathered by reliable organizations on the small percentage of educated negroes who have been in trouble which brought them into the courts. Less than one half of one per cent of the total number of criminal cases coming into the courts, come from negroes who have had the opportunity to get an education.

There are still some communities in the state which forget that there is a law which specially provides against the segregation of taxes for public education on the basis of the property values of the different races. Mr. Newbold cited a number of instances in which this was still done in North Carolina. He did not call names, but said he had the information and the data. He made an appeal to the teachers of this district to help wipe out this prejudice.

A. T. Allen Addresses Teachers. We are not offering equality of educational opportunity to all children of the state when we draw a line around a rich district, build fine school houses there, employ fine teachers to teach these schools, and run them eight or nine months, while children just outside this artificial line have to go to a poor school, taught by an untrained teacher, six months in the year, declared A. T. Allen speaking before the second annual session of the North Eastern District teachers meeting at East Carolina Teachers College, in Greenville, on Friday. Mr. Allen renewed the appeal he has made at other meetings of the North Carolina (Continued on page 2)

Education Association for the elimination of strictly district lines, and the establishment of the county unit plan of school organization, and the county wide plan for the support of all the schools in a county.

The appeal was the preface to Mr. Allen's discussion of some of the things he will advocate before the next session of the general assembly. He believes that the state should make plans to help some of the weaker counties through the creation of a larger fund for the equalization of education opportunity.

Mr. Allen does not attempt to suggest where the additional money necessary for doubling the equalizing fund and lengthening the school term shall come from. He believes the legislature can and will work this problem out. He does believe, however, that the state is not only able to furnish these additional months, but we have reached the point in our development now where we cannot afford to spend this money for the children of the state.

Dr. Alexander Addresses Teachers. Teachers in the south do not know what to teach, and they do not know how to teach that which they know, was the rather frank and somewhat startling statement of Dr. Thomas Alexander of Teachers College, New York City, to the teachers who met in Greenville this week for the second session of the North Eastern District Association of teachers.

While North Carolina is somewhat better off so far as teacher training and teaching equipment is concerned than the other states in the south or in the nation for that matter, this state still has much to do before it can claim that it is offering an education to all of the children.

He contrasted the educational standards of America with the standards of other countries. He called attention to the fact that a majority of the teachers of America were untrained, whereas in many foreign countries, people do not attempt to teach in the secondary school until they have training that is equal to that usually attained from four years of college work, plus some post-graduate work.

Foreign nations are rather jealously watching America in its experiment in universal education. Some of them hoping that this experiment will fall down. Some of them declare that we cannot, from a financial standpoint, afford to try to give every child a high school education.

They declare that it is not possible to raise sufficient money from taxes to do this. These nations do not attempt it. They believe that just a few of the children of certain families should have a high school education, while the others should remain somewhat in the same station in life to which they were born.

Dr. Alexander said his reply to those who said we could not afford to spend the money for this purpose was that we can afford to do otherwise. The salvation of the country, and the only assurance of continued development lies in the education of this generation so that in the complex civilization thrust upon us it will be possible to solve the problems and meet the situations brought about by modern civilization.

In addition to appearing on the general program Dr. Alexander appeared on a number of the departmental programs during the two day session of the North Eastern Association.

Mark Twain's famous story, "Life on the Mississippi," was used as a text book by James Cruze in filming his latest production for Paramount, "The Fighting Coward," White Theatre Monday, Nov. 17.

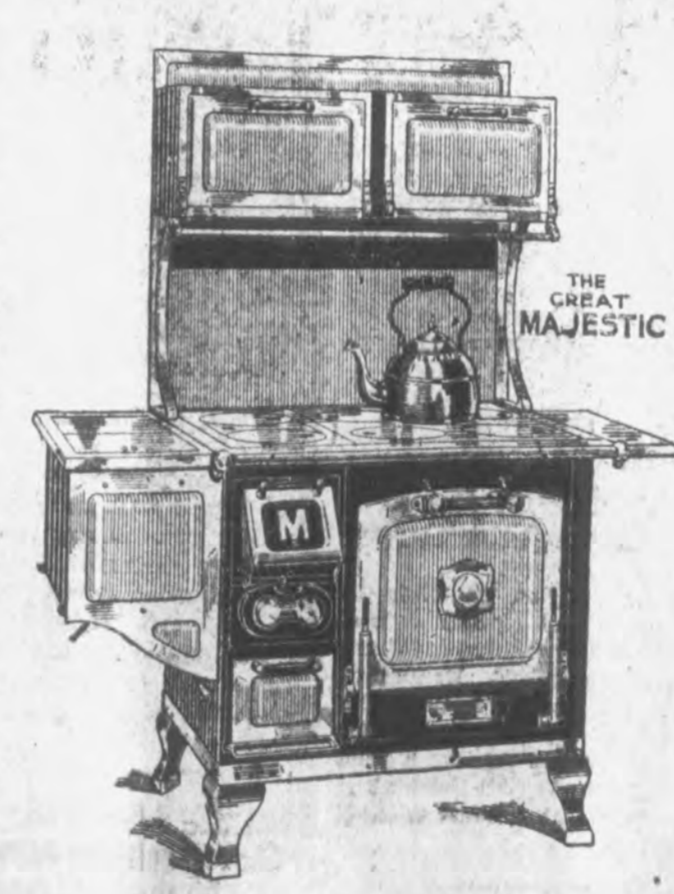

HOME BREW

There came one call for Webster's Dictionary while the jury was deliberating: somebody wished to look up "wine." But in the end, twelve of his peers have acquitted Representative John Philip Hill of Maryland on all six counts against him.

Mr. Hill himself has been making home-brew wine for some time past, not secretly but with as much pomp as ordinarily attends the launching of a battle-ship.

It is not the constitutional amendment, of course, but the Volstead law which defines intoxicating liquors. The definition there is one-half of 1 per cent. But the Volstead law specifies exempts from its penalties the brewer of "non-intoxicating cider and fruit juices exclusively for use in his home."

And that means what? This, if the decision holds: that there is no standard test which can be applied and that each jury must in each case brought before the courts decide what is "in fact" intoxicating.

liquors only—would be explicit sanction for the theory of leaving to each community authority for dealing with the question as it likes—a horrible thought to the good Volstead.

That will be the case if the court's decision holds and is applied by other courts in other sections of the country. But there is nothing in this Maryland decision which binds other courts.

Congress has one alternative if it wishes to rule against home brew and to make its decision sweeping. That is, to amend the Volstead law by repealing section 29. Then its definition of one-half of 1 per cent, would apply to every sort of liquor.

INDIVIDUAL INDIFFERENCE THE CAUSE

In Europe it is not uncommon to find buildings several hundreds of years old, that have never seen a fire other than in a fireplace, there are whole villages that have not seen a runaway fire in centuries.

To eliminate that nine-to-one differential in America, would not invalidate the principle or change the practice of fire insurance, it would only make fire insurance more universal, at far lower cost.

During the year Red Cross nurses have made 130,533 visits to homes where sickness and disease threatened human life. They have inspected 149,943 school children, and helped to get their defects corrected.

The following is a report of the resolution committee which is submitted for the consideration of the teachers in the Northeastern District:

We wish to go on record as expressing our thanks to East Carolina Teachers College, people of the City of Greenville, City and County school people, to the program talent, and to others who have aided in making this second meeting of the district Association successful.

Believing that the future educational progress of the state is based on the fundamental idea of an extended school term to a minimum of eight months, the teachers of the Northeastern District of the North Carolina Education Association heartily endorse the efforts of Supt. A. T. Allen to work out plans which will bring this to pass at the earliest practical date. Desiring to equalize the tax rate while bringing equal educational opportunity to every child in North Carolina, we urge and recommend a larger participation by the State as a whole in the support of schools.

Since the district meetings of the association have become a distinct feature of the association work we believe the district organization should be tied up more closely with the State organization. 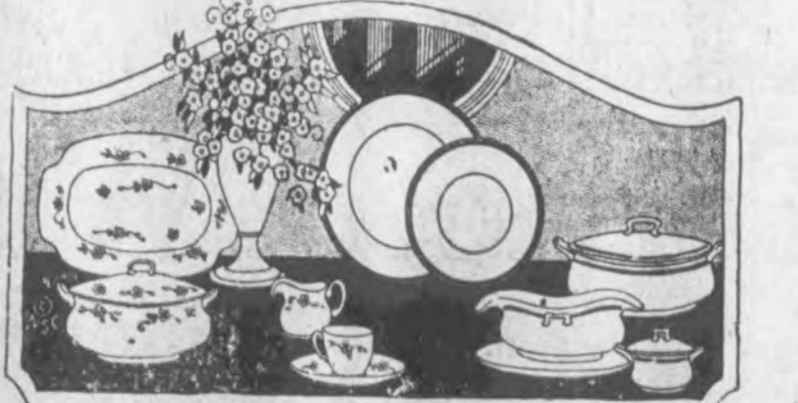
