BAPTISTS EFFECT MANY CHANGES IN CONVENTION LAWS

Rev. Charles E. Madry, of Raleigh, Presented Watch As Token of Appreciation for Services

Raleigh, Dec. 10.—Following a business session marked by an address by J. W. Bailey, of Raleigh, in behalf of the Biblical Recorder, the church paper, this morning's meeting of the Baptist State Convention was featured by the presentation by more than 300 Baptists of a watch, chain and knife to Rev. Charles E. Madry, Corresponding Secretary of the State Mission Board in token of appreciation of his services. The presentation speech was made by Rev. J. R. Jester, of Winston-Salem. Dr. Madry, who left his sick-bed to attend the session because State Missions was scheduled for today, was almost overcome by this evidence of "love and esteem" from his fellow Baptists and could scarcely reply as he was supported while standing by Dr. B. W. Spillman, president of the convention.

Mr. Bailey's address on the subject of the church paper was the high light of the morning session. Changes recommended by the committee appointed last June by the mission board were made in the laws of the church at this morning's session. Thereby the convention's books will be closed November 15 each year and the convention will meet as early as possible thereafter. An audit of the accounts will be made by an auditor or audit concern instead of by the church auditor as in the past. Each church will keep a record of the contributions of every organization but only the total sums will be reported to the mission board. The Woman's Missionary Union, however, may keep whatever records they see fit. The convention treasurer will balance his books monthly and publish same in the Biblical Recorder instead of making weekly reports as heretofore. All employees of the mission board will be under direct control of the secretary. These changes in the methods of keeping books it is said will save the convention about \$2,500 each year. The Mission Board has grown to be a million dollar affair. Secretary Madry said and it was necessary to wipe out the old system of books and make the changes in order to take care of the work properly.

Wake Forest to Be Host Big Convention in 1925

Wake Forest, Dec. 10.—Wake Forest was selected over Princeton as host for the 1925 convention of the association of university and college business officials, bursar E. B. Earnshaw reported today when he returned from Princeton, Rhode Island, where he attended the 1924 convention at Brown University. The meeting next year will be held on December 3-4. At the meeting at Brown 97 officials representing 68 institutions were present. During the session it was voted to receive as members institutions which had formerly comprised the New England Association. The taking in of these new members together with Southern institutions that are expected to join this year will mean that when Wake Forest entertains the body the number of men attending and the number of institutions represented will be considerably increased. In addition to honoring Wake Forest with the 1925 meeting the association re-elected Mr. Earnshaw as a member of the executive committee. He was also named as head of the committee on nominations which placed the names of the following officers: president, D. D. Bostwick, comptroller of Cornell University; vice-president, F. B. Johnson, bursar and general manager of Yale University; secretary-treasurer, H. S. Ford, bursar Massachusetts Institute of Technology.

OFFICIALS PREDICT EARLY APPOINTMENT SUCCESSOR CONNOR

Indications Point to Probable Selection by President of Isaac Meekins as Judge

Washington, Dec. 10.—Prompt decision in the appointment of a judge for the Eastern District of North Carolina was predicted by W. G. Bramham, of Durham, Republican State Chairman for North Carolina, after a conference today with President Coolidge.

The president has before him recommendations from various North Carolina groups working in behalf of half dozen candidates and Chairman Bramham urged that the matter be disposed of in the near future.

Mr. Bramham as well as the majority of the members of the State Executive Committee have endorsed Isaac M. Meekins for the place.

CONSCIENCE HURTS CITIZEN, SO HE PAYS UP HIS BACK TAXES

"Led by the Lord" Unidentified Person Sends Wake Sheriff \$24 for Taxes Not Listed

Raleigh, Dec. 10.—Because he failed to list for taxes several years ago an unidentified conscience stricken citizen today sent D. Bryant Harrison, sheriff of Wake County, \$24 in currency to pay taxes for that year and including interest.

The money was enclosed in a letter in which the writer said he was sure being led by the Lord in paying these back taxes. The letter was not signed.

"Some few years ago I lived in Wake Forest, North Carolina for part of a year," the letter reads, "and failed to list for taxes. I left about listing time and did not list at the place to which I went. Therefore I paid no taxes that year. I am sure I am being led by the Lord to pay this back tax so I have allowed more than enough for the tax that year and then compound the interest every year since making the amount of county tax \$18 and the town of Wake Forest \$6." The money has been added to the conscience fund of the county.

Committee Appointed Fix Date Inauguration for Angus W. McLean

Raleigh, Dec. 10.—One of the first things the legislature is expected to do after it convenes next month is to hold a joint session of the two houses and appoint a committee to arrange for inauguration of Angus Wilton McLean as Governor and to fix the date of the inauguration. The inauguration is expected to take place about January 15.

For the past few inaugurations, the ceremonies have been conducted at the City Auditorium and it is thought the inauguration ceremonies will take place there this year.

Promoters Declare Boxing In Raleigh Thing of the Past

Raleigh, Dec. 10.—Boxing in Raleigh is a thing of the past so far the promoters of all the bouts staged here since fighting was legalized here several months ago are concerned. The promoters say they lost more than \$200 on the Tresco-Johnson-Battling Dick bout staged here last week.

"You can say that Jack and Bill are through," said Jack Cameron, who with Bill Wynne have been promoting fights here. "We've soaked some good money in the fight business in Raleigh and it will not pay. That's all."

SENATE TO CONTINUE BRITAIN QUESTIONS ON SHOALS QUESTION AMERICA'S RIGHT TO UNTIL DISPOSITION COLLECT WAR CLAIM

Leaders Expect Vote On Measure By Senate Before Week End; Isle of Pines Treaty Next

Washington, Dec. 10.—The Senate today agreed unanimously to hold the Muscle Shoals issue before that body until it was disposed of an allow consideration of the Isle of Pines Treaty to follow immediately.

The first amendment to the Underwood bill now under consideration to come up before the Senate today was one offered by Senator McKellar which would authorize the Secretary of War to regulate the charges for power produced by Muscle Shoals. The amendment was voted down.

Communication is Receiving Careful Study by State Department; America's Position Is Clear Say Spokesmen

Washington, Dec. 10.—The State Department has received a communication from the British government explaining the attitude of Great Britain on the collection of war damage claims from Germany by the United States under the Dawes reparation plan.

It is not understood here that the British objections lie against the Rhine army cost claims for which special agreement has been set up between the United States and the Allied powers but the note questions more directly the right of the American government to obtain cash payments through the Dawes reparation plan to meet awards of the claims commissions. The British communication is now in study and will be answered within a few days.

In the light of what has been said by administration spokesmen on the question it is considered certain that Secretary Hughes will insist upon recognition of the principals of the American claims against Germany and shall be treated equally with those of other powers. The Washington government has always taken the position that it is entitled to share to a limited extent in the proceeds of the Dawes plan and expects to be given the support of the allied governments.

It has been pointed out by authorized spokesmen that the United States is entitled to be repaid under her treaty with Germany just as the allied powers are entitled to payment under the terms of the Versailles treaty. In support of this position it is said that the American treaty with Germany furnishes both legal and equitable rights for collection of war claims against Germany out of the benefits derived by that nation under the Dawes plan. As the United States participated in a common victory it is held that the allied governments cannot take all the assets of Germany and leave the American government in a position of being unable to collect the Rhine army cost as well as the claims being sought by the German-American Mixed Claims Commission.

Officials declared that when the Dawes plan was formulated it provided in many terms that the proceeds should cover all claims of the allied and associated powers. At the time of the London conference it was believed the position of the Washington government had been made very clear. In advancing the explanation of America's position to the other interested powers, it was also made clear that the United States had no desire to be oppressive or to make any other than just claims defensible on legal grounds, and having equity apparent to all.

N. C. Assembly Comm. Will Meet in Raleigh On Thursday, Dec. 11

Asheville, Dec. 10.—A meeting of the North Carolina Assembly Commission, named by the legislature for the purpose of looking over sites in this state for the proposed national park of the Southern Appalachian mountains, will be held here Thursday. State Senator Mark Squires is Chairman of the Commission of seven.

Charlotte Speedway To Stage Second Meet

Charlotte, Dec. 10.—Officials of the Charlotte Speedway have asked the American Automobile Association to award them April 13 as the date for the second auto race at the local track. The request was forwarded to Lee Folger, North and South Carolina representative on the contest board of the association, for forwarding to Richard Kennerdell, of Pennsylvania, chairman of the board.

BELIEVE TRINITY WILL COMPLY WITH REQUESTS OF DUKE

Raleigh Alumni Clash Over Proposal Change Name of College to Secure Gift

Raleigh, Dec. 10.—The proposed change in the name of Trinity College to Duke University in order to participate in the trust fund created by James B. Duke yesterday received hearty approval and bitter denunciation by alumni and friends of the college here. The clash that came between the adherents of the opposing opinions is expected to culminate at a meeting of the local association tonight.

Charlotte, Dec. 10.—James B. Duke, who on Monday night announced the creation of a \$40,000,000 trust fund the present income of which is estimated at \$2,000,000 a year, for education and charitable causes, will leave his Charlotte residence for his home at Somerville, N. J., where the trust indenture will be recorded tomorrow or Friday it was stated here today.

Mr. Duke, while retaining his principal interests in North Carolina, is a legal resident of New Jersey.

William R. Perkins, attorney for Mr. Duke said today that no meeting of the trustees named to handle the details of the trust will be held until the attitude of Trinity College is ascertained. Trinity is to be the recipient to "not in excess of \$6,000,000" to be expended under the trust for buildings and expansion into a great university provided the name be changed to Duke University. Otherwise the trustees are directed to expend the money to found a new university in North Carolina. Although the Board of Trustees of Trinity College must act on the question to change the name of the college, the president of the board, Joseph G. Brown, of Raleigh, and President William P. Few, of the college, yesterday lauded Mr. Duke's gift and President Few expressed belief that officials of the college would co-operate in every way. The new university would receive 32 per cent of the income from the trust.

Telegrams from throughout the country lauding Mr. Duke's gift have poured into his residence here ever since announcement of the gift was made.

WAKE COUNTY MAN HELD FOR MURDER THREE YEARS AGO

Sam Brantley, Farmer, In Wilson County Jail for Murder of Preacher in That County in 1921

Raleigh, Dec. 10.—Sam Brantley, farmer of Taylor's township near here, is in the Wilson county jail charged with the murder on July 21, 1921 of his father-in-law Rev. Ennis Pearson, pastor of the Free Will Baptist church in that neighborhood.

Brantley was arrested late yesterday and will be given a preliminary hearing in a few days.

The Rev. Mr. Pearson was shot to death while feeding hogs at his farm and the shooting of him remained a complete mystery for three years. The authorities have not pronounced the evidence on which Brantley was arrested. The killing the preacher was said at the time to have been the outgrowth of a sermon preached by Pearson against bootleggers and moonshiners of the neighborhood.

Two Prisoners in 'Safe Keeping' Dept. of the State Prison

Raleigh, Dec. 10.—There are only two prisoners in the "safe-keeping" department of the North Carolina State Prison now, it was learned today. They are Ernest Lee of Nash county and Joe Godette of New Bern. They will be moved from the prison to county jails in a few days, it is understood, to await trial.

### OUR ANNIVERSARY DAY

This date thirty years ago The Reflector, established thirteen years prior to that time by the late D. J. Whichard and published as a weekly newspaper under management of its founder, began publishing a daily edition. Announcement was made at the time that The Daily Reflector would be published for one month as an experiment, at the end of which time it would be determined whether or not it would continue longer. The first of the daily edition had only three columns to the page being less than one fourth the size of one page of the present editions. Though a small paper, it was received with such favor by the public, and there were so many requests for its continuance at the end of the first month, that it was decided to continue the daily edition, and it has gone right on through these thirty years.

It must be admitted that it took some nerve to start a daily paper in a town no larger than Greenville was then, the census giving the town just 965 population. And just think of the marvelous development and changes that have come to Greenville in these thirty years, and the history The Daily Reflector has recorded of the town's growth. At the time The Reflector made its first appearance as a daily paper there was but one brick store building in the town, while now a frame structure is not permitted in the business districts. Then our educational advantages consisted of two or three private schools, while now we have a city school system unsurpassed by any in the state and a state-owned and operated college preparing more than 500 young women for teachers in the various schools of the state and country. Then the churches of the city worshipped in small wooden structures while today practically all of the denominations have handsome brick edifices. Then the community was served by a small group of doctors while today the town can boast of a dozen expert physicians

and a hospital modern in every respect. Then we had scarcely no tobacco market, while today Greenville is the second largest tobacco market in the world, millions of dollars being invested in the tobacco industry here, and Pitt county is the largest bright leaf tobacco producing county in the world and the second largest tobacco producing county, all types considered. Then the town had only dirt streets while today we enjoy more than twelve miles of the best paved streets, and more than twenty miles of paved sidewalks. Greenville is now the hub of a net work of hardsurfaced roads connecting with all parts of eastern North Carolina, there being seven paved highways leading into the city and more than ninety miles of such highways within the borders of the county. In place of a population of 965 recorded 30 years ago the town now has around 8,000 inhabitants. Then we had only one small bank with only a few thousands in deposits while now we have three banking institutions which, with those of the county, have a total capital, surplus and undivided profits of more than a million and a quarter dollars, deposits of nearly three quarters of a million and resources of more than eight millions. Then the chief sports consisted of checkers and pitching horse shoes while today the city enjoys its country club, fair grounds and race track and other sports.

We might go on with more enumeration, but these are enough to show that Greenville has been doing things and during this time The Daily Reflector has remained a permanent institution chronicling these achievements as they came along, and lifting its voice to bring them when they did not come fast enough.

Though small at the beginning, The Daily Reflector did not stay in its swaddling clothes, but grew on as the town grew, except that its aim has been ever to keep a little in the lead rather than to follow. The abiding policy of the paper to stand firmly for right and truth against evil in every form, gave it such a place in the confidence and esteem of the people as to be its chief pride. Being a home institution, founded and always conducted by native borns whose every interest was here, we have loved Greenville and Pitt county above all places on earth, and every dollar of profits derived from the paper has been spent at home and in helping to advance home interests. Never has the paper wilfully or intentionally wronged any person, and never has it received a dollar knowingly without rendering full value therefor. It has always been the people's paper, laboring for their welfare and the advancement of their interests. The people in turn have shown their appreciation of the effort to serve them faithfully by extending a liberal patronage that has made the paper what it is today.

As in its beginning the motto of the paper still is "Truth in Preference to Fiction," and its aim is work unceasingly for the upbuilding of Greenville and Pitt county and the betterment of humanity.

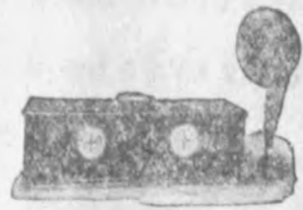

### Employment Not Up to High Record Set Few Months Ago

Raleigh, Dec. 9. — Employment throughout North Carolina while still comparatively plentiful, is not up to the high record set some few months ago and maintained since that time, according to the report for the week ending Saturday, December 6, issued by the State-Federal Employment Service here today.

During the past week, placements by the service dropped to 596, of which 444 were men and 152 were women, the report shows, while registrations numbered 536 men and women, a total of 725.

The report also shows that requests for help numbered 661, of which 481 were for men and 180 were for women, while those referred to employers numbered 479 men and 177 women, or a total of 656.
