Katy, the hired man, reported that Santa Claus under the direction of several groups of Kiwanians had visited twenty-six homes within a radius of fifteen miles of Greenville and brought gladness to the lives of some eighty children whom Santa might otherwise have overlooked.

President Will Hooker then placed the meeting in charge of Henry Staton who had been asking for this privilege ever since he had become a member. Will told him to spread himself for now was his opportunity. He delivered the goods and everybody had a fine time.

Under the instruction of Professor Charlie Forbes, assisted by Victor Davis the piano man, the Club was taught to sing "Doodle-de-doo." The Club provided apt pupils and were soon singing this piece of classical literature with gusto.

Katy was called upon to give the Kiwanians a look backward over the past year's work. He reported an average membership of 45.7; an average attendance of 37.2 members per meeting; an average attendance of \$1.4 per cent for the year.

Among the Club activities for the year are: The Club initiated and sponsored the opening of St. Francis Hospital for the colored people of Greenville. Held a booster meeting at Bethel August 29, entertaining about fifty business men of the place. Henry then called for the special feature of the evening, several musical numbers from the Christmas Cantata "Christmas Memories," beautifully rendered by a quartette from the Memorial Baptist Church choir, composed of Mrs. Earl Carter, Mrs. W. Z. Morton, E. E. Rawls, and Will Lipscomb with Mrs. Lula Fleming at the piano.

In the absence of President-elect Charles Laughinghouse, Kiwanian Cook gave the Club a short practical talk on "Looking Forward." It was full of the Kiwanis spirit with good meaty suggestions that every true Kiwanian should take to heart and put into practice.

President Will told something of the plans underway for Ladies night just a month hence, then the meeting broke up with a song.

Well Established Woman's Clubs In Rural Districts

Louisburg, Dec. 27.—"Not all successful active and well established woman's clubs are in the cities and towns," says Miss Daisy Caldwell, home agent of Franklin County. "We have a club at Bunn in a strictly rural community that has held regular monthly meetings for the past 13 years. This club has not only aided with the home demonstration work, but has also helped demonstrate in schools and aided in every school and community project. No entertainment or other scheme for making money is ever adopted by this club unless the club is satisfied that the project is worthy in other ways. During the past year at community parties, ice-cream suppers, box parties, and the like, a total of \$350 has been raised. This was put into playground and school equipment."

SUIT FOR \$50,000 IS FILED AGAINST RALEIGH SURGEON

Complaint Charges Neglect of Girl By the Surgeon Following An Operation Caused Her Death

Raleigh, Dec. 27.—A suit for \$50,000 was filed in Wake County superior court here today against Dr. E. C. Judd, local surgeon, by W. W. Davis, of Waltham, in Wake County. The complainant alleges carelessness and negligence on the part of Dr. Judd following an operation on his daughter, Ethel Davis for appendicitis on July 23, 1923 after which the 16 years old girl died.

In the complaint it is alleged that Dr. Judd was called in on the case to operate on recommendation of the family physician, that after operating he paid only one or two visits and then left the city leaving the girl in care of an intern who it is claimed was inexperienced. The child subsequently died and the complaint alleges that responsibility for her death lies with Dr. Judd.

A similar suit is now pending in Wake county superior court against Dr. Judd, filed by W. W. Davis, as administrator of the girl's estate.

DR. EDWARD W. SIKES CHOSEN PRESIDENT CLEMSON COLLEGE

Dr. Sikes will succeed Walter Matthew Riggs who died suddenly in Washington, D. C., several months ago while on a visit there.

THREE CHILDREN INSTANTLY KILLED BY ELECTRIC WIRE

Lad Trying Out New Christmas Rifle When Bullet Cut Wire and It Fell Upon Him

Hamlet, Dec. 27.—Three children, the eldest 16, lie dead today in their home here the victims of a high tension transmission electric wire which a rifle ball cut down. They were the children of Mr. and Mrs. Pearl Martin.

The accident occurred at Robersdale, four miles from here, yesterday afternoon. A young boy, 16, who had a 22 caliber rifle, according to information here, was shooting at a target. One of the shots struck the electric power transmission wire and broke it. The wire fell on the boy entangling him and holding him helpless. There were no eye witnesses to the tragedy but apparently Ethel, age 11, and Willie age 9, rushed to the aid of their elder brother. They were apparently killed instantly.

Neighbors found the three in a little heap with the death wire holding them still.

SHEPPARD SAYS HE WILL PROTECT SELF

Foster Father of Dead "Millionaire Orphan" Arrives in Chicago for Investigation Into Death

Chicago, Dec. 27.—William Sheppard arrived in Chicago today from New Mexico to protect himself in the investigation into the death of his foster son, William N. McCintock, "Millionaire Orphan." Sheppard declared he would seek public exoneration of the publicity which has been directed against him. At the same time examination being made of McCintock's exhumed body.

McCintock's death a month ago was attributed to typhoid fever but dissatisfaction among friends resulted in the decision to exhume the body and hold an official inquiry.

Dr. Plato Durham To Address Gaston Asso. Trinity Alumni

Gastonia, Dec. 27.—Dr. Plato Durham, a native of North Carolina and now of Emory University in Atlanta, Georgia, will be the principal speaker at the meeting to be held here on Tuesday, December 30, of the Gaston County Association of the Trinity College Alumni. It has been announced. He will discuss the recent endowment gift of James B. Duke to the college. At the same time the county association of the alumni of the University of North Carolina will be holding its meeting in this city also. All the college and high boys of the county have been invited to attend both meetings.

FOUR STORY STRUCTURE COLLAPSE FROM EXPLOSION

Kansas City, Mo., Dec. 27.—A four story building housing a plumbing supply concern collapsed here today following an explosion. First reports did not indicate whether any one was killed or injured.

JOINT FUNERALS HELD YESTERDAY FOR FIRE VICTIMS

Twenty More Victims of Oklahoma School Fire Will Be Buried in Common Grave This Afternoon

Hobart, Okla., Dec. 27.—Babbs Switch, a little farming settlement south of here, today continued the burying of the 35 victims of the fire which wrecked the community's school house during a Christmas Eve entertainment.

Eight bodies were buried yesterday after memorial services at the Hobart auditorium in which ministers of all denominations took part. Plans for burying other victims yesterday were held up because of the inability to get the graves finished. One large grave was being dug in the little snow covered cemetery to receive 20 of the victims today. Families of the others have requested separate graves. No new services are planned for today those of yesterday sufficing for all.

At least three of the injured are not expected to recover.

COLOGNE AREA WILL NOT BE EVACUATED

Allied Council of Am- bassadors Sends Let- ter to Germany In- forming That Country of Decision

Paris, Dec. 27.—The Allied Council of Ambassadors today agreed upon terms of a letter to Germany announcing that the Cologne area will not be evacuated on January 10. This was the date stipulated for evacuation by the Versailles treaty, provided Germany had fulfilled her obligations under the treaty.

The text of the letter will not be made public until it has had time to reach Berlin.

GYPSY LANGUAGE IN PRINT FIRST TIME IN CAMPAIGN DOCUMENT, SAYS REPORT

Sofia, Dec. 26.—The Gypsy language, which is not regarded as a written tongue, has been put into print for the first time this autumn for political campaign purposes.

It is printed in Slavic characters, but most of the words are unintelligible to a Bulgarian or any other Slavic-speaking person. The political terms, however, are Slavic words.

An agrarian campaign document, printed in the Romy language, points out that the late dictator, Stamboulsky, was anxious to enfranchise the entire Gypsy race, but the Democratic Union prevented the enfranchisement by putting an end to the Stamboulsky regime.

Under the Bulgarian constitution the Gypsies enjoy the same rights of equality that are enjoyed by every other race.

MAN LIVES AFTER BULLET IS TAKEN FROM HIS HEART

Chicago Surgeon Still Patient's Heart Long Enough to Remove the Bullet and Heart Then Resumes Action

Chicago, Dec. 27.—Max Peck was alive today after surgeons had extracted a bullet from his heart, that fact being hardly less remarkable, his friends said, than the manner in which the metal got into his heart.

Peck lived in a lodging house and on Christmas Eve, having gotten lonely he decided to end his life. Having no weapon he constructed a cannon from a piece of lead pipe, rammed home a charge of powder and for a bullet used a piece of steel spike. Placing his cannon upon the table he pointed it at his heart and exploded the charge with a piece of red hot wire.

Other inmates of the house reported to police that Peck had merely blustered his chest but an X-ray examination disclosed the piece of steel in the heart.

Dr. Carl Meyer, opened a "flap" in Peck's chest, cut through the sack around his heart, stilled its beating by grasping it in his hand and by exerting pressure forced out the spike bullet. The heart was then released into position and resumed its beating.

JURY HAS REACHED NO DECISION IN THE CASE OF KID MCCOY

After 24 Hours Deliberation Jury Is Six to Six in Murder Trial of the Once Pride of Prize Ring

Los Angeles, Cal., Dec. 27.—"Kid McCoy," one time pride of the prize ring, faced a no decision verdict today after putting up a fight for his life against a charge of murder of Mrs. Theresa Mors.

A jury was given the case at noon yesterday. The jurors retired last night in a six to six deadlock. When deliberations were resumed this morning there was no indication as to whether the jurors had changed their deadlock situation or whether they would report a mistrial to the court. Shortly before midday the jury was still deliberating.

Employees Twin City Post Office Are Given Oyster Supper

Winston-Salem, Dec. 27.—A hundred employees of the local postoffice were tendered an oyster supper on Christmas eve by Postmaster Benbow. The supper was served on the top floor of the post office building. Giving the supper to the employees, Mr. Benbow was following out his custom of giving the postal employees here a Christmas entertainment.

CAUCASIAN JAPANESE SUBJECT BECOMES A CITIZEN OF AMERICA

Los Angeles, Dec. 26.—Granting of citizenship here recently to a Caucasian native of Japan established what government officers believe to be a precedent.

The applicant, Riccardo Stanicci, a local interpreter, when applying for citizenship papers, stated that he was born in Japan, brought up according to the customs of that country, but that he was of Italian parentage. Investigation showed that his parents years ago were connected with the Italian embassy in Tokio.

After death of his parents, Stanicci said, he was adopted by a Japanese family with whom he lived until 12 years ago, when he entered the United States at San Francisco.

He stated that his wife is half English and half Japanese, but that no Oriental blood flows in his veins.

THIRD COLD WAVE WITHIN TEN DAYS SWEEPING NATION

Seventeen Deaths From Christmas Cold Snap Reported; New Cold Wave Traveling East- ward

Washington, Dec. 27.—Much cold weather will overspread sections of the Mississippi River except the extreme south within the next 36 hours, Weather Bureau officials predicted today and at the same time announced that cold wave warnings for sections as far south as Tennessee, Virginia and the extreme western part of North Carolina had been posted.

Chicago, Dec. 27.—The mercury was falling in the middle west today as the winter's third cold wave extended over most of the country with the coldest weather of the season reported from Nevada. The severest cold experienced this year is anticipated by tonight or early tomorrow in Kansas and Wisconsin. A bitter wind accompanied the drop of the mercury.

Chicago, Dec. 27.—Another cold wave, the third in the past 10 days was driving from western Canada into the Rocky Mountain states today with a forecast that it would spread zero and sub-zero temperatures into the middle western states by tonight.

The middle west had just breathed a sigh of relief as the thermometer began to climb from its resting place of the past few days and the cold wave drove eastward with diminishing intensity when reports of the new cold wave were received.

Seventeen deaths followed in the wake of the Christmas cold weather a nation-wide check indicated, there being four in Illinois, three in Ohio, two in Colorado, two in Oregon and one each in California, Texas, Utah, Montana and New Mexico.

Strenuous Campaign Being Made For Clean Tobacco Seed

Raleigh, Dec. 27.—Dr. F. A. Wolf, G. W. Fant, H. A. McGee, E. G. Moss and others of the agricultural extension workers, are making a strenuous campaign for clean tobacco seeds, planted in clean beds so as to insure healthy seedlings and thus prevent much of the great loss accruing to North Carolina farmers each year by leaf diseases of tobacco. They want and ask for the help of every extension worker and every farmer who grows tobacco in North Carolina, to help put this plan across in this state.

Great Confidence Expressed in County Agent of Davie

Raleigh, Dec. 27.—"All he has to do is to ride by the farm and the corn will grow," said a farmer of Davie county who was visiting the extension division office in this city during this week. He was speaking of and expressing his confidence in George Evans, county agent of Davie county who has been doing some special work among his farmers in perfecting the growth of corn.

WOOLWICH ARSENAL SHOPS TO MAKE PEACETIME GOODS

London, Dec. 26.—Part of the great workshops at Woolwich arsenal will in the near future be used for private enterprise in the manufacture of goods instead of implements of war, it was revealed by J. Bradford, of the Woolwich Chamber of Commerce at a meeting of the Association of British Chambers of Commerce.

"When you are not making guns for war," he said "in killing your enemy and having your kitch and kitchen in return, these valuable workshops in Woolwich arsenal are idle, and the district is suffering."

He added that the chamber had persuaded the government to release certain of the workshops and parts of their river frontage for private enterprise, and that "we hope in that way that we shall be less dependent upon war and be able to develop peace industries."

TAX-EXEMPT BURDEN INDUSTRIES An issue of Salem, Oregon, tax-exempt improvement bonds, bearing 6 per cent, sold for a premium of more than one year's interest during life of bond. Similar bonds bring approximately equal prices.

Tax-free bonds are large enough in volume to make it difficult to secure money for industrial investments, and they abnormally increase rates for money for farms, for factories and business. BARNUM WAS RIGHT

"They leave their automobiles unprotected, for thieves to steal. They carry large sums for pickpockets to get. They are weak when they cash checks for strangers. They purchase real estate without looking up the title, invest in schemes without consulting their bankers, pay mediums to talk to the dead, play cards with sharks and bet on pre-arranged events.

"It is hard for the police to guard them entirely; they must learn to protect themselves."

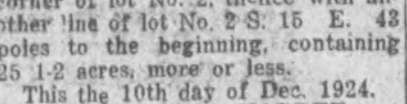

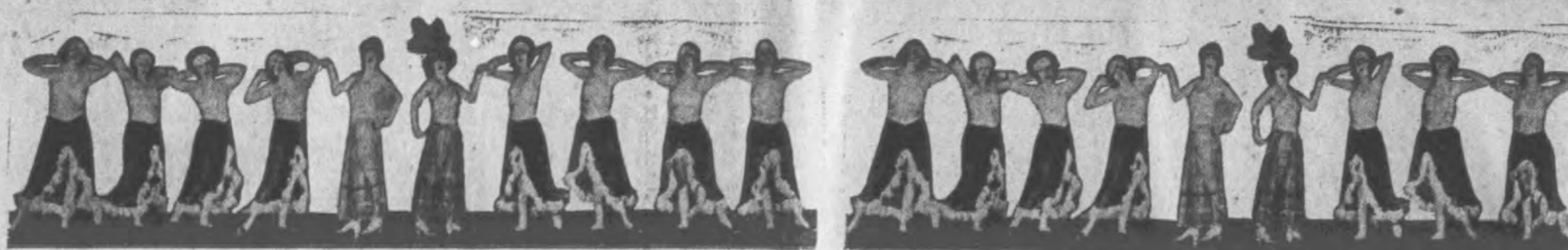

COTTON

New Orleans, Dec. 27.—The cotton market is being favorably affected indirectly by the strength of the grain and stock markets and by prospects for expanding trade on both sides of the Atlantic, making it likely for the world's consumption of American cotton to continue to increase.

Owing to the holidays abroad, European interests have been buyers in American markets and Wall Street, the west and the south have been good buyers of contracts.

The severe cold weather throughout the country, one cold wave following another, with another one in sight is expected to improve the demand for heavy cotton and woolen goods.

Week-end and year end domestic trade reviews are favorable, with the outlook for further trade expansion after the new year.

Because of the heavy exports from the United States and the increasing takings by American spinners, the disposition is to increase consumption estimates.

House with foreign connections are reported to have said that foreign spindles will consume 6,900,000 bales of American cotton this season, which would be about 1,500,000 bales more than foreign countries consumed last season.

The demand for American raw cotton is world wide, as noted by the following comparatives as to exports from the United States from August 1 to Dec. 23rd:
