ENGLAND WILL NOT STAND IN WAY OF BEBT SETTLEMENT

Reported Communications Say England Requests Only Equal Proportionate Payments on Part France

Washington, Jan. 2.—Officials here apparently see hopeful tendencies in the New Year's dispatches from Great Britain although they have received thus far no communication declaring the willingness of the British government to approve specially indulgent terms for France.

When shown a story published in London to the effect that Great Britain assured the United States she would not stand in the way of a Franco-American settlement on terms more lenient than the Anglo-American agreement high officials of the state department authorized the statement that no such assurance had reached Washington either officially or unofficially.

London, Jan. 2.—"Here is a chance to settle once and for all the problem that has faced the world since peace was declared and stood in the way of the economic recovery of Europe," says the Morning Post in commenting upon the communication which according to its Washington correspondent, Great Britain has made to the United States with reference to settlement of the French debt.

The correspondent's aim is to the effect that Great Britain has assured Washington that it does not object to the United States granting special terms to France in the repayment of her debt, only entrusting that whatever payments France makes to the United States shall be shared "pari passu" by Britain.

"Clearly a new situation has been created and public opinion in this country will give Premier Baldwin's government the highest credit for the conception of such an appealing stroke of policy for it America recognizes our generosity. France surely will not be unmindful of the assistance we shall have been able to render her" the comment adds.

County Agents to Meet at the State College Jan. 6-14

Raleigh, Jan. 2.—James M. Gray, assistant director of the county agents of North Carolina has sent out a letter to all agents announcing that the agents are to be the guests of the department at the annual conference to be held at State College during January 6 to the 14. The agents, says the letter, will be housed in the college dormitories and will be furnished meals in the college dining hall.

The agents are instructed to report to the office of Mr. Gray at 110 Ricks Hall for registration and assignment to rooms and to receive a meal ticket. They are also requested to notify Mr. Gray immediately of the time that they will arrive. The work of the conference, it is stated, begins promptly at 8 o'clock Tuesday morning, January 6.

COOPERATIVE SOCIETIES PROSPER IN GERMANY

Berlin.—Germany today claims no fewer than 52,300 co-operative societies, which is far in excess of the number in any other country.

There are both consumers' and producers' societies among these organizations. Some are for marketing goods, others for the purpose of buying, while still others extend credit to their members on better terms than the individuals can obtain at the banks.

WOMEN BARRISTERS ADDRESSED IN VARIOUS WAYS BY WITNESSES

London.—There seems to be much uncertainty on the part of witnesses as to how they should address the women barristers who sometimes practice in the courts.

Miss Jessica Cobb, one of the foremost of English women barristers, said she was sometimes addressed as "madam," but more often she was addressed as "my lady," and she had even been called "my dear." One kind, motherly old lady, she added, had soiled the dignity by calling Miss Cobb "my dear."

ARMY MAINTENANCE BILL WAS REPORTED TO CONGRESS TODAY

Measure Carrying \$331,131,114 Appropriations is Less Than Amount Available Present Year

Washington, Jan. 2.—Maintenance of the regular army during the coming fiscal year as its present authorized strength of 12,000 commissioned officers and 125,000 enlisted men exclusive of 8,000 Philippine scouts is proposed in the War Department appropriation bill reported today to the House.

As approved by the appropriations committee the measure carried \$331,131,114 or \$6,552,000 less than the amount available for expenditures this year and about \$300,000 less than the budget estimate. Of the total \$258,317,958 is for military and \$72,813,156 for non-military activities.

Included in the allotment is a \$40,000,000 lump sum appropriation for improvement of rivers and harbors.

English Spinners Interested in Silk and Cotton Mixture

Blackburn, England.—The suggestion that artificial silk will ever displace cotton, or even become a serious competitor is absurd, according to T. Wilkinson, head of the Textile College, who declared recently that "cotton is not played out yet." He added that a combination of cotton and artificial silks, however, was a valuable idea and capable of enormous development.

Speaking of the British trade, Mr. Wilkinson said the progress made in the manufacture of artificial silk fabrics on the ordinary Lancashire loom was encouraging, and that mills were in the course of construction with a view to preparing the new artificial silk yarn.

Important manufacturing firms are experimenting on a large scale.

BURNING STEAMER BEACHED TO SAVE 200 PASSENGERS

Clyde Liner Mohawk South Bound From New York Catches On Fire in Storm Yesterday

New York, Jan. 2.—The Clyde Liner Mohawk, which caught fire yesterday while enroute from New York to Charleston and Jacksonville, was today beached at Lewes, Delaware, officials at the steamship company's offices here announced today.

The ship was beached after the 200 passengers had been taken off by a coast guard cutter and two tugs. The ship is safe according to the company's offices.

Lewes, Delaware, Jan. 2.—The Clyde liner Mohawk with 200 passengers bound from New York to Charleston and Jacksonville, caught fire in one of the wildest storms of the present winter off the New Jersey coast last night and ran into Delaware Bay to save the passengers. The blaze started in the after hold of the ship and spread so rapidly that all passengers were ordered to get ready to leave the ship.

The last radio report was to the effect that the fire was under control and that the passengers would be landed at Lewes and returned to New York or sent on to their destinations. So far as is known there were no casualties.

The Mohawk left New York New Year's Day about noon. The fire was discovered when the ship was about 70 miles south of Sandy Hook. Gales accompanied by snow were blowing. Captain Steele decided to run for Delaware Cape but the storm got worse and as he approached the entrance to Delaware Bay he was unable to anchor because of the weather. By this time several vessels were on their way to the Mohawk and soon two cutters and two tugs were alongside.

There was no communication with the ship except by wireless and reports stated that the passengers were being cared for.

RADIO IS GREATEST MENACE TO THEATRE DECLARES PRODUCER

First Radio Concert By Famous Artists Last Night Cuts Attendance of New York Theatres

New York, Jan. 2.—With untold dio concert of John McCormack and Lurezia Bori, the theatres of this city according to spokesmen are facing a crisis as a result of the latest developments of the free amusement on the air.

In the first of a series of bi-weekly concerts by noted artists never before on the air, Mr. McCormack and Miss Bori with their golden voices gave a concert last night through station WEAF with seven other stations in eastern cities participating in the broadcasting.

William A. Brady, veteran theatrical producer, in commenting on the concert asserted that radio constitutes the greatest menace to the theatre ever faced. He cited poor attendance last night as proof of his assertion. Patronage of nearly every theatre in the city was affected by the first appearance of the golden voices on the air. Even the productions ordinarily playing to capacity houses failed in some instances to be sold out.

Power Trust Probe Blocked in Senate

Washington, Jan. 2.—Characterizing the Federal Trade Commission's investigation into the so-called power trust proposed by the Norris resolution as "a fishing expedition" Senator Edge, Republican, of New Jersey, again blocked consideration of the measure today in the Senate.

CONGRESS IS NOW DOWN TO BUSINESS AFTER HOLIDAYS

Senate Resumes Muscle Shoals Hearings While House Hurries Through With Supply Bills

Washington, Jan. 2.—With the last of the holiday recess behind it the 68th Congress today plunged into the legislative task that must be handled in the 53 working days before March 4.

Muscle Shoals which continued with right of way in the Senate was taken up immediately while the House put aside its program of supply bills momentarily and gave its attention minor bills for which unanimous consent for consideration had been obtained. The House has already sent four appropriation bills to the Senate and will take up and dispose of the War Department bill tomorrow. Early today this bill was presented by the committee which had been considering it.

After disposition of the War Department bill the half dozen supply measures not yet considered will come up one after another and with completion of this vital legislation the House expects to turn its attention to general legislation.

In the Senate Muscle Shoals will be considered today and tomorrow, but on Monday the veto by the president of the postal salaries increase bill will be taken up. In the meantime the Senate Post Office committee today reported that it was reaching an agreement on a combination postal rate increase and postal employees salary increase bill to present, at the same time the president's veto is considered.

EFFORTS TO EXTEND CITY LIMITS WILL BE MADE NEAR FUTURE

City Fathers Hold Interesting Session; The Committee on City Extension to Report at Called Meeting During Month

The Board of Aldermen met in regular monthly session last night with the mayor and seven aldermen present.

Mr. S. B. Currin appeared before the Board relative to the placing of curb and gutter on East Eight street. The matter was deferred until a petition could be circulated among property owners and presented in regular form at the next meeting of the Board.

Chief Jones and the purchasing agent were authorized to buy a new motor cycle.

A committee was appointed to go over the proposition of the extension of the city limits and to insert amendments to the present charter in order to make such possible. They will report at a special meeting to be called by the mayor sometime during this month. If the city is extended a large area will be taken in. The matter will be presented to the next legislature for final action.

Reports of the various committees were heard and passed upon. The session although short, was interesting and many minor matters were disposed of.

PARIS WINE DEALERS READY TO HELP THIRSTY VISITORS

Paris.—The people of Paris, during the year ended Oct. 1, drank 10,000,000 fewer liters of wine than they consumed in the previous 12 months, but even so the 1924 figures provided a gallon a week for every man, woman and child in the city. And these figures do not include beer.

Wine merchants however, are not down-hearted. They look to a cold winter to stimulate the demand, and they are ready to sell champagne to the foreign visitors who are coming to Paris in increasing numbers.

Flagler, has appealed to legal counsel and has engaged detectives to run to earth persons behind an alleged scheme to blackmail her and her young husband, Lawrence Lewis, from whom she had been estranged until their unnamed foes threatened both.

FRANCE MAY ASK TEN YEARS MORATORIUM IN DEBT SETTLEMENT

French Officially Confirm Reports That Negotiations for Settlement Opened With America

Paris, Jan. 22.—The French Foreign Office today confirmed reports that negotiations had been opened between Finance Minister Clementel and Andrew Mellon, Secretary of the United States Treasury, regarding funding of the French war debt.

A note signed by M. Clementel went forward Tuesday. It suggested a ten year moratorium and gives indication as to what the French government thinks France might be able to do in the way of payments.

It is thought in official circles that M. Clementel's note cannot afford the basis of actual settlement but that it will open discussions that may lead to a final agreement. It is understood a similar note with a similar proposal has been sent to London concerning the funding of the French debt to Great Britain.

Arrangements Being Made to Pay Bonus

Washington, Jan. 2.—The Treasury today took the first step toward financing the soldiers' bonus by investing \$100,000,000 in special Treasury securities at four per cent to meet the first call on the government funds January 1, 1930.

Greenville Cotton Market Will Open Each Day 1:30 p.m.

Beginning Monday, January 5th, the Greenville Cotton Market will open each day at 1:30 p. m. This change is being made for the convenience of the weigher, buyers and sellers. The receipts are very light at present and by opening in the afternoon there will be ample time to weigh what is brought in.

SENATE COMMITTEE APPROVES POSTAL INCREASE MEASURE

New Bill As Amended Will Increase Postal Rates and Salaries of Postal Employees

Washington, Jan. 2.—The Senate Post Office committee approved today the administration bill providing for increase in postal rates and employees' salaries which had been drawn up earlier in the day with amendments.

The rate increases recommended by the Post Office Department, however, were reapportioned in that second class mail will be charged considerably less than originally proposed. The bill is effective April 15 this year and terminates February 15, 1926. It provides for the creation of a joint committee of House and Senate to conduct hearings on the rate increases and report to Congress by the first week of next regular session.

The eight zones for mail with advertising matter are grouped under the new bill in three divisions with rates of three cents per pound in the first three zones, six cents per pound in the fourth, and six and eight per pound in the last two zones.

The new measure provides a flat one and one quarter cents per pound rate on all second class mail devoted to reading matter instead of two cents as proposed by the Post Office Department. The present rate is one and one half cent per pound on all matter except that devoted to religious, education or non profit material which is now charged one and one fourth cents per pound.

Washington, Jan. 2.—Amended re-appointment of the increases in postal rates proposed in the administration's measure to advance both rates and salaries in the postal service were drafted today by the Senate Post Office sub-committee.

The committee will complete its work this week and will submit the amended measure to the Senate by Tuesday.

U. N. C. Sees Duke Gift as Big Stimulus

Chapel Hill, Jan. 2.—News of the acceptance by Trinity College of the gift of Mr. Duke has been received by University officials with satisfaction. There is every disposition at the University to rejoice genuinely in the good fortune which has come to its near neighbor.

University officials here have been recalling in how many instances in America strong universities on private foundations have grown up in the same states with strong state supported institutions, to the mutual advantage of both. In California, for example, Leland Stanford and the University of California, and in Illinois the University of Illinois and the University of Chicago are illustrations of this fact.

What is looked for at the University is a stimulation of the general field of higher education in the state as a result of this great donation.

Young Lady Has "Splendid" Luck First Hunting Trip

Raleigh, Jan. 2.—Much excitement was created in the Department of Labor and Printing the other day, when Miss Kate Hamilton, a member of the staff of Commissioner M. L. Shipman announced that during the holidays that she had gone hunting for the first time in her life and killed a bird. She said that she got a real thrill from the experience as well as a strong kick from the gun.

One of the sedate members of the staff after pondering a while over the story related by Miss Hamilton, inquired, "who held the bird?"

BRING THEM IN

Efforts two years ago to extend the limits of the City of Greenville developed such strong opposition that the project was abandoned. On last night the Board of Aldermen appointed a committee to make a thorough investigation of the situation and map out proposed extensions of the limits of the town which should be included in a petition for change in the charter. No doubt the proposition will again be faced by opposition but it is one that should be put across regardless and should the opposition be so great as to cause hesitancy on the part of the board then let an election be ordered and the citizens themselves be given an opportunity to decide the question.

A third of our population living outside of the city limits is a condition that should not longer exist.

CUTTING THE REPARATIONS CAKE

In a technical as well as business sense the United States has an interest in the next step to be taken in clearing away the problems left in the wake of the war,—the allotment of reparation payments.

This is pointed out by Basil Miles, American Commissioner to the International Chamber of Commerce at Paris, in his review of European economic conditions.

"The next step in disposing of the problems inherited from the war," he says, "is about to be taken. The Allied and Associated Powers are about to attempt a final agreement upon the division and allotment of reparation payments. They are about to cut the cake. Heretofore, they have been too inclined to an attempt both to have their cake and eat it. The Dawes Plan disposed of that attempt and reduced reparation payments to terms of definite annual amounts.

"The London Conference, in putting the Dawes Plan in effect, took into account the necessity of reaching a final conclusion as to how the proceeds issuing from Germany under the Plan could be divided among the creditor countries. The Finance Ministers of the countries concerned are now about to meet in Paris in the hope and expectation of reaching a final agreement. The business world is keenly interested in the result, and will suffer a serious set-back if the attempt to agree proves a failure. The United States is directly concerned, both technically and in reality. Technically, the United States has claims against Germany for the cost of the Army of Occupation and for the settlement now being attempted by the Mixed Claims Commission of which Commission Judge Parker, a prominent member of the American Section of the International Chamber of Commerce, is the umpire."

Merchant of Avery Recommends New Laws for the State

Raleigh, Jan. 2.—There is still hope for the eager old maid and old bachelor but little hope for the young flapper, bobbed haired teachers, friends of Lady Nicotine and enemies of Mr. Volstead and those who believe in personal liberties if the recommendations for new laws for North Carolina that were made to Revenue Commissioner Doughton by a merchant of Avery county, should all be enacted into the statutes of the Commonwealth.

Commissioner Doughton is in receipt of a letter from a merchant of Avery county who claims to sell everything that one needs and to buy everything that one has to sell. The letter condemns the man who lives off of others and requests a law be enacted to allow his debtors to "hire him out" and take half his earnings to pay his debts.

The merchant would put such restrictions on school superintendents to have only married persons in such offices so as to "cut out these courting schools" and add that after 1927 there should be no school teachers with bobbed hair.

The letter to Commissioner Doughton reads: "I have just read the sketch from Raleigh as to the vacation of your official men in visiting young homes during Christmas. Hope you all had a nice time.

"Then I notice other things you all are doing, and in which I am interested. I hope you all will see that the taxes on cigarettes cigars, and all tobacco are raised; then that there will be no man or woman, other than married, sober and modest, to superintend our public schools (so as to cut out these courting schools) and that after 1927 that there will be no lady teacher with bobbed hair allowed to teach in North Carolina; then that the female sex all wear dresses rather than trousers and leggings.

"Then, if it can be done, where a man gets a living off of others without working, that those who owe shall have a perfect right to take him up and hire him out and keep one half of his earnings to apply to his indebtedness and the other half to go to the maintenance of his family.

"Then that a boy under 18 years of age, having no income, be not allowed to run an automobile for pleasure.

"Then I wish that some thing could be done for the farmer and to aid him in securing farm labor. Hoping to hear from you when you find time, and hoping to have you visit me some time, and with kindest regards to you and yours, I am very respectfully yours and fraternally."

The letter is signed by a merchant of Avery county with a genealogical review of his family for two generations.

Commissioner Doughton stated that he had received many requests and many suggestions in regards to the business pertaining to his department and how it should be run, "but," he added, this is the most expensive one of all and it beats them all, though they came from the four corners of the state."

DENMARK TURNS FROM DRINK HABIT

Aarhus, Denmark.—Of the 330 communes into which Denmark is divided 270 now favor prohibition, in only 60 is there a majority of the voters in favor of retaining alcohol, according to Larsen Ledet, member of the Danish parliament from this city and leader in the prohibition movement.

According to M. Ledet, "it is hopeless to expect the moral and economic regeneration of Europe unless intoxicating liquor disappears from the face of the earth."
