STEWART AND SON TO EXPIATE CRIME IN ELECTRIC CHAIR

Governor McLean Declines to Interfere With the Sentences; Electrocutation to Take Place Friday

Raleigh, April 15. — Charles W. Stewart and his son, Elmer, will expiate the crime of murder by dying in the electric chair on Friday. Their court of last appeal—the Governor, late yesterday, after giving the case deep consideration, decided "that there are no grounds upon which Executive Clemency should be extended to either prisoner," and therefore declined to interfere with the sentences of the court, which had been affirmed by the Supreme Court.

The Governor, in his statement denying main clemency, asserted that he and Pardon Commissioner, Sink, had gone into the matter carefully, especially with reference to the state's case against Elmer Stewart, in order to ascertain if there was any reasonable way in which clemency might be exercised. He admitted that "evidenced disclosed a typical case of willfulness and premeditated murder, greatly aggravated by the fact that the men whom they killed were officers of the law engaged in faithful attempt to uphold the very laws, which the prisoners had for a long time been engaged in breaking."

Stewart and his son were convicted of the killing of United States Deputy Marshal Sam Lilly and Sheriff Leon George while the officers were on a search for prohibition violators in Brunswick county. The officers were shot from ambush as they drove along the road in a desolate section of the county.

There had been three executions scheduled for Friday, but the Governor yesterday postponed the electrocution of Cheatham Evans, a negro, until May 1. Evans was sentenced to death for the murder of Arthur L. Joyner, a white man of Halifax county.

C. W. Stewart and Elmer Stewart, of Brunswick county, were tried on the charge of first degree murder, at the September, 1924 term of the Superior Court of Brunswick county. Judge Henry A. Grady, presiding and sentenced to death by electrocution. They entered an appeal and their case was heard by the Supreme Court of North Carolina, at the spring term 1925. The Supreme Court sustained the verdict returned in the lower court.

After having been adjudged guilty of murder in the first degree in the county of Brunswick, by the Superior Court of that county, the Stewarts were sentenced to be executed on November 28, 1924. The execution was stayed by their appeal. The Supreme Court's opinion, affirming the verdict and judgment of the Superior Court, automatically fixed the date of electrocution as Friday, April 17, under the terms of a law enacted by the General Assembly of 1925. Prior to that time, execution dates, when defendants lost appeals, were fixed by the Governor. They are now automatically fixed for the third Friday following the Supreme Court's ruling.

It was charged in the indictment that:

"C. W. Stewart and Elmer Stewart, late of Brunswick county, on the 29th day of July, 1924, with force and arms, and in said county, feloniously, wilfully, and of their malice aforethought, did kill and murder Leon George and Sam Lilly, contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State."

The case was prosecuted by Woodus Kellum, Solicitor of the district.

Raleigh, April 15.—Charles W. Stewart and Elmer Stewart, father and son, from Brunswick county, who will be electrocuted Friday, have signed a statement that will be released for publication following their electrocution. This was stated this afternoon by Dr. John H. Norman, warden of the State Prison.

"I do not know the contents of the statement," said Dr. Norman. "I was not present when it was written or signed, but an attorney for the prisoners told me that he had a signed make any confession."

Youth Must Die



William Cavalier, fifteen-year-old boy, who shot his grandmother, Mrs. Peter Cavalier, of Pottsville, Pa., seven times and killed her to steal \$58, will be executed April 27 unless an appeal to the Supreme Court halts the execution. PAINLEVE AGREES TO FORM A NEW FRENCH CABINET

Ex-Premier Notifies the President That He Will Undertake Task Having Been Assured of the Socialists' Support

Paris, April 15.—Ex-Premier Paul Painleve today definitely agreed to form a cabinet in succession to the Herriot ministry.

M. Painleve has, for the President of the Chamber of Deputies, spent a busy morning receiving what were described as eventual collaborators, and many would be ministers. He reported to President Doumergue at 3 o'clock this afternoon that he would undertake the formation of the cabinet having been assured by the Socialists that he would have their support.

It is remarked that the socialists, which shoulders none of the responsibility of power, and according to the party's official reports has only 780,000 members, has been assuming an altogether too predominant role. Predictions are freely made that a Painleve cabinet, with a Socialist foundation, must be expected to encounter the same obstacles as did the Herriot Ministry, and that with the issue of extreme financial difficulties as its climax such a ministry is to hope for only a few weeks of life.

It is understood that a hint has been conveyed to M. Painleve that while it is well enough to have Socialist support, Socialist dictation must end. In circles close to M. Painleve, it is said that beside M. Herriot, there will be only a small representation from the outgoing cabinet in the new combination, and that the Senate will be given a bigger share of government post with a view of gaining a better footing for the cabinet in the upper house.

Summary of Evidence Against Crouch is Received War Dept.

Washington, April 15.—The 40-year sentence imposed by military court at Honolulu on Private Paul M. Crouch, of the 21st Infantry, and a native of North Carolina, was based on evidence that Crouch had enlisted with the purpose of fomenting a revolution, both in the Garrison and Civil population of Hawaii. A summary of the evidence was received today at the War Department and indicated for circulating communist propaganda, and were concerned in plotting against the government before they went to Hawaii.

BRAMHAM AVOWS OUTLOOK VIRGINIA LEAGUE PROMISING

President Says Circuit Completely Organized and Placed on a Strictly Business Basis

Durham, April 15.—"The outlook for a good season in the Virginia League is especially promising," said W. G. Bramham, president of the league, today.

"The circuit," continued President Bramham, "has been completely reorganized and placed on a strictly business basis. The roster of the clubs indicates added strength this year, which justifies the prediction of fine sport throughout the circuit."

"The rules of organized baseball and of the Virginia League will be strictly enforced. I do not anticipate any rowdy conduct on the playing field, but if it occurs heavy penalties will be inflicted upon the offenders. The game will be conducted for ladies and gentlemen and they will be protected against rowdy conduct on the part of both players and fans."

"Supporters of the game should remember that the umpires on the field represent the game in an official capacity and are there to see it played on the square, not to fatten players' batting and fielding averages or to control the result of wagers made by gamblers. They will make mistakes of judgment but they are entitled to the protection and respect of the club owners and the fair minded public. Obnoxious characters who conduct themselves in a rowdy manner should be put out of the parks of the circuit and denied admission for the remainder of the season. Their absence is more beneficial to the game than their financial support."

"Each year we hear charges during the season that this club or that is violating the class or salary limit. Most of these charges are without foundation. The penalties for either offense are severe, both under the Virginia rules and those of the National association."

In this connection, President Bramham declared:

"I will pay to any club, owner, player, manager or sports writer the sum of \$200 who will furnish me, under oath, proof of any such violation which results in the final conviction of the offender before the proper baseball tribunal."

"Instructions to the umpires have been issued and managers advised what is required of them and their players. The fans may expect a season of clean high grade sport, and in behalf of the clubs, I enlist their moral and financial support."

NEWSPAPER MEN MAY WITNESS ELECTROCUTION

Raleigh, April 15.—Attorney General Brummitt ruled today that July accredited newspapermen do not come under the classification of witnesses at electrocutions, and may be admitted to the death chamber in their official capacity. Under the law, only six witnesses and a necessary number of officials may be admitted to electrocutions. The ruling of Mr. Brummitt was made at the request of the State Prison officials. Newspaper men were advised yesterday that the press would be limited to one representative at each electrocution. Warden Norman interpreted the law to include newspaper men in the category witnesses. Protest was made by several correspondents located in Raleigh against the warden's interpretation of the law. Under the ruling of today, Superintendent Pou said accredited newspaper men will be admitted to the electrocutions without any mention of the number.

TEACHERS COLLEGE FINALS TO BEGIN SATURDAY, MAY 30

GERMAN BUTCHER EXECUTED TODAY

Fritz Haarman, Convicted of Murder of 26 Boys and Men, Dies on the Guillotine

Hanover, Germany, April 15.—"I am guilty, gentlemen, but hard though it may be, I want to die as a man." With these words, Fritz Haarman, Hanover butcher, convicted on a charge of murder of 26 boys and men stepped to the guillotine early this morning and a moment later his head was severed from his body. He was pale and nervous, but he maintained his bravado.

In accordance with German law, 12 highly respected citizens were chosen as witnesses. Dressed in silk hats and black Prince Albert coats, they assembled at 6:00 o'clock at the guillotine, which was hidden from their view by a curtain. The guillotine had been erected in a secluded spot of the prison ground. Next to it stood an altar with a crucifix. The prosecuting attorney stepped before the altar dressed in the official judicial robe and read the sentence and court opinion to the assembled panel of jurors, who again acknowledged and affirmed the sentence. When this was done, Haarman, garbed in a grey prison uniform and hand-cuffed, was brought from his cell. When he faced the judges and witnesses, he nervously changed from one leg to the other, and blinked incessantly. He listened in silence as the prosecuting attorney read the sentence and agreement of the charges to the executioner of the verdict. Only as the curtain before the guillotine was withdrawn, did the realization of death seem to dawn on him, and for an instant he appeared to be paralyzed, but as the death bell sounded he pulled himself together and in a few unemotional words acknowledged himself guilty, and ready for execution of the sentence, adding that he felt sorry for his action. A few minutes the blade was dropped.

HEARINGS ON NICKEL PLATE MERGER WILL START TOMORROW

Motion to Postpone the Consideration of the Merger Plan Overruled Today by the Interstate Commerce Commission

Washington, April 15.—A motion to postpone consideration of Vann Swearingen Nickel Plate merger plan filed by a committee representing minority stock holders of the Chesapeake and Ohio railroad, was overruled today by the Interstate Commerce Commission.

Washington, April 15.—Railroad consolidation in the eastern section of the United States, permissible under the Transportation Act, will await the outcome of hearings to be started tomorrow by the Interstate Commerce Commission on the Nickel Plate merger.

This proposal runs counter to the tentative plan of the Commission for consolidation of the 16 odd class one railroads into 19 or 20 great systems in that it proposes to group in one system three roads which had been selected to head as many separate divisions, the Erie, Chesapeake & Ohio and Pere Marquette.

The difference between the two programs outlined by the Commission and O. P. and M. J. Van Swearingen and their associates in the Nickel Plate is the more marked in that actual ownership of railroad stocks and leasing agreements between operating organizations have all been assembled by the Nickel Plate controlling group, while the tentative commission plan has no force in law, there being no compulsory provisions in the Transportation Act on the subject.

With the emergence of the enlarged Nickel Plate as an actual competitor with the Baltimore & Ohio, New York Central, and Pennsylvania roads a division of interest among those railroads also is indicated. The Pennsylvania has submitted its own scheme of taking in additional lines which it suggested the Commission might approve if the Nickel Plate plan is to become effective. This scheme differs in material respects from proposals which the three railroads filed originally. The Commission has acted upon none of those preferring to await the actual showing which will be made during (Continued on page four).

FOREIGN PROPAGANDA!

Our larger cities, it appears, are often-times unfortunately the budding and ripening fields for alien sympathies and militant foreign manifestations. It seems a relentless fate pursues Chicago in particular, charging her with many crimes and attributing to the city government numerous evils which perhaps never even entered her municipal consciousness.

The latest incident, coming as a peaceful lull between the intermittent barks of gangsters' and rival beer-runners' automatics, was a free-for-all fight which terminated a little theatre party, the performance being in Russian, and the audience becoming a trifle restless. The police were called to render a decision. Following is the report of the affair as contained in an editorial of the Masonic Chronicler, of Chicago:

"A fine example of intolerance in perfect flower was recently furnished at the Garrick theatre in this city. Representatives of the Kerensky faction sought to hold a Sunday afternoon mass-meeting at which appeals could be made for funds with which to relieve the sufferings of prisoners and exiles under disapproval by the ruling soviet regime in Russia. Soviet sympathizers made an effort to capture the meeting and prevent the advertised speaker being heard. The soviet disturbers precipitated a riot in which twenty persons were hurt and which the police were two hours in subduing.

"It is claimed that the disturbance was inspired by soviet propagandist chiefs in America. If such is true they are spreading propaganda with which there is very little sympathy here. Free speech is a principle upon

which democracy insists, and the soviets have howled for it loudly and long. They are strong for free speech—for themselves. If anyone else should wish to be heard, down with them. Free speech for us only. No wonder even Emma Goldman became disgusted with the reigning reds of Russia. It is the same old intolerance. Orthodoxy is my doxy and if you have any doxy at all it is heterodoxy.

"The sooner these autocratic, mercenary, persecuting advocates of free speech for themselves and silence for everyone else are taught that the American principle is equal justice for all, the better."

It's about time that the various foreign factions; and ardent alien sympathizers, were sharply brought face to face with the hard fact that Chicago is distinctly an American city, and not a suburb of Moscow or Leningrad. Much consideration is due our big cities by reason of their varied troubles caused by vast alien populations. The jargon of foreign tongues, and peculiarly free customs and practices of the alien, are hardly compatible with true Americanism. Every big city is making valiant efforts to cope with the trying alien situation. The members of police departments and state authorities are daily risking their lives in dealing with excitable foreigners, many of whom consider a pistol or knife an essential part of their daily sartorial appearance.

These fiery adherents of old world doctrines should be severely dealt with. The United States is not a breeding place of revolutionary tendencies, and the free speech guaranteed by our Constitution must not be distorted to suit the individual needs and fancies of the alien. The day of hyphenated-Americanism is over, a divided allegiance to this country is out of the question.

It is becoming seriously alarming when a representative American city is flooded by alien propaganda and un-American sympathy. Legislation along lines of restricted immigration (such as incorporated in the Act of 1924) is the remedy for those ills. Wholesale deportation of undesirables who, by violation of federal and state laws, have forfeited their rights to remain in our country, should be seriously carried out. The dross must be carefully skimmed from the surface of the "melting pot." Thinking citizens of the United States should soon awake to a realization of the fact that crime and internal revolt will never cease until we have educated our vast alien population to the degree of conviction that America demands obedience to her laws, and strict adherence to her national customs.

WILD BEASTS OF THE ZULULAND THREATENED WITH EXTINCTION

Washington.—Appealing to naturalists in the United States to help save from slaughter the fauna of his country, Maj. F. Vaughan-Kirby, game warden of Zululand, S. A., has enlisted the co-operation of the American Nature Association. Maj. Vaughan-Kirby points out to the association that he hopes the coming visit of the Prince of Wales will be of help, and that he has called upon the Society for the Preservation of Fauna of the Empire in England to come to his aid.

The warden explains that in Zululand there is a movement to abandon all game reserves, which would mean the extermination of the once magnificent fauna of the sub-continent, and that he has been powerless to stem it. He believes the Prince of Wales will throw his influence in favor of wild life conservation, and the American Nature Association has issued an appeal to its members throughout the world to write to Maj. Vaughan-Kirby and protest against the continued slaughter of the wild animals of his country.

At an adjourned meeting of the Board of Aldermen held on the 19th day of March, 1925, the foregoing notice of the election was ordered published and Mr. L. H. Bowling, appointed registrar, to open the books for registration on April 10th, and to keep open said books for a period of 20 days, exclusive of Sunday at

various places in the Town of Greenville most convenient for the registration of those citizens not already registered who desire to register and vote in said election.

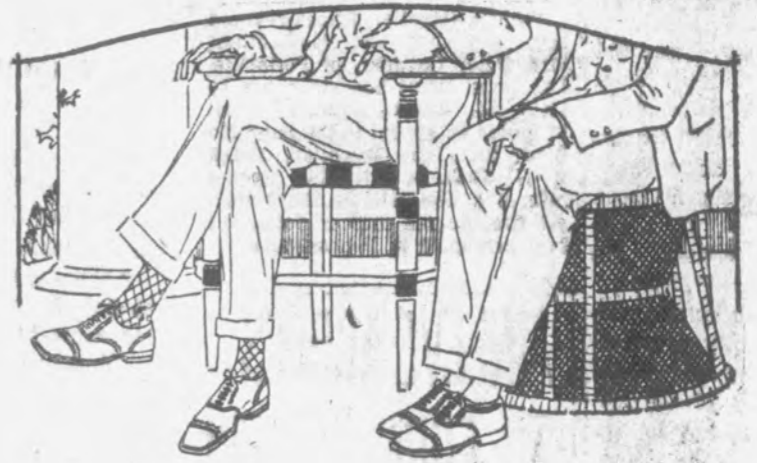

HEARINGS ON THE NICKEL PLATE MERGER TO START THURSDAY

(Continued from page 1)
The Nickel Plate hearings. Through the west, a series of changes in railroad ownerships, most of them following the Commission's tentative consolidation program already have been made effective. The Southern Pacific bought in the El Paso & Southwestern and San Antonio & Arkansas Pass lines and the Rock Island obtained control of the St. Louis Southwestern. It was the theory of Congress in enacting the Transportation Act that consolidations would simplify rate regulation and equalize railroad earnings. The commission was authorized to relieve any railroad from the necessity of obeying the anti-trust laws, which heretofore has operated to block many merger schemes. The first actual step toward consolidation was taken when the Southern Pacific which had been ordered to sell its control of the Central Pacific system by a Supreme Court decision, was allowed to retain the Central Pacific in its entirety. The commission held that its tentative plan for general railroad consolidation contemplated the continued merger of these two systems.

Socialist Motion Defeated Today in Chamber of Deputies

Paris, April 15.—A Socialist motion, that would have prevented the introduction of a bill to legalize an increase in the circulation of the Bank of France, was defeated in the Chamber of Deputies today 322 to 104. After some debate, the Chamber of Deputies ratified the convention with the Bank of France, introduced by M. De Monzie, by a vote of 339 to 275.

Bankhead Highway Ass'n. Will Meet in Houston, Tex., Apr. 20

Statesville, April 15.—The Bankhead Highway Association, of which Colonel Benehan Cameron, of Statesville, is the president, will meet in Houston, Texas, April 20. At the same time there will be a meeting also in Houston, of the United States Good Roads Association, of which Governor E. Lee Trinkle, of Virginia, is president.

Colonel Cameron has been advised that there will be a special train run from Washington to Houston, to be known as the "Presidents' Special." Colonel Cameron and Governor Trinkle will go to Houston on this train, together with delegates from North Carolina and Virginia.

Governor McLean has appointed more than seventy delegates, representing all sections of the State, to represent North Carolina at the Houston meetings. Governor Trinkle, also, has appointed delegates. The two presidents, Colonel Cameron and Governor Trinkle, will spend Sunday, April 19, in New Orleans, where they will be guests of honor of the New Orleans Chamber of Commerce.

The United States Good Roads Show will be held in Houston at the time of the two meetings above mentioned.

Motor Club to Re-open Offices

Mr. Frank G. Dawson, district manager of Northeastern North Carolina, for the Carolina Motor Club, is in this city in the interest of the motorist organization. Mr. Dawson stated this morning that Mr. J. D. Murphy has been employed to take charge of the office here and same will be re-opened within a few

days at the John Flanagan Buggy Company.

Owing to the heavy expense incurred by the state in operating the branch offices of the Secretary of State Automobile License Bureau the state was considering the closing of these branch offices but realizing the value and convenience of these branch offices to the motorist of the various sections of the state the Carolina Motor Club has arranged to take over the handling of the automobile licenses despite the fact that it must do so at a loss.

During its existence the Motor Club has been a great benefit to motorists in the state as well as to tourists who have had occasion to pass through. Besides taking care of the needs of the individual motorists in the way of information together with free road service the club has used its influence and efforts in behalf of the motorists by urging such legislation as was needed and helping to abolish such features as were unnecessary and a burden to motorists.

In cities where a sufficient number of members have been secured for the organization local chapters have been organized and through these local bodies much in the way of advertising the cities and attracting tourists has been accomplished. Mr. Dawson expresses hope that enough members will be secured in Greenville to justify a chapter here as he feels that it will prove a great benefit to the city as well as to the in-

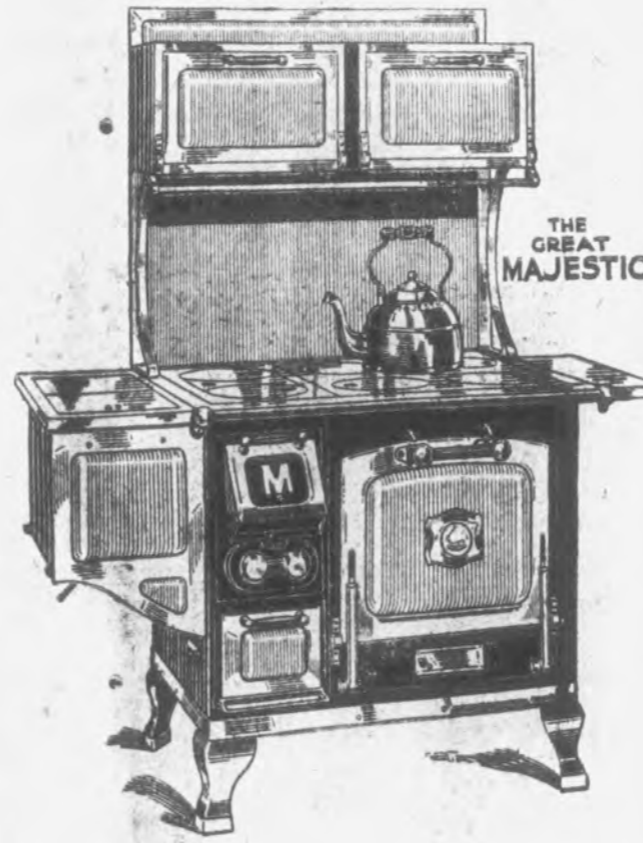
