MEET TO CONSIDER FISH CONSERVATION HE HELD MAY 22

Governors of Coastal States Invited to Meet in Washington to Consider the Question

Washington, April 29.—Declaring the question had become one of utmost national importance, Secretary Hoover today invited Governors of Coastal States from Maine to Texas to send representatives here May 22 to consider fish conservation along the Atlantic and Gulf Coasts.

"In thirty years the shad catch of the Atlantic Coast has decreased 37,000,000 pounds, or 75 percent," he told the Governors, "Sturgeon, 2,890,000 pounds, or 88 percent, and lobsters nearly 20,000,000 pounds, or nearly 66 percent, while the cost to the public of shad increased five fold, sturgeon eight fold, and lobster nine fold.

Means of rehabilitating these fisheries must be found. The problem can not be solved by any one state alone, and any extension of federal authorities is most undesirable. Therefore it is our purpose to discuss such provisions as might be made for coordinated state action toward these ends. I believe it is possible to work out some basis of interstate action that should serve to preserve these fisheries.

Mr. Hoover pointed out that considerable benefit had resulted in Pacific Coast waters from conservation of Salmon fisheries. At the last convention of the United States Fisheries, he also outlined a series of propositions on "Cultivation of a sense of National Responsibility toward fisheries and their maintenance."

New Outbreaks of Fighting Gov. Troops and Communists

Rome, April 29.—A dispatch to Tribuna from its Sofia correspondent reports a new outbreak of fighting between Bulgarian Government troops and Communists. Casualties are not known, but the dispatch says they are believed to be fairly heavy. According to the story, there was a sanguinary battle last yesterday between government troops and Communists. The population of Sofia became panic stricken because of intermittent explosions, and street traffic was stopped. A stricken censorship prevailed, the dispatch added, and the explosions were caused by attempts of government forces to blast Communists out of underground tunnels, where they had taken refuge.

Hand Car Wrecked Two Negroes Injured

Richard, Thigpen and Willie E. Brown, well known colored men of this city and section hands on the Norfolk-Southern railroad are in the St. Francis Hospital suffering from injuries received when a hand car on which they were riding was wrecked near the Greenville Ice Plant. Thigpen suffered a fractured leg and injuries to his head while Brown also received serious injuries.

Marshall Appointed Asst. Atty. General Succeeding Holland

Washington, April 29.—John Marshall, of Parkersburg, West Virginia, today was appointed to be Assistant Attorney General, succeeding Robert L. Holland, of Ohio, who resigned.

GOLD DRAWS ADVENTURES INTO TROPICAL SURINAM

The Hague.—Baron A. J. van Heemstra, governor of Dutch Guiana does not cease expressing his admiration for the enterprise of Americans in his colony.

Gold draws these adventurers, according to the governor, and American engineers now are seeking the location of a rich lode in the far interior from which the present lowland alluvial deposits must have come.

Local papers in Surinam are full of admiration for the go-ahead methods pursued by Americans in that country, especially their organization of air transport which does away with the slow and cumbersome travel by river boats.

MEMBERS OF KLAN ATTACKED WHILE LEAVING MEETING

Several Injured While Running Through a Continuous Shower of Rocks and Bricks

Whittsville, Mass., April 29.—Police were planning today to conduct an investigation into the disorder which marked the meeting of the Ku Klux Klan in North Bridge early this morning, when 150 members were attacked by 200 men as they attempted to leave the meeting place. State police also were considering the possibility of an investigation to learn the leaders of the attacking forces which met the klansmen with a fusillade of stones and bricks, which smashed automobiles, and injured the machines and, which it was claimed, injured several of the klansmen. While the klansmen were leaving the field, running through continuous shower of rocks and bricks, nine members of the police patrol rushed to the scene to aid the klansmen, however, nearly all the klansmen had left the field when they arrived.

FLORIDA DRAWS SPENDERS FROM SHORES OF FRANCE

London.—The balmy winter climate of Florida, long a lure to Americans from the cold northern states, has begun to draw wealthy Britons away from their sunny but chilly coasts along the Riviera.

The winter just ended saw hundreds of leisured Londoners cross the Atlantic to get away from the fogs and rain of their gray and gloomy capital. Formerly only a few score Englishmen took the time and trouble to discover the sunshine of the West Indies and Florida. The steamship companies have begun to trumpet the attractions of both, and expect increasing numbers of tourists to cross the Atlantic next winter in search of bright skies and soft southern breezes.

Those who have tried the trip bring back tempting tales of their experiences. One relishes a winter swim in the gulf, they say, whereas along the Riviera winter-time dips in the Mediterranean are taken only by the younger and brawnier visitors

SAYS GERMANY'S FOREIGN POLICY NOT BE CHANGED

Dr. Hans Luther Addresses Annual Conference of League of German Industry and Commerce

Berlin, April 29.—Germany's foreign policy will not be changed, Dr. Hans Luther, German Chancellor declared emphatically today in an address before the annual conference of the League of German Industry and Commerce. This declaration is understood to reflect a viewpoint of President Elect, Von Hindenburg, with whom Chancellor Luther conferred yesterday.

At the same time, Dr. Luther issued a statement dealing with the evacuation of occupied territory in which he stated that "in order to bring about stable conditions in Europe, the question of the evacuation of the Cologne areas by the allies must be speedily settled."

"For more than three months we have waited in vain for the reasons to justify the non evacuation."

While Dr. Luther, in his speech, did not refer to the recent election, it was generally understood that he spoke with full authority on Von Hindenburg, and the forces which represented the Field Marshal's candidacy.

Five President Type Vessels to Be Sold To Dollar Interest

Washington, April 29.—Contract was executed today for the sale by the shipping board to the dollar interest of the five President Type vessels in the service of the California Orient Line. Approval of the shipping board was given to the contract as drawn by its counsel and R. S. Dollar, Vice President of the Dollar Lines, and Chairman O'Connor, of the shipping board, who signed the contract.

Suspended Judgments Featured Tuesday's Court

Tuesday's session of County Court was featured with suspended judgments. A large docket was disposed of with several defendants being fined and given road sentences.

Z. V. Johnson was adjudged not guilty on the charge of driving auto while drunk.

The case of Hugh Lewis, Fred Lewis, Claude Jones, Herbert Evans, Dalton Parker, charged with being drunk and disorderly on highway, was transferred to Superior Court for jury under bond of \$150 each.

Hugh Lewis, Fred Lewis, Claude Jones, Herbert Evans, Dalton Harper, charged with trespass. Cause transferred to Superior Court under bond of \$50 each.

Walter Keel, was adjudged guilty of non support and judgment was suspended two years during good behavior and payment of costs. Defendant allowed time to pay cost.

Ben Atkinson, Colleen Taylor, Walter Barfield, McKinley Barfield, charged with the charge of transporting liquor. Judgment that each defendant pay a fine of \$50 and 1-4 cost each.

ALEX RODMAN IS GRANTED REPRIEVE BY M'LEAN TODAY

Sentenced to Die in the Electric Chair Friday, May 1, on Charge of Murder; Sink to Make Investigation

Raleigh, April 29.—Governor McLean today reprieved Alex Rodman, Mecklenburg County, scheduled to die, in the electric chair on a charge of murder, on Friday, May 1, to Saturday, May 2. This, under the terms of an act passed by the General Assembly of 1925, automatically grants a stay of execution until the third Friday following, which will be May 22.

In the meantime the governor has directed Hoyle Sink, Commissioner of Pardon, to visit Mecklenburg County with a view to ascertain whether there was evidence which might have been brought out at the trial, but which was not brought out.

May Call Special Session to Try Paul Rubber Co. Case

Asheville, April 29.—A special session of Federal District Court probably will be called here by Judge Webb to try the Paul Rubber Company case, of Salisbury, in which indictments are pending against the officials of that Company for alleged violation of the Postal Laws.

This was learned today when the docket of the approaching May term of court for criminal cases was completed. The Paul Company case was not set down for trial at the regular term, and Deputy Clerk of the court said a special session would be called later to handle the case.

Five Killed and Two Injured in Fire in Portland

Portland, Oregon, April 29.—Five persons were killed and two others probably fatally injured in a fire early today which swept the Hendricks Apartment here.

BODY OF KITCHEN FOUND IN CREEK

Coroner's Jury Believes Deceased Was Killed by George Geer, a Negro

Salisbury, April 29.—A coroner's jury investigating the death of Special Officer, Charles E. Kitchen, of the Southern Railway, whose body was found yesterday afternoon in a creek near that city today feel that the deceased came to his death from wounds inflicted by some blunt instrument in the hands of George Greene, a negro, who is in a hospital here with what will probably be fatal wounds in the abdomen.

LONDON TAKES TO WHIPPET RACES

London.—Whippet racing, long a popular sport in the north of England, has reached London, where meets are held weekly at various athletic grounds. Instead of chasing rabbits or hares, the dogs race toward their masters at the end of the course.

The dogs are treated much the same as race horses and appear to enjoy the races as much as their owners and followers of the pastime. Books are made on each race and the course takes on much of the aspect of a miniature horse race track.

M'LEAN BE REQUESTED DESIGNATE WEEK OCT 12-19 'HOME COMING WEEK'

Raleigh, April 29.—Governor McLean will be requested to designate the week of October 12-19, 1925, as "Home coming week for North Carolina," and to appoint a home coming commission to make the celebration state wide in its scope, it was decided today at a meeting held here at which practically every section of the state was represented. Chambers of Commerce, railroad interests, and Educational and Historical organizations of the state were represented at the meeting. The affair will be in line with an act of the 1924 Special Session of the General Assembly, which designated October as the month for the Home Coming celebration throughout the state.

Dr. Charles E. Brooks, President of State College, presided over today's meeting and it was announced that the meeting of a committee of the whole would call on the Governor later today to lay the matter before him, and ask his official sanction.

EXPLOSION WRECKS PART OF BOSTON RUBBER SHOE CO.

Death List May Reach Three, Officials Announce After Preliminary Check Up

Malden, Mass., April 29.—The death list from an explosion, which wrecked a part of the Boston Rubber Shoe Co., on Commercial street in that city, today may reach three, officials announced after a preliminary check-up. Two employees are known to have been at work where the explosion occurred, and a third is dying in a hospital. The explosion was heard for miles around, and was followed by a fire.

Additional Guards Assigned to Protect Sec. Chamberlain

London, April 29.—Additional guards have been assigned to protect Foreign Secretary Austin Chamberlain, presumably in connection with the discovery of a plot against his life.

Bulgarian Gov't. Considering Calling Army Class to Colors

Sofia, April 29.—The Bulgarian government is considering calling out one of the army classes to the colors, as it has been unable to get the 10,000 additional volunteers recently authorized by the council of Ambassadors at Paris, to settle the affairs of the country.

France May Return to Gold Standard

Paris, April 29.—The establishment of a Gold Standard by Great Britain will necessitate France taking the same step, in the opinion of the best informed French official authorities. Minister of Finance, Caillaux, already is studying the question, and has intimated that if necessary the French people will make sacrifice to accomplish the return to the Gold Standard.

LOCAL PHYSICIAN CHOICE OF BOARD HEALTH DIRECTOR

Dr. C. O'H. Laughinghouse Undecided as to Acceptance of Position to Succeed Rankin

Pinehurst, April 29.—Dr. Charles O'Hagan Laughinghouse, of Greenville, was the choice of the State Board of Health as the successor of retiring Secretary Watson S. Rankin, when it met last night, following the evening session of the State Medical Society.

Dr. Laughinghouse was undecided as to accepting the post and there was talk of postponing the election as it was explained that Dr. Rankin's term of office does not expire until July first, and that while he will probably retire sooner than that, Dr. George M. Cooper, who was in charge during Dr. Rankin's year's leave of absence, can continue the affairs of the office until that time. If a successor is elected prior to that time it would be for an unexpired term of office.

Wolfe Addresses the American Water Works Association

Louisville, Ky., April 29.—Discriminatory and excessive taxation of public utilities creates an extra and unnecessary burden for customers of the light, water, gas, traction and telephone utilities declared H. Carl Wolfe, engineer of the Maryland Public Service commission, speaking today before the American Water Works Association.

He said there are virtually as many utility patrons as there are taxpayers and that "efforts to shift the tax load to the utilities are futile because to obtain money with which to pay taxes, the utilities turn to their customers."

"If the principle of equality is to prevail," Mr. Wolfe continued, "the burden of the taxes upon public utilities should correspond to the taxes levied upon other kinds of property and business. Possession of property by the public utility should measure taxpaying obligations to the extent that similar property is actually taxed to other owners. But the factor of assessment at less than true value must not be overlooked."

Summary of Crop Weather Conditions Week Ending Tues.

Washington, April 29.—Crop and weather conditions in Southern States for the week ended yesterday were summarized by the Department of Agriculture today as follows:

In the South Atlantic States it has become too dry, especially for proper germination of late planted seed. However, rains at the close of the week were beneficial in North Carolina, and planting made good advance in Virginia. Condition of fruit seems good throughout the country, although heavy damages from various causes are in many localities. Tobacco is doing well and transplanting has begun as far north as Tennessee and North Carolina.

For North Carolina, the report said, the week had been dry, and abnormally warm. It was unfavorable for wheat, oats, strawberries and lettuce, but beneficial showers and cooler weather at the close of the week helped. Good progress has been made in cotton planting in the upland section, while tobacco has been set out in the coast. Truck farming is good, and peaches and apples are doing better.

Gary, Indiana, April 29.—A pair of eye glasses for a middle aged man and a woman's suede left shoe were keys here today by authorities investigating the death of an unidentified girl, whose dismembered burned and bullet riddled body was found Sunday near Chesterton, Indiana.

"THE CASUALTY LIST GOES ON"

The Casualty List goes on. The World War ended November 11, 1918, for most of us. Since that date America has not seized its morning newspaper to read in haste, and in fear, that list of those "Dead on the Field of Honor." The poppies of six summers have covered the scars of Flanders Field and babies walk and talk and play, who were not born when the last shell burst beyond the Meuse. But the casualty list goes on.

During 1924 more than five thousand men died in the United States from disabilities directly originating in their World War service. These are the deaths officially recorded and certified by the government as due to war causes. There were others not so of record.

Fifteen every day. And the others not of record. At each sunset we know that fifteen more have gone, "Dead on the Field of Honor,"

as surely as those who rest under the little crosses, row on row, in Northern France. Not mercifully "killed in action," but mercilessly scarred and maimed and tortured these long years, going at last to a rest they have earned not once but a thousand times. And the widows and the orphans are here in more numbers today than yesterday, and more tomorrow than today.

In 1922 the deaths "directly traceable to service origin" were 4,556. In 1923 they fell off to 4,304. In the first half of 1924 they rose again, to 2,721 for half a year. Where is the end to be?

Five thousand children of veterans are orphaned and dependent now. By 1932 it is estimated the number will be 38,000. Several hundred of these children are in dire need, are emergency cases for whom provision, if it is to be made, must be made quickly.

It is to aid these two sufferers of the war, the disabled and the orphans, that The American Legion is now engaged in raising an endowment fund of \$5,000,000. The fund, to be held in trust forever, will place on a permanent financial basis the rehabilitation work being done by the Legion.

The Legion has said publicly that while it has assumed the obligation of looking after the disabled and the orphans, the responsibility for their welfare lies as much with the public as with the ex-service men. The public now has the opportunity of assuming its share by contributing to the endowment fund.

The cause is worthy and has a great appeal and the Legion should encounter no great obstacles in raising this comparatively small sum of money. The work is such as the Legion can efficiently do, and by doing it the veteran organization seems bound in the direction its founders pointed it seven years ago.

Charlotte, April 22.—The super-racer with the super-chargers—forecasting super-speed—will be the outstanding feature of Charlotte's speed classic here on May 11.

The same cars that carried Tommy Milton, Benny Hill, Peter DePaolo and Harry Hartz around the Culver City bowl at the unprecedented speed of 135 miles an hour, will whiz around the Charlotte oval in the May 11 race. It is freely predicted that the local track record of 118.4 miles an hour will be shattered. Whether the new mark of 126 miles an hour for 250 miles hung up at Los Angeles on March 1 will topple and fall by the wayside, remains to be seen. Race enthusiasts who saw the big classic here last October will remember the memorable speed duel between Tommy Milton and Earl Cooper. 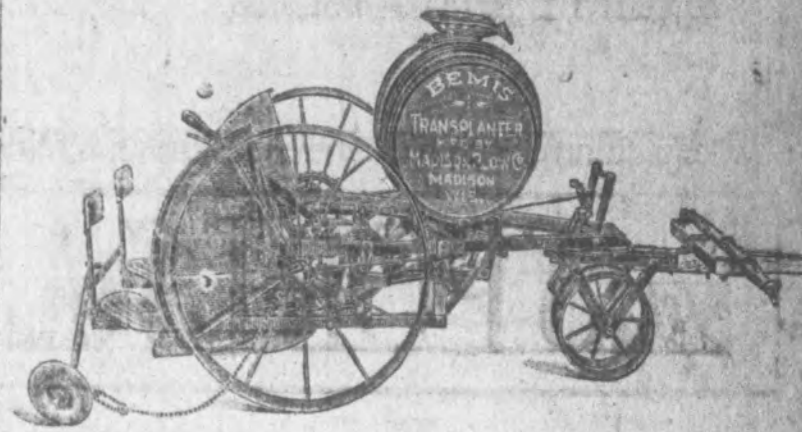

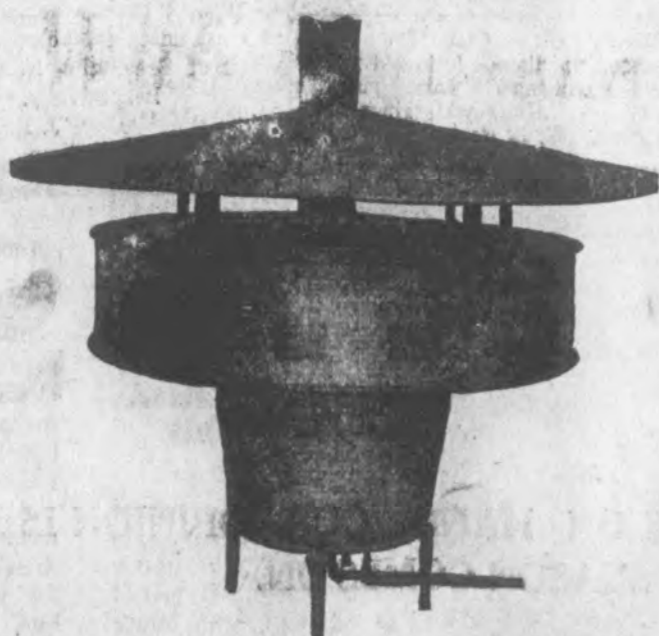
