Judge Meekins Finds
No Evidence to Justify
a Receivership, However Ass'n. Remains "Under the Wing" of Court

Raleigh, April 3.—(AP)—Winners in the bankruptcy proceedings brought against it in Federal Court here, the Tri-State Tobacco Growers' Co-operative Marketing Association nevertheless remains "under the wing" of the court with Judge I. M. Meekins retaining the liberty of changing the decision should occasion demand.

Creditor banks are also and party defendants to the order and both they and the association are restrained from dissipating the assets of the association freezing on the association's indebtedness or otherwise disturbing the situation. The association is restrained from doing any extra ordinary business, although it may carry on its usual affairs. The order was signed late last night after conference held with Judge Meekins with opposing counsel. The order was signed some four and one half hours after court adjourned at the conclusion of argument late yesterday afternoon. The case, which opened Monday morning, occupied five full days.

In signing the order Judge Meekins made this comment: "On this record there is no evidence to justify a receivership at this time. However, I think this association should be retained under the wing of the court and I have no intention of turning it loose."

Files Petition
Prevent Paying
Chaplains Salaries

Washington, April 3.—(AP)—The petition for an injunction to prevent payment of the salaries of Chaplain of the senate and house and of all clergymen attached to the navy and department was filed in District of Columbia supreme court today. James I. Elliott, member of the recently chartered American association for the advancement of atheism is the plaintiff and Frank White, treasurer of the United States, is defendant.

The petition sets forth that "the employment of chaplains in the congress of the United States, in the department of navy and the department of war, constitutes the promotion of the establishment of religion and sectarian views, and objects in violation of article one of the constitution which provides that the congress shall make no law respecting the establishment of religion or prohibit the free exercise thereof."

Chaplains employed in the department of the government are ecclesiastics, engaged in the performance of the religion and sectarian duty not authorized and expressly prohibited by the constitution, the petition continues, and the compensation authorized under appropriation acts is a diversion of the funds of the United States for a purpose not with the delegated powers of congress to legislate upon.

Ordered Dissolve

Baltimore, April 3.—(AP)—The Ward Food Products Corporation under Maryland laws with an assessed capitalization of \$2,000,000, is ordered to dissolve within thirty days and surrender its charter to the State under a consent decree issued by Judge Morris A. Soper, in Federal District Court here today.

The decree provides also that the capital stock of the General Baking Corporation shall be decreased and orders complete separation of the Ward Baking Corporation, the General Baking Corporation and the Continental Baking Corporation.

CHAPMAN CALMLY
AWAITS HIS DEATH

Appointment With
Death By Way of
New Hanging Machine Less Than 70
Hours Away

Weathersfield Conn., April 3.—(AP)—Gerald Chapman's appointment with death by way of Connecticut's new hanging machine, which throttles out life with a double jerk, was less than 70 hours away today. The bandit spent all of yesterday calmly reading and smoking cigarettes in his cell at state prison while his attorneys worked feverishly to save him from the ever nearing gallows. Only once did he betray anxiety when he was visited by a member of his counsel. Chapman anxiously inquired would this man return again today, and appeared relieved when given an affirmative reply. Frederick J. Groehl, head of the Chapman defense attorneys, refused to have much to say today, but this morning he was to appear before Judge Jennings of the superior court and request a new trial on the strength of affidavits from six or seven new witnesses of the murder, for which Chapman stands convicted. Mr. Groehl said he would have all witnesses on hand in case Judge Jennings required their appearance.

Hartford, Conn., April 3.—(AP)—Judge N. A. Jennings destroyed Gerald Chapman's last hope of escaping the gallows Monday night through court action by ruling this afternoon that the new evidence presented by his attorneys was not worthy of hearing in a formal motion for a new trial.

Chapman's only chance now lies in the board of pardons or an executive reprieve. Judge Jennings said he would see the Governor this afternoon and "talk the case over."

Rioting Between
Hindus, Moslems
Breaks Out Again

Calcutta, India, April 3.—(AP)—Rioting between the Hindus and Moslems broke out in Calcutta again this morning and the situation appears to be more serious. A greater number of persons were killed and injured today than yesterday. Reports yesterday said that 20 persons were killed and 150 injured when Moslems barred the way to the procession of Hindus near Mosque in the northern part of the city.

Washington, April 3.—(AP)—A note declining the League of Nations' invitation to the World Court conference at Geneva will be forwarded early next week by Secretary Kellogg.

Instead of meeting other nations in conference to discuss the American reservations to the court, the United States will continue direct negotiations on that subject with the signatories to the court protocol.

Planes Versus Mosquitoes.
Cormiere Is Dead.
2,000,000 Always Sick.
The Murders of 1925.

The Marines at Quantico, Va., will fight mosquitoes this summer with flying machines. Commander McLean will scatter from planes sawdust soaked in water containing a little arsenic. It isn't strong enough to hurt humans, birds, fishes—in fact, it's a good tonic for them. But it will destroy mosquitoes in swamps, creeks or stagnant water instantly just as a slap that does not hurt your cheek kills the mosquito.

The government ought to be doing that work everywhere. To rid the entire country of mosquitoes would be worth fifty times the national debt. It is said that the Rockefeller Foundation, which seeks to PREVENT DISEASE, rather than cure individuals, may try the flying machine mosquito attack. If successful, it would end yellow fever and malaria FOREVER.

Now turn to news from Great Britain. There the prison population has fallen off in twelve years. Since the war twenty-five jails have been remodeled for other purposes. Here we haven't enough. How do you explain that? Easily. Bootlegging, creating a new crop of millionaires, bringing in hundreds of millions every year, has created a new crop of murderers and other criminals.

Chinese doctors are paid when their patients are well. No pay when they are sick. If Uncle Sam could arrange that for his children he would save money. Every day there are 2,300,000 sick people in the United States—a loss of 50,000,000 working days every year. Allow \$5 for each day in these high wage times, and you have enough to pay the national debt. Worse than the loss of wages is shortening of life. Colds, that people neglect or despise, weaken the system permanently, and cut so many months from your life at the far end.

Science proves that canned vegetables retain their full quota of vitamins. This has been known for a long time to doctors that gave canned tomatoes to infants in public institutions, unable to afford fresh orange juice. The juice of the tomato is rich in vitamins, which makes it important to include a well-made tomato soup or canned tomatoes, stewed, in the regular family diet.

When President Coolidge and Secretary Mellon decided to cut income taxes, they were told they wouldn't raise enough money to pay government expenses. Now, with lower taxes, total payments for March were \$54,000,000 greater than in March last year. The government will have a comfortable surplus. Excessive taxation is never profitable for the taxed or taxpayer. The Turkey is a thing long ago.

HEARINGS ON
PROHIBITION TO
BEGIN MONDAY

Wet Leaders Busy
Re-Arranging Plans
for Start of Hearings; Drys to Have
Second Week

Washington, April 3.—(AP)—Wet leaders were busy rearranging their plans for the start of the prohibition hearings Monday. A change was necessary after the judiciary subcommittee had refused to summon witnesses other than government officials and the additions of a new administration bill for tightening up the Volstead Act also gave them new matter to discuss.

The modification forces have been allotted the first week of the hearings, to present their case and had asked the committee to call a number of city and state officials and others to testify.

The drys will have the second week and are expected to urge a favorable report on the drastic prohibition law amendment recommended by Assistant Secretary Andrews of the treasury.

The action of the judiciary subcommittee in refusing to subpoena witnesses was described by Senator Edge, republican, of New Jersey, one of the authors of the modification bill, to be considered as an effort to prevent the wets from presenting valuable information.

Chairman Means and Senator Walsh, democrat, of Montana, held that the action was in line with long established practice of requiring proponents and opponents of legislation to supply their own witnesses at hearings. But Senator Edge contended that when one recalls the witnesses subpoenaed in past investigations on matters in no way as important, the committee's decision will surely provoke speculation.

Harry Bartley Is
Exhonerated of
Murder Charges

Asheville, April 3.—(AP)—Harry Bartley, local jeweler, was exonerated of charges of murder in connection with the death of Lindsey Campbell when a jury in Buncombe county superior court returned a verdict of not guilty shortly before noon today after deliberating 15 minutes.

The evidence showed Campbell had come to the Bartley home in the early morning of November 1 in an intoxicated condition. After knocking and kicking on the door he aroused Bartley from sleep. The defendant ordered Campbell away but he refused to go and declared he had come to tea, the house down. He broke a pane of glass in the front door and Bartley fired a shot from a shot gun into the ceiling to frighten him away. Bartley testified that Campbell said "You missed me that time." Bartley then opened the door and remonstrated with Campbell but the latter plunged at him and Bartley shot him in the thigh.

Campbell was taken to a hospital for treatment, but blood poison developed and he died a week later.

Loss for State
Totalled \$783,544

Raleigh, April 3.—(AP)—A fire loss for North Carolina of \$783,544 for the month of February is reported by the State Insurance Department. This loss was caused by 216 fires. The figure shows an increase both in the number of fires and the damage over February 1925 when the number of fires was reported as 184 and the damage \$518,088. The figures show an improvement over January of this year however, when 268 fires caused damage estimated by the Department at \$708,725.

The unveiling took place this afternoon with Miss Emma Long and Mrs. Frances Long Taylor, daughters of the physicians, pulling the chord lifting the cloth covering from the bust.

Chief Justice Richard B. Russell, of the Supreme Court of Georgia, made the presentation at the statue on behalf of the Crawford W. Long Memorial Association, after which Attorney General Nepper, of Georgia, presented it to the United States Government on behalf of the State of Georgia.

MEDITATION"THE TESTIMONY OF
THE ANGEL"

St. Matthew 28:6: "He is not here: He is risen, as He said."

The battlefield of Gettysburg, once soaked with blood, is now a fertile and pleasant spot. The ground torn and ploughed with shells is now planted with potatoes, and wild flowers turn their multi-colored blossoms to the smiling, peaceful sun.

Other battlefields have similarly passed away, leaving only their name and story. But around the tomb of Jesus the hottest battles of the centuries have raged.

I do not mean the sanguinary fights of the Crusaders who, roused by the eloquence of Peter the Hermit, marched through Europe to Palestine to rescue the tomb from the hands of unholy Saracens; nor do I refer to the capture of the Holy City and its sepulchre by the Christian arms of the British, nine years ago under General Allenby; but I refer to the armies of unbelievers who have flocked to the Savior's borrowed grave, and have denied the testimony of the Angel who said: "He is not here: He is risen."

1. Some have said that Jesus did not really die. He only fainted on the cross, and the coolness of the rocky grave, belonging to Joseph of Arimathea, revived Him. But they forget the spear thrust into His side which was sufficient and satisfactory evidence to the experienced Roman Centurion that He was actually dead.

Surgeons, physicians and scientists agree that the "blood and water" which came from the pierced pericardium of His heart was sure proof of real death.

2. Others, seeing the folly of trying to disprove the Resurrection by denying Christ's death, have taken the other side and said:

"Yes, He died all right, and was buried in the garden; but He never rose again. In the stillness of the night, by the bright light of the Paschal moon, His followers opened the grave and spirited His body away. The grave was later found empty—but He still sleeps somewhere under the Syrian stars. The angel was mistaken when

he said, 'He is risen.'"

But this supposition is disproved by the sealed tomb, by the watchful Roman guards, by the crafty and cruel eyes of the religious leaders of the people. If there was any truth in this assertion, would not the rulers of the Sanhedrim and the Roman officials both alike have rejoiced to make it known? They would have silenced the claims of the early Christians and stifled their romance at once and forever by the sight of the stolen corpse. But they could not produce it, and it was left to unbelievers of centuries later to suggest this foolish theory.

3. Others, again have asserted that the idea of the Resurrection of Jesus was born in the sentimental fancies of the disciples. Mary, of Magdala, in the abandonment of her love and grief, thought she saw Him in the garden—it was only her excited fancy. A murmur through the olive trees in Gethsemane; a rustle among the rushes on the banks of the brook Kedron; the weird, mysterious moans of the midnight wind winding around the three crosses on the ghost-haunted "Place of Skulls": on some such mental and temperamental ground the idea of the Resurrection was built up.

But that would be more miraculous than the Resurrection itself! You cannot build a lasting effect on so vague a cause. The evidences of the Resurrection were not ghostly but real; not flimsy fancies but cold hard facts; and the disciples were not dreamers or visionaries, but skeptical men who would not be deceived by a myth. "Christ died, yea, rather hath risen again," they cried. To say that one half of the sentence is to be taken literally, and the other half figuratively, is to destroy every principal of interpretation and make ourselves ridiculous. If the death of Christ was real, we may be absolutely sure His resurrection was real also, and the testimony of the angel is true.

4. Admitting all this, another class of unbelievers have said, "Yes, Christ died and rose again, but not in the literal way. It was a spiritual Resurrection."

It is a great thing to live in the lives and hearts of those who come after us. But the Resurrection of Jesus was not a mystical spiritualized rising. It was as actual and as real as His crucifixion and death.

All these arguments are made to do away with the miracle of the Resurrection. It is a marvelous thing, an impossible thing, for a body to rise from the dead. But not if you connect God with it. "Why should it be thought incredible that God can raise the dead?" Doth He not raise the seed in yonder wheat field until it lives again in the golden harvest?

It is not incredible, and the angel's assertion, "He is risen, as He said," still stands as the truth.

For the reality of the Resurrection rests on the reality of the Gospel. It is evident that something occurred on that first day of the week, "as it began to dawn," that turned the fearful and unbelieving disciples into courageous apos-

les and martyrs, and that has changed the character of the world's civilization. And we accept the infidel sneer as simple truth: "It is upon an empty tomb that the Church is erected."

598 Killed in
Traffic Accidents
in Three Months

Eleven Southern States yielded a total of 598 dead and 3,316 injured in traffic accidents during the first three months of 1926. The consolidations of weekly surveys by the Associated Press revealed today. This consolidation left out the remaining three days of March, winding up the period with last night. Accidents by train, automobiles, trolley cars, and motorcycles were taken into account in the compilation of the surveys.

Florida and North Carolina led in the number of deaths with for the three months, while North Florida slightly ahead with 120. Arkansas trailed the list with only 29 deaths for the period. Florida also led the injured column with 666, North Carolina coming fifth with 285 injured. South Carolina was last in this column with 68.

The county by months follows: January, 233 dead, 1,271 injured; February, 199 dead, 1,118 injured; March, 166 dead, 927 injured; total, 598 dead, 3,316 injured.

It will be noted there was a gradual falling off each succeeding month in the deaths and injuries but with the opening of spring and a great increase of automobile travel it was believed by traffic experts that the number of accidents would show an increase.

Gossip of Staff Correspondents at World Centers of Population.

Washington, April 1.—(INS)—A wide variety of historic land and buildings, long since abandoned, will be sold by the Treasury Department, if legislation now before Congress is enacted.

Among the items specified are lots at Sitka, Alaska, acquired from the Russian government; an old custom house at Wrangell, Alaska; abandoned boarding stations for the Customs Service at Pass, a L'Outre, Southwest Pass and the Jump, Louisiana; and the old custom house lot at Astoria, Oregon.

Funds from the sale would be deposited in the Treasury as miscellaneous receipts.

Senator Copeland, of New York, has introduced a bill to amend the Migratory Bird Act, and throw greater safeguards around American game birds, many of whom he believes are in danger of extinction.

In addition to woodcocks which would be unmolested under the Copeland bill for five years, the following limits are provided for one day's hunting:

Ducks, 15; geese, 4; brant, 4; rails, coot and gallinules, 15; black bellied and golden plovers and greater and lesser yellow legs, 10; Wilson snipe or jack snipe, 15; mourning dove, 15.

"The Last of the Sioux," once a dreadful tribe that massacred General Custer and his men, will soon be known by name if Congress adopts a bill which calls for a final roll of the famous Nation for the purpose of determining the per capita share of individuals in all tribal trust funds, held on

January 1, 1930.

Indians with one-eighth or more Sioux blood in their veins would be enrolled if their claims to the heritage are passed upon by a majority of the Tribal Business Committee.

First steps towards establishing a national military park to include all of the Bull Run battle fields are provided in a bill now before Congress. Creating a commission to inspect the historical grounds, the bill would authorize \$5,000 for the survey.

Head of the government who so often hear themselves and their departments attacked from the floors of both houses, may soon be given the right to defend themselves "right on the spot" and verbally, if Congress adopts Senator Couzens' bill to grant them privileges of the floor and the right to participate in debate.

The Couzens' Bill not only would allow each department head to engage in debate on issues relating to his business, but would allow them to attend the House sessions on Monday of each week and the Senate sessions on Wednesday to give information asked of them by resolution.

Tri-State Tobacco Co-Op Association Winners In Bankruptcy Proceedings

(Continued from page 1, first sect.)

The suit instituted against the Tri-State Tobacco Growers Co-operative Association by five members of the Association residing in the state of Virginia was the culmination of internal troubles which had bothered the organization for a considerable length of time. In this action the five plaintiffs charged insolvency and a number of other counts which they said prevented the Association from functioning properly. They therefore sought dissolution by the appointment of a receiver to wind up the concern and dispose of its assets for the benefit of the growers. Chief among the allegations of the suit were charges of incompetency, wastefulness, fraud and misrepresentation in securing a sign-up of members, wrongful diversion of assets of the Association, and conducting of legislative lobbies—all resulting in insolvency and costing the growers large sums which were subtracted from the price of their tobacco.

For several years the Association, which is composed of tobacco growers of Virginia, North Carolina and South Carolina, had had difficulty in securing deliveries of tobacco by all of its members. The trouble appeared to be caused by the fact that on the auction markets growers were able to obtain the full cash payment for tobacco while the Association members received a part-payment at the time of delivery and the balance at a later date. The Association claimed that its entry into the field had caused a general increase in the price which the grower obtained for his tobacco but this increase was reflected as well on the auction floors. Inability to obtain full payments caused unrest among the members and resulted in contract-breaking.

In a number of cases the Association went to court and ob-

tained injunctions compelling delivery and later, when there were violations of the court order, contempt proceedings were resorted to with the result that some growers faced fines and imprisonment.

Institution of court proceedings, however, failed to check the discontent or defections among some elements of the membership and a number of meetings were held, chiefly in North Carolina and Virginia territory, which had for their purpose protesting against and subsequent withdrawal from the Association. In 1923 a test case was tried in Superior Court at Greenville, in which a grower named Pittman, charged mismanagement by the Association and sought release from his contract, offering this plea as a defense for having violated its terms. This case, indirectly, involved the existence of the Association for had this grower been released from his contract others would have had the same recourse on the same grounds. Evidence on salaries and expenses of the Association was submitted and it was held and sustained by the Supreme Court of the State that there was no evidence of mismanagement to uphold the plea of the grower.

The issue of re-drying next agitated the membership when it was learned that certain officers profits from re-drying the Association tobacco in their private of the corporation had made large plants. The officers involved were—R. F. Patterson, general manager, and T. C. Watkins, Jr., a director in charge of certain phases of the Association work. It came to light that the directors by resolution had authorized its directors and employees, to re-dry tobacco in private plants but had set a price of \$1.75 a hundred pounds to be paid for such

operations. The directors claimed this was a lesser amount than would have been paid to outside concerns for the work.

Early in 1925 the Association directors invited a committee of public men and officials from the three states to investigate its affairs. This committee reported it found some defects and recommended some changes. It held, however, that the affairs generally, were in good shape, their direction bona-fide and honest and that the cooperative movement had rebounded to the benefit of the growers. Certain changes then were made, chiefly in the reduction of overhead expenses and in leasing re-drying plants to handle the Association tobacco.

During 1925 the Federal Trade Commission, at the order of Congress, made an investigation of the trade practice of the American and Imperial Tobacco companies in their dealings with co-operatives. An initial report of the Commission was withheld until it could go more fully into certain phases suggested by the co-operative management and the final report was issued about the middle of January 1926.

The report dealt at length with the management of the Tri-State Association and charged that its principal troubles were not from the competing tobacco companies on the auction floor but from within, caused by mismanagement. It criticized particularly the re-drying activities of Patterson and Watkins, whereby each admittedly had profited.

On January 19, 1926, Wiley M. Person of Franklin county, instituted a suit in Franklin county seeking dissolution of the Association. He charged that waste and extravagance permeated the organization and cited the statements of the Federal Trade Commission as to re-drying activities of its officers. The plaintiff alleged that because of the actions of the Association's directorate and officers, many growers found themselves in desperate financial straits, and some

were practically bankrupt because of inability to collect for tobacco crops from the Association.

The bill of complaint was presented in Superior Court at Rocky Mount, and Judge M. V. Barnhill signed an order for the Association to show cause before Judge Thomas H. Calvert in the Wake County Superior Court at Raleigh, on February 5, 1926, why it should not be dissolved and a receiver appointed in accordance with the petition of the plaintiff.

Answering the report of the Federal Trade Commission, the Association directors on January 30th issued a statement to its membership defending its re-drying policies and alleging that the Trade Commission had published the full facts and findings of its investigation where they favored the two tobacco companies which they investigated and were against the Association but where they favored the Association and were against the tobacco companies, all the evidence was not made public. In support of this charge a mass of evidence was cited which the Association directors declared showed collusion between the two tobacco companies to the detriment of the Association. The statement also declared that by following the re-drying policies which it did, in spite of the fact that the two officials under fire had made large personal profits from their private operations, the members had had their tobacco re-dried more economically and more efficiently than if the work had been turned over to outside re-drying plants. It also claimed that a prospective alignment of outsiders to boost the re-drying charge had been prevented by the Association's action.

When the Person case came up in Raleigh on February 5, after a day of hearing it was thrown out of court on the ground that the plaintiff had failed to sustain his allegations by the evidence which he offered.

Then a new trouble developed for the Association. With the expiration of the contract in the South Carolina territory a campaign was staged in that state for the purpose of obtaining a sign-up to carry on the work of the Association over another period of years.

Shortly after the first of March the campaign ended and it was announced that the Association had failed to sign up the required percentage of tobacco growers in the State.

Immediately after the campaign closed, however, it was announced by the Association officials that, in spite of the failure in South Carolina the organization would continue to function.

On March 10, five tobacco growers of Virginia appeared in Federal Court at Raleigh, charged the Association, by misrepresentation had deceived the farmers and that its practices had rendered it insolvent and they requested appointment of a receiver to wind up the organization.

Judge Isaac M. Meekins, presiding, issued an injunction restraining the Association from conducting its sales or carrying on any volume of business other than actually necessary until a hearing on the suit of the members. The date of the hearing was set for March 22 at Fayetteville. That night Judge Meekins modified his order to allow the Association to sell such stocks of tobacco as were on hand if sales were obtainable. The complainants in the case were I. B. Farmer, C. F. Loveace, J. E. Gosney, J. H. Butcher and J. H. Williams. On agreement of both sides, Judge Meekins on March 16, decided that the hearing on the injunction would take place March 29 at Fayetteville instead of Raleigh, the extension being granted because of the necessity of compiling voluminous records.

Generally, the five members charged that the sign-up of members in 1921-22 included thousands of signatures "which were

obtained by false and fraudulent representations" and that there were thousands of duplications in the sign-up in "an effort to carry out the false and fraudulent scheme." It also charged that the organization committee of the Association was aware of this when it announced to the growers that the Association had been legally organized and was ready to proceed with business.

In concluding their complaint the five members cited a number of minor allegations, which combined as substantial reasons for the dissolution of the Association which they asked. These included special contracts for certain parties, waste in publicity to deceive rather than inform members, maintaining of legislative lobbies, discrimination in assessment of members for purchase of properties, and re-grading of tobacco to the detriment of the grower and the financial gain of the Association.

It was this case which was decided by today's decision.

American Forest Week, Apr. 18-24

The President of the United States, has asked that the governors of the various states join him in proclaiming and asking the co-operation of their people in American Forest Week, April 18 to 24.

The wasteful depletion of the American forest has been a national reproach for more than a generation. As a people we have literally squandered an inherited capital until we have begun in the prime necessity of wood to feel the pinch of actual want. This has been the more deplorable because with intelligent care returns from forest lands would today be a stable source of national income and employment. Instead, wood which is in a hundred ways essential to every day life, which is the basis of great industries and which in the shape of forest cover is essential to becoming so scarce that one of the chief economic problems is to continued use of the land itself and a substitute for what have remained a continuing and ever growing natural resource. In beauty and utility the land produces nothing to compare with the tree. Wantonly to destroy a forest is an evil as destructive in its final results as the policy of the ancient conqueror who sowed his enemy's field with salt.

North Carolinians need do no more than remember the vanished naval stores industry, wiped out by the needless sacrifice of the long leaf pine forest, to take this lesson to heart. We should know, too, that while two-thirds of our total land area is in timber of some kind, much of it has been so buried and abused that it returns no revenue and is a tax burden rather than an asset. We should know that we are cutting yearly twice as much timber as we permit to grow, and that the great furniture industry and the many wood using plants are every year importing their raw material from abroad, much of it from the Pacific coast states at ruinously high freight charges.

Such remedies as are possible by state action is my purpose to endeavor to apply to the limit of the state's ability to meet the emergency. These include a statewide organization to prevent and control forest fires, guided by a strong forestry department to gather and supply information to the end of popular education as to forest needs.

They include effective forest laws to encourage reforestation, experiment and demonstrations forests and scenic woodland parks. Most of all, however, we need appreciation on the part of the people of the fact that timber is as much a necessity as other crops; that it is as much property as a dwelling house, and that it should be held sacred against violent trespass or negligence. Properly managed the timber lands can in twenty-five years be returning as much money annually as the cotton crop and at infinitely less expense for maintenance. Mismanaged and neglected, these same lands can in the same time become practically barren wastes, of little or no value and a drag on other lands. Knowledge of these facts can be brought to our people only by ceaseless education, continued publicity and tireless effort.

Now, therefore, I, Angus Wilton McLean, governor of the state of North Carolina do hereby proclaim and designate the week of April 18 to 24, 1926, inclusive, as American Forest Week, to be observed by all proper educational and publicity agencies, both public and private, by special efforts to bring this subject before the students in our schools and colleges, and the members of our civic clubs, women's clubs, and other organizations. Special programs, exercises and addresses should be arranged wherever possible.

The co-operation of the newspapers and their advertisers is also suggested, in inserting brief slogans about forest fire prevention such as was so effectively given by several papers last year.

As governor of this state and as honorary chairman of Forest Week committee I do therefore hereby urge all public officials, public and business organizations, industrial leaders, landowners, editors, educators, clergymen and all patriotic citizens to unite in the common task of forest conservation and renewal.

In witness whereof I have hereunto set my hand and caused to be affixed the Seal of the State of North Carolina.

Done at our city of Raleigh, this 1st day of April, in the year of our Lord, one thousand nine hundred and twenty-six, and in the one hundred and fiftieth year of our America independence.

Pittsburgh Expedition Seeks Pirate Gold

Temple Terrace, Fla., April 2.—(INS)—Ho, for pirate gold. A hunt for the buried treasure of Jose Gasparilla, who terrorized the Florida west coast a century and a half ago is, it is said, being secretly organized.

Tourists from Pittsburgh sailing recently along Manatee river some distance south of Temple Terrace, came upon the rotting hull of a ship half buried in sand. According to their story, they found several human skeletons in the old derelict with a faded parchment map in a tightly corked bottle.

The chart indicated two possible caches for Gasparilla's buried treasure. In one spot under a lone palmetto tree, the tourists declare they found a sea chest of ancient design with the hinges rusted off, but it was empty.

Though they searched for several days in the thick brush for the other cache, they were unable to locate it. They have taken their chart to Pittsburgh, where, it is said, they will have a translation made of an inscription in antique Spanish in ink in the lower left hand corner. They announced before leaving that they will renew their search in the spring. Gasparilla captured and sacked Tampa in 1771.

Calif. Dry Men Face New Problem

San Francisco, April 2.—(INS) Enter the bootleg bee. This tiny buzzer, no bigger than a lima bean, has created a new problem for prohibition enforcement officers in California.

The little insect is openly flaunting the Volstead act in many California rural communities, making them among the wettest sections in the country.

To winekeepers the "scofflaw bee" is known as the wine bee. He merely wipes his hind feet in a bucket of sweetened water, and converts it into high powered hooch.

Early day California Indians knew of the properties of "bee wine" and spent long hours hunting for the pools in hollow logs where the bees fermented the insect brew into compound that rivaled the best mule whiskey.
