People bought five billion dollars' worth of goods on the installment plan in 1925, and some say, "we are rushing into bankruptcy." But don't worry. Money well spent by those that can pay helps spender and seller and hurts nobody.

The important thing is that installment business should be on a sound basis, not encouraging extravagance, charging excessive rates for time payments, or encouraging a man with a car, good for two or three years more, to get rid of it prematurely and start the used car market.

"Zip," eighty-two years old, and in the hospital, may not live long. You may have met him, when he was Barium's "What Is It?" You remember circus and dime museum rows of freaks, fat ladies, living skeletons, bearded ladies, tattooed men, sword swallows, dwarfs, giants, that used to delight the populace. Contrast with that our modern moving picture, beautifully made. The world improves.

Shooting doesn't discourage Mussolini. With his nose plastered, his ears deafened with gunfire, shrieking sirens, cries of "Viva Mussolini" and "Viva Fascismo," Mussolini left yesterday for Tripoli, announcing his desire to convert the world to Fascism.

Russians would convert the world to Communism. Mussolini and Trotzky are exact opposites, and each has the same plan to make the world accept his ideas.

Of the two, Mussolini makes more progress. The human race understands powerful dictators. But a man that wants to "divide up" a communist basis seems a dangerous novelty.

5,000,000 radio sets in the United States have 27,000,000 human beings listening in. Sad that so little broadcasting is worth attention. WETS TURN TO CANADA EVIDENCE SUPPORT FIGHT

Former Member of Quebec Liquor Control Commission Is Principal Witness at Today's Hearings

Washington, Apr. 10.—(AU)—The wets turned to Canada today for evidence to put in the record of the Senate prohibition hearing in support of their fight for modification of the Volstead Act.

Sir William Stavert, of Montreal, former member of the Quebec Liquor Control Commission, was the principal witness, for this phase of the hearing, since he is familiar with the working of the Quebec plan of government manufacture and sale of liquor.

An outgrowth over the demand of Senators opposing the Volstead Act for an inquiry into conditions attributed to its operation of hearings begun a week ago with a series of modification proposals as its basis. KOERBER WILL PAY PENALTY IN ELECTRIC CHAIR

New York, Apr. 10.—(AP)—Sentence of death in the electric chair will be imposed upon Herbert Koerber, 38 year old leader of the youthful hold-up gang who are known as the "Cake Eaters."

Leader of Youthful Gang Known as "Cake Eaters," Found Guilty of First Degree Murder

A jury in the Queens county court deliberated 40 minutes last night before returning a verdict of first degree murder against Koerber for the slaying of Angelo Mahairis, a Jamaica restaurant owner three weeks ago. Koerber testified that he shot Mahairis when the latter refused to sell him and his companion liquor.

Drinking, bad companions, and night in Harlem negro cabarets after the loosening of home ties following the death of his mother were the features of the youth's career as outlined during the trial. Counsel for the defense appealed in vain to the jury for leniency because of the defendant's youthfulness and early environment.

Five Killed When Planes Collide

Honlow, Eng., Apr. 10.—(AP)—Five members of the Royal Flying Corps were killed when two airplane collided over the air drome here today. The planes fell 300 feet and burst into flames, burning the occupants, who were two officers and three enlisted men.

OUR SATURDAY NIGHT MEDITATION

"Rejoice!"

8. Matthew 28:9—"And as they went to tell His disciples, behold, Jesus met them, saying, 'All hail!'"

Mary was the first individual to see Jesus after His resurrection; the incident recorded in the text was the meeting of the first group of company of believers with Him. It was an advance detachment of the church going forth to meet her Lord.

And what was Christ's first word of greeting to His people? Our English New Testament tells us, both in the old and the revised version, that He said "All hail!" But in the Greek we find His one word was Chairete,—that is, literally, "Rejoice!"

This Greek word, in its imperative, as here, was afterwards used only three times in all the Bible; twice by the Apostle St. Paul, and once by the Apostle St. Peter. St. Paul used it in addressing the Thessalonians: "Rejoice evermore!" and also when writing to the Philippians: "Rejoice in the Lord always, and again I say, rejoice!" It was so used by St. Peter writing to the church in general: "Rejoice inasmuch as ye are partakers of Christ's sufferings, that, when His glory shall be revealed, ye may be glad also with exceeding joy."

In each instance both the writer and the reader would remember the history and feel the significance of the imperative word, "Rejoice!" To them it would be a sacred word. It had in it the echo of the joyful sound which the risen Lord sent flying through all Christian times from that opening moment on the first day of His resurrection. It was His first word to the first representative of His church, and it became the keynote of Christianity and its distinctive feature.

When Hebrew traditionalism was binding grievous burdens upon men, and all the rest of the world seemed to be dying of sated self-indulgence, hopeless fatalism or stoical philosophy, these disciples were commanded by their Lord to "Rejoice!"—and they did

rejoice. Never was outward life so trying; never was inward life so full of joy. The bloody Emperor Nero, might illuminate the imperial gardens, but joy irradiated the souls of the martyrs.

Some years ago I went through the Catacombs at Rome, those dark underground passages and chambers in which the hounded hunted disciples of the early church sought to hide from the tyrant's notice and shelter from the storm of cruel persecution. I can testify to the fact that Joy reigned in the Catacombs!

Joy inspired them because their thoughts habitually dwelt on the joy-inspiring fact that He who once died for His people, now lives for them, and will so live forevermore.

If Christians could "Rejoice!" in those days, under the cruel persecution of the Emperors Nero, Vespasian and Domitian—rejoice when as the historian Tacitus tells us "a great multitude" were put to death because of their faith in the Risen Savior, and not simply killed, but he adds: "Various forms of mockery were added to enhance their dying agonies. Covered with the skins of wild beasts, they were doomed to die by the mangling of dogs, or by being nailed to crosses; or to be set on fire and burnt after twilight by way of nightly illumination." If, I repeat, Christians rejoiced under such circumstances, this one word of our risen Lord should have at least equal power upon our lives today, who have seen Him capture the power and throne of the Caesars and conquer the civilization of the world!

1. This word, "Rejoice!" is a word in season to Christians who have sombre fancies about the nature of Christianity.

How came such fancies into existence? How did what has been called "a holy melancholy" come to be an accepted ideal of the Christian religion? Why did George Herbert ever sing—"Not Solomon's sea of glass, or world of stone Are half so dear to God as one good groan?"

What can there be in the gospel to cloud our sunshine—to frost our flowers of gladness, or to make a deep minor in our music? It is not in the gospel, but in us the secret lies. If we only rightly and constantly appreciate what the Easter Fact means, there would be no more long-faced, sour-looking, or pessimistic Christians. All would be filled "with joy unspeakable and full of glory"

2. This word, Chairete! is one for Christians who are crushed under the sorrows of life.

Through the power of the resurrection "all things have become new" Even sorrow is now only the name of a process which has joy for its result. Though grief may be the soil of grace, gladness is its flower.

3. This is a word to inspire all Christian workers—"Rejoice!"

Our's is a glad religion. We should laugh, not the laugh of the frivolous, but of the happy. In grace, as in nature, the rule is that a happy child is a better child than an unhappy one. A soul full of joy sings better, prays better, gives better,

serves better, than any misanthropic man. We are most effective in what we delight to do.

4. This one word, "Rejoice!" is for Christians who are troubled at the thought of the grave.

Every recurring Eastertide brings to our memory dear ones who are gone, and as we garland with flowers the gravestones in our cemeteries, the thought of our own approaching end will crowd sadly in. But we are not to fear the grave since He has passed through it. It is no longer a sepulchre in which we may be imprisoned; He has made it a road on which we may go after Him into the life eternal. We shall not stop THERE; for He did not stop there. "Rejoice!"

Do you notice that I have repeatedly stated that this word "Rejoice!" is for Christians?

If you are not His, I can see little joy and no rejoicing in the sorrows and disappointment of life nor in the certainty of awaiting death. But it is not yet too late. Even tonight, you can accept Him by faith, and know what it means to "Enter into the joy of thy Lord."

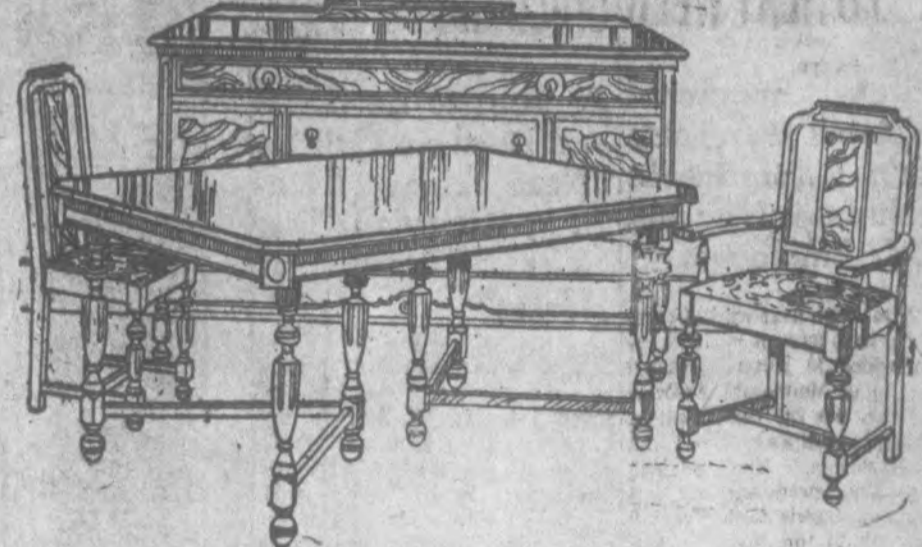

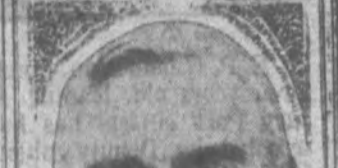

The heat was so intense that thousands were kept hundreds of feet away, National Guardsmen were making an attempt to keep the crowds outside a roped off area around the building in case the walls should fall. State College freshmen, who were pressed into service, were being held in readiness to evacuate the other buildings should the flames reach them.

The only hint of the possible origin of the fire came from a nurse who said that a new floor was being put down in the seventh ward and that there was considerable litter in the ward.

The building was valued at \$890,000 it was said at the Budget Bureau and the insurance carried was \$445,000. The building was constructed before the Civil War.

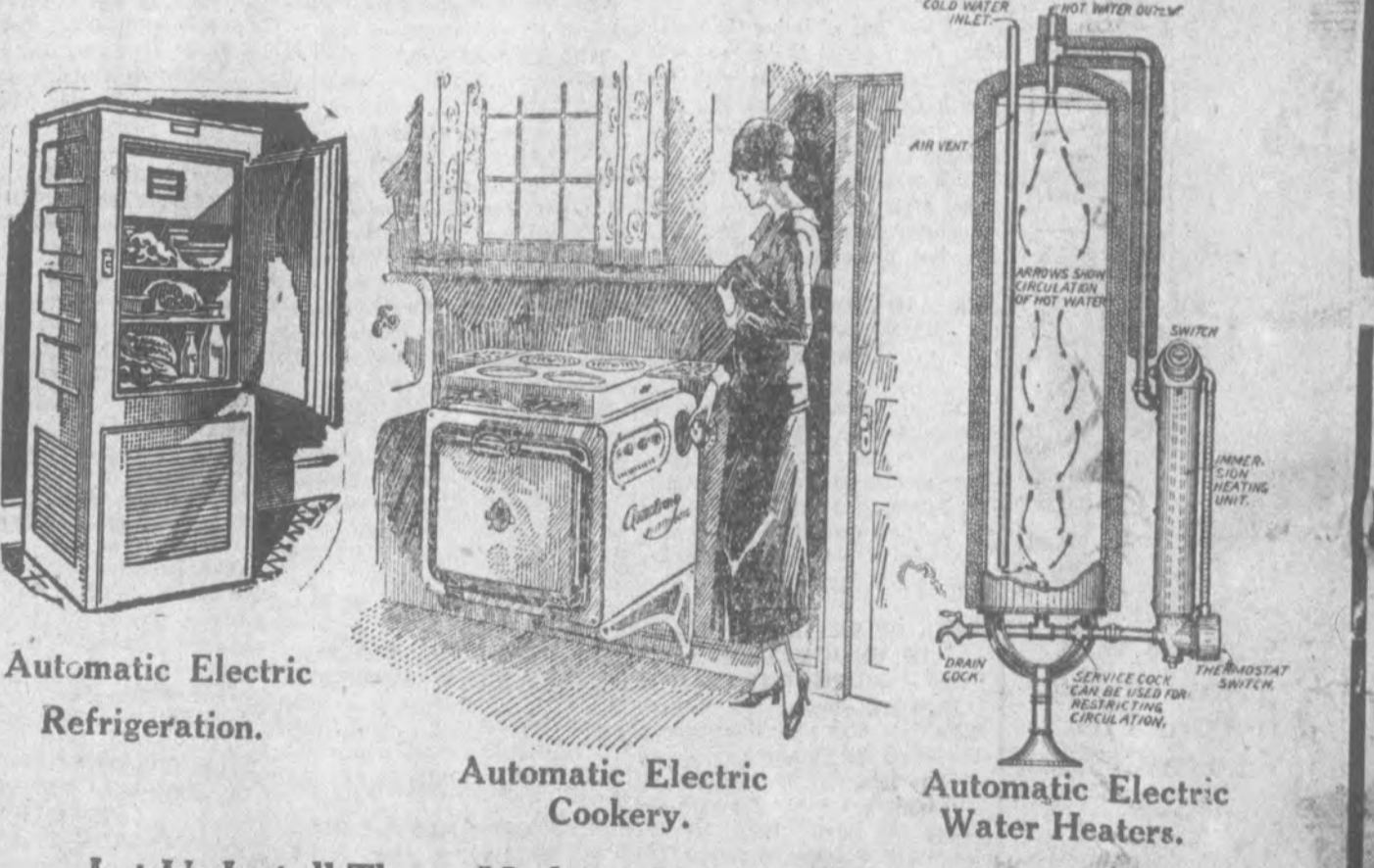
