LARGE DOCKET IS GIVEN HEARING IN COUNTY COURT

Day's Session Featured by Fines; Number of Defendants Found Not Guilty

Harry Baker and J. T. Williams, charged with disposing of property with intent to defraud, Williams called and failed. Judgment nisi si fa, Defendant Harry Baker in Federal prison, Capias issued for Williams.

Jim Roberson pleaded guilty to the charge of having whiskey for sale. Judgment suspended 2 years upon good behavior and payment of costs.

Will Vainwright was adjudged not guilty of assault with deadly weapon.

Thomas Davis, John Wilson, Jack Williams, Ernest Nobles, John A. Brown, John Williams, charged with gambling. Defendants all plead guilty except Davis and Brown. John Williams not taken, capias and continued. Tom Davis was adjudged not guilty, all other defendants adjudged guilty. Each defendant fined \$20 and cost. Defendant John Wilson fined \$30 and part of cost. Ernest Nobles fined \$10 and cost. Defendant John Williams, appeared to Superior Court under a \$50 bond. Defendant John Wilson was sentenced to 60 days on roads and Jack Williams was sentenced to 30 days on roads on account of failure to pay fine and costs.

Louise Wilson was adjudged not guilty of having whiskey for sale.

Thad Atkinson pleaded guilty of carrying concealed weapon and is fined \$50 and costs, and pistol to be confiscated.

Stanley Barnhill pleaded guilty to charge of transporting liquor and is fined \$25 and costs.

LaFayette (fox was adjudged guilty of cruelty to animals and was sentenced to jail for 60 days to be assigned to work on roads.

Smith to Represent Pamptico Council in Washington

Guy V. Smith will represent the Pamptico Council at the Sixteenth Annual meeting of the National Council of the Boy Scouts of America to be held in Washington, D. C., on April 30 and May 1. President Coolidge, Honorary President of the Boy Scouts, will address the members of the National Council. Lieut. General Sir Robert S. S. Baden-Powell, originator of the Boy Scout movement and Chief Scout of the world, will also take a leading part in the program.

Though Scouting was introduced in America only sixteen years ago, the movement has spread rapidly until practically every city and town has a troop of Boy Scouts and leaders, according to figures published on January 1, 1926. Over two million boys have received Scout training since its introduction into America in 1910.

C., Apr. 28.—(AP)—Approximately 70 delegates from the Carolinas, Georgia and Virginia today discussed the most effective method of expending the proceeds of the Duke endowment fund distribution to orphanages. The assemblage was the first session of the two days' tri-state conference of orphanage workers.

DEMOCRATS WILL HOLD BIENNIAL MEET THURSDAY

Sessions Will Open at 11 O'clock With Several Hundred Delegates in Attendance

Raleigh, Apr. 28.—(AP)—Democrats of North Carolina will move in force on Raleigh tomorrow for the biennial State Convention. Following precedent, all Democrats in good standing have been named as delegates to the convention though the voting power of each county is limited. Several hundred delegates are expected to attend the convention.

John G. Dawson, a candidate for re-election as state chairman, apparently will be unopposed. W. C. Feinstein of Newton will deliver the keynote address while T. E. Warren, of New Bern, will act as temporary chairman of the convention.

In advance of the convention, it did not appear there would be any outstanding issue, before the convention. Rumors that evolution, the Morrison plan for state ports and the eight months' school term would be carried to the floor of the convention had not developed into anything definite today. However, one delegate may start discussion by introducing resolutions or motions dealing with any of these issues and cause the convention to assume an importance, which in advance it appeared it would not assume. Indications were that the party meeting would be quiet the McLean administration would be overwhelmingly endorsed and the platform would not contain anything likely to split the convention.

Political chieftains were foregathering here today for the advance work of the convention: strengthening party lines and holding councils of war dealing with matters likely to be considered. It was expected the platform would be worked out at these meetings and be ready for presentation tomorrow immediately the platform committee retires to draw it up. The convention session is scheduled to open at eleven o'clock.

Raleigh, April 28.—(AP)—It looks like tomorrow's Democratic convention will be undisturbed by the major questions which are now confronting the Democrats of the state and which promised to make 1927 general assembly a turbulent session. Representative Z. V. Turington, a leader of the forces of fundamentalism, is opposed to the question of evolution coming up on the convention floor. Cameron Morrison, proponent of State Port Warehouses and Ships, says he will not bring that matter up in the convention. No leader has been found to carry to the convention the fight for an eight month school term. The proposition has many strong supporters, but they are biding their time waiting for the 1926 legislature. The question of a state-wide Australian ballot system may reach the convention floor but the odds are against it, for though it also has many supporters, no definite sentiment had crystallized for broaching it in the convention.

However, the convention is open to any proposition anyone of the 1,063 delegates may mention, and no doubt many things will be mentioned which have not been figured out in advance.

RALEIGH TIMES FILES ANSWER TO LIABLE SUIT

Denies "Malicious" Intention of Injury to Plaintiff, Rev. J. R. Pentuff, in Editorial

Concord, Apr. 28.—(AP)—The Raleigh Times today filed its answer in the \$25,000 liable suit brought against it by Rev. John R. Pentuff.

The answer, filed here at noon today by attorneys for the Raleigh paper, admits publication of the editorial to which exception was taken, but denies "malicious" intention of injury to plaintiff and affirms the truth of "all statements" contained in the editorial.

Mr. Pentuff, a Baptist minister, filed his suit in Concord on March 23, alleging publication in the Times on February 23 of an "injurious" article. He alleged that the article "was injurious to Dr. Pentuff as an individual and an educator," it being declared that the minister was referred to as an "immigrant ignoramus" and called him "unmannerly" and "discreetous."

WILSON'S DREAM COMES TO PASS

Representatives of Rifflans and Their Antagonists Discuss How to End the War

Ouggo, Morocco, April 28.—(AP)—President Wilson's dream of peace without victory has come to pass. Representatives of the Rifflans tribesmen and their antagonists, the French and Spanish, are sitting at the conference table discussing how to end the war in the Rifflans.

The first fact established in the acknowledged peace conference is that the Rifflans are recognized as belligerents and are negotiating on equal terms with the Franco-Spanish plenipotentiaries security and respect for international treaties, are said officially to have been the subject of the first deliberations. The armistice which had existed in fact for six weeks is now effective under military law. Roughly summoned up the first official contact seems to indicate that all three delegations to the peace conference are convinced that there must be peace.

Your Interesting Pancreas,

International News Reel shows the first pictures of Manna Loa's latest great eruption. Smoke and flame rise slowly from bowing fields of lava, that soon harden into smooth and apparently hopeless rock.

Men now living will never see anything grow there, and the ancients of course thought that lands thus formed was cursed forever. But time and the weather break up the rock, earth focus slowly through the centuries. The earth worms do their marvelous work, grinding up the soil into tiny particles, producing for fertility. Plants and grass grow. Cattle eat the grass, man eats the ox instead of wasting time digesting plants. He writes a good book, and humanity moves a little farther upward—thanks to the old volcano, throwing up fertilizing treasure from inside the earth.

E. J. Evans, of San Francisco says the United States should end its worries about crude rubber by planting rubber trees along both sides of the Panama Canal, (on two strips 50 miles long, 10 miles wide) as a government enterprise. The government won't do it because the administration does not believe in having government do anything that private enterprise can do. European nations have been compelled to outgrow that primitive notion dating from the time of Romulus and Remus, and that is why their government enterprises are worrying out industries.

This writer lacks information as to soil qualities along the Panama Canal. But there are in Mexico unlimited opportunities for rubber growing, ideal soil, plenty of labor. These bosom friends Ford and Freestone, and the other tire makers need rubber. Why don't they try it?

"Independence" today has a wider meaning than in Thomas Jefferson's time.

Industrial independence of other nations is almost as important as political independence.

Diabetes, that kills men, begins by destroying the pancreas.

Professor Bensley of Chicago's University, has succeeded in destroying and then restoring the pancreas of a rabbit.

Diabetes has been successfully fought, recently, by the use of insulin, a pancreatic extract. Now science, knowing that the pancreas after severe injury can restore itself by growing new tissues, as certain lizards grow a new tail, hopes to fight diabetes in a new way.

All this will shock and disturb those who believe that there is no such thing as disease, and that all you need do is to deny its reality. But it may cure diabetes that kills millions and can't be helped by amiable theorizing. And that is the important thing.

Mayor Denver of Chicago tells the Senate that prohibition can be enforced, but it would mean "forcing the law down the throats of an unwilling and objecting people."

That is not the easiest way to deal with people, although Lord Northcliffe did call Americans "VERY SUBMISSIVE." It has always been hard, in all countries, to force laws down peoples' throats. In America we are trying to keep bootleg liquor out of high schools. In Japan they are trying, in their high schools, to root out Communism. From belief in the old Mikado, sons of Heaven, to the theories of Karl Marx and Lenin is a long jump. But many Japanese have made it.

The Japanese are trying what other nations have found to be the wrong way, namely, the American anti-evolution method. We decided, or our fundamentalists did, that no school child should ever hear anything about evolution and in consequence 115,000,000 Americans heard much about it.

URGES STRONGER ENFORCEMENT OF PROHIBITION LAW

Bill Added to Senate's List of Pending Bills to Make Prohibition More Drastic

Washington, Apr. 28.—(AP)—After serving as a new vehicle for expressions of wet and dry sentiment in the House, the bill to give sanction to the reorganization of the Treasury enforcement agencies has been added to the Senate's list of pending administration bills to make prohibition more drastic.

The bill would raise the prohibition unit and the custom service to the status of bureaus attended by commissioners appointed by the Treasury Secretary.

The bureau with the coast guard would be grouped to the direction of a single assistant secretary charged with supervision of prohibition enforcement. The measure also carries an amendment to place all except the highest prohibition officials under civil service regulations.

Wet members of the House offered little opposition to the proposal, and it was passed by a vote of 196 to 43. By making enforcement more drastic some of the wets contended it will make the law more objectionable and in this way win supporters for modification. A number of amendments including one to legalize 2.75 per cent beer were thrown out or defeated.

Another amendment defeated was one which would have held the administrator, and other employed for prohibition enforcement, to accepting no salaries outside of their government pay. This amendment was introduced by Representative Laguardia, of New York, who commented on the fact that the recent Senate hearing had disclosed that F. C. Baird, prohibition administrator at Pittsburg, was at receiving a \$12,000 annual salary as a railroad official while acting as prohibition administrator.

ATTORNEY SLAIN IN BLAST FROM A MACHINE GUN

William McSwiggan, Asst. State's Attorney of Chicago, and Two Companions Victims of Gangsters

Chicago, Apr. 28.—(AP)—William H. McSwiggan, youthful assistant State's Attorney, known as the "hanging prosecutor" because of his zeal in conducting criminal trials, was slain last night in a blast of machine gun fire poured by gangsters into an automobile in which he and two other men were riding.

Two of his companions also were killed. They were James J. Doherty, reputed leader of beer runners, of Cicero, a suburb, and Thomas Duffy, owner of a saloon. The hail of lead came from an automobile which drew up beside the car in which McSwiggan and his companions were driving.

While authorities were delving in a maze of possibilities for the shooting, John Sege, veteran Captain of Detectives, said that the assistant prosecutor was marked to death because of his prosecution of John Scallio and Albert Abselmi, two gangsters under sentence of 14 years for the slaying of two policemen.

Search for the slayers began immediately under the direction of State's Attorney Robert E. Crowe, who declared he was astounded at the timidity of the killers. A conference of state, county and city officers was called to lay plans for rounding up gangsters who might furnish clues leading to the identity of the machine gun crew.

McSwiggan left his home last night with Duffy, telling relatives that he planned to go to another suburb for a game of cards. The two entered an automobile and drove away. Attached to the State Attorney's office expressed the belief that the trip to Cicero was also connected with two cases on which he was working.

140 or more arrests were made in raids upon saloons and road houses in search for the machine gun crew. Steve O'Donnell, known as being in the liquor business at Cicero in which Doherty and Duffy also were interested, was one of the suspects brought in. There was a report that a brother of O'Donnell had been a companion of the three slain men last night. Doherty and Duffy both owned saloons and Doherty was on close terms with O'Donnell's brother. A bullet-riddled and blood-stained automobile believed to have been the machine in which the men were believed to have been riding when slain was found today in Mid Park, a suburb.

Railroad Diggers Find Oysters Buried for Unknown Ages

Chanote, Kan., Apr. 28.—(INS)—Geologists and biologists here are puzzled. Live oysters in quantities, have been discovered here eighteen to twenty feet underground, in the heart of Kansas, in a gravel and sandrock formation that has existed for ages.

Probably, the biologists say, the bivalves were left there when an ocean covered this part of the country, and disturbances of the earth's crust heaved the bottom of the sea into a plateau. But they are unable to conjecture how the oysters managed to attain the state, or how they lived after they got there.

Mexican track laborers, excavating for a new subway for the Santa Fe railway, came across the find, and thought the oysters were scattered along the track, and only a few were still alive when they called to the attention of Paul McQueen, chief clerk, in the Santa Fe bridge and building department.

The shells of the forty oysters are about four inches long and two inches wide. The outside is more ridged and whiter than that of the salt water oyster, whose shell gathers sediment and is worn by attrition experiences unknown to the oysters here.

NATIONAL CHILD HEALTH DAY

May 1 will be National Child Health Day. President Coolidge has proclaimed and national officials, governors and mayors have added their endorsements.

A ream of convincing statistics about the necessity of Child Health Day has been poured out. Organizations have interested themselves in the celebration and many earnest-minded men and women in charge of children will really work to make it a success.

On the other hand, the day cannot be a success until every citizen of each community regards himself as a genuine part of the celebration.

Here is the way for you, the citizen, to do it.

Try to bring forth just one thought, just one idea of your own, upon the subject. First, try to learn something about child health conditions; drop by the public library or write to one or more of the several agencies engaged in this line of work, and ask for books or pamphlets on the subject.

On Child Health Day, thresh out the matter you have assembled, put two and two together and try to arrive at your own conclusion.

When you do you will light a bonfire that is really worth something to the child health movement. No man is really enthusiastic about the fact that he learns or the idea he gains, from another.

He must discover his own fact—bring forth his own ideas. Then he is a real convert. If a few citizens will do this, it will be a real "day" for child health on May 1.

MORE INTELLIGENT FARMING IS BEST SOLUTION

Many farm relief measures have gone before the House agricultural committee, and every one has come out crippled by the assaults of those who want something else.

There is no doubt of the willingness of Congress to pass any farm relief measure that seems to have the support of those who are to be relieved, and of common sense. But there are so many kinds of farmers, so many problems of transportation and marketing, that no universal measure seems to fit.

The genius is yet to be born who can wipe out differences in geography, elevation, distance, climate, farming ability, and reduce

farming to one standard of profit. It has never been done in other business; the ruins of 10,000 creameries, factories, sawmills, railroads, that tried to buck Nature, dot the land. George Shima, Western Japanese potato king, recently died in California, worth \$3,000,000, all made in growing potatoes, largely on leased lands. He knew how to grow potatoes, and "relief" laws didn't worry him. If any part of the farm problem lies in better farming, that is beyond all laws.

World Art Experts and Collectors to Gather for Sale

London, April 28.—(INS)—Art experts, collectors, and dealers from all parts of the world are expected to attend the sale May 7 next of the famous Biscossheim thropier.

The sale is to be held at the famous auction rooms of Messrs. Christie, and ready fairs are beginning to be expressed by the English press that the sale will result in further famous old masters being bought by Americans.

The Biscossheim collection contains fine examples of the work of Gainsborough, Reynolds, and Romney, and the French masters, Nattier, La Oillere, Boucher, and his pupil, Drouais. There is also an important work by Sir Antonio Mor, favorite of Philip the Second of Spain.

Among the Reynolds pictures are those of "Miss Charlotte Fisher" and "Lady Digby," the former painted about 1761, and the latter probably one of the 150 portraits which Reynolds painted in the year 1758. The Gainsborough pictures in the collection include the portrait of Mrs. Minet, exhibited in 1778, and probably painted in 1777, when Gainsborough reached his peak of perfection.

The collection includes four Romneys—Lady Lushington, Lady Gordon and Son, Lady Hamilton, and another head, portrait of Lady Hamilton. The picture by Sir Antonio Mor is said to be the cream of the collection, inasmuch as it is one of the very few known to be in existence.

SANDLESS GLASS IS NOW BEING MADE AT CORNELL

Ithaca, N. Y., Apr. 27.—(AP)—Sandless glass, is being made in the chemistry laboratory at Cornell University.

The substitute for sand in the process of manufacture is the dioxide of germanium, a rare, mysterious and costly element, which Professor L. M. Dennie, head of the Department of Chemistry, is now able to produce in quantity after years of experimentation.

Whether the new glass has properties that will make it of great value for optical purposes is still undetermined, but the results thus far obtained indicate quality.

Two years ago, Stanley Harns, a non-conformist always, picked up Joe Martin, a 35-year-old recruit pitcher from the Southern Association. Joseph failed to click, but a precedent was set.

At the present writing, we have no less than six recruits in the major leagues, who never again will see their thirtieth birthday, which is the point where the average ball player starts running the wrong way of the track. Yet three of these elderly young men made the rifle in the first week of the season.

Joe Tate, 33-year-old left-hander, who never saw the big time before, stopped the Senators with two hits in 6.2.3 innings for the Athletics' first victory of the year. For some reason, he was allowed to languish over long at Fort Worth.

Al Tyson, 30, the new Giant centerfielder, affords another interesting study. He started as a pitcher and, after giving the early years of his career to that vocation, suddenly decided that he was going nowhere and switched to the outfield. He is just coming up now, although it is generally agreed that he should have been with us years ago. The boy is good.

Lloyd "Chick" Davies, 31, furnishes the most unique record of the three, however. He was up with the Athletics as far back as 1914 when just out of college. He won his first game, too, and was so sensational about it that he had all Philadelphia buzzing.

He faced Carl Wellman and the St. Louis Browns and stood them off well into the eighth inning when Connie Mack, seeing a chance to win with one run, looked down the bench for a pinch hitter. Davies had other ideas, however.

"Let me bat, Mr. Mack," he requested. "I can hit that big string-bean," referring to Wellman. Mr. Mack decided that any young man who felt that way about it would be a good bet. Mr. Mack was right. Davies won his own game with a single.

But he couldn't seem to stand prosperity. He seldom pitched well thereafter and tried out as an outfielder. He didn't succeed there, either, and subsequently passed from view. Now he is back again after twelve years and, as a pinch-pitcher, won his first game at the Polo Grounds by stopping the Braves with one hit in his innings.

TIME HAS ARRIVED FOR "LIBERTY AND JUSTICE" FOR ALL SCHOOL CHILDREN

(By Lucy Cherry Crisp)
On a fair, fine morning in February, a dozen or more Pitt county folks decided to go traveling. The company met at the court house in Greenville and there secured as guides for the day the superintendent and supervisor who stand at the head of the force maintained for the education of Pitt county children.

Leaving Greenville at eleven o'clock, and traveling in automobiles, the travelers, drove out on the hard-paved road that leads toward Washington and Bath. For a distance of two miles they drove, and then, at the suggestion of the guides, the cars were parked by the side of the road near a place where stood a ten-story house of the usual four-room variety. There the travelers alighted, crossed a little yard of hard-packed dirt and entered the house by way of its diminutive front porch. Finding themselves in a narrow hallway noticing only vacant rooms to their right, they knocked on a closed door at their left and in response to a summons, went in.

It was a matter of more or less surprise to the travelers, upon entering the room to find before them forty or more youthful Pitt county children, and to learn that this was one of the twenty-one schools making up Pitt county's quota of the 995 one-teacher schools maintained in North Carolina. The wall between two rooms had been taken down to make space enough for the children (who ranged in grade from little beginners on up through the seventh grade) and a heater occupied the central position left vacant by the removal of the wall. Crowded into

the space in front of the stove stood a group of boys and girls, a section of the first grade reading class ready to begin their lesson. "Three little kittens lost their mittens and they began to cry," they read, each one taking up the refrain when his nearest neighbor had finished.

The lesson must have covered two pages, at least, for when the teacher called on one little boy clad in overalls to read, he asked, "You want me to read this here page or over here on this here one?" The travelers, looking about the room caught interested bright eyes upon them, thought the flushed faces of those sitting nearest the stove bespoke an atmosphere more conducive to sleep than to study, while those who sat in the far corners shivered a bit from the cold.

At a signal from the guides, the travelers rose to go, leaving the first-graders still concerned with the three poor little kittens. Then back to Pitt county's capital they went, passing the splendid new Junior High and the brand new graded school buildings. (What a world of difference a scant two miles may make in the life of a child), and out into the country again. The way led again over hard-paved road, and their next stop was five miles out. The travelers recognized their stopping place this time, for it was a building of the architectural type most popular with builders of the two and three teacher school houses in North Carolina some twenty or more years ago. It was noon recess, time there, and the children and their two teachers gave a hospitable welcome as the visitors came on their grounds. Inside

the building, in one of the rooms a group of the boys and girls stood, finishing their noon-day lunch, and a merry laugh went up from them all as a little boy with puffed out cheeks, in answer to a visitor's question as to what he had in his mouth, said "bis-cut," amid an explosive shower of crumbs.

The travelers did not linger here, but were soon again on their way in a northerly direction this time. They came to the end of the hard-paved road, and soon after crossed Tar River, then journeyed on over a road that led through the river low ground, and out through the fields again. Finally they came to a crossing of roads which is known by various names, of which Monkey Den is one (and this, in all probability, dates back to pre-revolutionary days) though the one most used at present, perhaps is Bell's Cross Roads.

There, just beyond the cross roads, in the midst of an eight acre plot of land, which looked as if it had recently been merely a sandy field, stood a big important looking brick building. It was there that the travelers, at their guide's suggestion, made their third stop, to find that this was another of the schools in which Pitt county is educating her youth. Two years ago in Belvoir township, of which Bell's Cross Roads is the center, there were several small six-month schools, of the one and two teacher variety. But there were people living in Belvoir township who were not satisfied with such meager educational facilities, so they went to work to change them. There was opposition, of course—there always is—but there were faithful ones who labored on until the necessary bond issue was passed. And these, with many of the original supporters, today enjoy the possession of the Belvoir High School, a ten room brick building with a splen-

did auditorium, equipped with heat and light and water, and up-to-date school furniture, set in the midst of an eight acre school ground, the whole plant now being valued at the sum of \$40,000.

It is not the plant alone, however, of which the Belvoir people are proud. Five trucks running each day bringing 250 children to school. Eleven of these 250 boys and girls are in the eleventh grade, in this the second scholastic year of the Belvoir school's existence. There are many agencies at work in the school that are making their helpful influence felt throughout Belvoir township; two literary societies; a parent-teacher association; and a girls' sewing club, to say nothing of ten well equipped and wide awake good teachers. The campus of the Belvoir school presented a busy appearance to the travelers as they arrived, for this was a day long-planned for as the first Belvoir Arbor Day. The travelers were invited to one of the class rooms, there to be served a delightful luncheon prepared and served by white-aproned Belvoir school girls.

When finally the delighted travelers, could be enticed away from the chicken salad and Angel Food, they were shown into the auditorium, where an Arbor Day program was presented.

There is nothing else that can take the place of a school gala day performance—when children sing and march and recite—there is nothing else quite like it, for the children as well as their audience. After the program doors were over, the travelers, with parents and other visitors, stood out on the grounds and watched the children perform their "Daily Dozen," a thing which Pitt county has wisely seen fit to introduce in her larger schools. And then came the planting, for which the Arbor Day was planned. Trees and shrubs and borders and flowers were dedicated and planted, all according to a landscape plan a friend of Belvoir had made. When after the planting, an American flag was presented to the Belvoir school, it seemed that all things needful had at last been done to make it a memorable day. Sturdy, happy boys and girls; more serious High School folks; cordial, dignified teachers, and proud, happy parents—these with a few smiling candidates for office, and the interested travelers themselves made up a colorful panorama spread out on the Belvoir campus. Later on in the afternoon, with a feeling of great and pardonable pride, the travelers drove away from Belvoir, proud that such schools as this are maintained for the education of Pitt county children.

But there were those among their number who somehow kept remembering those forty boys

and girl, they had seen in the early morning—the forty boys and girls and their teacher packed up in that tight little room—and the thought kept repeating itself in their minds. "These, too, are Pitt county children."

Scattered throughout North Carolina today, there are 995 such schools; some are better than the one the travelers saw, and some, perhaps, are worse. There has been a day when a one teacher school served a purpose, and served it well, but the conditions that pupils from such schools faced were not those of the present day. And the time has come when North Carolina, with Pitt and all her counties might do well to remember that oft-repeated phrase "With Liberty and Justice for all" for out in those 995 schools are hundreds of country boys and girls of whom some traveler might honestly say, "These, too, are North Carolina children."

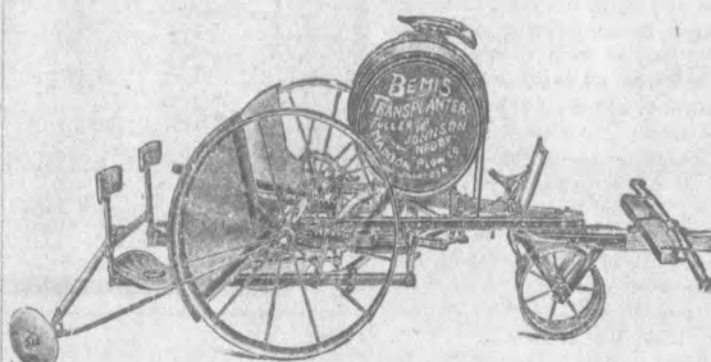

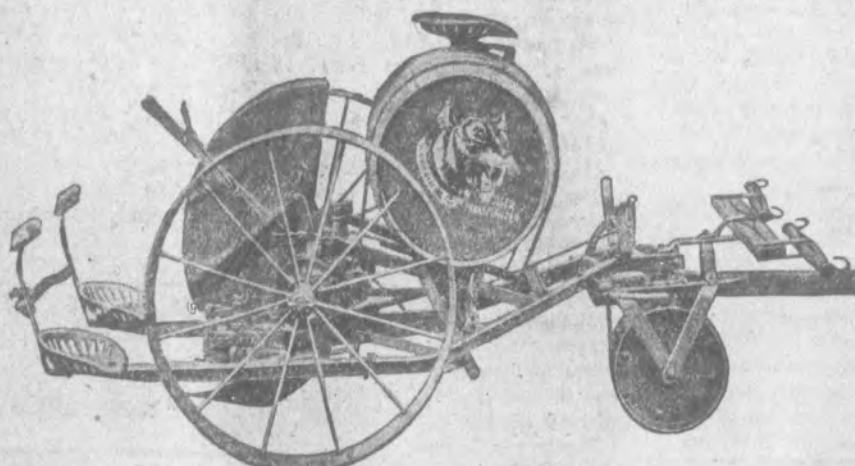
