MORE WITNESSES PLACED ON STAND AGAINST CRANFORD

No Indication As to When the Defendant Will Take Stand in Evidence Today

Albemarle, July 20.—(AP)—Additional character witnesses were placed on the stand this morning in the trial of Nevin C. Cranford, for alleged murder in connection with the deaths of two convicts.

No indication as to when the defendant would take the stand was given.

Harry Thomas told the jury that Sam Thompson, a prisoner, had denied tales of harsh treatment at the hands of Cranford in a conversation with him. Thompson previously had testified that he was beaten by Cranford.

Vick Shankl, a contractor, testified that Thompson told him he had received better treatment than he expected and that Cranford had never struck him.

Albemarle, N. C., July 20.—(AP)—The defense today mustered its strength in the trial of Nevin C. Cranford, former superintendent of the Stanley County Convict System and placed sixteen character witnesses on the stand. All of them testified as to the good character of the defendant, who is charged with the murder of James Terry and James Howell, negro convicts.

Cranford is expected to take the stand before the day's hearing is completed.

FENNING RESIGNS AS COMMISSIONER OF DIS. COLUMBIA

Resignation Placed in Hands of Attorney General at the President's Request

Paul Smith, N. Y., July 20.—(AP)—Commissioner Fenning, of the District of Columbia, has resigned.

The resignation, it was announced at the executive offices today, was placed in the hands of the Attorney General by request of the President before Mr. Coghlin left Washington.

The Commissioner, who was under fire in Congress at the recent session because of his conduct of war veterans guardianship cases, however, was requested to remain at his post long enough to dispose of some incidental matters with which he is familiar.

ORGANIZE 'LEPER SUNDAY' FOR AID TO AFFLICTED

London, July 20.—(INS)—In a secluded Middlesex village, a quiet elderly woman, Miss Kate Marsden, though crippled and paralyzed, is now energetically organizing a 'Lepers Sunday' throughout the world on behalf of the St. Francis Guild of Lepers, an organization which owes its origin to her.

To help the lepers this wonderful old lady has journeyed by horse back and sled over 16,000 miles across the frozen wastes to the far north of Siberia. Now, back in her rose covered cottage, she is exerting all her efforts toward raising funds for the benefit of lepers throughout the world.

VIENNA WOMEN STUDENTS DECREASE IN NUMBERS

Broadcasting Brutality.
Al and Cal at Luncheon.

Observe how a barbarous civilization degrades science of which it is unworthy. Brutality is utilized in the killing of miserable criminals, chemical science used for wholesale murder in war also used in a "lethal chamber" for criminals.

And worst of all, radio, that should be the most powerful agent of civilization and education, is used to take the brutality of the prize ring into millions of homes.

Around a ring in New York on Friday night, a crowd of 45,000 was howling, yelling, cursing, beating one or the other of two prize fighting brutes to lift his antagonist.

No harm, perhaps, was done to the crowd at the ring, among whom the percentage of semi-civilized and criminals was no doubt greater than in any crowd of similar size on earth. You could not hear or degrade that crowd. It had selected and selected itself.

But what could be more outrageous than sending broadcast to every radio machine for miles around the details of the criminal trial as it proceeded, with the trial room of the hearing mob as a background to the speaker's voice, giving details of the blows exchanged.

Prize fighting is illegal, violating the constitution of New York State. It is permitted by corrupt politicians that belong to the prize fighting class and divide profits with the prize ring promoters.

Public sense of decency is not strong enough to prevent that, but it might have something to say about broadcasting such brutality and deliberately cultivating a fondness for it among millions of children that gather around the radio. Some ask, "why interfere, if the people like it?" Several things mentioned in the 7th amendment are "liberty" by many; however, they are facts.

The Al and Cal Luncheon has become history, and you may even find President Coolidge and Governor Smith talked of fishing and conservation, each exhibiting esteem for the other.

It was a meeting almost as interesting as that of Francis the First and Henry the Eighth, on the field of the Cloth of Gold, although the two modern personages did not wrestle physically, in sight of their courtiers.

That wrestling may come, mentally, in 1928, and you may even find Al refer to Cal as slightly as did Francis, later, to Henry. "Wuad done ce gros lounnes acconchera-t-il?" Cal will say little, and collect votes.

Solemn undertakers who deal in expensive caskets and fine graves have discovered what is the matter with their business and ask for the world's sympathy.

It seems that this thoughtless age no longer buys first-class caskets with solid silver mountings, preferring to spend money on first-class automobiles.

Nobody will refuse sympathy to the undertakers. But there is something to be said on the other side. In an automobile you get a fine view, fresh air, health, family laughing and talking together. You get no more of those things in even the highest grade solid mahogany or "chased bronze" casket.

In various places female modesty protests against the use of automobiles as both houses, shocking "indecency" is alleged. When the lady told Dr. Johnson that there were indecent words in his dictionary, he replied, Madam, I perceive that you have been looking for them.

It might pay some automobile man to market a bath house trailer, to travel behind the family car. Many Americans will learn with satisfaction from Mr. Mellon that United States war debt terms to France are more generous than those to other countries.

JURY DEADLOCKED SINCE YESTERDAY IN FREEMAN CASE

Current Report Says Ten Jurors Stand for Acquittal, and Two for Manslaughter

Charlotte, July 20.—(AP)—The jury in the case of Mrs. Nellie Freeman "razor girl" who slew her husband, Alton Freeman on the night of May 22, was still deadlocked today after a night of deliberation. Judge Michael Schneek, who delivered a charge of an hour and thirty minutes to the jury, had not indicated this morning what time he expected a report from that body as to its progress.

The jury went out at 5:30 yesterday afternoon after a day spent in hearing of arguments of counsel and the Judge's charge. At ten o'clock last night they had not agreed and Judge Schneek ordered them to bed.

The 20-year-old slayer, who told the jury she cut her husband's throat, when he threatened to desert her, anxiously awaited the verdict in her cell at the county jail. Today the lobby of the Selwyn Hotel was crowded as the jury had been sent there for their deliberation. The jury sent word to Judge Schneek at ten o'clock this morning that there was no prospect of an early agreement and requested to permission to continue their deliberation at the hotel. The Judge instructed Sheriff Cochran to permit the jurors to remain there until after lunch if no verdict had been reached.

A report gained wide currency today that ten jurors stood for acquittal and two for manslaughter verdict. The court room was crowded as interested persons awaited the verdict.

Charlotte, July 20.—(AP)—No sign of agreement was apparent this afternoon in the case of Nellie Freeman, charged with the murder of her husband.

As the crowds loitered around the court house the defendant appeared comfortable in her cell in the county jail.

"My this is a good rest," she said. "I was tired after all that time in court. When do you stop?" they will end it," she asked in reference to the verdict.

World May Help In Prohibition In United States

London, July 20.—(AP)—A bid for world wide cooperation of foreign governments in the enforcement of prohibition in the United States may be the outcome of the present Anglo-American discussions here if plans materialize as anticipated by Washington.

In the event an agreement is reached with the British it is considered likely that other Governments, particularly the European Continental countries, soon will be approached by the United States with a view to opening similar discussions designed to bring about international understandings which ultimately will mean death blows to the rings of trans-oceanic bootleggers.

Brigadier General Lincoln C. Andrews, American prohibition enforcement chief, today said to the Associated Press:

"If we are successful in our present mission it is quite probable indeed that other governments may be appealed to to give an ear to our pleadings to interrupt the activities to the rum runners who have constantly broken our laws. This is a question however which must be decided by Washington. The initiation of actual negotiations and it will entail considerable diplomatic correspondence prior to that."

"In view of the fact that our mission came specifically to confer with the British," General Andrews added, "the present delegation would scarcely be in a position to continue any such negotiations in any other quarters."

Greenville Public Library

(By Rev. James E. W. Cook)—One of the most valuable assets to any progressive city is its Public Library.

Greenville is fortunate in having such an institution. Fostered by the self-denying efforts of some of our talented women the library, though small compared with those of other cities, is a source of civic pride.

It is situated in the Evans Street school building, through the generous hospitality of the school board; and this arrangement is fine until the city builds a separate building, or some generous and far-visioned citizen donates one.

There are about 2,500 volumes in the library, properly classified and card-indexed. For the eight months from November 1, 1925 to June 30, 1926, there were 991 adult and 496 junior borrowers. That means that over 2,200 of our people find the library a source of information, culture and recreation each year.

During the same eight months nearly 400 persons have been doing work in the library, utilizing its reference works, and prosecuting their studies along various lines.

It is evident from these facts and figures that the library is functioning as a source of knowledge to hundreds who could not afford to purchase the books outright.

What does the library cost the city?

The Board of Aldermen have been appropriating \$150.00 a month for the upkeep of the library, and the full-time services of a qualified librarian.

This is little enough—indeed, too little!

The laws of the State of North Carolina authorize aldermen to set aside for library purposes up to one-tenth of one per cent of the taxable property.

The taxable property of the city of Greenville is something over ten million dollars.

The law would therefore permit our aldermen to appropriate at least \$200.00 a month to the library.

We hope they will take steps to do so at their next meeting. Rocky Mount and other towns are going the limit. Greenville cannot afford to lag behind.

Under its present management books have been secured from the Library Commission and the State Library, Raleigh, and several valuable volumes have been donated by the Carnegie Endowment.

The appearance of the books in the high school and junior sections is a mute evidence of their popularity. How much happiness they must have brought into the home circles of our city! Now they need to be replenished. A mending department for the repair of covers has been opened, and is saving many books from the discard.

PUBLIC EXCLUDED FROM HEARING OF ASHLEY CHAPPELL

Asheville Minister Goes On Trial On Charge of Immorality at Statesville

Statesville, July 20.—(AP)—The public and newspaper reporters were excluded when the church trial of the Rev. Ashley Chappell, of Asheville, began here today before a board of the Western North Carolina Conference of the Methodist Episcopal Church South.

In explaining the executive session of the court, I. F. J. Prettyman, chairman of the hearing, declared that in closing the doors to the public, the court was following a custom and rule of the church in such matters.

"We hold that our business is the business of the church and not the business of the world," said the chairman, who was chairman of the United States Senate in the administrations of Presidents Wilson and Roosevelt.

Rev. Chappell, attending trial on charge of immorality, has been suspended from his pastorate at the fashionable Central Church of Asheville. He has stoutly asserted his innocence of wrong doing.

As a preliminary to the trial, Dr. Prettyman made an oral statement to the trial committee explaining the purpose of the session and the nature of the deliberative party.

"We are here," he said, "not of our own choice, but called by the church to consider a matter calling for the exercise of our highest Christian qualities."

The court was recessed for lunch at 12:30 and the hearing was resumed at 1:30 o'clock. The case of the church against the Asheville pastor was presented before lunch and Dr. Chappell also laid his case before the court. Cross examination of Dr. Chappell which began before the afternoon session, was interrupted for lunch.

The documentary testimony which constituted the prosecution case was admitted over objection of defense counsel. Exceptions to these admissions were entered providing the basis of an appeal by the churchmen.

The action of the church court is favorable to Dr. Chappell will be final and without appeal. If the findings substantiate the charge, however, Dr. Chappell may appeal to the general conference.

A verdict of guilty against Dr. Chappell would result in his suspension from the Methodist Ministry should the findings be sustained by the conference.

This morning's session of county court, Judge W. A. Darden, presiding, was consumed in the hearing of the case of Mrs. Sam D. Morton, charging her husband with abandonment and non-support.

Hearing of evidence in the case had not been completed when court adjourned for dinner at one o'clock. There are several other cases awaiting consideration, but it is hardly likely they will be reached before late in the afternoon.

APPROPRIATIONS SOUGHT IN NEXT STATE BUDGET

Increased Funds Are Sought for Enlarging Various Branches of Work

Henderson, July 20.—(AP)—Larger appropriations for all the state institutions are being sought from the state budget, to be adopted by the 1927 General Assembly, declares R. A. McCain, of the State Budget Commission, who has recently returned from a tour of inspection of a number of the institutions. Mr. McCain added that in his opinion none of them were in as great need of financial assistance as in the years prior to the time the state began enlarging proportions.

Mr. McCain was accompanied on his tour by Senator P. H. Williams of Pasquotank, and Representative Nat. Townsend of Harnett.

While on the tour the committee visited the Negro State Normal at Elizabeth City; the North Carolina State College for Women at Greensboro; the A. and T. College for Negroes at Greensboro; the Winston-Salem Teachers' College, formerly known as the Slater Normal, at Winston-Salem; the Jackson Training School at Concord; the State Orthopaedic Hospital at Gastonia; the Morrison Training School at Rockingham; the North Carolina College for Negroes at Durham. The tour lasted a week.

Senator Williams and Representative Townsend are members of the Budget Commission by virtue of their chairmanship of the finance committees of the Senate and House, respectively, and Mr. McCain is one of the two members appointed by the Governor. The report of the committee will be presented to the full membership of the committee when it meets with Governor McLean in Raleigh.

REV. J. J. LEWIS PASSES AWAY AT GRIMESLAND

Methodist Minister to Be Buried in Wash- ington This After- noon 3 O'clock

Rev. J. J. Lewis, 61, pastor of the Methodist church at Grimesland and Shelburne, died at his home at Grimesland this morning at 3 o'clock, following prolonged illness resulting from blood poisoning.

Funeral services will be conducted from his late home in Grimesland this afternoon at two o'clock by Rev. F. E. Mercer, presiding Elder of the Washington district. Interment will take place in Oakdale Cemetery at Washington at 3 o'clock. He will be buried with honors of the Masonic Lodge.

The deceased is survived by his wife, Hannah L. Lewis, three sons and three daughters; Prof. F. S. Lewis, of Charleston, S. C.; C. F. Lewis, of Raleigh; John Lewis, of Baltimore; and Misses Omaciss, Ola Blair and Ruth.

Mr. Lewis was serving his fourth year as pastor of the church at Grimesland, and other churches on that charge. He had greatly endeared himself to the people of that section. He was in active church service until a few weeks ago when an infection of the leg necessitated its amputation. It was thought at the time that he might recover, but complications developed which resulted in his death.

Oklahoma, July 20.—(INS)—The Creek Indian nation, in a national council meeting in the house of kings, will take into its own hands the alleged systematic looting of the estates of uneducated members of the tribe.

FRENCH PREMIER SAYS NEW CABINET HAS ONLY ONE AIM

That Aim, He Says, Will Be for the De- fense of the French Government

Paris, July 20.—(AP)—Premier Herriot had a new cabinet today, with Anatole De Monzie holding the portfolio of Ministry of Finance.

"My cabinet has but one aim—the defense of the franc," said M. Herriot to President Doumergue, when he presented the ministers at the President's palace early today.

"Apart from all party spirit," the cabinet promises the country an energetic administration. It requests the nation to preserve that calm which to the same extent as national industry is one of the indispensable elements for the recovery of the franc."

M. Herriot informed the President that the policy of the ministry would be described before Parliament Thursday. M. De Monzie who was Minister of Finance in the Herriot cabinet last year, and urged a forced loan and increase in note circulation, while M. Herriot desired a capital levy, said that the Government could not have recourse to inflation, but at the same time the ministry of finance would be helpless without "certain latitude, and certain liberty of action." He added that when he asked for a vote of confidence in Parliament he would also ask that means of action be accorded it so far as financial questions were concerned.

Mr. Herriot said that M. De Monzie would ask very much the same full powers in the Briand Cabinet had requested. The request of such powers for M. Briand and Finance minister, Joseph Caillaux, led to the defeat of the Briand ministry last Saturday. If M. De Monzie's wishes are granted he will move an adjournment of Parliament until October.

Among the financial measures attributed in some quarters as being desired by M. Herriot, is some form of a capital levy.

CUBA, GREECE AND LIBERIA ACCEPT RESERVATIONS

Proposals of the United States Favorably Received by Three Countries

Washington, July 20.—(AP)—Only Cuba, Greece and Liberia have accepted the reservations laid down by the Senate to United States adherence to the World Court protocol.

This became known today when a tabulation of interchanges initiated by the State Department last February with notifications to 42 governments that the United States is prepared to adhere to the court with reservations and asking acceptance of those reservations showed that only acknowledgments had been received from 19 countries, six others had explained that they would reserve their decisions until after the Geneva conference, and no response whatever has been received from the other fourteen nations.

BIG GAME INCREASES IN NATIONAL FORESTS

Tellahouse, Fla., July 20.—(INS)—Big game is increasing in the national forests of the United States, according to J. B. Royall, Florida commissioner of game and fish. National authorities attribute the increase, Royall said, to more effective enforcement of game laws, destruction of predatory animals by state and federal hunters, and, in a few states, complete prohibition of hunting in the forest reserves because of the danger of forest fires.

'MA' MAY RESIGN IF MOODY LEADS IN TEXAS RACE

Lieutenant Governor Barry Miller May Be Head of State Until January 1; Rumors Current As Mrs. Ferguson May Quit As Husband Is Ill

Fort Worth, Texas, July 15.—(INS)—Lieut. Gov. Barry Miller of Dallas may become governor of Texas on July 23. Should Mrs. "Ma" Ferguson, present incumbent, be defeated by Dan Moody, attorney general, her leading political opponent, in the primary of July 24, and keep her promise to resign if the results show him leading her in number of ballots cast, Miller will succeed to the executive position and hold it until January 1927, when then newly elected governor would be inaugurated.

Miller was elected to his present post two years ago, going into office with Mrs. Ferguson. He now is making a campaign for re-nomination to the office of lieutenant governor.

Rumors have been current in Texas for some time that Mrs. Ferguson will get out of the race before the primaries. James E. Ferguson, her husband and former governor, who is campaigning in her behalf, has been ill for some time. It is said, and the rumors have it that on account of his health she may decide to withdraw at any time.

This rumor was offset, however, in part at least, by an announcement a week ago by Ferguson that he expected Mrs. Ferguson to win by a large majority in the primary race. Ferguson admitted, however,

In his statement that Lynch Davidson, of Houston, third of the leading candidates, has made great inroads into Moody votes, and it is pointed out by political observers, that if this be the case, then surely the Fergusons also have lost supporters.

Davidson, who at the outset of the race, was not believed by supporters to have much chance at the governorship, has undoubtedly made great strides during the past six weeks. He has gained many supporters, both from the Ferguson and Moody camps, and many observers are of the opinion that if either Mrs. Ferguson or Moody is eliminated in the primary, he will have an excellent chance at being elected in the run-off.

YOUNG PEOPLE OF TODAY SAYS BOSTON EVANGELIST NOT SO WILD AS PAINTED

Boston, July 19.—(INS)—"Many young people of today are not so wild as they are painted. You give them something to understand in religion and they will follow it. I really believe that today we are dealing with a better class of young people than a generation ago."

The speaker was Lewis E. Smith, evangelist. He was addressing a group of ministers and laymen, who met to complete plans for a religious revival in the fall.

Plymouth Eng., July 20.—A terrible three days' fight with fire

on a ship at sea while passengers jazzed on deck was described when the British liner Sagana arrived here from Rangoon.

Channel Isles Again Refuse To Be Taxed

London, July 20.—(INS)—A critical decision is understood to have been taken by the Jersey-Channel Islands State Committee which has been examining the demand of the British Home Department for a contribution to Imperial funds in respect of the cost of the World War of \$600,000 annually for the next 100 years.

The report of the committee is to be published almost immediately. Briefly, it will be found to repeat only the previously rejected offer of a single final payment of \$1,500,000 without prejudice to the liability of the Jersey State.

A proposal that Jersey should pay \$2,500,000 in respect of war pensions already paid by the British Government, and be responsible in future for its own pensions administration and the maintenance on the Militia, was advanced by a group of local legislators, but this compromise was also refused by the State Committee.

The majority of the members of the committee contend that the ancient privilege of the Jersey State free it from all monetary claims and that the only sovereign power to which they are subject is the King, although the Committee of the Privy Council of England which investigated the position on the spot in the Islands ruled that the British Parliament has unquestionably the right and legal power to impose financial legislation upon the Islands with or without their consent.

The Privy Council Committee found that the cost of the contribution would involve the imposition of taxation amounting to nearly \$15 per head in Jersey and nearly \$10 per head in Guernsey, compared with \$37 per head in Britain.

The Cook county alimony bureau, sponsored by Superior Court Judge Joseph J. Sabath, has been granted an appropriation for the expense of collecting and distributing the \$5,000,000 alimony paid by divorced husbands to their former wives.

The first alimony case is Mrs. Margaret Denar, of the board of public welfare, long associated in court and social service work.

It will be her duty to accept from husbands the alimony they have been ordered to pay for the support of former wives and children. She will make out checks for the amounts, and forward them to the beneficiaries.

Judge Sabath, who has a record of handling more than 3,000 divorce cases annually, said he believes other judges of the municipal court through whose court many additional divorce suits are settled, will co-operate.

"I don't care so much about the childless wives," said Judge Sabath, in speaking of the bureau's inauguration.

"But every day, mothers appeal to me for assistance in enforcing the payments of alimony. In many cases they are too poor to hire attorneys to press their claims. Even if they do obtain a lawyer's services, he usually collects about one-half of the money thus obtained as his fee."

Under the alimony bureau.

BARBARISM AND
CIVILIZATION

We know the world is
pretty well stocked up with
heartless, cruel beings.

But we cannot imagine
anyone being quite so savage
and barbarous as Nevil
Cranford, former convict
superintendent of Stanley
county, who is now on trial
charged with the murder
of two prisoners. If evi-
dence already submitted in
the case is true, no punish-
ment devised by civilized
communities is too severe
for him. In fact, death is
too good.

It is true there are thou-
sands of fanatics through-
out the country crying for
abolition of capital punish-
ment. But how can crime
be stopped without punish-
ing the criminal? Is the tak-
ing of a life like that of
Cranford's atonement for
the crimes he has commit-
tee?

Consider the numbers of
pitiable beings who have
gone to untimely graves be-
cause of his brutality. Is
the life of the murderer
more precious than those he
killed. Would the taking
of his life expiate the hein-
ous crimes he is charged
with committing?

If the electric should be
dismantled in favor of pris-
on sentences there will go
with the change that salu-
tary fear of the law which
has acted as a check on a
'twicked and criminally in-
clined people.

Abolition of capital pun-
ishment in cases like that in
which Cranford is involved
would endanger civilization
as nothing else has ever
done before. It is true the
taking of life is not in ac-
cordance with teachings of
the Bible. But even those
teachings do not cover
crimes as repulsive and re-
volting as that in Stanley
county.

Cranford's unprovoked
attack upon an invalid boy
under his care shows be-
yond question that the man
was possessed of little sen-
sibility. (It shows beyond
question that he had little
regard for the feelings of
his fellow man. He be-
came so hardened by his
own villany, his own savage
thirst for human blood, that
his passions knew no bounds
—no limitations.

The courts function for
justice to humanity. Here
is a case where justice must
be meted out. It is up to
the courts to determine how
severe it shall be.

JUST "BLOWING OFF"
TO BE BLOWING

To hear some people
"blowing off" you would
think they had been Mayor
of some great city, United
States Senator, or possibly
President of the United
States.

All of us like to "blow
off" every now and then.
This letting off steam seems
to be a kind of safety valve
to prevent our doing some-
thing actually great some-
times.

All of us think we could
handle the other fellow's
job better than he handles
it himself. We are all mortals
in one sense of the
word. We place unusual
significance on the capital
"I." In fact, all of life is
centered around it. We are
so chock-full of egoism that
we can hardly walk down
the street without hearing
someone say, "There goes
one of the brightest men in
the world."

Mother used to call us
"son" in the old days. She
did it to designate us from
sister, that's all. And not
because she considered that
we scintillated like Old Sol
himself. Naturally she
thought we were "some
stuff." That was because we
were a part of her, flesh and
blood, and not because of
any extraordinary qualifica-
tions or mental endowments.
We like to advise the
other fellow what is best
for him. We like to tell him
how to mould his own des-
tiny, while our experience
is confined to our own nar-
row horizon. We just nat-
urally fancy the idea of
knowing what the other fel-
low is doing, and he might
sure he doesn't pull some-
thing over us.

It must be that we have
a little of Pandora's charac-
ter about us. We cannot
account for anything else
incriminating about our
characters. Old Pan was
so inquisitive that she sim-
ply had to open the little
box in her keeping. We
know that she let out all the
pests which now trouble
mankind.

That is the mythological
version of inquisitiveness.
The average every-day ver-
sion gives it as just "prying-
into other people's affairs."
That's about all it is, too.

The other fellow is going
to take care of his job. If
we take care of our own,
we will have our hands full.
The President may not suit
us all the time. Other things
may not come out just ac-
cording to our way of think-
ing. But the world's going
about it's business just the
same, despite all we say,
and do. So keep quiet—
don't rock the boat.

All Harmony
With Connecticut
Republicans

Hartford, Conn., July 20.—
(INS)—All is harmony among
Connecticut Republicans, their
leaders here say as they plan for
the coming fall election campaign.
Hiram Bingham, professor of
Latin American history at Yale
University, and United States
Senator from Connecticut, is to
have the nomination for that of-
fice again. John H. Trumbull,
wealthy manufacturer and pres-
ent Governor of Connecticut, will
find on one to contend against
him for the nomination as can-
didate for Governor of Connecti-
cut on the Republican ticket.

Two years hence, say some
Republicans, Governor Trumbull
will seek nomination as Republi-
can candidate for the United
States Senate, succeeding George
P. McLean, gentleman farmer,
who is now representing Con-
necticut with Prof. Bingham in the
Senate.

Professor Bingham, two years
ago, was elected Governor of
Connecticut, with John H. Trum-

bull as Lieutenant-Governor. U-
guarding an English outpost, all
S. Senator Frank B. Brandegee
had then been dead for several
months, and many Connecticut
Republicans hoped to elevate and
Congressman John O. Tilson, of
New Haven, to the Senate. At
that time started you must finish
the eleventh hour, Governor Bing-
ham decided he desired to be day's
World Magazine. Articles
Senator and made the campaign of
interest and the best of all
at a special election without re-
siding as Governor. Eventually
elected Senator, he was inaugu-
rated as Governor and the next day
resigned, after convening the
Legislature.

Meanwhile Congressman Tilson
elevated to the dignity of House
Leader, is content with that hon-
or and will not compete against
Senator Bingham again though
two years ago he almost snatched
the nomination from the Yale
man. Congressman Tilson, it is
believed here, evidently will be
given a Federal Court judgeship,
a bill to create a new district in
Connecticut now being in the
making.

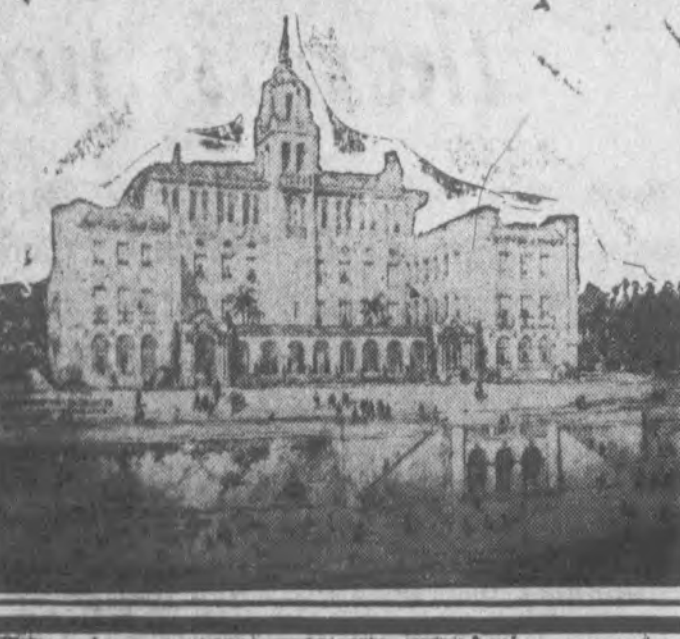

FLYING FIELD AT SEA
FOR OCEAN TRAVELERS

Philadelphia, July 20.—(INS)—
Ocean travel may be entirely
revolutionized within the near
future, according to Edward R.
Armstrong, mechanical engineer
who has invented a floating fly-
ing field.

According to those who have
seen Armstrong's model on his
state, at Holly Oak, Del., where a
demonstration will be made
shortly, a 34 hour trip by airplane
across the Atlantic Ocean could
be made. Eight of these float-
ing and anchored land fields,
equipped with hotels, fuel stations,
machine shops and weather sta-
tions could be placed at regular
intervals across the ocean, accord-
ing to Armstrong's plan, where
the airplanes could land.

The "seadrome" as the inven-
tion is called, will have a drift
placement of many thousands of
tons, 97 per cent of which will
be below the line of wave dis-
turbance, it is said.

According to the tentative
plan, it provides for a terminus
at Atlantic City, and one at Ply-
mouth, England. The planes car-
rying 25 passengers each will fly
in both directions each day and
at no time will they be more than
150 miles to the nearest seadrome
which are planned to be less than
400 miles apart.

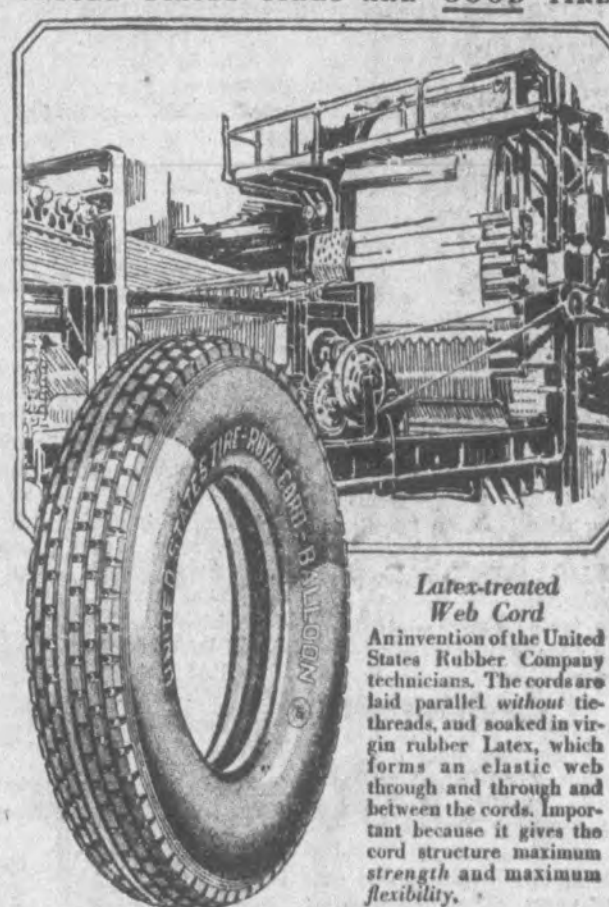

Lincoln Holds Annual Festival

Lincoln, Ill., July 29.—(INS)—Boston had its tea party, but in Lincoln it's watermelons that count. Residents of Lincoln talk of the watermelon christening much as the Bostonian speaks of the tea fest, as the Chicagoan the 'ree.

Twenty-four United States cities or towns bear the name of Lincoln. But only one, Lincoln, Ill., was named in honor of the Civil War martyr before he passed on. Only one bore his name before he ever became famous.

As a struggling country attorney, Lincoln lived in a town that was a mere handful of small dwellings. It was known as Potsville, and sprang up at a crossroads 33 miles northeast of Springfield, the state capital.

In 1839, Lincoln's bill creating Potsville the seat of Logan county became effective. A crowd invaded the country in 1852. Three pioneer real estate promoters bought a section of land near Potsville and laid out a rival village.

Lincoln was their legal advisor, and, against his good-natured warning that "nothing named Lincoln ever mounted to much," the town was named after the future president.

Lincoln, snail, homely, lank, ungainly and whimsical, bought two watermelons from a country peddler.

With a humorous flourish, he squeezed a handful of the red melon meat, performing the 'ceremony' of baptism for Lincoln, Ill.

Egypt's Buying From U. S. Sees Great Increase

Boston, July 29.—(INS)—Egypt now buys \$10,000,000 worth of merchandise annually from the United States, four times as much as the famous Biblical country purchased from the States before the world war.

On a visit to Boston recently, Richard A. May, United States Trade Commissioner to Egypt, said that since the pre-war period American exports to Egypt have increased from \$2,500,000 a year to \$10,000,000.

Most of Egypt's purchases from this country now consist of luxuries and modern-day comforts, while before the war they were largely necessities, May asserted.

Showing how the major products of exports to Egypt, have changed, May pointed out that in the pre-war period they were flour, coal and steel, but today they are automobiles, typewriters, razors, toilet preparations and specialties.

Despite the material increase in exports from the United States to Egypt, however, the balance of trade is heavily in favor of Egypt, May continued. American imports from that country consisting principally of Egyptian cotton. The greater part of the cotton lands at Boston for shipment to Baltimore and New York and thence to Akron, Ohio, to be made into tire fibre.

Although rich in tradition and history, Egypt is rapidly picking up America's made of daily life and becoming modernized so to speak, by building excellent railway, tram cars and large imposing buildings.

Several months ago, May said, he visited the heart of Sudan and learned that there were 800 automobiles in that section, 750 of which were made in America.

British East Africa, according to May, ranks second to the United States in automobile population, with one car for every eight inhabitants while his country has one for every six.

Relative Fights Auction Sale of Buffalo Bill's Ring

Denver, July 29.—(INS)—Johnny Baker, of Golden, a foster-son of Buffalo Bill, who is a nephew of the famous Indian fighter to State Bank Examiner Grant McPerson to prevent the latter from auctioning off a 61-2 carat diamond, said by McPerson to have been the property of the noted scout, to satisfy a claim against a nephew of Colonel Cody.

Bank examiner McPerson claims the ring was given by E. Cody Bond of Greeley, Colo., a nephew of the famous Indian fighter to Northern Bank and Trust Company, as security for a loan of \$3,000.77. The bank later failed and the state examiner directed that the ring be sold as part of the assets.

Baker denies that the ring was ever the property of Buffalo Bill and that no one has the right to represent it as such, inasmuch as such representation, might have a tendency to enhance its value in the eye of some prospective bidder.

DEATH OF GOVERNOR'S WIFE BRINGS FREEDOM TO DOOMED MAN

Springfield, Ill., July 29.—(INS)—The thud of hammers in the hands of workmen erecting a gallows not only saved Ignatz Potz, from the gallows but will make him a free man October 11, 1930.

And it was all due to the fact that the noise reached the ears of the wife of Gov. Len Small, who was present when the Governor at that time was on trial in Waukegan on charges of having failed to turn over to the state certain interest on funds collected during his term as state treasurer.

When Mrs. Small heard the blows, she inquired as to their source and was told that they came from the gallows on which Potz was to be executed for the murder of William Peterson a motorcycle policeman. So she asked the Governor to commute Potz's sentence.

Before the execution, however, Mrs. Small did and the Governor remembered her plea and commuted Potz's sentence to life imprisonment.

Then on the fourth anniversary of his death recently, the Governor again commuted the man's sentence, this time to freedom on the date set.

Now residents of Lake county are recalling the sensational trial of Potz and his four companions. Potz and his mates had borrowed an automobile for a hunting trip and it is alleged, drank freely. While passing through Winthrop Harbor at a rapid rate they were chased by Peterson on a motorcycle. Suddenly a shot-gunt was poked through the carment window at his rear, a shot sound and Peterson hurtled from his motorcycle. The men escaped at that time, but later, were captured. Potz's companions all shifted the blame to him and there seem to be some doubt as to his understanding of the proceedings.

N. Y. Prohibition Leaders Not Fight the Referendum

Albany, N. Y., July 29.—(INS)—Organized prohibition forces have decided not to test the constitutionality of the wet-dry referendum in the courts, according to word reaching the state capital.

There had been talk that the drys would retain Louis Marshall, noted lawyer of New York, to fight the validity of the proposal. Before the measure was passed by the Legislature, Marshall issued a statement declaring it unconstitutional.

Under the referendum the voters will be asked to decide whether the state should ask Congress to modify the Volstead act so as to permit each state to determine what shall constitute the alcoholic contents of liquors.

Indications are that the referendum will play an important part in this fall's election. Although Governor Al Smith approved the bill providing for the referendum he has since declared

that this is only one of the many important things which the voters will be asked to pass upon at the election in the fall.

The referendum bill was sponsored by two Republicans, but the Democrats feel that the proposal will be the means of bringing many votes to their state candidates at the election.

ADAM NELSON'S PENSION IS SOLE PERPETUAL GRANT

London, July 29.—(INS)—The only perpetual grant pension now paid by the British Government is that of \$25,000 per annum, granted by Parliament in 1806 to the famous Admiral Nelson and to his male heirs and such other persons on whom the title of Earl Nelson may descend.

This information is provided by Chancellor of the Exchequer Winston Churchill in a written reply to a question in Parliament. The present recipient of the pension, he adds, is the grandson of the nephew of the first Earl.

Perpetual pensions are not now given to soldiers or sailors. An instance of this was given when Parliament granted lunsums to the leaders of the British army and navy at the conclusion of the world war.
