NEARLY FIFTY KILLED AND HUNDRED INJURED BY EXPLOSION TODAY

Fire Following two Explosions Made Furnace of Paint Plant Where Hundreds were Working.

Detroit, April 23.—(AP)—At least a score of men are believed to have been killed and more than 100 others burned and injured, some probably fatally, in a fire that swept the main building of the Briggs Manufacturing Company plant after an explosion in the paint shop this morning.

Ambulances took a dozen or more loads of injured to various hospitals. At receiving hospitals, where 25 injured were brought, Dr. Thomas K. Gruber, superintendent, said that probably two thirds of them would die.

The dead were believed to be buried under the wreckage of the building. More than an hour after the explosion search still was being made.

A strong wind and the fact that the plant contained quantities of paint and varnishes used in auto body finishing, hampered rescue. More than 2,000 persons were at work in the building at the time of the explosion.

Many of the injured were treated in the plant's first aid station, but this had to be abandoned when the flames spread to that part of the building. Most of the injured were victims of the heavy smoke and fumes.

As the fire continued more than an hour and a half after the explosion occupants of nearby houses and stores were directed to vacate immediately, it being apparent the walls of the plant would collapse. Police lines were established 300 feet around the plant.

At 10:20 o'clock the walls on the Harper side of the building collapsed and the fire spread to the opposite side of the street. Residents of the house and shops there began to vacate the building.

The cause of the explosion was not immediately determined but a workman expressed the belief a short circuit motor was responsible.

Adolph Hussey, a truck driver, described the explosion as follows: "I had just delivered an order to a store across the street from the plant and was coming out of the store when I heard the explosion. There were two of them, one after the other.

"The whole wall seemed to crumple up and fall into the street and bricks and stones were every where. A man was blown through the glass of the large windows along the street. Another man and I helped to pick him up and send him to the hospital. He was injured seriously but still living.

Floyd King, 20 a checker on the third floor of the building, who escaped with slight burns, said: "It was like standing in the mouth of a cannon while it was being exploded."

The first explosion he said, came without warning and was followed a second later by a searing sheet of flames that engulfed a spraying room where 50 men were working. "It came like a clap of thunder," King said. "Then everything became fire. The fire passed over my head like a wave and burning my hair. I started running for my clothes to get my money and my street car tickets."

"I had taken no more than half a dozen steps when someone bumped against me and knocked me down. I fell to the floor. While I was struggling to get up the floor leaped into flames and I was burned on the shoulder and arm."

"I was lucky," he said, "I don't know what happened to the other men. I know that their clothes seemed to shrivel into rags when the sheet of fire hit them. The room was like a furnace. Flames and cries and shouts. I got out as quick as I could."

King said he believed the explosion occurred in spraying tanks on the fourth floor.

Scenes at the receiving institution a city institution where many of the victims were taken, resembled a dressing station during the world war.

The flames were brought under control shortly before noon at that time Charles T. Earl, deputy coroner, estimated that a score of bodies still were in the ruins. Many of the injured were negroes.

BIG SANDY RIVER BRIDGE COLLAPSES

Huntington, W. Va., April 23.—(AP)—A span of the new bridge across the Big Sandy River between Kenova, W. Va., and Catlettsburg, Ky., near here collapsed today. Men at work on the span were warned of the danger and escaped unhurt.

The bridge under construction fell in December killing seven men.

His Motto Work and Fun, Is 93 Years Old



New York, April 23.—(AP)—Chauncey M. Depew, whose famous motto for longevity is "work, temperance and fun" is 93 years old today.

Depew has figured in a long list of serious achievements in business and politics. For 12 years he was president of the New York Central railroad for 14 years and director of numerous other companies.

The farm at Peekskill, N. Y. where he was born April 23, 1834, is an historic landmark.

SEE DANGER TO PARTY IN SOLID SOUTH

Democratic Leaders Say Withdrawal of Smith McAdoo Necessary to Save Party.

New York, April 23.—(AP)—The New York Times and the World supporters of Governor Smith, say today that the leaders of the Democratic party have seriously discussed the circulation of a round robin among leaders of the party calling upon both Smith and Wm. G. MacAdoo to withdraw as candidates for the Presidential nomination.

The Times quotes these leaders as saying that the withdrawals would be asked "to save their party from defeat which would be inevitable should they both remain in the race."

The movement, says the Times, originated in the South.

The World says that Senator Carter Glass of Virginia, who has been in this city recently, is expected by friends to voice such a demand publicly.

"George F. Milton, Editor of the Chattanooga News and in 1924 one of MacAdoo's principal lieutenants, in a statement in the Times says that in a race between Smith and Coolidge 'The Republicans would be certain to break into and disrupt the solid south.' 'Mr. Milton has been in the city several days, and so has Mr. MacAdoo."

Washington, April 23.—(AP)—Senator Glass, Democrat, Virginia, who returned today from New York, declared that there was not "a word of truth to the suggestion printed in New York newspapers that he might voice a demand for the elimination of Governor Smith or William G. MacAdoo or anyone else for the Democratic nomination for President."

Bodies of Lovers Found in Paris

Paris, April 23.—(AP)—The bodies of Julian Meredith of Buffalo, N. Y., and his fiancée Miss Marion Roberts, a New York pianist, were found in an automobile near the Eiffel tower today. They had been shot to death. A pistol was clutched in Meredith's hand.

Meredith had 6,400 francs and a diamond valued at 20,000 francs in his pockets, eliminating the possibility that the crime was committed by robbers. The police are working on the theory of murder and suicide.

FREIGHT RATE MEN ADDRESS KIWANIS CLUB

Secretary of Elizabeth City Chamber Of Commerce Also Speaker Last Night.

D. A. House, president, and W. L. Thornton, secretary, of the North Carolina Shippers Association, were the principal speakers at the regular meeting of the Kiwanis Club here last night. They discussed the freight rate situation in North Carolina, declaring that efforts of the Shippers Association were producing splendid results in this section of the state. Dick Job, secretary of the Elizabeth City Chamber of Commerce, also spoke.

The Kiwanis Club program last night was one of the most interesting and entertaining in several weeks. It consisted of a delightful musical program by Misses Agnes and Carolyn Pulllove, and Miss Eugenia Thomas. This all came under the program presented by Kiwanian Hugh Porter. President W. H. Woolard presided over the session.

Mr. Thornton told of the freight rate situation as it exists in North Carolina today, and what the North Carolina shippers association is doing to bring about a change for the better. He said everyone should be interested in transportation problems because they vitally affect the consumer—the man who has to pay.

He enumerated what the association is doing, what it has done, and what it intends to do to give the state rates similar to those enjoyed by other states. He said the North Carolina Shippers Association had been in existence two years. During that time it has been instrumental in greatly decreasing the price of several commodities. Nineteen million pounds of sugar have been handled through the association at New Bern at an average saving of eight cents per hundred pounds to the consumer, he said.

He spoke in an informative way of the earnings of the various railroad systems of the nation, declaring that they had been greater than railroads of the transportation laws provided. These rates, as they affect North Carolina, will never be reduced, unless business men take some concerted action through sources provided by associations interested in transportation problems.

Mr. House, who is a leading business man of Wilson, said transportation is one of the most important questions before the public today. Regardless of everything else, the problem of transferring goods from one section of the country to another, is of the most vital concern to people in every walk of life.

He said decreased rates on sugar from Baltimore to this section of the state, through the inland waterway at New Bern, had resulted in a saving of \$35,000. Savings on all other commodities through the port of New Bern amounted to \$135,000.

He told of how the association had been instrumental in the suspension of rates on potatoes shipped from the two Carolinas, saying that this alone amounted to an annual saving of \$150,000.

He declared that the business men of North Carolina should get together and try to improve conditions as they affect transportation. An enormous saving in freight rates may be realized each year through properly organized channels, he said. North Carolina is deserving of rates similar to those enjoyed in other states but she will never get them unless determined effort is made.

Mr. Job told of what his section of the state had been doing in the way of improving transportation problems. He said a considerable sum of money had been saved annually through decreased rates on beans and potatoes. A total of \$12,000 annually has been saved on bean shipments alone through activities of the North Carolina Shippers Association, he said. \$31,000 annually has been returned to the pockets of shippers through rate savings on the potato crop.

Price levels are not established by the shippers in this section of the state, he said. They are fixed by northern markets. After discriminatory freight rates from North Carolina have been deducted, a decrease in freight rates will result in hundreds of thousands of dollars annually to shippers of North Carolina. This money will not go to the upbuilding of some other section of the country. It will remain at home and enable our growers to improve their farms, their living conditions, and assist in a general way in the development of Eastern North Carolina.

C. B. Rowlett told of the recent district meeting of Kiwanis Clubs in Rocky Mount. He said it was one of the best sessions in years. He presented the club with a tin can, bound with crepe, as a reminder of the poor attendance by the Greenville organization.

BAKER FOUND NOT GUILTY

Criminal Court Continues Sitting Today to Complete Week's Docket.

Following a week of most intense activity, the criminal term of Pitt county Superior court which convened in this city last Monday morning, continued its sitting today in order to complete as near as possible, one of the most congested dockets in years. The final week's session will convene Monday morning.

A jury in the case of P. O. Baker, Greenville man, charged with manslaughter, this morning returned a verdict of not guilty. The charge against Baker resulted in an automobile wreck last year in which Dave Fleming was killed.

The case against Preston Gardner and D. R. Mercer, Jr., Fountain young men, charged with assaulting an officer with intent to kill, was suspended on account of insufficient evidence. They pleaded guilty to a charge of driving an automobile while under the influence of whiskey, but judgment was suspended on payment of cost. They were required, however, to appear before the court two times annually for a period of two years, and will not be allowed to drive an automobile in the state within the next twelve months.

Judgment was suspended in the case against Willie Hudson, colored, charged with bastardy. The defendant, however, was required to pay to Eula Joyner, prosecuting witness, the sum of \$200.

Sentence so far has not been pronounced in the case of H. F. and T. L. Brooks, who were found guilty of manufacturing liquor, during the first part of the week, and Henry Smith, charged with incest. The calendar for next week contains a number of important cases of interest to people in this section of the state. Among them is the case of A. C. Jackson, former sheriff, who was removed from office on a charge of shortage of funds.

START MAN HUNT TODAY IN CHICAGO

Attacker of Women Busy Again Last Night in Business District of City.

Chicago, April 23.—(AP)—A man hunt with few local parallels has been started for "The Cat," Chicago's most feared nocturnal marauder and attacker of women.

More than 90 attacks within 8 months now are charged to this bandit who matches purses, occasionally beats and sometimes assaults his women and girl victims.

Last night he appeared as always in the past—dressed in a grey topcoat and the inevitable grey fedora which his victims all have mentioned as distinguishing articles of his attire. A sliken hankerchief was tied over his lower face and he moved with the catlike agility that has given him his name.

Two of the women were robbed of their purses and saved themselves from his further advances by screaming, a third woman pleaded with him and then screamed, whereupon he fled.

The fourth attack, the most brazen in the long list of outrages, nearly resulted in his capture. He had climbed a tree and entered the home of Max H. Sobel, where he concealed himself in a closet of a room occupied by the two small daughters of the house. Mrs. Sobel, opening the closet door, saw him flattened against the wall, masked and holding a small revolver.

As "the cat" slowly advanced in to the room, commanding her to the point of the revolver to keep quiet, Mrs. Sobel screamed and snatched the silken covering from his face. As she struggled, her husband rushed into the room.

"The Cat," menacing both with the weapon, ordered them to back out of the room. Then he fled.

Baker To Head Flood Relief Work

Washington, April 23.—(AP)—Henry M. Baker, national Red Cross director of disaster relief, today was named as director of the relief work in the Mississippi flood area.

His designation was announced after a meeting of the special committee which has been named to deal with the situation which includes four members of the cabinet.

Coinciding with the meeting the Red Cross National headquarters donated \$100,000 to go into the fund of \$5,000,000 which is to be raised for relief purposes.

WOMAN KILLS 3 CHILDREN

Says She Killed Them Because She Wanted Them to Go to Heaven.

Flandreau, S. D., April 23.—(AP)—Because she wanted them "to go to heaven," Mrs. Lloyd Overdahl killed her three young daughters at her farm home 18 miles southeast of Flandreau.

The explanation was given to county authorities after she was placed in jail here today. Her husband brought her here and turned her over to sheriff Edward O'Hern.

While the three slept last night the mother slashed their throats with a butcher knife, according to the version she and her husband gave the sheriff.

JOHN EARLY TO BE SENT HOME TODAY

Laughinghouse Wires Sheriff to Take Charge of Escaped Leper at Burnsville.

Raleigh, April 23.—(AP)—State Health Officer C. O. H. Laughinghouse today wired Yancey county sheriff Hugh Banks at Burnsville to take charge of John Early, escaped leper, and have him returned to the Carrville, Louisiana, leprosyarium at once.

Dr. Laughinghouse wired the sheriff to "apprehend and detain John Early. Secure attendant to convey Early to Carrville, La., with agreement to pay attendant" the necessary expenses for the transportation.

The action of the State Health authorities followed several days of "hands off" policy on the part of the Federal and State governments in the case.

While private negotiations were proceeding, Early was reported to have been encamped in Yancey county where he had gone to be with his homefolks.

It had been privately understood that, under state charge, Early would have certain rights which might embarrass his removal from the state back to the unfortunate man's confinement in the federal leprosyarium in Louisiana but these were ironed out privately and terminated in the telegram sent this morning to the sheriff.

State and federal authorities cooperated in the matter and Early moves out after a joint consideration by the State Attorney General, Dennis Brummitt, and state and federal health authorities.

Dr. Laughinghouse wanted no technicalities to stay an expediting cautiously for several days, meaning being sure Early was not a cause for alarm in western Carolina, before today's telegram was dispatched, apparently closing the incident of his arrival, so far as the state health officers were concerned.

In returning Early to Louisiana, the state will be acting simply as agent for the federal government.

Dr. Laughinghouse's telegram to the sheriff followed directly upon a telegram from the state health officer from acting Surgeon-General C. C. Pierce of the U. S. Health Service, Washington, D. C. which stated "We are returning Early" to Carrville, and asking the state authorities to hold Early pending arrival of an attendant. If an attendant were available in the state, the Surgeon General said he would appreciate the state's securing one.

In receipt of the telegram from Washington, it was commented informally at the health department here that the state had won its point, that is, that the matter was one solely for federal action, and followed a series of conferences, ending in the federal government taking over responsibility and disposition of the case.

Meanwhile, state health authorities have secured an attendant to take Early back to the leper's home. The state pays the transportation expense, \$35 a day.

FEDERAL TROOPS KIL THIRTEEN MEXICAN REBELS

Mexico City, April 21.—(AP)—Official announcement was made today that federal troops in the State of Guanajuato had killed 13 rebels and captured three of the band in a clash near Don Diego Hill. Those captured included the leader, a German named Pichardo, who was court-martialed and executed.

FLOOD SITUATION IN THE MISSISSIPPI VALLEY IS MORE MENACING TODAY

WINSTON-SALEM SENDS \$11,000 TO SUFFERERS IN FLOOD TERRITORY

Winston-Salem, April 23.—(AP)—The Winston-Salem Red Cross chapter at noon today forwarded a check for \$11,000 to the American Red Cross for relief of the Mississippi flood sufferers, this sum being \$1,000 in excess of that asked by the National Society.

The R. J. Reynolds Tobacco Company made a cash donation of \$10,000 to the fund and several other substantial donations have been made.

JUNE 4TH IS ALUMAE DAY AT COLLEGE

The kitchen is equipped with ice boxes, electric range, and all necessary utensils and vessels. Beds and cots will be placed in the Y. W. C. A. Hall.

The visiting alumnae will be much more comfortably located than in previous years.

The Alumnae Association will hold its regular business session Saturday morning, and the alumnae luncheon will be held at one o'clock. On the evening of June 4, the college will present Edwin Swain, baritone, in honor of the alumnae.

COAST GUARD ORDERED OUT

Entire Personnel of Louisville Station to Go to Mississippi Valley.

Washington, April 23.—(AP)—A relief party composed of the entire personnel and all vessels of the Louisville station of the Coast Guard was ordered today to aid in relief of victims of the Mississippi Valley flood. An emergency force to man the Louisville station, in the absence of the regular members probably will be recruited today.

The relief party is expected to start at once taking all available life and motor boats into the stricken area. It will work with the Coast Guard vessel Kankakee, to the commanding officer of which they will report. The Kankakee has been carrying hundreds of refugees to safety from the inundated Missouri district. Coast guard headquarters here have instructed the senior officer at the scene of the floods to co-operate in every way possible in relieving suffering.

If the flood rains in proportion it is expected that life boats will be shipped by rail from the Great Lakes to the threatened areas.

FLOOD CONDITIONS CREATE TRANSPORTATION TROUBLE ON RAILROADS

Washington, April 23.—(AP)—Flood conditions in the lower Mississippi valley have created a transportation emergency. The Interstate Commerce Commission decided today and railroads affected were authorized to disregard until further notice all usual conditions affecting the routing of freight.

Inhabitants Race With Death as Surging Food Waters Con- tinue on Their Ram- page

Memphis, Tenn., April 23.—(AP)—Epic races with death were taking place in many parts of the lower Mississippi today as the surging flood waters of the great river continued their rampage.

Seaplanes, fast motor boats, river steers, skiffs and even slow moving barges were the agencies which tireless rescuers pressed into service in an effort to save thousands marooned on water lashed levees, knolls, house-tops and in trees.

Despite all effort to rescue the death list in the flood was steadily mounting with the known dead placed at 48 early today and reports of many other drownings in various sections, and especially in the Yazoo basin, flooded alike by the raging Mississippi and the backwater from the Yazoo River.

While no new breaks in the protecting levees on the lower Mississippi were reported the waters thundering through the crevasses at Knowlton's landing and other places were rapidly spreading over the delta country, inundating additional plantations and rendering more thousands homeless.

With the rush of the floods into the lower valley extra precautions were taken from Vicksburg South to strengthen the levees. All the water from the major breaks above Vicksburg will course down tributary streams to find its way back into the Mississippi.

Slowly Vicksburg and with it some places already weakened by high waters, no chances were being taken as armies of men toiled on the levees with stand-bags and shovels.

Their homes engulfed by the raging waters, thousands of refugees were in beleaguered cities and towns or clung precariously to house-tops, trees, small knolls and levee tops. Reports to the Mississippi River Commission indicated that the refuge situation was most acute along a line from Bolivar to several miles below Greenville, Miss. All possible government equipment and many private boats have been sent to Greenville and also to the levees above the crevasse at St. Louis to remove refugees to points of concentration.

From over the flooded area came the cry for boats.

Surging was said to be intense among hundreds marooned without provisions of sufficient clothing.

At Greenville, Miss., ten thousand refugees from the lowlands in addition to citizens and the situation was described as desperate. Hundreds camped on the river; levee and water and food were scarce.

The River Commission learned that water was at least two feet deep in high spots near the levee and about ten feet deep in outlying low portions.

Despite that the river was falling at most points in Mississippi, as waters emptied out into the delta, orders were issued to levee guards to redouble watchfulness.

The number of deaths resulting from the break in the levee at St. Louis Landing will not be known until the waters have subsided. An Associated Press correspondent advised from Greenville last night that bodies of negroes had been seen in the water which was coursing through the city in a swift current.

Government engineers reported there was more crevasse water in Greenville than in its history. The current was said to be stronger than in the great floods of 1897 or 1903. The engineers estimated that 200 River before the St. Louis Landing approximately 1,000 square miles were under backwater from the Yangtze break poured its deluge into the basin. The waters are expected to extend over more than 2,000 square miles, they declared.

Governor Dennis Murphree Mississippi said boats were not to traverse flooded areas in the State.

"It is the plan of State authorities to remove from Greenville all the refugees and all other persons who desire to leave the city," the Governor said.

Throughout the Arkansas lowlands, where the rescue work has been longer organized and was sustained yesterday by scouting, boats continued the work of removing refugees of roadway and the first train in several days from Little Rock to Memphis left the Arkansas capital at 10 o'clock last night.

Government seaplanes from Pensacola, Fla., have been sent to the Little Rock area.

FIFTY PLAYERS LEADING RUTH IN BATTING AVERAGE

Chicago, April 23.—(AP)—Strange facts appear among the group of leading major league hitters in the first week of the season, with some of the regulars, particularly Babe Ruth, far down the row. Fifty players have better figures at bat than Ruth, according to the averages compiled today including Wednesday's games. But Rogers Hornsby is showing his stuff to Giant fans and stands third with the surprising percentage of .467, compared with .233 for Ruth.

Harry Heilmann, the American batting champion, starts off the season in front of his contenders with a mark of .500 for the first week. So far the American League can boast of 11 batters in the 400 class, while the National League has ten.

Among the leading National League sluggers whose averages have withstood the withering heat of the mid-summer competition, Bubbles Hargrave of Cincinnati, one of last year's leaders, is just within the first ten for the opening week of 1927. Kiki Cuyler of the Pirates, another "regular," stands eighth, while Heinie Sand of the Phillies holds the first position with .565, the heavy hitter of the major leaguers for seven games.

Old Cy Williams of the Phillies is the temporarily leader of the major league home run hitters with three in games including Wednesday, while Hornsby, Hack Wilson and Earl Webb, of Chicago and Harper of New York have two apiece.

Tyson of the Giants leads the National League base stealers with four, and he also has the largest collection of bases acquired with the bat, 26 bases on 19 hits, which included three doubles and two triples.

There are fifteen National League pitchers with clear records so far, seven having won twice and the others one game. In point of innings pitched, Fitzsimmons of New York leads the league and is the only twirler except Mordridge and Smith of Boston to appear in more than two games.

Leading Harry Heilmann in the American League parade of heavy hitters is Pat Collins, catcher of the New York Yankees, with seven hits in five games, three of them baggers. His percentage is .538. GOLF THRILLS

Atlanta, April 22.—Jim Barnes the lanky Australian, was the first golfer to receive a tournament trophy from the hands of a president of the United States. That was in 1921 at Columbia Country Club in Washington when Barnes won the National open championship.

"When President Harding presented me with the National open cup and I realized I was the only player who had been so honored it was the proudest and most thrilling moment of my life," says Jim. It was Barnes who dashed the hopes of Britons at Prestwick in 1925, when they strove vainly to regain the coveted British open cup, which had been in America possession with the exception of one year since Jock Hutchinson's victory in 1921.

Barnes needed only a 300 to get the title and was one stroke ahead of Edward Ray and Archie Compston. He came into the home stretch in a race with McDonald Smith, who led him by five strokes but the latter slumped into an 82 in the final round and wound up in fourth place.

Like Walter Hagan, Jim crossed the water several times before gaining the British open title, but back to England every year until he captured the trophy.

Barnes is a great friend of Bobby Jones, with whom he spent many hours while here for the Southern open.

Three times Barnes has held the Western open title. He won it first at Minneapolis, in 1914, with a score of 293, taking his second honor when he bested Hagan at Evanston, Ill., in 1917, with 283. Hagan could do no better than a 285.

There was no western open in 1918, but Jim repeated in 1919, stroking the 72 holes for another 283, with Leo Diegel as his runner-up. The next year, he barely missed winning the title the fourth time, finishing one stroke behind Hutchinson, who had a 296.

SPORT SLANTS

There is an impression that the next battle for the world's heavyweight championship again will find Jack Dempsey trying to pierce the shell of Gene Tunney's fist philosophy.

Insiders profess to see, in Tex Rickard's preliminary maneuvers a plan to bring Jack and Gene together again on the theory that they will draw the biggest gate of any possible attraction.

Rickard has made no secret of his desire to have such a match but he has been equally as insistent that Dempsey first must show whether he is entitled to a return bout by meeting one or more of the survivors of the heavyweight elimination tournament.

Dove-tailing with Rickard's purposes, in all probability, is Dempsey's latest statement from his training camp retreat—to the effect that he expects to be ready to fight around July 4.

The probability is that if Dempsey definitely decides to come back he will have only one obstacle to surmount in order to gain a return title fight.

This obstacle may be Jim Maloney, Jack Sharkey or Paulino Uzcudun, the Spaniard. With Jack Delaney apparently out of the heavyweight picture, by edict of the New York Boxing Board the prospect now is that the winner of the Sharkey-Maloney scrap May 19, will meet Paulino to decide an opponent for Dempsey around July 4.

Rav Kremer has reached the pitching peak at a time when most hurlers are on the down grade. Just turned 31, he led the National League twirlers last year and has gotten off to a flying start this season with three sensational victories in a row for the Washington Pirates crew.

He seemed doomed to end his pitching days in the minors, spending seven of his best playing years with the Oakland Club in the Pacific Coast League until the Pirates corralled him in 1924. Starting his fourth season with Pittsburgh his records show 58 major league triumphs and only 24 defeats for a percentage of about .700.

He has improved with age topping the major moundmen last season with 20 victories and six defeats—yet a dozen years ago his health wasn't good enough for him to get a trial with the New York Giants. He was called in from the Pacific Northwest in 1915 by John McGraw but sent back to the same territory when illness cost him his chance for a tryout. Now it seems he will be a big factor in the drive of the Pirates to beat the Giants or any other pennant contenders to the top.

Eddie Roush isn't alarmed at all for his failure to get his batting sights adjusted so far in his new outfield role with the New York Giants.

"I recall one season with Cincinnati," he said, "when I failed to connect safely in the first ten games, but I caught my stride later and led the league in batting."

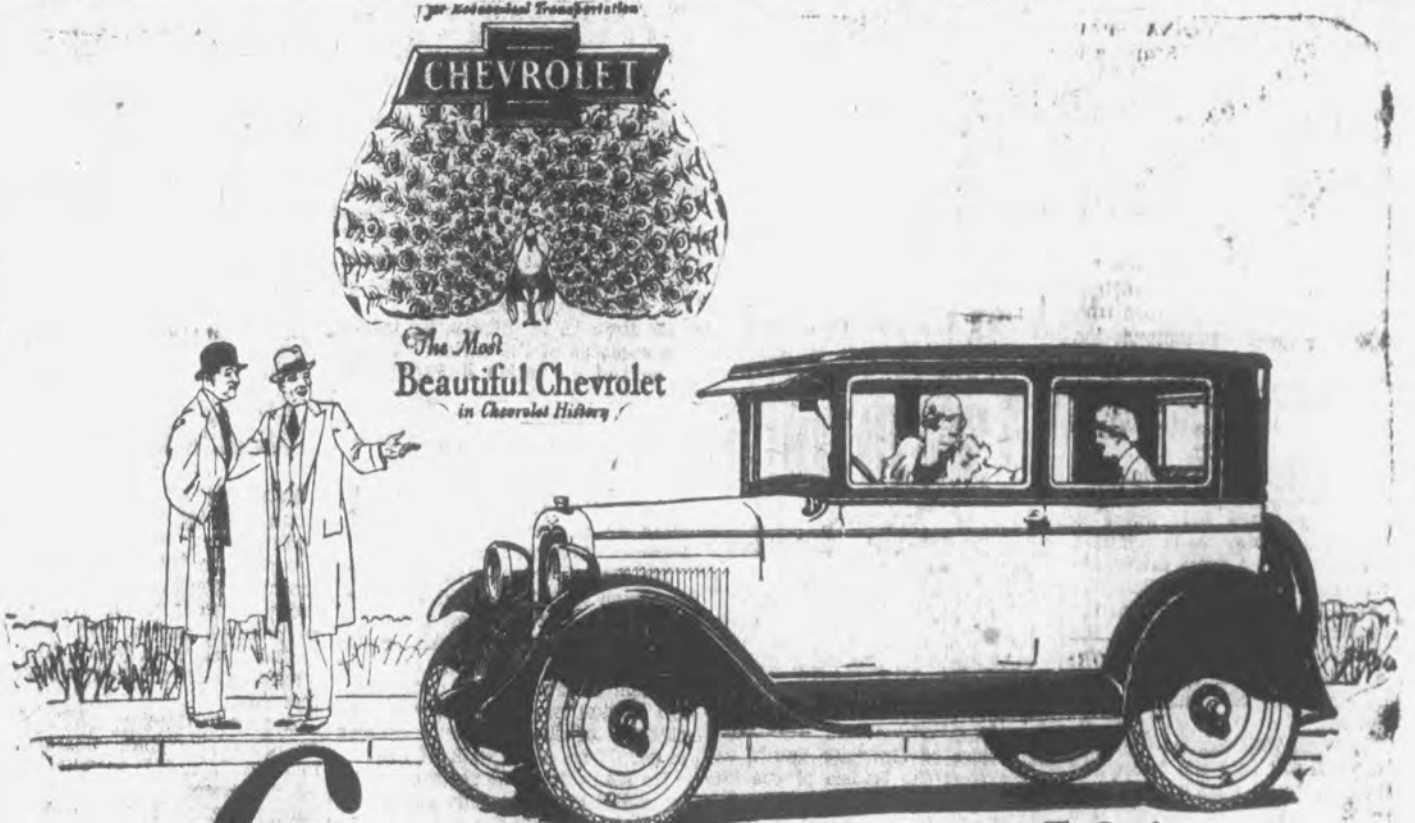

ANSWER THE CALL

Raging floods, have taken a terrific toll in the Mississippi Valley, mile after mile of territory has been devastated and thousands of people are homeless and suffering. These homeless people, many of them women and children, must be cared for if their lives are to be saved and it is up to the citizens of the nation at large to come to their aid.

Yesterday President Coolidge issued a call to the people of the United States for \$5,000,000 to aid the flood sufferers and today this call was passed on to citizens of this county through the American Red Cross. It is to be hoped that Greenville and Pitt county will respond nobly to this call to aid their distressed brothers of the Middle West.

We, in this section of the country have been greatly blessed in that we have been spared the many catastrophes that have befallen other sections of the country, and now that we have the opportunity to aid the sufferers of the stricken sections, it is up to us to do so.

Except through the goodness of Him who controls the universe and who has blessed our section with good crops and prosperity, we, too, might be in dire circumstances. What we have is not our own, but His, in our keeping. Let us follow His example by ministering to distressed and suffering humanity.

A liberal and quick response is necessary for the relief of the flood sufferers. Pitt county has never failed to do its bit and in the present instance we feel confident that our citizens will give to the limit for this worthy cause.

LONGER STAPLE NECESSARY

Records of the past season show that much of the cotton produced in this section was of the short staple variety, for which there is very little demand in the foreign markets, and growers of the section are being warned of the dangers that accompany such production and urged to give more attention to the choice of their seed for this season's planting.

A letter recently sent out by one of the large cotton exporting houses, of Norfolk, clearly sets forth the situation and we reproduce it here because of the valuable information that it contains for the farmers of our section.

"As we are fast approaching the 1927 planting season we feel compelled to say a few words relative to the 1926 crop in our section and the prospects for the future.

"To be perfectly candid, we are very much alarmed over the situation. During the present season a large



percentage of extremely short staple cotton has appeared in our district, so one interested in cotton to much so that we have been very seriously embarrassed. During the fall, being under the impression that the majority of the cotton which we were purchasing was the ordinary cotton which we have been handling for the last thirty years, we paid little or no attention to its length. When our shippers arrived in Europe we were quickly advised that they contained twenty-five to forty per cent of very undesirable, short staple cotton, and further that such cotton would not be accepted against our sales. In order to satisfy ourselves we sent a member of our company abroad, and his investigation while there developed the fact that we had unwittingly sent forward approximately the amount claimed of very short staple. After much negotiation we were compelled to make allowances of approximately \$4.50 a bale on a large percentage of our shipments. This of itself could have been overcome, but our regular customers have decided finally that, unless we can guarantee to ship them hereafter sound seven-eighths and better cotton, they will be forced to make their purchases in other markets where the staple answers their requirements.

"We are writing this letter for the purpose of appealing to the farmers, generally to plant better seed, such seed as will produce certainly a good, sound seven eighths and better staple. Otherwise we must reluctantly admit that Norfolk as a cotton market will lose its prestige which it has enjoyed for he past thirty years, and we ourselves along with others, will be forced to seek our supply from sections where the necessary staple can be secured. We understand that throughout our district a large portion of the seed was planted which is generally known as "Half and Half"—this for the purpose of securing a better yield. While this may be to the interest of the grower who produces it one season, it will surely mean disaster to the section generally unless some drastic steps are taken to eliminate it. We cannot urge our friends too strongly to avoid this short staple seed. Norfolk has enjoyed the reputation of ex-

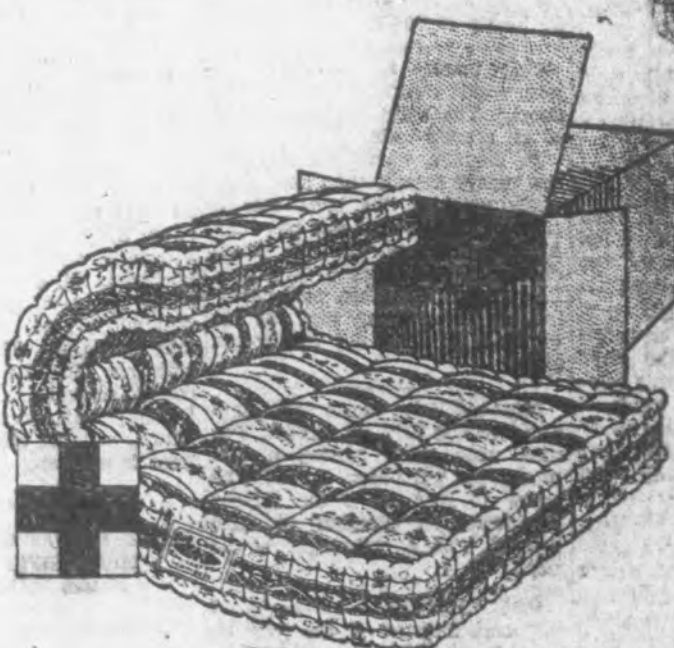

Gossip of Staff Correspondents at World Centers of Population

Oslo, Norway, April 23.—(INS)—“Cheap housekeeping” is the slogan in Norway at present and an interesting discussion is now raging as to how to follow it with most effect. The storm center of the discussion has been the authors of a new cook book, Mrs. Meidell, who has had the audacity to maintain that a family of four persons does not need to spend more than one hundred kroner (about 25 dollars) per month on its food account. Legions of furious housewives have protested indignantly while smiling husbands have given the fearless lady cautious encouragement viewing dimly in their imagination a reduction of their grocery—and butcher bills. The incident even has stirred political interest as the labor parties have feared that the statement might lead to a general reduction of wages, and consequently the combined forces of housewives and laborites have combatted the expert in modern cooking very forcefully and exerted themselves to the utmost in showing that the dishes prepared for that amount quated were uneatable. The culinary lady was not so easily scared, however, and the other day she demonstrated her dishes in presence of a committee of experts and a vast and mostly hostile number of spectators.

Within a few weeks prohibition in Norway will belong to the past. At the referendum last fall the law was defeated by a majority of about 150,000 votes, and the parliament at present debates a proposition presented by the cabinet for a new liquor law. Apparently the prohibition problem has still a curious tendency to create dispute and quarrel and the public at large is greatly discontent with the manner in which, as it is maintained, the law makers disregard the will of the people as manifested in the referendum verdict of last October. Particularly vehement indignation has been fostered because of the parliamentary body has limited the number of cities that shall have a right to sell intoxicants. The cabinet had proposed that the 31 cities where the vote was in majority at the referendum should be entitled to sell, where the law as passed by the Storting limits the number to the 13 cities which before prohibition had a local right to engage in trade with beverages and run a store for the purpose, the so-called “samling.”

Local option rulings for the various cities will be introduced. The political parties having the chief responsibility for the new liquor law as just passed by one of the two main divisions of the Storting are the radical lefts and the labor parties, and it is predicted by political fortune-tellers that the stand taken by these parties in this question may influence the result of the parliamentary elections to be held in the fall. The voters have defeated prohibition and will not be deceived.

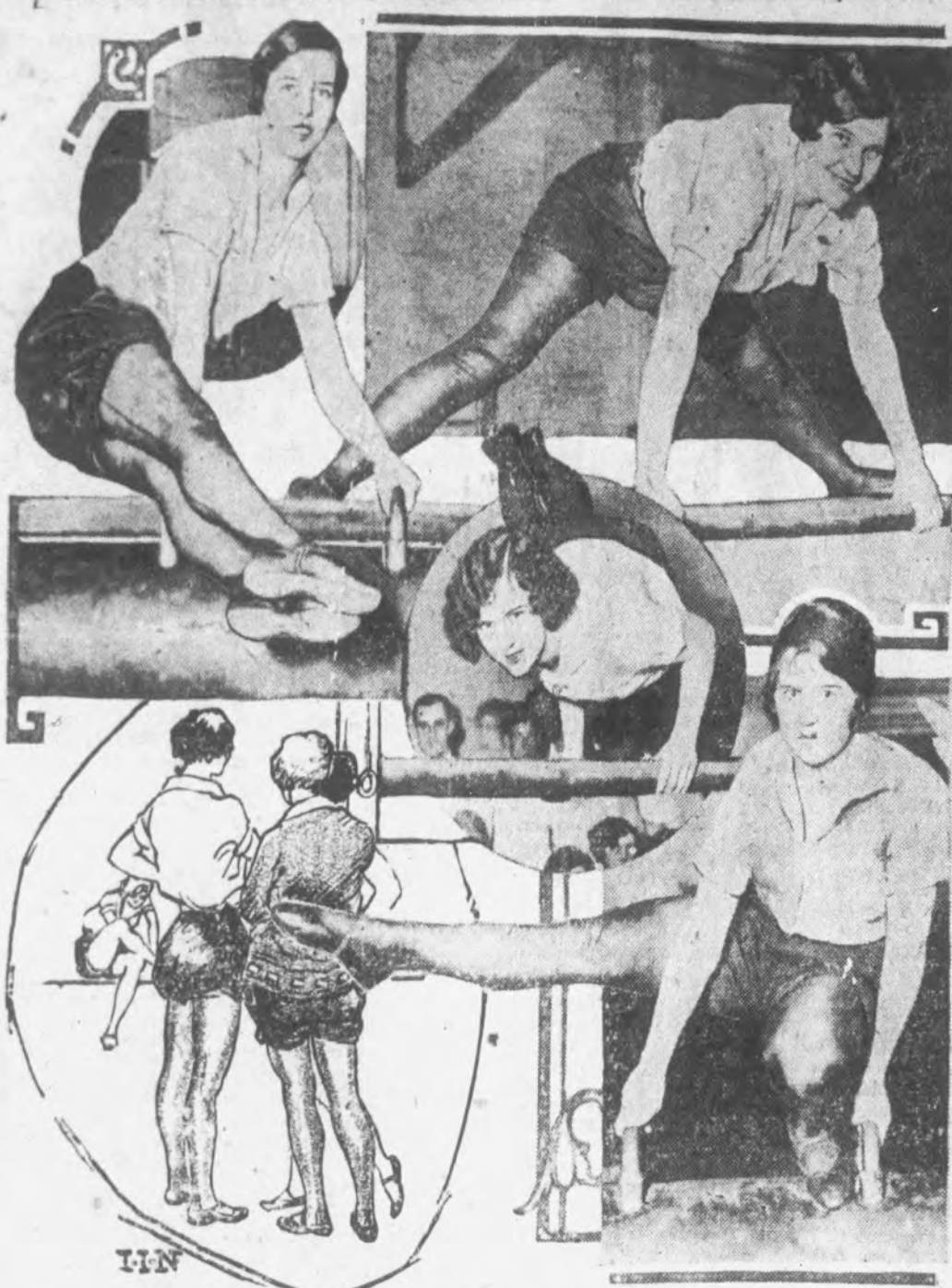

Trains Demolish Two Automobiles

High Point, April 23.—(AP)—Two automobiles were demolished and two men injured by trains within the corporate limits of High Point last night. The two men injured were C. E. Haywood and W. B. Carter.

Mr. Carter was only slightly injured, while the injuries sustained by Mr. Haywood were of a more serious nature. Mr. Haywood is in a local hospital, suffering with a broken arm and several head and body lacerations. Both of these men were riding in the same automobile.

The occupant of the other automobile has not as yet been located so it is not known whether or not he was injured. Railroad authorities report that a man was seen running away from the damaged automobile. It is not believed he was greatly injured if hurt at all. The auto in which the two men were riding was struck at the Main Street crossing by a freight train.

Harris Files Suit For \$7,500,000

New York, April 23.—(AP)—Suit for \$7,500,000 was filed in the Supreme Court today by Zack M. Harris, theatre owner, against the Cinema Corporation and its subsidiary, Producers Distributing Corporation. The sum is a ten per cent commission for arranging the “tie up” between the Cinema Corporation of America and the Keith-Albee and Orpheum Circuits, where, by the vaudeville chain will exhibit the Cinema Corporation films for the next 15 years.

The Producers Distributing Corporation is the producing and distributing end of Cecil B. De Mille's company.

Deported Priests Arrive in Texas

Laredo, Texas, April 23.—(AP)—Archbishop Mora Del Rio of Mexico City, Archbishop Leopold Ruiz of Morelia, Michoacan, Bishops Francisco Ortega of Cuernavaca, and Bishop Jesus Maria Eucharria of Saltillo, deported from Mexico City on orders of President Calles, arrived in Laredo this morning from Mexico City.

Although they were notified Thursday by the government to leave the country in three hours, six Mexican secret service men arrived at the Episcopate Home within two hours and hustled the prelates into a carriage, said Archbishop Del Rio.

He was put on a train with other members of the Episcopate without time to assemble personal belongings, he asserted. Leaving Thursday night under guard, they were delivered at the border and told “to get out of Mexico and stay out,” they said.

Archbishop Del Rio is a man of about 80 years old and the long trip apparently had tired him. The party was met by United States Consul Harry M. Walsh at Menlo Laredo and escorted to the American side.

Warehouse Suit is Compromised

Winston Salem, April 23.—(AP)—The suit of the Independent Planters Tobacco Warehouse Company against J. G. Flynt, in which the plaintiff was asking for recovery of close to \$70,000 alleged to have been taken by the defendant from the proceeds of the business of the plaintiff during the seven years he was the manager and president of the concern, has been settled by a compromise, the consent judgment having been signed by Judge Oscar O. Efrid of the Forsyth county court.

The consent judgment declares there was no criminal intent on the part of the defendant; that the

books of the company disclose the true transactions between him and the corporation; these being found all matters between the plaintiff and the defendant have been settled.

The directors authorized N. L. Cranford, who was elected president in the place of Mr. Flynt, at the time of the starting of the suit, to settle by deducting from the total the sum of \$1,693.55, this being the loss incurred by Mr. Flynt in purchasing tobacco on the floor of the warehouse.

For the balance due by Mr. Flynt the directors were to accept the 403 shares of stock held by him and his family at par; also to accept tobacco purchased by Mr. Flynt and credit it to his account, this being \$21,089.50; the balance due was to be accepted either in cash or a note at reasonable times.

TO OPERATE BUS LINES FOR NEGROES

Raleigh, April 23.—(AP)—Francis H. Hight to operate bus lines for negro passengers in North Carolina was issued today by the Corporation Commission to Al Kramer and H. G. Bales, both of Raleigh. Lines will be put into operation within the next sixty days, the operators said, from Greensboro to Charlotte via Gastonia to the South Carolina line; Winston-Salem via Mocksville to Statesville; Greensboro via High Point; Salisbury and Mocksville to Winston-Salem; Winston-Salem, via Greensboro; Raleigh and Goldsboro, to Wilmington.

LIGHT RATES IN VIRGINIA HIGHER THAN CAROLINA

Raleigh, April 23.—(AP)—Despite the fact that electric light rates in Virginia will be generally reduced on May 1, the rate in the Old Dominion state is still higher than the rate in North Carolina, R. O. Self, chief clerk of the Corporation Commission, said yesterday.

The Virginia rate per 100 kilowatt hours will be reduced from \$10 to \$8.50. The present rate in North Carolina, with no change in the rates contemplated, is \$7.32 per 100 kilowatt hours.
