MIGHTY FLOOD WATERS DEVELOPING DESPERATE SITUATION IN VALLEY

Two Score of Towns Under Water Within Radius 100 Miles; Guardsmen Called Out.

Memphis, Tenn., April 27.—(AP)—While Louisiana authorities were preparing for the unprecedented extent of deliberately cutting the dykes to save New Orleans from the mighty flood tide sweeping down the Mississippi, situations little short of desperate were presented today in Southeastern Arkansas and the Mississippi delta section.

Two score of towns within a radius of less than 100 miles in the two States were under water with the plight of thousands of refugees described in official reports to Red Cross headquarters here as serious in the extreme.

With the raging waters battering at their homes or the levees and knolls upon which they had sought refuge, those in the devastated area were sending out piteous calls for boats, clothing, food and other supplies. Directors of Red Cross relief moved as speedily as possible to render aid.

Almost hourly new groups of refugees are being found by relief workers as they move by steamer, motor boat or plane over the desolate regions. One such group was found last night on the Mississippi North of Helena. They had been without adequate food for days and had little shelter on the levee perch. An intrepid little woman, Nell Williams, a Red Cross worker from St. Louis, was the first to carry succor to them, braving the raging flood crest in a tiny motor boat alone at night that some measure of relief might be afforded the women and children at least.

While no new reports of breakers in the levees on either the Mississippi or the Arkansas Rivers were reported overnight the flood waters already released by yawning crevasses were rushing over lowlands and through valleys to lay waste new areas and drive more thousands from their homes.

The flood roaring through the stops landing break in the Mississippi above Greenville was slowly forcing waters in the delta region, and today Belzoni, Miss., sixty miles southeast of Greenville and almost 80 miles from the St. Louis Landing Crevasse, was being inundated.

Isola, Louise and Midnight, nearby towns, were reported under from 7 to 10 feet of water. Some residents were reported on roofs and in trees.

Across the surging Mississippi in Arkansas, Arkansas City was being flooded deeper and deeper with approximately fifteen hundred of its inhabitants still stranded on the levee. Nearly a dozen nearby towns also were flooded.

Far reaching steps to save the lives of hundreds and to get the homeless to safety points were taken by Henry M. Baker, director of the Red Cross relief. Because of the terrible conditions in Southern Arkansas, he ordered 16 coast guard motor craft from Vicksburg to Arkansas City and they breached the tide of the Mississippi all night so urgent was the call.

Additional seaplanes for reconnoitering and one hundred motor launches from the coast guard have been called for by the director so that all of the stranded may be removed from levees and promontories by the time flood waters begin to recede and leaves these refugees behind an impassable sea of mud.

New Orleans, April 26.—(AP)—The tramp of National Guardsmen echoed along levees today as two Southern Louisiana Parishes were evacuated preparatory to surrendering them to the Mississippi River that the South's largest city might be saved from the onslaught of the flood.

Vigorous protests on the part of citizens of the two parishes, St. Bernard and Plaquemine, which either have witnessed the withering fire of guns in the perennial trapper's warfare, gave way to a determination to insist upon adequate reparations. The residents continued to patrol the levees while the territory was being evacuated.

The entire Louisiana National Guard has been called into service and many miles of levees above and to the vicinity of New Orleans are patrolled by armed soldiers, while workers continue their steady battle against the rising tide. Although all remarks today are reported in satisfactory condition, there is faint hope of holding an unbroken chain (Continued on page six)

H. GREY SAYS MRS. SNYDER HOUSED HIM

Principal in New York Murder Trial Tells Of Illicit Love Affair.

New York, April 27.—(AP)—Henry Gray agreed to kill Albert Snyder because Mrs. Snyder "Hounded him and got me in a whirl with her love making," he asserted in his confession read in court today.

The confession related how Gray met Mrs. Snyder, and stated that she told him of half a dozen attempts she had made on her husband's life.

He told her he thought she was "terrible," the confession continued. "But she played me pretty hard," and finally he agreed to help her.

He got the wire, chloroform and sash weight at her orders, he said, but never really thought he would go through with the scheme until he found himself actually striking the sleeping husband.

Gray's confession said he was in a daze throughout and his description of himself was that of a man in a hypnotic trance, unable to withstand the commands of the hypnotist.

He asserted that Mrs. Snyder directed him in his every action and when the husband seized him under the first blow she took the sash weight and beat the already stunned man unconscious.

The confession then told of burning a bloody shirt to turning the house topsy turvy to stimulate a burglar, and of his returning to Syracuse after binding Mrs. Snyder.

Gray said he had decided not to go through with their plans, and was leaving when the Snyders returned from a party, and he had to run back to the unoccupied bedroom where he was hiding.

Once Mrs. Snyder came to him and said her husband was asleep and "The time has come," he said he was powerless to disobey her.

The confession then related how he had established an alibi by getting Haddon Gray, a Syracuse friend, to occupy his hotel room while he was away. He exonerated Haddon Gray, who is not related to him, of any knowledge of the real purpose for which the alibi was intended.

Gray said in his confession that Mrs. Snyder not only took the sash weight and beat her husband but it was also she who administered the chloroform.

In Mrs. Snyder's confession, read to the jury yesterday, it was asserted that all blows were struck by Gray and that he soaked the pillows with chloroform and pushed Snyder's face into it.

There Is No Such Issue.
Mr. Kerensky Is Mistaken.
One Citizen Is Better.
For Railroad Men.

"Coolidge must face the issue of a third term at an early date. He will be asked to state his views on that question as Governor Smith did concerning Catholicism."

You read that from Washington but it is not accurate.

There is no reason why Governor Smith should have answered more or less pertinent questions about his religion unless he chose to do so. He answered ably.

A sufficient answer would have been "My religion is none of anybody's business. If you doubt that, read the Constitution of the United States."

As for Mr. Coolidge, "Facing the issue of a third term," there is no such issue.

George Washington was elected President once, twice, and could have allowed himself to be nominated a third term and a fourth term, but he felt that such a program might lead to restoring monarchy which he had recently eliminated.

Other Presidents have been satisfied with two elective terms as President. It seems to be a good idea although there is no law about it. Mr. Coolidge thus far has been nominated and elected President once. He can, if he chooses, be nominated and very probably elected a second time.

Every American with a quarter of an ounce of brains knows that such a man as Coolidge would, under no circumstances, think of accepting a third term. And everybody who knows him understands that he will not be bothered or "bluffed" by a third term talk until after his second election.

It is at the election that the President shows and uses his power and it was THREE ELECTIONS that Washington had in mind. An accidental part of a term with no election, is not a Presidential term.

The other day Kerensky, now traveling in America, who had "for a short time the pleasure of living in the Czar's palace, is here to denounce Bolshevism and said that it was worse than Czarism."

He may change his mind, now that an admirer of the Czar has slapped his face at a public banquet.

Whatever else it may be, Bolshevism is an improvement on Czarism, for the reason that it teaches the people of Russia to read and write, public monies to feed half starved children.

The Czar allowed his people to remain ignorant, the public money was spent by more or less drunken Grand Dukes and other Romanoff parasites.

Bolshevism will not last because it is based on Communism, a doctrine that calls for universal unhappiness.

President Calles Believes Road Has Been Opened for Settlement With America

Mexico City, April 27.—(AP)—President Calles believes that the road has now been opened for a satisfactory settlement of all difficulties between Mexico and the United States.

He emphasized this in commenting on President Coolidge's New York speech and said that at the bottom of all the difficulties "there is nothing more than a misunderstanding or divergence of judgment in appreciating a matter of legal order, which really had not affected the legitimate interests nor fortunately injured the sentiment of the nation, nor brought any injury to our decorum."

The Mexican chief executive has no desire that the Mexican-American controversy shall be settled by arbitration, saying: "It appears to us perfectly satisfactory that such settlement should be obtained by means of negotiations."

"I think, as President Coolidge does," he said, "that there is a great desire to maintain cordial relations. It is not only possible but easy to reach an amicable settlement, and using Mr. Coolidge's own words, as carried by the newspapers, I believe that if the two countries should comfort themselves in such a way that their friendly relations are not impaired."

Asked his opinion relative to the President's mention of the origin of the difficulties with Mexico, President Calles declared:

"I believe he spoke of claims which over a long series of years were referred to as damages, either as regards American lives or property, which due principally to revolutionary acts, have been, and will be judged by general and special claims commissions, which are functioning."

According to the newspaper version of President Coolidge's speech, he traces the origin of the intensification of the difficulties to promulgation by the Mexican government of laws which Washington considered practically menacing confiscation of American properties. Fortunately, due to correct understanding and exact comprehension of our purposes and the scope of those laws, President Coolidge in his speech showed a thorough understanding, that Mexico never proposed, and never will propose to confiscate foreign property. As I clearly expressed it at every opportunity, the policy and its expression by means of laws have never had either the spirit nor intention of confiscating."

"There may have been, there may continue to be, divergences or interpretations of a technical nature in studying those laws, not so much as regards practical results which the laws may produce, but as the ideal conception which has given them life. But application of those laws translated into facts has not resulted, nor do we intend that it shall result, in material injury to the principles involved."

"We think exactly as Mr. Coolidge does, that stripped of all technicalities and of legal discussion, the principal difference which our government has with that of the United States is the supposed threat of confiscation, and on this principal difference I think I have been absolutely clear."

"Regarding the expropriation of agricultural lands which has been made by the government, Mexico has never denied compensation naturally within the government's power, having regard to the economic situation. It is very satisfactory for me to note that Mr. Coolidge remembers that the American government agreed to accept bonds issued by the Mexican government in payment for damages admitted by the respective commissions in cases in which lands were taken for division."

Asked his opinion on the arbitration question, President Calles declared that Mexico at the present time had two commissions to arbitrate with the United States and in general principles Mexico always has been and would be a partisan of such remedy.

LANIER WINS PLAUDITS IN WAR RECORD

Valor of Mayor of Greenville Told in Story of the Seventh Division.

Pitt county people are familiar with the heroic deeds of hundreds of soldiers who participated in the great world war, but very few know anything of the brilliant service rendered by men of Greenville and Pitt County.

The history of the Seventh Division, which has just been issued, gives a detailed account of the activities of that unit from the time it landed in France until the end of the great conflict. Contained in this thrilling narrative of war and bloodshed, is an account of the part which J. Con Lanier, Mayor of Greenville, played in winning an objective in the Rembertcourt sector.

Mayor Lanier was a lieutenant of Company E, 34 Infantry, and was in charge of the third platoon. "Without food or water for 30 hours," the narrative says, "the troops held the position, the taking of which had been largely due to Lieutenant Lanier's reckless disregard of personal safety and the skillful manner with which he pushed the assault."

The story in detail follows: "Company E, 34th Infantry, led the attack on Hill 310. This company under Lieutenant Porter, worked its way under cover of the early morning mist to a draw situated in the enemy front lines between the objective and another part of the ridge. While Lieutenant Crown with his scouts made a demonstration in the valley in front of the ridge, the assaulting (31) platoon, led by Lieutenant Lanier, gained the nose of the ridge, and the 2nd platoon under Sergeant Sanders was brought into position on its left. The two platoons swept down the ridge to the east, closely followed by the 1st and 4th platoons under Lieutenant Humphries to prevent a rally of the enemy behind Lieutenant Lanier's troops."

The health official issued a statement giving his position in the case and called upon the Attorney General, Dr. John B. Wright and Senator Rivers Johnson, Duplin, two principal in the graft charges.

NAVAL COURT ENDS PROBE PLANE WRECK

Record of Inquiry Into Death of Noel Davis and Pilot to be Made Public Soon.

Washington, April 27.—(AP)—A Naval Court of Inquiry has completed investigation into the death of Lieutenant Commander Noel Davis and Lieutenant Stanton Wooster, who crashed at Newport News, Va., recently, while testing their huge biplane for a trans-Atlantic flight and has forwarded its report to Washington.

The records of the investigation will go through the regular channels until it reaches Secretary Wilbur. It will not be made public until the secretary acts upon it.

Coinciding with the arrival of the report, Edwin Wideman, a Washington business man, made public what is believed to be the last letter written by Davis and in which he disclosed that Mrs. Davis would personally supervise the preparation of the food needed for the flight. She planned to prepare four dozen sandwiches, roast beef, chicken and ham for her husband and his companion as well as stuffing into the larger hard-boiled eggs, pork and beans, chocolate bars, coffee in thermos bottles and a dozen packages of chewing gum.

For an emergency Mrs. Davis planned to add thirty six two ounce packages of sliced beef, a quantity of hard tack and water.

These preparations, cut short by death, would have been Mrs. Davis second function in sending her husband in quest of the \$25,000 Orteig prize for which he was competing in the proposed first non-stop flight between New York and Paris, recently she christened his plane "The American Legion."

This ship, which was to reflect itself in the broad expanse of the Atlantic, came to its end in a Marshy strip of water not more than 100 feet long and five feet deep, known as the "Duck Pond". A few yards away a lone fisherman W. J. Forist sat in his boat. He heard a splash and a crash but rushing to the pond found he was helpless singlehanded.

"I was the first one there," he said, "but there was nothing that a man could do. I called for help and signalled to Langley Field and waited until a party came over in a boat."

It was an hour later before the relief crew could reach the fliers. Both were dead.

Mrs. Davis and Miss Sallie Finney, who was to have married Lieutenant Wooster just before the flight began, left Langley Field last night for Washington. Later Mrs. Davis will go to Pensacola, Fla., where her husband will be buried. Wooster will be buried in Washington.

Temperatures Add To Flood Danger

Kellogg, Idaho, April 27.—(AP)—The worst floods in the history of this district were forecast today as high temperatures rapidly melted an unusually heavy snow blanket to swell mountain streams. Large crews have been employed in an attempt to save highways and railroad tracks.

ARMY TENTS FOR FLOOD SUFFERERS

Boston, April 27.—(AP)—Fifteen hundred tents, enough to shelter 12,000 refugees, were withdrawn from the quartermaster's stores of the first corps area here during the night and started for St. Louis for distribution through the devastated Mississippi Valley.

Amos Jackson Charged With Misappropriating \$21,352.18 of County Funds.

Hearing of the case against Amos C. Jackson, former sheriff of Pitt county, charged with embezzling \$21,352.18 from county funds during his administration as sheriff, was begun in the criminal term of Pitt county Superior court yesterday afternoon at two o'clock, and continued until ten o'clock last night. The first day's session consisted of the selection of a jury and examination of a number of State's witnesses.

The jury was chosen after a special venire of fifty men and a part of the regular jury had been exhausted. The majority of jurors are farmers, and well advanced in age. They are:

Jackson mysteriously disappeared from Greenville last summer while an audit of county records was in progress. Following discovery of the alleged shortage in funds of the sheriff's department, and failure of the sheriff to return, the office was declared vacant.

An extensive investigation of records and affairs of the sheriff's office was conducted by representatives of the bonding company with which Jackson was bonded. This resulted in the protection of the county from any loss, by the bonding company making good the amount involved in the embezzling charge.

The original bill of indictment, acted upon by the grand jury in the January term of Pitt county Superior court, contained 24 separate and distinct counts. Each count embraced some particular fund which the sheriff was supposed to have collected, and which it is alleged, had not been turned into the county treasury.

The State, through Solicitor D. M. Clark, assisted by former Superior court Judge Albion Dunn, began linking together a long chain of evidence at last night's session. A number of witnesses were introduced to show for what purpose a considerable portion of the alleged misappropriated sum of \$21,352.18 had been employed by the former sheriff.

Colonel Dunn presented a number of county records to which the sheriff had access, and called upon members of the various county departments to identify them, and to designate for what purpose they had been used.

The first witness, C. C. Coppeden, county auditor, presented records and reports turned into his office during the administration of the deceased sheriff.

J. F. Harrington, clerk of Superior court, was asked to identify certain records of Drainage District No. 2, but this was deferred until later on account of vigorous objection by attorneys for the defense, who contended that it was not a part of the original bill of indictment. Judge Wooten was also asked to the stand in this connection.

YEARS PROVE NO HANDICAP FOR TY COBB

They are cheering Tyrus Cobb today for a feat as remarkable as he ever achieved in 22 years of Major league baseball.

At 41 when it seemed he must tire under the weight of years, he called forth his youthful fire and speed to win a game almost singlehandedly. He scooped in a fly at full stride for an unassisted double. He cracked out three hits. He scored twice. He was all over the field as the Athletics formed into the first division by beating the Red Sox 9 to 5.

With his team trailing 7 to 1, the Georgia Peach opened up with the kind of baseball he played in the World Series of 1903 and led a headlong attack while Connie Mack who paid \$45,000 this year for Cobb sat on the bench and sent in reinforcements. Twenty players all told took the field for Philadelphia, but Cobb served nine full innings and finished fresh.

When Cobb's team rose a peg in the league the Detroit Club with which he played all his 2,804 games before this season settled into the second division by losing to the White Sox, 9 to 3. New York and Washington, which head the league in that order, did not play and the St. Louis Browns, who are third, dropped a game to the Indians, so the advance of the Athletics was a long step toward the top.

After one brief day at the head of the National League the St. Louis Cardinals lost their first game in seven starts to the Pirates who went into a tie for first place with New York. Respected Lee Meadows downed the World Champions for his fourth straight victory 9 to 5 while the slow ball artist Sherdel was battered off the Cardinal mound in his third.

Bill Terry's homer, double and sacrifice helped the Giants to their 2 to 2 victory over the lowly Robins, who could not connect with the slants of Fred Fitzsimmons.

Like the Athletics, the Reds turned defeat into victory as they put on their chubbing clothes in the sixth and hammered out six runs for an 8 to 5 triumph, the heavy hitting Webb knocked a homer for the Cubs in the ninth as a pinch hitter but no one was on and it was not enough to win.

HARD HITTING WINS GAMES IN PIEDMONT

Raleigh, April 27.—(AP)—A State College star's home run at Winston-Salem, Rocky Mount's heavy hitting and High Point's slugging decided contests in the Piedmont circuit yesterday as Winston-Salem, Rocky Mount and High Point won at the expense of Raleigh, Durham and Salisbury.

Raleigh, after losing two to Winston-Salem, went to Salisbury today for a series with the Colonials. Durham visited Rocky Mount for a return engagement and the Twins moved to High Point.

Croaker Wade's ruthian was a feature of the Winston-Salem-Raleigh tilt yesterday, ending 11-4 for the Twins. The weird contest at Durham ended in favor of Rocky Mount, 11-10, as five pitchers proved ineffective in the contest. SPORTS SLANTS

If Jesse Joseph Haines, of Philadelphia, Ohio, has not set a record for early season pitching effectiveness so far he has at least come within hailing distance of it.

The rambunctious twirler of the St. Louis Cardinals has won all three of his starts, each against a different team, and permitted the meagre production of ten hits and a single run off his delivery in 27 innings.

In his first game, April 13, he blanked the Chicago Cubs with two hits, 5 to 0. Six days later he held Cincinnati to five hits, one a triple while his mates clubbed out a 9-1 decision. He came back Monday with another artistic touch, holding the slugging Pirates to three hits and winning a spectacular 1-0 duel with Ray Kremer, himself previously undefeated in three starts.

In these three skirmishes, Haines issued five bases on balls and struck out eleven.

Perhaps it was the heroic role he played in the 1926 world's series that inspired him to a new lease in pitching life. In seven years with the Cardinals he has seldom shown anything like consistent brilliancy of this spring.

He won two games against the Yankees in last fall's classic. The first was a spectacular 4-0 shutout in which he clinched the decision personally with a home run. He also was credited officially with the final victory although Grover Cleveland Alexander saved the day by relieving Haines and fanning Lazzari with the bases full.

Lake Kremer, Vance and others, Haines seems to be striking his stride late in life. He will be 34 in July. Only two other Cardinals, Alexander and Frank Snyder, are older.

Haines' sensational pitching in the opinion of John A. Heydler, president of the National League, is only one symptom of a remarkable exhibition of early season twirling.

"It has been a record-breaking start in many respects, attendance upsets and startling performances," said the league chief, "but the pitching has been especially impressive. Look the list over. Bob Smith pitched a two hit game for the Braves, matching Haines' performance. Carlson and Pruett of the Phillies, Alexander and Sherdel of the Cardinals, Meadows and Kremer of the Pirates, all have done exceptionally well. These are just a few of the National League stars. There has been some great pitching in the American League, too."

The lot of the major league umpires may be easier now than it was when the players were more truculent, but it still is far from a bed of roses, president Heydler avers.

"For instance," he said, "there was the incident that led to the suspension of Stuffy McInnis of the Phillies a few days ago. Roush of the Giants, hit a sharp grounder along the base line that struck foul territory after hopping the bag. Two umpires agreed it had out over a corner of the base and therefore was fair. McInnis led a parade of protest and was banished. It happened that this play decided the game. It was a close decision unquestionably called fairly, but it illustrates one difficulty of the arbiter's job."

"Umpiring these days has become a science just as has the playing of any position on the team. There is less bailing of the arbiter than there used to be. This is because the umpires themselves have become more proficient and also because the players themselves, recognizing this, realize there is nothing to be gained by jazzing or too much kicking."

Norfolk nosed out Portsmouth, 6-7, when Mundy's single in the eighth inning with the bases loaded helped the Tars win after four consecutive losses.

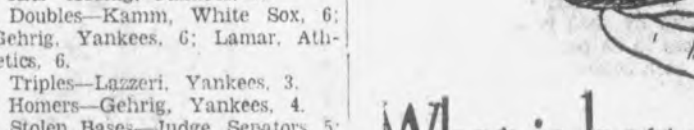

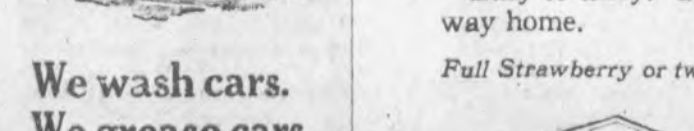

SEES END OF OIL AND LAND CONTROVERSY

Coolidge's Conviction That Amicable Settlement at Hand Through Encouraging.

Washington, April 26.—(AP)—President Coolidge's conviction that the oil and land controversy with Mexico is capable of amicable adjustment was regarded at the capital today as encouraging.

The statement by Mr. Coolidge at the dinner of the United Press Association last night that he had received assurances from the Mexican Ambassador that Mexico does not propose the confiscation of the American property proved gratifying. The added assertion, however, that the Washington government feels that Mexico "is threatening" to disregard the principle that private property must not be taken without fair compensation prompted discussion.

Although the President devoted a major portion of his address to Mexican relations, he outlined, in addition a general foreign policy in keeping with the new world position which he pictured for the United States.

The chief obstacle in the exchanges with the republic to the South as President Coolidge presented it, is that Mexico seems insistent on enforcing laws which the Washington government believes threatens American property. This trouble can be handled best through diplomatic channels, the President declared, and not by

arbitration as proposed by the Senate, because "very likely Mexico would feel that the right to make a constitution and pass laws is a privilege of her sovereignty which she could not permit to be brought into question."

The President's address was the first official expression since an impasse between the two nations was considered to have been reached. He disclosed that Ambassador Tellez, after a hurried trip to Mexico City, had called at the White House and informed him that Mexico does not intend to confiscate American property and that she has shown diligence in capturing and punishing those who murdered American citizens as well as expressing the wish for cordial relations.

Mr. Coolidge disclaimed any program of his government of imperialism and declared it to be a "curious circumstance" that those who advocated this government taking mandates over far-off countries in Asia were "most critical when we are attempting to encourage the maintenance of order, the continuity of duly established government and the protection of lives and property of our citizens under a general reign of law in these countries that are near at hand and where we have large and peculiar interests."

As for China, the President declared, the United States forces are there, he said, to protect Americans. In time order will emerge from the present chaos, he added.

In Central America, Mr. Coolidge declared, the United States feels a moral responsibility that does not attach to other nations. Revolutions will be discouraged and for that reason this government has taken a hand in Nicaragua, the President said.

"We are not making war on Nicaragua any more than a policeman on the street is making war on passersby," he declared.

Gossip of Staff Correspondents at World Centers of Population

Des Moines, Iowa, April 27.—School teachers of this state are beginning to wonder just where their duty to the classroom ends and where the question of personal liberty begins, following recent rulings by school board in two towns.

At Paton the board passed a rule under which teachers of the consolidated school are required to spend at least two Sundays of each month in town and attend at least one church service on that day. Most of the teachers live in nearby towns and usually go home over the weekend. The directors however believe the sight of their instructors going to church will have a good moral effect. No provision for checking up on the pedagogy was made by the directors and it is not known if the lay is being observed.

In another small town the directors clamped down on teachers attending dances or playing cards. Both, it was stated, were not proper pastimes for teachers.

A third case that has attracted considerable attention over the state is that of Miss Florence Cochran, 19-year-old New Virgin teacher. She was discharged by the school board when charges were made that she had stolen small pupils with ruse stories. She denied the charge and appealed to the county superintendent, who exonerated her. The school board, however, has taken the matter to state superintendent of schools. Miss Cochran says her refusal to keep company with the board's president is the real reason behind her discharge.

Iowa's dirt roads subject of bitter and frequent criticism, are in worse condition this spring than in years. Many communities are entirely cut off from the outside so far as motor car traffic is concerned. Schools in some rural sections have been closed up pending improvement of the roads. Even the graveled highways have been hard hit. In many places on the "bottom" has dropped out" leaving great holes and depressions.

Improvement in highways is slow, however, in recent changes made in the highway law. Under the new law, all primary roads and roads funds are under the supervision of five-man highway commission, while county supervisors formerly controlled primary highway work.

As regards 99 Russians out of 100, the present Russian government is as far above that of the Czars, as the government of Washington and Jefferson was above that of King George, the foolish.

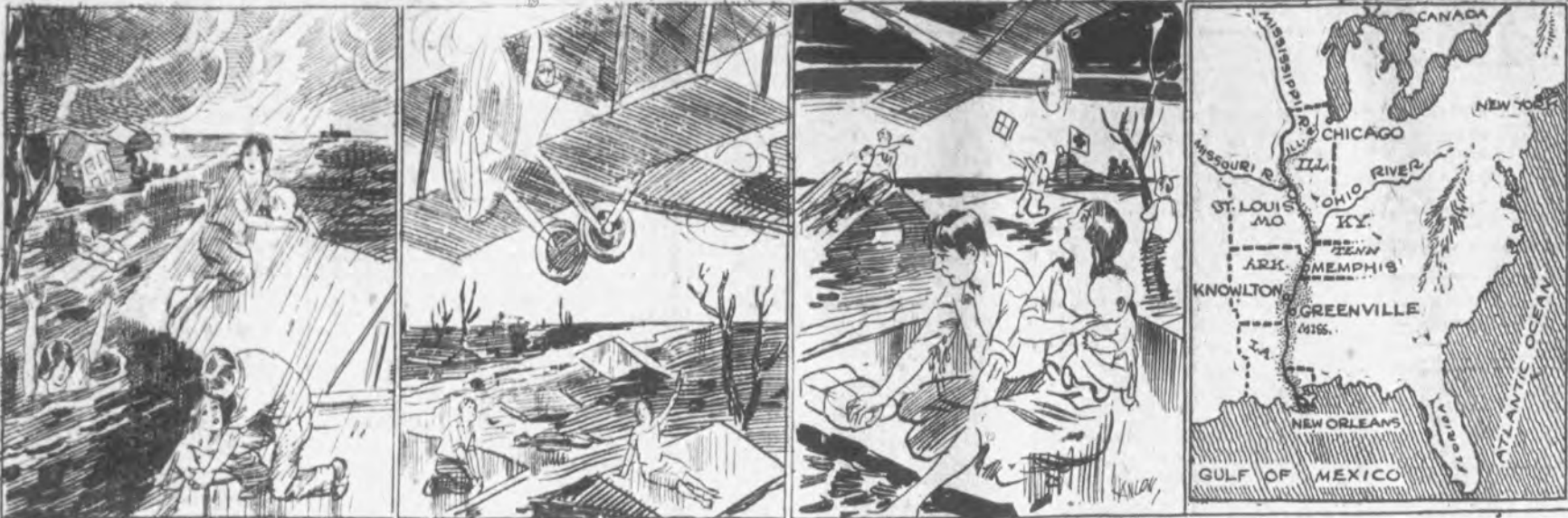
Railroad men, doing their best to help stockholders as they are bound to do, have concentrated on getting increased passenger fares and freight rates from the public authorities and that has seemed good business. The time is not far off when good business will consist in finding a way to carry passengers and freight for LRS and thus making more money.

For instance, the train on which this is written, bound east from the Pacific, traveling just now 7,000 feet up in the air, over the border from Arizona to New Mexico, on the Atchison, Topeka and Santa Fe, is as well managed and as good a type of American railroad as there is anywhere. It is profitable, its stock higher than it ever was.

The danger to the railroads is a small, ridiculous looking thing on four wheels running along the highway, paralleling the highway on a "right of way" that costs the motor omnibus and motor truck nothing, but the price of their license. Every day, four motor buses leave Los Angeles carrying passengers to Chicago. That doesn't amount to much. But they can carry twice as many passengers as there are on this magnificent Santa Fe "Chief" express. And the bus over head is one man driving and another to relieve him.

Omnibus travel is uncomfortable and will never compete with the express train. But what about

FLIERS CONQUER TIDES TO SAVE HUNDREDS FROM RAGING FLOODS



OVERFLOWING ITS BANKS and tearing down levees in its irresistible sweep to the Gulf of Mexico, the Mississippi River has made thousands of persons homeless and has brought death to more than 100. Towns have been suddenly flooded and their inhabitants swept away or forced to upper stories and roofs. In some places terror-stricken multitudes are marooned on tree tops. Apparently it is their doom to die of hunger or of exposure or of drowning when the waters reach them.

BUT HUNDREDS OF these refugees have been saved through the daring of a handful of aviators, many of whom served in France. Hourly they take their lives in their hands to fly over the stricken areas locating persons in distress. The locations are reported to relief stations and steps are taken for rescue. The aviators have dropped food and medical supplies and mail in many isolated places, preventing starvation, spread of disease and the panic which follows no word from the outside world.

The ablest managers of this country are men at the head of railroads.

The time is coming when they will have to make their money by serving the public more cheaply. Increasing volume, instead of arranging to get by Interstate Commerce Commission and otherwise, whatever may be required to pay what transportation costs. Old fashioned ways must change.

The cheapest thing is the most profitable thing. Look at the price of Woolworth stock. Ask Henry Ford how he got his money. Ask Mr. Sloan or Mr. DuPont of General Motors, if it is not Chevrolet, their small car, that represents their greatest asset.

Jay Gould built the elevated railroad in New York and charged a ten cent fare. The road never did earn any money, until the fare was dropped to five cents, against the will of the owners.

Before the movement was completed Lieutenant Lanier advanced to a strong point 311 with the 2nd and 3rd platoons, and here repulsed a counter attack. At 6:00 that evening three platoons of Company D relieved three platoons of Company E and the next morning two platoons from Company G relieved the platoons of Company F on the advanced position.

"On the morning of November 2nd

another and more determined German counter attack was made. Lieutenant Porter, in command of the assaulted sector, succeeded in repulsing this attack, and his heroism on this occasion won for him the Distinguished Service Cross. Meanwhile officers of the two parishes were warning inhabitants to flee after the issuance of a proclamation by Governor Simpson setting noon, Friday, as the time for the crevasse to be cut at Poydras, near the scene of a break in 1922.

Approximately four thousand persons must be moved out of the area before the crevasse is made. Hundreds of persons formed the

seemingly endless caravan which streamed out of the doomed area. Battered automobiles, trucks and wagons and even push carts trundled through the gravel toward New Orleans, where they will be cared for until the waters recede. All movable belongings were included.

Many of the refugees were persons who had been driven from their homes in the Poydras area by the 1922 break. But in the previous flood they had but the briefest notice and in many cases were forced to abandon their belongings.

The waters from the Poydras break will inundate about 70,000 acres, engineers estimate. No towns of any size are likely to be touched although the village of St. Bernard is perilously close to the path the water is expected to take.

Truck farmers and trappers are the main inhabitants.

FOUR MINE WORKERS KILLED BY EXPLOSION

Wilkesbarre, Pa., April 27.—(AP)—Four mine workers were killed today in a gas explosion in number two shaft of the Truesdale Colliery of the Glen Alden Coal Company in Hanover township near Nanticoke. The cause of the explosion if known was not announced by the company.

PLUMBERS STRIKE NEW YORK TODAY

New Orleans, April 27.—(AP)—Threatening an eventual tie-up of 700,000 workers and a halting of New York City's \$1,000,000,000 building program, 10,000 plumbers and their helpers were ordered to go on strike at the close of the working day to day it was announced by C. G. Norman, head of the building trades employees association.

BEVERIDGE DIED TODAY

Former United States Senator Passes Away at Home in Indianapolis, Ind.

Indianapolis, Ind., April 27.—(AP)—Albert J. Beveridge, former U. S. Senator from Indiana, died suddenly here today.

Mr. Beveridge was twice elected to the senate from Indiana. He was retired from the senate in 1911 and twice sought to return but was defeated in 1914 as the Progressive Party Candidate and in 1922 was defeated by Samuel M. Ralston, Democrat.

Death came this morning at his home here. He had been working here for some time upon his latest book, the life of Abraham Lincoln. Mr. Beveridge's work on the life of Lincoln was only half completed.

The former senator's health had not been the best for several months but his condition was not regarded as serious. His death occurred at 6:45 o'clock this morning. It came as a shock to close associates, who said there was no intimation yesterday that his condition was in any way critical.

TWO NEGROES ESCAPE FROM STATE PRISON

Raleigh, April 27.—(AP)—Superintendent Poul at state prison today

reported that two negroes escaped last night from the Liberty Hall work farm near Greensboro.

Frank Johnson, Wilson county serving 9 to 12 months for larceny whose time would have expired in July, and Cloe Castello, Edgecombe county, serving three to six years for assault with a deadly weapon, who would have been discharged in June, escaped.
