DEATH LIST INCREASING IN MISSOURI

More Bodies Yielded
By Debris in Missouri
Arkansas; Others
Die in Hospitals.

Kansas City, May 11.—(AP)—Prospects of a steadily increasing death list in the huge checkerboard scopped out of the middle west by a series of tornadoes and storms in which at least 236 persons perished and more than 900 were injured, today added to the trials of relief workers.

While casualty lists in Texas, Illinois, Kansas and Louisiana showed little change, debris of razed communities in Missouri and Arkansas yielded more bodies last night and several injured died in hospitals.

Physicians reported that more than a score of injured in Missouri and Arkansas had little chance to live. This coupled with failure to establish communication with several villages since the tornadoes struck Monday, caused relief agencies to estimate the dead would total approximately 250.

Relief was placed on an emergency basis at Poplar Bluff, Mo., where 80 of the 96 killed in Missouri met death as few restaurants remained that was necessary to supply food as well as to solve hospital and salvage problems.

Similar conditions prevailed in northeastern Arkansas where residents of several isolated villages were reported destitute.

Weather observers found little to connect the series of freak storms that started in Kansas Saturday, swooped down on northern Texas early Monday morning and then skipped through Arkansas to Missouri and finally appeared in Illinois.

Indications of the violence of the storm was found in Arkansas where small twisters branched off from the central disturbance to flatten farm buildings and isolate many communities.

Casualties in Wyoming were limited thus far to three persons frozen to death in a blizzard that sent cool winds over the tornado area to aid in settling atmospheric conditions. Three negroes were the only persons known to have been killed in high winds in Louisiana.

Make Non-Stop Flight From San Diego to St. Louis

St. Louis, May 11.—(AP)—Captain Charles A. Lindbergh, former air mail pilot, who is planning a New York to Paris flight, arrived in St. Louis at 8 o'clock today, after a non-stop flight from San Diego which began yesterday afternoon. Lindbergh flew direct to the Lambert-St. Louis flying field near here, ascended to within 100 feet of the ground rose again and flew over the business district.

The first 1,550 mile leg of his journey to New York, whence he will "take off" in a week or ten days, on the trans-Atlantic flight on a course similar to that planned for the Coli-Nungesser flight was completed in three hours less than Lindbergh had planned before leaving Rockwell field.

Seek To Control Oil Production

Washington, May 11.—(AP)—Some of the leading oil producers have applied to the federal government for help in restricting oil production and the federal oil board has replied that the government is ready to assist in any proper manner.

The appeal which embodies a restriction plan to guard against overproduction, was addressed to Secretary Work, chairman of the board and was signed by Walter D. Towle, president of the Standard Oil Company of New Jersey and W. W. Farish, former president of the American Petroleum Institute.

It declared that overproduction had "recurred this year in a form so malignant so as to seem to be without precedent." A co-operative method of control, worked out through joint purchase of certain producing lands was proposed as a solution.

We Excel in Smallpox.

As this is written New York City greatest congestion of human beings on the continent, is looking out to sea, hoping that a plane reported in the northeast will prove to be that of the brave French flyer, Nungesser.

Nungesser and his companion in courage, Francois Coll, driving their "White Bird" across the ocean, are men of courage, worthy of the French blood which they shed willingly in the war.

Captain Charles Nungesser is well described as a "patchwork of bone, flesh and metal," a production of army surgeons.

Wounded 17 times in the war, his body is fastened together in several places with metal joints. Both elbows are patched with platinum, a disc of platinum covers a hole on the top of his skull.

His right ankle is more than half platinum, and there are four platinum patches in his legs. In addition he carries various metallic patches inside his torso.

His fellow flyer, Captain Coll, wears a black patch over his right eye. A German machine gun bullet destroyed that eye during an air duel.

You may not even know the fate of these men when you read this. Successful or not, they are entitled to the immortality that high courage deserves. And there are thousands like them in France.

The United States has more smallpox than any country except Asia. There were 33,752 smallpox cases in this country in 1926. The reason is simple. We have more smallpox because we have more cheerful idiots opposing vaccination which prevents smallpox.

In Europe, where vaccination is intelligently enforced, ten nations had not one single case of smallpox in 1926. Eighteen nations had only 1,000 cases among them.

It is enlightening to read that smallpox is more frequent where opposition to vaccination is strongest. Southern California and North Carolina.

GREENVILLE MAN HONORED

Dr. John D. Humber
Considered One of
Ranking Physicians
Of Pacific Coast.

Dr. John D. Humber, son of Mr. and Mrs. R. L. Humber of this city, has been chosen by Dr. Coffey, head surgeon of the Southern Pacific General Hospital, San Francisco, to represent him and through him the hospital, at the national convention of the American Medical Association which meets at Washington City May 16th. The Southern Pacific Railroad is one of the largest systems with one of the largest hospitals in the United States with a large medical staff, and it is an unusual honor for one of the younger members of the staff to be chosen to represent the Head Surgeon who usually attends in person.

Doctors Coffey and Humber have recently returned to San Francisco from two extended trips in the former's private pullman, one to Yuma Arizona and the other to Los Angeles California, where they were invited to make addresses before the Arizona and California Medical Societies.

Another indication of the esteem in which Dr. Humber is held is evidenced by the fact that he was granted a year's leave of absence in order to complete special research work at Tulane University, New Orleans, his alma mater, where he was attached to the medical staff. After the completion of this work he was invited by Dr. Coffey to become co-author with him of a medical text book which has been recently completed and will soon be off the New Orleans press.

Recently the church of which Dr. Humber is a member, the oldest Protestant church in California, made him a trustee, and elected him Director of Religious Education for a term of three years, which is the highest position within the gift of the church next to that of pastor.

Honors such as these could have been attained only through unusual knowledge, skill and personal integrity.

At the close of the medical convention at Washington City Dr. Humber will visit his parents for a few days at Greenville.

CAR CRASHES THROUGH TAR RIVER BRIDGE

J. E. White Suffers
Minor Injuries in
Twenty Foot Drop
Through Bridge.

J. E. White, of Eighth Street, had a narrow escape from death last night about 11:30, when his automobile crashed through a temporary barrier on the west side of the highway end of Tar River bridge, and fell into the river, about 20 feet below.

The accident occurred at place where members of the highway commission were making improvements. Several feet of the flooring on the west side of the bridge had been removed, making it necessary to erect a barricade around that part of bridge where work was in progress. Mr. White, who was returning from a trip to Williamston, is said to have been blinded by lights from a car approaching the bridge from the other direction, and failed to see the barricade in time to avoid crashing into it.

The car landed on the ground about twenty feet below the bridge. It was considerably battered and flattened out by the force of the impact.

While suffering considerably from shock and lacerations of the face and body, Mr. White was able to be up and around the house today. He was carried home last night by members of the police department who appeared at the bridge a few moments after the accident occurred.

MANY STORIES OF HEROISM IN TORNADO AREA

Plans for Rebuilding
Poplar Bluff, Mo.
Considered by Business Men.

Poplar Bluff, Mo., May 11.—(AP)—Plans for rebuilding a "Greater Poplar Bluff" were launched today as a result of a meeting of the city's representative business men with Mayor John W. Berryman. The assertion of Governor Sam A. Baker, who hurried to the storm swept town, "that it would rise greater than before," sounded the keynote of the general feeling.

The death toll of Monday's tornado remained at eighty early today and Red Cross figures showed 350 injured, 100 seriously. Relief work was well organized.

Gangs of men continued cleaning up debris in the main business section, which bore the full shock of the tornado. Other men were digging graves.

With the confusion over, stories of heroism and personal courage are heard everywhere. The quick wit of Miss Minnie Smith, principal and teacher in the East Side School, saved all her flock from death and all but six from injury.

A few minutes before school was to be dismissed, the children thought the sudden darkness a good joke. Miss Smith said. When the twister struck she told them to crawl beneath their seats. Several rushed to her and she pushed them under her desk, as windows were shattered and crashes were heard from many directions.

"A little boy under my desk tugged at my skirt to call attention to the fact that his leg was broken," Miss Smith said, "and a little girl showed me that her arm was broken."

Another teacher, Miss Lulu Stone, thoughtful enough to remember the comparative safety of an inside wall, herded the children against it and not a one was hurt.

John Whitlow, operator for The Associated Press in the Republican Building, was hurled from his chair and pressed against the floor by a large plate glass window blown in by the tornado. He crawled under his instrument table, managed to flash the new to the St. Louis office and remained with his wire until it went out.

FIVE CASES HEARD HERE YESTERDAY

Ayden Colored Women
Hold Limelight as
Result of Fight Over
A Man.

Women of all nationalities have been fighting over men since time immemorial and the incident seems to be as strong today as ever. Because of this fact, Minnie Burney and Eva Simmons, colored, of Ayden, appeared before Judge Darden in County Court yesterday morning to answer to charges of assault with a deadly weapon.

The charge is said to have resulted from an argument over Eva's man, as she termed him. She told the court that Minnie Burney had been making an attempt to take her man away from her. She simply couldn't tolerate any such situation, so a knife was brought into play and a cutting frolic ensued. Injuries, however, were not serious.

Eva Simmons was found guilty. Judgment was suspended for a period of two years upon payment of cost and good behavior.

"Canny Grimes, colored, drew a six months' sentence to the county roads on a charge of trespass. Notice of appeal to Superior Court was filed under bond of \$300. Grimes, who is at present serving a three months term on the roads is also said to have been the home of a white man near Greenville for the purpose of burglary.

Goldman Mills, colored, was fined \$100 and cost on a charge of driving an automobile while drunk. He was ordered not to drive a car for a period of six months. He was also charged with being drunk and disorderly. Judgment being suspended for a period of two years upon payment of cost.

John Henry Phillips and Bessie Phillips, charged with adultery, had judgment suspended providing they should be legally married.

In the case of Elizabeth Rouse and William Grantham, colored, charged with adultery, the former received a 90-day suspended sentence in case of good behavior and to appear in the town of Ayden for a period of six months. Grantham failed to appear and bond was forfeited.

Mexicans Prepare To Meet Indians

Nogales, Ariz., May 11.—(AP)—A crisis in the rebellious movement of Yaqui Indians against the Mexican government appeared near today as Federal troops rushed preparations to meet a band of Red Men, avowed followers of Adolfo De La Huerta, former provisional president, reported marching northward toward Nogales, Sonora, just across the border from here.

Entrenchments thrown up by the Federals about the border town were visible from the American side last night, while skirmishes with the Yaquis were reported at points as near as 15 miles from the international line. Hundreds of motorists held vantage points north of the boundary until late last night watching the military activities.

Eight Hundred Marines Sail For Nicaragua

BAYOU LEVEES MAY COLLAPSE AT ANY TIME

Fight Not Yet Given
Up to Prevent Mud-
dy Waters From
Flooding Sugar Bowl

New Orleans, May 11.—(AP)—Leaves at Bay Des Glaives, about 170 miles above New Orleans, were expected to collapse at any time today, allowing a rush of muddy water to cross the "Sugar Bowl" of Louisiana, where most of the domestic cane is grown.

The fight had not been given up, however, and at Big Bend, where heroic efforts of citizens in that section has been concentrated to bolster the weakening rampart, work continued.

Should the crevasse occur today it is thought that much of the strain on the levees along the Mississippi would be relieved, minimizing the danger of a break along that line. A break at Bayou Des Glaives would inundate thousands of acres of the most fertile soil in the state, flooding many sugar houses and driving additional thousands from homes to refugee camps.

A rescue fleet already has been mobilized in the zone, dangers of loss of life have been reduced, and in all probability a toll similar to that taken in Arkansas and Mississippi would be averted.

With Vidalia, La., inundated from a crevasse in the protection levee that held back the backwaters from the four crevasses in lower Concordia parish, northeast Louisiana was under water.

All precautions had been taken at Vidalia and loss of property will not be great. Many citizens moved their household goods to higher ground more than two weeks ago.

The crests of two floods were moving toward Old river today, one formed of the waters from breaks in the Arkansas levees and the other of the torrents pouring through the Cabin Teale and winter quarters crevasses in northeast Louisiana.

Waters in the Texas basin were deeper today than at any previous time in the history of the state, weather bureau officials said, and was rising at a rate of five inches in twenty-four hours.

Herbert Hoover, Secretary of Commerce, was in Baton Rouge today for a conference with former Governor John M. Parker, flood dictator, on relief measures, after which he will go to Vicksburg, Miss., to confer with L. O. Crosby, flood relief dictator of Mississippi and the financial committee in the state of rehabilitation.

Justice of Peace Jailed Today in City of Charlotte

Charlotte, May 11.—(AP)—S. A. Mangum, local justice of the peace, was locked in the city jail today without privilege of bail to await trial in recorder's court on a charge of failing to account to the county for certain fines and forfeitures collected while he was acting as rural police judge.

He was arrested on a capias issued after he failed to appear yesterday for trial for the third time. He was arrested some time ago and released on \$300 bail when he failed to show up. Later a physician's certificate further postponed the trial. He was captured today after a brief foot race in woods near his home between himself and two city detectives.

GRAY WANTS TO TALK TO MRS. SNYDER

Would Like to Say
Farewell to Para-
mour Before They
Die in Electric Chair.

New York, May 11.—(AP)—Henry Judd Gray would like to bid farewell to Mrs. Ruth Snyder before they die in the electric chair for the murder of her husband.

Twice since their conviction Monday he has expressed a desire to jail attendants to talk with her.

"I didn't want to hurt her," Gray told Henry Masser, under-sheriff. "The least you can do is let me see her and say goodbye."

"I tell you I don't want her to suffer. I'm sorry the verdict went so hard against her. I just couldn't do anything else. I told the truth. Now I feel better."

Gray and Mrs. Snyder will see each other in court Monday when they are sentenced. After that they will be conveyed in separate automobiles to Sing Sing, where there will be no opportunity for communication.

Gray was described today as apparently unconcerned by the prospect of death, but Mrs. Snyder was said to be suffering from extreme nervousness, though far from a collapse. Commenting on reports that the woman had suffered a hysterical collapse, Frank F. Fox, warden at the county jail, said:

"She is in as good health as she has been since her arrival."

At the District Attorney's office it was said that except for a brief spell of weeping, Mrs. Snyder had shown no emotion since the verdict.

Attorneys for both man and woman are making preparation for appeals. Thirty days are allowed for the filing of appeals.

Litigation is expected regarding life insurance on the life of Albert Snyder, which totalled \$97,000. While the insurance company has given no indication of what its attitude will be it is thought the matter will be taken to court.

Dismiss Suit of Irish Free State To Possess Bonds

New York, May 11.—(AP)—Supreme Court Justice Peters today dismissed the suit brought by the Irish Free State, claiming to be successor of the Irish Republic and entitled to the bonds subscribed for in the United States for the Republican cause. Justice Peters also denied the claim of Eamon de Valera and his co-trustee, O'Mara, to the bonds and ruled that the bonds should be sold and proceeds revert to original subscribers.

The today's ruling some \$2,500,000 which was subscribed to the Irish Republic cause in this country will go back to the subscribers, after being tied up in litigation since 1922.

At that time an injunction was secured restraining banks which held the money from releasing it to de Valera or any of his agents. The injunction was granted to attorneys representing Michael Collins and other officers of the Irish Free State forces.

The suit finally began in March of this year with de Valera as one of the principal witnesses. The trial ended on April 30, and Justice Peters reserved decision until today.

REVIVAL TO END TONIGHT

Dr. McCless to Preach
Final Sermon at Pres-
byterian Church at
8 O'clock.

To a well-filled house Dr. R. G. McCless, pastor-evangelist of Chatham, Virginia, retold last evening at 8 o'clock, in the Presbyterian Church the Saviour's matchless marvelous, wondrous story of the prodigal son. From Luke 15:11-32.

1. It is a story of rank rebellion. "Give me the portion of the goods that falleth to me." He was not entitled to them till his father was dead; the same as saying, "I wish you were dead." Hurried to get away; gathered all together; greedy, selfishness moved him. Rebellion was complete.

2. It is a story of ruin. Indulging in sin unrestrained he soon ruined himself. Sin ruins. He had the riches of youth; the riches inherited from his father; all were ruined by sin. His ruin was extreme; "began to be in want; worked in a pig pen; fed hogs, for Jews the extreme of disgrace; friends all gone; and no man gave unto him a beggar yet receiving no gifts."

3. It is a story of repentance. "When he was come to himself." Yes, now his extreme want and wretchedness, his bodily hunger brought him to his sense. The turning point was the famine; thank God for that famine. We would welcome a famine here in our country, if nothing else will bring our people to God. Out of the sting of want the famine brought, he said, "I will arise and go to my father."

Repentance was genuine, for he used the strongest and ugliest word possible to describe himself: "I have sinned." True repentance alone says I have sinned.

4. It is a story of a gracious and hearty and loving reception. Here is the heart of the parable; the warm reception by his father, who represents God. Several touches make plain and emphatic God's welcome for the repenting, returning sinner. "While he was yet a great way off." Not accidental, the sight of his returning boy, he was looking for him. So is God. "Hear ye, so does God run to meet the sinner. He does not for the sinner to come; He runs to meet him. And fell on his neck: a token of reconciliation and affectionate reception."

"And kissed him." Further proof of affection and welcome. "Bring forth the best robe." The best robe; the best robe was his lost robe now found. "And a ring on his hand," a signet ring that marked him as beloved to his father. "And shoes on his feet." Yes, shoes for my son; servants and hired men go barefoot; my children wear shoes for they are members of my family.

"Kill the fatted calf," the one kept for special occasion. "And let us be merry." Yes, God does not return, repenting sinners. And he clothes us in the righteousness of His Son, robes us in His love who do not want a salvation like that.

The pastor and congregation profited to Dr. and Mrs. Snyder many thousands of thanks for their donations of flowers to adorn the church. They are specimens of rare and exquisite beauty.

We regret sorely to announce that the series of meetings will be ended with tonight's services. Im-

mense good has been done in and by these meetings. Come tonight, bring your friends, and get a blessing and then go out and be a blessing.

Radio Corporation And Wireless Stations Sweep Atlantic With Queries.

(By The Associated Press.)
The sea and land gave back no answer to the incessant calls for word of the missing airmen—Captains Nungesser and Coll. The Radio Corporation, the Independent Wireless and the Navy swept the wide Atlantic with radio queries—and met a wall of silence.

The "White Bird" was 48 anxious hours overdue at New York at three o'clock this afternoon on her flight from Paris and was last seen heading northwest off Kilrush, Ireland, Sunday morning. There was a report early today that the plane was found at Truro, N. S., but this was quickly proved to be false.

Naval vessels are searching the seas off New England and the Nova Scotia waters while the French government has a fleet of destroyers heading westward in hunt for the French aces. So far their efforts to locate the plane have been fruitless. Lookouts on the trans-Atlantic liners bound east and west scan the horizon for signs of the plane now believed forced down by weight of ice formed on her wings in flight.

Scant hopes remain of the finding of the missing men, who many believe fell into the sea north of the chartered course of steamships. Others suggest that the "White Bird" came down in the waters off New Foundland, and unless the aviators were rescued by a fishing smack, they fell victims of the ice that crushed their fragile plane.

Paris was steeped in gloom and despondency today. The bitterness expressed by some against American because of the reports that the United States government had failed to provide adequate weather reports rebounded when it was officially announced that the failure to receive wireless reports two days before the flight was due to static.

The aviators had a food supply calculated to last them a little over ten days, largely caviar and hams. Having sailed the sea for years before he took to aviation Captain Coll tucked away a fusillade and some bait in the corner of the fuselage just before the plane hopped off.

Captain Saint Roman and Commander Moumyres, two other French fliers have been missing since last Thursday when they hopped off from St. Louis, Senegal, or Pernambuco, Brazil, in an attempt to be the first to make an uninterrupted flight over the South Atlantic.

Have, France, May 11.—(AP)—The liner France, leaving tonight for New York, has been ordered by the French line to follow the route Captain Nungesser's trans-Atlantic plane is supposed to have taken, in the hope of rescuing the aviators.

New York, May 11.—(AP)—Notwithstanding warning by Ambassador Herriek that the start of any American airplane on a flight to Paris while the fate of Captains Nungesser and Coll remained in doubt might stir misunderstanding in France, owners of the Bellanca monoplane Columbia, today planned to start for Paris early Saturday.

While the north Atlantic was being searched for the missing airmen, sponsors of the Columbia sealed the plane's instruments and awaited only favorable weather before starting a 3,800 mile flight the reverse of that on which Nungesser and Coll failed.

As joy in France over imminent news that the war heroes had succeeded turned into resentment against the United States, Ambassador Herriek notified the State Department that the start of any plane from America for Paris might be "misunderstood and misinterpreted."

Th. A. Charles A. Levine, head of the Columbia Aircraft Corporation owners of the Bellanca plane, said that the start which had been set for Thursday, would be deferred to Saturday. Nungesser's fate undoubtedly would be known by then, he added.

"The finest tribute we could pay these brave men is to take up the attempt where circumstances compelled them to lay it down," Mr. Levine said.

Lloyd Bertrand, navigator of the Columbia, said: "We won't go to."

THE FRENCH ATTITUDE

The attempt of the French public to place the blame of the failure of the trans-Atlantic flight upon the American government, is just another example of the real anti-American feeling that lurks within the hearts of those whom the American soldiers helped to save from destruction or bondage. Bedded deep in their hearts and souls this feeling creeps out at intervals upon the least provocation and the point has been reached that it is not only disgusting but distasteful to the American public.

In the face of the interest the American public has expressed in the attempted feat of the two French fliers, and the expressions of anxiety for their safety, the attitude of the French public, as recorded in press dispatches, is little short of an insult and shows clearly that they still have no love for their benefactors.

It is safe to say that had the attempt of Nungesser and Coli been successful, the two Frenchmen would have been received in this country far more royally than any American can ever hope to be greeted in France.

THE VERDICT

Few will dissent from the verdict of the jury in the Snyder murder trial, which has found both Gray and Mrs. Snyder guilty of murder in the first degree. If there ever was a case which corresponded to our picture of premeditated murder, this was it. There was no single circumstance to confuse the moral issues involved; the defendants planned their deed for months, they committed it with the utmost deliberation; their motives, so far as one can understand them at all, were wholly sordid. Indeed, so lacking were they in common decency that they failed utterly to arouse any of the sympathy that usually goes to people in their plight—they turned on each other with ratlike ferocity, apparently being devoid even of the honor of many a thief who at least tries to shield his woman.

But if the moral issues were clear, the psychological problem was too much for most of us. When the cold-bloodedness of the crime is compared with the commonplace appearance of those who committed it, one is completely at a loss for an explanation. This pair, so far as one could see, differed not a whit from thousands of other pairs one sees daily on the subway; it would be hard to think of two persons who superficially varied so little from the norm as they. Much has been written about her hardness; if we are honest with ourselves we admit that we would never have looked at

her twice in a crowd, and certainly never have associated her with murder. He was even more usual than she. He was the last person in the world one would have suspected of such a crime. Yet there is the crime. What horrible alchemy of

psychology explaining the fact that as soon as they came into contact with each other they sank to the lowest depths of depravity? That, no doubt, will always remain a mystery. Certainly they themselves are utterly unable to account for it,

even though they seem vaguely aware of it.—N. Y. World.

Many Theories In Mysterious Death of Woman

Asheville, May 11.—(AP)—Theories of murder and suicide in connection with the mysterious death of Mrs. Mary R. Cooper, widow of Arthur S. Cooper, whose body with the throat cut and head wounds was found in the yard of her Montford Avenue home, yesterday morning still were balancing themselves against each other today while police and sheriff's departments continued search for clues which might offer some solution in the case.

The disappearance of the instrument with which Mrs. Cooper's throat was cut, offered the most baffling problem to the police and furnished the strongest rebuttal of the suicide theory. The latch key which Mrs. Cooper always carried, had not been found, and gave rise to the conviction that others than herself had a hand in her death.

Practically the only clue which remained in the yard late Tuesday was a curved piece of gas pipe, spotted in one place with blood to which four strands of grey hair were firmly fixed. Police doubted the belief that the bar had played a part in the tragedy, saying it had been picked up near the body and had been used in searching the weeds for the missing instrument.

COBB GIVEN BIG OVATION AT DETROIT

Detroit, Mich., May 11.—(AP)—With the cloud of an indefinite suspension lifted by Ban Johnson's ruling and with the plaudits of thousands of Detroiters ringing in his ears, Ty Cobb was back in the Athletics line-up today to "give his best" against the team which yesterday joined the multitude of fans in a tribute to the Georgian.

Cobb's reception yesterday was marked by a spontaneous outburst of welcome, that came as unanticipated from the city's dignitaries as from the kids in the streets. On the Georgian was thrust the unwilling role of a conquering hero, returned to the scene of his major league triumphs. The cheering acclaim, which began the instant he stepped off a boat from Cleveland did not reach its zenith until he poked a two base hit in yesterday's game, that spelled the beginning of the end for Detroit's hopes of victory.

It remained for George Moriarty, his successor as manager of the Tigers, to strike the keynote of the entire celebration. Speaking at noon day luncheon in honor of Cobb after a host of prominent citizens had delivered eulogies, Moriarty typified his predecessor as the "man who reduced the hit and run to a prank, base stealing to a common incident and revolutionized the entire aspect of the game."

Moriarty, placing his hand on Cobb's shoulder as he spoke, related his experiences as teammate of the former Tiger 20 years ago and pictured him as one athlete above all others who played at all times for the winning run regardless of conditions.

"And that same trait has lived with him through the years to make him one of the greatest ball players of all time," the Bengal pilot concluded.

New York, May 11.—(AP)—Storm signals, baseball men think are about to be hoisted again in the American League, now that Ban Johnson has suddenly terminated his "leave of absence" and returned to exercise the functions of President once more.

These observers profess to see the hornet's nest stirred up by Ban's suspension of Ty Cobb and Al Simmons of the Athletics, thereby removing most of the sting from the attack of Mack's machine. Lifting of this suspension yesterday may soothe matters over temporarily but there are unmistakable signs of unrest, nevertheless.

The venerable and usually mild-mannered Connie Mack for instance bitterly resents the action against his two stars during whose absence the Athletics dropped three games in a row to Cleveland. Mack shattered a few precedents when he demanded a hearing, took a fling at the umpires as having "too much power" and criticized the steps taken by Johnson.

Whether the American League is to have another of its periodic show-downs remains to be seen. The last on the schedule, involving Johnson and Commissioner Landis, was sidestepped by putting Johnson "on leave" and appointing Frank Navin of Detroit to handle the league's affairs.

Baseball men understood that Johnson was to be regarded as a "president emeritus" until his contract ran out in 1935. They started talking about candidates for the active presidency, among them George Wharton Pepper and Mayo Walker of New York, consequently there has been no little surprise even among the magnates, at the return of Johnson to active duty.

It has been the understanding of Jacob Ruppert, as an example, that Johnson was "out of office" so far as control of league affairs was concerned.

"It surprised me as much as I did everybody else," said the Yankee owner. "It was my belief that Johnson was to remain 'on leave' for the period of the present season so far as I know he has taken 'upon himself to resume his old place.'"

It's the punch, as a rule, that determines the betting odds. Belief that Jack Dempsey still packed the old wallop influenced the odds in his favor over Gene Tunney. For the same reason Jack Delaney was a heavy favorite over Jimmy Maloney in their expensive indoor bout last February.

Now Maloney, admittedly the hardest puncher of the two, has been installed a favorite over Sam Sharkey for their heavyweight semi final on May 19.

"But what of it?" asks Sharkey. "The other favorites got their lickings. Why not this one?"

"Why do you train indoors for an outdoor fight?" Sharkey was asked.

"Did you ever step out of a rail road smoker into the open air and feel the invigorating of drawing a good deep breath?" he countered. "Then you know what I meant. I'm raring to go when I set outdoors after being cooped up in the gym."

High Series To End Saturday

Raleigh, May 11.—(AP)—The list of high school teams seeking the State championship continues to narrow daily and the final game between East and West is slated for Chapel Hill Saturday.

CUBS AND SOX CONTINUE TO MOVE UPWARD

The baseball representatives of Chicago were in second third places in the American and National Leagues, respectively today after moving up at the expense of Eastern teams.

Each foot of ground was contested stubbornly but to no avail. In both cases the Eastern opposition ended by forming another stepping stone for the Chicago advance.

Paris if they don't want us. We'll fly over and around the Eiffel Tower, touch our wheels at Le Bourget and then go to London and land at Cobham Field."

"Nungesser and Coli tried to get the jump on us and we hoped for their success as such as anyone in France did. Now is our chance. Let's go."

"Those are my sentiments," said Clarence Chamberlin, the plane's pilot.

French newspapers have blamed America for sending misleading weather reports to France and for the dispatches that had erroneously announced the success of the expedition.

Dr. Charles F. Marivin, head of the weather bureau in Washington, said Nungesser had not requested special advice from the weather bureau. The French Meteorological Institute, he added, receives weather reports broadcast by navy wireless.

Trans-Atlantic liners, navy and coast guard boats and French government vessels meanwhile, continued search of the seas. The hunt extended from New York to the French coast.

The navy tugs Mondak and Mogue had the task of investigating from Cape Ann, Mass., to Newfoundland. The coast guard cutter Ossipee put out from Portland Maine. The coast guard destroyer Shaw, just south of Sable Island, N. S., also was pressed into the hunt.

The coast guard cutter Modoc on international ice patrol in the north Atlantic, radioed a warning of icebergs and growlers not far from the steamship lane.
