CAROLINAS SWEEPED BY TERRIFIC STORMS

One Killed By High Winds In This Territory Today

HEAVY DAMAGE REPORTED AS RESULT OF SWELLING STREAMS IN TWO STATES

Hundreds of Persons Driven From Mill Villages Near Spartanburg, S. C., As Unprecedented Rain Fall Causes Streams To Overflow. One Death and Several Injuries Reported.

Charlotte, N. C., Aug. 11—(AP)—Sweeping up from Georgia, where it left threats of floods in its wake the tropical storm that for days menaced the Florida coast, today struck the Carolinas with unprecedented rains wreaking unestimated damage and driving hundreds of persons from their homes.

More than 7 inches of rain fell at Spartanburg. Union reported scores of negro houses flooded in the lowlands and crops and highways badly damaged. Greenwood had 5.93 inches of rain, the heaviest rainfall ever reported there.

The center of the storm was reported by the Weather Bureau here to be over Charlotte this morning with a barometric reading of 29.45 and rainfall of 3.45 inches from early last night until 7 o'clock this morning. Scores of telephones were reported out of order due to water in the conduits and at noon rain still was falling heavily.

Along the North Carolina coast, stiff gales were reported but none that would do great damage. Several vessels remained in port, but at Southport it was said that the New York Coastal Steamer put out on its regular run while a small tanker was blown for Charleston.

Spartanburg, S. C., Aug. 11—(AP)—Several hundred persons are homeless and at least one death has been reported as a result of a heavy rain in the section last night. Approximately 7 inches of rain fell during the 24 hours ending at 7 o'clock this morning. Rain still was falling today.

Bonds Missing



Roy C. Toombs, president of the International Life Insurance Company of St. Louis, has been threatened with criminal action unless \$3,600,000 in bonds, said to be missing, are returned.

There was no information as to his name or exactly how he met death, although it was attributed to the storm. Several narrow escapes were reported.

All highway bridges in every direction from Spartanburg were washed out and telephone and telegraph communication badly crippled. By working frantically from 2 o'clock until nearly 8 o'clock this morning American Telephone and Telegraph lines succeeded in getting up a few lines and the Associated Press printer circuit began operation on time.

The city of Spartanburg proper suffered considerable damage from water due to the sewers being unable to carry off the overflow water from the streets. Basements of stores were flooded and several buildings undermined.

Greenwood, S. C., Aug. 11—(AP)—Southern Railway passenger train No. 16, bound from Greenville to Columbia, and No. 15, from Columbia for Greenville, today were being held at Pomaria between Newberry and Aiston on account of a washout, according to information received here from Newberry.

KIWANIS CLUB ENJOYS REAL FULL PROGRAM

Appropriate Sum for the Under-privileged Children of The Community.

The under-privileged child, one of the greatest problems before the American people at this time, occupied attention of Greenville Kiwanis in regular weekly session at the Rotary building last night. At the end of the session members of the Board of directors met and set aside an appropriation of \$100.00 to be used in behalf of under-privileged children of this community.

The session last night was possibly one of the most interesting held in some time, consisting of a delightful musical program by Mrs. W. H. Tolson, of Des Moines, Iowa, and Miss Bessie Brown. Two vocal numbers by Miss Brown with Mrs. Tolson acting as instrumental accompanist, drew deafening applause from the Kiwanians. Mrs. Tolson also rendered a piano selection as one of the concluding features of the program.

The program last night was in charge of J. Key Brown who at the outset, explained the need of attention to under-privileged children of the community and urged his co-workers to take some definite action looking to their relief.

K. T. Futrell, director of the welfare department of City County, was the principal speaker of the evening. He told of the numbers of dependents coming under the supervision of his department in the course of their activities. He cited two or three cases where children were being denied food, clothing and moral and spiritual development because of the illness of parents.

He said deplorable cases of this kind were called to the attention of the welfare department several times a year, and that they were exerting every effort to carry cheer and comfort to as many as possible. He explained that they had no special funds for this purpose, and that numbers of agencies had assisted them in providing comforts for those who had been left without support.

He said civic organizations should be able to render notable service to such cases by providing specific appropriations for the purpose. He said without such aid the future for this class of humanity was anything but rosy.

D. M. Sellers Is Elected City Manager At Busy Session Of City Council

D. M. Sellers was elected city manager of Streets, George W. Gardner was elected fire chief, the city tax rate was officially fixed at \$1.50 for this year, a fire truck and additional thousand feet of fire hose were purchased and several other matters were given consideration at last night's session of the Board of Aldermen which convened at 8 o'clock and lasted until close to midnight.

The first matter taken up after Mayor J. C. Lanier had called the meeting to order, was that of purchasing an additional fire truck for the city. The invitation was then extended to representatives of the different companies to explain the specifications of their products and submit their prices together with the allowance their company would make for the old American La France hose wagon now in possession of the city. The first to appear was a representative of the Mack Company who submitted price on the new truck of \$12,500 and an allowance of \$1,800 for the old truck. The price submitted by the American La France Company was \$12,500 with an allowance of \$2,000 for the old truck. The Boyer Company submitted a price of \$12,000 with an allowance of \$2,200. The Maxin Company's price was \$12,500 with an allowance of \$2,100. The Seagrave Company submitted

a price of \$12,500 with \$2,500 allowance. After all the representatives had appeared before the Board, the speakers went into a discussion of the various trucks and the features offered by each as well as the value more on the old truck. It was pointed out that the Mack Company, besides the fact that their allowance for the old truck was the lowest, offered additional features in the way of extra ladders, four wheel brakes and a more powerful motor which were thought by members of the board to more than offset the difference in the allowance and a decision to purchase the Mack truck was reached. The first vote was as follows: For Mack, five; Seagrave, two; American La France, one. As soon as this vote was taken, the members voting in the minority withdrew their action and made the Mack the unanimous choice of the board. The fire committee was then empowered to go into the matter of specifications etc., with the Mack representatives and complete the transaction for the purchase.

LOCAL GUARDS TO LEAVE FOR CAMP SUNDAY

113 Field Artillery to go into Two Weeks Encampment at Fort Bragg.

Members of the 113th Field Artillery, North Carolina National Guardsmen, will leave Greenville tomorrow for a two weeks' encampment at Fort Bragg, according to information given out this morning by Captain Lester Jones, who is in charge of the unit.

The troops will board a Norfolk-Southern train tomorrow morning at ten o'clock. They will be picked up by a special train bearing many other units at Wilson, arriving at Fayetteville some time in the afternoon.

The company is composed of sixty men and three officers, the same strength of the organization that went to camp last year. Captain Jones stated this morning that his men were in splendid condition. They have been put through four regular armory drills during the months, and should be able to make a showing equally as good as good if not better than the outfit last year.

MANY GATHER FOR HOOVER NOTIFICATION

Republican Candidate Given Notice of Presidential Nomination Today.

Stanford University, Calif., Aug. 11—(AP)—Californians by the thousands converged today upon this seat of learning to celebrate a great political event in the State's history—the formal notification of Herbert Hoover that the Republican party has selected him as its candidate for President.

By airplane, by motor and by train they came to rub shoulders with the great and near great of the party who had traveled thousands of miles to bring the message of nomination to the Engineer and Administrator who began his life's career here thirty-seven years ago as one of Stanford's first students.

Hours before the gates of the huge Athletic Bowl were thrown open at noon, the east portion of the far flung campus was swarmed with automobiles while the little city of Palo Alto, resplendent in its holiday dress was overrun.

While the crowds were gathering in and around the Stadium, the nominee himself remained quietly at his home. He appeared to be in the best of health and spirits and laughingly related to relatives and guests some of the shafts which went his way during the birthday dinner given him last night by the newspaper correspondents who accompanied him here from the East last month.

Missing Flying Boat is Found

Miami Fla., Aug. 11—(AP)—The tropical Radio Telegraph Company reported it had received a message today announcing that Robert Holland, pilot, and a passenger named Bevely, of the Nassau Flying Boat Topsy Fish, had been found north of Andros Island by a Miami relief plane and a boat from Nassau. The Topsy Fish was reported lost in Bahaman waters during Wednesday's tropical hurricane.

BARN AND OUTHOUSES ARE MOWED DOWN BY TERRIFIC GALE AT EARLY HOUR TODAY

One dead and crop and property damage reaching well into thousands of dollars was the toll taken by a heavy wind storm that cut its way through Green and Pitt Counties early today. Numbers of barns and outhouses were completely demolished by the storm demon as it reached its greatest intensity at Maury and Hookerton in Green County and near Farmville, Pitt County.

A tornado of minor intensity was reported at Ayden this morning about ten o'clock. Two or three buildings were unroofed and the tops of a similar number of automobiles destroyed by obstacles picked up by the storm.

One person was killed and a number of outhouses and barns blown down by a high wind storm that passed over Greene and Pitt counties between three and four o'clock this morning. The report of another death reached the city this afternoon, but this had not been confirmed at a late hour.

Moving in a northeasterly direction the storm struck first at the villages of Maury and Hookerton in Greene county and passed on over to about two and a half miles of Farmville, uprooting trees and leveling barns and outhouses as it went.

The storm is believed to have reached greatest intensity on the T. M. Dail farm, across the Greene county line, where a negro woman met death when a tenant house was blown down over her head. Other tenants on the same farm are said to have had narrow escapes from death or possibly serious or fatal injuries.

Gathering himself for a last grand assault, the storm demon struck the Mack Horton farm near Farmville with such force that twelve tobacco barns were completely demolished. A huge pack house and several outhouses were also razed.

It was impossible to determine the extent of the damage today, but it is believed it will go well into the thousands of dollars.

A tornado of slight intensity passed over Ayden this morning about ten o'clock, ripping the roofs from two or three shelters and smashing the tops of automobiles parked along the Main street of the town. While the damage was only of a minor nature, the populace received a considerable scare by approach of the heavy cloud and many fled for cover.

Winterville Man Hurt When Mule Plunges Into Car

Clyde Bright of Winterville, is confined in the local hospital today suffering from injuries sustained when a mule drawing a tobacco truck crashed into his automobile Thursday afternoon. Bright is said to have sustained a fractured skull and probable internal injuries.

Three Prisoners Escape.

Marshall, N. C., August 11—(AP)—Three prisoners escaped from the Madison County jail about 5 o'clock Friday afternoon and rode out of town on a passing truck, unnoticed. Saturday morning they were still at large.

Storm Warning.

Washington, Aug. 11—(AP)—The Weather Bureau today issued the following storm warning: "Advisory 9:30 A. M. change to southwest storm warnings Wilmington to Norfolk and west southeast storm warnings north of Norfolk to Delaware breakwater. Disturbance over Western North Carolina, moving northeastward, will cause strong south and southwest winds this afternoon and tonight, Wilmington to Norfolk and strong southeast and south winds north of Norfolk to Delaware Breakwater."

CONSTITUTION DAY OBSERVED BY GERMANS

Ninth Anniversary of Republican Form of Government Celebrated Today.

Berlin, Aug. 11—(AP)—Germany's Constitution Day, the ninth anniversary of the Weimar constitution by the first Republican government, was celebrated today throughout the Reich.

The Republican black-red-gold banner waved from all official and many private buildings, the same colors were liberally displayed on street cars, motor buses and subway station entrances; public offices and schools are making holiday, and the streets are full of grave gentlemen in Prince Albert coats and top hats. There seemed no doubt that the major section of public sentiment wholly favored keeping the day in a dignified and becoming fashion, with a certain measure of sober thankfulness for benefits achieved under the Democratic regime.

The octogenarian President Paul von Hindenburg, who may be depended upon to be always at the post when his official presence is required, had postponed his summer vacation in order to attend the festival act in the Reichstag at noon today.

Indiana Youth Shot in Raid Of Dry Officers

New Albany, Ind., Aug. 11—(AP)—Clarence Smith, 16 years old, is in a hospital with his left arm amputated after he had been shot and wounded by a prohibition officer during a raid on the Smith home yesterday. Turner Devine, 15, who was with Smith in a bedroom when the officers arrived, said Smith was fired on because he was slow in getting out of bed at the dry agents' command, but George L. Winkler, deputy prohibition administrator for Indiana said he was convinced that the boy was accidentally shot during a scuffle.

Charges of conspiracy to violate the Federal prohibition law were filed late yesterday by George Winkler, deputy prohibition administrator for Indiana against Mrs. Francis Lowman, 50; James Smith, 50, and Otis Washburn, 46, following the raid. James Smith is the father of the wounded youth.

Two Persons Hurt As Car Turns Over

Mr. and Mrs. J. N. Tingle and two small children had a narrow escape from death or serious injury when the automobile in which they were riding overturned on the Greenville-Bethel Highway, about five miles from Greenville, this morning at four o'clock. Mr. and Mrs. Tingle received cuts and bruises, which though painful, were not considered serious. The children escaped uninjured.

AL SMITH HAS BUSY WEEK-END AHEAD OF HIM

Governor To Apply Himself to Finishing Touches of Acceptance Speech.

Albany, N. Y., Aug. 11—(AP)—At an hour this morning when ordinarily he still would have been sound asleep, Gov. Smith got back to Albany from Chicago, where he attended the funeral of George E. Brennan, Illinois Democratic leader.

Confronted with the task of whipping his acceptance speech into final form, the Democratic train to the Executive Mansion Presidential nominee went from the where he planned during the day and over the week end to apply himself to that job.

The Governor also was expected, with members of his family, to listen in there this evening to the address of his rival, Herbert Hoover, at the Republican nominee's notification in California.

Governor Smith returned to Albany after a 36-hour absence, aboard the first section of the Twentieth Century Limited which, running half an hour ahead of schedule, arrived here just before seven a. m., daylight time. The nominee was up and immediately detained, the special car of his friend, William F. Kenny, on which he had made the trip, continuing on to New York.

Although he went to Chicago on a non-political mission, Smith received fragmentary reports during chats there with various party leaders as to the outlook in the Middle West, particularly in Illinois. Floyd E. Thompson, Democratic nominee for Governor, was among those most optimistic about the chances of carrying Illinois in November.

As he passed through northern Indiana and Ohio late yesterday and last night, Governor Smith, in accordance with his wishes, was met by no political leaders. At the few stations at which his train stopped however, he was greeted as a rule stepped from the train by crowds of varying sizes, and to shake hands and exchange pleasantries, minus his coat and vest and wearing bedroom slippers.

Although there was a tendency to keep politics to the background during the trip, the Democratic nominee was able during his journey to discuss strategy and plans with two men actively identified with his campaign—Mayor Frank Hague of Jersey City, who is a vice chairman of the Democratic National committee and an intimate friend of the Governor, and James J. Hoy, of New York, one of the members of his campaign executive committee. Both were travel companions of the nominee, along with Kenny, who is a New York millionaire, James J. Riordan, another with Kenny, who is a New York millionaire, and Smith's son Arthur.

On his return to Albany, which for the present is his campaign base, the Governor had before him not only many hours of work polishing off his acceptance speech which will be delivered here a week from Wednesday evening, but decisions on other campaign developments.

Among these were the question of a debate on his political career with Dr. John Roach Straton, Baptist minister of New York, which Smith himself proposed should be held in Straton's church, and which the clergyman has suggested be held in St. Patrick's Cathedral in New York. The Governor is expected to adhere to his original challenge—one meeting—and that in the church where Dr. Straton charged the nominee was the greatest foe to moral progress in America.

Newton, N. C., Aug. 11—(AP)—One of the worst wind and rain storms in 1928 hit here about noon yesterday and was continuing unabated today.

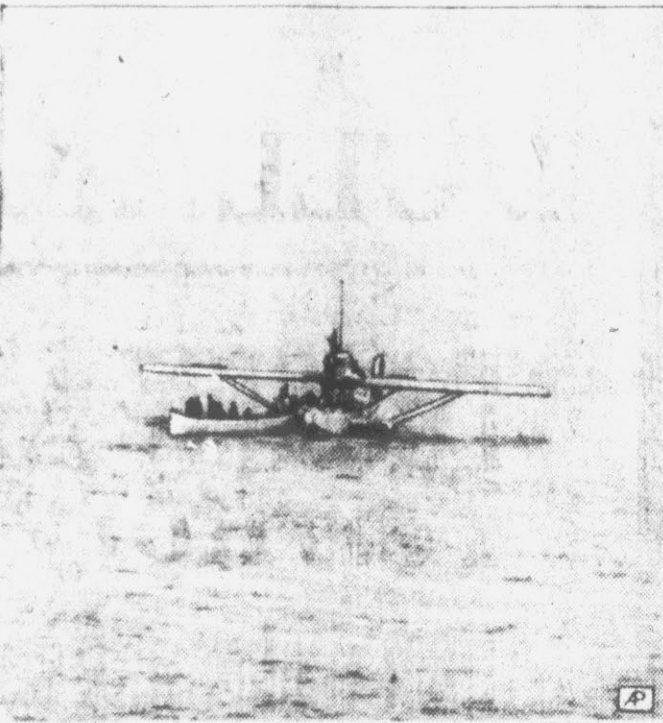
Great streams of water are flowing through the streets and creeks and streams in surrounding country are pouring over bridges. Bottom lands are inundated.

to elect its own chief. A letter from officers of the company recommending that the board elect G. A. Clark for chief was then read by Mayor Lanier. At this stage Alderman Bradsher submitted the name of George W. Gardner for the office and the nomination was seconded by Alderman Brown. The matter was then thrown open for discussion and citizens, members of the fire company and members of the board, were invited to take part. W. M. Jones member of the fire company, made a brief talk in which he suggested to the board that the matter be left up to the company. A vote was then taken on Alderman Smith's motion to this effect with the following result: For the motion, Smith, Boyd and Waldrop; against the motion, Brown, Bradsher, Harvey, Godson and Griffin. Gardner was then unanimously elected fire chief at a salary of \$25 per month. Gardner is already driver of the fire truck and is at the fire station at all times

Mr. Sellers was advised that in accepting the office he must take charge of same today, and Sheriff Whitehurst agreed to release Sellers as deputy Sheriff at once in order that he might take

up his new duties. The matter of the thirty days notice now being served by J. R. Edwards, as City Manager, was discussed and Mr. Edwards appeared before the board and declared that he would today turn over the management to Sellers, work the balance of his notice under him and give all the co-operation possible to the new city manager. A motion then made by Alderman Godson, that in view of the fact that former Chief of Police had not received his usual vacation during the year just closed, the city pay him two weeks salary in lieu of this vacation, was unanimously carried. The matter of purchasing a thousand feet of additional fire hose was discussed and representatives of the Boston Woven Hose Company and the Eureka Fire Hose Company appeared before the board to present the facts about their products. The decision of the board was that 500 feet of the best grade hose be purchased from each of the firms. Attempt To Set Aside Lloyd Will At Chapel Hill

ATTEMPT TO SET ASIDE Lloyd Will At Chapel Hill, Aug. 11—(AP)—What promises to be one of the most interesting civil suits ever heard in Orange county has been instituted here.

Thirteen nephews and nieces of the late Mrs. Carolina Lloyd, widow of Thomas F. Lloyd, have filed suit against another nephew, Lueco Lloyd, to set aside Mrs. Lloyd's will bequeathing the bulk of the Lloyd estate to him, the Chapel Hill

Weekly sets forth. The late Thomas F. Lloyd was reputed to be one of the wealthiest men of this section at the time of his death.

The complaint, filed with the clerk of court at Hillsboro, estimates the estate at \$150,000, while Lueco Lloyd's sworn report at the time of taking out letters of administration is said to have placed the valuation at only \$20,000.

Charges that the "purported will" filed by Lueco Lloyd last March was not a valid will is entered by the complainants. They allege that because of impaired mental faculties she was incapable of making a will, and seek an accounting of the property which they allege he wrongfully obtained from her both during her life and at her death through the will.

Pending the hearing Lloyd who had been named executor as well as residuary legatee, has been directed by the clerk of court to suspend until decision of the issue all further proceedings in relations to the estate except the preservation of property and collection of debts.

FRYING PAN AND THE FIRE

Those who are blandly look to the Republican party for the enforcement of prohibition might be interested in what the presidential nominee of the only prohibition party has to say on the subject. Remember, he isn't talking about Al Smith or Raskob. He's talking about the Republican party. Here it is:

"We, therefore, after eight years, are still called to battle this arch enemy of the human race, which still projects its slimy trail, socially, financially and politically into every walk of life . . ."

"It is true that during the first two years after the eighteenth amendment became effected it was largely respected by the liquor traffic—respected, not enforced—because at the first the rank and file of the wets believed that Uncle Sam meant business.

"But unfortunately, before the second year of prohibition had ended the wets discovered that Uncle Sam, as represented by the Harding administration at Washington, did not intend to enforce the prohibition law and hence they became emboldened . . . until today the bootleg liquor business has assumed enormous proportions and is being carried on both in utter defiance of the law and, what is more alarming, with the contemptible connivance of the government.

"The fact is that the last two administrations have not enforced the eighteenth amendment, they have be-

trayed it . . . It is a fundamental principle of law that one intends the natural consequences of his acts. Is it unfair, then, to charge that it was the deliberate intent of the administration in betraying prohibition instead of enforcing it, to create a public opinion hostile to prohibition?"

There isn't any debate about these statements. The record stands to confuse and humiliate any one who may seek to take issue with the analysis of William F. Varney.

And yet, good men and women, folks of conscience, are planning to shut their eyes to all this because of the personal opinion of the Democratic party's nominee.

HORNSBY AND BENTON LEAD IN NATIONAL

New York, Aug. 11.—(AP)—The National League still presents the same competitors in the lead for the major coronets—Rogers Hornsby in batting and Larry Benton in pitching—but new faces have crept in here and there in some of the less prominent endeavors. But Hornsby has sagged back a little at a time, so steadily with Paul Waner advancing by the same slow steps, that it no longer seems so certain that the Boston manager will regain the purple toga he wore for six straight seasons while playing for St. Louis.

Hornsby entered only two games in the week ending last Wednesday, and in them lost four points to sing to 383 as Paul Waner climbed to 370. The Red Sox played in 89 contests and the Pirate slugger in 102.

Behind this pair George Sisler was storming along with a mark of 367 for 60 games. The former star of the Browns can play in something like 115 games, and would, therefore, be eligible for the batting championship if he can pass the elder Waner and his own manager. Such a turn of events would entitle him to a place beside the late Ed Deleahanty the only man who ever led both of the present major leagues in batting.

In addition to pressing Hornsby for the batting lead, Paul Waner edged in among the leaders in total hits and doubles when Taylor Douthit and Jim Bottomley slumped. Paul ousted Douthit from the top in total hits with 152, and entered a tie with Bottomley in doubles at 35.

The St. Louis first baseman had several crowns left, however, and remained on the heels of Hack Wilson of Chicago for the League lead in home runs, with the Bruin outfielder just shading him, 26 to 24. Sunny Jim stood at the head of the class in runs scored with 92 in triples with 13 and in runs batted in with 95. Cuyler of Chicago again led in stolen bases with 22.

Hughes Critz, the Cincinnati double play hitter, set a season's record for hitting in consecutive games before his spurt was ended earlier this week at 24. Hughes went down as the Reds brought their eastern invasion to a close with a double defeat at Boston.

Other leading leaders were Grantham, Pittsburgh, 357; Lindstrom, New York, 352; Hagan, New York, 349; Bottomley, St. Louis, 341; and Herman, Brooklyn, 337.

Larry Benton the Giant ace, stood pre-eminent among the pitchers with 18 victories and 4 defeats for a percentage of 818.

Burleigh Grimes, the Pittsburgh work-horse, had won the highest total of any hurler in the league—20—but ranked fourth behind Benton, Flint Rhem and We Willie Sherdel. Burleigh had lost nine times which pulled his average down to .690. Rhem with ten victories and four defeats had an average of .714. Sherdel next through a record of 14 and 6 for .700. Red Lucas of Cincinnati, former runner-up had crept into a tie for sixth place with ten and five for .667.

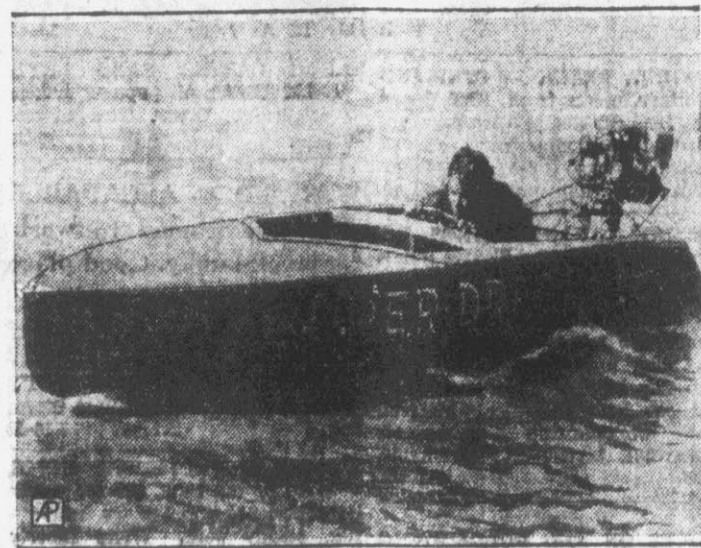

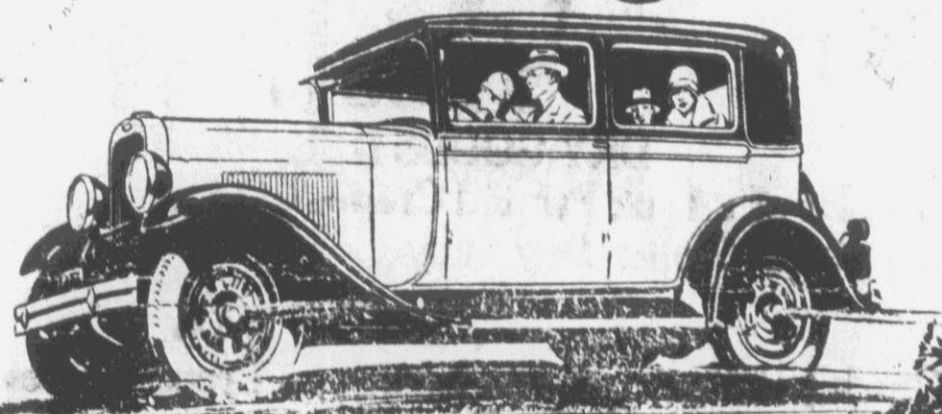

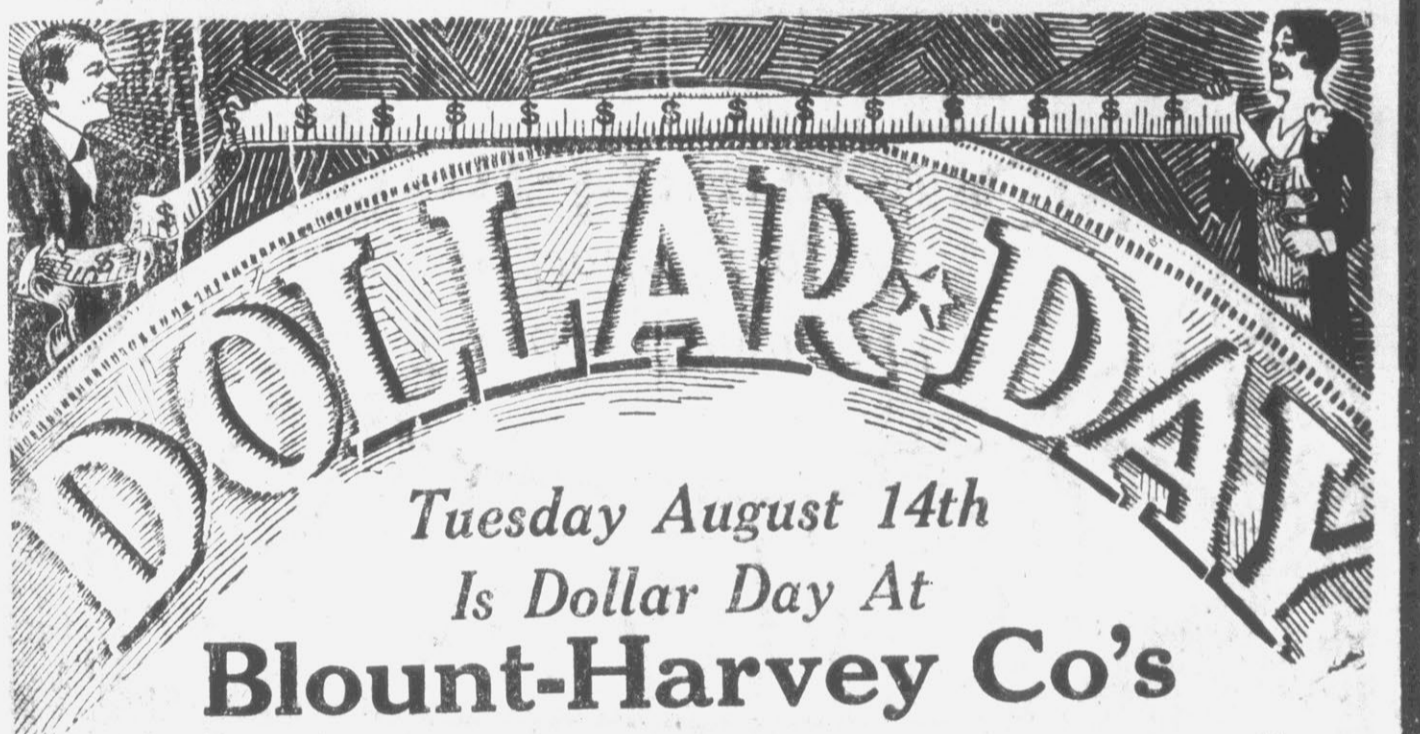
