## NEW TROPICAL STORM PASSES OVER FLORIDA

### Carolina Railroad Service May Be Impaired; Washington Recovers From Rain.

Jacksonville, Fla., Aug. 13.—(AP)—A 100 mile strip of the Florida west coast from Boca Grande to Tampa lay today in the path of a new tropical disturbance, described as of considerable intensity, which last night and early today brought high winds and heavy rains to the southern end of the peninsula but caused no damage.

In ordering advisory northeast storm warnings hoisted for that region, the weather bureau said that the storm at 11 a. m. was central about 50 or 60 miles north, northwest with the probability that it would bring strong northeast winds tonight in the vicinity of Tampa and strong east winds probably reaching gale force this afternoon in the region of Boca Grande, 20 miles northwest of Fort Myers on the coast.

At the same time the weather bureau warned of another tropical storm of slight to moderate intensity which passed over Windward island last night near St. Lucia.

Tampa today reported a barometer reading of 29.88, considerably below normal, but with only a gentle wind blowing. A reading of 29.76 was registered at Fort Myers, which, however, said that although a hard rain was falling, there had been no evidence of the tropical disturbance.

Charlotte, Aug. 13.—(AP)—Widespread possibilities of the development of serious conditions existed today generally throughout the Southern Railway System, but trains were maintaining fairly satisfactory schedules though flood conditions and the necessity of maintaining connections with trains of other lines were combining to force many trains to run late, according to information obtained today at headquarters here of the Southern's lines east.

Some detouring of trains was necessary Saturday and Sunday night but most of these unfavorable conditions were alleviated on Sunday, it was reported. No important bridge on the Southern's lines had been washed out, and no serious interference with the progress in traffic was presented by any wash-out in the road bed, officials of the railway said.

"Conditions are a whole are very fine, considering the widespread storm and its consequences," said the railway headquarters report. "We hope conditions will clear up soon but it will be necessary for the maintenance-of-way crews to keep on their toes for some time yet, it appears, as we never know what high water may do. At present many streams crossed by our lines are high, and we are maintaining a close watch all over the lines."

Other railroads entering Charlotte reported that no important impairment had resulted up to that time from the storm, which reached its height Saturday in the Carolinas, Georgia and Virginia.

Washington, Aug. 13.—(AP)—The national capital welcomed clear weather gratefully today after the worst hour downpour of rain it has witnessed in its history.

Hundreds of motorists went after their automobiles stranded throughout the city and in the neighboring countryside which they were forced to abandon over the weekend when a terrific, steady precipitation caused motors to fail.

In some sections of the city, particularly the southeast, streets were flooded so that their use was high impossible, cellars were filled with water and residents were forced to use boats to enter and leave their homes.

The Potomac river had risen considerably and new high levels were predicted by Major Brehon Somervell, of the U. S. Engineers' Bureau, said he expected no serious flood situation.

In this surrounding countryside, especially in Virginia to the northwest of Washington, rain, accompanied by almost gale force winds Saturday night had laid low hundreds of acres of corn. The extent of the damage had not been estimated.

The amount of rain which fell in Washington between Saturday night and last night was the greatest ever recorded here. During that period the weather bureau said 6.31 inches came down.

## Garrett Urges Later Opening Leaf Markets

In a telegram from Conway, South Carolina, today, R. M. Garrett, of the Person-Garrett Tobacco Company, of this city, urges a postponement of the opening of the Eastern North Carolina tobacco markets until September 4, declaring that he believes the inability of the larger companies to have buyers here at an earlier date will cause financial losses to the growers.

Mr. Garrett's telegram to the growers is as follows: "Owing to the lateness of the Georgia crop, some of it yet to be cured, I think it well to advise the public and our farming companies are much concerned and nearly all have expressed themselves adversely as to August 28th opening in Eastern North Carolina. I feel that if this date is adhered to that it will work a financial loss to the planters, since several of the large companies will not have their buyers on, and the independents cannot handle all of the tobacco and pay anything like a living price. Prices are not high in South Carolina nor Georgia, and if Greenville and other Eastern Carolina markets open before September 4th prices will be much lower than these states. It is up to the warehousemen to act and save the situation. Please give this space in your paper."

## Bryant Alienation Case Opens Today At Asheville, N. C.

Asheville, N. C., Aug. 13.—(AP)—Trial of the involved \$100,000 alienation case, G. Wallace Bryant, nephew of Mrs. Henry Ford, has instituted against Henry Westall, prominent Asheville clubman and collector, opened Monday before Judge H. Hoyle Sink in the special civil division of Buncombe County Superior Court.

As selection of a jury was begun, a long and hard fought legal battle loomed as likely to take place before the litigation can be settled. Considerable haggling over each individual juror took place between the opposing counsel as the examination proceeded.

It appeared likely that it would be late afternoon before any evidence in the case would be introduced. After a jury is finally selected, the voluminous pleadings of both the plaintiff and the defendant will have to be read before any witnesses are put on the stand. Both Mr. Bryant and Mr. Westall were present as the trial opened, but Mrs. Bryant was not. Mrs. Bryant is in Philadelphia with her two children whom she is charged, in Buncombe, with having kidnapped from custody of the Juvenile Court.

## Local Child Hurt In Wreck of Auto

The five-year-old child of C. H. Harper, of the cotton mill section of the city, sustained painful but not serious injuries last night about nine o'clock when an automobile in which it was riding with other members of the family turned over on the Greenville-Washington highway, about three miles from Greenville.

While the occupants were badly shaken up, all escaped with nothing more serious than shock and abrasions.

The wreck happened near the old Pitt County Court House site. The car, which was driven by the child's father, is said to have suddenly left the road and turned over. The cause of the wreck had not been determined today.

## MURDER MILL IS BROKEN UP AT CHARLOTTE

### Six Persons Jailed On Charge of Attempting to Do Away With Their Mates.

Charlotte, N. C., Aug. 13.—(AP)—The principals in the alleged poison plot uncovered by local officers last week are granted a continuance until Wednesday when their case was called for preliminary hearing in city Recorder's court today.

Charlotte, N. C., Aug. 13.—(AP)—Preliminary hearing for six persons under arrest in Charlotte on charge of murder or conspiracy to murder in connection with what police say was a plot whereby they were to rid themselves of their mates by poisoning them, will be afforded today. The cases will be called in Recorder's Court before Judge E. McCurry.

While detectives working on the case announced that additional arrests are to be expected, most of yesterday and last night was spent in securing amplified confessions. They were closed until an early hour this morning with S. W. Daniels, alias Professor Brandorini, who is alleged to have furnished the poison which police say caused the death of one man, L. W. Lockamy, of Charlotte, and the serious illness of another man and a negro woman.

Daniels together with E. F. Pressley, of Charlotte; J. H. Moore, a negro preacher of Newton, N. C., and Mrs. L. M. Lockamy (now Mrs. E. F. Pressley) remained in the city jail this morning. Mrs. Lilly Townley, of Thomasboro, N. C., and Mrs. L. M. Priddy, of Charlotte, have been released on \$2,000 bond each. Both face charges of conspiracy to murder their husbands, who are reported seriously ill.

Murder charges face Pressley, his wife, who he married a few weeks ago, after the death of her husband, June 5th, this year, and Daniels. In a signed confession made shortly after his arrest Saturday, Daniels, who represents himself to be a crystal gazer and "fortune teller" said that he sold the poison to Mrs. Lockamy and Pressley after they told him they wished to "put Lockamy to sleep" to collect his insurance and allow them to be married.

The negro preacher likewise faces a charge of conspiracy to murder, he being alleged to have administered doses of the poison to his wife who is now seriously ill. The alleged murder mill was uncovered when officers arrested a woman for shop-lifting last week. Under questioning she admitted, officers said, that she needed the money to pay Daniels for an operation. A search of Daniels' rooms disclosed a note book with the names of the "clients," they said. The arrests followed quickly after a complete investigation.

## Plane Carries Mail From Deck Of Ocean Liner

Isle De France, at Sea, Aug. 13.—(AP)—By Radio to The Associated Press: An Amphibian plane carrying mail, was catapulted from the deck of this liner at one o'clock New York Time today. The plane intended to approach the Long Island and reach the quarantine station in New York at six P. M.

The Isle De France was approximately 450 miles at sea. The plane weighed 7,475 pounds and had aboard Commander Louis Demougeot, pilot; M. Monrouzeau, radio operator, and A. Sarzach, mechanic.

After passing customs and health examinations, the plane will continue to the French line pier at Fourteenth street and the North river where it will discharge its cargo.

By means of such flights, the French line expects eventually to cut a full day from the time of transporting important trans-Atlantic mail. It is also expected to extend the service to passengers later.

## Coolidge Faces Busy Week With His Desk Clear

Superior, Wis., Aug. 13.—(AP)—Following his life-long habit of never getting behind his work, President Coolidge faced the opening of another week today with a clean desk before him.

Later in the morning, however, the mail brought in the daily ration of routine correspondence, the gist of which was communicated to the executive residence by telephone from the offices before being taken out to the lodge.

President and Mrs. Coolidge and their son, John, attended church at Brule yesterday as usual. Last Sunday's unusually warm weather was repeated yesterday and the presidential family again appeared in the light of summer clothing.

The large crowds which Brule has become accustomed to seeing gather every Sunday were present again yesterday. President and Mrs. Coolidge responded to the crowd's greetings with smiles and waves of their hands before returning to the lodge.

## DENIES PART IN THE PARIS DIVORCE MILL

### Dudley Field Malone Declares He Didn't Take Part In Airing Recent Scandal.

Paris, Aug. 13.—(AP)—Dudley Field Malone, American attorney, had made public a denial of reports carried by the Associated Press on July 21 connecting his name with divorce irregularities in the French courts during the recent investigation of the "American Divorce Mill" scandal in Paris. In its report of the investigation, the Associated Press said that presiding Judge Wattine mentioned by name Mr. Malone, Charles G. Loeb and Benjamin H. Conner, President of the American Chamber of Commerce in Paris. This was an error which the Associated Press is glad to correct.

The names of the three American attorneys were mentioned during questioning of the French defendants in the investigation as among American lawyers from whom they had received the divorce cases under investigation. Judge Wattine said that he was not concerned with American lawyers but since the cases came from their offices he made a general criticism of "American divorce lawyers" without distinguishing between those whose cases were found regular and those who turned in faulty papers.

The implication carried in the report of July 21 that Mr. Malone's name and those of Mr. Conner and Mr. Loeb had been connected with the divorce irregularities by Judge Wattine was erroneous and hereby is corrected by the Associated Press.

Mr. Malone's message of denial to the Associated Press was as follows:

"No such accusation was ever made against me, since I was not even in France at the time of the irregularities charged, and since the French Counsel expressly exonerated me from any knowledge of or participation in the said irregularities and since, on the contrary, the French authorities thanked me and my office for the assistance we gave toward a thorough investigation of the charges.

"During 21 years as a member of the bar this is the first time that ever false accusation has been made against my professional practice or conduct."

Mr. Malone later amplified this by saying:

"I had no contact with, knowledge or responsibility for any irregularities charged against me or one of my French solicitors. I was not even in Paris when the few cases handled by this man were presented and they were given him by my French advocate, Maître Floriot, to whom they had been sent by different American lawyers in the United States through the medium of my Paris office.

"I have never met the clients in question, and until very recently for the purpose of investigating these charges, I had never even had a conference with this French solicitor."

## LOCAL MEN INJURED IN CAR WRECK

### Neil Johnson Probably Fatally Injured By Crash In Washington Saturday.

Neil Johnson, 21, of Greenville, is confined in a Washington hospital today suffering from supposed fatal injuries received in an automobile wreck in Washington Saturday evening. George Clark and L. Bain, both employees of a construction company here, were held in Washington jail awaiting the outcome of Johnson's condition.

Johnson is reported to have received a fractured skull and broken ribs. Physicians this morning declined to give out the slightest encouragement regarding his recovery. J. A. Johnson, father of the injured man, said today. All three occupants of the car are said to have been knocked unconscious by the impact, and Johnson was said to be in the same condition today.

The accident occurred at the corner of Third and Bridge streets at 10:30 Saturday night. The three had left Greenville for a pleasure ride. When they reached Washington the driver of the car in going northward swerved from the right hand side of the road to a ditch hitting a water main and later a telephone pole. The car shot some distance, turned over several times and was completely demolished.

Whiskey is said to have been found in the car. Bain and Clark contended that Johnson was driving and a single witness to the accident substantiated the story.

Mr. Johnson, father of the injured man returning from Washington today, stated that physicians declined to say whether they thought there was any chance for the young man's recovery. They did say, however, that the broken ribs did not puncture the lung as first supposed.

## Mrs. J. B. Baker Died Last Night

Mrs. J. B. Baker, 55, died last night at 11:35 o'clock at her home at the corner of Reed and Eleventh streets, following a stroke of paralysis which she suffered on the 3rd of August.

Funeral services will be conducted from the late home at 4:30 this afternoon by Rev. J. E. Nobles, assisted by Rev. T. E. Beaman, of the Free Will Baptist church. Burial will be made in Greenwood cemetery.

She is survived by, besides her husband, five children: Heber C. Baker, J. L. Zaker, of Greenville; Lee C. Baker, West Palm Beach, Fla., and Mrs. Katie Hardee, of Clark's Neck.

Mrs. Baker was a member of the Pentecostal Holiness church. She had resided in this section over 20 years and was well known over the county.

## Dr. Straton Refuses To Debate Smith In Church

New York, Aug. 13.—(AP)—The Rev. Dr. John Roch Straton, Calvary Baptist church, has refused to meet Governor Smith in debate in his church in his church on the grounds that the pulpit is no place for a political discussion.

Governor Smith had asked to be allowed to defend himself here from the attack Dr. Straton made on him from the pulpit at Calvary a week ago Sunday in which the Governor was called the "deadliest foe of moral progress in the country".

Dr. Straton's refusal to meet the Governor in debate in the pulpit from which he made his charges was made in a statement read to the congregation in Calvary last night by his son, the Rev. Hillyer Straton, of Philadelphia, who conducted the evening service in the absence of his father who is at his summer home in Greenwood Lake, N. Y.

"I stand ready to meet the Governor at any time, except the Lord's day, and in any suitable place," Dr. Straton wrote, "and I sincerely hope that he may be led to take my acceptance of his challenge at its face value."

Dr. Straton said that his previous statement that he would meet Governor Smith "face to face" in Calvary Church if the Governor would also debate him on the same question in St. Patrick's Cathedral was in the nature of a joke, and for the "sake of a bit of humor to relieve the rather tense situation."

Dr. Straton pointed out in the statement that from the first he had suggested Madison Square Garden as a more suitable place than the church for the debate and that he had never had any intention of debating with Governor Smith in Calvary.

Several years ago Dr. Straton opened his pulpit to William A. Brady, theatrical producer, with whom he debated the morals of the stage and last year held two debates on evolution with the Rev. Dr. Kirkley T. Mather of Harvard University.

## AL SMITH TO CONFER WITH PARTY HEADS

### Democratic Nominee Also to Talk With Delegation of Farm Leaders.

Y., Aug. 13.—(AP)—In a series of conferences that may have far reaching political effects, Governor Smith intends before the end of the week to discuss the agricultural situation here with a group of farm leaders and to talk over his Presidential campaign with three men high in Democratic party councils—Senators Walsh of Montana and George of Georgia, and Josephus Daniels, secretary of the navy under Woodrow Wilson.

The farm delegation, headed by George N. Peek of Illinois, who cast his lot with Smith several days ago, was in Albany today for its meeting with the nominee. Daniels is due Wednesday, George Thursday, and Walsh on Friday, all coming at the governor's invitation.

Prior to their call on the Presidential nominee, the identity of all the agriculturists who planned to sit in at the round table discussion today had not been disclosed, as arrangements had been life to peek and he had not advised the governor definitely who would be with him.

Indirectly, however, the governor had been advised that among those who would go over the farm problem with him were two of the leaders in the rising fight at the Republican national convention for a farm plank along the lines of the vetoed McNary-Haugen bill—Earl C. Smith of Illinois and Frank W. Murphy of Minnesota.

In addition others expected to be on hand were William Hirth, publisher of "The Missouri Farmer," W. H. Settle, head of the Indiana farm bureau federation; Chester C. Davis, former commissioner of agriculture in Montana; X. Caverio, president of the Missouri Cotton Growers Association; B. W. Kilgore, head of the American Cotton Growers Exchange, and J. N. Kehoe, of Mayville, Ky., who is active in the Furley Tobacco Growers Association.

As for the three party leaders the nominee will see later in the week, all at one time or another during the pro-convention campaign were lined up against Smith. George, who is the junior senator from Georgia, had the solid support of his home state delegation at Houston and also received votes for the Presidential nomination from other states.

Walsh, with the support of William G. McAdoo and many of his followers, became a candidate for the Democratic nomination, but the prosecutor of the senate oil inquiries, declaring that Smith's nomination appeared inevitable, withdrew from the race after he had run third in the California primaries.

Like George and Walsh, Daniels is a dry and worked for the nomination of a dry at Houston, where as a member of the platform committee he aided in the drawing up of the prohibition plank.

He has declared that he would work for Governor Smith's election. It was indicated that Smith's conference with the farm leaders had as its purpose the lining up of support in the agricultural west and south and the mapping out of an intensive campaign in those sections rather than the solicitation of suggestions for the nominee's acceptance speech, which will be delivered a week from Wednesday evening.

## TROOPS BURN NEW ORLEANS MONTE CARLO

### Governor Personally Supervises Wrecking of Gambling Dens of City.

New Orleans, La., Aug. 13.—(AP)—A pile of smoldering, blackened debris was all that remained today of the trappings of two casinos of New Orleans' "Monte Carlo," after a raid by troops which was personally supervised by Governor Huey P. Long.

In the hours just before dawn today, the governor received the reports of state troops which he had sent into the Jackson barracks neighborhoods six miles out then remarked with a smile:

"Gambling is going to stop under my administration. I told them what I was going to do if they didn't close down."

The governor struck the blow swiftly and quietly, coming into New Orleans early last night and driving to Jackson barracks to deliver personally his orders to Adjutant Fleming.

Then he awaited developments, and reports.

He heard the story from his officers, how the names of prominent persons were cloaked under John Doe fiction; how a sentry's shot brought pandemonium, and how the hundreds of patrons were cowed back into the houses. When a news cameraman attempted to flash a picture, he was grabbed by a mob and beaten into insensibility.

The governor's actions were the answer to New Orleans business men who complained that some patrons were unable to meet their legitimate bills because of casino losses the governor had previously threatened to use troops to "clean up" New Orleans after telling the city and parish authorities they were having their chance to do so first.

## Low Prices On Border Markets

Wilmington, Aug. 13.—(AP)—Prices paid on tobacco by the North Carolina border markets of the Pee Dee belt for the first week of this season which ended last Saturday, were much lower than last year, but averaged about the same as quotations in 1924 and 1925.

The average price for the seven markets ranged around \$12.00 per hundred pounds, which is \$5 per hundred less than last year. The quality of the week offered thus far, however, is said by warehousemen to be much inferior to that of last season.

# HOOVER OPENS AT FULL BLAST IN SEPTEMBER

## Republican Presidential Candidate To Expand Upon Subjects of Address.

Stanford University, Calif., Aug. 12.—(AP)—Swinging into his campaign in earnest early in September, Herbert Hoover, probably will expand upon several of the subjects treated in his address here Saturday accepting the Republican Presidential nomination. They will include prohibition, farm relief, foreign affairs and the development of national resources.

While the candidate himself has not disclosed the line he will take in amplifying his declaration on the wet and dry question, some of his confidential advisers have stated that he will make clear his position and that the searching investigation he proposed in his speech will extend to the subject of the Volstead Act itself as well as the abuses which have surrounded its enforcement.

These same advisers state specifically that Mr. Hoover by no means closed the door on the modification of the first enforcement act passed under the Eighteenth Amendment if all of the facts obtained by the investigating commission point to this as a constructive method of carrying forward what he has characterized as "A Great Social and Economic Experiment".

In this connection, however, they emphasize that the standard bearer himself said in his acceptance speech; that modification to permit that which the constitution forbids is nullification, which the American people will not countenance.

Hoover's views as to farm relief are to be amplified in the address he will make at his birthplace at West Branch, Iowa, on the evening of August 21, and present expectations are that he will advert to this subject upon more than one occasion before the campaign ends in November.

In his speech, that is to be delivered at a homecoming celebration in Los Angeles next Friday afternoon, he will touch again upon development of water resources and probably will speak briefly regarding the Boulder Canyon Dam project, which he has endorsed.

Additional messages regarding his acceptance address continued to pour into his home today, supplementing the 200 or more he received Saturday night and yesterday.

Thomas J. Love, a Democratic leader of Texas, who already has announced that he would vote for Hoover, said: "I shall vote for you in November, and only blunders can prevent you from carrying Texas, whose voice you have uttered tonight".

Senator Charles Curtis of Kansas, Hoover's running mate, sent this telegram: "I congratulate you on your speech of acceptance. Best wishes".

W. N. Doak, president of the Brotherhood of Railroad Trainmen, hailed the speech as "the political masterpiece of the ages", while Alexander Moore, American Ambassador to Peru, cabled congratulations on "A masterful address".

Senator James E. Watson, of Indiana, who bitterly fought Hoover in the pre-convention campaign, sent a telegram saying in part: "I heartily congratulate you upon this lucid declaration of your personal views and of party purpose".

### Get 500 Bottles Of Bootleg Beer In Raid Saturday

Five hundred bottles of bootleg beer are in possession of county officials today as result of a raid made on a filling station on the Greenville-Washington road about five miles from Greenville, late Saturday afternoon.

As a result of the raid, Sam Edwards, filling station operator, was arrested and bound over to the next term of Pitt county court under bond of \$200.00.

This was said to have been the largest capture of beer made by officials since the new kind of beverage has been on the market. Demand for the concoction is said to be real extensive, as indicated by the amount which the single dealer had on hand.

## Negro Fireman Injured When Trains Collide

Rocky Mount, N. C., Aug. 13.—(AP)—Henry Williams, negro fireman of this city suffered a broken leg when the Havana Special, through Atlantic Coast Line passenger train, southbound, collided with an extra Southern Railway northbound freight train running over the Coast Line track at Kenly last night.

The engine and baggage car of the passenger train and three cars of the freight were derailed. Through traffic was not interrupted as the line is double-tracked. The wreck occurred, according to reports received at railroad offices here today, when the freight train,

too long to take the passing track, remained on the northbound track. The special plowed into the freight as it was backing to clear the main line so the passenger could come back on it after passing.

Railroad officers reported today that Atlantic Coast Line traffic was being detoured over the Southern between Richmond and Washington because of washouts on the Richmond, Fredericksburg and Potomac.

## Farmer Prevents Wreck of Train In New Jersey

Cape May Court House, N. J., Aug. 13.—(AP)—Waving an American flag over his head while his son signaled with a burlap bag, John Anklet, a farmer of Swain, near here, today flagged a passenger train in time to save it from possible derailment. The train, a Monday morning special over the Pennsylvania Rail-

road, carried about 300 passengers from Wildwood to Philadelphia. The heavy rain of yesterday undermined some of the railroad ties, causing a rail on the northbound track to buckle and snap. It left a gap of several inches. The train after being stopped proceeded slowly and passed over the break without mishap.

## Manchuria Not To Be Put Under Nanking Regime

Tokio, Aug. 13.—(AP)—A dispatch from Mukden to the newspaper Asahi today stated that Chang Shueh-Liang, military Governor of

Mukden, had unconditionally accepted Japan's "advice" that he refrain from placing Manchuria under the domination of the Nanking Nationalists. It was understood in Tokyo that the agreement against which Japan warned Chang gave Nanking control of the Mukden Government's autonomy in domestic affairs.

Vernacular newspapers also printed dispatches from Mukden today telling of a farewell convention between Chang and Baron Consuke Hayashi, who was sent to Mukden to explain officially the views of Premier Tanaka of Japan and to represent Japan at the formal funeral of Chang's father, Marshal Chang Tso-lin, once dictator of Northern China.

Young Chang was reported to have informed the Barco that he had decided to suspend negotiations for a compromise with Nanking because of uncertainty in the Chinese position as exemplified in the Plan of the Koumintang at Nanking.

### THE MODERN MOTHER.

Mother love is not enough. No matter how great it is, it can never teach a mother what to feed her child. In these days it is the function of mother love not only to cherish and serve, but to go in search of knowledge.

From books and doctors the modern mother has learned the health giving properties of sunshine, a vitamin juice. And the new generation of children is growing up with limbs that are straight and bodies that are free and strong.

Science offers knowledge not only of the laws of the child's physical growth, but also of the laws that just as surely determine his character. In recent years progressive schools, laboratories and clinics for maladjusted children have accumulated a body of knowledge by which every mother can guide her child so that his mind and heart will grow as soundly as his body. Hers is the responsibility for developing in him a character adequate and gallant to meet whatever life may bring.

It is the hundred details of the small child's daily life that shape his personality. What is done in the first ten years can never be wholly undone. The child's early tasks, his

eating and sleeping habits, his use of money, his experience in play with others, fix forever the way he will respond to life's responsibilities and the quality of family life he will be able to achieve for himself. We busy mothers find ourselves with scant time for the quiet reading or the lengthy study which would give us the insight we need. Our task is ever present and demands immediate, specific help. Day by day our children's characters are being moulded by many little happenings on which we have no time to meditate. Here daily will appear little pointers for parents gathered from scientific research and the facts of wide experience which it is hoped will give just such definite help as will enable us to build more soundly in our children the basis of lives rich in fulfillment and joy.

## Helping the Homemaker

By LOUISE BENNETT WEAVER (Associated Press Home Editor)

"What shall we serve for dinner?" is the daily cry of twenty million housewives.

"How can I make white sauce free from lumps?" "What tempting pickle recipe shall I choose?" "How shall I remove peach and rust stains from my table linens?"

"What can I cook that will be good served cold for Sunday supper?" "How can I make a moist chocolate cake?"

These are the questions which confront homemakers all over the country and this department will aid those and all others interested in the different well defined phases of homemaking in general.

Seasonable, well balanced menus, tempting economical recipes, household suggestions and "shortcuts" table service and cookery principles will be presented. Other homemaking arts and sciences will be frequently covered.

The material will be written for ready adoption by the mother with growing children, the department housewife, the farm homemaker and the housewife who is employed.

Recently a housewife found herself in a dilemma because her jelly would not stiffen sufficiently to stand when turned out. Through this department she would find that by setting the glasses in a pan of hot water and cooking in a slow

oven for thirty minutes her jelly would stiffen to her liking. The material in this department will be practical because it has been worked out in an average home with children in it. "What shall I do with this cup of sour milk?" There are many excellent cake, cookie, frosting and even fudge recipes, calling for sour milk. These recipes will be given from time to time so that you may clip them and paste in your cook book file.

Of course all the recipes have been tested so that your first trial should produce the desired results.

### Lenex Pepper Hash.

(Delicious for hot or cold meats). 12 red peppers; 12 green peppers; 12 green tomatoes (2 inches diameter); 12 white onions (1 1/2 inches diameter); 5 cups vinegar; 1 cup water; 3 cups sugar; 3 tablespoons salt.

Wash all vegetables. Remove the pulp and seeds from the peppers, the blossom ends of the tomatoes and the outside of the onions. Chop all vegetables and cover with boiling water. Let stand for five minutes. Drain and cover again with boiling water and let stand for ten minutes. Drain thoroughly and add the rest of the ingredients and boil gently for thirty minutes. Stir frequently to prevent scorching. Pour into sterilized jars and seal.

WHAT DOES HOOVER  
OFFER?

First expressions by the  
drys following Mr. Hoover's  
acceptance speech were of  
a jubilant nature, but after  
the din of the oratory had  
died down and they began  
to take stock of what had  
been said, did they find  
themselves any better off  
than before Mr. Hoover  
spoke?

Previously Mr. Hoover  
had characterized prohibi-  
tion as an "experiment that  
must be worked out con-  
structively," and in his ac-  
ceptance address on the sub-  
ject he says:

"Common sense compels  
us to realize that grave  
abuses have occurred—  
abuses which must be reme-  
died. An organized and  
searching investigation of  
fact and causes can alone  
determine the wise method  
of correcting them. Crime  
and disobedience of law  
cannot be permitted to break  
down the Constitution and  
laws of the United States...

"There are those who do  
not believe in the purposes  
of several provisions of the  
Constitution. No one denies  
their right to seek to amend  
it. They are not subject to  
criticism for asserting that  
right."

So far as Mr. Hoover goes  
prohibition is still an experi-  
ment and he does not forbid  
"the organized and search-  
ing investigation" to offer  
modification as the construc-  
tive method of working out  
the "noble experiment."

Not only did Mr. Hoover  
not give the prohibitionists  
a platform on which to stand  
but other phases of his ad-  
dress covering other issues  
of the campaign, in our  
opinion, were even weaker.  
With reference to the ad-  
ministrative scandals the  
country has suffered at the  
hands of the Republicans,  
Mr. Hoover endeavors to  
minimize them by including  
them with state and munici-  
pal maladministrations  
when he said the following:

"In the past years, there  
has been corruption partici-  
pated in by individual offi-  
cers and members of both  
political parties in national,  
state and municipal affairs.  
Too often this corruption has  
been viewed with indiffer-  
ence by a great number of  
our people. It would seem  
unnecessary to state the  
elemental requirement that  
government must inspire  
confidence not only in its  
ability but in its integrity.  
Dishonesty in government,  
whether national, state or  
municipal, is a double  
wrong. It is treason to the  
state."

What we are wondering  
is how Mr. Hoover can stand  
before the American people

and declare that too often  
this thing has been viewed  
with indifference after his  
silence regarding the oil  
scandals. Brought to his at-  
tention shortly after the  
leases had been fraudulently  
and illegally given out, did  
Mr. Hoover, then and there  
declare that such a course  
was wrong and was treason  
to the government? He did  
not. Instead he made a no-  
tation on the bottom of the  
informatory telegram, turned  
it over to Albert B. Fall,  
perpetrator of the oil scan-  
dal frauds, and then kept his  
silence. Was this action on  
Mr. Hoover's part such as to  
inspire the confidence of the  
American people?

No doubt Mr. Hoover's  
actions regarding the oil  
scandals were the same as  
in the case of repudiating  
statements he made regard-  
ing the flood relief and pre-  
vention in the Mississippi  
Valley. "They (no doubt  
the higher-ups of the party)  
told me to do it," was his re-  
ply when asked why a  
changed attitude toward the  
devastated sections.

We do not doubt that  
they told him to do it, and  
it is our opinion that should  
Mr. Hoover go to the White  
House "They" (the Mellons,  
Vares, Insulls and the like),  
will tell him again what to  
do regarding prohibition,  
farm relief, the power de-  
velopment and the like, and  
again he will do it.

On the face of his own  
record and the record of the  
party that he represents, we  
see little that the American  
people can hope for in  
Hoover.

New York (AP)—It was the din-  
gier side streets of lower Manhat-  
tan that saw the passing, some  
years since, of the last of the  
"milkmen's movies."

Into cheaper theaters where the  
films flickered all night and gave  
way to new programs each dawn,  
came not only homeless wanderers,  
glad of a chance to begin and end  
their slumbers by seeing a movie  
show but dwellers in congested  
tenements who preferred spending  
the night in a theater to fighting  
for their share of the family mat-  
ress. The all-night movies van-  
ished, one by one, as exhibitors tired  
of the "dopphouse" audiences and  
found bigger profit in fewer and  
better shows.

At The Stroke of Twelve.  
Now the shows that begin at  
midnight are coming into vogue  
again, but in a greatly different  
guise and in the center of the  
amusement sector.

One of the biggest motion pic-  
ture theaters is giving a show every  
night at twelve, with all the fur-  
belows of the regular performances.  
Another presents a midnight pro-  
gram whenever audiences are run-  
ning close to capacity or when some  
special event keeps the crowds late  
in Times Square. At least one not-  
able motion picture premiere was  
a midnight event, and gained sus-  
ter thereby.

The stage, too, is experimenting  
with midnight shows. Two negro  
revues have launched occasional  
special performances at the hour  
when users usually are looking  
under seats for lost vanity cases  
and forgotten Panamas. The cast  
which revived "Ten Nights In A  
Barroom" capped its burlesque ca-  
pers by presenting that opus in Ro-  
man dress to a twelve o'clock au-  
dience. When Mae West found her  
"Diamond Lil" the summer hit of  
the town she trod the boards a  
time or two in extra presentations  
while the clock struck one, and  
two, and even three.

For The Profession.

The midnight show was inaugu-  
rated, without much fanfare, for  
the benefit of actors whose duties  
kept them from seeing contempo-  
rary diversions at normal hours.  
Some players preferred a midnight  
show to a special matinee, both to  
play and to witness. When Broad-  
way habits, unwilling to go home  
until the last light goes out began  
to clamor for admission, seats were  
put on sale to the public, which  
now drifts in increasing, if not yet  
formidable numbers toward box of-  
fices that are still doing business  
at midnight. It may be a passing  
fad, but at least a few of the  
amusement vendors are convinced  
that midnight shows are, to coin a  
phrase, only in their infancy.

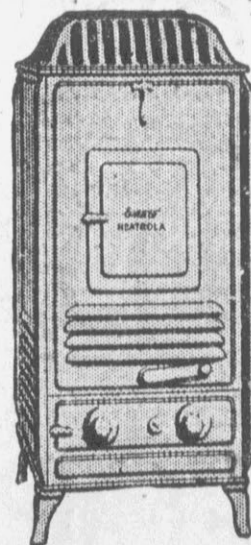

# GIANTS OUT FOR PENNANT IN NATIONAL

A shadow, dark and menacing, hangs over the St. Louis Cardinals and their hopes of another National League pennant.

The shadow is cast by the bulky figure of John J. McGraw and his New York Giants, almost yearly factors in any pennant chase. The Giants now are playing the kind of baseball that wins pennants. If they can keep up their present gait on their swing through the west they should return for their final home stand either leading the League or close enough to the top to make them the most dangerous of contenders.

Rhem was greeted by home runs by Cuyler and Wilson, accounting for three runs in the first inning. The Cardinals were out in the third and finally knocked out of the box with one out in the fourth. Arthur Reinhart took up the burden and gave the Cubs only one hit the rest of the way but the damage had been done. Wilson's homer was his 27th of the season. Pat Malone gave the Cards seven hits, one of them Jim Bottomley's 25th homer of the year. The defeat reduced the Cardinals' lead to two and one-half games.

The Cincinnati Reds clouted three pitchers for 15 hits and romped off with an easy 6 to 3 victory over the Phillies.

Jess Petty slightly outpitched Johnny Cooney and Brooklyn defeated Boston 3 to 1.

Taking advantage of the fact that the Philadelphia Athletics were out at Washington, the New York Yankees added half a game to their American League record by trimming the Boston Red Sox for the fourth time, 8 to 0.

Three runs in the ninth gave Cleveland a 3 to 2 decision over the Detroit Tigers.

Alvin Crowder granted the Chicago White Sox only four hits and the St. Louis Browns won by the shutout route, 7 to 0.

# U. S. TAKES MANY FIRSTS AT OLYMPIC

Amsterdam, Aug. 13.—(AP)—The ninth Olympiad was athletic history today, and Amsterdam, center of the sports world for a fortnight, deserted by the picked athletes of a score of nations.

Fifty thousand packed the olympic stadium yesterday to witness the official closing of the games but not even their cheers when the medals to the winners were awarded, could prevent the affair from coming as somewhat of an anticlimax after the breath-taking thrills of actual competition during the past two weeks.

To the Dutch at least the biggest sensation was the appearance at the stadium of Queen Wilhelmina and the rest of the Royal family, including the Crown Princess Juliana, the Prince Consort, Henry, and the Queen Mother, Emma, Wilhelmina's opposition to Sunday reports is well known and this reversal of position came as a surprise. It was explained that the Queen was interested in military affairs and had come chiefly to watch the final event of the Ninth Olympiad—the Equestrian obstacle jumping competition.

But it was none other than the Queen who awarded the gold medals, significant of first places won during olympic competition. The Prince Consort Henry awarded the silver medals and Count Ballet-Latour the bronze.

Prize winners of all nations lined up in the field and listened while announcement was made as to the number of first, second and third places had been won by each nation. To the United States went the bulk of the honors—22 firsts, 17 seconds and 15 thirds. Left in Amsterdam for the closing ceremonies were 12 girls and 23 men to represent the United States. The others were participating in post-olympic meets in Great Britain, Belgium, France, and Switzerland.

Count Ballet-Latour, as President of the International Olympic Committee, then expressed gratitude to the Queen that the Dutch people and asked "the youth of all lands to meet again four years hence at Los Angeles, there to celebrate the games of the Tenth Olympiad."

The olympic flag was lowered from the pole in the arena and the Ninth Olympiad was over.

# WORLD SERIES SCHEDULED TO OPEN OCT. 3RD

New York, Aug. 13.—(AP)—The world's series, blue ribbon classic of professional baseball, will open on October 3 but just where remains in the hands of the gods.

Under the existing circumstances, however, the first game of the fall series can open only at one of two cities—New York or Philadelphia.

Under the alteration rule, put in to the books by the late Charles H. Ebbets, the series this year will open on the grounds of the club winning the American League championship. The New York Yankees and Connie Mack's Philadelphia Athletics, alone of the field in the American league have a chance of winning the 1928 title. The St. Louis Browns, in third place, are 19 games distant from the league leading Yankees and thus are out of the running.

The schedule of dates, agreed upon last week by officials of clubs concerned in the series, calls for games in the American League park on Wednesday and Thursday, October 3 and 4, with a day for travel before the scene shifts to the National League pennant winner's park if a western team captures the title in John Heydler's circuit. If the championship lies between two eastern clubs the series will continue through without a break, starting with October 3.

The game was well played by both teams, Joliff receiving very good support from his mates. Williams made an unassisted double play. Patterson started two double killings to aid his support.

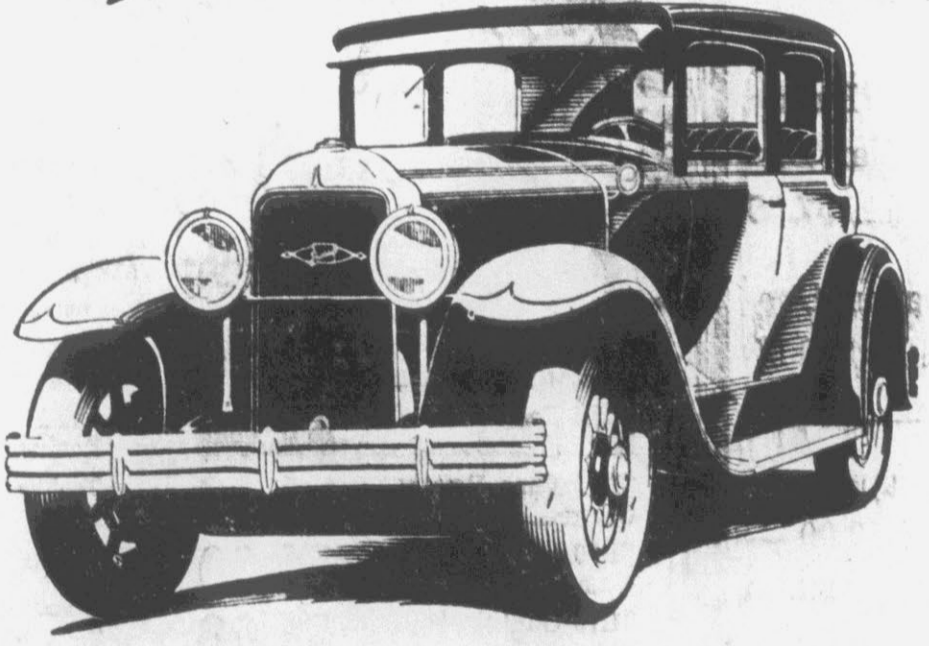

Other eastern Carolina rivers, the Cape Fear, the Tar, and the Neuse, have been very little affected, it was said.

Less Cotton Seed Crushed This Year

Washington, Aug. 13.—(AP)—Cottonseed crushed in the year ending July 31, totalled 4,653,663 tons compared with 6,305,775 for the same period last year, the Census Bureau announced today, and cotton on hand at the mills July 31, totalled 21,781 tons compared with 89,784 tons a year ago.

Cottonseed products manufactured during the period and on hand July 31 included: Crude oil products, 1,476,535,872 pounds compared with 1,887,910,641 last year and on hand 19,456,834 pounds compared with 16,296,641 for the same period last year.

Refined oil products, 1,211,509,019 pounds compared with 1,636,478,187 last year and on hand 335,405,666 pounds compared with 378,612,700 a year ago.

Cake and meal produced 2,093,127 tons compared with 2,940,084 last year and on hand 32,601 tons, compared with 63,632 tons a year ago.

Linters produced 876,498 running bales compared with 1,041,864 and on hand 42,697 compared with 46,177.
