FIND MANGLED BODIES OF TWO LOST AVIATORS

Charred Wreckage of Lindbergh Plane Reveals Fate of Missing Fliers.

Milford, Pa., Aug. 30.—(AP)—The bodies of M. M. Merrill and Edwin M. Roone were found today by Arthur McCarthy, said a telephone message from Pond Eddy. They were said to have been mangled by the plane crash.

The bodies were about six miles from Milford in the heart of an almost impenetrable forest. McCarthy said that the gasoline tank of the plane which the two men were flying from Buffalo to New York had apparently exploded.

McCarthy was one of several score men who had been combing the woods since the wreckage was sighted from an airplane yesterday evening.

New York, Aug. 30.—(AP)—On the highest point of the Pennsylvania Blue Ridge the charred wreckage of Colonel Lindbergh's Falcon plane lay today, and a mountain wilderness surrounded the fate of its two pilots.

In or near the wreckage, however, searchers attempted to find the bodies of M. M. Merrill and Edwin M. Roone, commercial fliers who took off late Monday from Buffalo for Curtiss field, and for whom the greatest aerial search ever made in the country was carried on until their craft was sighted from the skies yesterday.

The wilderness prevented a landing and searching planes traveled to Port Jervis, N. Y. From there some of the airmen returned by automobile to the mountains and began cutting their way through the forests. Darkness descended when they were a few miles from the wreck, and prevented further hunt until today.

J. Nelson Kelly, commercial pilot and pilot of Merrill and Roone, was flying low over the mountains when one of his two observers saw the wreckage of the plane at the end of a wide ridge in some tree-tops on a thickly wooded point in the sparsely settled country along the Pennsylvania-New York line near Port Jervis, 80 miles from New York.

Flying in a formation with Kelly were Charles "Casey" Jones, veteran commercial flier and associate of Merrill at Curtiss field, and Fred Melchior, Junkers chief pilot, in one of the planes of his company. Scores of other craft flew over New York, New Jersey and Pennsylvania during the day in a spectacular search that had enlisted volunteers from commercial air concerns, the army, railroads, and scores of men in automobiles and on foot.

Descending to 150 feet above the tree tops the men in Kelly's plane saw the charred wreckage of the Lindbergh craft and the torn and twisted tree tops which marked the swath the plane had cut as it plunged to the ground.

Jones directed searching operations in the forests, but Kelly, whose plane was damaged in the landing at Port Jervis, returned to New York by train. Here he said he believed Merrill and Roone had crashed into the tree tops while attempting to fly through a fog which hung over that part of the country Monday night.

He said they did not locate bodies, but he had no doubt that both men were dead and their bodies would be found in the plane when the searchers penetrated to the spot.

Plans to Organize Young Democrats of Old North State

Charlotte, N. C., Aug. 30.—(AP)—Troy C. Taylor, Charlotte lawyer and former field secretary of the Alumni Association of the University of North Carolina, who was named last night by State Chairman Odus M. Mull, of Shelby, to organize the young Democrats of North Carolina for the opening campaign, stated today that he would begin at once with Mecklenburg county, and would announce definite plans to that end within a day or two.

Mr. Taylor, who is widely known among the college graduates of the State, stated that he is assured that the overwhelming majority of the young Democrats are in favor of supporting the Democratic ticket, state and national, to the limit, and that his efforts will be for the purpose of making their voting power effective.

While the movement will include specifically the young citizens who have just come of age and will vote first in the next election, he said that the influence of the movement would cover a wider scope, and that he thought that at least 75,000 young voters would cast their ballots under the auspices of the organization.

HOOVER GETS DOWN TO WORK EARLY TODAY

Surprises Office Staff By Descending Upon Headquarters Ahead of Them.

Washington, Aug. 30.—(AP)—Descending upon his new general headquarters at an early morning hour, Herbert Hoover today caught his own staff by surprise and was deep in work when the members arrived at the Greystone Massachusetts Avenue residence.

William J. Donovan, assistant to the Attorney-General and George Darr Baker, of New York, were the first callers at the new office of the Republican Presidential candidate. They accompanied him on his trans-continental trip and are among his closest advisers.

After a conference with them, Mr. Hoover inspected his new quarters and paid telephone linemen all over the place installing instruments while carpenters and scrubbers also were busy.

Hoover's most important engagements today were with William H. Hill, chairman of the New York Hoover-Curtis committee, and H. Edwin Machold, newly named chairman of the New York State Central committee. He wanted to discuss information and get additional organization to assist him in determining policies with the respect to the campaign in the East in which he personally is to participate with at least two addresses, one in New York City and the other in New England, probably at Boston.

KELLOGG IS WELCOMED BY IRISH TODAY

All Classes Join In Hearty Welcome to American Secretary of State.

Dublin, Irish Free State, Aug. 30.—(AP)—All classes in the Free State joined in a hearty welcome to Secretary of State Kellogg when he arrived today for his Irish visit fresh from the memorable signing at Paris of the Kellogg-Briand Renunciation of War Pact.

The enthusiasm broke loose the moment the cruiser Detroit, bearing Secretary Kellogg and his party, steamed into Kingstown harbor. A great crowd which had been gathering on the sea front at Dunlaoghaire for hours cheered the arrival of the chieftain while a salute of 18 guns of the Free State army which had been mounted for the occasion, boomed out.

When the cruiser was first sighted, a small boat containing Vice President Blythe and members of the cabinet accompanied by Frederick A. Sterlin, American Minister, Mrs. Sterling, and Washington Abbott, Secretary of the American Legion, sailed out to meet her. The boat brought back Mr. and Mrs. Kellogg and President Cosgrave who had accompanied them from Paris.

The American Secretary of State and the Free State President landed to the alternate strains of the National anthems of the United States and the soarstat played by an army band.

The reception committee included men of all occupations and parties. The local townships representative welcome and a procession of automobiles then formed for the drive to Dublin. The first car contained Mr. Kellogg, Mr. Sterling and President Cosgrave. The second carried Mrs. Kellogg, Mrs. Sterling and Mrs. Cosgrave, while the third carried Vice-President Blythe, Desmond Fitzgerald, Minister of Defense; John Sullivan, Minister of Education; Patrick MacGilligan, Minister of Industry and Commerce; Patrick Hogan, Minister of Agriculture, and Fitzgerald Kenny, Minister of Justice.

Two Bodies Washed Ashore Reveal Fate of Canadian Plane

Port Townsend, Wash., Aug. 30.—(AP)—The bodies of two passengers washed ashore in Discovery Bay here, today revealed the fate of the seven persons aboard the Canadian Airways tri-motored plane that plunged into the Strait of Juan de Fuca in a dense fog Saturday.

The bodies, wrapped in the wreckage of the plane, were those of Mrs. Alexander MacCallum Scott of London, whose husband, a former member of parliament, also was a passenger, and Floyd Soverel of East Orange, N. J., an official coast guard report said.

Search for the remainder of the bodies and the plane would be continued, the report said.

NEGRO DRAWS TEN YEARS IN MURDER CASE

Several Other Cases Receive Attention of Criminal Term of Superior Court.

Convicted of second degree murder by a jury sitting in the criminal term of Pitt county Superior court in this city yesterday, Frank Diggins, colored man of the Falkland community, was sentenced to ten and not more than fifteen years in the State Prison. He was charged with the murder of W. Wooten, colored, of the same section, in an affray occurring about the 18th of this month.

Several other cases were disposed of in yesterday's session. They included charges of larceny, violation of prohibition laws and others of a minor nature. Although the docket had been cleared of numbers of cases at the expiration of the session indications were that several other cases would not be reached this term. Despite the important cases receiving consideration yesterday, the court officials were able to establish something of a record in the number of cases disposed of and ended the day with eight cases definitely out of their way.

Wilbur Gurganus, young white man of the Farmville community, who has been giving members of the Sheriff's department quite a chase the last few weeks, was sentenced to two years in the State prison on a charge of larceny.

Gurganus was arrested in Raleigh and returned to Greenville the first of the week. He was arrested several weeks ago but escaped from the jail at Farmville, and it is alleged, stole another automobile, and hid off to other sections of the country.

Willie Beard and Raymond Randolph were each sentenced to three years on the county roads on charges of larceny and robbery. Their arrest resulted from the robbery of Bell's store, several miles from this city, in which a considerable amount of goods were taken.

W. J. Anderson, colored, charged with robbery, drew six months' sentence on the county roads.

Amundsen Plane Believed Found In Sea Near Norway

New York, Aug. 30.—(AP)—The finding of a wrecked Latham airplane in the sea near Vesterland, north Norway, was reported today in a cablegram from Oslo to Bergen S. Prentice.

Prentice, who was American chairman of two of Raold Amundsen's expeditions, said he believed the plane was the French craft in which Amundsen and six others were lost in the search for Italy disaster survivors.

The cablegram was sent by Froets Froelands, head of the Oslo newspapers relief expedition for Amundsen. He said the report came from Karstad and that he was investigating.

"The message indicates that the plane fell in the open sea," said Prentice, who was chairman of the American advisory committee of the unsuccessful Amundsen-Bellsworth polar flight of 1925 and the transpolar flight of 1926.

Amundsen and his party disappeared in June while flying across the arctic region to join the forces at King's Bay, Spitzbergen, searching for General Nobile and his men of the Italian polar dirigible.

Moscow, Russia, Aug. 30.—(AP)—With the sun slipping away from the Polar seas, the Russian icebreaker Krassin is hastening its return to Kings Bay so that it may resume the search for lost members of the Noble arctic expedition and the six missing rescuers under Raold Amundsen. The Krassin has been completely refueled and has food sufficient for several months.

Peking, Aug. 30.—(AP)—An anti-foreign military movement led by Communists was reported today from Tainan-fu, seat of the Shantung province provisional government since the Japanese occupied Tsinan.

Official dispatches said troops occupied the American and English mission buildings.

A letter received by the Methodist Episcopal mission here said the Tainan-fu missions were occupied last week by Nationalist troops but the three American mission workers there were not disturbed.

The American legation has received no reports in regard to the movement.

HOT SPRINGS IS PREPARED FOR NOTIFICATION

Uncounted Thousands Throng City Today for Notifying Democratic Candidate.

By WALTER CHAMBLIN (Associated Press Staff Writer) Hot Springs, Ark., Aug. 30.—(AP)—A drizzling rain, similar to that in Albany, N. Y., which forced the notification ceremonies of Governor Smith indoors, began falling this morning upon the early arrivals for the ceremonies incident to the notification of Senator Joe T. Robinson as Democratic Vice Presidential nominee.

The rain gave promise of continuing indefinitely and caused the committee on arrangements to prepare for holding the ceremonies indoors if necessary. Many committee members, however, were optimistic and expressed belief that the skies would clear by 6 p. m., the scheduled time for the program to get underway and that the notification ceremonies could be held outdoors as scheduled.

Should the rain continue, all was in readiness to shift the scene of the notification from the Natural Amphitheatre in front of the Arlington Hotel into the ball room. Immediately after the Smith notification, the Hot Springs committee began preparations for holding the Robinson ceremonies inside if necessary and press wires were in readiness in the ball room, should the program have to be carried out there.

Hot Springs, Ark., Aug. 30.—(AP)—From the four corners of the nation, Democrats were trooping today into this valley in the Ozark Mountains for the formal notification of a southerner, Senator Joe T. Robinson of Arkansas, as his selection as his party's vice Presidential nominee.

"They found a city seduced for the occasion and from nearly everywhere came an exclamation of surprise at the natural beauty of the little amphitheater in which the ceremonies will be held tonight.

The senator, in order to greet personally as many of the visitors as possible, had arranged his program to be up at an early hour and also had disposed of his business so as to have the entire day free to devote himself to welcoming his friends.

All preparations for the ceremonies were completed last night. Before retiring, the senator spent a few minutes testing out the amplifiers which have been installed to carry his voice to the distant corners of the amphitheater and also well up the mountain sides where many are expected to gather.

The decorations of the city was completed two days ago. From every hotel, bath house and office building floated red, white and blue streamers while the street was arched at intervals with banners, among them several bearing the inscription: "Our own Joe, next Vice President."

Mrs. Robinson to whom the senator gives much credit for his political success, also had arranged a program to keep her busy to virtually the notification hour. She was up late last night welcoming many of the first arrivals and finally separated herself from a group of friends in the Arlington lobby with the remark: "I must go see that my husband is in bed."

While the city last night began to fill with visitors most of the early arrivals were from nearby towns and it was not until this morning that John J. Raskob, chairman of the Democratic National committee; Senator Peter G. Gerry, of Rhode Island, a member of the Democratic Advisory committee, and a host of other chieftains were scheduled to arrive.

Included among those to reach this city today was Claude G. Bowers, of New York, the party's key-note at the National convention, and the man selected to notify formally the senator of his selection for second place on the ticket.

Plans Flight From San Francisco to Hong Kong, China

Seattle, Wash., Aug. 30.—(AP)—Lieutenant Lester J. Maitland, army flier, who conquered the Pacific in June, 1927, when he flew from San Francisco to Honolulu, will try to fly from San Francisco to Hong Kong next year if his superior officers consent, he said here today.

"Undoubtedly we'll use a trimotored plane," he said. He expects to fly first to Honolulu, a jump of about 2,500 miles, and then to Manila, a distance of about 5,000 miles, or make a stop at the island of Guam.

# WASHINGTON BYSTANDER

Washington—Acting Secretary Robbins of the war department, back on part time duty while his cracked ribs and collar bone heal up, came within shooting distance of eligibility for membership in that highly exclusive aggregation of aviators, the Caterpillar Club, on the trip during which he suffered damage to the slats.

A little more wind over the Pennsylvania mountains where he took his mid-air spill, and he might have been forced to jump, trusting to a parachute lifeboat. He not only is the only near cabinet officer to have been hung up in an air accident that did not involve a plane crash, but also the only one so far as known ever to have been threatened with the necessity for making a parachute glide for life.

### Flew Into Stern.

Robbins was on his way back to Washington from a long air pilgrimage of inspection and was bucking over the Pennsylvania mountains piloted by Lieutenant Quesada, a noted air corps joystick expert, in a huge tri-motored Fokker transport. The ship had made good altitude for the trans-mountain hop, but not enough to satisfy Quesada, as there were storm centers all about. He circled back to get another 1,000 feet up. Robbins sat beside the pilot in the control cockpit, raised two steps from the floor of the enclosed cabin behind. Just then a local storm in the mountain draws below sent up a few additional twisters. They gripped the ship, setting to reeling and bucking madly. She shivered in the conflicting strains of winds and motors and Quesada had visions of cracked wings and a tumble to the rugged land below with no good landing in sight. He took no chances.

"You'd better step down in the cabin and be prepared to jump, Mr. Secretary," he said to Robbins, fighting to keep the ship in control. Robbins stepped—hastily. It's no pleasing prospect to think of stepping out into thin air six or seven thousand feet up, and trusting to the chute folded into the cumbersome bag on which you are sitting to get you down alive.

In hurrying down through the narrow cabin doorway as the ship reeled and bucked, Robbins caught his foot and crashed to the cabin floor, carrying away struts in his fall, bashing in a rib or two and shattering a collar bone.

### Pilot's Flight.

Quesada had been facing the necessity of abandoning ship in air. With Robbins helpless, he knew that to do so might save his own life via a chute jump, but meant death for the secretary when the abandoned plane crashed. The flier gritted his teeth and hung to his controls, deliberately shutting the door on consideration of his own best chance for safety. He showed the stuff in him then, the stuff that makes fliers. Fighting desperately, he dropped his big ship down to a narrow field, hardly large enough to hold her, and despite the tugging storm winds, eased her to a landing. She brought up safely against a wire fence.

It was a narrow squeak for Robbins, but what of it? The men under him face such dangers smilingly every day as a part of their professional life. You could no more keep the war department civil heads out of army aircraft than you could keep them away from the front in time of war, with the guns pounding around the ears of the army. They will face voluntarily the same dangers that the men under them face whenever chance offers.

### DEMAND INVESTIGATION OF ALABAMA HOSPITAL

Birmingham, Ala., Aug. 30.—(AP)—The demand of the staff of internes for a complete investigation of the county operated Hillman hospital here today pressed the second potential strike at the institution with in 48 hours.

Thirty student nurses walked out of the hospital yesterday protesting against rule restrictions, only to return a few hours later. The hospital was silent, pointing to a victory, but the nurses said they had been promised a lightening of the ban against more than one evening out a week.

The internes, meanwhile, registered their protest over the dismissal of "the good of the hospital," of Dr. D. B. Carr, an interne. Supt. E. P. Hogan, assigned no specific reason, declaring they would resign at noon today unless the county board of revenue decided on an investigation of the present administration of the institution.

Takes Out Aircraft Policy. Asheville, Aug. 30.—(AP)—If an airplane, taking off from the new Asheville-Hendersonville airport, has a mishap and crashes into the grounds of the Calvary Episcopal Church nearby, the church will not suffer monetary loss. An aircraft policy, something new in Asheville insurance, has been written for the church, protecting all its property against damage up to \$20,000, learned today.

Belhaven, Aug. 30.—(AP)—Gaily decorated with flags and bunting, Belhaven today staged the biggest celebration in its history in observance of the opening of the 22-mile Alligator-Pungo river cut in the inland coastal waterway.

Thousands of visitors were present to help the townspeople in the exercises commemorating the completion of the link which brings deep water transportation to this city and surrounding territory and opens an inland waterway from Norfolk to Elizabeth City.

Josephus Daniels, former secretary of the navy and former congressman John Small were the principal speakers at exercises which preceded the mammoth picnic and fish dinner prepared by the townspeople. Mr. Small spoke briefly of the work that led up to the governmental approval of the Pungo river cut and lauded the enterprise of the local citizens in securing the work.

Mr. Daniels predicted a new era of understanding among the cities of Eastern North Carolina and complimented the townspeople on the celebration. Other speakers were Congressman Lindsay Warren, Congressman Charles Abernethy, R. A. Doughton, commissioner of revenue and others.

The picnic and fish fry were spread near the home of Capt. J. A. Wilkinson, whose lawn and porch were used for the speaking and exercises. Two big dirigibles hovered overhead and seaplanes loaned by the government, dived above the crowds to lend a colorful touch to the scene.

### Scarfice Capone Faces Action of Philadelphia Court

Philadelphia, Aug. 30.—(AP)—A grand jury's investigation of bootlegging gangster slayings and quick fortunes in Philadelphia today involved Scarface Al Capone of Chicago.

Capone was named by the prosecutor as an ally of Max "Boo Hoo" Hoff, wealthy sportsman and fight manager, who is charged by the prosecutor with being the leader of an alcohol ring and with directing attempts to intimidate witnesses, remained under subpoena.

Louis R. Elftman, former chauffeur for Hoff, before the grand jury yesterday linked Hoff with the rum ring and asserted that he had been beaten by Sailor Freedman, former Chicago prize fighter, and threatened with death if he testified against his former employer. The warrant has been issued for Freedman's arrest.

Elftman's disclosures, District Attorney John Monaghan said, show that Hoff has a close alliance with the notorious Scarface Al Capone of Chicago, and had been instrumental in bringing to Philadelphia gunmen from Chicago to intimidate witnesses in the investigation.

PUBLIC SCOLDINGS. (By Mrs. Agnes Lyne)

It is admittedly a breach of good manners to make personal and critical remarks in public. Yet often grown-ups who are unfailingly courteous and decently considerate of each other's feelings are heard to criticize loudly and emphatically the poor comings of a child.

This reprimand in the presence of strangers will either humble the child's spirit or render her callous, ready to let future reprimands leave her untouched. Billy's poor school report is commented on in the family circle. Before his brothers and sisters he is singled out and asked to account for himself. He is shamed in their eyes and made to feel a culprit.

## Helping the Homemaker

Dinner Menu  
Browned Veal Creamed Carrots  
Pinwheel Biscuit Butter  
Fruit Salad French Dressing  
Butterscotch Pie Coffee

BROWNED VEAL FOR FOUR (This is good served cold)  
1 pound veal steak, cut 2-3 inch thick; 1 teaspoon salt; 1-4 teaspoon pepper; 1-3 cup flour; 4 tablespoons fat; 2 tablespoons butter.

Wipe off the veal with a damp cloth. Cut in four pieces. Sprinkle with the salt and pepper and roll in the flour. Pat the flour on the meat so it will not come off during the cooking. Place the fat in a frying pan and when hot add the meat and brown on both sides. Add the butter and a lid and cook very slowly for 45 minutes.

This meat may be baked for 50 minutes in moderate oven. If desired, the potatoes may be peeled and baked with the meat instead of being served creamed.

PINWHEEL BISCUIT FOR FOUR (Try these with coffee or tea on a rainy night)  
2 cups flour; 4 teaspoons baking powder; 1-2 teaspoon salt; 3 tablespoons fat; 3-3 cup milk or water.

Mix the flour, baking powder and salt. Cut in the fat with a knife and slowly add the milk until a soft dough forms. Mix with the knife. Place on a floured board or paper and pat out until the dough is 1-4 of an inch thick. Spread with the cinnamon mixture and roll up tightly, like a jelly roll. Cut off one-inch slices and place flat side up in a greased pan. Bake in a moderate oven for 15 minutes.

Cinnamon Mixture  
3 tablespoons soft butter; 1 teaspoon cinnamon; 1-3 cup dark brown sugar.

Mix all the ingredients and press into the soft dough.

Fruit Salad For Four.  
1-2 cup diced pineapple; 1 cup diced peaches, canned; 1-2 cup seeded white cherries.

Mix and chill the ingredients. Drain and place portion in lettuce cups. Add the chilled French dressing and serve.

Butterscotch Pie Filling.  
2-3 cup dark brown sugar; 1-3 cup flour; 1-4 teaspoon salt; 3 egg yolks; 1 cup milk; 1 cup water; 1 teaspoon vanilla.

Blend thoroughly the sugar, flour

and salt. Add the egg yolks, milk and water. Cook for 20 minutes in a double boiler. Stir frequently to prevent lumping. Add the vanilla and pour into a baked pie shell. Cover with meringue.

Tomatoes contain valuable vitamins and should be eaten often. The children should be encouraged to eat them. Heat does not change the vitamins, so canned tomatoes may be eaten with benefit.

machines in Pennsylvania, both as wet as they have been shown to be corrupt. The sad truth is that, with enough exceptions to prove the rule, in the North both Republican and Democratic politicians are wet because they think a majority of the people are wet. Why should dry Democrats denounce Edwards and Raskob and other wet Democrats and get in a wet bed with Edge, Wadsworth and Moses, who called the Volstead Act 'a jackass law?' Would they not, so far as prohibition is concerned, be jumping out of the frying pan into the fire?

"3. The Democrats can neither forget nor condone the corruption of the Republican administration, beginning with the chest fund raised to defeat the League of Nations and appeals to alien influences, and ending last week with the appointment of an Insull intimate to the cabinet. The record throughout has been stained by corruption and favoritism. Of the first, the worst rascals are still out of jail and the second are still receiving bonuses from all consumers. We cannot stomach the Coolidge hostility to Walsh's investigations or Harding's gang of crooks or forgive any man in those cabinets who did not cry out in condemnation.

"4. There is another reason why Southern dry Democrats cannot support Hoover. It is because he is running on a platform that approves Lodge's defeat of the ratification of the League of Nations and promises to stand by that rejection. Most of them followed Wilson in that greatest moral reform of the century. They thought Hoover was sincerely with them. They are pained now to see him the spokesman of the Bitter-Enders and the crowd that broke Wilson's heart and made him the great casualty of the war. That is not now a paramount issue, but Hoover is the only candidate pledged to stay out.

"5. A fifth reason is that the Hoover manager, like all the Slemps and Hitchcocks and other manipulators of Republican politics in the South, resorted to the same (old) method always employed by Republican administrations to get delegates. Traffic in office shames the Southern Republican party and it is inspired and made possible by Republican Federal officials. Southern dry Democrats are of no mind to have any affiliation with Southern Republicanism. They know it and will not affiliate with it, even now that they profess to have sobered up and to have taken the pledge.

"6. Southern dry Democrats know that neither Gov. Smith nor Mr. Hoover could effect any change in the prohibition laws or in the Eighteenth Amendment. One-third of the Congressmen in either house can prevent submission and Southern Democrats and Maine and Kansas Republicans can effectively veto submission. Even if that might miscarry, it requires only thirteen states to effectively kill the proposition of amendment. The South does not even discuss Smith's proposal of the liquor business, because it knows discussion will never reach that place."

In a toast to the guest of honor, Lord Decies called Gene a "great gentleman" and hoped he would have much success in "his chosen field of literature."

The young Marquis of Clydesdale followed with a brief speech and the ex-champion replied with graceful phrases of appreciation.

"I don't know why you make this fuss over me," Gene said. "What is boxing? The ability to coordinate mind and muscle at a critical moment, that is all."

"Yet you receive me with all this acclaim. If I had been a great painter I would have been met by a couple of long-haired men and short-haired women; had I been a famous literary author my welcome would have been left to posterity. He denounced the "killer" type as a menace to boxing, declaring the only joy to be obtained in a fight is by facing a man of physical and intellectual equality.

Nothing that Tunney's dinner jacket failed to hide his shoulder muscles, the Express writer's first impression from the American's appearance was as he puts it in today's edition:

"There was a mountain guide who ought to be something better, a man you would trust your sons to on a camping holiday, a man you would trust your daughter to anywhere."

Gene's speech is described as a triumph of sincerity that carried all before it. The speaker is characterized as "an orator to whom words are mystic."

only qualification was to be a pledge by each member that he would catch the turnstile with his hand and let it finish its quarter-turn softly instead of landing with a crash.

But his proposal brought no diminution of the din. A cynical commentator pointed out that the hypothetical society was foredoomed to failure because most New Yorkers associate noise in some vague way with pleasure, and would become distracted in a city which went its way in perfect quiet or any semblance of it.

It is not so many years since the turnstile succeeded the ticket-choppers. Now, if the subway companies win pleas for a seven-cent fare, all the stiles must be remodeled to respond to a token of a new size. It is estimated that the change will cost hundreds of thousands of dollars, but it seems certain that the turnstiles will not be replaced by the humans they supplanted.

The subways may be noisy and often jammed and uncomfortable, but they have no serious rival in the task of taking New York to work and home again. Not only do

they carry more passengers each year; they carry a growing proportion of all the millions who ride to work.

One of the city's street car companies reckons that it is carrying but 1 passenger this year for every 20 it carried in 1927. The principal bus company reports that the city transit commission that it transported 432,000 fewer persons in the first three months of this year than in the corresponding period of 12-month before. The elevated lines lose business steadily.

Speed is the factor. Bus and trolley lines blame loss of patronage to the growing street congestion which slows them up. Their pace is measured by that of street traffic, and on many avenues they must go as slowly as the slowest of the vehicles with which they share the thoroughfare.

Suburban population gains, and commutation trains find business growing in proportion. But most of the millions ride to work on the subway and depend upon it to get them back to Brooklyn or Washington Heights or the Bronx when day is done.

## STOCK MARKET

New York, Aug. 30.—(AP)—The "bull" market moved ahead at full steam today as call money continued in plentiful supply at the renewal figure of 7 1-2 per cent. Operators for the advance shifted their activities from group to group lifting two score issues to record high levels on gains ranging from 1 to 8 points.

A wave of selling swept through the market before mid-day but offerings were easily absorbed, and the market was headed upward again by early afternoon. Total sales crossed the 3,000,000 share mark before the end of the third hour, but were somewhat smaller than those of yesterday.

The heavy inflow of funds from foreign banks kept the call market steady in the face of unusually large month-end and Labor Day domestic demands for funds. Canadian banks were reported to have dumped \$20,000,000 into the market yesterday, and another large sum today. Some of this money is believed to have originated in Great Britain.

There was little in the day's business news to influence the price movement. Most of the weekly trade and mercantile reviews were cheerful in character, and the bulk of earnings statements published during the day made favorable comparisons with the corresponding period of last year.

The close was strong. Total sales approximated 3,400,000 shares.
