TREASURER OF BAPTIST BOARD STILL MISSING

C. S. Carnes Believed to Have Served Term in Federal Prison at Atlanta.

Atlanta, Aug. 31.—(AP)—B. F. Bates, of the Atlanta federal penitentiary, and a former record clerk said today that photographs of Clinton S. Carnes, missing treasurer of the Baptist Home Mission Board, resembles a C. B. Carnes who served a term for using the mails to defraud in 1916.

Carnes disappeared from Atlanta on August 15th after telephoning his chauffeur that he was going to Raleigh, N. C., on business. Diligent search has failed to produce any information of him since that time, Raleigh reporting he did not keep any engagement he may have had there.

Bates said that the resemblance was marked in the mouth, eyes, ears and the contour of the face. On entering prison the Carnes sent up from Birmingham, gave his age as 37, complexion dark, weight 125 pounds, height 6 feet and one-half inches. He said he had served a five months term in a Clinton, Mo. prison, following conviction in Kansas City federal court of using the mails to defraud.

Prison records here showed that he was discharged, according to his statement, from Clinton prison in the spring of 1913.

Members of the family of the missing treasurer of the Baptist Home Mission Board denied having any knowledge that he was ever behind prison bars.

Atlanta prison records showed that a Carnes was admitted from Birmingham in 1916 for a sentence of 13 months for using the mails to defraud.

Mrs. Carnes, wife of the missing treasurer, was prostrated at the home on Fairview road today and could not be seen. The two sons of the family told friends that they were holding a vigil for their father had been in prison.

Members of the mission board of the Southern Baptist convention, who have been called to meet in Atlanta next Tuesday morning, were astounded at the information.

Dr. Luther R. Christie, president of the board, and other members declared they could hardly believe the report true.

The books of Carnes are now being audited and a report of the audit will be made to the board at its meeting Tuesday.

In real estate circles Carnes was known to have dealt in property on a large scale, most of his negotiations in this field being conducted in the name of the Phoenix Realty Company, under which title he held large property holdings.

According to the latest property returns filed with the city tax department, the real estate held by him in his own name and that of the Phoenix Realty Company was assessed at \$159,885, which is estimated would constitute an actual valuation of nearly \$300,000. In addition to real estate holdings, Carnes' personal property would approximate \$3,000 according to figures on the books of the city tax assessors. His real estate activity was centered largely in commercial property with considerable trading done in Spring street parcels. He maintained offices of the Phoenix Realty Company at 1005 Healey building. These offices adjoin those of the Franklin Mortgage company, of which Carnes was a director and secretary and treasurer at the time of his disappearance.

As a treasurer of the Baptist Home Mission Board, Carnes had a regular office with that of the church board, at 804 Wynne-Claughton building. He apportioned his time between business interests in these offices.

In real estate activities he was regarded as a careful trader. He also speculated in the stock market, but so far as could be learned in Atlanta Thursday these investments were on a small scale in comparison with his financial resources.

Two Critically Injured.

William Francis Griffith, Jr., of Washington, is believed to be suffering from a fractured skull and severe body lacerations. The men had been to a horse show at Warrenton. An undertaker discovered them, Griffith lying in an automobile and Wetherill alongside the road.

DUBLIN MAKES KELLOGG VISIT GREAT AFFAIR

American Secretary of State to Leave for Cherbourg and N. Y. Monday.

Dublin, Aug. 31.—(AP)—Citizens of Dublin are making the stay of Mr. and Mrs. Frank B. Kellogg here a memorable one. The American Secretary of State and party probably will remain in Dublin till Monday, going then in the cruiser Detroit to Cherbourg to take the Leviathan for New York.

The state banquet held in Mr. Kellogg's honor at the Shelburne Hotel last night, was the most remarkable gathering of its kind since the Free State was established. The attendance included every man high in the country's service who was present in Dublin. All were presented to the Secretary and he had a friendly word for each.

Among the guests was the singer John McCormack.

Nearly three thousand guests participated in the reception and ball at the Plaza, Dublin's largest hall, which followed the banquet.

Enthusiastic crowds have greeted the visiting statesman every time he has appeared in public.

Shortly after reaching Dublin from Kingstown, Mr. Kellogg was presented with a scroll printed in the native Irish and in English, giving him the freedom of the city. He then paid a visit to Governor General James McNeill at the Viceroyal Lodge.

President Cosgrave himself issued the invitations to the banquet. The secretary disclaimed credit for the War Renunciation Treaty, signed in Paris this week.

"I did not do it," he said. "I could not have done it. That treaty is an expression of the hopes of millions of people in the world. I cannot believe but that it will have profound moral effect. It springs from the people whose voice is more listened to today than at any other time in the world's history."

Two Hundred Die In Hurricane In Southern Haiti

Port Au Prince, Haiti, Aug. 31.—(AP)—The situation on the southern peninsula of Haiti, devastated by a hurricane August 17, appeared today to be desperate.

Aviators who made a reconnaissance flight over the storm ravaged region reported that they could see little sign of activity.

About 200 persons were killed in the disaster and more than ten thousand were rendered homeless. Crops were destroyed on a large scale.

ALLEN FOUND NOT GUILTY IN POISON CASE

Freed of Alleged Attempt to Poison the Family of Willie Hardee.

Jennings Allen, charged with an attempt to poison Willie Hardee and family, was found not guilty of the charge by a jury sitting in yesterday's session of the criminal term of Pitt County Superior court. Hearing of the case consumed a greater part of the day's session, only two or three other actions getting attention.

The case against Allen had been hanging fire for several months. He was indicted for an alleged attempt to poison Mr. Hardee and members of the family following their severe illness from drinking coffee believed to have contained bichloride of mercury tablets.

Mr. Hardee lingered between life and death for several hours after drinking the coffee and little hope at one time was entertained for his recovery. Hogs to which the remainder of the contents of the coffee pot was fed, are said to have died within a few hours afterwards.

The case attracted widespread interest because of the prominence of the two families of the rural community in which they live several miles from this city, and the court room was packed to capacity while the case was in progress.

Indications today were that court would be continued through tomorrow owing to the number of cases yet on the docket. The grand jury completed work shortly before the noon hour today and awaited dismissal by Judge Nunn following the reading of the report.

It seemed quite probable at the noon hour that the case against K. G. Johnson, Simpson storekeeper, charged with eloping with the wife of Moye Hardee, would come up for trial either this afternoon or tomorrow morning. A true bill was returned against Johnson by the grand jury the first of the week. He was bound over to criminal court following preliminary arraignment here last Friday before Magistrate John Ivey Smith.

Fred Atkinson paid a fine of \$50 and costs of action following conviction on a charge of assault with a deadly weapon by a jury yesterday.

POLICE AFTER LIQUOR RING

Graft Payments Link Philadelphia Authorities to Giant Bootlegging Concern.

Philadelphia, Aug. 31.—(AP)—Records of graft payments in black and white today linked police officers and police officials to a bootlegging ring which is credited with banking \$10,000,000 in seven years.

These records were revealed in the books of Marks, Weinberg & Co., public accountants, seized by District Attorney Monaghan last Wednesday to aid the grand jury in its investigation of gang warfare in Philadelphia.

The district attorney in a statement said: "An investigation of the accounts of the bootlegging concerns whose audits and records were subpoenaed for the grand jury from the offices of a firm of accountants show that these records disclose enormous sums paid to police officers and police officials."

In declining to enlarge upon this statement, the district attorney explained: "Anything additional would tend to weaken our plans for the objective we are seeking."

The investigation, in charge of the district attorney, was begun by the grand jury after the shooting within a week of Hugh McLoon, cafe proprietor, and Daniel Joseph O'Leary, reputed gang leader and at the time of his death sought in connection with the death of McLoon.

A round up of gangsters and men connected with the bootlegging ring was one of the first acts of police who in turn were among the first to be interviewed by the grand jury.

Judge Lewis charged the jury to investigate the criminal conditions of the city, urging them to pay particular attention to the directing heads of the bootlegging ring.

GAINES PAYS FOR DEATH OF HIS DAUGHTER

Walla Walla Man Dies On Gallows for Killing Girl Two Years Ago.

Walla Walla, Wash., Aug. 31.—(AP)—Wallace C. Gaines was hanged at dawn today in the State penitentiary here for the murder of his 22-year-old daughter, Sylvia, in Seattle two years ago.

Gaines went to his death protesting his innocence and unforgiving toward those who had prosecuted him. He walked unaided to the gallows.

Frank Clovak, prison evangelist, who was closed with Gaines for nine hours before the hanging, said he would make a statement as soon as he had recovered from the ordeal.

In a final statement, made public by his wife, Gaines concluded: "I do not forgive the friends who are the cause of taking an innocent man's life, and know that they will be made to suffer for the unjust punishment they have inflicted upon my family. They will pay dearly for this outrage on earth and in the hereafter, for their sins will find them out."

The murder of Miss Gaines, a graduate of Smith College and daughter of Gaines by his first wife, now Mrs. L. E. Maynard of Lynnfield, Mass., occurred here on the night of June 16, 1926.

The girl disappeared from her home about 8 o'clock that night and the next day her mutilated body was found on the shore of Green Lake.

Testimony was offered at Gaines' trial that his daughter had been the object of his "strange, unnatural affections," and that when she attempted to break the relationship, he killed her while she was drunk. Gaines' present wife testified there was nothing unnatural in his affection for the girl.

Guard Killed In Caledonia Jail Breaking

Caledonia Prison Farm, Halifax County, Aug. 31.—(AP)—Searchers were closing in this morning on five white convicts who escaped yesterday afternoon from the state prison farm here after an outbreak in which A. D. Spivey, a guard, was killed. Members of the party sent word to camp that the fugitives had been sighted on the banks of the Roanoke river.

No serious difficulty was anticipated in making the recapture, it was said, as the convicts were believed to be unarmed, they having thrown away the gun used in killing Guard Spivey. The weapon was obtained by overpowering another guard.

Seven men participated in the break for liberty but two were captured before they got off the farm. Dr. J. H. Norman, warden of the state penitentiary at Raleigh, arrived here late yesterday to assist in directing the search. Dr. Norman had the records of the escaped prisoners, according to Capt. N. E. Raines, superintendent of the farm, who said he was unable to name the fugitives until Dr. Norman returned to the prison headquarters from the field.

Poorhouse Head Indicted In S. C.

Anderson, S. C., Aug. 31.—(AP)—W. L. Jackson, Superintendent of the County Home for the poor, his wife and their daughter, Lula Mae Jackson, were arrested last night for alleged irregularities in the affairs of the institution.

They are charged specifically with "breach of trust with fraudulent intent" and are alleged to have purchased merchandise valued at \$10,000 which they charged to the county and appropriated for their own use.

County officers with a search warrant investigated the premises and found silk stockings, shoes, blankets, cut glass and other merchandise which they said had been illegally purchased from local merchants on orders obtained from the disbursing office.

The defendants said the articles purchased were for use of the inmates of the home, but declined to make a further statement.

Robinson Warns Voters To Beware Of Political Serpents Of America

Hot Springs, Ark., Aug. 31.—(AP)—As a full fledged Presidential candidate, Joe T. Robinson of Arkansas, today turned his attention to the arduous campaign ahead.

Ready almost from the moment of his selection by the Houston convention for second place on the Democratic ticket, the senator has awaited only the formal notification of his choice to raise in protest a voice against what he regards as the short comings of eight years of Republican control.

And last night in this valley of the Ozarks where a quarter of a century ago he spoke in his first campaign for Congress, he was told with all the ceremony that a hundred years of tradition has prescribed that the party of Jefferson and Jackson had turned for the first time in recent history to the Southland for a vice presidential candidate and conferred the honor upon him.

This official word of his notification, conveyed by Claude G. Bowers of New York, himself a chief in the councils of Democracy, hardly had ceased to echo up and down between the towering mountain ranges before the senator was on his feet, issuing a challenge to his political foes.

Farm relief, prohibition, merchant marine and political corruption—these are the issues he said upon which the Democratic party must fight out the campaign. And of the four, he cited the farm problem as perhaps the most outstanding.

Prefacing his address with a warning that "numerous political serpents" were abroad seeking to poison the minds of the voters, the senator, without mincing words, reviewed the eight years record of Republicanism in Washington and den of that party's new chieftain.

"Mr. Hoover, as the President's trusted adviser, is perhaps more directly responsible for the failure of farm relief legislation during the eight years referred to than any other single political leader. His present position touching legislation for agricultural relief marks no material advance. In his speech at acceptance it is asserted 'the most urgent economic problem in our nation today is in agriculture. Differences of opinion as to both causes and remedies have retarded the completion of a constructive program of relief.'

"This language expressly recognizes the persistence of the problem and what is more significant, his failure of his party to advance a constructive program of relief."

Then the senator added that although the equalization fee principle was not expressly approved, the Democratic platform did recognize the "principle of distributing the cost of operations with the respect to surplus crops over the marketed units whose products are benefited thereby."

He declared that if a better plan than the fee were discovered it should be adopted, but the time had come "when an economic adventure is justified in behalf of the millions of farmers throughout the nation."

He passed from farm relief to prohibition.

"There has always been room in the Democratic party," he said, "for those who differ as to the best means of promoting temperance and of suppressing the traffic in alcoholic beverages."

The convention recognized that the Democratic party is neither prohibition nor an anti-prohibition organization, but if entrusted with such duty would be to enforce all law.

DUDLEY MADE FOREST FIRE WARDEN HERE

Public Meeting to Be Held at Evans Street School On Thursday Night, Sept. 6th.

The appointment of S. I. Dudley as County Forest Warden for Pitt County is announced by the State Department of Conservation and Development through E. M. Eustles, District Forester in charge of the Fourth District. Mr. Dudley is well fitted to assume the duties of County Forest Warden, in the past having served the county as both sheriff and deputy sheriff for a number of years. He will assume his new duties immediately, beginning at once the organization of a Warden organization throughout the county. Sufficient tools and equipment have been ordered through the State Forest Service and will be placed in the hands of the fire fighting crews as they are organized.

On Thursday night, September 6, a public meeting will be held in the auditorium of the Evans Street School, and all who are interested in forestry and the protection of the forests and of fish and game are invited to attend. Short talks will be made by the District Forester, District Chief Warden, Mr. F. M. Wooten of Greenville, and others. Afterward, the meeting will be conducted as an open conference, the round table discussion being devoted to forest protection, together with the allied subjects of fish and game protection, within the county. During the evening moving pictures will be shown depicting the ravages wrought by forest fires and showing the results of adequate protection. It is desired that all who are interested in conserving the resources of the county attend this meeting, as the subject is one which should appeal to every thinking citizen.

The District Forester states that he is gratified highly at the interest which is being manifested in the Board of County Commissioners have placed the forests of the county under the protection of the State Forest Service. A number of the influential citizens of the city and community are co-operating heartily with the State Forest Service in order that the protection afforded may reach its maximum efficiency.

REBELS PUT TO ROUT BY U. S. MARINES

Managua, Nic., Aug. 31.—Two Sandinistas were killed, one wounded and five captured when the patrol of twelve marines led by Capt. George F. Stokes routed a band of forty rebels near Macuelizo on Tuesday. There were no casualties among the marines.

Details of the engagement have been obtained by marine headquarters here with great difficulty. Since there is on other means of communication, Captain Stokes conveyed the news to airplanes flying low over his encampment, by means of the messages printed on a large panel spread on the ground.

Miguel Angel Ortiz, who led the rebel band, attempted to ambush the marines. The attack took place at 8 p. m. and despite facing a superior force armed with machine guns, Stokes' men routed the assailants and pursued them throughout the night.

COOLIDGE TO LEAVE CEDAR ISLAND SOON

Begin Probe Into Building Collapse At Shelby, N. C.

Shelby, N. C., Aug. 31.—(AP)—With the summation shortly after 11 o'clock this morning of six men to comprise the coroner's jury, the formal investigation of the cause of the collapse of three buildings here Tuesday when six persons were killed, was started.

A deputy sheriff began the summoning under direction of Coroner T. C. Ekridge, whose daughter, Miss Ekridge, was one of the victims of the catastrophe.

It was not believed that the investigation would be concluded before late afternoon, if then, as the news was expected first to view the ruins and then recess until 2 o'clock when contractors, the building owners and others connected with the buildings which caved in, would be queried.

Sherwood Brockwell of the State Insurance Department, is here to attend the investigation. Several hundred people, including many from outside of Shelby, were gathering in the center of town today, apparently waiting announcements by the coroner's jury.

A NEW YORKER AT LARGE

New York—Locating a street in New York is a task to confound even a native. Avenues running lengthwise of Manhattan Island, and many which run in other directions, are numbered from "one" with no regard for whether they start uptown or down. Broadway begins at the Battery. Fourth avenue is the center of Greenwich Village. Fifth avenue at Washington Square and Madison Avenue is the center of the city. Madison Square, where the traveler who starts east across town meets Times Square, intersects Broadway in the 1600's. Sixth avenue is in the 800's. Fifth avenue in the 300's and Madison in the 300's. If an address cannot be identified in the vicinity of Times Square, Grand Central Station, Greenwich Village or some other familiar district, many a stranger finds it simplest first to locate the street he seeks, and then to follow it in either direction until he finds the right number.

Crosstown streets above the vicinity of Washington Square are numbered east and west from Fifth Avenue. Here, too, avenues run north and south and streets east and west. A street running north and south in downtown is a street in whatever direction it runs, and even sections which are not a part of old New York on an occasional course stops suddenly and another begins. Fourth Avenue, for instance, becomes Park Avenue at thirty-fourth street without a break in the width or straightness of the thoroughfare.

Systems With Exceptions.
Riverside Drive starts at Seventy-second street, and the numbering of its apartments begins there just below the eminence from which the \$50-million-dollar mansion of Charles M. Schwab overlooks the Hudson. On the Drive, as elsewhere, it is impossible to deduce from the street number the location of a given address.

But one New Yorker has divined the numbering along the Drive a pattern which those who assigned the numbers probably did not anticipate. Since it begins at Seventy-second street, he takes a tenth of the street number he is hunting and adds it to 72. Thus 310 Riverside Drive—31 and 72 totalling 103—will be found near the intersection of 103rd street; and 480 Riverside Drive can be located at 120th street.

Unfortunately even this system has its limitations. For above Grant's Tomb the Drive crosses a diaduct and there are no more apartments until the farther bank is reached. There the next number appears, as if there had been no gap, and so the formula fails north of 125th street.

Broadway's Baby Brother.
Broadway, of course, is the longest New York street, running the length of Manhattan Island, across the Bronx and on to Yonkers. It is often called the longest single street in the United States, but it isn't. The shortest street in the city is down near where Broadway begins. It is Edgar street, less than 100 feet long.

No Whiskey to Be Had in Nicaragua During Elections

Managua, Nic., Aug. 31.—(AP)—To avert disturbances in connection with the presidential election, sale and possession of distilled liquor will be prohibited throughout Nicaragua during the registration and voting period.

A decree to this effect has been approved by the national election board. The ruling will be enforced by the national military police.

The government has a monopoly of the "aguardiente" or native liquor supply and in previous times this was used freely in buying votes.

The decree provides that all government distilleries and liquor warehouses are to be padlocked Sept. 1 and the keys deposited at the military police headquarters.

Possession of liquor is forbidden between Sept. 17 and Nov. 17 and purchase and sale of all distilled liquors is barred on each of the five registration days and election day and for 24 hours preceding and following each of these periods.

Four Hogs Stolen From Dr. Spence

Dr. E. P. Spence today reported the stealing of four hogs from his place on the outskirts of the city, sometime last night.

"I would give almost anything to bring about the apprehension of these thieves," Dr. Spence declared this morning, telling what he knew about the disappearance of the swine.

So far no clue as to the identity of the thieves had been obtained today, but it was stated that nothing would be left undone to bring them to justice.

BRAVES STOP RAPID MARCH OF YANKEES

The open season on pennant contenders is here again. The last month or so of the baseball season usually is rich in drama for it is then that cellar or near-cellar dwellers delight in knocking the props from under pretenders to baseball's two major crowns.

The Boston Braves, notorious in the last few years for their ability to take the wind out of sails apparently set for a pennant win, were crushed by the New York Giants in three straight games this week in a series that saw most of the fight gone from the clan McGraw just when it needed a few victories to bolster its shattered confidence. The fall of the Cincinnati Reds from the heights they held earlier in the year in the National League dates to a series they played against the last place Phillies. The Reds lost four straight at that time and their play for weeks afterwards was below form.

Yesterday the Philadelphia Athletics and the New York Yankees, fighting a two club battle for the American League pennant, were cut down by foes they should defeat with little trouble, the Yanks bowing to the Washington Senators and the A's to the last place Boston Red Sox. These reverses left the A's two and a half games back of the defending champions.

"Sad Sam" Jones, who once did his pitching chores for Miller Huggins, was the immediate cause of the Yankees' defeat at Washington. Sam allowed the champions seven hits, won his game, 3 to 1, and would have had a shutout had not George Herman Ruth took a lead off home run in the seventh inning.

At Philadelphia the A's were forced to accept a 3 to 2 reverse by the Red Sox.

Detroit took the final game of the season from the Cleveland Indians, 5 to 3, clubbing Willis Hudlin for three runs in the first inning.

The National League's crucial series between the St. Louis Cardinals, the leaders, and the Pittsburgh Pirates, one of the many contenders, developed into a fizzle temporarily for rain halted the clash after the first inning had been played. The Cards were leading then, 2 to 0.

The Chicago Cubs took undisputed possession of second place and advanced to within five games of the Cardinals by downing the Cincinnati Reds, 2 to 0, in a battle ended by rain at the end of six innings of play.

The Braves kept up their winning streak by defeating the Phils, 6 to 5. During the day, Judge Emil Fuchs, president of the Braves, announced that Rogers Hornsby had signed a contract to manage Boston for the next six years.

Pirates And Bugs Drop Back A Step

Both Goldsboro and Wilmington kept in step in a backward march yesterday, after dropping games to their opponents, leaving the Goldbugs still clinging to the Eastern Carolina leadership. The Pirates are only a few notches behind in the percentage column with final games in the league to be played next Monday afternoon.

Fayetteville defeated the Bugs 4 to 3 in the ninth, after Young, Hubert and Benedict singled in succession with none out. The score was knotted at the close of every stanza except the first and ninth.

Speed balls of the Tobaccoists' hurling staff, Allen, were unsolved by the Pirates and played a large part in the 3 to 0 victory chalked up by Greenville. Not only did Allen prove himself the most of the situation from the box, but in the sixth with Bailey on the paths drove the sphere over center garden fence to register the last two tallies of the game.

Kinston was enabled to reduce Rocky Mount to a 5 to 3 defeat by opportune hitting, coupled with airtight pitching and brilliant fielding. The Stemmers took an early lead and maintained it with ease throughout the mixup.

Cardinals, Kan. (AP)—If the St. Louis Cardinals fail to win the National League pennant, it won't be Milt Simpson's fault.

For Milt, the Iola blacksmith who played first base for Springfield, Mo., in the old Southwestern league 40 years ago, has done his duty by supplying Branch Rickey with a nice, new shiny horseshoe.

Milt had sent the Cardinals one of these tokens of good luck in 1926, just to help em along in the scrap for the flag, and they won the world series to boot.

Rickey was grateful, sending the benevolent blacksmith a ticket to the series. Simpson was too busy repairing automobile axles, tuning up farm tractors and shoeing the occasional horse to see the 1926 classic, but the charm stayed with the horseshoe despite his forgetfulness.

This year when the New York Giants got on top of the Cardinals, the owner of the St. Louis club locked to Iola for a change of luck.

"Why in thunder don't you send us an' other horseshoe?" said a telegram from Branch Rickey to Milt Simpson.

Milt waited until the moon was right and then hammered out a shoe, polished it and wrapped it so the ends pointed up when the postman handed it to Rickey.

Two days later the Cardinals were ahead.

Simpson gave his first horseshoe to the baseball world in 1919, when he favored the Chicago White Sox with the gift and luck favored them with the American league pennant.

In 1923 he sent an iron charm to the Kansas City Blues and they became the champions in the American association.

Four years ago the Washington Senators rode to victory in the world's series after Simpson had shod them. The Pittsburgh Pirates nailed his horseshoe to their mast in 1925 and soon afterward they loaded the richest treasure of baseball on board the Buccaneer boat.

Last year Simpson bestowed his favor on the Chicago Cubs. Much to his chagrin, they finished in fourth place. Milt consulted the almanac and discovered he had made the horseshoe in the dark of the moon.

So he was careful about the lunar influence when he stirred the coals in his forge to warm up the Cards in the National league race of 1928.

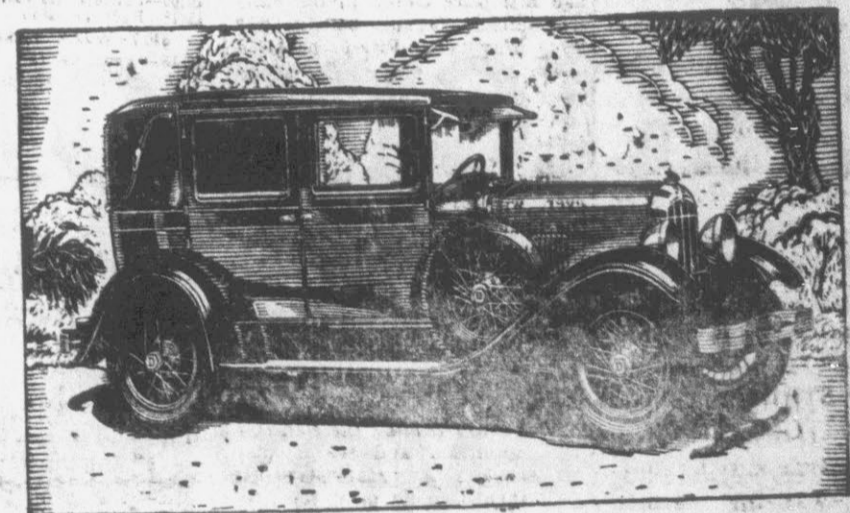

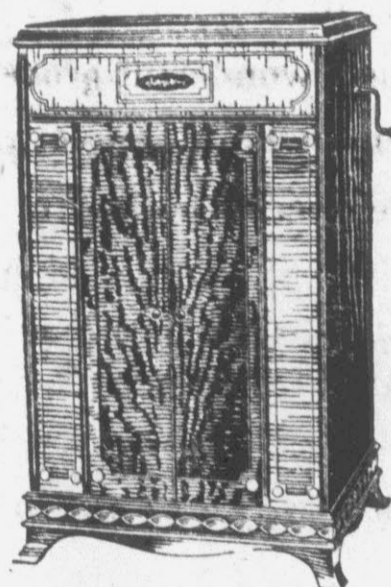

Surveys East Carolina Tobacco Crop Situation

O. L. Joyner Writes of Conditions Confronting Tobacco Growers.

(By O. L. JOYNER.)

The tobacco farmers of eastern North Carolina are looking forward to the opening of the markets this year with more serious concern and anxiety than they have in many years. This crop of tobacco has cost the farmers more to make it than any crop produced since 1920. The principle item in the additional cost of this year's production is the labor required to save it. There is no doubt but that the acreage was increased to a considerable extent throughout the entire eastern belt, but it is doubtful if there will be any more tobacco sold on the bright markets this year than last. Is it not possible for the farmers to learn a valuable lesson from this fact? Based on a pretty close observation of conditions throughout the entire belt, in my opinion, the farmers have raised a crop of tobacco at a labor cost alone of at least 25 per cent more than it cost to produce and house the 1927 crop due to the fact that the labor had to be secured elsewhere than on the farms where it was employed, and even at this there was not near enough to save the crop. As a result, literally and actually, millions of pounds burned up in the field and went to waste. If preparations for a crop had been made based on the supply of labor on the farm, eastern North Carolina would have sold this year just as many, and probably more pounds than they have saved, it would have been better tobacco and brought more money at a saving in the labor item alone of hundreds of thousands of dollars. I repeat, therefore, will not farmers pause and learn a lesson from this year's experience and in planting next year's crop, not rely on outside labor to harvest it?

I do not believe this crop of tobacco which has just been saved (I mean saved, and not grown), in eastern North Carolina is large enough to make prices any lower, and possibly not as low as the 1927 crop. It will require some little time for the buying interest to find out this fact. I am aware also that the above statement will no doubt sound startling to a great many, especially in view of the prices that have prevailed on the southern markets this season. The prices at which the South Carolina and Georgia tobacco has sold should

not prove an important factor in influencing the prices at which eastern North Carolina tobacco should sell. By every right of justice and equity eastern North Carolina tobacco should bring from five to eight cents a pound more than tobacco in the territory where the tobacco is not graded and sold almost immediately after curing, and where tobacco barns and storage houses are not required.

In making the statement that I do not believe that this crop of tobacco is large enough to cause a price level lower than the 1927 average I base the statement on the law of supply and demand. While admittedly the farmers made preparations to increase the 1928 crop, probably 20 per cent, throughout the eastern belt, the largest increase was in the new bright sections of the North and South of the main eastern territory of which Wilson, Pitt, Lenoir, Beaufort and Greene counties are the center, and it was in these outlying counties where the farmers were not well prepared to care for the crop that the greatest loss occurred. Knowing a great many of the men who are largely interested in buying our tobacco, I state it as a sincere conviction, I believe if the buying interests had reasonable assurance that the tobacco crop would not be increased beyond the limit of or within reasonable bounds of the increase in consumption of the manufactured products they would as a matter of choice, prefer and would pay the farmers a profit on their crop. In conclusion I again assert my belief and conviction that the 1928 crop of tobacco will sell for as much or more than the 1927 crop because I believe before very much of this crop is sold it will become apparent that the crop is not a large one.

Stinnes broke down and is reported to have admitted he knew about the secretary's manipulations which consisted in buying up war loan bonds and pretending they were in his possession since before the inflated period.

Wheat closed firm, 1-4 to 3-4c up, and corn firm at 1-2 to 1 1-2c advance, September gaining the greater margin. Oats were unchanged to 3-8c higher and provisions irregular, lard down 7c to 15c ribs unchanged to 12 lower and bellies unchanged.

STOCK MARKET

New York, Aug. 31.—(AP)—Stock prices made further recovery today as large scale pool operations were resumed in a wide assortment of industrials, rails and specialties. More than two score issues were lifted to new high records. Extreme gains ran from 1 to 15 points, with trading so heavy that the ticker again fell more than 20 minutes behind the market.

Call money renewed unchanged at 7 1-2 per cent. Banks called \$40,000,000 in loans by early afternoon to meet the heavy month-end and Labor Day currency demands. Time money held firm at 6 1-2 per cent. The buying rate on bankers' acceptances was reduced 1-8 of 1 per cent on all maturities.

High-priced specialties were whirled upward at a dizzy pace, many of them at the expense of an over-crowded short interest. Federal mining & Smelting soared 14 points, International Nickel 9, Continental Canadian 7 and Radio, Johns Manville and Montgomery Ward 6 points each. Scores of others were lifted 2 to 5 points. One block of 10,000 shares of General Motors changed hands at 198, involving an outlay of nearly \$2,000,000.

The rise received its chief impetus from the unexpectedly small increase of \$34,000,000 in brokers' loans coming on top of a spectacular advance in stock prices. Oscillation of additional bond syndicates and the heavy inflow of funds from Canadian banks, whose loans do not figure in the Federal Reserve brokers' loans reports, were held responsible for the small gain in borrowings. Wall Street is looking for temporarily easier call money after the turn of the month, and a general slackening in rates in October when the crop financing is out of the way.

Rails took a more prominent part in the advance today. Missouri Pacific common ran up 2 points to a new top at 74 1-2. St. Louis Southwestern climbed 3 to 5, and St. Paul preferred and Rock Island also bettered their previous 1923 high prices; New York Central was bid up 3 1-2 points.

Renewed selling of Loft Candy, based on unconfirmed reports of a stock exchange investigation of recent fluctuations in that issue, sent the stock down about 5 points to 9 1-2, as against a high of 19 3-8 on Monday.

The closing was strong. Total sales approximated \$1,000,000.

Chicago Police Declared Rotten

Chicago, Aug. 31.—(AP)—The April primary election campaign, launched by bombs, accelerated by violence and capped by murder, had left an ugly smear across the Chicago police department today.

The special grand jury, besides indicting 14 persons for crimes that grew out of the campaign, returned a report which described the police department as "rotten to the core." Frank J. Loesch, representing the Attorney-General in the grand jury investigation, explained that the reference was not to the department as now constituted, but as it was under the regime of Commissioner "Go Get 'Em" Michael Hughes, who resigned several weeks ago.

"From the testimony heard and the evidence presented," the grand jury report said, "the utter disregard for the fulfillment of their duties by the police department is appalling, and there is no question in the minds of the members of this jury that the police department is rotten to the core."

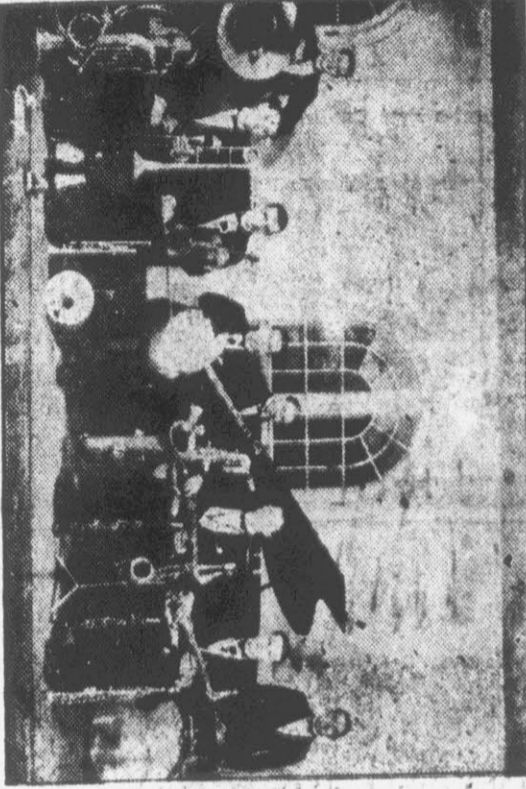

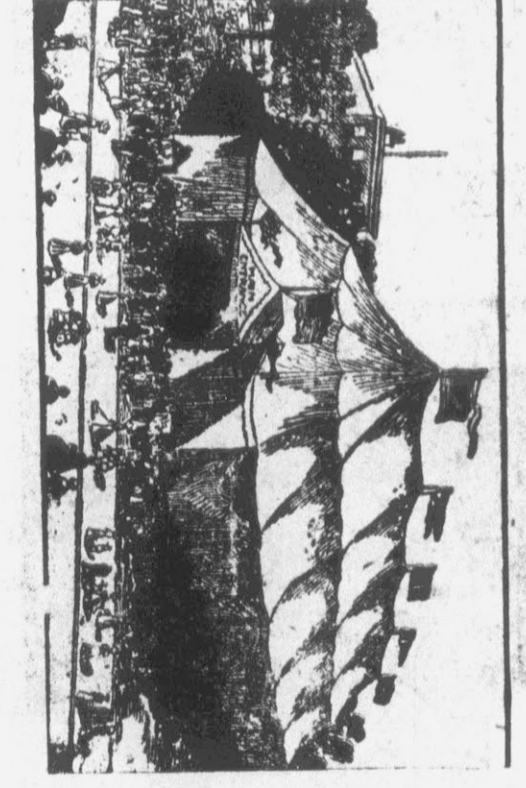
