ROCKFORD FLIERS SAFE IN GREENLAND

Greenville Tobacco Market To Open Tomorrow Morning

Bert Hassell And Cramer Picked Up By Expedition Few Miles Of Mt. Evans

Illinois Airmen, Lost On Second Leg Of Projected Flight To Sweden, Were Making Their Way Over Wastes To Safety; Forced Down By Fuel Shortage.

New York, Sept. 3.—(AP)—Missing two weeks in the Arctic, Bert Hassell and Barker Cramer, American fliers, were safe today at Mount Evans, Greenland, the second stop on their projected flight from Rockford, Ill., to Stockholm, Sweden.

While the world was becoming convinced that they had suffered the fate of other aviators who perished during the Atlantic, they were making their way over a 50-mile stretch of icy Greenland waste.

Word of the rescue came to the New York Times via its radio station in a dispatch from Professor W. H. Hobbs, leader of the University of Michigan Greenland expedition. Members of the expedition which has a base at Mount Evans, brought the airmen to safety yesterday after picking them up in the icy wastes, a short distance from the base.

The fliers were uninjured. Although hungry, having lived on a ration of eight ounces of pemmican a day, they were stated to be in excellent condition.

Storage of gasoline forced the airmen down on the ice arm of Foul Sukkertoppen on August 19. Point Sukkertoppen is a headland on the southwest coast of Greenland about 50 miles southwest of Mt. Evans at the base of which the Hobbs' expedition had prepared a landing field for the airmen.

The plane was not damaged. For two weeks the airmen traveled over the icy surface and through wild and unexplored country hoping to reach safety. A smoke signal they sent up brought members of the expedition in a motor boat to their rescue as they wandered over the wastes. They were taken across a fjord to Camp Lloyd three miles from the radio station at Mount Evans.

Apparently Hassell and Cramer had been forced off their course by adverse winds when they attempted to fly from Cochrane, Ontario, to Mount Evans, a distance of 1,600 miles, on the second leg of their flight.

Hopping off from Cochrane in their monoplane Greater Rockford, No. 1212 p. m. (E. S. T.) on August 19, the airmen were sighted over Wisconsin about 200 miles south of Point Sukkertoppen at 10:30 a. m. the next morning.

News of the fliers' safety came a day after another mystery of Arctic flying had apparently been cleared up by the finding of one of the floats of the missing seaplane in which Roald Amundsen and five companions had gone to the rescue of the ill-fated Italia expedition. The float was found off the Fugloe Island near Tromsø, Norway, from which point Amundsen had started on June 18. With its finding the slim hope that Amundsen and his companions were still alive faded.

A hint that another Arctic mystery might be cleared up was seen in an Associated Press dispatch from Copenhagen today. It said a vessel from Tromsø, Norway, was that the Jopetter, a hunting vessel of Alesund, Norway, saw a fire on Stone Foreland, the eastern extremity of Edge Island, a fortnight ago. Edge Island is the southeast member of the Spitzbergen archipelago.

The crew believed the fire was connected with the missing group of the dirigible Italia. Six men were carried off to the east in the balloon part of the dirigible after it crashed on the ice north of Northeast-Land on May 25. They have not been heard of since. It appeared probable that the balloon might have carried them toward the point at which the fire was seen.

Many Hurt In Accident N. Y. Train

Scores Faint And Are Overcome by Smoke When Subway Train Stalls.

New York, Sept. 3.—(AP)—Scores of passengers were overcome by smoke and several others faint and were trampled in a panic when an interborough subway train stalled and filled with smoke from a short-circuited third rail while passing under the East River viaduct yesterday afternoon. It was the third accident of the interborough system in ten days.

Forty three of those affected were treated at hospitals. Others were given emergency treatment on the scene.

The train was nearing the end of the East River tunnel from Manhattan to Queens when dense smoke billowed from the first car. Passengers, still mindful of the recent wreck at Times Square when 18 persons were killed, stampeded for the door to the second car.

Women screamed, some of them fainted, and the door was jammed before many had passed through. Those left in the front car were choked by the smoke.

Word of the trouble reached the street as the first passengers escaped through an emergency exit. Police reserves and subway employees led those still underground to a station in queens.

Five or six women who had fainted were carried to the street by police.

Investigation disclosed that a contact shoe on the fourth car of the five car train had broken and ripped the wooden shield off the third rail, causing the short circuit.

The other accident on the interborough occurred early Saturday morning when a work train jumped the rails at a curve and side-swiped a loaded passenger train. Several were injured, none seriously.

Darrow Declares Musicians Have Right To Strike

Chicago, Sept. 3.—(AP)—Musicians in 300 outlying moving picture theatres had the word of Clarence Darrow, famous for his defense of Leo-Loeppold and Darwinism, that they were at liberty to quit work today, a federal injunction obtained by theater owner notwithstanding.

"Courts," Darrow said in an opinion prepared for the Chicago federations of musicians, "have no authority to compel anyone to work against his will in the absence of a satisfactory contract of employment."

James Petrillo, president of the Musicians' Union, issued no strike call, but he directed the attention of union members to the Darrow opinion. He issued a statement after a lengthy conference with other officers of the union and attorneys.

The temporary restraining order, issued last week by Federal Judge Wilkerson on petition of theatre owners, would restrict the musicians from "leaving or threatening to leave the employment of said complainant, either by way of strike or otherwise, unless with the consent of said complainant, for the purpose of forcing or coercing said complainant to agree to, acquiesce in or comply with said demands or any of them."

Johnson Has 4 Years In State Prison

Simpson Storekeeper Files Notice Of Appeal To Supreme Court In Elopement Case.

Convicted of eloping with Mrs. Alva Lee Hardee, wife of a Simpson farmer, K. G. Johnson, storekeeper of the same community, was sentenced to four years in state's prison by Judge R. A. Nunn, of New Bern, who presided over the closing sessions of the criminal term of Pitt county Superior court in this city Saturday night. Immediately after sentence had been pronounced, attorneys for the defendant filed notice of appeal to Supreme court under bond of \$2,500. Bail had not been provided at the noon hour today and Johnson was still in jail here.

One other case was disposed of during Saturday's session, that being the charge of larceny against Will Eaton, colored. He was sentenced to six months on the roads. Decision in the Johnson case was returned about nine o'clock Saturday night, after which court was adjourned until next term.

The case against Johnson grew out of a trip which he and Mrs. Hardee made to Chattanooga, Tenn., and which resulted in their being returned to this city in the custody of county authorities. He was given a preliminary hearing Saturday a week ago before Magistrate John Ivey Smith, and bound over to the criminal term of court under bond of \$2,500.

At the preliminary arraignment, Mrs. Hardee, under direct questioning of prosecuting attorneys, confessed to going to beaches and other public places in the company with Johnson, finally winding up about a month ago in an apartment in Chattanooga, Tenn. While there, she said they lived as man and wife.

She told the court that the reason she ran away with Johnson was because he told her that her husband was sub-normal and not competent to provide for her. She told the intimate relations existing between Johnson's wife and herself prior to the trip that resulted in their arrest and detention by the Tennessee officials.

The testimony of Sheriff Whitehurst, who went to Tennessee to bring the couple back, corroborated some of that of the woman, in that he found them living together as man and wife, and that examination of the apartment indicated that they had been existing under such a relationship.

The case attracted more than ordinary attention because of the prominence of the two families in the Simpson community. Johnson is a married man of family. Mrs. Hardee is a young married woman, the wife of Morye Hardee, well known farmer of that section.

Raleigh Stages Labor Day Event

Raleigh, Sept. 3.—(AP)—Rain today threatened to throw a damper on the Raleigh Labor Council's plans for an outdoor celebration of Labor Day, but leaders had made arrangements to hold their meeting and barbecue indoors in the event the weather did not clear.

George W. Marshall, international organizer of machinists, was the principal speaker on the labor program, although Josephus Daniels, Raleigh editor; J. W. Bunn, president of the Chamber of Commerce; and Frank E. Thompson, president of the Merchants' Association, also were scheduled to make brief addresses. Representatives of organized labor from Durham, Greensboro and other nearby cities were here for the day's celebration. State government offices were closed.

GEORGIA TOBACCO AVERAGES OVER NINE CENTS

Atlanta, Sept. 3.—(AP)—Georgia tobacco market sold 10,275,948 pounds of tobacco during the week at an average price of 9 1/8 cents per pound. The total value of the weekly sales was \$982,673.19. The figures include sales from all except two warehouses, one in Camilla and another in Hazlehurst.

Five Killed In Crash Of Al Smith To Carry Facts An Airplane On His Tour

French Minister Of Commerce and Four Others Victim Of Wreck Near Toul.

Paris, Sept. 3.—(AP)—A sudden nose dive of an airplane and its crash in flames had robbed France of her youngest cabinet member, Maurice Bokanowski, minister of commerce and aviation.

Four others, Gabriel Hanin, pilot; Jean Vidal, mechanic; Henri Wilkins, radio operator; and Edouard Lefranc, general secretary of an airplane company, also perished in the crash near Toul.

Just previous to boarding the plane, Bokanowski while chatting with General du Perray and Capt. Houbert said, "Newspapermen insinuate that I never fly, that I take all possible precautions even when I approach a plane standing still. You see," he continued as he jumped into the cabin of the plane, "an airplane trip has no terrors for me." Five minutes later he was dead.

Bokanowski spent Saturday at the country house of Premier Poincare at Compiègne where he attended an informal meeting of the cabinet, celebrating the Premier's 68th birthday and also the second anniversary of the formation of the National Union Cabinet. Sunday morning he went to an aviation field 25 miles away and took his place in a plane ordered from Le Bourget.

The machine, a Spad biplane, took off laboriously with its motor coughing. It rapidly gained altitude and headed for Clermont-Ferrand where Bokanowski was to attend an aviation festival. Captain Houbert, who was escorting the minister's plane in a military machine noted the Spad suddenly veer to the right when about 1,500 feet aloft and go into a nosedive.

It took two hours to extricate the bodies from the wreckage and Bokanowski was identified only by a platinum watch which he was known to carry.

Premier Poincare is expected to decree that the minister died "in the performance of ministerial duty."

Labor Day Is Observed By Herb Hoover

Republican Candidate Drops Work And Spends Day With His Family.

By JAMES L. WEST (Associated Press Staff Writer) Washington, Sept. 3.—(AP)—Like almost everyone else, Herbert Hoover today observed Labor Day by abstaining from work with the intention of spending the holiday very quietly with his family and a few friends at home.

The week-end let-up in his drive for the presidency gave the Republican candidate opportunity to review the work thus far done and to study some of the suggestions which came to him in his recent conferences with party leaders from various sections of the country.

Before leaving Wednesday or Thursday for several days of fishing on Chesapeake Bay, Hoover will meet with a number of those entrusted with carrying a major share of the burden of national campaign speaking and will give his personal attention to an accumulation of mail.

Among those who are to call at the nominee's headquarters is Senator Borah, of Idaho, who is to begin his speaking tour at Detroit later in the month, after Hoover himself has invaded the east for the delivery of his first address in that section.

Borah was among the first of the first outstanding figures in the party not previously committed to declare for the nomination of Hoover at Kansas City, and it was he who with his celebrated questionnaire drew a public expression from the party standard bearer on the prohibition question in the pre-convention days.

The Idaho Senator ranked among the leading independents in the Senate, has made no engagement beyond that at Detroit on September 19, but he said today he would speak in both the East and the West.

"I am going to see Mr. Hoover, while I am here," he said, "but I shall personally arrange my speaking itinerary." Asked if he would talk about prohibition in the East, Borah said he most assuredly would. He also will discuss farm relief and other issues.

Silk Merchant Shot To Death

New York, Sept. 3.—(AP)—Chas. K. Eagle, wealthy silk merchant and sportsman, was found "dead yesterday with a bullet wound in his left temple in the gymnasium of his beautiful Penthouse villa on the roof of an upper west side apartment house he owned and had built. Police said he had committed suicide.

Beside the body lay a double barreled rifle which folded and could be used like a revolver. From his physician it was learned that he had been suffering from insomnia for several weeks, and police believed the long protracted illness of his wife also might have been a contributory cause of his suicide. Mr. Eagle had suffered no financial reverses so far as could be established today.

Mrs. Eagle told police she last saw her husband alive Saturday night when he went into her room to say good night. She said he told her not to worry about her own condition and gave no indication that he was troubled about his own life. His body was found by Mrs. Eagle's nurse who sought him when he failed to appear for breakfast.

ACTRESS HAS SEVERAL POUNDS OF FLESH REMOVED

Los Angeles, Sept. 3.—(AP)—Molly O'Day, screen actress, was resting in a hospital today after an operation to remove several pounds of flesh from her hips and legs.

The actress said her excessive weight had been the cause of her illness while under contract last year. She resorted to the operation after other methods of reducing failed, she said.

Liquor Ring Controlled By Iron Hand

Story Of "Czar" Of Underworld Related By Grand Jury Witness At Philadelphia

Philadelphia, Sept. 3.—(AP)—A "Czar" who rules his "subjects" with an iron hand has been at the head of the Philadelphia rum ring. As described by John Monaghan, in the "Court of Justice" set up by the bootleggers, the Czar settled all disputes among the rum runners, fixed prices, collected all money to pay for liquor-bearing trucks, breweries, whisky plants and speakeasies. Offenders, if not slain, were "framed" and sent to prison on manufactured evidence.

Monaghan promises more startling disclosures when the grand jury investigating underworld activities resumes its inquiry tomorrow.

The prosecutor stated that he had received a complete report of the Rancocas Creek case of 1925, in which liquor valued at \$500,000 belonging to the Philadelphia rum ring, was seized by New Jersey state police when they raided a barge in Rancocas Creek, Burlington county, N. J.

They arrested 55 men, many of whom gave fictitious names and disappeared the next day when a "big pay-off man" from Philadelphia provided cash bail for all those taken into custody. The eight finally brought to trial were acquitted.

Governor McLean Back In Raleigh After Vacation

Raleigh, N. C., Sept. 3.—(AP)—Governor Angus W. McLean was back in the capital today to take up his executive duties, after a two months' vacation in the Lake country of Northern Wisconsin.

The Governor had no statement to make in regard to politics, although he came by way of New York where he conferred briefly with National Democratic leaders, and last night he talked with Cameron Morrison, recently elected National Committeeman. He said his services would be placed at the disposal of the State Executive Committee after he disposes of accumulated executive business. His vacation put him in good physical condition for a strenuous campaign; he added.

FARRELL MUST DO SOME REAL PLAYING

Chicago, Sept. 3.—(AP)—To defeat Walter Hagen, British champion, three straight matches over 36 holes is a seemingly impossible task, but Johnny Farrell of New York, American open titleholder, must do it to win the mythical "world's golf championship."

Sir Walter made it two matches to nothing in their championship series Saturday when he stroked the 6,452 yard Ridgemoor country club course in three under par to beat Farrell 5 and 3.

In the first match at Detroit last week, Hagen won one up.

PLANE BRINGS MAIL FROM STEAMSHIP

Halifax, N. S., Sept. 3.—(AP)—A seaplane enroute to Boston bearing mail from the French liner Ile de France was catapulted from the steamer off Cape Race about two o'clock this morning and arrived here to refuel at 8:40, local time. The mail was expected to reach New York two full days ahead of the ship.

Although Heavy Sales Are Anticipated, Break Is Not Expected To Be As Large As Opening Days Of Last Three Years; Nine Warehouses Open For Business.

With tobacco pouring into the city from many sections of the country, the Greenville tobacco market today was in readiness for the opening of the 1928-29 season tomorrow morning. The buyers of the large manufacturing concerns began their annual pilgrimage to the city the latter part of last week, and when the curtain rises on the new season tomorrow a large corps of representatives of the great industry will follow the auctioneers down the countless rows of tobacco, playing their part in the opening day's activities.

Sales will begin promptly at nine o'clock at the following warehouses: Gorman's, Farmers, Star and Forbes & Morton.

Indications today were that the opening would not be as large as opening days the last two or three years. Farmers are believed to be watching the market before rushing their crop for sale.

The goal set by the Greenville market this season is seventy million pounds. The market last year sold over sixty-one million pounds. With nine warehouses, covering a total floor space of ten acres, and capable of handling around a million, seven hundred thousand pounds of leaf daily, tobaccoists were optimistic on the eve of the opening day for realization of the ambition to reach the seventy million pound goal.

As customary, tobacco town has taken on an appearance of extreme activity. Today and tonight will witness the arrival of hundreds of loads of tobacco, accompanied by the annual pilgrimages of countless thousands of people who will through the floors to see the mammoth industry get away to its first start. Numberless hot dog stands and refreshment joints have sprung into existence along the street leading to the warehouses, and none will go hungry or thirsty who bring along with them the price of a square meal.

The Greenville tobacco market this season has experienced unprecedented growth. With two new warehouses, and many improvements to other warehouses and drying plants, the market was never more able to care for the offerings of the thousands of growers who sell here. While improvements in facilities have been continuing over a period of several years, it is possible growth has been more pronounced the past three seasons, and especially the season just opening.

First reports of the sales are awaited expectantly in all parts of the country, and bookkeepers will be kept busy all through the night of the first day compiling the information sought, so eagerly by members of the industry in other towns and cities. The most interested watcher, however, will be the grower who has spent all of the long spring and summer months planting, cultivating and curing his crop for this harvest season. The outcome of the sales vitally affects him, in that he either realizes handsome profits for his labor, breaks even or is doomed to loss.

Wisecrates have not been as busy attempting to figure out prevailing prices for opening day. For one time in their lives they have been caught without material for prognostications, but after the first sales their tongues more than likely will get busy and predictions will be forthcoming rapidly until the curtain has been wrung down on the closing sales.

Five Killed In Series Of Accidents

Many Also Injured As Tourists From U. S. Stream Into Wet Ontario.

Toronto, Ont., Sept. 3.—(AP)—Tourists from the United States streaming into wet Ontario from the United States for the holiday week-end figured in various auto accidents, five of which resulted in fatalities so far as reported today. One American dropped dead of heart disease at the wheel of his car.

Roads leading from the International border were choked with automobiles and officials at Niagara Falls and Windsor reported unprecedented business over the bridges and ferries.

Mrs. Margaret Ann Schwartz, 68, of Buffalo, died after a collision with a Detroit car near Chatham, Ont., two women and two children were hurt.

H. C. Schwarzenberg, of Castle, N. Y., was killed and five others were seriously injured in a head-on collision near Paris, Ont. The injured are: Mr. and Mrs. R. Goddard, Detroit; Mr. and Mrs. Thomas Sands, Detroit; and Jack Turle, Windsor, Ont.

Hartley Robbins, of Newark, N. J., was held on a manslaughter charge at Ottawa as a result of the death of William Roulahan, 65, whose buggy was struck by Robbins' automobile.

John McFarlen, 70, died after being thrown to the pavement by an automobile driven by Elmer Dinsdale of Detroit.

Phillip Ulanov, of New York City, succumbed to heart failure while motoring with friends near Hamilton.

Sidney Smith, Niagara Falls, N. Y., suffered serious injuries and Leslie Saunders, Niagara Falls, sustained minor cuts and bruises when automobiles driven by the two youths collided head on near St. Catharines.

Mrs. J. Butkiss, of Detroit, was severely hurt and her daughter, Miss A. Butkiss, was cut about the face when a car driven by J. Butkiss crashed into the rear of a Canadian car near Beamsville.

Rachel Beach of Lockport, N. Y., was seriously injured when an automobile driven by her brother, Joseph, struck the rear of an unidentified machine at Grimsby.

Hubert A. Mayhew, Rochester, N. Y., was arrested at Grimsby on a charge of reckless driving after a collision in which several people were shaken up. He was released on bail but police held his automobile.

John Coolidge Leaves Home For Good Now

Superior, Wis., Sept. 3.—(AP)—Preparations for what may be John Coolidge's permanent separation from the home of his parents, cast a shadow of gloom over the summer White House today and accounted for most of the activities there, where bags and trunks were being packed for his journey East tonight.

Anticipating with great sorrow the departure of his son, on his way to find a job and to work out his own future, Mrs. Coolidge watched and helped in packing of his luggage. As early as yesterday noon, at the church services at Brule, her eyes had glistened with tears when she had told John Taylor, the blind preacher at the church, that after tomorrow her son would no longer be with her.

President Coolidge himself, although outwardly carrying out his usual daily routine, betrayed enough interest in the arrangements for his son's departure to show how deeply he felt the oncoming separation.

Up to this morning the White House had refused to reveal exactly what John's destination would be and what plans for the immediate future he entertained. It was reported, however, that he would go first to Hartford, Conn., on his way to meet Miss Florence Trumbull, daughter of the Governor of Connecticut, who is due back in a few days from a trip to Europe. John has often been guest of the Trumbull family at Hartford, in whose household he is, by now a familiar figure.

It was thought likely here that John would later accompany Miss Trumbull to Maine where her father has been spending the summer and where she is due to join him.

It was known, however, that so many attractive offers had been received by the boy that his problem was chiefly which job to take. The only certainty in this connection was that John expected to be busy at his new work very soon, as he had made statements to this effect to friends on the Brule.

Rockford, Ill., Sept. 3.—(AP)—A single word—"unharmed"—last night unlocked all the pent emotion that Rockford had locked in its breasts for the two anxious weeks.

It transformed dull hope to glorious reality—Bert Hassell and Parker Cramer, co-pilots of the monoplane Greater Rockford, were safe. Word to their safety in Greenland stirred the city to a bedlam of noise in a spontaneous celebration that rivaled that of Armistice Day ten years ago.

Through it all, two children clutched the hands of a dry-eyed mother who fought for self-control as she watched the news of Bert Hassell as it came in over telegraph wires at the offices of the Rockford Morning Star.

With eyes for nothing but printed words and tears for only the noise of automatic typewriters, the wife of Bert Hassell said:

"I would have kept up my hope if he had been gone a year."

When asked what she thought about it all, she appealed: "Do I have to go through all that now?"

Mrs. Fannie Cramer, mother of Parker Cramer, was in LaGrange, Ill., and her other son, William, telegraphed her the glad news from New York. It was quiet in LaGrange and she was glad. She could give thankfulness in comparative quiet.

But not so in Rockford. Automobile horns squeaked and factory and locomotive whistles screeched. Strangers slapped strangers on the back, hats were tossed in the air, and thousands shouted and cheered as they shoved and pushed and rushed about the streets eagerly seeking the "latest news".

It was just two weeks ago yesterday that the Greater Rockford's radio set signalled the letter "R" at three o'clock in the morning indicating by that alphabetic code that the plane was about 75 miles off Cape Chidley, Canada, on its way to Mt. Evans. From then until last night hope rose and fell as almost daily rumors of messages purported to be from the lost fliers were proved erroneous.

Junker Pilots Fail In Attempt To Break Record

This was learned today when the steamer Orcona arrived here. Local authorities, however, who boarded the ship to pay their respects, were informed that he was not well enough to receive visitors.

Over the objection of Wade Hampton Whitley, commonwealth's attorney, who claimed that validity of the indictments already had been upheld, Judge Ben G. Williams, sitting in circuit court, ordered a hearing on the demurrer tomorrow.

A status trial is set for Monday, Sept. 10.

Helping the Homemaker

By LOUISE BENNETT WEAVER
Dinner Menu
(Using Sunday's Leftovers)
Roast Beef Hash Creamed Carrots
Chili Sauce
Bread Peach Butter
Perfection Salad
Watermelon Coffee

Roast Beef Hash For Four.
1 1/2 cups chopped cooked potatoes; 3 tablespoons fat (bacon fat is good); 2 tablespoons chopped onions; 2 tablespoons chopped green peppers; 1 1/2 cups chopped cooked meat; 1-2 teaspoon salt; 1-4 teaspoon pepper; 1-4 teaspoon celery salt; 1-4 cup water or left over gravy.

Place the fat in a frying pan. When hot add the onions and cook slowly until a little brown. Add the remaining ingredients and cook slowly for 15 minutes. Stir frequently to prevent scorching. If a brown hash is desired, when cooked and thick, brown for 5 minutes directly under the broiler. This will give a crust. If a moist hash is preferred, add 1-2 cup milk, water or gravy and cook for 5 minutes. If bacon fat is not available, use half butter and half some other fat as lard or lard substitutes.

Chili Sauce.
12 red tomatoes (2 1/2 inches in diameter); 1 cup finely chopped onion; 1 cup finely chopped celery; 1 cup finely chopped green peppers; 1-3 cup salt; 1-2 cup sugar; 2 teaspoons cinnamon (powdered); 1 teasponteaon cloves (powdered); 1 teasponteaon mace; 2 cups vinegar.

Peel and chop the tomatoes and add the rest of the ingredients. Cook in an enameled kettle over a slow fire until the sauce becomes very thick. Stir frequently with a wooden spoon. The sauce is done when the path of the spoon may be seen for a second after stirring. Pour into small necked bottles, cork well and cover the corks with melted wax or paraffin. Store in a cool dark, dry place.

Perfection Salad For Six.
1 package lemon flavored prepared gelatin; 1 1/2 cups boiling water; 1-4 cup vinegar; 1-4 cup sugar; 1 teasponteaon salt; 1-4 teasponteaon pepper; 1 1/2 cups chopped or shredded cabbage; 1-4 cup chopped celery; 1-3 cup salad dressing.

Pour the boiling water over the gelatin mixture and stir until dissolved. Add the vinegar, sugar, salt and pepper. Cool. Add the rest of the ingredients and thoroughly mix. Pour into a glass mold which has been rinsed out of cold water. Set in a cold place to stiffen. Unmold on lettuce leaves and top with a small amount of salad dressing. The salad dressing mixed and chilled in the gelatin mixture gives a pleasing flavor. The leftover salad may be served the following noon for luncheon.

Add one tablespoon of chili sauce to meat loaves, vegetable soup, meat gravies, macaroni and cheese, sandwich fillings and cheese mixtures. The piquant flavor is most desirable.

Guiding Your Child

GOOD EATING HABITS

(By MRS. AGNES LYNE)

A child who has good eating habits not only consumes the requisite calories and vitamins, but does it promptly and without fuss. Ordinarily a healthy child comes hungry to table. There ought to be no question of his eating a hearty meal.

Yet again and again mothers complain that their children refuse to eat their food or entirely refuse it. They find that neither coaxing nor coercion bring any appreciable improvement.

We have all seen the intelligent mother who knows what is good for growing bodies, stuffing spinach into an obstinate and resistant mouth. Inevitably the situation ends in triumph for the child.

Again, who is not familiar with the conscientious mother who resorts to the system of "One for mother, one for father—see, it's almost gone, now just one more— and so on for an hour. Perhaps she even tells him stories or sings to him.

Then there is the youngster whose poor appetite is the subject of parental controversy over the breakfast table. He listens while mutual recriminations fly over his head.

Any normal child would rather go hungry than forego certain victory in a clash of wills, or miss these situations of which he is the center. The merest baby cannot fail to realize that simply by refusing his food he can make the world revolve around him. He can force his mother to pay attention to him, and to him only, for an hour at a time. He can make himself the center of an emotional family scene. Once a child has learned this key to power he does not readily give it up.

It is therefore vital not only to serve the right food, but to serve it casually. Voice and manner must be free of the concern a mother always feels for her child's health. When food has stood before him

for 15 or 20 minutes it should, without comment, be removed, though it has been but partly eaten or not even touched. It will take strength of mind to carry through this program with a child who has as it were, been accustomed to music with his meals. If he is actually left to his course of voluntary starvation, his appetite will soon be normal, and his eating prompt and regular.

Unveil Boulder To Johnson At Raleigh Today

Raleigh, N. C., Sept. 3—(AP)—North Carolinians and visitors from other states gathered here this morning to attend exercises in connection with the unveiling of a granite boulder to indicate the birthplace in Raleigh of Andrew Johnson, seventeenth President of the United States.

With Josephus Daniels, former navy secretary, presiding, the ceremonies start in the state capitol at 10 o'clock. Speakers are Col. Andrew J. Patterson, Greenville, Tenn., grandson of President Johnson, and Robert A. Winston, author of a biography of the Tailor's apprentice who rose to the nation's highest office.

The granite boulder, weighing nearly a ton, was placed on the East side of Fayetteville street, half a block from the capitol. Its bronze plate ledge reads "One Hundred and Twenty Five Feet East of this Spot, Andrew Johnson, Seventeenth President of the United States, was Born."

The actual unveiling was entrusted to Miss Margaret Johnson Patterson, of Greenville, Tenn., great-grand daughter of President Johnson, while presentation of the marker to the city of Raleigh was the charge of Dr. Oscar Haywood, president of the Andrew Johnson Memorial Association.

Texas is everywhere. No circle of

Washington—it is a little startl-
ing, at first glance, to observe Wash-
ington enthusiastically urging Hon-
duras and Guatemala to submit
their ancient boundary dispute to
the Central American Tribunal for
arbitration.

Unusual diplomatic pressure has
been exerted on Honduras and Guate-
mala for arbitration by Presi-
dent Coolidge or Chief Justice Taft.
Not so long ago, Secretary Lansing
was bluntly telling the now defunct
Central American Court of Jus-
tice to mind its own business when
on Costa Rican complaint it under-
took to consider questions arising
from the Bryan-Chamorro canal
rights treaty between Nicaragua
and the United States. The court
expired with the treaty creating it
due to Washington's cold-shoulder
attitude, largely.

Imperialism Cry Avoided.

There is a very wide difference
between the Tribunal and the def-
unct court, however. The former
is not a purely Central American
permanent body, subject to ines-
capable political influences, but
merely a panel of Pan American
jurists of repute, North South and
Central Americans, from which each
party to a submitted dispute would
select a disinterested member, those
two judges to name a third man
either of the panel or outside it as
presiding officer for the purposes
of the ensuing arbitration. No sov-
ereignty question could be taken
up without the assent of the Cen-
tral American government involv-
ed.

Bearing that picture in mind, it
is easy to see that Washington has
glimpsed a chance to make a grace-
ful diplomatic gesture, inviting Pan-
American cooperation in adjust-
ment of Central American differ-
ences. Who could raise the cry of
imperialism, particularly as two
great American owned banana com-
panies, one with Honduras and the
other with Guatemalan contacts,
have developed the productive value
of much of the disputed territory
and will be affected by the out-
come? These companies, Washing-
ton holds, have nothing to do with
the boundary row which far anted-
ated their appearance. Any dis-
interested arbitration should amply
care for their legitimate rights.

Past Experiences.

Honduran pleas for American ar-
bitration falls on deaf ears for sev-
eral reasons. For one thing, Presi-
dent Coolidge had bitter experi-
ence in the Tacna-Arica arbitra-
tion impasse. Although he acted
only as an individual, not in the
name of the United States govern-
ment, demands for police work by
the United States to insure a fair
pleadecite arose clamorously. More
than that, however, anti-American
propagandists in Latin America and
abroad have pictured the "Colossus
of the North" as trying to hog the
whole show in Central America and
maintain a virtual lone-handed pro-
tectorate over the five little repub-
lics against their will.

What Washington would like to
see happen would be selection of a
South American panel member by
each disputant and the third mem-
ber picked by those two from qual-
ified international jurists in the
United States who have no govern-
ment connexion. Such a man as
John Bassett Moore would fit this
picture. Perils of governmental en-
tanglements or international polit-
ical bias would be escaped. So
Secretary Kellogg, with Roy T.
Davis, American minister to Costa
Rica and who headed the last fruit-
less commission effort to solve the
boundary row, sitting at his elbow,
is insistent on Tribunal treatment.

Gardner To Stay With Gov. Smith

Democratic Nominee For Governor Behind Candidacy Of New Yorker.

Boone, Sept. 3.—(AP)—Asserting that he would wholeheartedly support Gov. Alfred E. Smith and the national Democratic ticket, O. Max Gardner of Shelby, Democratic nominee for governor of North Carolina, today opened his campaign in an address at the court house here.

With the open declaration of Senator F. M. Simmons in favor of thorough organization of the anti-Smith movement, the statement of the gubernatorial candidate had been awaited with much interest in the state.

"While I did not prefer the nomination of Gov. Misunderstanding Prevents Hoover Meeting The 'Babe'

Washington, Sept. 3.—(AP)—A "misunderstanding" kept Babe Ruth from meeting Herbert Hoover when the presidential candidate attended Saturday's game between the Senators and the Yankees and the home run king has expressed regret that the meeting did not take place.

Declaring that "politics had nothing to do with it," Ruth said that when a photographer requested that he and Mr. Hoover pose together, the game was about to start and that with the nominee the center of attention he felt that it would look "odd" if he should go over to the Hoover box at that time.

"I labored under a misunderstanding," he said, "and I deeply regret that I did not avail myself of the opportunity of meeting him."

Learning of the incident from the newspapers, Hoover said he certainly could sympathize with Ruth for not wishing to delay the game for more photographs. He added that as an "earnest baseball devotee," he long had admired the Babe's hitting ability and looked forward with pleasure to meeting him.

Larsen, sailing this month for the South Polar regions.

The hickies, assembled at Harrington, Mutton Bay and Blanc Sablon by David E. Buckingham, consulting veterinarian to the Byrd expedition, arrived here in express cars to which they were transferred at Quebec from the steamship North Shore.

The dogs were mostly friendly, although some of the crates were marked "bad dog," or "devilish, or not handle."

A special treadmill has been installed aboard the C. A. Larsen to enable the animals to get exercise during the voyage, as well as equipment to prevent their temperatures from rising dangerously in tropical waters. Every dog has been vaccinated against distemper, for which \$1,000 worth of serum was prepared and donated by the federal laboratory at Berkeley, Cal.
