## BYRD LEAVES ON TRIP FOR SOUTH POLE

### Explorer To Go To San Pedro, California, To Catch Whaler Larsen.

New York, Sept. 28.—(AP)—Commander Richard E. Byrd leaves New York tonight on the first leg of the long land and sea trail that will take him to the Antarctic continent where he and 80 comrades expect to spend the next two years.

Byrd is going first to his home in Boston, where he will take a train for San Pedro, Cal., to catch the whaler Larsen for the voyage to Enderby, N. S., rendezvous of the expedition. The Larsen, carrying four airplanes and the aviation personnel, is now on her way from Norfolk to the California port, and is expected to leave there October 6th.

The ice breaker City of New York, flagship of the Byrd flotilla, is in the Pacific about 500 miles southwest of Panama on her long, slow trip to the meeting place. The freighter Eleanor Bolling is 1200 miles this side of Panama, while the steamer Ross, a mother ship for whalers, is expected to reach the canal in a few days. She is carrying the expedition's 100 dogs and their five drivers.

The expedition hopes to reach the Bay of Whales on the Ross Sea, ice barrier of Antarctica, where the permanent base is to be established, by the middle of January. The exact time of arrival, Byrd explained today, is problematical because of the uncertainty of conditions in the heavy pack.

The four airplanes may not see much service during the first half year because the expedition reaches Antarctica too near the beginning of the six months polar night. This interval will be spent in establishing the base camp and preparing for the scientific work which is a major part of the Byrd program. The attempted flight to the South Pole will probably come soon after the reappearance of the sun.

Captain Sir George Hubert Wilkins, now on his way to Antarctica, will be based in Graham Land, 2,000 miles from the Byrd party.

"I've told him," said Byrd, "that when he flies over our way I'd be very glad to give him any help I could and to have him use our base."

Wilkins' station will place him about 2,000 miles from the Pole, while Byrd's position on the Ross Sea ice barrier will be 800 miles from the geographical bottom of the world. Because Graham Land is comparatively near to Antarctica first and can therefore be first in the air.

## Admiral MaGruder May Get Another Post In The Navy

Washington, Sept. 28.—(AP)—Rear Admiral Thomas P. MaGruder, former commandant of the Philadelphia navy yard who was relieved from duty last fall because of magazine articles he wrote criticizing the navy, may be given a post soon.

Several conferences with high naval officials have been held recently by Secretary Wilbur to consider what disposition would be made of the Admiral, who has been "awaiting orders" in Washington since he was relieved of all duties.

Admiral MaGruder has two more years to serve before he reaches the retirement age of 64 years. He is of the so-called "upper half" of the Rear Admirals and received \$5,000 a year salary.

## Bombers Still Busy At Chicago

Chicago, Sept. 28.—(AP)—Life for Anthony Giancane, owner of an ice cream factory, has developed into just one attack after another. Within 12 days three violent gestures have been made against him, the third one last night. Twelve days ago a bomb exploded at the rear entrance of his plant. Wednesday night the bombers went around to the front door and tossed another. These bombs resulted in several thousand dollars' damage, not only to the plant but to buildings in the neighborhood.

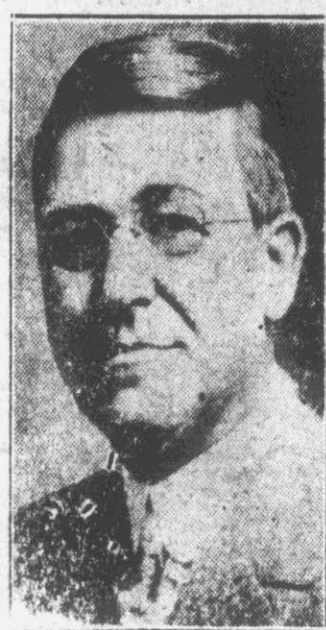
Last night the enemy became personal. Three armed men drove up to the ice cream factory, in front of which Giancane was seated with two friends. The visitors opened fire, but Giancane and one of his companions, Russell Russo, put so much distance between themselves and their attackers that they escaped uninjured. Tony Deledda was somewhat slower, and a shotgun slug caught him in the leg.

Giancane says he cannot understand why he should be attacked.

## Pitt County Growers Resolve to Cut Crop Of Tobacco Next Year

A resolution providing for a 25 per cent reduction in tobacco acreage was adopted at a meeting of Pitt county farmers held in the courthouse in this city this morning. Three other resolutions also passed by the gathering, provide for planting of all idle lands in food and feedstuffs, the opening of Eastern Carolina tobacco markets not later than August 20th, and that the farmers join in declining to place on the market grades of tobacco bringing below 5 cents a pound.

The session today was held under auspices of the Eastern Carolina Chamber of Commerce. Secretary Newell G. Bartlett was present and stated the nature of the meeting and the good results which should be obtained from every farmer living up to the resolutions.

The tobacco situation as it exists in this community was discussed by Dr. T. G. Basnight, of Stokes; Judge F. M. Wooten, Greenville; J. E. Whichard, J. W. Martin and G. S. Porter.

The resolution pertaining to the refraining from marketing tobacco bringing below 5 cents a pound was offered by J. E. Whichard.

The other resolutions follow:

Whereas, there has been an estimated increase of one hundred and fifty million pounds of tobacco in the United States in 1928, and

Whereas, this over-production has had a tendency to suppress the price of this important commodity, and

Whereas, it is the sense of this meeting that Eastern North Carolina, growing as she does, nearly one-third of the entire tobacco grown in the United States, should consider seriously a remedy for this situation. Therefore be it

Resolved, that this meeting go on record as approving a 25 per cent reduction in acreage of tobacco in North Carolina in 1929, and be it further

Resolved, that every tobacco farmer plant no more acreage than he can comfortably take care of during the rush season, and be it

Resolved, third, that the banks, time merchants and warehousemen of Eastern North Carolina will be called upon to assist in this movement, and be it

Resolved, fourth, that this meeting petition the Eastern Carolina Chamber of Commerce with headquarters in Kingston, N. C., which serve all of Eastern North Carolina, to take the lead and wage an intensive campaign towards putting this program into effect for 1929.

Adopted in mass meeting in Greenville, N. C., September 28, 1928.

## GOOD SALES CONTINUE ON THIS MARKET

### Tobacco Market To Date Has Sold A Total of 18,639,436 Pounds Of Leaf.

According to official figures made public this morning by K. W. Cobb, secretary of the Greenville Tobacco Board of Trade, the Greenville tobacco market has sold a total of 18,639,436 pounds of tobacco, including sales yesterday. The market has been handling anywhere from a million to a million and a quarter pounds of leaf daily since the opening of the market, and heavy sales are still anticipated for the future because of the improved conditions of the roads from the recent floods.

The market yesterday sold 1,078,340 pounds of tobacco for a total sum of \$191,667.30. The average on this amount was given at \$17.90.

The market sold out completely yesterday and indications today were that sales would be completed during the afternoon. There was over a million pounds of leaf on the various warehouse floors today.

Farmers were still warned to give more attention to the marketing of their crop. Much damaged tobacco was offered for sale during the week, and this had much to do with the prices situation, it was stated.

### "WHITE" COTTON FEATURES THE PRESENT CROP

Washington, Sept. 28.—(AP)—Of the 966,486 bales of this year's cotton crop ginned prior to September 1, a total of 856,181 bales or 89.51 per cent were estimated tenderable today by the department of agriculture for contracts made under Section Five of the United States Cotton Futures Act.

Most of the cotton 937,398 bales, was listed under the federal grade known as "white."

## MAX GARDNER SCORES G. O. P. AT RALEIGH

### Charges Hoover With Disloyalty To Woodrow Wilson in Fiery Speech.

Raleigh, N. C., Sept. 28.—(AP)—O. Max Gardner, Democratic nominee for governor, today expressed gratification with the reception he was given in Raleigh last night when he spoke in behalf of his own candidacy and the party's ticket to a crowd that filled the city auditorium to two-thirds capacity.

The nominee arraigned the Republican party's conduct of State affairs when it was in control in North Carolina, and its administration of national affairs since Warren G. Harding became president. He denounced Herbert Hoover for alleged disloyalty to Woodrow Wilson, and charged him with sitting silent in the cabinet while Albert B. Fall and others conspired to sell the navy's oil lands.

Referring to the slogan "If Hoover is good enough for Woodrow Wilson, he is good enough for me," Gardner came back with "If Alfred E. Smith is good enough for Mrs. Woodrow Wilson, he is good enough for me."

Without uttering a word in condemnation of the Anti-Smith Democrats in the state, the speaker appealed to them:

"Don't dishonor the memory of that great chieftain by voting for Herbert Hoover who is running on a platform written by the same forces that destroyed Woodrow Wilson."

Of Governor Smith, Gardner said "If honesty is a star, then I tell you, Alfred E. Smith is one of the brightest stars that ever flashed across our political firmament."

The audience came to its feet and cheered as the candidate pledged his loyalty to the national ticket with the assertion "I would rather go down in defeat than be disloyal to the general leading my army."

Tonight Mr. Gardner will speak at Wilson.

## ROBINSON TO APPEAR AT KANSAS CITY

### Democratic Vice-Presidential Candidate Discussed Issues At Springfield.

Robinson Special Car En Route To Kansas City, Sept. 28.—(AP)—Embarking upon one of the most extensive campaign tours ever undertaken by a vice presidential nominee, Senator Joe Robinson, in his first appeal to the West, hit home upon the same issues that he stumped upon time after time in his recent drive through Southern States.

The senator moved on to Kansas City today for the second of three speeches in Missouri, after opening his program in the state at Springfield last night by taking repeated thrusts at the 8-year record of Republicanism in Washington and denouncing in plain English preachers who, he said, were trying to mingle politics with religion.

He declared it was his opinion that a minister who injected politics into religion did himself and his church more harm than the candidate he sought to oppose, and then at the top of his voice shouted out:

"When he stuns preaching Christ and Him crucified, and starts preaching Al Smith and him crucified, I lose patience."

This brought cheers and applause from an audience which packed every niche and corner of the auditorium in the Shrine Mosque and overflowed into the street outside.

Mr. Robinson also hit upon the Republican farm record and declared that the party sought was "another lease on power" and that all its standard bearers, Herbert Hoover, had promised was to call another conference.

"Why that's what Presidents Harding and Coolidge did," he declared. "What we want is action, and Al Smith has promised that."

Wilkins Mother Dead

Sydney, Australia, Sept. 28.—(AP)—The mother of Sir George N. Hubert Wilkins, the noted flier, died here today. She was 82 years old.

## National Crisis Declared Today In Australia

Port Adelaide, Australia, Sept. 28.—(AP)—With further rioting growing out of the dock workers' strike today a national crisis was proclaimed today by the South Australian Cabinet. All work has stopped until Monday.

Riots occurred again today when 2,000 strikers tried to enter a bureau where volunteers were being enrolled for work on the coast. The police used their batons and dispersed the raiders after a lively scrimmage.

## GEO. PRESCOTT ELECTED HEAD PITT BANKERS

### Judge Wooten Speaks On Needs Of Business Methods Of Farmers Of County.

George W. Prescott, of Ayden, was elected president of the Pitt County Bankers Association at the annual meeting of that organization held at the Rotary club in this city last night. He succeeds F. J. Forbes, cashier of the National Bank of this city.

Other officers elected last night were S. C. Ives, of Bethel, vice-president, and Bruce King, cashier of the Farmers Bank, of Greenville, secretary and treasurer.

Representatives of the various banks of the county attended the session last night and entered into the discussions with more than ordinary interest. The principal address of the occasion was delivered by Judge Frank Wooten, of Greenville, vice-president of the Farmers Bank. Judge Wooten spoke on the subject of "Better Business. He made five divisions of his subject, embracing the five major industries of this locality, namely: agriculture, merchandising, banking, transportation and fertilizer. He declared that agriculture was the backbone of the entire business structure of the community, and yet, unlike the other businesses, it was practically without organization and business methods.

Judge Wooten urged that the farmer in preparation for next year's tobacco crop, adopt a plan for raising only the number of acres to which he could give his personal attention. He likewise impressed upon his hearers that, in behalf of better business, the farmer should begin to plan for his next year's crop immediately and make arrangements with his banker and business houses for such financial assistance deemed necessary for the season.

The Bankers' Association expressed a desire to co-operate with the grower in every way possible to aid in putting agriculture of the county on a real business basis. At the request of the Pitt County Board of Agriculture, a committee of bankers was appointed to confer with a committee of farmers to be appointed by the Agricultural Board to study conditions and work out the best possible plan for 1929 and the future crops of the county.

## TWO WOMEN TO SPEAK IN CITY TONIGHT

### Mrs. Jerman and Miss Henderson To Make Political Speeches at High School.

Plans had been completed today for the appearance in this city tonight of Mrs. Palmer Jerman and Miss Mary Henderson who are scheduled to speak in behalf of the Democratic campaign at the high school auditorium at 7:30 o'clock. Members of the committee said this morning that Mrs. Jerman would be introduced by Miss Sally Joyner Davis, member of the faculty of Eastern Carolina Teachers College. Miss Henderson will be presented by Mrs. R. L. Smith.

This is the first time that women have spoken here in the interest of the Democratic campaign, and members of the committee stated that they hope the new high school auditorium would be packed to capacity. Both men and women are invited to attend and hear the various issues of the campaign discussed by the two of the best known women in the state.

This will be the first time a public gathering has been held in the high school since its completion. The auditorium is said to be one of the finest in this section of the state and those who attend the speaking will also have an opportunity to see the auditorium at its best.

Miss Nell Battle Lewis, Raleigh newspaper woman, spoke at Farmville yesterday afternoon. She was heard by a good crowd. Other speakers have appeared in the county from time to time, but this is the first time women have taken to the platform in the interest of the campaign.

## Presbyterians To Talk Education In Greensboro Today

Greensboro, Sept. 28.—(AP)—Educational leaders of the Southern Presbyterian Church were gathering here early today for sessions to be held for discussing a survey of the educational work and responsibility of southern denominations.

Included in the gathering are faculty members, trustees and committee men and women who are taking part in the effort to solve the problem now confronting the denomination—that of serving a constituency of 70,000 Presbyterians and a combined student body of 2,300 in nine different institutions, with a financial investment and endowment of around \$4,000,000.

Dr. W. J. Martin, president of Davidson College, will preside, while Dr. B. Warren Brown will present to the gathering his findings in a survey which took more than a year to complete. Dr. Brown, whose home is in Chicago, is a member of the Northern Presbyterian Church.

### HOOVER WILL SPEAK IN NEW YORK OCT. 13TH

Washington, Sept. 28.—(AP)—Herbert Hoover will speak in New York City on October 13th, instead of October 17th, as originally planned. His address will be delivered in Madison Square Garden and not Carnegie Hall.

## HOOKS NAMES CHAIRMEN OF COUNTY CLUBS

### Lindsay Warren Greeted By Large Crowd At Ayden School Last Night.

W. E. Hooks of Ayden, chairman of the Pitt County Democratic Executive Committee, stated today that W. S. Tyson, attorney of this city, had been appointed chairman of the Democratic club for young men and women of Pitt county.

It was also announced that E. O. Worthington had been made chairman of the veteran's organization. Both of the newly elected officers, it was stated, will begin work immediately getting lined up for the election to be held during the month of November.

Mr. Hooks stated that Congressman Lindsay Warren was heard by a large crowd in Ayden last night at the high school auditorium. The speaker was introduced by K. A. Pittman, Ayden lawyer. At conclusion of the address Mr. Warren was presented with two bouquets of flowers by Misses Frances Turnage and Willie Boyd, daughters, respectively, of J. R. Turnage and W. J. Boyd, of Ayden.

The Congressman was also entertained at dinner at the Beverly Hotel. A number of well known business men of the town and county were in attendance.

Other speakers appeared at different points in the county last night, opening the Democratic campaign. They were greeted by good crowds in all places and much interest was said to have been manifested in the discussions dealing with political issues of the day.

Mr. Hooks again expressed appreciation of the splendid work being done by Democratic leaders over the county. Organization of Democratic clubs is proceeding rapidly in virtually all localities, with indications that the next several days will see memberships greatly increased.

## SMITH FLAYS REPUBLICANS AT ST. PAUL

### Democratic Nominee Delivers Broadside On Inaction Of Party On Farm Issue.

St. Paul, Minn., Sept. 28.—(AP)—Leaving behind another attack on the Republican party and administration, this time a triple barreled assault for alleged inaction on the questions of farm relief and inland waterways and for "whispering", Gov. Smith takes to the road again today for the last speech of his western drive for the presidency.

Tomorrow night at Milwaukee, the Democratic presidential candidate will wind up his two weeks' stumping of the middle and far west with an address, probably on prohibition. The Democratic state convention at Rochester next Monday, which he also plans to address, then will be his only engagement before returning to Albany for a rest.

Ripping into his Republican opposition, Gov. Smith took a crowd that jammed into the St. Paul auditorium last night that there was an "absolute lack of vigorous leadership" at Washington and had been for the last seven and a half years. As a result, he asserted, Republican platform declarations on farm relief and inland waterways have amounted to nothing more than "glowing promises."

The Democratic platform "hits the nail squarely on the head" on these subjects and it is from this party that real relief must come. The nominee charged into Chairman Work of the Republican national committee, Secretary Jardine, and Senator Nye, Republican, North Dakota, on the farm relief score and quoted a statement by Senator Norris, Republican, Nebraska, "issued after his Omaha farm speech, as furnishing his best defense from criticisms of that address.

"Tackling this question first, after declaring that lack of leadership at Washington had led such western senators as Shipstead, farmer-labor, Minnesota, and the late Senator LaFollette to "bolt" the Republican party, Gov. Smith repeated that he stood for the principle embodied in the McNary-Haugen bill for handling surplus crops. Then he tackled Work.

He referred to him as "the doctor" and said he did not know whether he spoke for himself, for the national committee or for the Republican presidential nominee, when, in commenting on the Omaha speech, he said the governor had "enunciated a principle which he says he finds in the McNary-Haugen bill, but which is not the one over which the battle has been fought for the last four years."

"What's the matter with the Doctor?" Smith asked. "I'll tell you. The Doctor is unable to distinguish between the principle and machinery for making the principle operate. He has tried to put two principles into one thing."

Turning to a speech by Mr. Jardine at Riverhead, N. Y., last week, the governor seized on the secretary's remark, that "for several years we have managed to get the farmers a pretty good price for wheat and potatoes."

"A good price for wheat," Smith expostulated. "The secretary is doing a little Moran and Mack stuff. A good price for wheat—a price less than the cost of production."

The nominee took a rap at Nye for lining up with Hoover on farm relief while at the same time favoring the McNary-Haugen bill and declared his argument and that of Chairman Work is "completely annihilated" by the Norris comment on the Omaha speech; that Governor Smith proposes to take care of the surplus and charge it to the producer.

"All three gentlemen that I have quoted," the governor said "are members of the Republican party. The difference is that Senator Norris looks at it through the broad, liberal progressive way; the other two men look at it through the crude and narrow little peephole of stand-patism."

As for inland waterway legislation, the nominee said Republican efforts along that line "runs parallel with the farm problem, and before could be offered tonight as another exhibition or another example of the slarney word of vigorous leadership in Washington."

## NEGRO PAYS FOR MURDER FARM GIRL

### Larry Newsome Executed At State Prison This Morning At 10:35.

Raleigh, N. C., Sept. 28.—(AP)—Larry Newsome, Wayne county negro, paid with his life this morning for the death of Beulah Todder, young Wayne county farm girl. Strapped in the electric chair at State's Prison at 10:35, he was given two shocks and pronounced dead at 10:43 o'clock.

The diminutive negro entered the death chamber at 10:35 a. m., with "one" of a smile on his face. Before he was strapped in the chair he looked around the room, and addressing newspapermen and witnesses, said: "How you all feel."

As he was being placed in the chair and until the first shot was sent through his body he was whispering something, apparently a prayer, but it was too low to be heard by those near him.

The first shot, lasting from 10:30 to 10:40, was not sufficient to produce death, and he was given another at 10:41. The electricity was turned off at 10:42 1-2 and he was pronounced dead by an attending physician at 10:43 a. m.

## SOCIETY BOOTLEGER Given Term In Pen

Philadelphia, Sept. 28.—(AP)—Joel D. Kerper, so-called "society bootlegger" was sentenced to a year and three months in the Atlanta Federal penitentiary and fined \$20,000 in Federal court today.

Kerper pleaded guilty to 29 counts of illegal possession and transportation of liquor.

## SIMPLE RITES FOR FUNERAL FLORIDA DEAD

### Utmost Simplicity To Be Observed At Palm Beach For 2,300 Storm Victims.

West Palm Beach, Fla., Sept. 28.—(AP)—Plans were made here today for a simple funeral service to be held Sunday for Florida's 2,300 storm dead.

Members of the city ministerial union met yesterday at the First Methodist Church and appointed eight of its body to conduct the service, which will be held over the graves of more than 700 storm victims buried at Woodlawn cemetery here. Rites will be conducted for those buried there, for those whose bodies still lie unbound along the devastated shores of Lake Okeechobee.

Two services will be held. The first at 2:30 p. m. will be for white people, and the other to be conducted later and by negro clergymen, will be for storm victims.

Under present plans the funeral dirge will be played by the city band, the opening hymn will be sung by a mass choir from all the city churches and the invocation will be read by the Rev. Charles G. Dilworth of the Norwood Baptist Church.

A scripture passage will be read by the Rev. John G. Strandley, Methodist minister, and a brief address will follow by the Rev. Chas. H. Bolton of the First Baptist Church.

The commitment service will be conducted by the Rev. William A. Cooper of the First Methodist Church. Prayer will be said by the Rev. John H. Minges of the Church of Christ, and the benediction will be by the Rev. E. A. Lindsey of the Memorial Presbyterian Church.

Tokyo, Sept. 28—(AP)—Precedents were shattered today when Yashukito, Prince Chichibu, 25-year-old heir presumptive, to the throne, married Miss Setsuko Matsudaira, 19-year-old daughter of Japan's former Ambassador to Washington.

For the first time since the establishment of a hereditary nobility, a prince of the blood went outside the perage to select his wife. He made the selection under romantic circumstances, falling a victim to her charms when visiting the Japanese embassy in Washington in January, 1927.

The wedding ceremony began at 9 o'clock this morning when the prince and his new princess entered the outer sanctuary before the Kashtokodore, "the place of awe," in the imperial palace where the spirit of the Sun Goddess is worshipped as the material ancestor of the Imperial House.

To the strains of flute music the doors of the sanctuary were opened, disclosing the sacred metal mirror, one of the three imperial treasures, symbol of the spirit of the Sun Goddess. There Prince Chichibu made a formal report of the marriage to the goddess and the other deities of the pantheon, of which she is the central figure. Then a master of ceremonies handed the divine cup of sake or rice wine to the prince and his bride in turn. The actual wedding ceremony was completed when they drank this.

Under court ritual only a few princes and princesses of the blood and court ritualists and officials were eligible to witness the ceremony. Setsuko's parents, Tameo Matsudaira and his wife, however, were granted imperial permission

and attended. No foreigners were present.

Further ceremonies were then held in the Kereden and Shiden sanctuaries within the palace to announce the union to the imperial ancestors.

The couple left the imperial palace together at 10:30 o'clock in a horse-drawn closed carriage still wearing their ancient ceremonial robes. The princess' outer kimono was a brilliant Nile green. A gold half crown surmounted an elaborate coiffure of the medieval court.

Crowds lining the streets were composed mostly of school girls. The only escort was a platoon of cavalry. The couple were driven to the Prince's Omote-Machi mansion, an occidental style dwelling near the imperial palace, which is to be their residence.

This evening the couple returned to the imperial palace, this time in modern dress, to receive the congratulations of the Emperor and Empress. The princess appeared in a Parisian gown and the prince in the military uniform of the guards' division.

Criqui won the 126 pound crown from Johnny Kilbane on June 2, 1923, and surrendered it on July 23 to Johnny Dundee after possession of less than 2 months.

At a Democratic rally here last night Elliott said: "I do not understand how a Democrat can be consistent with the principles of democracy if he spurs the ticket."

## Lindbergh Drives Passenger Plane

St. Paul, Minn., Sept. 28—(AP)—The commercial airways called again today to Col. Charles A. Lindbergh.

A dozen passengers who had booked passage to Chicago on a Northwest Airways plane did not know in advance that they were to have a New York-To-Paris pilot at the controls when their tri-motored plane took off today.

Col. Lindbergh flew here last night from Chicago, accompanied by Major Thomas G. Lanphier. He had flown to Chicago yesterday from St. Louis, where he had gone to register for the November election.

The ocean liner was as non-committal concerning his plans as always.

With North Carolina's voting population placed at 1,207,343 in 1924 there were only 432,687 votes cast for Davis and Coolidge. Truly it is the duty of every citizen to take a part in the election of public officers and it is to be hoped that in the coming campaign the vote will be such as to clearly indicate the wishes of the people. So long as less than half the qualified voters take interest enough to vote and a majority of these votes are sufficient to elect, our officials will be chosen by approximately 25 per cent of our qualified voters or 12 per cent of our population. Surely a government set up by 12 per cent of the citizens is not representative. Every citizen has a solemn duty in connection with the government, local, state, and national, and when a person willfully stays away from the polls on election day he or she is shirking a duty and is leaving the affairs of government to the minority. Let's have a record vote in the coming election.

a rigid responsibility," and that "the prosecution and punishment of all who betray official trusts shall be swift." Another plank called for appointments "with sole reference to honesty, fidelity and capacity." Mr. Hayes ran as an avowed reform candidate. His chief supporters pointed to him as the man who would purge his party. Republicans like Carl Schurz, Cyrus W. Field and Horace White saw that "the widespread corruption in our public service" was never lost sight of. Hayes himself was outspoken. He promised in his acceptance speech, "the speedy, thorough and unsparring prosecution of all public officers who betray public trusts." He declared he would enforce a return to "the true rule that honesty, capacity and fidelity constitute the only real qualifications for office."

There is one evident difference between the position of Hayes in 1876 and that of Mr. Hoover in 1928. Hayes had no connection with the Grant Administration, while Mr. Hoover sat in Mr. Harding's Cabinet throughout. It is true that this corruption dates back before 1924; it is true that the Republican party did speak feebly upon it in the campaign of that year. But Mr. Hoover has never spoken with ringing firmness. He has never imitated Mr. Hayes, and his silence gives Gov. Smith a basis for the charge of complacency.—N. Y. World.

By HORACE C. KENEGAR (Associated Press Sports Writer) Athens, Ga., Sept. 28—(AP)—Georgia's football squad last year was known as the "team of a thousand backs"; Coach Harry Mehre said this year it would be the "team of a thousand backs". But Mehre, Harry must have been wrong.

The big Red team of Athens—the eleven men who carried the colors of the Southern Bull Dog almost to the national collegiate championship in 1927—will be starting this autumn with the same dynamic backfield power that blasted Yale, Virginia, Alabama, Tulane, Florida, and all save Georgia Tech, from its path.

Herdie McCrary, Frank Dudley, Bobby Hooks and Houdini Johnston, the same four will be carrying on again.

True, Chick Shiver and Tom Nash, all-American end selections of many, will be one. Coach Mehre, however, has so many worthy flank prospects he can't decide who looks best. None appear great but all are showing the speed and wit needed in dependable ends.

McTigue, a reformed half back, Palmer, Nixon, Smith and Maffett, and several other flank candidates apparently will see service. All are showing the knack of boxing, tackling, blocking, catching passes and breaking through interference, a few of the things an end is supposed to be doing during less busy moments.

As for tackles, Lautzenheiser is a certainty at one of the positions the other. He must beat out two while Friesie is showing ability at or three good boys to start, however.

Jacobson and Haley, veteran guards will be one line and the pivot position will be under care of Boland, a star of last year.

So, while Coach Mehre and his assistant Jimmy Crowley, both former Notre Dame stars, opine they look pretty good out we can't tell yet—most of the critics are willing to concede Georgia a fair chance for the conference throne.

That is only a part of the story of Georgia's power. Buster Cook, a light but ripping half back, will be ready to step in for half back duty at any time. Harvey Irah, a sensational punter, will in all probability alternate much with Hooks. Hill is consistent in getting off long spirals, a pleasing indication to Coach Crowley, who sees a couple of good kickers in Hooks and Hill.

The line will average around 190 pounds while the backs will scale an average of 160.

The Bull Dogs this year have another inspiration. As they trample Sanford Field the sound of steam shows floats from a nearby valley. Only a few yards from Sanford Field a mammoth stadium is under construction. The Bull Dogs are to have a new home to seat 30,000 spectators. It will be an all-concrete bowl, designed after that of the University of North Carolina.

## May Patch Up The Army-Navy Squabble

By ALAN J. GOULD New York, Sept. 28—(AP)—The now historic army-navy break in athletic relations, it develops on the eve of their 1928 football season, is likely to be patched up much sooner than has generally been expected.

It is even possible, though not likely, that the two service schools will effect a reconciliation and get together on the gridiron this season in spite of the fact that both have arranged rugged and independent schedules as a result of the rift that occurred last winter. If not, it is now considered certain that they will resume football relations in 1930.

The primary basis for this unexpected outlook for peace, it is understood, will be a complete reversal of the navy's stand on the three year varsity player principle—the rock on which the academies split. The paramount motive, however, will be to restore harmony and regain public confidence in the ability of the nation's foremost service institutions to get along together.

In other words, as the situation is outlined authoritatively to the Associated Press, Annapolis authorities, having failed to effect any compromise agreement on the issue of athletic eligibility requirements, will concede West Point's right to play its men, regardless of how much previous college experience they have had.

## Champion Finds Her Way Blocked

Hot Springs, Va., Sept. 28—(AP)—Nineteen years ago Mrs. Dorothy Campbell Hurd of Philadelphia, was a golf celebrity, champion of the United States, Great Britain and Canada. Miss Virginia Van Wie of Chicago was waiting to celebrate her first birthday, still some six months distant.

Today the Philadelphia woman, three times American champion, found the way blocked to her fourth title in the semi-final round by Miss Van Wie. The veteran still possessed her remarkable vitality and skill, while Miss Van Wie plays a game well worthy of an American champion.

Glenna Collett, the Providence girl, who hits a golf ball like a man and puts with a delicate touch, opposed Mrs. George H. Stetson of Philadelphia, in the lower bracket. Art Nehf, once the left handed ace of John McGraw's heart, dealt his one time boss a staggering blow yesterday when he twirled the Chicago Cubs to a 3 to 2 triumph over the Giants in the opening clash of a double header. The Giants, fighting desperately to keep in the running, came back with a 2 to 0 win in the nightcap, but lost ground over the Boston Braves, carried the St. Louis Cardinals to a full game lead over the Giants where a half game had been their advantage before. Only three games remain on the schedule and that one-game lead may well stand until the two contenders clash in their final battle of the year at the polo grounds on Sunday.

Nehf, like Burleigh Grimes of Pittsburgh, another Giant alumnus, delights in taming his former teammates and he did just that thing to perfection, holding them to six hits while the Cubs were touching Karl Hubbell for nine.

In the second game the Giants got only three hits off Charlie Root and Perry Jones but one of them was Frank Hogan's home run in the second and another was a single in the fourth by Lindstrom, who eventually scored on Hogan's sacrifice fly. Joe Genewich gave the Cubs only five hits and never was in danger.

Jess Haines pitched the Cards to an easy 8 to 3 triumph over the Braves.

Wally Pipp hit two home runs as the Cincinnati Reds trounced the Phillies, 6 to 2, and Del Bissonette did the same thing as the Brooklyn Robins took the Pirates over the traces in two games, 7 to 6, in ten innings, and 8 to 1.

The New York Yankees just about clinched their third successive American League pennant when they beat Detroit on both ends of a double header 4 to 3, and 8 to 5. Darkness halted the second game at the end of the seventh inning, a lucky break for the Yanks for their pitchers were reeling and staggering. Waste Hoyt shaded Owen Carroll in the opener. Babe Ruth hit his first homer in the first inning of the first game and his 52nd in the initial round of the nightcap. One more Yankee victory or another defeat for Connie Mack's Athletics will clinch the pennant for Miller Huggins.

Philadelphia retained their mathematical chances by turning back the Chicago White Sox 5 to 3.

The Cleveland Indians overcame a seven run lead to beat the Boston Red Sox 14 to 10 in the first game of a double header, but dropped the second, 7 to 4, when big Ed Morris kept them in check.

The Washington Senators shaded the St. Louis Browns, 6 to 5, in the first game of the vinup series at St. Louis.

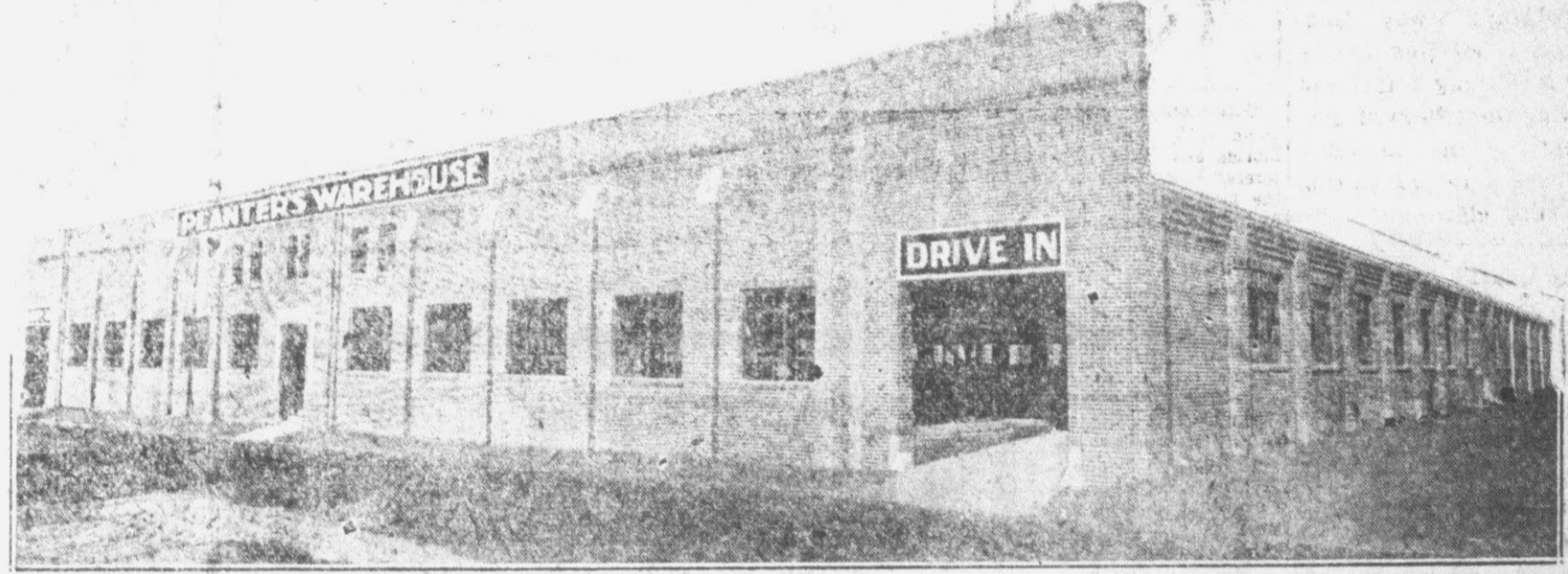

# COOLIDGE IS NOT SURE OF WHAT TO DO

### Would Like To Assist In Campaign, But Somehow, He Just Can't Get Started.

Washington, Sept. 28.—(AP)—Frank statements of some party leaders who have called on Herbert Hoover recently concerning the Republican prospects in Massachusetts, the home State of President Coolidge, have served to revive speculation as to what part the chief executive is to play in the presidential campaign.

Mr. Coolidge and his successor as the head of the Republican party have conferred upon this subject but there has been no announcement beyond the mere statement that the chief executive wants to be as helpful as possible.

Since that pronouncement word has gone around in some political circles that Mr. Coolidge contemplates making at least one speech before election day and since his party appears to be having its troubles in his own State, the natural assumption has been that he would speak there.

Political observers who have dug into the records of the past have found plenty of instances of a President actively participating in a campaign in which his own political fortunes were not at stake, but there are few instances of a chief executive directly urging the voters to support the presidential candidate of his party.

President Coolidge has clung scrupulously to the precedents in such matters and should he decide to make an address in or out of his home State he would be expected by those who profess to know him best to confine himself to a review of the party record under past administrations and to an exposition of his own ideas of the benefits that might flow to the country by a continuation of Republican policies.

Hoover, himself, is to invade New England late in the campaign just before he begins his driving finish of the presidential contest in his trip across the continent.

Meanwhile, the Republican presidential candidate is giving special study to the situation there as well as in other New England States which have become denatole territory at least in the claims of the rival political managers. There are indications that the Republican drive in that section is to be increased in intensity even before the nominee makes his excursion into that territory.

## John Coolidge Gives Testimony In Court Today

(New Haven, Conn., Sept. 28.—(AP)—John Coolidge had to go before Deputy Coroner James J. Corrigan today, to testify regarding an automobile accident which caused serious injury to Wilfred Veno, Hockey Star, and the player's mother, Mrs. Mary Veno.

The police would not reveal who was driving the automobile. It was owned by Governor John H. Trumbull. In it were Coolidge and William Cunningham, the governor's chauffeur.

The New Haven Journal Courier, said today that it had learned from authoritative sources that John was at the steering wheel when the machine crashed into Veno's automobile at a street intersection. Veno was thrown against the front of his car and was taken to a hospital with a fractured skull. His mother was bruised.

John Coolidge was on his way to work in the New Haven Railroad office after having spent the night at the home of Governor and Mrs. John H. Trumbull in Plainville. John's mother also was an overnight guest there. The crash occurred almost in front of the home of Prof. Benjamin W. Bacon, where Coolidge is living while working here.

After his day's work John went to the hospital to inquire about the victims' conditions. Mrs. Coolidge, when she learned of the accident on her return to Northampton with her friend, Mrs. R. B. Hill, and secret service agent, expressed regret.

A license to drive an automobile in Connecticut was issued to John last May.

Washington, Sept. 28.—(AP)—The swashbuckling orator of the good old days of red fire politics rapidly is disappearing. The radio has sent him to the oblivion which has claimed many of the accountants of his time.

Radio has come into such universal use in this campaign that there are few stages left upon which the arm-swinging, platform-charging, high-slapping spellbinder may function. The town meeting or the ward rally now largely encompasses the field of his activity.

The man who wants to get his message over to the American people must stay put. He may range within a foot or two and raise an arm now and then, but the "Mike" cramps his style if he is inclined to raise to heights, either of voice or of gesture.

Even at the most important of political gatherings, such as those the presidential candidates themselves address, the battery of microphones is limited and hedges in the speaker so that his every intonation will be carried to his unseen audience.

Should the speaker get too far away, or turn to one particular side of the hall, his words are likely to be lost not only upon those who are listening in from afar, but upon many of his immediate audience who are depending upon the amplifiers.

The radio has proved a handicap to some of the speakers who have been pressed into the service of the ritual camps, but it has proved an aid to others.

## Politics Over Nation Today

St. Paul.—Smith assailed Harding-Coolidge administration for lack of leadership; declared for preservation of immigration restrictions; reiterated stand for principle of McNary-Haugen bill; said willing to be guided by engineers in inland waterway development.

Oklmulgee, Okla.—Curtis emphasized restricted immigration; emphasized tariff issue in series of speeches in Oklahoma.

Springfield, Mo.—Robinson declared Smith's record on legislation affecting women and children exceeded "that of any other statesman."

Washington.—Speaker Longworth attacked Democratic tariff stand; charged Raskob with "bare-faced misrepresentation of facts."

New York.—Charles Evans Hughes to make five speeches for Hoover-Curtis ticket during last two weeks of campaign.

Washington.—Elihu Root declared for Hoover with reservation that he disagreed with nominee on prohibition.

Milwaukee.—Rep. Berger, Socialist, Wisconsin, said statements of New York Socialist leaders been misconstrued as meaning Socialists prefer Hoover to Smith.

New York.—Democratic headquarters announced formation of "Hotel Men's League for Smith" with David B. Povan of Philadelphia as chairman of executive committee.

Waco, Tex.—Robert L. Owen Owen, former Democratic Senator from Oklahoma, supporting Hoover declared he could not be "browbeaten" into voting for a candidate "who would give the government of the United States over to Tammany Hall."

**OPPOSE CANDIDACY OF GOVERNOR SMITH**

San Diego, Cal., Sept. 28.—(AP)—Despite opposition by several ministers and laymen, the Los Angeles Presbytery in annual convention yesterday passed a resolution opposing the presidential candidacy of Governor Alfred E. Smith, and favoring Herbert Hoover for president. The resolution was based on the Governor's statements with regard to modification of the Volstead Act.

## N. Y. Woman Held In Perjury Case

New York, Sept. 28.—(AP)—A woman who insisted her brother-in-law was her husband was under arrest today, charged with perjury.

Mrs. Della Frank, 23 years old, of the Bronx, was separated from her husband, Albert Frank, several years ago and granted alimony of \$25 a week, none of which she ever received, she says.

Last Tuesday she had a man arrested, saying he was her husband. The man, however, insisted he was Albert's brother, Samuel.

Supreme Court Justice Humphrey, after holding five hearings in the case, yesterday sustained a writ of habeas corpus brought to free the prisoner. Samuel, as the man arrested, insisted he was named, then demanded the arrest of Mrs. Frank for perjury and her attorney demanded his arrest on a similar charge.

Assistant District Attorney Gallagher, after hearing several witnesses, had Mrs. Frank arrested and declined to entertain a similar charge against Samuel.

**N. C. TO COMPETE AT LEGION CONVENTION**

Charlotte, N. C., Sept. 28.—(AP)—Three drum and bugle corps of the American Legion posts in North Carolina will compete for national championship honors at the convention the legion will hold October 8-12 in San Antonio, Texas. These outfits will represent the posts at Charlotte, Gastonia and Raleigh.

**AL SMITH STARTS FORGET-ME-NOT SALE**

Minneapolis, Sept. 28.—(AP)—Unsolicited donation of \$100 by Gov. Alfred E. Smith, set Minneapolis chapter, disabled American veterans off on a flying start in its annual "forget-me-not" sale yesterday.

After Owen Galvin, chapter commander, had pinned a special "forget-me-not" on his label, the governor slipped a bit of paper into Galvin's hand, saying: "Hope this will start you off boys—I hope the drive is a complete success."

**PLEDGE TO DEFEAT WET CANDIDATES**

Butler, Mo., Sept. 28.—(AP)—Ministers of the St. Louis conference of the Methodist Episcopal Church stood pledged today to "do everything in our power" to defeat wet candidates at the November election. Two of the 250 ministers, who voted adoption of the resolution yesterday, protested the action was "putting the church in politics."

## Probe Death Of Man In New York

New York, Sept. 28.—(AP)—Investigation of the death of William D'Olier, important witness in the Queens county sewer contract investigation, was given impetus today with the report of the Queens county grand jury that he had been murdered. At first it was believed that he was a suicide.

D'Olier, president of the Sanitation Corporation which received subcontracts in the building of Queens county sewers, in which work it is alleged \$16,000,000 in graft was taken by various parties, was found shot to death on a lonely road in Queens county, September 2. A pistol was lying in the crook of his arm.

Police listed the death as a suicide but on the insistence of D'Olier's widow and other members of his family, an investigation was started. The grand jury heard 58 witnesses, but failed to discover who killed him.

D'Olier was to have been a witness in the trial of former Borough President Maurice E. Connolly and Frederick E. Seool, former Queens engineer of sewer design, now under way.

The death of D'Olier was the second among persons involved in the sewer investigation. John M. Phillips, head of the so-called "Queen sewer ring," died in Atlantic City, N. J., July 3, shortly after he was indicted with Connolly. The cause of his death was given as acute appendicitis.

Mr. Davis will begin his speech at 6 o'clock Eastern Standard time.

The count against him came as a result of the death of R. S. Henry, aged resident of the Remount Station section, who is said to have been run down by Nolan's car.
