# YANKEES AGAIN WIN WORLD'S SERIES

## Greenville Tobacco Market Averaged \$23.39 Yesterday

### NEW YORK TAKES FOURTH STRAIGHT VICTORY FROM CARDS BY SCORE OF 7 TO 3

**Babe Ruth Stars With Three Circuit Clouts Alexander Relieves Sherdel in Seventh; Hoyt Pitches Brilliantly for the Yanks.**

At Sportsman's Park, St. Louis, Oct. 8.—(AP)—Smashing all world's series achievements by making their second successive sweep to the championship the New York Yankees who badly beat the Cardinals for the fourth straight game seven to three. It was a record shattering orgy of home runs by Babe Ruth.

### SEEK SOURCE OF BAD WHISKEY IN NEW YORK

**Police Attempt to Determine Source of Liquor That Caused Many Deaths.**

New York, Oct. 9.—(AP)—City and Federal authorities joined today in seeking the source of the poison liquor that in three days has taken 32 lives.

Acting under orders from Police Commissioner Warren, police raided 21 alleged speakeasies in the lower Eastside where most of the deaths occurred. Samples of the seized liquor were sent to the city toxicologist for analysis and the owner or person in charge of each place arrested.

A specially qualified investigator with a picked squad was sent out by Mayor Maurice Campbell. Federal prohibition administrator for this district, to co-operate with the police.

Mayor Walker issued orders that the responsibility for the poison liquor be apprehended and prosecuted. He declared its distribution is more than a violation of the Volstead act and amounts to homicide.

Meanwhile the bodies continued to pile up at the morgue where autopsies of ten of the dead had shown that death was caused by drinking wood or denatured alcohol.

The policy of the government in using poison in denaturing alcohol was assailed by Dr. Charles Norris, chief medical examiner of the city. "Drinking is suicide," he said, "but accidental suicide. The ignorant, at least, should be protected as far as possible from poisons. I invite both presidential candidates to see the noble experiment in extermination."

Dr. Norris was sure that a flood of poison alcohol had been loosed on the lower Eastside and that none of the liquor sold in the better class speakeasies was responsible for the deaths. "It is too expensive for the poor," he said.

Some of the prohibition agents viewed the exceptional death toll as the first results of their efforts to dry up New York, the drive causing the lower class speakeasies to "cut" their drinks with denatured alcohol which had not been previously treated to remove the poison.

### BIG PARADE FEATURE OF CONVENTION

**Thirty Thousand Legionnaires To Take Part In Pageant At Texas.**

San Antonio, Tex., Oct. 9.—(AP)—Through flag-draped streets of this southwestern city, at whose nearby training camps and army posts many of them first heard the word "Legionnaire," more than ten years ago, 30,000 Legionnaires prepared today to march in review to the accompaniment of martial music from 100 bands.

The parade, feature and sole business of the second day's program of the tenth annual American Legion convention, was the magnet that promised to bring attendance to its peak. Adding to the 60,000 distant visitors estimated to be here now, hosts of south Texas residents poured into the city today to witness the event.

Starting shortly before noon, marchers will require more than three hours to pass one of several reviewing stands erected near Texas' shrine of patriotism, the Alamo. General John J. Pershing, secretary of War Dwight Davis, Field Marshal Viscount Allenby, Major General Henry T. Allen, Commander of the 90th Division of the Rhine, and other distinguished visitors.

Two thousand wounded veterans also have been given vantage points to view the pageant of marchers. Mothers, wives and sisters of the Legionnaires have positions in the line of march.

Visions of going over the top in a storm of shot and shell still were fresh in the minds today of Legion members, memories of days in the trenches having been re-kindled last night at a sham battle in which the infantry, tanks and field artillery depicted actual fights in France. Flares lighted the sky as cannon, machine guns, tanks and all the implements of combat figured in the storming of a position held by enemy troops.

Opening the convention yesterday National Commander Edward E. Spafford strongly advocated a uniform draft law and urged the convention to make passage of such a law a major objective. Major General Frank T. Hines of the Veterans' Bureau received progress in rehabilitation and hospital work and General John J. Pershing stressed citizenship rights.

The convention convenes again Wednesday. In the midst of the round of entertainment arranged for the city's visitors yesterday, the wheels of Legion politics were set in motion and definite lines were drawn for the contest Thursday to elect a national commander to succeed Edward E. Spafford.

Oklahomans were working diligently in behalf of General Roy Hoffman, for several years an outstanding candidate, who possesses strong alignment of delegates. Likewise, friends of General Albert L. Cox of North Carolina, announced considerable strength, and sponsors of Captain John D. Ewing of Shreveport, La., were enthusiastic as to their candidate's chances for election.

### SMITH LEAVES N. Y. FOR TRIP TO THE SOUTH

**Democratic Nominee To Visit North Carolina Capital Thursday.**

Albany, N. Y., Oct. 9.—(AP)—Primed for the second stage of his contest for the presidency, Governor Smith leaves Albany today for the first half of a journey that will take him into four southern and southern border states. Only one night—at Louisville, Ky., Saturday night—will be made this week, however, the other portion of the trip being set aside for train platform receptions and conferences with his party leaders.

Virginia and North Carolina will get their first glimpse of the New York executive as Democratic presidential nominee on Thursday and Thursday night, while Tennessee will have him as the center of a big reception and rally on Friday.

Leaving here by regular train shortly after noon, Gov. Smith, accompanied by his wife and daughter, Mrs. John A. Warner, and a few advisers, goes first to New York, arriving there around 4 o'clock. Tonight and tomorrow will be given over to callers from the Democratic national committee for any reports they may wish to convey and perhaps a personal visit to the party council center in the General Motors building. No definite program considerable to do with arranging for the nominee.

The trip to Dixie will get under way tomorrow night at 11 o'clock when the governor, joined by his entire escort, boards his special train at the Pennsylvania station. The nominee's decision to travel through the middle Atlantic states at night precludes any rear platform appearances along the way until he crosses the Potomac and gets well into Virginia.

It originally was planned to stage a reception in the national capital, but this was discarded, and it now is contemplated making Richmond the first stop to greet well-wishers. The partial itinerary as announced does not say how long the stops along the way will be, but gives only the following arrival times:

Richmond, 10:15 a. m., Thursday; Raleigh, N. C., 3 p. m.; Greensboro, N. C., 7 p. m.; Salisbury, N. C., 8:30 p. m.; Charlotte, N. C., 9:50 p. m.; Chattanooga, Tenn., 11 a. m., Friday; Nashville, 6:30 p. m.; Louisville, Ky., 10 a. m., Saturday.

The subject of the Louisville address had not been determined definitely today, nor had the itinerary for the trip beyond that city. Commenting on published reports that he would discuss the tariff in Kentucky, the governor emphasized that his text would be and would adhere to a policy of making no advance forecasts of subjects for any of his campaign speeches.

Gov. Smith will spend three hours in Chattanooga in conferences with party leaders and will continue his discussions in Nashville Friday evening. Rep. Joseph W. Byrns, from the Nashville congressional district and ranking Democrat on the House appropriations committee, will accompany the nominee on the trip through the south and will have considerable to do with arranging his conferences and receptions in his own state.

### Big Monoplane To Hop-Off For Rome Tomorrow

Roosevelt Field, N. Y., Oct. 9.—(AP)—Charles A. Levine's veteran monoplane, Columbia, was ready today for a take-off at dawn tomorrow on its second crossing of the Atlantic—this time to Rome.

Plans for the flight were announced by Roger Q. Williams, veteran aviator, who said he would pilot the plane with Pietro Bonelli as navigator and Levine as a possible passenger. Williams and Bonelli had been working for the last year with Cesare Sabelli on a projected flight to Rome in Sabelli's sesquiplane, Roma. Various delays held up the flight, however, and Williams said he and Bonelli had definitely severed connections with the venture.

### Democratic Vice-Presidential Nominee Spoke at Phoenix, Ariz., Last Night

Robinson's Special Car En Route to Los Angeles, Oct. 9.—(AP)—Senator Joseph T. Robinson, Democratic vice-presidential nominee, carried his campaign into the home state of Herbert Hoover today, following a long journey from the Middle West.

The senator broke the trip from Oklahoma with a few speeches en route, the last of which was delivered at Phoenix, Ariz., last night, on which occasion he again generously praised the record and character of his running mate, Governor Alfred E. Smith.

The senator depicted Governor Smith as a builder of schools, a defender of immigration restriction, an advocate of veterans' aid, and a plain man of the people in his speech before a large crowd. He asserted the platform of both great political parties were almost identical in regard to immigration.

In reply to the question of one of his listeners, Senator Robinson said that Governor Smith had not bolted the platform of his party in coming out for modification of the prohibition law and added: "The Democratic platform pledges the party only to enforcement of the Eighteenth Amendment."

Robinson said there never had been a Democrat or Republican prohibition candidate for president and that "so far as anybody knows, Herbert Hoover, Republican standard bearer, is not a prohibition candidate."

The vice presidential candidate attacked the record of the administrations of Presidents Harding and Coolidge for their attitude of aiding war veterans.

### NEW HIGH PRICE RECORD FOR SEASON SET ON OVER MILLION POUNDS OF LEAF

Over Million Pounds of Tobacco On Floors of Nine Warehouses Today With Indications of Continued High Prices; Market Nears 28 Million Pound Mark

Prices soared to new high levels on the Greenville tobacco market yesterday, and all previous records of the season were shattered by a margin of two cents a pound, according to information contained in the official report made public this morning by K. W. Cobb, secretary of the Greenville Tobacco Board of Trade.

The market disposed of a total of 1,221,158 pounds, paying out to the farmers \$28,722.55 at an average of \$23.39 per hundred pounds. Prior to yesterday's sales the record price of the season was \$21.29 per hundred pounds. This was made last Thursday on over a million pounds of leaf.

Approximately a million pounds of tobacco was on the floors of the nine warehouses today, the report stated, and indications were that the price situation would remain firm. Much good tobacco was in evidence today as on yesterday and this is expected to have much to do with the price situation.

The market continues to average over a million pounds of tobacco daily, with total season's sales nearing the twenty-six million pound mark. This record has been maintained throughout the season and it is expected to hold good for some time to come.

With Indian summer weather still holding sway over this section of the state, it was stated that sales were expected to continue heavy for the next several days. Farmers who have been busy putting in cotton and looking after other crops requiring attention, have been attracted by the upward trend of prices on the Greenville tobacco market and thousands are expected to make daily pilgrimages to the shrine of bright leaf tobacco during the next several days.

James J. Davis Will Speak At Winston-Salem

Winston-Salem, Oct. 9.—(AP)—James J. Davis, secretary of labor and dictator general of the Loyal Order of Moose, will speak here tonight in behalf of the Republican party. He went to Mount Airy this morning to inspect sites offered as possible locations for a Moose home. Since the announcement early in the summer that the Order of Moose had selected North Carolina as the state in which the home would be located to carry on work such as is now being done in Mooseheart or Moosehaven, Mount Airy, Winston-Salem has entertained the hope that a location in this vicinity would be chosen. The White Sulphur Springs, three miles north, has been often mentioned by local Moose, but the inspection tour of Mr. Davis as planned will include a trip up the Fancy Gap highway.

Mr. Davis will address the employees of the North Carolina Granite Corporation at the noon hour.

### Seven Men Stage Fist Fight Today At Courthouse

Charged with a stinging a free-for-all fight in the corridor of the Pitt county courthouse, seven men representing the Briley and Spain clans from the northside of Tar River, were this morning fined \$25.00 and cost, each, by Judge W. A. Darden, presiding over today's session of Pitt county court.

These fined were Edgar Briley, Clifton Briley, Early Briley, C. B. Spain, H. M. Spain, A. O. Spain and Asa Spain.

The fight occurred about eleven o'clock today on the outside of the court room. One of the Briley men had just been tried for a previous assault on one of the Spains. As the defendant passed out of the door of the courtroom, somebody hit him. Brileys and Spains tangled up and a pitched battle ensued.

Court officials were called in to action to stop the fight. One deputy sheriff is said to have felt the impact of a first as he stepped into the melee to help restore order.

The fighters were immediately carried back to the courtroom where they were required to leave twenty-five "barries" apiece, by the presiding official.

### Roman Way Is Unearthed At Old Italia

Seville, Spain, Oct. 9.—(AP)—A Roman way with stone pillars similar to those found at Pompeii has been unearthed on the site of ancient Italia, the foundations of a Roman house with marvelous mosaics, five by six meters, in a perfect state of preservation, were also found as were numerous objects of value.

(Italia was founded by Scipio Africanus about 205 B. C. as a refuge for his veterans. It was the birthplace of three Roman emperors, Trajan, Hadrian and Theodosius. In the middle ages and later the ruins served as a quarry for Seville.)

McLean; United States Senator Lee S. Overman, and O. Max Gardner, nominee for governor.

Definite plans for the parade were laid out for consideration at a meeting this afternoon of a special committee appointed by Mr. Poy to arrange for the occasion. Tentative plans call for invitations to all bands in this section of the state, who may wish places in the line of march, including college bands, and the entry of labeled automobiles from all different counties represented. Police from nearby towns will be expected to assist in handling the huge throng which have been entrusted to expected.

### About 300,000 Chinese Reported Massacred By Frantic Moslems Today

New York, Oct. 9.—(AP)—Dr. S. Parkes Cadman, chairman of the China Famine Relief organization in New York City, received information today of the reported massacre of about 300,000 persons by fanatic Moslems in Kansu Province, China.

Dr. Cadman received a letter from Leighton P. Rand, China Inland Mission, at Lanchowfu, Kansu, China, depicting the horrors of the situation which he says have been intensified by an insurrection of the Moslems, who form a third of the population of the Province.

### Communist Attacks Dominant Parties In Fiery Address

New Orleans, Oct. 9.—(AP)—The Democratic Republican and Socialist parties alike were attacked here last night in an address by William Z. Foster, Communist nominee for President, when he brought his party's cause into what he termed the "new industrialized south."

The nominee declared the key-stone of the Communist or Workers' party, the abolition of capital and the "capitalist system" in substitution he advocated setting up a communion of property and industrial ownership.

### Three Japanese Ships In Distress

Tokyo, October 9.—(AP)—Three Japanese freighters, the Oyama Maru, the Fukui Maru and the Irukayama Maru, were reported today to be in distress off the east coast of Japan after a typhoon which swept the region last night.

The Fukui Maru reported that two seamen had been washed overboard and perished. The Irukayama Maru was enroute to Japan from Grays Harbor, Washington. Warcraft was ordered from the Yokosuka naval to assist the vessel.

### Abandon Appeal For W. Hickman

Washington, Oct. 9.—(AP)—Efforts to obtain from a justice of the supreme court an appeal for William Edward Hickman at Los Angeles under sentence of death for the murder of Marian Parker, were abandoned today after counsel for Hickman had vainly urged Justices Butler and Holmes to permit the case to be brought up.

# HOOVER WILL VISIT N. Y. ON OCTOBER 22

## Considers Tentative Plans For Trip To Nation's Metropolis In Near Future.

Washington, Oct. 9.—(AP)—Herbert Hoover had before him for approval today a tentative schedule for his one-day visit to New York City on October 22, when he will deliver the fourth and last of his set campaign addresses in the Eastern section of the country.

The draft was prepared in New York by party leaders in conference with George Akerson, personal assistant to the Republican candidate. It called for a busy day, including conferences with political managers before the visit to Madison Square Garden where the address will be delivered.

The excursion into the home city of the Democratic presidential candidate will be less strenuous than that to be made to Boston at the beginning of next week, a journey which calls for overnight rides in going to and returning from the Massachusetts metropolis.

After his New York address, Hoover will return to Washington to remain perhaps a week before packing up for his journey across the continent, during which he will deliver at least one major address. He has stated that he will not add to his eastern itinerary. His last days will be devoted to final directions for the closing drives in the campaign.

Just now the nominee is dividing his time between preparation of his Boston address and conferences with his closest advisers as to strategies and policies during this, the most intensive part of the presidential fight. There are indications that renewed efforts will be made in a number of sections from which have come reports of situations that are not as satisfactory as those on the ground would like to see them.

Some disturbing reports have come in from the northwestern wheat producing section and it is being understood that Hoover has been urged by some of his advisers to make a personal visit to that territory during his trip home to vote, speaking preferably at the twin cities of Minnesota. Others suggest that he make St. Louis the principal point of call, but the nominee is withholding a decision pending later reports from western headquarters.

Amplifying one section of the speech he delivered last Saturday at Elizabeth, the Republican standard bearer, in a formal statement made public last night, said he entirely agreed with the proposal to dedicate the great government plant at Muscle Shoals to agriculture and the disposition of the surplus power "on such terms and conditions as will safeguard and protect all public interests".

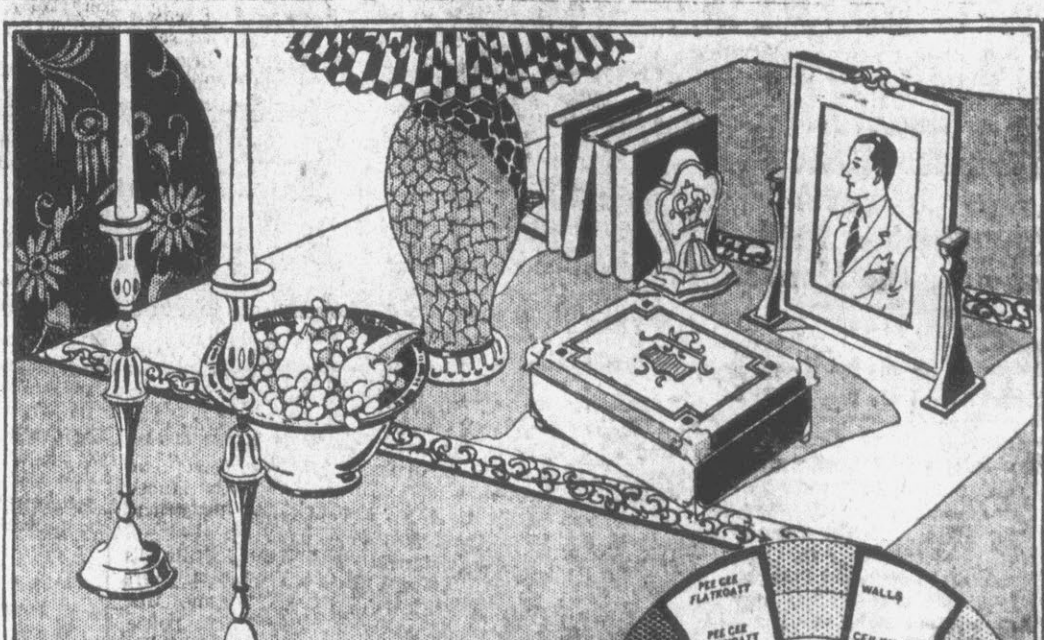

Taking three in a row makes the Yankees almost certain of the World's Series. The only question now is whether or not by the time you read this it will be all over and the Yanks have again won a championship by a four in a row count.

Voters of this county have a treat in store for them tomorrow night when Hon. Stanley Winborne, candidate for Democratic Elector from this district, delivers a public address at Ayden, and Congressman Lindsay Warrent speaks at Grifton. Every voter should avail himself or herself of these opportunities to hear the political issues discussed, and it is to be hoped that the Ayden and Grifton audiences tomorrow night will be large and enthusiastic ones.

MR. HOOVER AT ELIZABETHTON

Mr. Hoover divided his speech at Elizabethton about evenly between a description of modern democratic government as a vastly complex business, which it unquestionably is, and a summary of his attitude toward various issues which have been brought into the campaign through no great effort of his own. It was the general conclusion of the first half of his speech that now as never before "does

the keeping of our economic machine in tune depend upon wise policies in the administrative side of the government," and that those who know how to keep affairs "in tune" ought to be permitted to continue doing it. But with a grave farm problem directly affecting the happiness of millions of American citizens and indirectly the welfare of the Nation, with various highly protected industries like the textile industry enjoying profound depression, with nothing whatever done with such problems as railway consolidation and coal legislation, long ago described by the Coolidge administration as extremely urgent, and with the machinery of government so badly in need of reorganization that the President condemned its inefficiency in 1923, there is a good deal of doubt how successfully those who are now in charge of the government have put affairs "in tune."

In the matter of concrete issues, in the second half of his address Mr. Hoover repeated his earlier recommendations regarding farm legislation and also declared himself in favor of good roads, economy, foreign trade, the tariff, peace, flood control, public schools, a defensive army and navy, swift and surer justice and the civil service.

On none of these latter points is there much controversy. In two respects, however, Mr. Hoover clarified his earlier attitude toward matters in dispute. First, he dashed the hopes of those Eastern Republicans who have been doing their best to see in his candidacy some faint hope of modification of the Volstead act and declared himself a thorough-going prohibitionist. Second, he came out flatly, or nine-tenths flatly, against public development of water-power resources. With certain unspecified exceptions, he said that private development is to be preferred to the "deadly and destructive doctrines" of public development.

He made this statement in Tennessee, where Muscle Shoals has been a live issue for the last ten years. And the plain facts are (1) that not a single offer for Muscle Shoals issued from a private source which was deemed decent enough to be seriously debated at the last session of Congress, (2) that a bill embodying "the deadly and destructive doctrines" of public development was overwhelmingly passed by both houses, and (3) that this bill was given a pocket veto by the President.

What happens next? — New York World.

It will be heart-breaking finish should this ambition be realized. The Yanks would certainly be counted as baseball's immortals. Their feat of capturing so many world's series would go down as the greatest achievement in history of the sport."

# CAVALIERS TO PUT ON FINE GRID OUTFIT

RENEGAR (Associated Press Sports Writer) Charlottesville, Va., Oct. 9—(AP)—"Greasy" Neale's football teams are always slow developing—this 1928 Virginia team is no exception—but the Cavaliers will be able to give all comers a real tussle and will doubtless bump off at least half of them.

The fact that the Cavaliers could not stop South Carolina Saturday, although a setback, will not prove sufficient to break the morale of the team. Sloan, Close, Flippin, Turner, Whalen, Taylor—in fact the whole squad—has too much left to be downhearted.

They even hope here to catch Princeton napping Saturday, holding a belief the South Carolina team will jolt the Tigers into an easy frame of mind, so to speak. It's a heavy team at Charlottesville this fall. The line will average 185 pounds from end to end and has speed. And the backfield has experience.

Starting with the ends, there is to be numbered Harry Flippin, a star team man, whose speed serves him well; Turner, also fast going down; Byrd, center a year ago, and now converted into a flank man, and Ivey and Paxton, reserves. Turner is the lightest scaling around 160, while the others all go over 180 pounds.

At tackles, Captain Bill Luke, 209 pounder, is an inspiration of his men and steady in breaking through the line, whether it be on the offense or defense. Whalen, who weighs 212, will be a mainstay on the other side of the line while Debutts, Dunn and Capps will furnish the necessary reserve strength.

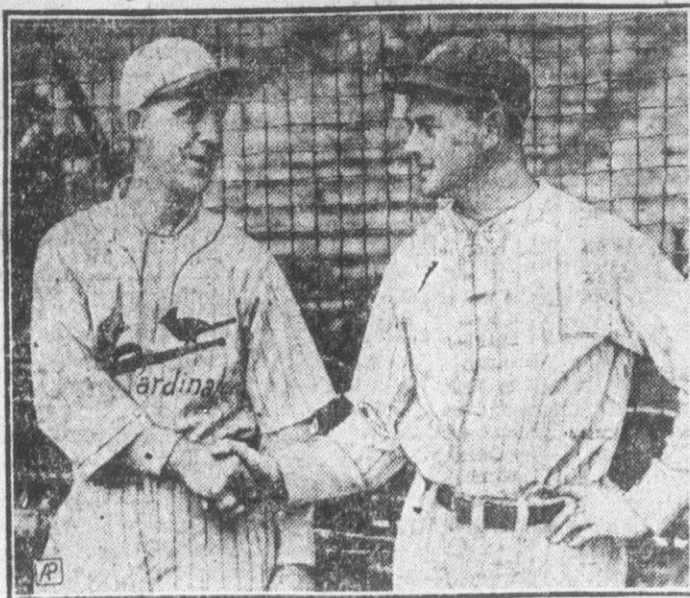
Veterans also will look after the guard positions. Motley, weighing 202 pounds; Symington, another experienced man; Harris and Austin will be the men around the center.

The Cavaliers have two fine pivot men, either standing ready to take ahead without weakening the line-up. Day passes well and uses his great weight, etc.

As for backs, besides Sloan and Close, a pair of aces, Neale has Pinkerton, Faulconer, Weaver, Smith, Marchant, Hayden, Anderson, Jannet, and Lewy, all good ball carriers.

Both Close and Sloan can pass well while the latter also is a fine punter and can count on an alternate kicker in Paulconer. Each will average 45 yards which is far from poor. Sloan also passes with his left hand while Close throws from the other side, thus giving the Cav-

The formations are fundamentally sound, few trick plays being used. The attack will be basically a running one with Sloan ready at any time to engage in a punting duel and probably get the best of the exchanges.

Once the tackling is improved, which can be expected soon, the Cavaliers will be hard to get by and also will offer a scoring threat sufficient to win from any opponent if not checked from the start by breaking through the line—which usually is a difficult task against a heavy forward wall.

It is football history that Georgia gave Yale's great team of 1927 its only setback and the way Mercer was annihilated, 52 to 0, last Saturday, indicated that the red and black again may replace the blue as predominant color

scheme at Newhaven for the day. Princeton takes on Virginia, beaten decisively by South Carolina last week and Harvard meets North Carolina which was hard put to pull out a 26 to 19 victory over Maryland.

# WISCONSIN IS PUZZLED IN POLITICS

## Insurgency Becomes Commonplace With Many Changes Now Pending.

Milwaukee, Wis., Oct. 9.—(AP)—In the ways of political insubordination, Wisconsin continues to keep her sister states interested and puzzled, even in a year when insurgencies have become commonplace. More than ever before, Wisconsin politics in 1928 is like a home-made house, which has been remodelled year by year by many carpenters. At the moment further alterations are under way, and the workmen themselves seem hesitant to predict whether the house will be found on November 6th to be facing East or West.

A fleeting glimpse of the chief architects of the state's political destinies shows the young senator LaFollette, heir to his father's leadership, running for re-election as the Republican nominee, on a platform that favors beer and the McNary-Haugen bill, and saying nothing about Smith or Hoover; LaFollette's Democratic opponent withdrawing in his favor; his Republican colleague, Senator Blaine, refusing to support the party's presidential nominee; a reconstituted Republican state organization, headed by one LaFollette opposition, seeking to rally the state's tremendous Republican majority under the Hoover banner; a Democratic committee doing what it can to promote the Republican split, and thus swing the state to Smith. Both sides are predicting victory, but both are still hard at work.

The materials at hand are of the most varied character. Taken more or less at random, they may be inventoried in part as follows: Wisconsin is a Republican state, which followed its favorite son, the elder LaFollette, on his third party venture four years ago and gave the Democratic nominee in that election but one-twentieth of its total popular vote. The count stood LaFollette, 453,678; Coolidge, 311,614; Davis, 68,115.

Wisconsin is a wet state, which

two years ago endorsed 275 per cent. been by a vote of two to one. Once the home of many breweries, it is described in the handbook of the Anti-Saloon League as having continued "a center of Anti-Prohibition agitation".

Wisconsin is the country's leading dairy state, and her farm problem often has been spoken of in terms of protective tariff for dairy products.

Wisconsin has a citizenship embracing a little more than the average percentage of Catholics, and far above the average percentage of German and Scandinavian Lutherans, many of whom harbor a long-standing antagonism toward Catholicism.

Wisconsin is interested in immigration, by virtue of her large foreign population, and her Germans and Scandinavians are being told by the Republicans that Governor Smith's immigration policies would favor Southern Europe. Large elements in the state are interested in the St. Lawrence waterway, favored by Hoover, and in government retention of waterpower sites, made a talking-point.

## Crimson Tide Causes Worry To Ten Rivals

Chicago, Oct. 9.—(AP)—Pat Page and the towering crimson clad Indiana eleven has whipped together on the banks of the Wabash are causing nothing but worry among their ambitious big ten football rivals this year.

Ever since the ingenious Page played football, baseball and basketball for the University of Chicago years ago, he has been busy blasting other team's championship hopes. At Butler, he made a great record and last year his Indiana team ruined Minnesota's title hopes by holding the Gophers to a 14-14 tie.

But this season Page has what is heralded as one of the most powerful eleven in Indiana's history. And while it is not regarded as a big ten title contender, its rivals, Michigan, Illinois, Ohio State, Minnesota, Northwestern and Purdue, respect and fear it. Coach Zuppke of Illinois is especially apprehensive as his team meets the Hoosiers in its first conference clash, October 20.

Page's hopefuls, strong in the line and fleet in the backfield, showed its fighting instinct Saturday when it came from behind to defeat the Oklahoma Sooners, 10 to 7. Indiana has some capable kickers, especially Hughes, who kicked a field goal from his 38 yard line against Oklahoma.

Michigan is Indiana's first conference opponent. They meet at Ann Arbor Saturday.

# NEW YORKER IS ASKED TO LEAVE FRANCE

## Correspondent of N. Y. American Classed As "Undesirable Foreigner."

Paris, Oct. 9.—(AP)—Harold Horan, correspondent of the New York American, has been requested to leave France before Thursday because of his connection with the public through the Hearst News Service of a memorandum covering the Anglo-French navy pact. The press bureau of the Ministry of Foreign Affairs notified Horan that France considered him an "undesirable foreigner" and warned him that he might be the object of a decree of expulsion.

The continental edition of the London Daily Mail today printed a statement furnished by the Paris bureau of the International News Service saying that Horan had finally consented to accept a decree of expulsion and thus undertook to leave French soil. He was offered the choice of doing this or of going to ante prison where he would be detained at the disposal of an examining magistrate. The statement concluded by saying "The French foreign office declines to take any action in the matter."

The statement was issued after Norman Armour, who is in charge of the American embassy in the absence of Ambassador Herrick, had twice visited the foreign office in behalf of Horan. Secretary Kellogg had instructed the embassy to take steps to insure that Horan's rights as a newspaperman were respected.

Horan said he had been detained by the police for seven hours yesterday and only released after he had signed a report of a cross-examination on how he obtained the memorandum. The press bureau of the Ministry of Foreign Affairs asserted that Horan had not been arrested but had simply been requested to appear to explain his

## Byrd Makes Final Plans For Trip To Antarctic Region

Los Angeles, Oct. 9.—(AP)—With only a day remaining before the scheduled departure on his Antarctic exploring expedition, Commander Richard E. Byrd and several aides busied themselves today with last minute details of the projected long stay in South Polar waters.

The commander announced he would personally supervise loading of tons of provisions and livestock aboard the whale, C. A. Larsen, due today from New York. It was anticipated that 24 hours after the Larsen docked, it would be loaded, and ready to sail for New Zealand, first rendezvous of the expedition's four ships. The Larsen, flagship, will be the last ship to depart from American waters.

## Several Injured In Mexican Quake

Mexico City, Oct. 9.—(AP)—Five persons were injured and damage was done over a wide area by an earthquake which rocked Mexico City and nine states of Mexico last night, reports to police and newspaper dispatches stated today.

One family in the suburb of Tauba was buried by the collapse of a wall which crushed the humble wooden shack in which they lived, injuring one child seriously and four others. Several buildings in various parts of Mexico City were damaged.

Dispatches from Oaxaca said that the earthquake was violent there and that a large part of the southern section of the city was in ruins with other sections badly damaged. The inhabitants were panicky. Some had abandoned their homes and were camped in the open. The tremors were preceded by a strong subterranean rumbling.

The Pacific port of Apulco, in the state of Guerrero, was violently shaken and several buildings were damaged.

This principle was recognized as far back as the passage of the Underwood tariff bill. Our platform re-states this in unmistakable language."

## Valuable Art Collection To Be Sold In U. S.

Hanover, Germany, Oct. 9.—(AP)—Because Ernest August, former Duke of Brunswick and husband of the former Kaiser's only daughter Victoria Louise, is hard pressed financially, Germany may soon lose a valuable collection of art relics to America. The collection, known as the Guelph Treasure, is of early handwrought jewels and furniture, including a cupboard and other relics brought by Henry the Lion from the Holy Land in 1173 when he made a pilgrimage there.

As sole heir and successor to the Dukes of Cumberland, Ernst August inherited this treasure. Beginning in 1857 it was exhibited for many years at the Vienna museum for art and industry. Later it was returned to the Duke of Brunswick who quietly shipped the treasure to Switzerland to avoid the possibility that the Federal Art commissioner might attempt to prevent its sale.

STOCK MARKET

New York, Oct. 9.—(AP)—Extensive readjustment of speculative accounts imparted an irregular trend to prices in today's stock market. Large selling orders appeared in a number of the recent pool favorites which has shown difficulty in breaking through their recent high records, losses of 2 to 4 points being distributed over a broad list. At the same time, buying operations were conducted with success in about a dozen specialties which were lifted to new high records.

Call money renewed unchanged at 6 1/2 per cent. But the supply was again so plentiful that the official rate was ahead in the "outside market." Bankers predict that the peak of the fall commercial demands will be reached within the next two weeks, after which money rates should ease moderately until the holiday demands begin to make themselves felt.

N. Y. Stock Exchange To Buy City Block

New York, Oct. 9.—(AP)—The New York World today says that the New York stock exchange is negotiating for the purchase of all other buildings in the block where the exchange is now located with the intention of centering all the details incident to trading under one roof. Elimination of messenger service, now necessary to transfer securities from one brokerage house to another, would mean an annual saving of \$10,000,000, the paper estimates.

The exchange and the buildings it proposes to buy are located in the block bounded by Wall, Broad and New streets and Exchange Place.

Governor Paroles One Of Needleman Assaultants Today

Raleigh, Oct. 9.—(AP)—Governor A. W. McLean today paroled four prisoners, one of them F. W. Sparrow, Jr., Martin county, who was convicted in May, 1925, of being a member of a mob that assaulted Joseph Needleman, Philadelphia salesman.

"An uncommonly large proportion of the leaders in all departments of life are the children of rectories and parsonages," he told Episcopal laymen, and "a large part of that leadership may be traced to the invariable custom of all rectories and parsonages to have family prayer as a part of the daily routine."

Plans Paradise For New York

New York.—(AP)—Edward W. Browning is willing to spend \$1,000,000 to turn a disused reservoir in Central Park into a paradise for the people of New York. He would put 1,000 men to work at once and make the reservoir into a swimming pool in summer and a skating rink in winter. His name would not be used; his motive is merely the pleasure of benefiting the little children and people of the city.

FARM PROBLEM BE SOLVED OR STATE OF PEASANTRY EVIDENT

Fremont, Neb., Oct. 9.—(AP)—The prediction was made by Senator Smith W. Brookhart in a Republican campaign address last night that unless the farm problem is solved within the next ten years, all farms will be operated by corporations and the farmers reduced to peasantry.

"The farm problem is the real problem," the senator said. "Since 1922 the value of farm land has decreased \$20,000,000,000 and in the same period 1,500,000 farmers lost their property and farm bankruptcy has increased 1000 per cent."

Senator Brookhart blamed the Federal Reserve law which he said "takes money from the farmers for use of stock gamblers." He also blamed high railroad rates under the Federal Transportation act.
