AL SMITH TO END FIGHT IN N. Y. TONIGHT

Democratic Nominee To Make Last Stand At Madison Square Garden.

New York, Nov. 3.—(AP)—Having taken the time in the home stretch of the presidential campaign to plead with all the force at his command for election of the State Democratic ticket headed by Franklin D. Roosevelt, Governor Smith winds up in Madison Square Garden tonight the most intensive fight of his 25 years in politics.

The Democratic standard bearer is confident he will be the next president of the United States and tonight he will tell the home folk the reason why he thinks so. It will be the last audience he will address in person and his managers hope to make it the largest of his three swings around the country.

Monday night, after Herbert Hoover has made his final 15 minutes appeal to the American people from Palo Alto, Calif., to retain the Republicans in power at Washington, the Democratic nominee will address the voters, but it will be from a radio broadcasting studio.

In his first speech in his home state since he addressed the Democratic state convention at Rochester October first, Governor Smith told an audience in the Brooklyn Academy of Music last night that it was up to the people of New York to keep the Democrats in power at Albany if they wanted to see "a constructive, forward-looking, wise and economical administration" of their affairs continued.

Discussing state issues and their relation to similar questions in the national campaign, the nominee assailed Albert Ottinger, State Attorney General and Republican candidate for Governor on his water-power, agriculture, education and State finance stands before he struck the question of prohibition.

He described Ottinger as a "wet dry" and said he had made the "interesting suggestion that he will wait until the commission appointed by Mr. Hoover reports on it."

"Well," the governor remarked "that is a little bit too long to wait. There isn't going to be any report because there isn't going to be any commission. I'll attend to that. As I have promised throughout the country I shall take that question to the American people and lay it before them fairly, clearly, straightforwardly and intelligently, and I shall let them settle it."

Loud applause greeted this statement and then the governor swung into his own eight years of administration of State affairs and challenged his opposition to find fault if they could.

"At no time in the history of this State," he said, "was the government of this State in as good condition as it is today."

"I am going through a national campaign; I am fighting some pretty bright men. They have plenty of brains and they have a great deal of money. We are within two days of election. Have you heard from the lips of any mortal man a single criticism about the government of this State under me? He can't do it."

The Democratic office holders at Albany, he continued, were giving to New York a "constructive, forward-looking, a wise, a capable and an economical administration of their affairs."

"They have paid attention," he said, "to the human side as well as to the business side—and that human side is a great side of this government. When I leave Albany no matter what happens to me, I want to see that preserved as I worked night and day to build it up."

The governor spoke in the Academy of Music, which is no larger than an ordinary theater. The result was that his audience of a few thousand was the smallest of his whole campaign.

It gave him one of the longest ovations of his 11,000 miles of stumping, however, when he entered ten minutes before he was scheduled to go on the air. The cheering and hand-clapping continued for more than 20 minutes.

At the outset, Smith paid a first tribute to his running mate Senator Robinson, of Arkansas since his notification speech.

"All during this campaign," the governor said, "I have not had an opportunity to say something that I want to say now that I am at home, and that is to extend congratulations, great good wishes, and heart-felt gratitude to my running mate on the ticket, Joe Robinson, of Arkansas. He is a man of extraordinary ability, great capacity, and a man of wonderful experience. He has used every bit of it in the last six weeks working night and day in the interest of the success of the Democratic ticket."

ASHEVILLE IS VISITED BY EARTHQUAKE

Other Sections Of Appalachian Chain Felt Two Distinct Shocks Last Night.

Atlanta, Nov. 3.—(AP)—The southern tip of the Appalachian Mountain chain was shaken by two light earth shocks at 11 o'clock, Eastern Time, last night, and the Piedmont region further south felt a single and lighter shock at the same hour. Damage was negligible but residents were alarmed.

Asheville, N. C., 50 miles south of Mount Mitchell, highest peak in the Appalachians, reported the heaviest shocks. They came in succession at 11:00 and 11:05 p. m., interrupting telephone communication in isolated instances.

At Chattanooga, Tenn., on the tip of the Blue Ridge, residents of one apartment house, when a tremor was felt in the city. Many residents reported that their houses were rocked.

Newspaper offices at Bristol, Va., were called frequently by frightened residents when the tremor was felt there. Two distinct shocks were felt at Spartanburg, S. C., as at Asheville, Kingsport, Tenn., and Greenville, Tenn., also reported a slight trembling of the earth.

A score or more were received at Atlanta police headquarters reporting the shock in the higher sections of the city. Occupants of the upper floors of tall apartment buildings reported that furniture moved about on floors, dishes and windows rattled in many parts of the city. Communication lines were not affected.

PREMIER OF ROUMANIA QUILTS POST TODAY

Vienna, Nov. 3.—(AP)—Vintilla Bratianu, Premier of Rumania since the death of his brother on November 24, 1927, resigned today.

The three principal leaders of the opposition parties, Iulio Maniu of the National Peasant party, People's party and Nicholas of Jorga, of the National party, will be received by the premier this afternoon.

It is probable that M. Maniu will be asked to form a cabinet in which Vintilla Titulescu, who recently retired from the Bratianu cabinet, will become foreign minister.

The resignation of Vintilla Bratianu apparently brings to an end, at least for the time being, the long rule of the Bratianu family in Rumanian affairs. Vintilla was never the dominating figure that his brother Ion had been, but he had always had a share in his late brother's confidence and acted as a trusted colleague and adviser.

The death of Ion Bratianu a year ago left the political situation in Rumania in somewhat of a turmoil, on had been a dominant personality in Rumania for a quarter of a century and even the late King Ferdinand and Queen Marie never were in a position seriously to dispute his judgment. Ion was the arch foe of former Crown Prince Carol and his policy of refusing to permit Carol to return to Rumania or to have anything to do with the Rumanian government was followed by Vintilla.

Even with the Bratianu out, however, it is not likely that there will be much change in the attitude of the Rumanian government towards Carol who is now in exile in Paris while the Rumanian throne is being occupied by his seven-year-old son, Michael, under a

NICARAGUA WILL ELECT PRESIDENT

General Election To Be Held Under Supervision of Marines Tomorrow.

Managua, Nicaragua, Nov. 3.—(AP)—Under the supervision of American Marines and an American election board, Nicaraguans tomorrow will elect a president in a general election for which the registration has been the largest ever known.

The country was described recently by Marine headquarters as peaceful, with General Augustino Sandino, who a year ago was actively leading a rebel movement, stated to be no longer a factor. Prohibition has been established for the period of the election by presidential decree. Manufacture of brandy is a government monopoly and large amounts of it have been handed out in previous elections by the government in exchange for votes. This year all government liquor warehouses have been padlocked and possession of ale or brandy by private individuals was prohibited.

The election board has taken over supervision of the government telegraph lines which in previous elections had been used by the government's political workers free of charge while the opposition party was denied the right to send telegrams to members of its own organization.

In order to prevent repeating, every voter will be marked on the hand with a chemical stain as he casts his ballot. Details of the method used have been withheld by the election board since it was thought that both parties might try to mark opponents in advance of the election to prevent them from being allowed to vote.

The candidates are: Conservative, Adolfo Benard of Granada, for President; Liberal, General Jose Maria Moncada of Managua, for President; and Enoc Aguada, for vice President.

The total registration was estimated at 150,525.

AVIATION CORPORATION TO INTERCHANGE WITH N. Y. CENTRAL LINES

New York, Nov. 3.—(AP)—The newly formed universal aviation corporation has arranged for an interchange of passengers with the New York Central lines, it was learned today. Companies being taken over by Universal Aviation operate air lines radiating from Chicago and extending to Cleveland, St. Louis, St. Paul and Minneapolis. From the latter point air routes extend to Duluth and Fargo, N. D.

Tickets will be sold by the New York Central offices and reservations will be made for east and west bound passengers, who will board or leave the planes at Cleveland.

Bale Of Cotton Highly Honored At Bremen Today

Bremen, Nov. 3.—(AP)—Never before have such honors been accorded a bale of cotton as were extended today to the bale which the Graf Zeppelin brought from Lakehurst, N. J.

An automobile truck adorned with the flags of Germany, Bremen and the United States and flowers in profusion met the bale at the railway station. As thousands cheered and cameras clicked, the cotton was hoisted out of a freight car and onto a raised platform on the truck.

The truck then proceeded with a solemn procession accompanying it through streets which were lined with people. After the town had paid the bale due honors it was placed in the cotton exchange where it will be auctioned off on Tuesday for the benefit of the airship's crew.

Three Killed In Automobile Wreck

Newark, Ohio, Nov. 3.—(AP)—Three persons going to the Ohio State-Princeton football game at Columbus this afternoon were killed today and a fourth is in a serious condition at the hospital here as a result of their automobile striking a truck on a curve and going into a ditch.

SIX HURT IN PLANE WRECK

Two Persons Seriously Injured When Passenger Plane Crashes In California.

Chico, Calif., Nov. 3.—(AP)—All six persons and two pilots of a West Coast air transport passenger plane were injured, two seriously, when the craft crashed in the heavily timbered mountainous country near De Sable 20 miles northeast of here, late last night. The plane was flying to San Francisco from Portland.

G. H. Putnam of Portland and B. Silver of San Francisco, the most seriously injured passengers, were rushed to a hospital here. Miss Mildred Devitt, of Seattle; C. R. Adams, of Portland, passengers, and Lewis Goldsmith, pilot, and Noel E. Evans, assistant pilot, were seriously injured.

The names of the other passengers were not immediately available.

The wrecked plane was discovered by a reclusé of the mountain country who brought four of the injured to a camp of the Pacific Gas and Electric company early this morning.

The plane left Portland yesterday at 10:10 a. m. and was due at San Francisco late yesterday afternoon. Goldsmith encountered heavy weather in crossing, landing at Corning, 150 miles from San Francisco, where he took on 200 gallons of gasoline to get him to his destination. He said the weather was bad but he believed he could make it.

Two hours later the plane was heard over Chico, barely fifty miles from Corning. Later it was sighted over Maxwell which indicated that it was flying in circles, and the pilot either had lost his bearings or was endeavoring to find a safe place to land. It was not heard from again until the wreck had been found.

Lone Sea Rover Loses His Ship

Amsterdam, Holland, Nov. 3.—(AP)—Captain Thomas Drake of Seattle, Washington, known as the "Lone Sea Rover" who has been on a leisurely voyage around the world in his 35-foot Ketch Pilgrim, has lost his little vessel in which he had sailed the seas for several years.

The Pilgrim was wrecked in a storm off the Island of Goeree and a total loss. The captain was rescued by fishermen and taken to Stiensman after having saved only a few clothes and instruments.

The American Consulate at Rotterdam has offered all assistance to Captain Drake who had intended sailing back to the United States by way of the Far East.

FLIER HEADS FOR SAHARA DESERT

Croydon, Eng., Nov. 3.—(AP)—Captain Malcolm Campbell, who is seeking to regain the world auto speed record, left in a light airplane today en route for the Sahara Desert where he hopes to discover a 12-mile stretch of road level on which to race his new 600-horsepower Canpuel-Capra car.

The captain decided to go so far ahead because no spot in Great Britain is available for the test.

PRICES STILL CLIMBING ON LEAF MARKET

Average Price On Over 45 Million Lbs. Of Leaf Today Stood At \$20.24.

The Greenville tobacco market for the present season has averaged \$20.24 per hundred pounds, according to a report of official sales made public this morning by K. W. Cobb, supervisor of sales. The average was made on 45,048,794 pounds of bright leaf, and is said to be the highest established by any market in this section of the state.

For the week ending yesterday the market disposed of 4,230,628 pounds of tobacco for a total sum of \$1,094,433.67. The average on this amount was given at \$25.86 per hundred pounds. This was the highest general average of any single week since the opening of the market and was a source of much gratification to the hundreds of farmers selling on this market. For the same week last year the market sold 8,826,374 pounds of bright leaf at an average of \$28.81.

For the forty-five million pounds of leaf disposed of during the entire season the market paid out a total sum of \$9,120,824.09. For the corresponding date last year the market had sold 42,356,094 pounds of tobacco.

The report stated that the quality of tobacco showed considerable improvement during the week just closed. Prices, however, showed a pronounced upward trend on all grades. There was over a million and a quarter pounds of tobacco here yesterday.

The market will close Tuesday, November 6th, in observance of National election day in order to give tobaccoists and farmers an opportunity of casting their votes in their respective communities. It was stated that Tuesday's schedule of leaf would be followed up to the same hour Wednesday when Wednesday's schedule will go into effect.

The goal set by the Greenville tobacco market for this season was seventy million pounds. With forty-five million pounds already disposed of and the crop virtually sixty-five per cent sold, tobaccoists today expressed opinion that the end of the season would see total sales near the goal mark. Sales last season went above the sixty million goal.

Two Men Burned To Death In N. Y.

Irvine, Ky., Nov. 3.—(AP)—F. P. Prindle, 26, New York City, power engineer, and Edward Tehan, 23, of Staten Island, New York, chief chemist, were burned to death in a fire of unexplained origin which destroyed the oil refining plant of the Texas Oil company at Pryse Still County, six miles from here early today.

The men were engaged in experimental work on the second floor of the three story building when the fire started on the first floor. The flames spread so rapidly they were trapped.

The bodies were found later in the ruins.

Although officials refused to estimate the loss, other persons estimated it as high as \$100,000. Three hundred employees temporarily were thrown out of work. Officials said the refinery would be rebuilt.

The two victims had been at the plant only a few weeks. The company completed a \$1,000,000 plant several months ago. The refinery was used to refine gasoline and lubricating oils.

Mount Etna In Eruption Again

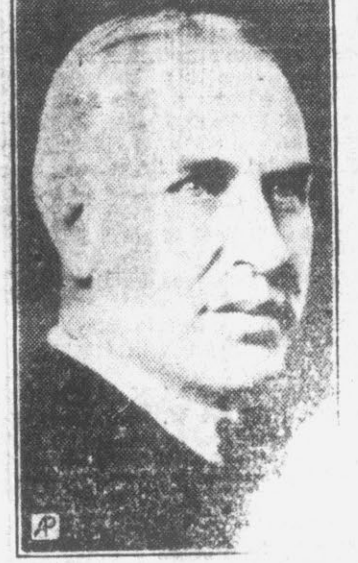

BREEDLOVES ALL FOR GOVERNOR AL SMITH

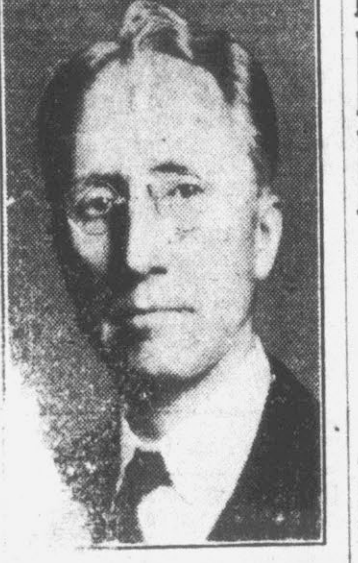

HON. RICHARD CLEVELAND PRAISES GOVERNOR SMITH AT POLITICAL KALLY HERE

"The Catholicism of Alfred E. Smith has no more to do with the Government of the United States than Herbert Hoover's Quakerism," declared Hon. Richard Cleveland, former president of the United States, speaking at the courthouse in this city last night.

"I have known thousands of Catholics during my lifetime," he said, "but none of them had horns, long tails and fiery breaths as pictured by those attempting to bring religion against Governor Smith."

The address was the last of the Democratic campaign in this county. It was heard by several hundred people who were packed and jammed into every conceivable nook and corner of the courtroom. The crowd was the second largest of the Democratic campaign in this county.

The speaking was ushered in by a concert on the balcony of the courthouse by members of the Greenville high school band. It was the first time music had been used in a political rally in Pitt County, and numbers of people who were attracted by the lively numbers of the youthful musicians.

W. E. Hooks, of Ayden, chairman of the Pitt County Democratic Executive Committee, presided over the meeting. In presenting Judge Albion Dunn, who introduced Mr. Cleveland, the county chairman urged his hearers to vote the straight Democratic ticket in the forthcoming election in order to insure a continuance of "white supremacy."

Judge Dunn declared the campaign the greatest and most bitterly contested in the history of the nation. He said the solidarity of the south was dependent upon the outcome of the election, and urged its hearers to vote the straight ticket. He declared the state must stand true to the traditions of its forefathers and support the principles which they made extant in the life of the country.

Mr. Cleveland said this was his first visit to North Carolina, but not the last by any means. He was greatly pleased by the things he had seen and heard and the spirit of progress evident upon all sides and congratulated members of the party for their activities.

His speech likened the fire and brilliance of the political orator, but there was something earnest and sincere about his delivery that immediately gripped the attention of his hearers and held it until the final words had died away. He remained for bitter utterances and courageously set forth the record of Governor Smith and his position upon the paramount issues of the campaign.

He told of some of the things that had come under his observation during his tour of the Middle West. He said there was no doubt in the minds of members of the National committee that Smith would be elected. The statement was not prompted by enthusiasm, but by carefully observing the reaction in the parts of the country which he has visited. Ohio and Indiana have been questionable all along, he said. Kentucky and Tennessee have a similar situation, but they are beginning to open the election seems to be quite favorable to the Democratic party.

"The Republican party started the religious campaign too early underrating the intelligence of the American people," Mr. Cleveland stated. "The insinuations have produced resentment and are reacting on decent people."

He said injection of the religious question was simply an absurdity. He couldn't find a more appropriate word to express it, and paused a moment as if searching his vocabulary for a synonym with more force and atmosphere. He didn't succeed, however, and left it with his hearers to decide whether the word fitted.

He said he had heard much about Anti-Smith and Hoover Democrats in the last several weeks. He admonished his hearers that if they wanted to turn down a man like Al Smith for what the opposition has to offer, it was their business, "but don't insult the rest of the people by calling yourselves Democrats."

He said character and decency were two of the most important essentials of a president. He declared Governor Smith learned decency in his early years and had practiced it in his administration as governor of the great state of New York.

"Decency is the spirit of faith upon which the party is founded," he said. "It is a medium of good government at the best. Everybody counts for one with Al Smith. His is an extraordinary character. He never goes back on any one."

"Smith is a master of association by reason of his long association with problems of this nature. Mr. Cleveland told his hearers. He has a sense of justice that translates decency into common government. He knows how to do things and does them. This is entirely different from the spirit that has dominated the national capital the last eight years."

He told of what prominent members of the Republican party had to say about the ability of Governor Smith before they had any idea he would ever become a candidate for the high office of president on the Democratic ticket. He quoted expressions from such celebrities as Euhu Root, Charles Evans Hughes, Cleveland, the county chairman urged his hearers to vote the straight Democratic ticket in the forthcoming election in order to insure a continuance of "white supremacy."

He sharply contrasted the capabilities of Herbert Hoover with those of Governor Smith. He said it would be poor politics and bad sense to attack the Republican nominee for the presidency. Hoover is a capable man for routine statistical operation. By training, he is well prepared for dealing with things of a scientific nature. He is an expert in engineering and on exports and imports. But these things are far removed from the duties evolving upon the shoulders of a president who is forced to use initiative in the vital problems confronting him from time to time.

He said Hoover had changed from a Democrat to a Republican, and from reading his speeches even at this time it is difficult to determine just where he stands. This is in striking contrast to the direct, forceful utterances of Governor Smith who has never left any doubt as to his position upon questions of great moment.

The speaker read an article clipped from the London Times that attempted to compare the temperaments of Smith and Hoover. It maintained that Hoover knew nothing of the rough and tumble of politics and consequently did not fit into the picture of a candidate for the high office of presidency.

"Smith is one of the greatest geniuses of the age. If the people knew him they would give him unanimous support. I am attempting to annihilate space to tell the people of the character and ability of this great man."

Discussing Tammany Hall, he declared that opponents of Smith did not refer to his affiliation with the great political organization until they got off where people didn't know anything about it. It is not brought into the campaign in sections where people know what the Democratic party is and has done for the Democratic party.

Smith's record of achievement as governor of New York he said should command the admiration of the entire country. He saved millions through programs of economy and would be able to do the same for the government. The Republican government of New York pointed with pride to their achievements, but turned around in the next breath and said Smith spent too much money.

Members of the Republican party injected the religious issue into the campaign because they were in desperate straits. But it is reacting upon them as intelligent people begin to think calmly over the things involved.

HOOVER MAKES LAST TALK AT PUEBLO TODAY

Presidential Candidate To Fire Final Broadside In Colorado City.

Hoover Train En Route to Pueblo, Colo., Nov. 3.—(AP)—Herbert Hoover began his day of campaigning in Kansas today at Council Grove in the midst of a snowstorm.

Although his train arrived 20 minutes ahead of schedule, several hundred persons were gathered here to welcome him. The Republican candidate, who was just finishing his breakfast, was a little slow in appearing on the rear platform of his car.

"Hurry it up; it's cold out here," one man in the crowd yelled.

The nominee appeared in a double-breasted gray ulster and his familiar gray Fedora hat. He waved to the crowd and inquired whether Kansas had heard his speech in St. Louis last night, in which he expanded upon his formula for farm relief. Several in the crowd assured him that they had.

Hoover Train Enroute to Pueblo, Colo., Nov. 3.—(AP)—Having completed his one campaign tour in the northern tier of border states, Herbert Hoover today passed into the normally Republican state of Kansas, the home of his running mate, Senator Charles Curtis.

Before him were a series of rear platform talks in the Sunflower state and the fourth and last address of his transcontinental trip. This will be delivered early tonight at Pueblo, Colo., where his special train will make a stop of half an hour.

During his two nights and a day of traveling from Washington, the Republican presidential candidate has been accorded enthusiastic receptions which culminated last night in a demonstration at St. Louis that struck the one given him at Madison Square Garden in the home city of his Democratic opponent when he closed his eastern campaigning more than ten days ago.

Speaking in the coliseum, Hoover presented to the formation of a new governmental institution, the purpose of which he said would be to meet not only the present farm needs but also those which might arise in the future.

"We propose to create a Federal Farm Board composed of men of understanding and sympathy for the problems of agriculture," he said, and adding that this board should have "power to determine the facts, the causes, the remedies which should be applied to each and every one of the multitude of problems which we mass under the general term, the agricultural problem."

"This program further provides more than investigation" he declared. "It provides that the board shall have a broad authority to act and be authorized to assist in the further development of cooperative marketing, that it shall assist in the development of clearing houses for agricultural products, in the development of adequate warehousing facilities, in the elimination of wastes in distribution and in the solution of other problems, as they arise."

"But in particular the board is to build up with initial advances of capital from the government, farmer-owned and farmer-controlled 'tabulation corporations which will protect the farmer from depression and the demoralization of summer and periods of surplus."

It is proposed that this board should have placed at its disposal such resources as are necessary to make its action effective."

In concluding his exposition of his farm relief plan, the nominee again expressed the hope that Congress at its December session would be able to pass remedial legislation, but said that if this should not be realized he would call a special session of the new Congress "in order that we might speedily arrive at a determination of the question before the next harvest."

Citing a more adequate tariff protection as one of the phases in his three-fold farm relief plan, Hoover stirred his audience by assailing the opposition for sponsoring the Underwood bill, which, he said, removed practically all agricultural products from customs duties.

"If you want the protective principle preserved, and if you want it strengthened on farm products" he added, "it should be entrusted to the party that has fought for and defended it for seventy years."

The nominee struck another responsive chord when he declared for the speedy development of the inland waterway system which would give twenty states a cheaper transportation outlet both to the Atlantic Seaboard via the Great Lakes and the St. Lawrence River and to the Gulf of Mexico by way of the Mississippi River.

POLITICAL FIGHT ENDING IN BURST OF ENTHUSIASM

By BYRON PRICE (Associated Press Staff Writer) One of the memorable political campaigns of history is ending in a dizzy burst of effort and enthusiasm.

As Hoover swings through the west, and Smith makes his final rounds among his neighbors in New York millions of their fellow citizens join in noisily to lift the drama to its proper climax. Party rallies are in progress in metropolises and hamlets, and party workers everywhere are lavishing advice on every wavering voter.

Most of this tumult will end tonight, when Smith speaks in New York City in Hoover at Pueblo, Colo., while scores of lesser figures on the stamp wind up their speaking tours and turn homeward to cast their own ballots on Tuesday. It will remain for the nominees themselves to sum up the argument in radio addresses Monday night.

As they prepare to close their doors, both Smith and Hoover headquarters are predicting victory. As put out for publication, these predictions on either side sometimes go the length of forecasting a landslide. When they talk privately the estimates of party lieutenants are less sweeping, but even then each insists that enough votes have been won to insure the election of his candidate.

Of course the details of these forecasts overlap, and both cannot be correct. It has been the sort of campaign to arouse unusual expectations, and party leaders down along the line have made surprising reports to their superiors—reports which even the most enthusiastic of the experienced politicians hesitate to believe. Some Democrats even now are claiming Pennsylvania and Michigan, and some Republicans are claiming Georgia and Arkansas. When such predictions are voiced in the presence of any leader of the opposing party, they are greeted with ridicule. Yet they illustrate the vague hopes which are afloat upon the twisting current of this campaign.

Even though they are so conflicting that one set or the other must be regarded as unworthy, the more studied predictions of the politicians, as made privately, meet at certain points and are worth analysis. They disclose a general agreement that expectations of a Hoover victory are based on the premise of a Republican sweep through the east and west, enveloping the border and perhaps a part of the south; and that expectations of a Smith victory rest on a supposition that he will hold the south, take a good part of the east, and pick up a few additional states here and there along the border, in the farm country, and in the far west.

The overlapping aspects of these calculations point to certain states as highly important factors in the result—states earnestly claimed by both sides as a part of the quota of victory. They forecast a particularly determined battle, in the very last hours of the campaign, in such eastern states as New York, Massachusetts, Maryland, and Rhode Island; in the border states of Kentucky, Tennessee, Missouri, and Oklahoma; in hotly debated mid-western and northwestern states like Nebraska, Wisconsin, and North Dakota; and in the far western states, notably Montana, Nevada, Arizona and New Mexico.

The list does not, of course, include all of the states in which the

hopes of the parties overlap. It does include, however, most of the states in which the minimum claims of the more modest of Smith and Hoover partisans come into violent contact. In the east, some Democrats would claim not only the three states named, but would add also New Hampshire, Connecticut, Delaware and New Jersey. In the south some Republicans are stoutly claiming North Carolina, Florida, Alabama, Virginia and Texas.

There is a similar situation in every section of the country, and for the first time since present party alignments came into existence, a complation of the more optimistic of Republican and Democratic claims would involve almost every state in the Union.

Not that conflicting pre-election claims are in themselves, anything new; the novelty this year is in the particularly wide range of the conflict, and the extraordinary reasons which underlie it.

this amendment which should be evidence that it would be a great help toward carrying on the work of the courts of our state.

The third, but by no means least in the order of importance, is the amendment that would permit the Legislature to classify intangible personal property and prescribe a uniform rate of tax throughout the state for each class. Those who have studied the situation declare that this change is essential to the proper functioning of the tax system in the present day. Thirty-one states have already adopted a provision similar to the one now sought in this state and in each instance those states have greatly benefited from the tax derived from the increased amount of intangible property listed as a result of the change.

As matters stand, certain classes of intangible property can not now be returned for taxation in North Carolina without virtually confiscating the income from this property. A bond for instance, yielding five per cent interest would be taxed in some counties at the present time more than four per cent, leaving the income to the owner of the bond one per cent. The result is that today neither bonds nor mortgages are generally returned for taxation in North Carolina. If the Legislature were authorized to classify securities of this character, imposing a low tax rate which would be uniform throughout the State, this property would be put on the tax books and would yield a substantial income to the cities and counties.



"I told Mr. Mull, Chairman of the Democratic State Executive Committee, that if he would run his campaign upon the record of the Democratic party in North Carolina, and because of the extraordinary conditions brought about in the national situation by Smith's nomination, let the people vote according to their convictions on the national ticket there would be no division among the Democrats on the State, district and county tickets.

"I have received probably 2,000 letters from people in North Carolina and outside of North Carolina, of course the bulk of them coming from North Carolina, and in the answers to most of them I have appealed to our people to support the State, district and county tickets, because our record here in North Carolina has been a wonderful record, and one we have a right to be proud of, and one that has excited the envy of every state in this Union.

"I understood he agreed to that. He gave out an interview, at least in the Charlotte Observer, in which he said they were going to make their campaign upon the record of the Democratic Party in North Carolina, and there they were going to stop, and they did stop there for a while. The first speech Gardner made seemed to stop there. Then all at once, for some strange reason, I do not know why—you can exercise your imagination about it, as I have exercised mine—for some reason or other they dropped the State ticket, dropped it altogether and they have been paramounting Smith ever since.

"We ought to stand by that ticket. The platform is all right. We stand on it. I stand on it with both feet.

"I am not a prejudiced man. My action in this matter is based upon my conscientious conviction. Feeling as I do, it is utterly impossible for me—I would rather have this right arm cut off, I would rather have my tongue cleave to the roof of my mouth, I would rather give up all my political honors—than vote for Alfred E. Smith for President of the United States.

"I asked them to read the State platform, and then explain to the people how they can possibly reconcile their position with regard to Smith with that platform.

"All I have ever said in this campaign upon this subject is this: I have said to these people, to Mr. Mull and to Mr. McLean and to the balance of them who have talked with me, that what I demanded in this campaign for myself I demanded for all the balance of the people of this great State.

"I have denounced any attempt to round up the Democratic people of North Carolina like a flock of animals under the lash of the party whip.

"I maintain that everybody in North Carolina, because of the extraordinary conditions that have arisen with regard to Mr. Smith's repudiations and affiliations, is entitled to vote on the National ticket according to his conscience, conviction and judgment, without feeling any party restraint.

"In the extraordinary situation which exists, you have the right to vote for whomsoever you please on the National ticket. It is your duty to do that, without any fear of being read out of the Democratic Party. They cannot read you out of the Democratic Party. You can read them out, because they put themselves out, but they cannot read you out.

MR. COOLIDGE LAUDS HOOVER TO THE SKIES

"Silent" Cal Comes Out With Declaration of Fitness of Republican Candidate

Washington, Nov. 3.—(AP)—High praise for Herbert Hoover came last night from the White House.

Breaking for a second time the silence which he otherwise has maintained consistently with respect to the presidential campaign, President Coolidge wired the Republican nominee at the conclusion of his St. Louis address an expression of confidence in his ability to administer the affairs of the nation and a declaration that he had demonstrated a fitness for the presidency.

Although reports persisted for weeks that Mr. Coolidge would at some stage take an active part in the Hoover campaign, he had previously made, but a single public pronouncement in this connection—a message to the Massachusetts State Republican convention asserting that the country needed a continuance of Republican rule.

Last night's telegram was dispatched after the president had heard Hoover's speech through the White House radio. There had been no indications that such a step was contemplated.

Declaring that he had listened to the St. Louis address with great satisfaction, Mr. Coolidge termed it the concluding speech in a series which had disclosed "a breadth of information, a maturity of thought and a soundness of conclusion on public questions never surpassed in a previous presidential campaign."

The chief executive told the nominee he had had "the knowledge and judgment" to "tell the people the truth," that he had been clear, candid and courteous and had demonstrated a faith in the people and a "consciousness that the truth has a power and conclusiveness of its own that is always supreme."

The discussion, Mr. Coolidge said, had "only made more plain the wisdom" of Hoover's proposals for meeting the issues of the day.
