ANOTHER TOWN IS WRECKED BY VOLCANO FIRE

Communication Of Sicilian Town Cut Off By Torrent Of Molten Lava.

Catania, Sicily, Nov. 10.—(AP)—The railway bridge at Mascali today fell prey to the molten torrent of lava pouring down the eastern slope of Mount Etna which has destroyed the town of Mascali, and was devastating the neighboring village of Nunziata.

The flow across the railroad tracks cut communication between Catania and Messina. Steamship service between the two places was inaugurated, four trips being made daily by four ships.

The village of Carrabia was cleared of inhabitants. Factories and mills in the region were being dismantled.

The molten torrent was also consuming another Sicilian village which lay in its path. Nunziata, a neighboring village to Mascali, which has been burned with the loss of three lives by the lava flow, has fallen prey to the fiery stream.

The inhabitants of Nunziata fled from the village as the lava advanced. As the smoking volcano became more active the glowing current crept into the town.

Pushing steadily onward at a rate of five meters an hour, the principal fiery current passed a point sixty meters from the railway station of Mascalia and continued its advance. A stream that had been advancing to the north joined the larger and central one and added force.

The third and southernmost stream was advancing at the rate of 32 feet an hour, and threatening the railway bridge at Giarrè.

The spirit of the Sicilians is unshaken in the face of this menace of the mountain on whose slopes they dwell and which periodically destroys their property. The inhabitants of Mascali have been comforted by a promise of the government to rebuild their town when the eruption is at an end. The government will construct 200 to 300 new houses at its expense.

The plight of the peasant folk is pitiable. The lava stream poured across land valued at from \$2,000 to \$2,500 an acre. Those who owned fifteen or more acres of this fruitful land were considered rich. This year there had been an enormous demand for lemons which are gathered twice yearly. The fruit was being nearly three cents apiece on the tree. Now the molten stream is creeping through these orchards and destroying them.

Once prosperous farmers today were filling their pockets with loot from the trees, slinging wine bottles over their shoulders and trudging away from the scene of desolation or begging rides to safety. Others were selling for a song what was left of their once ample stores of fruit and wines.

Developments during the past 2 hours showed that this was the most important outbreak of Mount Etna since 1869 in the point of lava flow.

Watchers spent a sleepless night observing the uncanny effects of the molten mass upon what was the richest fruit and grape bearing land of Sicily. The whole ruined country was studied with trees burning like torches while the relentless sweep of the torrent was punctuated by strange explosions. Crickets were formed and gave forth a strong odor like gasoline. It was thought that the explosions were due to combustion caused by the intense heat of the subterranean masses developed by the putrefaction of vegetable matter in the soil which is rich in water.

The cutting off of railroad communication was expected to be followed shortly by the blocking of the highway. The railroad was operated up to the last minute, nearly 2:00 a. m., then the lava moving 65 feet in two hours began to take possession.

Just as darkness was descending over Valbuena flying field the airplane swooped down upon it from the north where he had been hunting at the remote ranch in the state of Chihuahua. The volcano Popocatepetl and the encircling mountain range were still crested with the crimson of the setting sun when Colonel Lindbergh taxied across the field.

LEAF MARKET NEARS FIFTY MILLION MARK

Market Believed To Have Set World Record In Volume Handled This Season.

Season's sales on the Greenville tobacco market today stood at 49,652,802 pounds, according to official report of sales made public this morning by K. W. Cobb, supervisor of sales. For the corresponding period last year the market had sold 5,912,746 pounds.

For the season the market has sold out a total amount of \$10,194,265.2. The general average was \$20.62. The week ending yesterday the market averaged \$24.87 on 4,170,000 pounds of tobacco. The total amount paid out for this amount was 1,073,802.43. Sales yesterday amounted to 1,050,956 pounds for \$29,576.23, the average being \$27.79.

The report stated that it believed the Greenville market had established a world's record in the amount of tobacco handled with our sets of buyers during the 48 sales days. Buyers were heartily commended for their long hours of early and close attention to the market activities.

The general average of the market yesterday was somewhat lower than the preceding day because of the great volume of inferior grades of tobacco in evidence. Good tobacco continued to bring excellent prices, and tobaccoists expressed confidence that this would continue.

It was stated that Monday would not be observed as a holiday by the market and sales will continue as usual. There will be no more holidays until Thanksgiving Day.

Discredit Story Of Young Woman In Shooting Case

Memphis, Tenn., Nov. 10.—(AP)—Deputy sheriffs investigating the fatal shooting last night of Robert McDonald, 18, and the wounding of a young girl companion announced early today that their findings discredited the story of a freak accident told by the girl and friends of the two.

The officers said McDonald was shot three times through the body but not once as told in first accounts which described the shooting as having resulted when the entire McDonald's car and in one manner jarred a rifle lying in the rear seat.

Mrs. Beth Seavers, 14, three generalists McDonald, was wounded above the eye. She told officers and doctors at a hospital that the same bullet which struck her glanced from her head into McDonald's body. This story, the officers declared was proved false by the later findings.

The shooting occurred near the front door of a home where the couple had attended a dance. The owner of the home and other guests were questioned but officers said no motive for the shooting at the hand of a third person had been established. No arrests were announced.

Cambrai, France, Nov. 10.—(AP)—This town, which was one of the battlegrounds of the war, has called its felicitations in behalf of the devastated sections of France to President-Elect Hoover. The message recalls "the preponderant role he played in rationing the invaded departments of France."

Maryland School Head Addresses Conference Of District Teachers

"We believe that it is a sound principle that those sections of a state which participate in the equalizing fund should guarantee to the state at large that the money received from the state fund should be as efficiently and as economically spent as is the money spent in the largest and best schools in a state," declared Dr. Albert S. Cook, State superintendent of the Maryland schools, yesterday at the sixth annual meeting of the Northeastern district of the North Carolina Educational Association. "In Maryland," he continued, "we are convinced that efficient supervision of class room instruction by well trained women increases the efficiency of the average class room teacher at least 25 per cent. For that reason we have provided that there shall be a supervisor for every fifty teachers in the elementary schools."

The Maryland educator said that this was not done as a means of the state keeping control of the education of the state through dominating the class room teachers. It was not merely an effort to provide jobs for a large number of well trained teachers. It was done as an economy measure because it resulted in so much better class room work that the average child learned at least twenty five per cent more in any year than he could have been learning previously even though the teaching was done by teachers with the same training and experience. Supervision, therefore, is put on in Maryland as a means of seeing that the people get the most instruction for their children for the money that is expended on teachers' salaries. We have found that it works, and that this is the best means of getting the best grade of work from teachers even though these teachers are well trained," he said.

Dr. Cook contrasted the two state systems of education in Maryland and North Carolina and told his audience, composed of around 1500 teachers from the northeastern tier of counties that a speaker could talk about both school systems in the same terms, because there was a great deal of similarity between the two systems. Both provide an equalizing fund to aid the less wealthy counties. The equalizing fund is distributed on practically the same basis as it is distributed in North Carolina. He thought that in some respects the North Carolina law was a better one than the Maryland law because it required a county to levy only a forty cent tax for teachers salaries before it had a right to participate in the fund, whereas in Maryland a county has to levy 67 cents local tax for salaries before it can participate in the fund.

The speaker advocated a yearly salary for teachers rather than a monthly salary. This he believed would solve the problem of the length of term, because if the teachers are employed on a yearly basis and paid an adequate amount for their services, the schools could be run just as long as the authorities and people thought they should run without automatically increasing the cost on a very large scale.

Dr. Cook followed Dr. A. T. Allen, late superintendent of North Carolina on the program of the first general session yesterday at the meetings which were held at East Carolina Teachers College. Mr. Allen told the audience something of the progress that had been made in public education in North Carolina during the past twenty years, citing facts and figures which he believed were out of the ordinary.

He thereupon went to the Elvsee Palace and told President Doumergue that he was going ahead with his task in accordance with this decision.

Two Men Fatally Burned In Blast

San Diego, Cal., Nov. 10.—(AP)—Lieut. W. W. Seagriff, of the navy, attached to the torpedo school here, and Harry McArthur, a civilian, said to live in Los Angeles, were burned, probably fatally, last night in an apartment explosion which police said was caused by exploding alcohol.

Ensign Joseph B. Danhoff, also stationed at the navy yard here, was arrested on a charge of violation of the state prohibition act. Danhoff said the two men burned were in a small kitchen of the apartment where a kerosene lamp used to light the place was burning, suddenly there was an explosion, he said, and the two men rushed out, enveloped in flames.

Roosevelt On Way To Georgia

Charlotte, N. C., Nov. 10.—(AP)—Franklin D. Roosevelt, Governor-elect of New York, passed through Charlotte this morning en route to his winter home at Warm Springs, Ga.

Mr. Roosevelt told a reporter who was at the station that he believed that national political affairs are well set up to form the basis of a reorganization which in 1932 will make the Democratic party stronger than it was in any recent campaign.

He expressed regret that Senator F. M. Simmons, Democratic senator from North Carolina, had seen fit to join the "bolter". During the conversation he said that he had no formula to suggest for the admittedly needed reorganization in North Carolina, saying that the situation was "very delicate" and had to be handled "very carefully."

He was asked a question intended to elicit his opinion regarding the likelihood that he would be the Democratic party's nominee for President four years hence, but "carried the question by saying that the big and important thing now was party reorganization.

RED CROSS TO START ROLL CALL NOV. 12

Week Set Aside For Receiving New Members To The Organization.

The week of November 12th has been set aside at Red Cross Roll Call according to announcement made today by Mrs. J. L. Hassell, chairman of the Pitt County chapter of the American Red Cross.

During that week the local chapter will solicit new members in the organization and it is hoped every citizen of the county will become a member.

Mrs. Hassell today issued the following statement relative to the roll call campaign in Pitt county: "Membership in the Red Cross will cost you one dollar—and as much more as you will give—and this gives you an opportunity to share in the organization's work for humanity, for the annual dues to finance the national program as well as the work of the local chapters. So when you are called on for your dollar, just forget the numerous other calls, and remember, that in this small way you are helping to keep the Red Cross prepared for the emergencies that arise.

The disaster hardly happens before the Red Cross is moving to the relief of the stricken area. A little more than a year ago the Mississippi River rose in its fury and laid waste to a vast territory. 600,000 people turned to the Red Cross for help. The service rendered gave a demonstration of efficiency never before equaled. By the time the hurricane struck Porto Rico and headed for Florida the Red Cross was moving South and but for a few hours delay, they would have been on the spot when it reached Florida.

I am sure, where you stop to think what the result would have been, had it been necessary to put on a drive for funds before giving assistance you will heartily approve their plan for preparedness and be more than glad to renew your membership and feel that in so doing you are helping in the relief of suffering humanity.

William B. Smith, in 29 counts, is charged with extortion, maintaining a gambling house and conducting an illegal lottery. The indictments were returned by the November grand jury after Mark Johnson, a negro, had testified that he and Smith had been partners in a lottery known as the "Number Game."

Smith is the second Republican leader to be indicted as an outgrowth of the special grand jury's inquiry. The first, Matthew Patterson, was convicted and sentenced to five years in the county prison. He has an appeal pending in the State Superior Court.

Both Smith and Patterson were re-elected to the Legislature last Tuesday with comfortable pluralities.

New Japanese Monarch Ascends Throne Today

Kyoto, Japan, Nov. 10.—(AP)—A new sovereign today formally ascended the "high august seat, the Throne of the unbroken line of the heirs of the sun goddess whose tradition says have reigned over Japan from before the dawn of authentic history.

Before the highest dignitaries of the realm and representatives of twenty-six other nations, from his majesty under the Phoenix-crested canopy, Hirohito made the announcement this afternoon by which he took his place as the 124th Emperor of Japan, and among the enthroned monarchs of the world.

The climax of this solemn and meticulously planned and executed ceremony came precisely at 3 o'clock, when Premier Baron Tanaaka, standing at the foot of the stairs of the throne hall, led the brilliant assemblage in three cries of "Banza!" The train robber appeared suddenly in the mail car of the train as it left Fort Worth, and forced M. E. Pruitt and P. E. Carny, clerks, into mail sacks which he drew together and locked. Seizing the currency, a consignment to the Dallas Federal Reserve from banks in Abilene, Cisco and Seymour, Texas he jumped from the train as it gathered speed. A small satchel, containing the money in \$5, \$10 and \$20 bills was found shortly afterwards by police and the trap was laid.

It was believed the robber boarded the train east of Fort Worth, Texas.

Virginia Gives Herbert Hoover 24,515 Majority

Richmond, Va., Nov. 10.—(AP)—Complete unofficial returns from the 1,665 precincts in Virginia give Herbert Hoover a majority of 24,515 votes over Alfred E. Smith in Tuesday's election. The total Hoover vote was 165,510 as compared with 140,995 votes for Smith.

The vote given Governor Smith in the Old Dominion was 1,198 votes above that given to John W. Davis, who carried the state by a big majority in 1924, and was less than 1,000 behind that given Cox in 1920.

The Hoover vote was compared with 73,359 given Coolidge, a majority of 92,151 in favor of Hoover Harding received 87,456 votes in Virginia.

The greatly increased registration resulting from the intense interest in this year's campaign was well borne out in the voting, the total vote of 306,505 being the largest on record and in advance of even the most extreme pre-election forecasts.

Gov. Smith carried 52 counties and six cities of Virginia while Hoover carried 48 counties and 17 cities. Hoover won in practically all of the larger cities except Bristol, Petersburg, Suffolk and Charlottesville.

Both Smith and Patterson were re-elected to the Legislature last Tuesday with comfortable pluralities.

HOOVER PLANS FOR VISIT TO SO. AMERICA

President-Elect Expects To Study Conditions Of The Other America.

Stanford University, Cal., Nov. 10.—(AP)—Herbert Hoover contemplates spending forty days on a tour of South America, the only continent upon which he has yet to set foot, before returning to Washington for his inauguration as president on March 4.

Under present plans he will sail from a Pacific coast port, probably San Diego, within a fortnight, and end his long journey at some point on the Atlantic seaboard early in January, thus spending Christmas either in South America or on the high seas.

In desiring to visit the other America the president-elect has the two-fold purpose of fostering good will between his own country and to those of other nations.

Friends of the president-elect emphasize that this is to be in no sense a diplomatic mission, but purely one of good will. Thus the president-elect would keep clear of any discussion of pending diplomatic questions, such as Taft-Aries, adhesion to the Briand-Kellogg peace treaty denouncing war, and tariff questions, which have been the subject of exchange between the American government and some of the South American countries.

While the personnel of the party which would make the trip has not yet been named, the expectation is that Hoover will be accompanied by an official of the state department which under the leadership of President Coolidge has fostered the proposed good will mission.

In the party also would be several of Mr. Hoover's advisers including his secretary, George Akerson, and a limited number of newspaper correspondents and news cameramen. Should the contemplated journey be embarked upon, and there is no doubt here that it will be as soon as diplomatic exchanges between Washington and all the countries to be visited have been completed, it would constitute a precedent for never in history has there been a president or a president-elect of the United States who visited South America.

However, visits of presidents and president-elects of the Latin-American republics have not been uncommon. Brazil and Cuba have sent president-elects to this country in recent years.

While discussing policies of his administration during his campaign for the presidency, Mr. Hoover stated that one would be the fostering of the closest relations, commercial as well as diplomatic, with the Latin-American countries. As secretary of commerce he inaugurated several policies designed to improve commercial relations.

Formal announcements of the itinerary of the South American tour will be made here as soon as the necessary arrangements can be completed.

Show Girl Gets Sixth Of Income Of Slain Gambler

New York, Nov. 10.—(AP)—A former show girl is to receive one-sixth of the income from the estate left by Arnold Rothstein, grain gambler, under terms of a will signed on his death bed.

Although he will not have been filed for probate his provisions were made known by the slain gambler's associates. His estate is estimated at \$10,000,000, but much of this is said to consist of heavily mortgaged real estate and loans granted gambler.

The girl legatee is Inez Norton, who has been living at the Fairfield hotel, owned by Rothstein. Of her associates, few knew little except that she had been a show girl and was a divorcee. Her one-sixth interest in the income is to run only for ten years.

Rothstein's widow, from whom he had been estranged but who visited him at the hospital after he was shot last Sunday, receives the income from one-third of the estate for life. At her death, the money is to go to charity. His two brothers, Jack and Edgar, are to receive outright \$50,000 and \$50,000 respectively, and the income from 20 per cent of the estate for ten years. His three executors, Maurice Canlor, his attorney, Samuel Brown and William Weisman are to receive one-sixth of his estate. Other bequests were \$15,000 to Thomas Parley, Rothstein's negro valet, and the income for ten years from a \$75,000 trust fund to Sidney Stager.

No mention was made of his parents, who are moderately wealthy, but it was said he had provided for them before his death.

The will was drawn two weeks before Rothstein's death.

District Attorney Joab Banton and Police Commissioner Warren said today their investigation of playing was proceeding satisfactorily. Banton said he knew the names of the four men who were with Rothstein when he was shot in a hotel room.

Amendments To Constitution Running Close

Charlotte, N. C., Nov. 10.—(AP)—With the presidential and gubernatorial vote in North Carolina settled beyond any doubt by the large returns, interest of the electorate turned today to incoming return on the secondary issues, chief among which was the vote on three proposed constitutional amendments.

Reports from 930 of the state's 1153 precincts only served to intensify interest on the closeness of the vote on two of the amendments, while the other, the amendment providing for legislative salaries, appeared to be gaining in popular favor with each precinct return.

The vote in all three, however, still is close enough to be changed readily by final returns from the unreported precincts while the difference between two of the amendments is slight as to swing almost with each incoming report.

Early today the reports from the 930 precincts indicated that the amendments providing for legislative salaries were losing with the vote standing 80,855 for and 62,801 against. Likewise the amendment providing for classification of intangibles swung abruptly from the affirmative to the negative column by returns coming in early today. The count stood 78,942 for and 86,736 against. Earlier reports had piled a somewhat substantial majority for the affirmative on all three proposals. Later returns, however, diminished the majority considerably and with still later reports the tide appeared to have swung to the negative.

The State Legislative and Senatorial reports still were too meager to indicate any definite trend, but the Republicans persisted in claiming one-third of the House membership and two-fifths of the Senate.

Daring Convict Escapes Again

Coffeyville, Kan., Nov. 10.—(AP)—After kidnaping, unaided, two police officers sent to arrest him and forcing them to aid in his escape, a man identified as Dick Greag, Oklahoma convict and bank robber suspect, was at large today in the hilly, wooded country 25 miles east of here.

His flight in a stolen automobile was halted late yesterday when the police officers, Chief of Police Earl Hackney and Detective W. H. McMurry, who had been released 25 miles east of here, caught up with their abductor in a commandeered automobile and opened fire on him.

The man, who forced the officers into his car at the point of a revolver when he was caught stealing chickens in Coffeyville at noon yesterday, leaped from his automobile and ran after it suddenly veered from the road, crashed through a fence and into a tree.

He dropped twice as the officers continued fire, but got up each time and finally escaped in the underbrush. Darkness and failure to obtain bloodhounds to follow the trail caused postponement of the base by a posse last night, but guards were thrown about the spot and his capture today was expected.

Confesses Crimes At Memphis, Tenn.

Memphis, Tenn., Nov. 10.—(AP)—A confessed embezzler known to thousands as "Dr. John W. Barnes" scientist and welfare worker, today awaited word from police of New York and other cities that will determine whether he is to be tried for the crimes he says he has committed.

Revealing his identity as W. J. B. Housman, former newsboy and native of New York's east side, the erstwhile "Doctor" said he assumed his alias after embezzling a forgotten amount from the Hudson Guild, a New York welfare institution, in 1922.

In additional details to his confession garnered by police yesterday and last night, Housman said he once was Boy Scout executive in Richmond, Va., and later in 1916 established the first scout troop in Memphis. This statement was tentatively verified by scout leaders here.

Reduce Freight Rates On Florida Citrus Shipment

Tampa, Fla., Nov. 10.—(AP)—New freight rates on citrus shipments from Florida to all parts of the United States and Canada went into effect today. Although the charges to some parts of the country are higher than previously, according to E. D. Dow, traffic manager of the Florida Citrus Exchange, the reduction on shipments to other sections are enough to save growers about \$25,000 yearly.

Rates to Boston, Providence and a few other New England points are higher. The heaviest reduction was to central and middle western territory, including Ohio, Indiana, Michigan, Illinois, Iowa, Minnesota and Wisconsin, ranging from 7 to 20 cents a box on oranges. O grapefruit to the Pacific northwest the reduction was 25 cents a box or more.

The Interstate Commerce Commission, in making a decision in the case, known as the line-haul rate adjustment, which had been before it for nearly four years, divided Florida into each a large number of rate basing territories that charges vary from nearly every shipping point, and experts found it difficult to generalize on the effects of the new tariffs.

Memphis refrigeration costs been looked into by the commission examiners and their report will be examined at a conference of shippers' representatives in Washington next Tuesday, according to Mr. Dow. Representatives from five southeastern states—Georgia, Florida, Virginia and the Carolinas—will be present, to determine whether any exceptions will be taken to the report. This case was brought by the railroads seeking a higher rate. On the basis of railroad figures, said by Mr. Dow to show better than a reasonable profit, the shippers asked a reduction on icing charges.

Peasant Leaders Pledge Support Of The Regency

Bucharest, Rumania, Nov. 10.—(AP)—Juliu Maniu and his cabinet of peasant leaders took solemn oaths before the regency today to support not only the constitution but the regency and the entire Rumanian dynasty, and to do nothing to bring former Crown Prince Carol back.

Rumania thus for the present at least is in no danger of being changed from a monarchy to a republic, as has so often been hinted by Maniu's supporters and even by the new premier himself.

The scene in the old royal palace on the "Street of Victory" facing the former headquarters of the American Red Cross, was historic and impressive, as the tall, slender figure of Maniu and his ministry of 15 stalwart peasant-theatians, filed in before the regency council, some of them in their medieval homespun peasant's costumes.

At the regency table, over which hung a lithograph of little King Mihai, sat three solemn figures, typifying three branches of Rumania's national life. They were Queen's Marie's younger son, Prince Nicholas in naval uniform, glittering with decorations, representing the Rumanian dynasty, the bearded patriarch Miron Cristea, in black ecclesiastical robes, tall Conical Mitre, and with a huge crucifix suspended about his neck, who represented the Rumanian national church, and finally the dignified, judicial Garfore Buzugan, formerly chief justice of the Rumanian Supreme Court, in simple civilian attire, who typified the interests of the civilian population.

M. Maniu, fresh and alert despite all-night conferences with colleagues, took the oath on a Bible in a firm clear voice, followed by his associates.

Seek Kidnappers Lottie Pickford

Los Angeles, Nov. 10.—(AP)—Having but one slender clue to the identity of four men who were reported to have beaten, robbed and kidnaped Miss Lottie Pickford, screen actress and sister of Mary Pickford, after blackjacking her companion, police today sought to pick up their trail by a study of fingerprints.

Officers were put on the trail yesterday after Miss Pickford had reported that the four men accosted her and her escort, Jack Daugherty, former husband of the late Barbara La Marr, early yesterday. She said the men used a blackjack on Daugherty, robbed them both of a small amount of cash and then carried her off. She was freed after she had pleaded with her captors in Spanish.

Fingerprints found on Miss Pickford's automobile, in which she and Daugherty had been riding, were checked with police records. Accompanied by detectives, the actress and Daugherty last night went through that part of East Los Angeles where they had said they were accosted by the bandit quartet.

After the return from the tour the detectives said little progress had been made in the investigation.

his statement that North Carolinians were deeply interested in the education of the children. He touched on the economic value of an education and said that one of the reasons for the tremendous buying power of the American public today was that America, as has no other nation in the world, had educated her people.

One of the big reasons for the unusual increase in the cost of the schools, as compared with the increased number of children in school, is found in the fact that twenty years ago there were practically no high schools in the rural communities. Today there are 60,000 rural school children in the high schools, and there are graduated from these rural high schools every year more than 7,000 children.

National figures in the cost of education show that providing an education for a high school child is three times as expensive as for the elementary child. With the great

increase in the high school enrollment, there has been a consequent increase in the cost of the schools.

At the opening session the convention voted unanimously to hold its 1929 convention in Elizabeth City. The invitation was extended by M. P. Jennings, superintendent of the Pasquotank county schools, and seconded by a number of people from different sections of the district.

Following the general program there were departmental meetings of fifteen different organizations. Features of the programs of these departmental groups were Dr. Milo B. Hillegas, of Columbia University, New York City, before the elementary teachers this afternoon. Dr. Phillip L. W. Cox, of New York University before the High School groups, Dr. Albert S. Cook before the administrative groups and Dr. Valeria Parker, a specialist in social hygiene before other groups.

The meeting adjourned last night. The features on the evening program were a lecture recital by Marvin M. Steckel of Gastonia, and an address by Dr. Elbert Russell, of Duke University.

SPORTS SLANTS

New York, Nov. 8—(AP)—Talk of Jack Dempsey returning to the ring seems to most observers to be inspired largely by efforts to brace up the sagging fortunes of the fistie game.

They have sagged, especially from the box office viewpoint, this year to a marked degree by comparison with the heydays of the boom era that started in 1923. That was the year Dempsey and Firpo fought their memorable battle at the polo grounds.

By a strange, if not tinuous coincidence, Firpo also figures in the comeback talk. It would be an odd turn of circumstance if both the Argentine bull and the old Manner mauler climbed up through the ropes next year. It probably also would furnish an odder comparison with their fighting powers of 1923.

There was only one Dempsey-Firpo fight. No revival of that epic battle could touch the original, any more than the famous Leonard-Tender lightweight rivalry of the same period could stand today reproduced.

There appears little question, on the other hand, that Dempsey's return to the ring would stimulate legging interest in the heavyweight. No new figures have come along to capture popular imagination as the former champion did.

It is no secret that Tex Rickard would have much preferred last summer to have staged a third and final Tunney-Dempsey fight than the Tunney-Heney match that proved a financial as well as artistic flop.

Dempsey says he won't fight again and he may mean it. But it is just as well to note that if he said anything else now the winter's ball would be sadly handicapped. Just when things look a trifle dull in the ring racket, however, some first usually boots up in the west to administer a few resounding wallop.

Atlanta, Ga., Nov. 10—(AP)—"Championship" was written across the goal posts in the eyes of six unbeaten teams who risked their claims in southern conference gridiron encounters today.

A crowd estimated at between 30,000 and 35,000 held tickets for the annual Georgia Tech-Vanderbilt engagement at Grand Field here when these two teams faced each other in the premier game of the day. Victorious in three conference encounters and tied with Tennessee and Florida for leadership, the aggregations of Dan McGugin and Bill Alexander were rated on equal terms by the experts, although it was conceded that Tech had a reserve strength that was missing on the Virginia bench.

Pitted against the peerless Captain Armistead and his plunging mate, Bill Schwartz, was one of the best lines in the country and six or seven backs who have proved themselves capable of positions on a championship team.

Hardly less important was the Georgia-Florida encounter at Savannah, Georgia, unbeaten in the conference and winner of two engagements had its early season lineup intact again as did Florida. The return of Boland for the Bulldogs was expected to give trouble to Clyde Crabtree and his backfield companions who have been running riot over conference and other goals this season.

There was little doubt that Tennessee would remain in the leadership class as Sewanee faced the volunteers at Knoxville, although the Tigers were under the new management of Kirkpatrick. V. P. I. also victorious in two conference tilts and undefeated, met Virginia, rated as minor opposition, at Blacksburg.

Alabama and Kentucky were lined up at Montgomery, both determined to stage a comeback if possible that would counteract their one conference defeat. Ole Miss, conqueror of the much vaunted Clemson observation had Louisiana State as its foe while Tulane and Auburn were fighting for doubtful conference honors.

Washington and Lee and Maryland were in the east with little prospect of emerging victorious in tussles with Princeton and Yale, respectively.

North Carolina and South Carolina at Chapel Hill and Clemson and V. M. I. at Lynchburg completed the conference roster. North Carolina State and Mississippi went outside the field to play Davidson and Gettysburg, respectively.

COTTON MARKET, N. Y. STOCK LIST

New York, Nov. 10.—(AP)—The cotton market opened at a decline of 8 to 14 points and sold 11 to 18 points net lower during the first few minutes under a renewal of liquidation and some southern selling. The decline to 19.16 for December and 19.06 however was not for long and the market steadied up with prices just about recovering their losses by the end of the first half hour on covering coupled with some commission house buying. The amount of cotton on ship-board awaiting clearance at the end of the week was estimated at 190,000 bales against 168,000 last year. Private cables reported hedge selling and liquidation absorbed by trade calling and continental buying in Liverpool but said that higher prices were checking business in cotton cloths.

After the decline the cotton market rallied today accompanied by reports of trade buying, while there was considerable covering by shorts. January advanced from 19.10 to 19.24 and closed at 19.22, with the general market closing very steady at net advances of 8 to 14 points.

Future closed steady 8 to 14 points higher; spot steady; middling 19.55.

STOCK MARKET

New York, Nov. 10.—(AP)—The "Hoover market" moved higher today under a tremendous accumulation of buying orders in the oil and railroad shares. A few spots dropped out here and there as a result of heavy week-end profit taking sales but gains in the most active issues ran from 1 to 18 points. Radio Corporation common soared 18 points to 288.

Railroad shares assumed increasing prominence as a long line of investment and speculative issues were accumulated by large and small operators. Canadian Pacific rose 7 5-8 points to 233. Montgomery Ward climbed eight points to a new record high. Federal Mining and Smelting soared 7 points to 172. Vanadium Steel 6 1-2 to 105 and McCrory Stores B 5 1-2 to 118, all new high records, while Liquid Carbonic, By-Products Coke, and Corn Products advanced 2 to 3 points to new peak prices.

General Electric and Victor Talking Machine sold down 2 joints each.

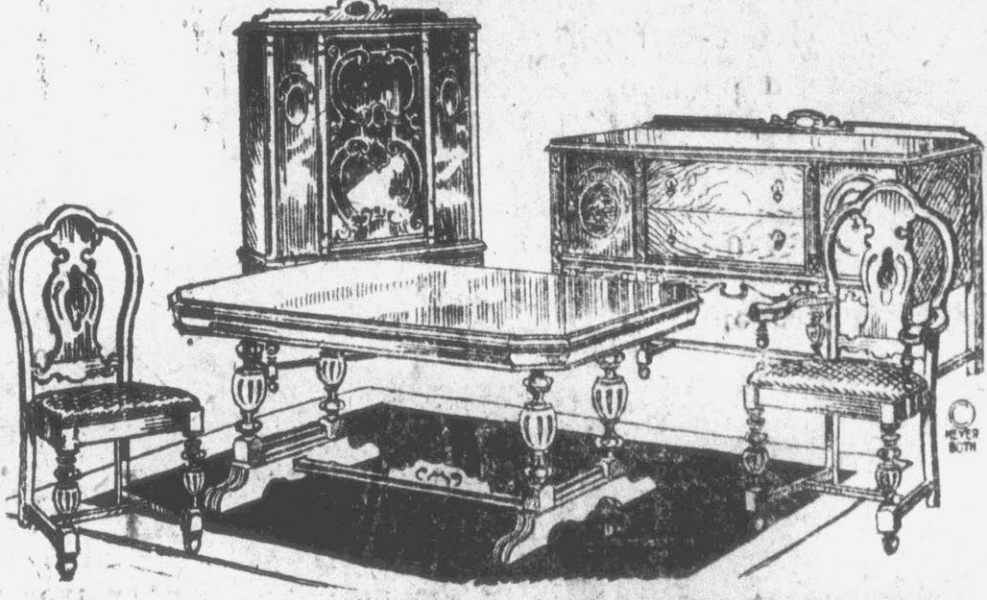
