HOOVER MAKES TWO SPEECHES OF GOODWILL

President-Elect Tells South American People Of Friendship Of United States.

Corinto, Nicaragua, Nov. 27.—(AP)—Herbert Hoover on his good will tour of Latin American countries, landed here at 10:55 a. m. today. He was officially welcomed by President-elect Moncada.

Several members of the cabinet were also in the welcoming party and a big crowd gave him a splendid popular welcome.

After greetings had been exchanged, Mr. Hoover entertained President Diaz and other Nicaraguan celebrities at a luncheon aboard the U. S. S. Maryland.

U. S. S. Maryland, off La Union, Salvador, Nov. 27.—(AP)—Herbert Hoover in his first speeches on his present trip told the people of Honduras and of San Salvador that he was paying them a call of friendship in behalf of the people of the United States. Both addresses, one at Amapala, the other La Union were brief and both emphasized the need for mutual understanding between the United States and other democracies of the American continent.

At both seaports yesterday he was given a warm and colorful welcome. The military were present in gorgeous uniforms. There were salutes and return salutes, the hoisting of flags and bands playing "The Star Spangled Banner."

The President-elect spoke first at Amapala.

"In our daily life good neighbors fall upon each other as the evidence of solidarity for the common welfare," he said, "and to each of the circumstances and points of view of each so that there may come both understanding and respect which are the elementary forces of all enduring society."

He told his audience that the United States and Honduras were pledged through the blood of their forefathers to National Independence.

"We in the United States have learned much from the experience of our Latin American neighbors and we in turn take pride in our contributions to the common pool of human advancement in these one hundred and fifty years. Therefore, I have felt that the larger personal acquaintance with both our neighboring countries and with their points of view and above all with the men who have been elected to responsibility in their governments would be valuable in the task which lies before us."

"Those who know the United States," he declared, "know also that we have only one desire and that is to co-operate to a constantly improving understanding; to common progress and to common attainment."

La Union is but ten miles across the Gulf of Fonseca from Amapala in Honduras. Mr. Hoover made the trip in a motor launch, and found the town enjoying a holiday while waiting for his coming.

"We perhaps hear more of economic and trade relations between countries than any other subject in the field of international life," he told a large audience. "This may be easily explained, for out of our economic life do we build up the foundations upon which other progress rests. And our international economic relations can have but one real foundation; they can grow only out of the prosperity of each of us."

Believe Chicago Gunmen Used To Scare Witnesses

Philadelphia, Nov. 27.—(AP)—District Attorney Monaghan, who is directing the special grand jury investigation of organized lawlessness and police corruption, expressed the belief today that Chicago gunmen might have been brought here by Philadelphia gamblers to intimidate persons who may be called for questioning by the investigators.

Monaghan said he had been informed that three gunmen from Chicago had been in hiding here for several days. They came to Philadelphia, the prosecutor declared, after Dr. Thomas "English Tommy" Gilchrist, convicted gambler, had been brought from the county prison for examination by the grand jury. Gilchrist was reported to have given the inquisitors a complete story of the gambling operations in this city.

THREE FIGURE IN ROTHSTEIN MURDER CASE

George McManus, Widely Sought Gunman, Arrested By N. Y. Police Today.

New York, Nov. 27.—(AP)—George McManus, widely sought by the police as the man who could throw more light on the slaying of Arnold Rothstein, gambler, than any one else, was arrested today.

He was arrested at 245th Street and Broadway shortly before nine o'clock by a detective. District Attorney Banton ordered him to be brought to his office immediately for questioning.

New York, Nov. 27.—(AP)—Three shadowed figures—one of them a woman—loomed today in the grand jury investigation of the Rothstein case.

Their identity is hidden under legal phraseology as "Jane Doe, John Doe and Richard Doe."

The first intimation that a woman was suspected of having had a hand in the slaying of Arnold Rothstein was contained in a document filed at yesterday when the state asked the detention as material witnesses of five friends of the slain gambler.

It was headed, "The people of the state of New York against Jane Doe, John Doe and Richard Doe."

"Yes, there is a woman in the case and she is very important," said District Attorney Banton, in explanation of "Jane Doe."

"I can't discuss her now. I am certain that we have enough evidence at this time to obtain an indictment against her."

The district attorney added that the public would have to wait until the grand jury completes its investigation, probably Friday, to learn definitely on whom the state has fixed suspicion in the search for the person who fired a bullet into Rothstein November 4.

The general belief had been that Mr. Banton would ask the grand jury to indict George McManus, gambler, who occupied room 349 of the Park Central hotel, where Rothstein was shot, and would also seek the indictment of a professional gunman.

McManus still is being sought as the man who could "clear up this thing in three minutes," to quote the district attorney.

Coastguardman Dies In Spectacular Fire

New London, Conn., Nov. 27.—(AP)—A check up today after a spectacular fire at the coast guard base, revealed the loss of one life. Fifty other coast guardmen escaped.

The fire laid waste two coast guard buildings. The spread of the blaze, caused by burning oil, necessitated releasing twenty government ships tied in the harbor. The administration building was saved.

Jacob B. Tatenam, of Chelsea, Mass., attached to the destroyer Erickson, was found burned beyond recognition in the ruins of the hospital building. He had injured an ankle playing basketball three days ago. Six other patients were carried out on stretchers.

Oil and ammunition were kept in the store room, which was burned. Explosions hastened its destruction.

The fire started in the canteen building and spread through dormitories and the sick bay. None of the ships were damaged. The buildings were owned by the State and their contents was government property. The loss was placed at \$100,000.

AL SMITH PASSES THROUGH RALEIGH

Raleigh, N. C., Nov. 27.—(AP)—Governor Alfred E. Smith, of New York, passed through Raleigh this morning going home, after his southern vacation, but he was not seen by the small crowd who went to the station in the hope of seeing the former Democratic nominee for the presidency.

Storm Destroys Coffee Crop In Porto Rico Area

Panama, Nov. 27.—(AP)—Dispatches from Costa Rica to the Star Herald today said that the entire coffee crop in Carago Province and the surrounding region had been virtually ruined by a storm which stripped the trees of berries ready to be picked.

It was generally believed the government would have to postpone an \$11,000,000 road building program to undertake reconstruction work and to give assistance to small coffee growers.

Coffee is Costa Rica's principal source of revenue.

New Mexico Senator

PRICES PICK UP ON LOCAL LEAF MARKET

General Average On 828,826 Pounds Of Tobacco Yesterday Was \$24.78.

The Greenville tobacco market yesterday sold 828,826 pounds of tobacco for \$205,464.03 at a general average of \$24.78 per hundred pounds, it was indicated in the official report of K. W. Cobb, supervisor of sales, issued this morning.

The market today had sold 59,333,984 pounds of bright leaf, which places it within less than seven hundred thousand pounds of the sixty million pound mark set for Thanksgiving. With only ten million pounds necessary to reach the seventy million pound goal for the entire season, it was believed sales after Thanksgiving would be marked by keenest competition on the floors of all nine warehouses.

The report stated that there was about seven hundred thousand pounds of tobacco on the floors here today with indications that sales would be completed during the afternoon hours.

The market will be closed Thursday in observance of Thanksgiving Day. This will be the last holiday until Christmas.

The price situation showed considerable improvement yesterday with bidding quite spirited. Much tobacco was in evidence and this was largely responsible for the advance of the general market average.

Mrs. Hill Horne And Two Daughters Injured Yesterday

Mrs. W. H. Horne and two daughters, Annie Rosemond and Mary Lorraine, received painful injuries when struck by a flying object from an automobile crash at the intersection of Third and Green streets late yesterday afternoon. Their injuries consisted mainly of cuts and bruises, which, although painful, were not considered necessarily serious.

The three were standing on the sidewalk talking when the accident occurred. Two automobiles collided in the street and an object of an undetermined nature hit Mrs. Horne and children with such force that they were knocked to the pavement in a heap. A lone passerby rushed to their assistance and called a doctor to minister to them.

One of the cars was driven by a Mr. Deaver and the other by Prof. C. M. Epps, principal of colored schools. Epps' car was completely demolished by the impact. Both drivers escaped uninjured.

ROTARY ATTEMPTS TO ABOLISH BASKETBALL

Coaldale, Pa.—(AP)—The rotary club is seeking to have basketball abolished as a sport for school girls. It has petitioned the authorities, averring that five players contracted tuberculosis when none was susceptible through heredity.

GALE CLAIMS BIG TOLL OF LIFE OVERSEA

Hundred Lives Lost And Heavy Property Damage From High Winds And Floods.

London, Nov. 27.—(AP)—Floods today followed in the wake of a four day gale which caused the loss of a score of vessels of substantial tonnage in Western European waters and possibly took a toll of 100 lives.

From Belgium north to the Persian Island, lowlands were flooded as the sea was driven in upon them by raging winds. Dykes and sea walls buffeted by heavy seas gave way to the rush of waters.

Police soldiers and civilians were working frantically in Antwerp to repair broken dykes there and on the opposite side of the Scheldt. The city water and gas pipes were undermined and gave way and the suburbs were flooded. Industrial plants in Hoboken and elsewhere were closed. Railroad bridges were damaged and telephone and telegraph lines were down. Six persons were missing and it was feared that they were dead. A hole 60 yards in circumference, and 6 yards deep was made in the Grand Palace at Antwerp.

At Ostend, Belgium, the water from the sea ran down streets and inundated the ground floors of buildings.

The Flanders villages of Grembergen, Moorsele and Termonde were evacuated by their inhabitants as the sea rushed through a break twenty yards wide in the dykes.

A number of houses in the neighborhood of Rotterdam, Holland, were also abandoned. At Bergen-op-zoom, Holland, a 130-foot levee broke with a tremendous crash, letting in the sea.

Sylt Island, one of the Frisian group, was inundated and dwellers on it sought safety on the highest points. At Elligoland the sea wall was torn away and sand dunes were levelled. The river Elbe was backed up by the sea and low lying streets of Hamburg were flooded.

Rivers in the Vosges Hills were rising with alarming rapidity. The Moselle was also rising and tributaries of the Rhine were raging torrents. Houses along the banks of the Ruhr at Mulheim were evacuated and the shipping on the Saar was at a stand still.

Two Railroad Men Hurt In Car Wreck

Cordale, Ga., Nov. 27.—(AP)—S. M. Dutton, train master for the South Carolina division of the Seaboard Air Line Railway, was seriously hurt and E. W. Walker, traveling auditor for the Seaboard, was slightly injured last night when their automobile ran into an embankment to avoid a collision with another car.

The accident occurred on the Coney-Cordale highway at the intersection of the Coney and Albany highways. Dutton was thrown through the windshield and was unconscious when taken to a hospital, but it was said his injuries were not expected to prove fatal. Walker returned to his hotel room after his injuries were treated.

Ben Thompson Arrested.

Raleigh, N. C., Nov. 27.—(AP)—Dr. J. H. Norman, warden of the State Prison here, announced today he had been notified of the arrest in Greensboro of Ben Thompson, one of the 14 convicts who escaped Saturday from the Caledonia farm in Halifax county. Eight of those who made their getaway in a commandeered laundry truck, were still at large, so far as was known to Dr. Norman. Thompson was serving a sentence of five years for larceny, imposed in Wilson county.

Ratification of Kellogg Anti-War Pact Assured

Washington, Nov. 27.—(AP)—Senate ratification of the Kellogg anti-war pact seems assured, barring unforeseen developments, with the only question to be settled that of procedure.

Senator Swanson of Virginia, ranking Democrat on the Senate Foreign Relations Committee, has announced his support of the treaty, as have Senator Borah of Idaho, chairman of the Senate Foreign Relations Committee; Senator Norris of Nebraska, a leader of the Republican Independents, and other senators, both Democrats and Republicans.

Norris has declared that he would like to have the treaty brought up for ratification ahead of the administration's \$274,000,000 naval bill. He said that there seemed to be an agreement among administration leaders to have the Senate vote on the naval bill first.

Chairman Hale of the Senate Naval Committee and Senator Borah have agreed to attempt to avoid a wrangle over the position of the treaty and the naval bill on the Senate calendar. The naval bill is already on the calendar, since it passed the House at the last session and has had committee approval in the Senate.

Senator Swanson's announcement yesterday that he would support the treaty was regarded as significant, since he is one of the leaders of his party in foreign affairs.

TWO TESTIFY AT CARROLL TRIAL TODAY

Woman Testifies That Asheville Doctor Made Improper Advance Upon Her.

Raleigh, Nov. 27.—(AP)—After two hours spent in hearing arguments on demurrers filed by counsel for the defendant, brief testimony from two witnesses was introduced by the plaintiff before Judge Harris adjourned. Wake superior court at one o'clock today in the action brought by the State Board of Chiropractic to revoke the license of the Highland Hospital at Asheville. The complaint alleges that Dr. R. S. Carroll, head of the hospital, is morally unfit to conduct such an institution.

Demurrers filed by defense counsel sought to have the action dismissed on the grounds that the complaint set forth no specific act of immorality or negligence by Dr. Carroll, and that the case had no standing in court as to Dr. Carroll since the license was not held by him personally, but by the Highland Hospital, incorporated. Judge Harris overruled the first demurrer, but reserved his ruling on the second.

The two witnesses presented today by the plaintiff were Miss Helen C. James of Dayton, Ohio, and Dr. Louise Mason Ingersoll, Asheville woman physician.

Miss James testified that her sister had been a patient at Highland Hospital for four years after entering the institution in 1921. She said Dr. Carroll told her he had questioned her sister about her sex life last week. M. L. Briley, driver of the motorcycle, of which Woodall was an occupant, received injuries from which he died a few hours later.

Big Zeppelin To Be Used Into Two Flights To Pole

Berlin, Nov. 27.—(AP)—The dirigible Graf Zeppelin, which recently completed the first round trip trans-Atlantic commercial air voyage in history, will be placed at the disposal of the International Aeroaeretic Society for two North Pole flights in 1930.

Decision to this effect was reached at a conference today which was presided over by Dr. Guerdner, minister of communications. Fridtjof Nansen, the noted explorer, who is planning the flights, Dr. Hugo Eckener, Captain Bruns, Prof. Hengke and other well known scientists, took part in the discussions.

Chicago Schools Face \$12,000,000 Deficit Today

Chicago, Nov. 27.—(AP)—Chicago newspapers today said that the city schools faced a deficit approximating \$12,000,000, caused by financial troubles "inherited from previous administrations, coupled with tremendous loss in revenue this year from uncollectable taxes."

Some extra legal means of maintaining current expenses must be found, it was pointed out, until more tax money becomes available about February 15. Both the Tribune and the Herald and Examiner said the schools would not be closed.

Half a dozen firemen, including Assistant Chief George Richardson, were rescued after being trapped on the roof of a building at the height of the blaze.

HUGH WOODALL PASSES AWAY

Second Victim Of Auto-motorcycle Wreck Died at Fayetteville This Morning.

Hugh Woodall, former employee of the McGowan Battery Co. of this city, died in a Fayetteville hospital this morning about 5 o'clock of injuries sustained in the motorcycle-automobile wreck at Turkey last week. M. L. Briley, driver of the motorcycle, of which Woodall was an occupant, received injuries from which he died a few hours later.

Funeral services will be conducted from Mr. Woodall's home, near Fayetteville, tomorrow morning at 11 o'clock.

Run On Bank At Macon Attributed To Baseless Rumor

Macon, Ga., Nov. 27.—(AP)—The run of withdrawals which resulted yesterday in the closing of the Fourth National Bank here, one of the largest financial institutions in central Georgia, was attributed today by officials of the bank to "baseless rumors evidently originating with the collapse last week of negotiations to sell it to a group of Atlanta men."

Directors of the bank met today with its president, Leon S. Dure, to discuss plans for a reorganization embracing a proposal of Mr. Dure for a new institution capitalized at \$750,000. The bank had a capitalization of \$500,000.

To Solve Servant Problem.

New York.—(AP)—Women of Great Britain and America are co-operating in an effort to solve the servant problem. Miss Winifred Spielman of London is here on a scholarship of the Laura Spellman Rockefeller Foundation to study the question. At a luncheon welcoming her, speakers suggested that domestics be lifted from the menial to the professional class, with a six day week and pay for overtime.

WOMAN GIVES TESTIMONY IN ADAIR HEARING

One Hundred or More Government Witnesses Remain To Be Heard At Atlanta.

Gainesville, Ga., Nov. 27.—(AP)—Although 100 or more government witnesses had not yet been examined, District Attorney Lint Hager today had completely outlined his case in the trial of four officers of the bankrupt Adair Realty and Trust Company.

The testimony of Miss Minnie Miller of Navarre, Ohio, that she had received pamphlets from the company advertising bonds for hotel projects in Birmingham, Ala., Little Rock, Ark., and Knoxville, Tenn., and had bought \$500 worth of them marked the technical end of the government's case. Testimony of a corroborative nature remained to be taken.

Forrest Adair, Sr., Forrest Adair, Jr., Frank Adair and E. A. Erwin are accused of misusing the mail to defraud investors throughout the United States and foreign countries in promoting the hotel projects through the sale of nearly \$3,000,000 in bonds.

Previously G. M. Stout, connected with the Adair bond department, had testified that the company was apprehensive before it failed in 1927, and cited an incident.

The witness said E. A. Erwin had told him to have stationers delete certain items from company stationery pertaining to the financial condition of the company on the ground that they might be misleading.

Then followed a mass of pamphlets purporting to show that the Adairs had cited their success in past years and past reputation in appealing to investors.

Along this line of questioning, Miss Miller furnished the testimony that she had bought the bonds after seeing some of these pamphlets, and had realized 11 cents on the dollar for her investment.

Hager was rebuffed by the court Miller say deliberately that she had bought the bonds under the influence of the advertising matter. Decision overruling the question previously mitigated for an earlier completion of the trial than had been expected.

Last week the government attempted to show that the Adairs and Erwin were robbing "Peter to pay Paul" when they issued \$3,000,000 in hotel bonds, while investments of some \$2,000,000 in the Whitefield estate, Sarasota, Fla., were going badly.

Byrd Expedition Gets Off Friday

Wellington, New Zealand, Nov. 27.—(AP)—Commander Richard E. Byrd and fifty members of his Antarctic expedition are planning to leave Dunedin on Friday directly for the Bay of Whales if ice reports from whalers now in Ross sea are favorable. They will sail in the City of New York.

The Eleanor Bolling, the commander's other vessel, will make two trips to the south carrying supplies and will remain at Dunedin for the winter. Early next summer she will leave with fresh provisions for the ice party.

When the expedition was first planned Commander Byrd intended, if conditions on the ice plateau were favorable, to do all his scheduled flying in a few months, returning to civilization before the "long darkness" settled over the Antarctic. This plan has now been abandoned.

"We shall be on the ice for a year and six months," said Commander Byrd in an interview. "The expedition is not going to make a dash or attempt any stunt exploit. It is out for scientific exploration."

Flo On Solo Flight From Canada to Cuba

Walkerville, Ont., Nov. 27.—(AP)—Leonard Flo of Ann Arbor, Mich., 26 year old former army and air mail pilot, today was making his second attempt at a non-stop solo flight from Canada to Cuba.

He took off from the airport here at 11:07 last night in a Spartan biplane and hoped to reach Havana in 18 to 20 hours. It is approximately 1,800 miles to the Cuban capital.

His route was via Dayton and Cincinnati, Ohio; Atlanta, Ga.; Tampa and Key West, Fla.; thence across the 90 miles of water to Camp Columbia, Havana. He must arrive there before dark tonight to insure a safe landing as the field is not equipped with guide lights, markers or searchlights. He hoped to arrive just before dusk.

KING GEORGE SHOWS LITTLE IMPROVEMENT

Noncommittal Bulletin Fails To Relieve Keen Anxiety Over Britain.

London, Nov. 27.—(AP)—Anxiety over King George's illness was not greatly relieved this morning when his physicians issued what might be characterized a non-committal bulletin.

The physicians, Sir Stanley Hewitt and Lord Dawson of Penn, informed the public that their royal patient had passed the night more restfully and that his feverish condition had abated somewhat. The bulletin did not actually give the King's temperature and summed up everything else by stating that conditions otherwise were unchanged.

On top of the disturbing bulletins of the past few days which have indicated that the king is very ill, today's report did not tend greatly to relieve a steady among his subjects over the eventual outcome of the attack which has now been in progress nearly a week.

It was realized that the King's stamina was undergoing a severe strain owing to constant pain from pleurisy and the lack of rest and sleep that attended it.

The doctors were early at Buckingham Palace, arriving shortly after nine o'clock, but it was not until well towards noon that their attendance on his majesty was concluded, and the bulletin issued.

There were hundreds of persons around the palace when the bulletin of the King's physicians was posted.

Quick to seize on anything with a hopeful sound, the crowd secured believed at least that no change for the worse in the King's condition was indicated and that he appeared to be more comfortable than during the last few days.

London, Nov. 27.—(AP)—The Press Association states that it was officially informed at St. James Palace today that the Prince of Wales has not been recalled to England as had been reported.

The Queen and Princess Mary left Buckingham palace in an automobile this afternoon to make some personal visits. It was noticed that the queen was smiling and looked well which was taken as an indication of further good progress which his majesty was reported to be making.

Turns Up Criminal, Fails To Get Reward

Raleigh, N. C., Nov. 27.—A former North Carolinian now living in Mississippi informed state officials of the whereabouts of John Cameron, recently brought back here to serve 19 years of a 20-year sentence imposed for second degree murder, but if he did it in the hope of obtaining a reward, he was disappointed.

Inquiries today developed that a reward of \$100 had been posted after Cameron's escape in 1914, but it was not renewed, and under the statute of limitations, it expired long ago.

Prison officials declined to disclose the identity of the informant, hearing the possibility of attempted retribution by relatives or friends of Cameron, who as J. B. Davis, became well to do as a turpentine operator in Sylvania, Alabama.

Labor Federation Favors Restricted Immigration Law

New Orleans, Nov. 27.—(AP)—The American Federation of Labor has gone on record as favoring restricted immigration, opposing judicial injunctions in labor disputes and reiterating its opposition to Communism.

The action came in adoption of committee reports, which again comes up today and may continue into tomorrow when the annual convention adjourns.

Restriction against entry of aliens into the United States should be more rigid in character though "tempered with human considerations and applicable to all aliens," the adopted report said.

"The American Communist movement is destructive in character," another report held. "It seeks to tear down regardless of consequence. While prattling loudly about workers' control over industry, it seeks to give industry control over the workers by destroying the trade unions which are the only agencies through which workers are enabled to exercise control over themselves."

"The anti-union employer and the anti-union communist are partners in the nefarious attempts which are being made to undermine trade unionism. They work toward the same end."

Arizona Governor And Senator Stage Fistic Engagement

Phoenix, Ariz., Nov. 27.—(AP)—A fistic encounter between G. W. P. Hunt, governor of Arizona, and State Senator Fred Colter during an argument in the State Capitol over the Colorado River question, gave an exciting touch yesterday to a problem which has harassed the state for years.

Arizona's intense feeling over the ultimate settlement of the Colorado River problem in which she has battled her sister states for what she insists is a just share of water and power from proposed dams, was the subject of an argument which precipitated the clash. The State Legislature has been called into special session primarily to consider action to be taken upon the Stone-Johnson bill now before congress.

Arizona's Colorado River Commission, appointed to investigate and handle the river problem in conjunction with the commissions of the six other states concerned, was being discussed by Senator Colter and several legislative associates when Governor Hunt appeared. Governor Hunt, who was defeated in seeking a seventh term at the November elections, became involved in the argument.

The governor's secretary, J. W. Strode, declared afterwards that he saw his chief stagger against the wall from a blow delivered by Colter. Strode interferred, catching the senator by the arms, whereupon the group of legislators closed in, fighting and shouting. Colter also was reported to have been struck in the face during the melee.

Police were called to the capitol, but found only an excited hum of after the battle talk when they arrived.

Governor Hunt, who unobtrusively walked down the capitol steps after the clash, insisted the blow he received was inadvertently brought about when Senator Colter moved his arms in argument.

His secretary maintained that the blow was intentional.

Governor Hunt, who is 69 years old, was elected the first governor of Arizona in 1911.

Senator Reed In Favor Barge Lines

St. Louis, Nov. 27.—(AP)—Speaking in his characteristically militant manner, U. S. Senator James A. Reed last night urged the Mississippi Valley Association to go before Congress not as "suppliants asking a benefaction" but as business men asking for money for a great public investment.

Senator Reed, the principal speaker at the association's tenth annual banquet, attacked railroad interests which he said were blocking the development of the barge lines in the middle west.

He turned a satirical eye on the waterway advocates who proposed asking Congress for \$10,000,000 when he said \$100,000,000 would be a more adequate amount with which to equip the barge lines.

The same enemies, under whom the creation of channels and administration of the barge lines is carried on, came under his criticism on the ground that they were "shrunk intellectually" by "conventions and army traditions. They were not entirely to blame, however, he said, but were hampered by lack of funds to buy operating equipment.

Turning to the railroads, he said "any railroad president in the middle west who tries to throttle waterway transportation is so short-sighted he should be deposed and his section boss ought to be put in his place."

A review of the progress made in the development of inland waterways during the four years since the Inland Waterway Corporation was formed to operate the government-owned barge lines, and a plea for further expansion, were made by Major General T. O. Ashburn, chairman and executive of the corporation, a speaker on today's program.

Tilson Favors Special Session Of U. S. Congress

Washington, Nov. 27.—(AP)—Representative Tilson of Connecticut, Republican leader in the House has come out for a special session of Congress, but he thinks that tariff revision is the principal subject to be considered at it.

In a statement issued yesterday he declared that he believed that farm relief legislation can be passed at the approaching short session and that if an extra session was to be called it should be done soon after March 4.

He said that his views were that the Ways and Means Committee should meet after March 4 and prepare a tariff bill, so that when the proposed new Congress met it would find its work facilitated.

Tirana, Albania, Nov. 27.—(AP)—King Zogu is understood to have broken his troth to the daughter of a wealthy landowner and decided that he must have a princess of royal blood to share his throne.
 Zogu, who was proclaimed king on September 1 had been engaged for six years to Lela, the 23-year-old daughter of Shekvet Bey Viltaz, a wealthy landowner of Elbasson. He is now understood to have written her saying that he deeply loves her but that reasons of state have compelled him reluctantly and sorrowfully to give up the idea of their marriage.
 Lela is reported to be nearly heart broken and unreconciled to her fate. She is quoted as having said that she can never love any man except the tall, handsome 34-year-old king.
 The reported breaking of Zogu's troth has again stirred up discussions as to whom he will choose to share his throne. Moslem subjects of Zogu refuse to believe that there is a possibility of Princess Giovanni, of Italy, becoming their queen since he probably would not be willing to abandon the Christian faith nor Zogu his devout adherence to Mohammedanism.
 When Zogu first announced his plans for turning the republic of Albania into a kingdom, there was a rumor that he intended to marry a daughter of King Fuad, of Egypt. This possibility is now being discussed again.

Sweed To Marry American Heiress

New York, Nov. 27.—(AP)—Count Folke Bernadotte, nephew of King Gustaf of Sweden and Lieutenant of the Swedish horse guards, is to have an American bride, a radio, an electric refrigerator and a vacuum cleaner.
 Next Saturday at Pleasantville, N. Y., he is to wed Miss Estelle R. Manville, prospective heiress to about \$25,000,000 of the fortune founded by the "asbestos king." It is estimated the wedding will cost \$750,000.
 "We are going to Stockholm and live where I have a flat," the count said on his arrival from Sweden with members of his wedding party. "I intend to have a radio, an electric refrigerator and a vacuum cleaner, just like all other folk have."
 With him came his royal cousins, Prince Gustaf Adolphus, heir apparent to the Swedish throne, and Prince Sigvard and other titled members of a party of 15.
 Miss Manville met him at the pier. The count gave her a big, long hug and he kissed her father and mother. Mr. and Mrs. Hiram E. Manville, "It's just like a circus," Miss Manville laughed.
 The count revealed that he first met Miss Manville at Monte Carlo, last spring.

DEMOCRATIC PRIMARIES

It is noted in the Raleigh News and Observer that Wiley Person, Senator-elect of Franklin county, plans to introduce a bill in the next General Assembly to abolish the Democratic primary. Senator-elect Person is of the opinion that the primary is a cause for considerable trouble in the Democratic ranks. Therein, to a certain extent, he is correct, for there are occasions where the candidate who loses the nomination of his party does not get over his defeat in the spirit that builds up a party. Perhaps the convention plan of selecting nominees would strengthen the party, and it is evident that some strengthening may be needed, but to our way of thinking, the entire situation could be well cleared up by seeing that no Republicans vote in the Democratic primaries. It is only natural that some of the Republicans who cast ballots in Democratic primaries do so because they thereby may help to nominate the weakest of the Democratic candidates, giving the Republican nominee an advantage. If Senator Person would make a move to strengthen that part of our primaries we believe he would receive

considerable help from the Democrats of the next Assembly.—Cleveland Star.

"Credit customers who have failed to settle up their obligations have one more week in which to do so," said members of the Greenville Merchants' Association today. "The new list of all credit customers will be compiled by the association the beginning of next week. The last appeal for settlement was sent out this week by members of the association. "Your credit rating will be vitally affected in the compilation of the new list, and it is necessary that you protect it in every way possible. Should you have any accounts which are past due, why not see your creditors and either make settlement or some satisfactory arrangement. Attend to this important matter at once and assure yourself of credit next year."

"Greenville people are urged to attend the union Thanksgiving service to be conducted at the Presbyterian church Thanksgiving morning," urged the pastors of the various churches today. "The community has many things to be thankful for this year, and it is nothing more than natural that we should desire to express appreciation of these blessings. The best way to do so is to attend the services set aside for this purpose. "An inspirational program has been provided for the occasion and everybody that can should attend."

"Sixty million pounds of tobacco by Thanksgiving," is the goal of the Greenville tobacco market at the present time," said a prominent tobaccoist today. "The reaching of the sixty million pound mark will put us within ten million pounds of the goal set for the entire season. While sales from Thanksgiving to Christmas will be light, we are hopeful they will be large enough to put us over the goal. "Realization of the seventy million pound ambition will establish a new sales record on this market and insure tobaccoists to attempt greater things next season. "The Greenville market is truly one of the world's greatest bright leaf tobacco selling centers and with continued development like the last three or four years we should gain even greater recognition."

"With Christmas decorations appearing in a number of show windows throughout the city, one is reminded of the slogan, 'Do your Christmas shopping early.' declared a business man today. "Everybody is out to make an effort to shop earlier this year. They will not only be able to get better values but will also avoid the hustle and bustle of final days. "Listen to the plea of the numbers of business houses and shop while stocks are complete. Many of the stores will remain open from now until the end of the holiday season. Therefore, there is nothing to prevent you doing your shopping now."

"Greenville extends a cordial welcome to the Young People's Christian convention in this city today," a delegate from a local church said this morning.  North Carolina States wolfpack after playing the Michigan Aggies in a snowstorm, are home again in the gamecocks of Wake Forest University of South Carolina and Billy Laval's men, who rested last week, are reported to be in fine condition for their annual battle with the Pack.

These two eleven close their season with the big turkey day classic at Raleigh and several stars on each eleven end their collegiate playing days. These men will display their best wares for the fans to see while likely prospects that get into the contest will exert themselves to the fullest extent in an effort to earn a berth for next season.

The eyes of many football fans in the Carolinas will be focused on Raleigh and thousands will trek there for the contest, which will mean much to the winner in conference standing but thousands of others will choose between two other games.

North Carolina and Virginia will be renewing hostilities of long standing at Charlottesville and Furman and Clemson will battle in Greenville in a game which may decide the championship of the Palmetto state.

Captain Harry Schwartz and his Tar Heels seem slated to win over the Cavaliers but North Carolina eleven has not had much success against the teams of "Greasy" Neale and the Virginians may pull an upset.

Clemson holds the edge over Furman by reason of its win over Carolina while the Hurricane lost to the Gamecocks. If Clemson wins the Tigers can claim the state championship if they defeat the Citadel December 8, but if Furman wins the hunting will be claimed by South Carolina. Clemson and Furman regardless of what the December 8 result is, but if Clemson loses that game also the Purple Wind and the Birds will have a better percentage claim, if not a better moral right to the top notch.

While these three contests hold the major positions on the edge the turkey day battle between Elon and Lenoir-Rhyne, Lynchburg and Atlantic Christian College, Guilford and Catawba, Southern and Wofford and Mercer and Wake Forest must not be discounted and the Devils of Duke must dispose of Davidson's Wildcats if they are to have an undisputed right to meet North Carolina December 8 for the Big Five title of North Carolina.

After the list of Thanksgiving Day games is finished there still remain two Saturday games for the week in which teams of the Carolinas will play. Presbyterian and the Citadel will clash in Charlotte and High Point will go to Baltimore to meet Western Maryland.

He will play his last game in a Cavalier uniform as captain of the team that led Princeton to a scoreless tie, for seven veterans will be back in harness when the whistle blows on Lambeth Field Thursday afternoon.

Dick DeBitts will work with Captain Luke in holding down the tackle position. "Lefty" Close will again add his to the backfield. Harry Flippin once more on the end of the line. Hunter Motley is at guard. Tompkins holding the pivot position, and Lusher will run at halfback. The return of seven regulars to the lineup has touched off a world of enthusiasm among the students that will be whipped into a frenzy at a spirit rally tomorrow night.

President Coolidge, who will be at Swannanoa, twenty miles of here in the Blue Ridge, will come by automobile with Mrs. Coolidge in time to attend special Thanksgiving services at the First Baptist church at 11 o'clock. With members of the official party and honor guests, including Governor McLean, of North Carolina, Governor Byrd, of Virginia, Mrs. Woodrow Wilson, President Coolidge and other notables, the president and Mrs. Coolidge will be in attendance with Dr. Edwin A. Tamm, president of the University of Virginia.

A special box for the president and the guests of honor has been erected in the concrete stands on the fifth yard line.

The Tar Heels have rushed preparations to have wrought havoc with the freshman and reserve opposition

in the home stadium at Chapel Hill. Neither team has an imposing record for the season and both have been badly handicapped by injuries, but records matter little amid the glamor of a contest dating back 33 years.

Thirty-two battles have been fought on the gridiron by Virginia and North Carolina, the Cavaliers winning twenty times, the Tar Heels eight and four ending in ties. Carolina has won only one victory since Coach Earle Neale took charge of the Cavaliers in 1923, but that victory—14 to 13 game at Chapel Hill last year, is fresh in the memory of students on the Virginia campus.

Students matrons, cross country run and dances Wednesday and Thursday night have added to the bustle that has aroused Charlottesville. Arrangements have been made to handle a crowd of more than twenty thousand persons and special trains are coming from all sections of Virginia and North Carolina, including a student special from Chapel Hill. But student bands will be present to add to the glamor of the contest.
