## CONGRESS GATHERS FOR SHORT SESSION TODAY; ADJOURNS AFTER NOON

### Hour Of Opening Session Given Over Entirely To Formalities Incident To Opening Day.

Washington, Dec. 3.—(AP)—Congress assembled and prepared itself in short order today for the three busy months ahead and for the special session Herbert Hoover has promised should it be necessary for farm relief.

Meeting after a six month recess, the two houses were rapped into order by vice President Dawes and Speaker Longworth. They went through the necessary formalities of getting themselves officially organized and then adjourned until tomorrow when the annual message of President will be read. The adjournment was out of respect to those members of the Senate and House who died during the recess.

Although the membership of the House and Senate came together for the first time today since the bitter days of the campaign, there appeared on the surface no lasting marks of that fight. Norris and Borah who fought on opposite sides for Smith and for Hoover sat side by side. Simmons, of North Carolina, warmly grasped the hand of Robinson, of Arkansas, and Heflin of Alabama, implacable foe of Governor Smith, seemed to be enjoying himself.

Secretary Kellogg, who has a peace pact he wants ratified, was on the floor of the Senate, and attorney General Sargent, dressed in a cutaway coat, was about shaking hands. In the House there was jubilation among the members who met again after half a year, and Speaker Longworth was kept busy for a time shaking hands all around.

Before the session was half an hour old it had received the report on Boulder Canyon Dam estimating the cost of the project at \$165,000,000. The Boulder Canyon bill has just of way in the Senate. The Farm Relief-Tariff issue showed itself immediately with the introduction of a bill by Representative Williamson, Republican South Dakota, to revise the duties on certain grains, and Senator Edge, Republican, New Jersey, urged agricultural legislation at the present session.

Neither House, however, desired any business done today. The procedure was prayer, a roll call, appointment of committees to notify President Coolidge that the session had begun, and then adjournment until tomorrow when business really will get underway.

Senator Simmons, veteran from North Carolina who fought Governor Smith, went gallantly about the Democratic side and if there were any hard feelings against him by coolies, they were not shown. Nearly the massive Helms of Alabama trembled to see in a jolly mood. Simmons stopped to say a few words to Senator Robinson, or Arkansas the running mate of Al Smith. Robinson clasped his hand heartily.

## Charlotte Man Dies Suddenly

Charlotte, Dec. 3.—(AP)—C. C. Coddington, nationally known automobile dealer and for 20 years a resident of Charlotte, died suddenly last night at Harbor Island, off the North Carolina coast. A telephone message from Morehead City at 9 o'clock this morning was the first information to reach relatives and friends here.

Death was due to heart trouble, the inquest stated. No further details were given.

Charles S. Wallace of Morehead City, telephoned news of the death of Lee S. Fogler, associated with Mr. Coddington in the executive management of the Buick automobile headquarters here. Mr. Fogler at once sent a funeral coach to Morehead City for the body. Funeral arrangements will not be announced until late tonight when the party returns.

Mr. Coddington left Charlotte on Friday morning for Hatteras on a duck hunting expedition. He was joined at Morehead City by C. L. Whiting of Rochester, N. Y.; A. R. Southworth of New York; A. R. Carwyn of Brooklyn; Frank McPherson, an executive of the Carolina, Clinchfield & Ohio Railroad, and Herman Carroll and W. M. Webb of Morehead City. They had planned to hunt for a week or ten days.

The dead man was a native of Woodbury, N. J. He was 50 years old. He married Miss Marjorie Lyon of Greensboro, in 1908. She died suddenly in the Coddington home here in February, 1925. Three children survive. C. C. Coddington, Jr., a student at Woodbury Forest; Dabney Minor Coddington and William Inslee Coddington; one sister, Mrs. Joe D. Taylor of Charlotte and two half sisters, Miss Alicia Coddington and Mrs. J. J. Kennedy, both of New York.

## MAYOR WOULD TAKE CARE OF VISITORS HERE

### Appeals For Ample Parking Space On Dickinson Avenue And Evans Street.

In order to accommodate the thousands of visitors expected in Greenville during the holiday season, Mayor J. C. Lanier this morning issued an appeal to the people of Greenville urging them not to park any longer than possible on Evans street and Dickinson avenue during the holidays.

"Either leave your cars at home or park them on side streets so as to leave ample parking space on these two principal streets of the city," the mayor asked.

The appeal follows:

To the Citizens of Greenville:

The Christmas holiday season is now beginning, and during the next three weeks thousands of visitors from all over Eastern North Carolina will be our guests, and will shop in our stores. I am appealing to you to do your part in welcoming these visitors by leaving your automobiles at home, or by parking them on side streets, so as to leave parking space on Evans street and Dickinson avenue and other business streets for the out-of-town folks.

We have a law prohibiting parking on Evans street for more than an hour during the daytime, but this law can only be made effective by voluntary compliance by our citizens. Therefore, I am asking that each of you make it a personal matter to co-operate with the police in trying to provide parking space for our visitors during the holiday season.

## Naval Disarmament Gains The Spotlight in Europe

(By The Associated Press.)  
Naval disarmament, which supposedly has been a slumbering subject awoke from what was only a doze last week and probably will get coming attention from Anglo-American international thought in the near future. Back of this was an idea which has been gaining ground in the big English-speaking nations, a feeling that face to face consultation will accomplish results more surely and with far greater speed than traditional negotiations through diplomatic channels.

Herbert Hoover voiced this in his initial address to central American people when he emphasized that contact was one of the principal objects of his journey, "above all by the men elected to responsibility in their governments."

A few more days before that Stanley Baldwin, Prime Minister of Great Britain, had said that much of the misunderstanding regarding the British and American viewpoint on navies might have been avoided had the statesmen of the two countries been able to talk things over instead of relying upon communications across 3,000 miles of ocean.

Jacksonville, Fla., Dec. 3.—(AP)—Lieutenant Leonard S. Flo, who recently failed in an attempted non-stop flight from Canada to Cuba, when he was forced down at Key West by illness, planned to leave here late today by rail for Chicago to attend the international air show.

Lieutenant Flo hopped off from Key West yesterday in his Spartan biplane on a proposed non-stop flight to Jacksonville, but was forced down at Daytona Beach because of bad weather. He left his plane there and proceeded here by train.

After attending the air exposition at Chicago, Lieutenant Flo said he would return to Daytona Beach and fly his plane north for another attempt at a non-stop flight from Canada to Cuba. He also said he was planning to enter the air race to be staged from Detroit to Miami in January. His home is at Ann Arbor, Mich.

## LEAF SALES RESUMED IN CITY TODAY

### About 700,000 Pounds Of Leaf Here When Market Re-opens After Thanksgiving.

The Greenville tobacco market reopened this morning following observance of the Thanksgiving season. There was approximately seven hundred thousand pounds of bright leaf on the floors of the nine warehouses with indications that sales would be completed during the afternoon hours.

Sales will start at usual, promptly at nine o'clock every morning, the supervisor of sales stated today. There will be no more holidays until Christmas. A considerable volume of bright leaf is expected to be offered for sales before the holiday season begins.

It was stated that the price situation today showed greater strength than last Wednesday when the market suspended sales for Thanksgiving. While the bulk of the offerings consisted of inferior grades, much good tobacco was also in evidence. Prices on all grades showed pronounced improvement over last week.

## HOOVER GETS OFF FOR PERU EARLY TODAY

### The President-Elect Leaves Ecuador After Receiving Splendid Reception.

U. S. S. C. Maryland, En Route to Callao, Peru, Dec. 3.—(AP)—Herbert Hoover today left Ecuador for Peru where he plans to land Wednesday at Callao.

The president-elect was accompanied on the seventy-mile ride on the cruiser Cleveland, from Guayaquil by President yora, who through newspaper men sent greetings to the American people. He said he was pleased because of Mr. Hoover's visit, declaring it would create better feeling and improve relations between the United States and South America.

After reviewing financial, sanitary and other reforms which he said his government had accomplished, Ayora asserted that Ecuador maintained friendly relations with all countries.

"There are some boundary disputes," he said "My government favors early and final settlement of these on the basis of justice and equality and wants to deal with them through direct negotiations with the governments concerned."

The principal boundary dispute is with Peru and there is also one pending with Colombia.

Ayora, who traveled to Guayaquil to formally welcome Hoover yesterday, talked with the president-elect on the Cleveland for more than two hours, discussing financial and economic affairs of Ecuador and the manner in which the United States might assist the republic.

Ayora seems proud of the fact Ecuador's finances had been restored to a gold basis, with a central bank system fashioned somewhat along the lines of the United States Federal Reserve bank. There is also a farm bank in Ecuador. Ayora said his government had established a board of social welfare to improve conditions of labor and to enact laws for the welfare of women and children.

Hoover was especially interested in the operation of these laws as they dealt with subjects on which he put emphasis in his campaign for the presidency.

Besides Ayora, Hoover was accompanied to the Maryland by Foreign Minister Fronte, Finance Minister Tejada and the American Minister Gerald A. Bading.

## British Freighter Sinks In Pacific

Vancouver, B. C., Dec. 3.—(AP)—The abandoned British freighter Chief Maquila, disabled by heavy seas last week, sank yesterday, in mid-Pacific, two thousand miles off British Columbia at about 175 east and 51 north.

The ships crew of 40, including eight white officers and thirty-two Chinese, was taken off by the Japanese steamer Yogen Maru, which was standing by when the freighter went down.

Loss was estimated at \$1,000,000 by the Canadian-American shipping company. The vessels owners, The 9,500-ton craft was valued at \$500,000 and its cargo, wheat and lumber consigned to the Orient, at a similar sum.

## AYDEN WOMAN KILLED BY CAR

Miss Mary Worthington, 60, was run down and killed by a hit-and-run driver on the Kingston-Greenville highway, on the outskirts of Ayden, Saturday night, according to information reaching this city today.

Miss Worthington was crossing the street in front of her home when an automobile driven by an unidentified person swerved to the left and crashed into her. The car is alleged to have then cut to the right and continued in the direction of Kingston. The sole witness to the tragedy said he was not close enough to recognize the driver of the car or to determine whether he was white or colored.

Several negroes were arrested by Ayden authorities shortly after the accident, but evidence submitted at a preliminary hearing was insufficient and they were released. Police and county officials were today maintaining a keen vigil in all parts of the county in an effort to apprehend the driver of the death car. Officers in other counties have also been notified to assist in the investigation.

Miss Worthington was buried in the Ayden cemetery yesterday. She was a native of Ayden and had lived on the outskirts of the city for a number of years. She is said to be survived by several relatives.

## SPECIAL TERM OF SUPERIOR COURT OPENS

### Jackson Embezzlement Case To Be Feature Of One Week Session.

A special term of Pitt county Superior court, for the trial of criminal cases, convened in this city today with Judge J. H. Harwood, of Wayneville, N. C., presiding. Numbers of cases which have been hanging fire for sometime will be given consideration during the week and the congestion which has featured the docket the last several months is expected to be greatly relieved.

One of the outstanding actions to be given hearing this week is that against former Sheriff Amos Jackson, charged with embezzlement of approximately \$100,000 from Pitt county during his administration. The case was first heard about two years ago, but the jury was unable to agree and mistrial was ordered. The case is set for Wednesday.

The other cases to be heard this week consist of violations of prohibition and traffic laws. The court got away to a good start this morning and it was indicated at noon that considerable progress had been made. Solicitor D. M. Clark was prosecuting the docket.

## Bottlers Meet At Greensboro

Greensboro, Dec. 3.—(AP)—Representatives for virtually every section of North Carolina and visitors from several surrounding states were here today to attend the fifteenth annual convention of the North Carolina Bottlers Association starting this afternoon.

N. N. Beadles, of Asheville, president of the State Organization is here to preside at the convention which will close tomorrow afternoon at a banquet at 7 o'clock tonight with George Martin, of St. Louis, presiding, will be a major part of today's program.

Senator Royal S. Copland of New York, will address the convention at 10:30 o'clock tomorrow morning.

## King George Reported Slightly Better Today

London, Dec. 3.—(AP)—Fears of impending calamity which had gripped the British public throughout the night, after it was learned that King George had been given oxygen and that his long illness had menaced his heart, were somewhat allayed by the doctor's report this morning. The report said the king's condition was slightly improved.

There remained in the public mind, however, a conviction that the king was fighting for his life with the issue still very much in doubt. This was intensified by the knowledge that oxygen was being used in his case. However, Buckingham Palace authorities minimized the importance of this and explained it was customary to administer oxygen for its tonic effect in such cases.

Six Stanley Hewett and Lord Dawson, of Penn, the king's physicians, issued this medical bulletin at 10:30 a. m.

The king has had three hours of quieter sleep since the issuing of the last bulletin. The temperature is now 99.8 and there is a slight improvement in the general condition.

No mention was made of how the king's hard taxed heart was functioning with the exception of the inference regarding it contained in the statement that his general condition was slightly improved.

The doctors' morning visit, their statement and its result seemed to have a reassuring effect at Buckingham Palace and there appeared an appreciable lessening of the tension which had prevailed there.

The queen, with Princess Mary at her side, spent a trying night, anxiously awaiting the next development with knowledge of the hard struggle her royal consort was having at this serious stage of his illness.

That the king's constitution, is making a stern fight against the weakness induced by his long struggle against microbial infection is the impression produced in palace circles and elsewhere.

## PROBE LIQUOR CONDITIONS AT PUEBLO, COLO.

### Practically Entire City Administration To Appear Before Federal Grand Jury.

Leadville, Colo., Dec. 3.—(AP)—Hell-roaring old days of this colorful, "cloudy city" mining camp. Federal dry agents claim, are not as passed as would be supposed under the Volstead act, and a Federal grand jury at Pueblo has summoned nearly the entire city administration to testify regarding the alleged present conditions.

The investigation was slated to get under way late today or tomorrow, and the city was nearly bereft of officials today.

Eighteen subpoenas served by the United States marshal called for the appearance of the entire city council, county sheriff, city attorney, a police captain, and owners of several alleged saloons along Harrison avenue, the principal thoroughfare.

Those scheduled to appear included Dennis O'Neil, city marshal; William Corbett, William Lapping, Douglas Platt, George Williams, Oscar Williams and Ross Pearson, all city aldermen; B. D. McLeod, city attorney; Harry Schneider, Lake county sheriff; O. M. Yammick, deputy sheriff; Art Lanning, Archie Knox, Jack Kern, Williams McCarthy, Aaron Spencer, Mrs. Louis Tartar, Mary Snyder and Mrs. John Lannich, all proprietors of restaurants, cigar stores and soft drink establishments.

Federal officials said that all the persons had been subpoenaed to act as witnesses, but that they are under information which if the jury sees fit, may result in Federal indictments. Although the nature of the charges was not learned, it was said the government is making a stand against alleged liquor activities here and against malfeasance of officials while in office.

Federal investigators, active for more than a year in making sweeping investigations of liquor conditions, claim that some of the 63 saloons doing business here when the state went dry in 1916, did not accept the mandate in the proper spirit, and that many glistening mahogany bars were not folded up, a short time, then they were brought back into service in "soft drink" parlors, and that the serving of liquor, on a reduced scale, soon was resumed in a half dozen parlors.

It was alleged conditions had become such that on the occasion of a recent appearance of Federal officers, an unidentified resident espoused down Harrison avenue, a la Paul Revere, and passed the word that "the Federals are coming." The officers found the town closed up.

Prior to 1916 prohibition lacked popular approval in Leadville, probably Colorado's richest mining camp which nestles among the bleak crags of the high Rockies nearly 11,000 feet above sea level. The city, then about 10,000 population, voted heavily against prohibition in the election that year.

## Louisiana Man Held On Charge Robbing Train

Monroe, La., Dec. 3.—(AP)—Arrestment on a charge of robbing the United States mail today faced Clyde Woodson, 24-year-old Monroe bricklayer. Woodson has confessed, the sheriff said, that he is the man who held up an Illinois Central passenger train near here Saturday night and escaped with a quantity of money and jewelry.

Woodson denied firing the shot which entered the neck of a passenger, K. M. Blount, of Memphis. He also denied entering the mail car.

Woodson was arrested yesterday after he had held up and robbed three negroes in Monroe. He was brought here in an automobile which halted Saturday night near the scene of the train robbery. The driver became suspicious when he learned of the train hold-up and tipped off police after his passenger had departed.

Two watches and \$46.20 were found on his person. Officers said they believed the rest of the loot had been hidden. It was estimated to be worth \$2,000.

S. W. Frisbie, conductor of the train, who was forced to accompany the bandit through the coaches while he relieved passengers of valuables, visited the jail and identified Woodson as the hold-up man.

The bandit, who got on the train at Monroe, crawled over the tender to the engine. The train was stopped and the conductor came forward to learn the trouble. The bandit forced the conductor to accompany him back to the coaches.

**GRID SEASON HAS CLOSED IN THE SOUTH**

 (Associated Press Sports Editor)

New York, Dec. 3.—(AP)—Except for a few sparkling and decisive tests in the south and far west, the 1928 college football season was closed an unprecedented and meteoric course along the chalk-marked battlefields.

Its chief developments have included record smashing attendance and gate receipts for the fifth straight year, an extraordinary succession of upsets featuring the downfall of champions and teams rarely out of the top flight—in short, a bewildering whirl climaxed by three crushing triumphs for the far west over legions east of the Mississippi.

From the spectacular viewpoint, the early season crowd of 122,000 that witnessed the Navy-Notre Dame game in Chicago was the high spot, smashing all football records. New marks in attendance also were set in the east and southwest, while every other section contributed to an outpouring over the country from September to December approximating 25,000,000 to 30,000,000.

From the angle of sheer playing accomplishments, representatives of the Pacific Coast and the south take the major share of the season's laurels, a situation that will find its appropriate climax in the New Year's Day engagement between two of the foremost teams of these areas, California and Georgia Tech, in the Rose Bowl at Pasadena.

The golden west has a double armlock and half Nelson on inter-sectional glory as a result of the sensational victories of Stanford over the Army, Oregon State over New York University, and Southern California over Notre Dame within a three day period. Whatever claims the east hoped to stake in the scramble for national title honors were wiped out by the crushing setbacks administered to the Army and N. Y. U. on the same brierion by teams that came 3,000 miles to rip up everything in sight.

Two of the foremost teams of the year, Georgia Tech and Florida, lead the south's drive for national recognition with fine records of achievement against all opposition. Neither has been beaten nor tied but each has one more sectional obstacle to hurdle this week, with Tech playing Georgia at Atlanta and Florida meeting another undefeated foe, Tennessee at Knoxville.

No team from any area has an unchallenged claim to national championship heights in a year that has seen so many sudden reversals, so many unexpected turns and days where otherwise brilliant outfits met misfortune.

So far as the records of major colleges go, only four can boast spotless slates: Boston College, the only tea mneither beaten nor tied in the east, and Detroit, enjoying the same distinction in the middle west, share this honor with the Southern Pacific, Florida and Georgia Tech.

**Score Injured In Train Detailment**

Roseburg, Ore., Dec. 3.—(AP)—Nearly a score of passengers were nursing injuries today as the result of the derailment of the Southern Pacific Shasta Limited seven miles north of here.

Two passengers coaches, a mail car and a baggage car of the train which was on its way from Portland to San Francisco, plunged down a six foot embankment and rolled over into a field. The locomotive stuck to the track.

The train was traveling between 35 and 40 miles an hour when engineer P. E. Prettyman of Portland felt the tire give way. He applied the brakes. The baggage car leaped from the rails and the others followed.

A group of vaudeville players and volunteers, led by Dr. Malcolm T. Maccahern of Chicago, administered first aid. Ambulances brought the more seriously injured to Roseburg. None of the injuries was believed to have been fatal.

**CARROLL CASE CONTINUED AT CAPITAL CITY**

**Judge Harris Overrules Motion For Non-Suit; Character Witnesses Called.**

Raleigh, Dec. 3.—(AP)—Judge W. C. Harris today overruled a defense motion for a non-suit in the case brought by the State Board of Charities and Welfare to revoke the license of Highland Sanatorium at Asheville, on the ground that Dr. R. S. Carroll, the proprietor, is morally unfit to operate such an institution, but sustained a demurrer by which Dr. Carroll, as an individual, was eliminated as a defendant in the suit.

With J. G. Stikeleather, of Asheville, a member of the state highway commission, and Congressman Zebulon A. Weaver heading the list the defense began its case today by calling a score of character witnesses.

Stikeleather and Weaver both testified that Dr. Carroll stood high in the regard and esteem of his community, and that his Sanatorium likewise was of high standing.

The defense demurrer sustained by Judge Harris was filed early last week. It was based on the contention that the suit brought by the State Welfare Board was instituted under a statute empowering

that board to bring a civil action to revoke a license issued by the board, and that inasmuch as Dr. Carroll personally held no such license, the case against him was without standing in court.

In opposing the demurrer, attorney General Dennis G. Brummit, conducting the case for the Welfare Board, explained to the court that Dr. Carroll had been named a defendant with the view that if the suit were won by the Board, the physician would be permanently barred from operating any hospital in North Carolina for the care of mental patients.

Dr. Carroll was expected to take the stand in his own defense after the character witnesses had given their testimony.

All of last week was consumed by the plaintiff in presenting testimony intended to establish charges of gross immorality and cruelty against the elderly head of the sanatorium.

London, Dec. 3.—(AP)—Arthur Wintworth Gore, former lawn tennis champion, died today at the age of 61. He had been ill since early this year.

Gore was the last Englishman to win the singles championship at Wimbledon. This was in 1909 and the next year he lost to A. E. Wilding. He was the captain of the English team which met America for the first time in 1900 and won Olympic Gold Medals in doubles and singles at Wimbledon in 1908.

**Boston College Finishes With Great Record**

(By the Associated Press)

East-Boston College, by beating Holy Cross, finished with best record, nine victories, no defeats or ties. Villanova, undefeated in the smaller college group, but tied once, Pennsylvania, Princeton, Brown, Lafayette and Carnegie beaten only once each but New York University, Army, Georgetown, West Virginia and Pittsburgh beaten twice in spite of otherwise impressive performances.

Big Ten—Illinois retains title after close race, with Wisconsin runner-up. All teams beaten at least once.

Six Six—Nebraska, the champion, winning all five conference games, but beaten by Army and tied by Pittsburgh.

Southern Conference—Florida and Georgia Tech, each with eight straight victories, in lead prior to final conference test this week, when Florida plays Tennessee, tied once and Tech meets Georgia.

Southwestern Conference—Texas holds title, with five victories and one defeat in conference play. Arkansas runner-up.

Rocky Mountain Conference—Utah captured championship, finishing conference slate with four victories and no defeats and one tie. Colorado University runner-up.

Pacific Coast Conference—Southern California, with four victories and one tie, tops list by narrow margin over California, showing three victories and two ties.

**College To Ask For Increase Of Appropriations**

East Carolina Teachers' College already has more applicants for the fall term of 1929 than it has space to accommodate. For the present college year it turned away more students than it accepted.

It has on its waiting list to enter for the winter term, which begins immediately after the Christmas holidays, 77 applicants. To enter the spring term there are 46 applicants. Judging from the records of the past several years, the college will again turn away more students for the coming year than it will accept.

The fact that the college has on file now a few more applications than it can accommodate for the coming year should all these applicants actually come, does not mean that owing to withdrawals it will not be able to accept some additional students for the coming year to fill the places of those who withdraw their applications.

The board of trustees at a meeting sometime ago decided to ask the next General Assembly to make appropriation sufficient to enlarge the college so that it can accommodate fifteen hundred students. This year the college has enrolled only 891 students to date.

## COTTON MARKET N. Y. STOCK LIST

New York, Dec. 3.—(AP)—The cotton market opened steady at a decline of 7 to 11 points during the first few minutes under liquidation together with some southern selling which was promoted by relatively easy Liverpool cables. The initial offerings were quite readily absorbed at the decline to 20.18 for January, and the market recovered to about Saturday's closing quotations after which trading was quiet and fluctuations rather irregular. At the end of the first half hour, prices were about 2 to 10 points net lower with December relatively easy under liquidation. Private cables said there had been local, London and continental liquidation in Liverpool but that cloth demand was well sustained with further business pending.

## GRAIN MARKET

Chicago, Dec. 3.—(AP)—Notwithstanding 2,168,000 bushels increase of the U. S. wheat visible supply total, wheat prices today averaged higher. World shipments of 21,935,000 bushels for the week set a new top record. Ready absorption of wheat offerings here, December delivery in particular, helped give the market a general upward trend except at the last. Corn was strengthened by reports of prospective large export requirements, and oats sold at new high prices for the season.

Wheat closed irregular at 3-8 to 1-2 net decline to 1-8 to 1-4 advance; corn 3-8 to 3-4 up; oats showing 1-2 to 5-8 to 3-4 advance, and provisions unchanged to a setback of 15c.

## STOCK MARKET

New York, Dec. 3.—(AP)—Heavy liquidation for both accounts brought about a sharp reaction in prices in today's stock market. Net losses of 1 to 4 points were distributed over a broad list of rails and industrials with a score or more of the high priced issues down 5 to nearly 15 points. Trading showed a further contraction in volume.

Call money renewed at 8 per cent and advanced to 9 as banks called \$35,000,000 in loans. Because of the necessity of strengthening their reserve position, banks had a relatively small supply of funds available, making 10 per cent call money again a likely prospect.

There was nothing in week-end news developments to influence the selling movement. However, the sharp break in Canadian Marconi on the New York curb, stiff money rates and the indications of another huge increase in stock exchange member loans led to a widespread liquidation of speculative accounts. Many traders also were scared at the rapid manner in which prices of some of the recent favorites melted away under pressure.

Greene Cannanea Copper broke 13 points on the first sale. Radio ran off 10 1-2 points before midday, but quickly recovered its loss. Canadian Pacific dropped 9 1-2 points and Keith-Albee, common and preferred, Woolworth, General Electric, Union Carbide, Victor Talking Machine, Montgomery-Ward, Cerro de Pasco Copper, Yellow Truck and Packard Motors sold down 4 to nearly 8 points.

Only a few issues moved against the general downward trend. Warner Bros. A soared nearly 10 points to 138 and Standard Milling moved up 4 to 128, both new high records.

While few commission houses recommended short sales at this stage of the market, most of them continued to urge a cautious policy on the long side because of the market's seemingly top-heavy speculative position. Recent tightening of margin requirements also has frightened some traders out of the market, although accounts generally are reported by exchange members to be in a strong position.

The closing was irregular. Sales approximately 4,500,000.

## River and Harbor Improvement Will Cost \$50,781,880

Washington, Dec. 3.—(AP)—Improvement of river and harbor projects throughout the country and their maintenance will require \$50,781,880 exclusive of Mississippi river floor control work, during the fiscal year ending June 30, 1930. Major General dear Jadin submitted estimates of the various projects to Congress today with his annual report showing that \$47,295,276 was expended on these projects in the year which ended June 30, 1928, and that \$73,181,490 was available for the work during the current year which ends June 30, 1929.

Seacoast harbors and channels will require \$20,418,260, while the Mississippi river system will require \$20,033,000. Lake harbors and channels will require \$4,897,500 and internal waterways \$3,491,500. The inland waterway from Delaware Bay to Chesapeake Bay will require \$1,000,000, and that between Beaufort and the Cape Fear river in North Carolina, \$1,000,000.

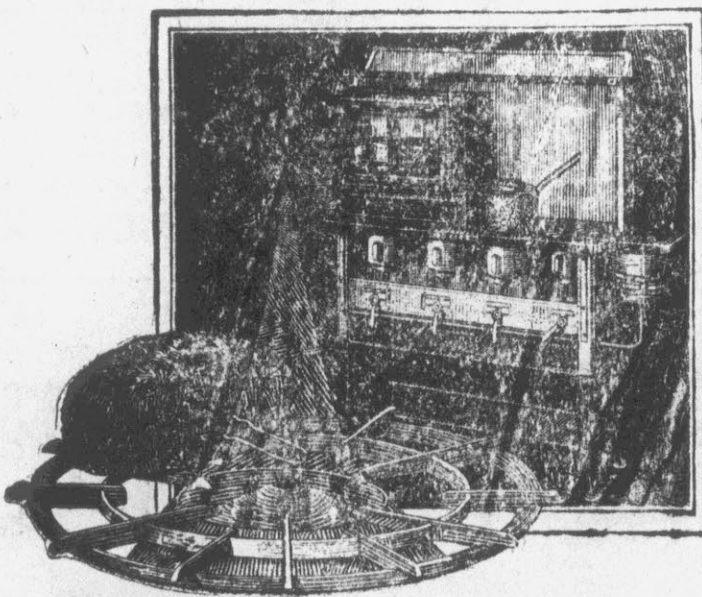
