## MRS. CARROLL TAKES STAND FOR HUSBAND

### Defense Completes Testimony Today In Case Against Dr. Robert Carroll.

Raleigh, N. C., Dec. 7.—(AP)—Testimony of the defense was completed today in the suit of the State Board of Charities and Public Welfare to revoke the license of the Highland Hospital at Asheville. The board charges that Dr. Robert S. Carroll, the hospital's medical director, is morally unfit to conduct such an institution.

Defense attorneys announced their testimony had been concluded at the end of two hours of the morning session after four witnesses had been heard. They asked and received permission, however, to put on more character witnesses later. At the request of attorneys for the Welfare Board, Judge Harris then recessed court until the afternoon session to allow them time for a conference in preparation of rebuttal testimony.

Mrs. Carroll, who testified last night, was called to the stand again today. She said it was her husband's custom not to visit the hospital on Sunday and vespers services. Her testimony was offered in refutation of Miss Gertrude Corbett's statement that Dr. Carroll had forced his advances upon her one

Sunday afternoon in his office at the hospital.

Two Asheville men, Dr. Charles H. Coker, former vice-president of the State Medical Society, and W. B. Williamson, trust officer of the Asheville branch of the Wachovia Bank & Trust Company, testified that the reputation of both Dr. Carroll and the Highland Hospital was bad.

Dr. Carroll completed his examination yesterday, continuing to deny all charges of immorality, impropriety, cruelty and neglect laid against him in the testimony of plaintiff's witnesses.

Last night, Mrs. Carroll took the stand and affirmed her faith in her husband's innocence of the charges. Miss Mary F. Porter, who described herself as a psycho-therapist and secretarial assistant at the hospital, testified this morning that in her 14 years connection with the institution she had never known Dr. Carroll to be guilty of immoral or improper conduct toward any of the patients or nurses.

She admitted having heard Miss Gertrude Corbett, former patient and employee, testify she had been wronged by Dr. Carroll, but she intimated that the young woman was perhaps influenced by anger she exhibited when another nurse was promoted over her at the hospital.

### Survivors Tell Harrowing Tale Of Yacht Blast

Melbourne, Fla., Dec. 7.—(AP)—Two survivors of a yacht explosion off Melbourne recounted their harrowing hours in the water today, while searchers were still looking for three other men who were on

board the craft when it took fire and sank Wednesday night.

Edward Satmover of Jacksonville, unable to swim, clung to a gek throughout the night and was picked up by a fishing smack yesterday morning. He had suffered little and was believed to be enroute to his home.

Leslie Royal, also of Jacksonville, was picked up here last night after swimming toward the shore most of the night and all day. He was suffering from exhaustion and was taken to a hospital to recuperate. He was almost unconscious after a long struggle to ward off cramps and strangulation in shark infested water.

The fate of the other three, identified as William Sutton, Johnny Koch and William Reynolds, who was with Satmover were indicted at Jacksonville Monday on charges of violating the national prohibition laws, was undetermined today.

Both of the survivors said the boat took fire from a back-firing engine and an explosion followed. Melbourne residents reported signals and flares Wednesday night, which sent four coast guard vessels to the scene. Royal said the coast guard passed within 150 feet of him several times.

### Radio Commission May Function For Quite Awhile Yet

Washington, Dec. 7.—(AP)—The Federal Radio Commission, scheduled to pass out of existence on March 16, may continue to function as usual for a time after that date. Chairman White, of the House Merchant Marine Committee, co-author of the radio act, is drafting a resolution asking that the life of the commission be extended. He said that he is opposed to

making the commission a fixture but he believes in view of its existence it should be kept in power long enough to complete some of the most important tasks confronting it.

Chairman White declared that this should not be taken to mean that he altogether approved of the commission's work, adding that he believed it made a mistake when re-licensed all outstanding stations.

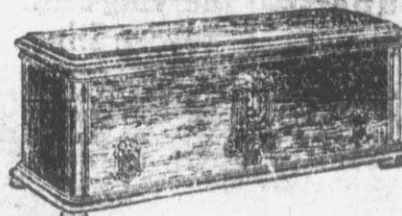

"In Roy O. West Mr. Coolidge has chosen for this office a man associated for many years with Samuel Insull in his power companies; a man who has had holdings of Insull stock; a man who testified before the Reed committee of the Senate that he has been an attorney for the Insull companies since 1897 and that he had 'always conferred with Mr. Insull' as to politics, during these twenty-five or more years."

"We do not impugn Mr. West's honesty or question his motives in accepting this appointment. But it seems perfectly clear that no man ought to be put in a position of passing judgment upon matters affecting the interests of corporations with which he has been identified for twenty years. And it also seems clear that no good precedent is set by placing a public-utilities lawyer at the head of the Department of the Interior."

"Mr. West's appointment ought to be promptly and emphatically rejected by the Senate."

"It is wonderful, my friendship in Ormond. People are so good to me. Friendship is one of the greatest things in life, Mr. Yorbi. What is that wonderful word?"

The attendant addressed suggested "contentment," but Mr. Rockefeller's thoughts were in another groove.

"Ah, yes," he smiled after a med-

itative pause spent gazing far away through the train window. "I have it—acclaim; that is the word."

Turning to the correspondent, he said: "You know that old saying, 'It's better to be acclaimed than have riches?' You want to remember that young man, because when you grow old you will find out how true it is."

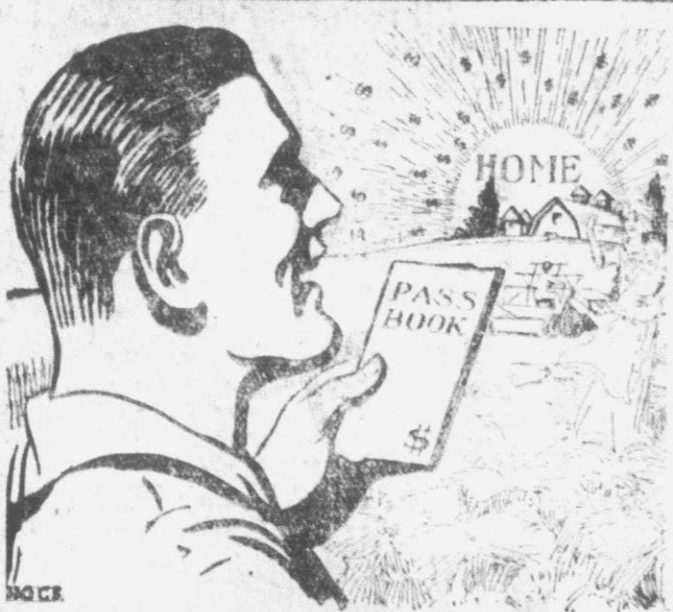

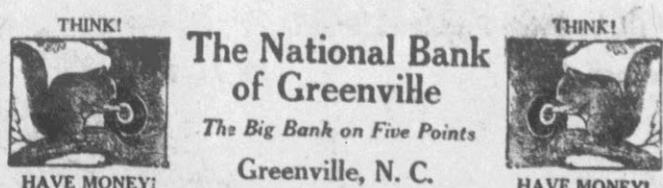

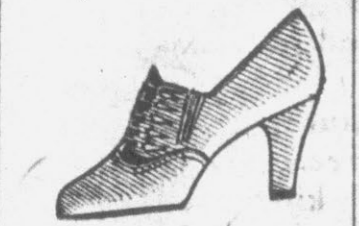

New York, Dec. 7.—(AP)—The cotton market opened steady at an advance of 3 to 7 points in response to relatively steady cables with January selling up to 20.19 and May to 20.15 on covering together with some Liverpool and Continental buying. The comparatively moderate demand was supplied by further liquidation and southern selling, however, and the market eased back to about yesterday's closing quotations during the early trading. The buying continued in sufficient volume to promote a fairly steady upturn, and prices at the end of the first half hour run about 3 to 4 points net higher. Private cables reported calling any Bombay buying in the Liverpool market and said there was a fair inquiry for cotton cloth from South America.

## GRAIN MARKET

Chicago, Dec. 7.—(AP)—All grain values were on the downgrade today and wheat touched the lowest price level of the week. One of the bearish factors was an estimate from a leading crop expert that the United States farmers have 241,000,000 bushels of wheat yet to be marketed, as against 205,000,000 bushels a year ago. Expert demand, however, for wheat from North America was somewhat improved. Purchases for Europe today totalled about 900,000 bushels.

Wheat closed weak 5-8 to 1-1-8 net lower; corn 3-8 to 3-4 down; oats also at 3-8 to 3-4 decline and provisions varying from 10 setback to a rise of 5c.

## STOCK MARKET

New York, Dec. 7.—(AP)—The stock market, which went through one of the most sweeping reactions in recent years in yesterday's session, started a remarkable comeback after a weak opening today. Early declines of 3 to 20 points were largely made up by midday, and a long list of issues were marked up 2 to 10 points above yesterday's final quotations in the afternoon trading. Sales were in enormous volume, with the ticker nearly half an hour behind the market at midday.

The recovery was stimulated by indications of easing credit conditions. Although call loans renewed at 10 per cent, the highest opening rate in eight years, a plentiful supply of funds appeared at that figure, leading to hopes of a lowering in the rate. Receipt of \$5,000,000 in gold from Canada, coupled with predictions that the current inflow may reach \$30,000,000, also helped to turn the tide of speculative sentiment.

Rails also took a prominent part in the upswing. Northern Pacific, which is expected to increase its annual dividend from \$5 to \$6 a share this month, advanced 5 points and Erie, common, 4.

The closing was heavy. Total sales aggregated 5,300,000 shares.

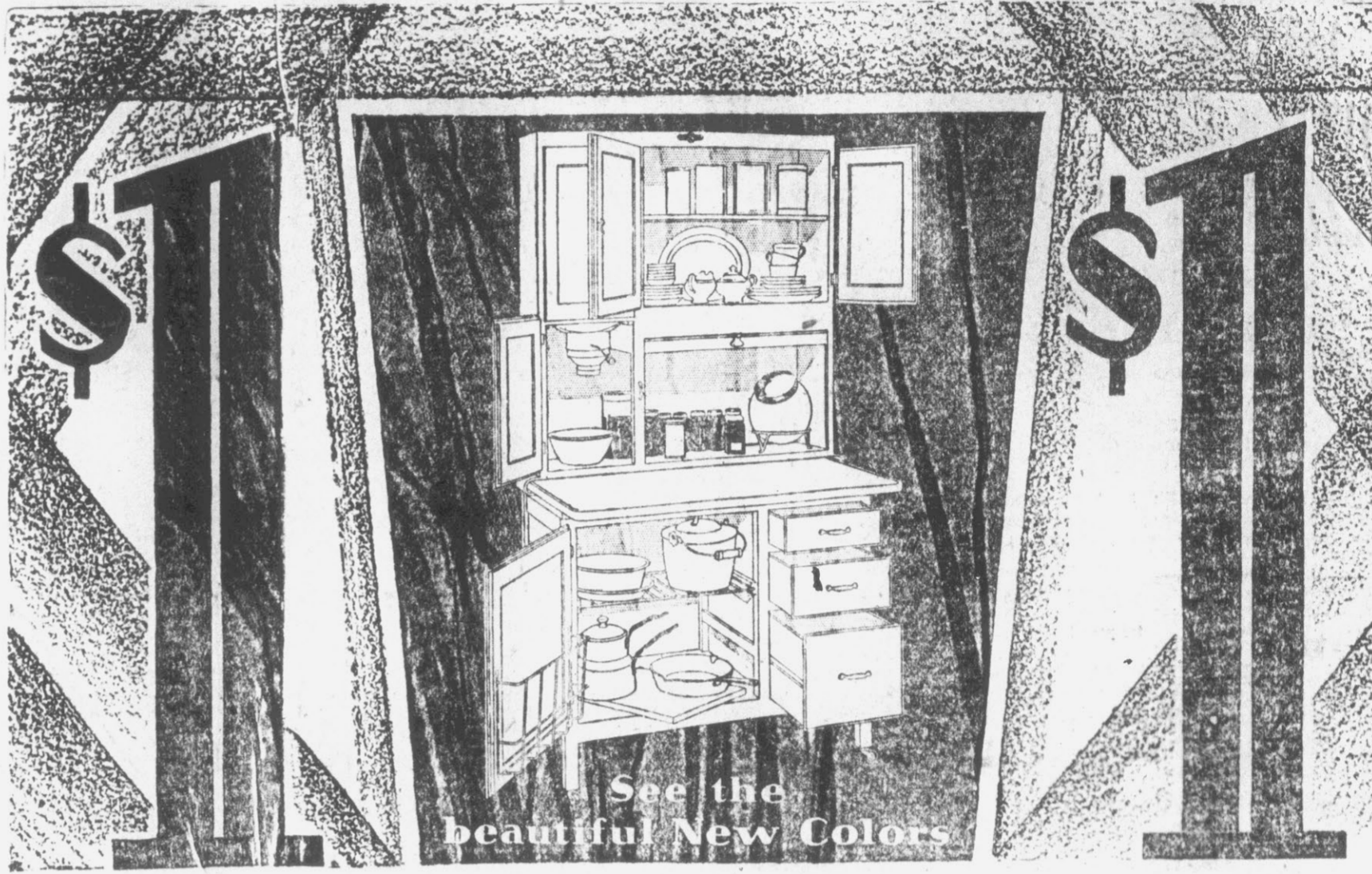

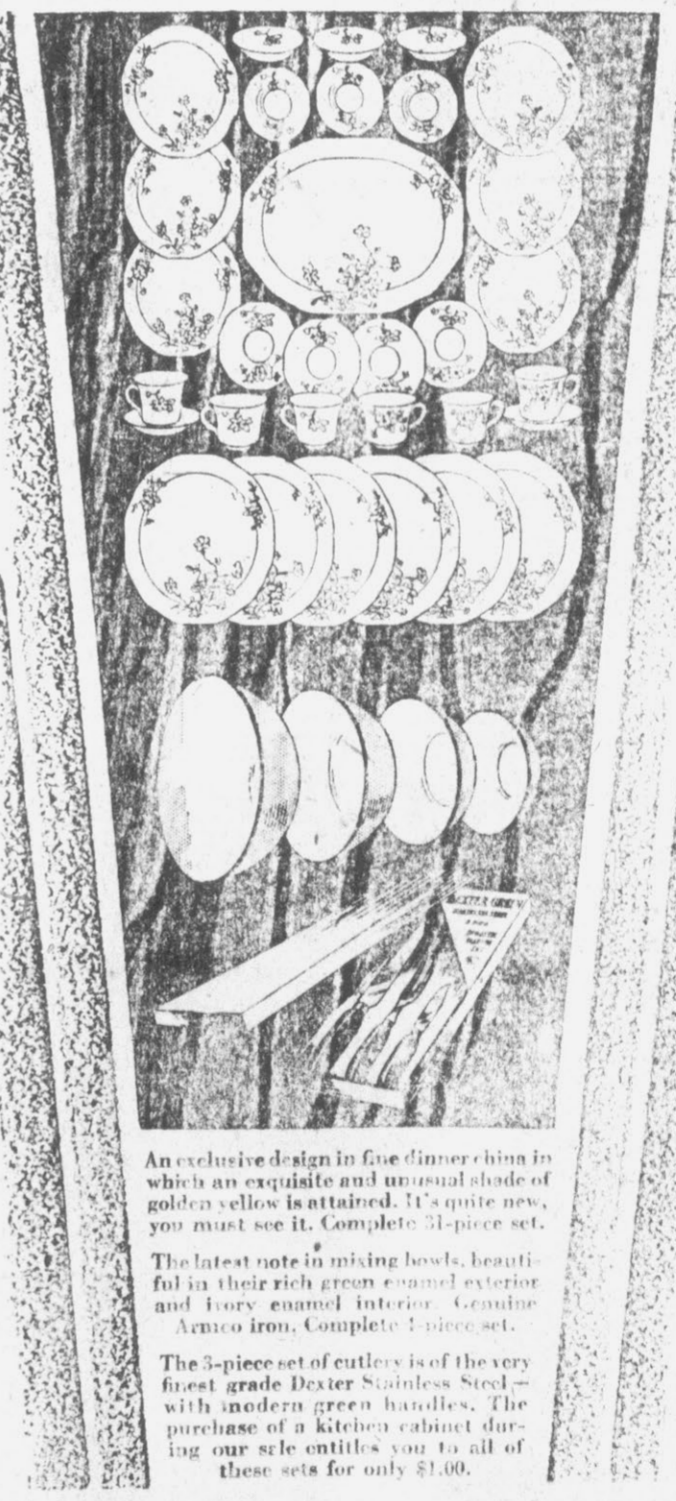
