TREATY STILL HOLDING SWAY WITH SENATE

House Again Tied Up With Reapportionment Of Its Membership.

Washington, Jan. 11.—(AP)—Caught in cross currents, the Kellogg treaty occupied its familiar place in the Senate today as the House again tried to decide reapportionment.

Due to unusual factors, the treaty is not expected to come to a vote this week. Some of those who want it passed without reservations of interpretations are in no hurry for the final roll call.

Representative Fenn, of Connecticut, has said that he was optimistic that his reapportionment bill would be passed but the opposition is known to be strong. Under the proposed plan the membership of the House would be reapportioned in accordance with the 1930 census. Those states who would lose members under the arrangement are fighting it; those who would gain are for it.

The flurry over fraudulent documents appeared to be over today for the moment, though Senator Borah, of Idaho, wants an investigation to get at the source of the spurious papers which purported to show that he and Senator Norris, of Nebraska, received sizeable sums of money from the Soviet government.

The Senate commerce committee yesterday postponed its report on the nominations of Brigadier General Thomas H. Jackson and Major Ernest Graves to be members of the Mississippi River commission and the question was still before it today. On the House side tariff hearings continued before the ways and means committee and the merchant marine committee had not disposed of the bill which would extend the life of the radio commission for a year.

Teacher On Trial In Evolution Case At Jamestown, Tenn.

Jamestown, Tenn., Jan. 11.—(AP)—A man who declares that "the true story of the creation of man can be found only in the Bible," and readily states that he is an anti-evolutionist, today faced trial before the Fentress County Board of Education on a charge of teaching and furnishing pupils literature teaching the theory of evolution.

The man is Prof. Elmore Gentry, principal of Clark Range county high school. Affidavits were filed against him by the fathers of two pupils.

With both contenders apparently on the same side, the fireworks of the famous Scopes evolution trial at Dayton apparently will be lacking.

Prof. Gentry is 48 years old, and has been teaching in Tennessee schools for 29 years. Although disclaiming his belief in the theory of evolution, Prof. Gentry maintains that he is in effect obeying another law of Tennessee and a regulation of the State Department of Education when he makes literature dealing with the subject available to the 48 high school and 125 grade school pupils in the Clark Range school.

The book upon which the charge is based is Volume 1 of "The Outline of Knowledge." It deals among other things with "evolution, the romance of the ages." The book mysteriously disappeared from the school library about the time the charges were brought.

The volumes, the professor said, include history, art, English, poetry and other subjects and if he noticed a discussion of evolution in them he thought nothing of it, as he said the state of Tennessee already had required him to supply books discussing the subject. He cited an encyclopedia as an example, saying that the law required him to have one available, and from a discussion of evolution in one he read the following sentence:

"The proof of man's origin from some primate is now past dispute." Prof. Gentry proposes to introduce both the encyclopedia and the dictionary as evidence, he said.

Lips Described As Stock In Trade

Los Angeles, Jan. 11.—(AP)—A motion picture actress' lips are "stock in trade," a Los Angeles judge stated yesterday in awarding Thelma Gorman, of the movies, damage of \$7,112 from Kenneth Sanderson because her upper lip was marred in an automobile accident for which Sanderson was held responsible. Judge James H. Pope, who made the ruling, said:

"In this day and age a woman's lips are her stock in trade, especially if she is engaged in motion pictures."

PRICES SHOW STRENGTH ON LEAF MARKET

Market Averaged \$19.47 Hundred Lbs. On Nearly Hundred Thousand Pounds.

Greenville tobacco market yesterday sold 87,164 pounds of tobacco for \$1,678,14, at a general average of \$19.47 per hundred pounds, it was made known today in the official daily report issued by K. W. Cobb, supervisor of sales.

The average was a few cents higher than any other day since the market opened after the Christmas holidays and led tobaccoists to believe a similar situation would continue the remainder of the season.

The report indicated there was something like two hundred thousand pounds of leaf on the floors of the nine warehouses today. Sales were expected to be completed before the noon hour.

Season sales today passed the 60-million pounds mark, which puts the market within less than a million pounds of the goal of 70-million pounds set for this season. With sales continuing the remainder of the month, tobaccoists were confident the goal line would be reached, probably with some to spare.

Tobaccoists continued to urge upon the farmers the necessity of marketing the remainder of their crop as hurriedly as possible. The market will close for the season the latter part of the month and it is hoped the entire season's crop will have been disposed of by that date.

Approve Increase For Prohibition Enforcement In U.S.

Washington, Jan. 11.—(AP)—An increase of \$25,000,000 in the fund for prohibition enforcement was approved today by the Senate Appropriations Committee.

The increased funds which would become available immediately to the prohibition bureau was voted on motion of Senator Harris, Democrat of Georgia, who recently described enforcement as a "farce."

Since the prohibition law became effective ten years ago, the government has been appropriating about \$13,000,000 and if the proposed increase goes through the money to use in enforcement would be trebled.

More Evidence In Los Angeles Case

Los Angeles, Jan. 11.—(AP)—The testimony of Milton Pike, star witness for the prosecution in the trial of former District Attorney Asa Keyes on charges of accepting bribes, remained unfinished today as the prosecution began its second session of presenting evidence.

Pike was an employee in the little tailor shop of Ben and Dave Getz-off, alleged intermediaries for Keyes and persons who are alleged to have paid him for clearing them of criminal charges. Upon taking the stand yesterday he produced a notebook which he said contained entries about what he had overheard from Keyes and those accused of giving the bribes.

Oil Magnate Weds
Pittsburgh, Jan. 11.—(AP)—Joseph C. Treves, 59, multi-millionaire oil operator who rose from a laborer in the oil fields of Western Pennsylvania, to be one of the dominant figures in the international oil industry, has married his former secretary, Miss Edith Lehm, 35, of Dormont, a suburb, it was learned here today.

LOCAL BODY IN FAVOR OF SURVEY HERE

Merchants' Association Endorses Survey Of Greenville And Community.

An industrial survey of Greenville received hearty endorsement at a meeting of members of the Greenville Merchants' Association last night. The proposition will be carried before an adjourned meeting of the Board of Aldermen tonight by James Jenkins, representing Craig P. Gilbert, of Washington, industrial representatives, and a committee from the Merchants' Association.

The proposed survey would set forth the advantages of Greenville and surrounding community with a view of interesting manufacturing concerns in locating here. The Craig P. Gilbert organization is handling surveys of several cities of the country, and has rendered valuable assistance to manufacturers in finding suitable locations.

Mr. Jenkins appeared before the directors of the Merchants' Association last night and explained the nature of the survey and the advantages which should be derived from it. Hundreds of manufacturers over the country are constantly erecting new plants or moving old ones, and the industrial concerns assist them in finding desirable locations.

The directors of the association were highly pleased with the proposition, and after expressing endorsement, appointed a committee to appear with Mr. Jenkins at the adjourned meeting of the City Fathers tonight for a further discussion of the matter.

It is generally realized that Greenville is badly in need of manufacturing enterprises. Members of the association expressed belief that an industrial survey, such as that proposed, would be a splendid means of interesting outside capital in moving to this community.

ROOT CONFERS WITH HOOVER EARLY TODAY

Former Secretary Of State Discusses Latin American Problems With President-elect.

Washington, Jan. 11.—(AP)—Elihu Root, of New York, secretary of state in the Roosevelt cabinet, had more than an hour's conference today with President-elect Hoover as a breakfast guest at the Hoover home on S street.

While no statement was made it was understood that Latin American affairs entered into the conversations. While Mr. Root was secretary of state he made a trip to South America and delivered a number of speeches in that country.

The president-elect had a luncheon engagement with Senator Watson of Indiana, prospective Republican leader in the Senate at the next session, but it was postponed until tomorrow. Mr. Hoover and the Indianan will go over the legislative situation in detail.

The president-elect had an unusually large number of callers today, most of them senators from the western agricultural states with whom he talked farm relief legislation and an extra session of the new Congress.

McLean Commutes Prison Sentence Of Raleigh Man

Raleigh, Jan. 11.—(AP)—One of the last acts of Gov. A. W. McLean before relinquishing his post to O. Max Gardner, governor-elect, today was to commute the sentence of Lawrence Gatlin, young man of Raleigh, convicted in January, 1924, of second degree murder and sentenced to thirty years in state's prison. His sentence was reduced to a minimum of ten years and a maximum of fifteen.

Gatlin was convicted after killing his wife and Owen Stevens, whom he found with his wife in their home.

Governor McLean recommended that his successor parole Gatlin six months before his sentence-ended, to restrain the prisoner in the future "and in some way assist in his reformation."

Gardner Becomes Governor Of N. C.

Raleigh, Jan. 11.—(AP)—With a simple ceremony in the presence of 5,000 men, women, and children O. Max Gardner, of Shelby, was inaugurated as 85th Governor of North Carolina here today.

Presented by his predecessor, Governor A. W. McLean, the 46-year old farmer, banker, lawyer, and manufacturer, took the oath of office at 12:30 o'clock this afternoon in the city auditorium, the same building in which he was nominated six months ago by the Democratic state convention.

Chief Justice W. P. Stacy, administering the oath of office, after other members of the New Administration had been sworn in by the four Associate Justices of the court. Immediately, the new chief executive launched into his inaugural address, pledging his administration to a continuation of a policy of advancement for the state on progressive but economical lines.

Few suggestions were made for new legislation. The Governor proposed, however, that the gasoline tax be increased from four cents to five cents a gallon, with a provision that the state take over certain county roads in order to relieve the counties of a portion of their tax burden. He advocated a substantial increase in the school equalizing fund, but opposed the eight months term by legislative enactment at this time. He made good on his campaign pledge to favor an Australian ballot system, and a revision of the primary laws.

After the inauguration, the new Governor and the former Governor reviewed a parade embracing military and civilian organizations, and retired to the state capital where in the Chief Executive's office, McLean formally turned the reins of state over to Gardner.

The inauguration program began at the executive mansion, where Governor and Mrs. Gardner were guests last night. State officials assembled shortly after 11 o'clock to greet the official photographers were taken and the inaugural party proceeded to the auditorium by automobile.

Governor McLean and Governor-elect Gardner occupied the first automobile in the procession. An R. O. T. C. unit from State college Gardner's Alma Mater, the Cadet corps of Oak Ridge Institute, and national guard military units made up the parade.

In the auditorium, Lieutenant Governor J. Elmer Long presided over the ceremonies as presiding officer of the joint session of the general assembly.

After the Governor's inaugural, Lee B. Weather's, publisher of the Cleveland Star and President of the State Press Association, presented the new Governor with a souvenir volume of bound letters written by 4,000 citizens of his native county of Cleveland.

He paid high tribute to the new head of the state government. A luncheon at 2:30 o'clock in the executive mansion was arranged for Mrs. Gardner by the inaugural committee.

Dollar Line Ship Reported Aground

Panama, Jan. 11.—(AP)—The steamship President Adams, of the Dollar Line, bound for San Francisco, was way of the Panama Canal, struck a reef of the Cristobal breakwater today and went aground. At 2 o'clock this morning three tugs were trying to pull her free.

The President Adams left Boston on December 30 and New York on January 3, with 90 passengers for Marseilles by way of Havana and San Francisco, calling also at Far East and Mediterranean ports en route.

Most of the passengers, it was said at the Dollar Line offices, were making the complete trip. A few were to disembark at Havana and San Francisco.

Five Persons Killed In Airplane Crash Today

Middletown, Pa., Jan. 11.—(AP)—Five persons were killed and three injured when a big passenger plane crashed at Royalton, near the Army airport here today.

The ticket agent of the Pennsylvania Railroad at Middletown said he saw the plane leave the field at Middletown, waver in its flight and finally fall. He rushed to the scene and helped extricate four bodies from the wreckage. Another man was dying, he said.

There were ten persons in the plane when it fell.

The wrecked plane was an Army transport piloted by H. A. Dinger, of Bolling Field, Washington, which arrived here at 10:40 this morning and left soon after noon.

Although Captain Dinger piloted the plane to the airport he left Middletown in another ship just ahead of the transport.

The plane was being piloted by Lieut. Robert Angel, also of Bolling Field. The machine carried seven soldiers and the lieutenant.

The passengers in the plane were Sergeants Mayland, Cronan, Lebuta and McCarthy, and privates Jones, Kelly and Birch. The machine was a Fokker transport of the C-24 type, and was being flown by Lieut. Henry R. Angell, who was one of the injured.

WOMAN HELD IN ASSAULT CASE TODAY

Mrs. Grace Wood Scoffs At Charge That She Hired Gunmen to Kill Husband

Detroit, Jan. 11.—(AP)—Despite a charge of assault with intent to kill, Mrs. Grace Wood today continued to scoff at allegations that she had hired four gunmen to kill her wealthy husband, Ralph A. Wood, so that she might inherit his estate.

Mrs. Wood refused to make any statement, but through her attorney, William O'Neil Kronner, it was intimated she intended today to divulge "important information" concerning her relations with her estranged husband; facts, it was contended, that would clear her of any complicity in the attempted slaying.

Kronner petitioned for a writ of habeas corpus late yesterday and a hearing on the application was to be held today. Before that time Ward Culver, assistant prosecutor, said he expected to obtain additional information which would justify her further detention.

Warrents also have been issued against William Thompson and Taylor Pierce, arrested as participants in the Wednesday night attempt to slay Wood, in which Ambrose L. Hagerly, one of the gunmen, was killed and a deputy sheriff, William Dunnigan, was wounded seriously. Both have admitted their part in the plot, police said, and have named Mrs. Wood as the one who planned the crime.

The plot to slay and abduct Wood, then murder him and stuff his pockets with narcotics so police might think him a victim of a dope feud, was frustrated when Cecil Holt, accountant, told police he was employed by Mrs. Wood to aid the plot.

Officers prepared an ambush and Hagerly was killed when he attempted to slug Wood as he left his office in suburban Wyandotte.

Gastonia Man Kills Himself

Gastonia, N. C., Jan. 11.—(AP)—F. A. Minges, part owner and manager of a local bottling works, accidentally shot and killed himself here early today.

The fatal accident occurred as Minges was leaving his rooming house to go to his place of business. It is believed he discharged a small 25 calibre pistol as he hurriedly attempted to put it in his overcoat pocket. The bullet entered the left side of the body and passed through the heart.

Minges was a native of Catawba county, having moved here two years ago, and his widow and two children live in Catawba. One daughter, Lola, is a student at Lenoir-Rhyne College at Hickory.

AWAIT REPLY OF BOOTH AT LONDON, ENG.

If Salvation Army Leader Should Refuse To Retire, Council Ready To Act.

Southwold, Eng., Jan. 11.—(AP)—An official statement issued in behalf of General Bramwell Booth late today said that after listening carefully to a deputation from the Grand Council which has urged his retirement, he announced that he would give his answer Monday.

London, Jan. 11.—(AP)—Having recommended to General Bramwell Booth that he retire as commander-in-chief of the Salvation Army, the high council today awaited his reply. Should he refuse to retire, the councilors will meet tomorrow to consider their next move.

Turbulent scenes were said by today's Daily Mail to have occurred in the high council chamber at Sunbury-on-Thames when the proposal for retiring the general was under discussion.

The commander had sent a letter to the council proposing that control of the affairs of the Army should be put into the hands of a commission which would include Evangeline Booth, leader of the reform element. They were to reform his office for him while he was ill.

When the general's letter was read someone questioned the authenticity. About that time the lights went off and a messenger arrived with a note for Commissioner Hay, president of the council. The commissioner read the note by flashlight and learned that the press had been stopped for the current edition of the War Cry, the Army's organ, in order to insert the text of the general's letter.

In the excitement cries of "Traitor!" were directed at the official responsible for the insertion of the letter. He was severely criticized and the council acted quickly. The printing offices were ordered by telephone to destroy the entire edition, which numbered about 20,000 copies.

The Daily Mail also published what was claimed to be the text of General Booth's letter to the council. This said that the fact that the council had been called left him no room to doubt that the commission were influenced by a desire to deprive him of the power "which belongs to every Salvation Army head under our foundation deed, that of appointing or naming a successor."

Say Smith Will Declare Himself Democratic Head

New York, Jan. 11.—(AP)—The New York Times today said it was hinted in Democratic circles that Alfred E. Smith would declare himself the actual as well as the titular head of the Democratic party in a nation-wide radio speech next Wednesday evening.

No intimation came from Mr. Mr. Smith or party leaders what he would discuss. It was made clear on his behalf that he would not reveal the subject of his address in advance of its delivery.

The former governor will speak over WEAF and a chain of 37 associated stations of the National Broadcasting Company. His speech will begin at 8:30 p. m. Eastern Standard time.

WAR VETERAN KILLS WIFE IN DEATH PACT

Garland Williams Tells Strange Story Agreement With Former Mate.

San Francisco, Jan. 11.—(AP)—A world war veteran, held here for the murder of his former wife, waited with apparent satisfaction today for the law to take its course, maintaining that his execution would complete a strange death pact and unite him with his erstwhile mate in the hereafter.

He is Garland Williams, 28, who saw service in Siberia, and who is accused of slaying Mrs. Lorraine Ambrose, whose body was found in a hotel room here Sunday.

When arrested in a hotel yesterday, Williams told out his wrists smilingly for the handcuffs. Police said he confessed killing the woman, assuring them that he would have given himself up as soon as he had found up his affairs.

"You fellows got me before I was quite ready," detectives quoted him as saying. "It doesn't matter, though, because I am ready to die. She's waiting for me, and there won't be anybody to come between us over there."

Police said Williams' words were the preface of an amazing confession, in which the prisoner vowed he killed Mrs. Ambrose in a death pact that was to be completed when the law claimed his life for the murder.

He said that he elected to be hanged because he objected to suicide. Outlining his domestic trouble, he told officers that his wife had separated from him because of trouble caused by a "friend" who told tales about him.

"She left me, and I did not follow her or molest her," Williams declared. "Last Thursday she came to my room and wanted to talk things over. She could not live without me, she said. She wanted me to kill her and then commit suicide, but I told her I couldn't do that. We talked all day, and finally she went away."

"Saturday she called me on the telephone and asked me to come to her. When I arrived, she had her suitcase packed. We took them and went to my room."

"She tried to coax me to turn on the gas so we could die together, but I told her I could not kill myself."

"Then I thought of letting the police take care of men. We had talked all day. She agreed to that plan."

"Be sure and do a good job, Bill," she said. "Good bye, Bill." "She just lay still while I choked her. Then I cut her wrists with a safety razor blade. I know nothing about the broken knife the police found in the room."

Police said Williams' story differed in some points from the facts as they saw them, but that his version had the ring of truth in it.

Says Vanderburg Will Be Acquitted Of Killing Family

Gastonia, Jan. 11.—(AP)—Prediction that Jacob Vanderburg, 17, sole surviving member of the family of J. W. Vanderburg, wealthy farmer, would be cleared of suspicion of having slain his father, mother, brother and two sisters, was made here today by A. E. Woltz, who has just been named attorney for the boy. Woltz was retained by Bismarck Capps of Gastonia, who has been appointed guardian for the boy.

The appointment of Woltz, with whom A. C. Jones of Gastonia, will be associated, it was said, displaces Marvin Ritch of Charlotte and J. M. Hoyle and John M. Wilson of Gastonia, as attorneys for the boy.

The inquest into the death of the five members of the Vanderburg family, postponed twice, is due to be resumed before Coroner Wallace tomorrow morning.

Mr. Woltz today asserted that there was "not one scintilla of competent evidence" against young Vanderburg and predicted that he would not be "held much longer." Marvin Ritch, who had been acting as counsel for the boy, said that he believed young Vanderburg would be freed at the inquest.

FORMER BERLIN CORRESPONDENT DEAD
Columbia, S. C., Jan. 11.—(AP)—William Counts Dreher, 72, contributing editor of the Columbia State, and former correspondent of the Associated Press and the New York Tribune, died here today. He retired in 1921 and went to Amherst, Mass., moving here two years ago.

"But we are assured that these singers will appear in several other programs during the year. This information will be received with pleasure. There is nothing that adds more to the life of a community than a well trained choral club."

"Everybody will be glad to hear these singers in an early appearance."

"The farm census is the only way the Department of Agriculture has of compiling accurate information dealing with activities of the agricultural life of a community," said a member of the Department of Agriculture today.

"The census is compiled for the purpose of ascertaining exactly how many acres of land is devoted to the principal crops of a community, and in this way the department is able to figure the approximate production of these crops."

"The farm census plan is receiving consideration in Pitt county at this time, and in the course of time one may be able to figure accurately the exact number of acres devoted to the main crops of the section."

New York, Jan. 11.—(AP)—The cotton market opened steady at a decline of 7 to 10 points with the active months selling 11 to 14 points net lower during the first few minutes, under fairly general selling inspired by late declines in Liverpool and reports that one of the trade authorities estimated domestic consumption for December at 532,000 bales compared with 611,000 in November. This consumption for December, however, was said to average about the same per working day as in November, after selling off to 19.89 for March, the market rallied to 20.06 for that position by the end of the first hour, when the market was about net up changed to 4 points higher. Private cables said that trade calling and continental buying had absorbed offerings in Liverpool market and that reports reaching Manchester from China were more encouraging as to pending business in cotton cloths.
