MARSHAL FOCH REPORTED AS SOME BETTER

Georges Clemenceau, Former French Premier, Recovering From Grippe.

Paris, Jan. 16.—(AP)—Two Frenchmen who played principal roles in the world war today were apparently making gains against illness.

Marshal Ferdinand Foch seemed to be slightly better. The crisis which some had feared did not occur and he had some sleep during the earlier part of the night.

Georges Clemenceau, former premier, suffering from a bad attack of grippe, is expected to resume his work before the end of the week unless his 87 years tell to heavily on him.

By orders of his doctors, Marshal Foch's house was closed to all callers during the night and plunged in quiet darkness so that the 77-year-old soldier could get as much sleep as possible. His condition this morning was still extremely grave, although, as Dr. Daveniers put it, the prognosis was as favorable as the age of the patient permitted.

Professor Andre, a specialist in kidney diseases who attended Foch throughout the war, was summoned yesterday when uremia developed from a kidney infected after the marshal's heart attack. His view that there was no immediate danger from the kidney infection and he returned to the university at Nancy today.

The marshal has suffered from functional kidney trouble for years and required constant care. For this reason Professor Andre was attached to his staff during the war. So far as can be learned the present symptoms are an aggravation of his old troubles due to illness.

While other physicians attending the marshal were extremely reserved in their judgment, Professor Andre was more optimistic. He said he gathered the impression from a long talk he had with Dr. Heitz-Boyer that the marshal, despite his 77 years, would make a slow recovery in view of his robust constitution. The marshal's two daughters were admitted to the sick room late last night to make a little visit to their father before he fell asleep. They found him cheerful, full of confidence and more hopeful than his doctors.

Senate Ratifies Treaty By Overwhelming Vote

Raleigh, Jan. 16.—(AP)—Work for the legislature piled up today as a flood of bills, many of state-wide application, were tossed into the hoppers of both houses. Additional committee appointments were announced in both houses, completing the regular machinery of the session.

House committees on finance and appropriations, which have charge of financial legislation, were called to meet this afternoon. The budget appropriation bills and revenue bill were formally introduced in the Senate.

The Senate will meet again at noon tomorrow, the House at 11 o'clock.

Raleigh, Jan. 16.—(AP)—Bills pouring into the hopper of the House today, included in the number were measures for taxing Electric power, raising the school equalizing fund to \$7,000,000 a year, and increasing gasoline and automobile license taxes.

Representative Halstead, Democrat, of Camden, sponsored the bill to make the equalization fund \$7,000,000 a year, or \$14,000,000 for the biennium, and the proposal to increase the gasoline tax to five cents a gallon, with a twenty-five percent addition to the motor license scale.

Both bills were introduced, the author said, with a view to reduction of property taxes in the counties. The road bill would have the state take over principal county highways, while the school bill would relieve the counties of a part of their present burden.

PRICES STILL GO UPWARD ON LEAF MARKET

Season Sales Today Stood Slightly Over 300,000 Pounds from Goal Line.

The Greenville tobacco market today was slightly over three hundred thousand pounds away from the goal of 70 million pounds of tobacco set for this season. It was stated in the official daily report of K. W. Cobb, supervisor of sales, issued this afternoon. The report included today's sales.

The market yesterday sold 157,992 pounds of bright leaf for \$24,667.00, at a general price average of \$15.61 per hundred pounds. Complete figures of today's sales had not been compiled. Season's sales were given at 69,665,719 pounds.

It was stated that there was approximately two hundred thousand pounds of leaf on the floors of the nine warehouses today. Sales were completed by the noon hour.

Yesterday's offerings consisted mainly of scrap tobacco and prices were declared to be as high as any other time of the season, although the general price average for the entire market was greatly reduced by the inferior offerings.

Tobaccoists continued to urge growers to market the rest of their crop as fast as possible in order that all offerings might be disposed of when the market closes the latter part of the month.

With season's sales standing slightly over three hundred thousand pounds from the 70-million-pound goal, tobaccoists declared they were confident of passing safely over the goal line before the market closes. The goal for last season was sixty pounds, but the market exceeded it by over a million pounds. While no one expects this season's sales to exceed the goal to any great extent, everybody is confident of realizing the 70-million ambition—the greatest in history of the market.

Serious Fighting Reported At Kabul

London, Jan. 16.—(AP)—London newspapers said today that they had learned in authoritative circles here that serious fighting was continuing in and around Kabul, Afghanistan, despite the abdication of Amanullah as king.

The Daily Mail said that rebels did not approve of King Inayatullah, Amanullah's successor, any more than they did of his younger brother.

The Daily Express said that a grim and ferocious battle was turning Kabul into a shambles. Bacha Saka, the rebel commander, refused to regard the abdication as a reason for laying down his arms.

Raleigh, Jan. 16.—(AP)—The budget appropriation bills and revenue bills were formally introduced in the Senate today by Senator Tapp and Womble, chairman of the appropriations and finance committees, respectively.

The Senate went into an executive session today for the first time in order to confirm appointments of boards and trustees of various state institutions made by former Governor McLean. It then adjourned until 12 o'clock tomorrow.

Declaring that he was giving the people of North Carolina a "birth day present" on the 9th anniversary of the 18th amendment Senator W. M. Person, of Franklin, introduced a bill to allow druggists to fill prescriptions for whiskey used for medical purposes under the provisions of the Volstead act.

Booth Declines To Retire Today

London, Jan. 16.—(AP)—General Bramwell Booth, in a statement given to newspapers for publication today, announced that he would not resign as commander-in-chief of the Salvation Army.

This statement was understood to be the first of his early reply to the high council of the Army, and the Daily Herald said it had been rejected by a show of hands. The council then proceeded immediately to a discussion of his fitness to govern the Army.

It was not certain that the council would immediately appoint a successor after the vote of removal as it was supposed a majority might desire a respite of 24 hours before making a decision so momentous.

The general's statement to the press said that the high council had been called to consider the position of the future after some bulletins on his condition had indicated that his recovery was doubtful.

"I should be clearly understood," the statement continued, "that the founder of the Salvation Army instituted powers under which the high council could be called for the sole purpose of turning out of office a general who was spiritually unfit and of electing a successor if that were done, or if for any other reason there should in fact be no general of the Salvation Army. An important point indeed is that in declaring the general unfit the high council has the power to set aside his nomination of a successor."

The general contended that legalizing the council had no power to propose or make changes in the constitution but that he wrote the councilors stating he was prepared to consider any feasible scheme for broadening the constitution. He also asked for a little time in order to regain his health. This was scarcely considered and he was asked to retire from office "under what amounts to nothing less than a threat of expulsion." As far as he could ascertain the only ground for the request was that he was ill.

"I have carefully and prayerfully considered the entire question in all its bearings," the statement concluded, "and, much as in some respects I should welcome complete rest and relief from responsibility, I feel I should be less than a man, let alone the leader of a great religious organization, if I agreed to a request to retire at a time when, as I understand it, there is agitation to change the foundation on which I rest."

"There I am compelled to refuse to do so."

Seven members of the high council who presented to him the proposal that he retire reported that they were convinced that he was too feeble to continue effective performance of his duties. The report said that a study of the communication which the committee brought to him was beyond his powers. It said that he was not quite able to follow the statement that was made to him and added that in his words to the committee he appeared to be following a course that had been prepared for his mind.

Sondino Ready To Lay Down Arms If America Will Withdraw Marines

Tegucigalpa, Honduras, Jan. 16.—(AP)—Withdrawal of American marines from Nicaragua is the condition upon which General Augustino Sandino, Nicaraguan rebel leader, is willing to lay down his arms. Letters written by General Sandino stating this and that he will not deal with the United States were made public by the newspaper El Sol, whose editors announced that the authenticity of the documents was beyond question.

One letter is an answer to Rear Admiral David Sellers, U. S. N., commanding the special service squadron in Central American waters, and to Brigadier General Logan Eiland, U. S. M. C., commanding the marines in Nicaragua. It reads: "Patriotism compelled me to rebel force by force and I must absolutely reject any interference by your government in the internal affairs of our country and demonstrate that the sovereignty of a people cannot be discussed but only defended by arms in my hand."

"It is in this sense that I say that I could enter into a settlement for peace only with Moncada in spite of the fact that he became a traitor to the Liberal party, which error he can correct by means of a compromise to be concluded with the Nicaraguan people and the Liberal party by respecting the terms which we shall propose at the proper opportunity."

"To arrive at an effective peace settlement, we propose as the first condition that it is indispensable that the American forces withdraw from our country. This accomplished, your forces should vacate the four northern departments of Segovia, Jinotega, Esteli and Matagalpa. The Nicaraguan civil and army authorities may remain but without any American officers or soldiers."

"In your reply please tell us the date when these departments will be evacuated and designate the day for the opening of the conferences. Without these conditions there cannot be peace and although you say that a continuation of my armed resistance serves no purpose, my resistance alone will bring the benefits to which you allude."

"I must also say that foreign lives and property would be better protected by us Nicaraguans than by the force of a foreign government, because any foreign interference in our affairs can only bring about the loss of peace and the ire of your people."

VANDERBURG IS INDICTED FOR MURDER

Grand Jury Returns Five Counts Against Gastonia Youth For Killing Family.

Gastonia, Jan. 16.—(AP)—An indictment in five counts charging Jacob Vanderburg, 17, with murder in connection with the death of five members of his family was returned by a Gaston county grand jury today.

Immediately after the formal announcement was made, John G. Carpenter, solicitor, announced that a presentment charging arson will be considered against the boy this afternoon.

Young Vanderburg has been held without bail since December 28 when the charred bodies of his mother and father, two sisters and a brother were found in the smoking ruins of their home near here. The state contended that the Vanderburgs had been killed and the house fired to hide the crime.

A special term of court probably will be asked to try the youth, the solicitor said. Unless such a term is called the solicitor said, the case could not be brought to trial before April.

The five counts of murder named J. W. Vanderburg, the father, Mrs. Vanderburg, Pauline and Louise Vanderburg, sisters, and Robert Vanderburg, 12 year old brother, as victims.

The action of the grand jury was the result of an independent inquiry started yesterday by Solicitor Carpenter. W. F. Wallace, coroner, said the fourth session of the inquest, scheduled for Saturday, probably would be deferred.

Says Signatories Will Soon Ratify The Kellogg Pact

Paris, Jan. 16.—(AP)—Speedy ratification of the Kellogg pact by all the signatories, following the lead of the United States is now expected in French official circles.

A bill to that effect will be introduced in the French Parliament at once and is expected to be quickly enacted. The almost unanimous vote of the Senate came as an unexpected surprise in French officialdom which had looked for ratification but expected greater opposition. The action of the Senate is regarded here as putting an end to Soviet negotiations with Poland for immediate application of the pact without waiting for ratification by the fourteen original signers.

The entrance of the Kellogg pact into a stronger position through its ratification in the United States is looked upon as greatly strengthening the Locarno policy and tending to facilitate the work of the reparations experts as well as negotiations for evacuation of the Rhineland.

Managua, Nicaragua, Jan. 16.—(AP)—General Augustino Sandino, rebel leader, has proposed that the province of Neuva Segovia be separated from Nicaragua and placed under his control.

President Jose Maria Moncada's reply to the proposal was to call it treason and to order the enlistment of volunteers to combat Sandino and his followers, whom he termed outlaws. He added that the proposal was "lunacy."

President Moncada and General Sandino were followers of Dr. Juan B. Sacasa, recently appointed Nicaraguan minister to Washington, when he headed a liberal government at Puerto Cabezas. Moncada was commander of the liberal armies and agreed to make peace with the conservative Diaz government, one of the terms being American supervision of a presidential election, which Moncada won. General Sandino was the only liberal army leader who refused to lay down his arms and his revolutionary activities in northern Nicaragua resulted in many engagements with American marines during the fall and winter of 1927 and during 1928 in which marines were killed.

After accepting Mr. Page's resignation yesterday afternoon, the governor let it be known that he would be in no hurry to name a successor, because he wanted, if possible, to get the "best man in the country" for the post. At the same time, he stated that he did not care to receive any applications for the commissionership because he intended to use his own judgment in making the selection.

PACTOLUS MAN FIRES BULLET INTO BRAIN

Louis Cannon Commits Suicide Yesterday Afternoon While Drinking Heavily.

Louis F. Cannon, 52, well known farmer of Pactolus township, committed suicide yesterday afternoon about 4:30 by firing a bullet from a .25 calibre pistol into his brain. Death was instantaneous.

The cause of the suicide was attributed to heavy drinking which took place over a period of several days.

Funeral services were conducted at 2 o'clock this afternoon from the late home of the deceased by Rev. J. H. Little, of Winterville. Burial followed in the Parker Chapel cemetery.

Besides his wife he is survived by six sons and three daughters, Johnnie, Jesse, Herman, Raymond, Eddie, Frank and Mrs. Sam Fleming and Misses Vela and Lillian Cannon two brothers, C. B. and W. J. Cannon, of Grimesland; two sisters, Mrs. Ida Hardee, of Ayden, Mrs. C. A. Mayor of Grimesland.

The tragedy was investigated by Coroner E. S. Williams, but an inquest was unnecessary due to the fact that Cannon made a statement previous to the shooting that "He would end it all."

The body was found in the yard in the rear of the home with the automatic pistol lying by the side of the dead man. Investigation of the pistol showed that only one bullet had been fired, it having entered the brain through the temple, producing instant death.

Proponents in the treaty contest, in many instances, were opponents in the naval fight. Opponents of the treaty for the most part, were on the other side today maneuvering for the naval bill.

As a result of the understanding whereby the treaty was placed ahead of the naval bill in the Senate's calendar, leaders believed a final vote would be permitted upon the latter. There had been threats of a filibuster against the treaty bill and peace organizations of the nations have been urging such a course. However, the outstanding opponents of the proposed measure have passed the word that they will not resort to filibuster tactics to block the naval bill vote.

Senators Norris, Republican, Nebraska, and King, Democrat, Utah, supported by the Republican independent bloc are prepared to wage a desperate fight against the naval bill. But unless they rely on a filibuster it is believed the measure will be brought to a vote within a week or ten days and passed.

A two-sided fight faces the measure. President Coolidge wants the time clause requiring construction of the 15 cruisers and an airplane carrier within three years to be eliminated. Opponents of the bill are going to ask that the authorization for cruisers be paired down to five or ten.

Chairman Hale of the Naval Committee is going to fight any change in the bill and Senator Swanson of Virginia, the ranking Democrat on the naval committee, is taking a similar position.

CRUISER BILL HOLDS SWAY IN SENATE TODAY

Committee Hearings On Radio Commission Proving Unusually Long Drawn Out

Washington, Jan. 16.—(AP)—With the Kellogg peace treaty ratified, the Senate today had the cruiser bill on the floor. It was calendar day in the House with a routine session in prospect. The \$448,000,000 War Department appropriation bill having been passed yesterday.

Quite a few of the group who were opponents of the Kellogg pact are in the role of proponents of the cruiser bill, among them being Reed of Missouri, and Moses of New Hampshire, leaders of the fight to have the Senate Foreign Relations Committee report its interpretation of the pact. Supporters of the measure providing for 15 cruisers and one aircraft carrier say it will pass but a fight is imminent over President Coolidge's recommendation that the time limit of three years for construction be lifted.

Committee hearings on the House side on the bill to prolong the life of the Radio Commission for a year are proving long drawn out and it was understood when the Ways and Means Committee took up tariff revision that it would extend over a period of weeks. Changes in selections Committee embodying its construction today.

The Senate Indian Affairs Committee had not finished with its inquiry into Indian affairs, though it had ended testimony on charges by Indian Commissioner Burke that Senator Pine of Oklahoma and others sought to "destroy him" and the Indian service.

This hearing began as an investigation into the affairs of Jackson Barnett, wealthy Indian, and its ramifications promise to lead into various phases of the administration of Indian affairs.

ROCKY MOUNT MEN TO BUILD LOCAL STORE

Tolar & Co. Awarded Contract For Erection of Montgomery-Ward Building.

The contracting firm of Tolar & Co., Rocky Mount, were awarded contract for the erection of the Montgomery-Ward building on Fifth street, yesterday afternoon. The firm's bid was \$47,500. This did not include contract for lights and heating.

It was understood that construction work would begin as soon as the successful bidders could get materials and equipment to the city. The building, a three-story brick structure, is to be built by W. E. Hooker, well known business man of this city, and will be occupied by a branch store of the Montgomery-Ward Co., as soon as completed. The building will be on the site of the old Greenville Wholesale Company, at the lower end of the Fifth street business district.

It was announced sometime ago that the great chain store organization was contemplating a branch store in this city, but nothing of any definite nature was made public until the building contract was awarded yesterday. It was understood that the firm had leased the new structure over a period of several years, although the length of the contract was not divulged.

The Montgomery-Ward Co. is one of the greatest chain store organizations in America. While the concern has a number of stores in the larger cities of North Carolina this is their first entrance into this immediate part of the state.

Marvin Blount Heads Judiciary Committee Of The State Senate

Senator M. K. Blount of Greenville, representing Pitt county in the North Carolina Legislature, has been appointed chairman of Judiciary Committee No. 2 of the Senate.

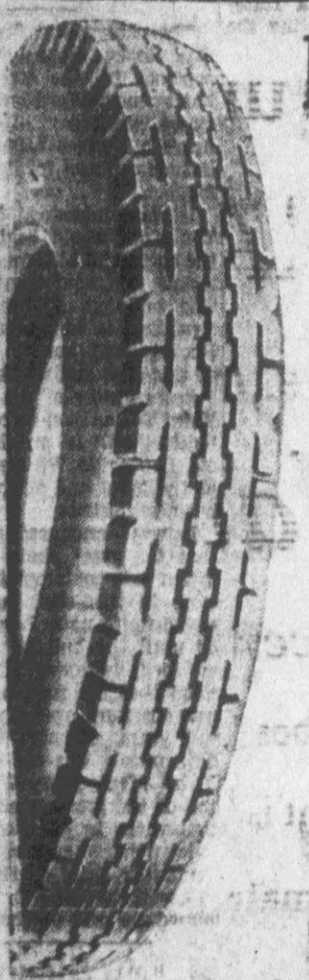

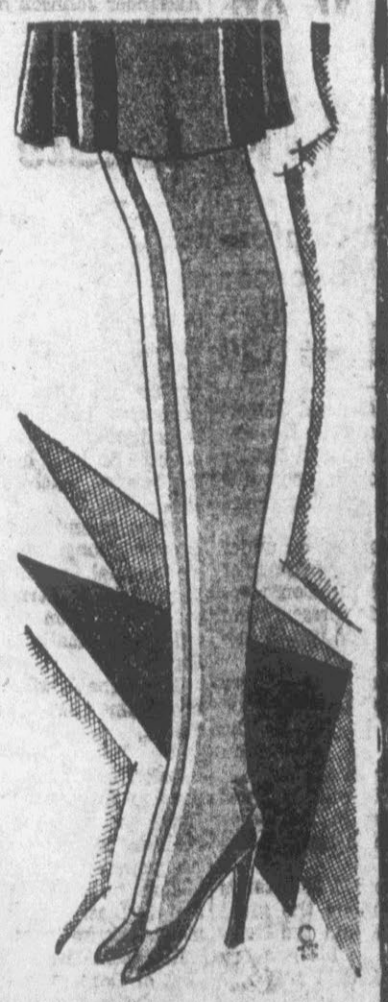

Naturally, there are some who will declare that such a change is too drastic, but behind prison walls is the proper place for drunken drivers if our highways are to be made safe for travel.

BREAKING UP THE LIQUOR TRAFFIC

Capture and destruction of twelve illicit stills in the first twelve working days this year is the record of the forces of the sheriff's office here, and is one that officers in other sections would do well to follow. At this rate of activity on the part of the officers the moonshiners surely cannot stay in business and such a campaign throughout all the counties of the state would no doubt have the desired effect of stopping the flow of so much bootleg liquor.

LESTER BANGS NEW PILOT OF LOCAL TEAM

The contract of the former Virginia leaguer has just been received by President Smith and the announcement was the first made in connection with activities of the Tobacconist organization for the approaching season.

Bangs succeeds Tommy Abbott, former member of the Virginia League, who took the place of Deacon Joliff about the middle of last season. It is the third change of pilots since the club was organized last year.

The new Greenville pilot is a power with the stick. It was this ability which earned for him the cognomen "Shipwreck," while he was playing with the Portsmouth club of the disbanded Virginia League.

Bangs started as a pilot in the Eastern Shore circuit last season, but after that circuit broke up and went out of business he took over the Somerville club in the Blue Ridge circuit.

The reserve list of tobacconists contains a number of men who are expected to show up with exceptional brilliance during the training season which opens sometime in March. Bangs is said to have signed some good material.

Things will begin to liven up in the local camp when the manager reports for action March 1st. Arrival of players will take place sometime later and from then on the fair grounds will be the scene of strenuous daily workouts.

President Smith feels confident he will be able to place a winning club on the field this season. No little attention is being given to the records of men who have received contracts, and this will continue, until the organization has been completed.

Other clubs of the circuit were reported to be making splendid progress with preliminary plans for opening of the season and when the umpire calls "Play ball," every club will be in prime condition for the strenuous season ahead.

Arrange Plans For Big Fight

Miami Beach, Fla., Jan. 16.—(AP) With final details assuring the heavyweight boxing between Jack Sharkey and Young Stribling is already settled, plans went forward here today for the hundreds of pre-fight arrangements with Jack Dempsey in charge of operations for the Madison Square Garden Corporation.

W. L. Stribling, Sr., father-manager of the young Georgia battler, signed articles yesterday for his son's participation in the fracas, which will lead to a heavyweight championship.

Sharkey, the Boston gob, already has signed for his part, which will bring him a \$100,000 purse, and nothing remains now except what the promoters say is the real work—the perfecting of those hundreds of little odds and ends plans and arrangements.

The fight will be a posthumous child of the brain of Tex Rickard, who died here recently, and who had planned the fight for his Miami Beach Kennel Club. Dempsey is acting in the role of his late pal, Tex, who guided him to a great fortune in the ring.

The Kennel Club will be arranged to seat a capacity crowd of 30,000 fight fans, and the tentative scale of prices will range from \$5 to \$25 each.

William F. Carey, vice-president and treasurer of Madison Square Garden, is to arrive here tomorrow, to supervise plans for the affair, he having succeeded Rickard as manager of the Garden.

JACK DEMPSEY MAY RETURN TO THE FIGHT RING

Miami Beach, Fla., Jan. 16.—(AP) Jack Dempsey may return to the ring, but he will not decide about it until he has had some workouts here.

The mansa mauler is beginning to "feel pretty good down here," he says he is "the only person who can tell whether or not my body is in trim for a fight, and until I have opportunity to test it, it is impossible to tell what I can do."

Dempsey is here directing plans for the Sharkey-Stribling elimination set for Madison Square Garden Corporation.

It is confidently expected in some quarters that the former heavyweight champion will essay a comeback. Not the least enthusiastic one in his beliefs along this line is William F.
