ORDER ARREST OF SEVENTEEN GANG MEMBERS

Chicago Police Commissioner Believes Actual Killers May Be Among Number.

Chicago, Feb. 26.—(AP)—An order for the arrest of 17 men was issued by Deputy Police Commissioner John Stege today in the gang massacre investigation.

Several of the men in this list, he said, may have been the actual killers. Others are believed to have definite and important knowledge concerning the seven fold murder.

Photographs of some of the 17 have been identified, he said, by witnesses whose identities have been kept secret for their own protection.

The arrests were ordered after Stege had spent several hours of study over the police "Blue Book" of criminals, and had re-questioned witnesses.

The 17 who are sought are: Claude Maddox, arrested a short time ago when a machine gun was found at "the Circus" cafe of which he is part owner.

Tony Capedia (Tony Tony) who is known as a sluffer, implicated in a murder two years ago, and partner of Maddox.

Jack McGurn, a machine gun expert and a lieutenant of Al Capone.

Joseph Lohrd, John Schulte, Danny Vallo, gang leader; Rocco Farnell, under indictment in connection with vote frauds in the "Woody Twentieth" ward; Tony Barone; Rocco Belcastro, whose description corresponds with that of witnesses have given of the man who drove the death car for the Valentine's day killers.

Frank Diamond, known as a maker of stills; Rocco Griffo; Samuel and Joseph Aello, brothers and friends of Rocco (Bugs) Moran; William (Doc) Reed; Charles (Slim) Finn; Mitchell and George (Big) Moran.

Some of these men are known to have been close to George Moran, and Stege hopes from them to learn who Moran's enemies are and who would have a motive to massacre seven of Moran's men.

Maddox is a major hope of the investigators. He lives near the private garage in which the slayers' car was found last week. His previous possession of a machine gun was another factor influencing police in their suspicion that he may be able to give valuable information.

Schulte is known as one who is deadly with small firearms. He is reputed to be a master of the use of springs concealed in his sleeves, by which he is able to drop an automatic pistol into each hand much faster than those who draw gun from pocket or holster.

Belcastro has one finger missing. A man similarly marked was at the wheel of the killers' car.

Negro Attempts To Burn White Woman At Atchison, Kansas

Atchison, Kans., Feb. 26.—(AP)—Mrs. C. V. Jacobs, 53, wife of a retired baker, was at the point of death today following an attempt of a negro assailant to burn her alive in the furnace of her home.

Louis Glover, 35, the alleged attacker, arrested shortly after he left the Jacobs home yesterday, was spirited out of town by officers who feared mob violence. There was some scattered talk of violence, but no demonstration.

Mrs. Jacobs was severely burned about the head and shoulders and nearly suffocated, but named Glover as her assailant before she collapsed. Physicians said there was little hope for her recovery.

The negro, who had been employed as a handy man about the house, attacked Mrs. Jacobs and then dragged her down the basement steps, she said. Matches falling to ignite her clothing, she said he thrust her head into the furnace and attempted to show the rest of her body through the door. He was frightened by the ringing of the doorbell when the woman's husband returned home, and fled. Jacobs found his wife's clothing ablaze.

Glover denied the attack. Officers said at one time he was an inmate of an insane asylum.

FAVOR RETURN OF AMANULLAH

POLICE PATROL CHICAGO POLLS

Aldermanic Candidates Under Guard As Election Gets Underway.

Chicago, Feb. 26.—(AP)—An Aldermanic election was being held today under unusually elaborate police protection.

Every available officer was called to duty. His orders were to "smash the butt of your gun over the heads of the hoodlums as soon as you see them."

Arrests were made even before the voting started. Deputy Commissioner John Stege sent special details sweeping through the "bloody twentieth" ward, and they picked up half a dozen men, among them Quinn, Barker and Michel Bellis, acquitted last week of murder; Sam Kaplan, Isadore Fox and Abe Klass, the latter a brother of Martin Klass, one of the Aldermanic candidates in the ward.

The deputy commissioner gave his squadmen the names of well known racketeers and ordered that they be picked up on sight. The names of George (Bugs) Moran, Willie Marks and Frank Foster—virtually the last of the Moran gang which lost seven members in the massacre of February 14—headed the list.

County Judge Jarecki convened court at 5:30 a. m., half an hour before the polls opened, to be ready for any election day violence, trickery or fraud causes that might arise. The court was to remain open until the results of the election had been determined tonight. The polls close at 4 p. m.

Two candidates in the "bloody twentieth" spent the day under police protection following threats of violence, seeking re-election, moved against their lives. Alderman A. J. his family yesterday from the ward in which he was born and in which he was always lived. A police guard was stationed at his home and another was assigned for his own and his family's protection.

State representative William V. Pacelli, another candidate for Alderman in the 20th ward, was given protection after receiving a threatening letter. It said that if Pacelli did not retire from the race he would be treated like Octavius Granady, negro lawyer, whose assassination marked the voting in the ward last April.

EXPERTS TO TACKLE NEW ANGLES NOW

Reparations Question To Be Considered in Different Way At Paris.

Paris, Feb. 26.—(AP)—Three sub-committees of the experts gathered here to solve the German reparations problem will attack different aspects of the question during the rest of the week.

Probably next Monday—or at the call of chairman Owen D. Young—they will meet in plenary session again and report what they have found.

One of these sub-committees will consider commercialization of the German reparations debt, a feature in the settlement which is bound closely to possible elimination of the transfer protection clause. This committee is headed by Lord Revistock, British banker.

The second of the sub-committees is investigating that proposed lesser part of the German annuities which will be subjected to the transfer protection clause and hence not available in the commercialization clause project. Sir Josiah Stamp, also of Great Britain, is chairman of this sub-committee. It probably will report on the formation of a committee of foreign membership which the Germans could consult if they found it necessary to invoke the protection clause.

The third sub-committee is headed by an American, Thomas N. Perkins, alternate for Mr. Young, and will deal with deliveries in kind. Some regard this as one of the most important aspects of the reparations problem.

The task of another committee was the determination of how much cash can be transferred each year from Germany without any sort of protective transfer measure such as now exists under the Dawes plan. Directly dependent upon this first, on all the German resources is the question of transforming future payments, when their amount is determined, into negotiable bonds.

Although this commercialization of the reparations is possible of great importance to America, Europe considers it secondary to other problems involved.

Charlie Chaplin Faints at Studio

Beverly Hills, Calif., Feb. 26.—(AP)—Charles Chaplin, motion picture star, has been confined to his bed today recovering from an illness which caused him to faint at his studio.

Shortly after beginning work at the studio yesterday Chaplin complained that he was ill and asked for a glass of water. As it was handed to him he swayed and fell to the floor.

Dr. Cecil Reynolds, Chaplin's physician, revived the comedian and ordered him to go home and remain in bed at least four days. The illness was diagnosed as ptomaine poisoning.

The physician reported that Chaplin had a high temperature but his condition was "not alarming." This morning Dr. Reynolds said there had been a "slight" improvement.

Senate Wages Big Fight Over Compensation Bill; New School Bill Is Born

Raleigh, Feb. 26.—(AP)—With various amendments, the workmen's compensation bill was passed by the Senate today and sent to the House.

Raleigh, Feb. 26.—(AP)—The Senate waged a battle royal over the workmen's compensation bill today while the House was largely occupied with routine, having for the time being delayed further action on the school bill.

Arguments for and against the compensation measure were made again today by several members who spoke at the three hour session last night. Galloway of Transylvania, and Clark of Mecklenburg, made their second speeches in opposition, and they were joined by Peel of Martin, who declared labor had been "betrayed" in the insurance committee's compromise measure under consideration.

Senator Broughton of Wake, once more took up the oratorical cudgels in favor of the bill.

Having substituted a six months term proposal, with an equalizing fund of \$6,500,000 for the MacLean eight months term bill, the House today awaited printing of the substitute before taking any further action. Meantime, another school bill was born. It was drafted and reported out by the Senate education committee, carrying provisions for a six months term, an equalizing fund of \$6,000,000, and regulatory authority expected to result in more economical operation of the schools.

A bill was introduced in the House to appropriate \$30,000 for equipping the state prison to manufacture automobile license tags.

Raleigh, Feb. 26.—(AP)—The opening speech on the workmen's compensation bill today was made by Senator J. M. Broughton of Wake.

Taking up every argument made against the bill last night in succession, Broughton declared that the bill was founded on the theory that "industry must bear the cost of industry."

Tornadoes Claim Number Of Lives

Memphis, Tenn., Feb. 26.—(AP)—Search of the ruins of Duncan, Miss., today revealed the bodies of seven additional victims of yesterday's tornado and increased the storm toll in the state of Mississippi, Arkansas and Texas to 29.

Most of the dead in Mississippi were negroes and Chinese while two white persons were killed in the collapse of a home near Dewitt, Ark., and two white persons and 2 negroes lost their lives in a matter of minutes.

"Among the several scores of injured in three states several were in a serious condition today and it was feared the death list might mount.

Memphis, Tenn., Feb. 26.—(AP)—Tornadoes making an early spring visit to three states left a trail today of 22 dead, scores injured, a wrecked village and property damage exceeding \$500,000.

At intervals of a few hours the wind storms dipped down into Northeast Texas, Northwest Mississippi and Southeast Arkansas yesterday, striking with greatest fury at Duncan, Miss., where 14 of the 450 population were killed and the village left in wreckage.

The dead were:

Texas: Mr. and Mrs. W. N. Jones, who lost their lives in the collapse of their home at Cooper, and two negroes killed at Grand Prairie.

Mississippi: J. T. Johnson, tenant farmer; Kate Mack, two, and Eddie Mack, six, her brother; a Chinese family of five, and six negroes crushed to death in the collapse of buildings at Duncan and two negroes killed on a plantation 11 miles northwest of Murks.

Arkansas: Mrs. C. I. Nicholson and her 15 year old daughter met death in the destruction of their farm home near Dewitt.

Almost without warning the hamlet of Duncan was demolished about 2:30 in the afternoon when a twister swept diagonally across the business section. Fourteen stores, a two story brick hotel, eight residences, and a number of negro cabins were leveled and almost every building in the town felt the effects of the terrific wind.

All power in Duncan was cut off and while rescue workers searched the wreckage in darkness, national guardsmen patrolled the vicinity to prevent looting and vandalism. The troops were ordered out early in the evening by Governor Theo. S. Bilbo.

LINDY STILL RETICENT AT MORROW HOME

Refuses to Talk About Date of Wedding To Daughter of Mexican Ambassador.

Cuernavaca, Mexico, Feb. 26.—(AP)—"Manana" is the best information obtainable about the plans of Colonel Charles A. Lindbergh and his fiancée, Miss Ann Morrow.

"Manana," says the Mexican, frequently. The word means "tomorrow," but it is the Mexican's method of indicating an indefinite time in the future.

"Some time later," Colonel Lindbergh has said, he will reveal when he is to be married, how long he is to remain in Mexico, what his plans for the future are.

Today he and his fiancée were free for walking, talking, riding—just being together, in a land almost dream-like in flowering verdant beauty.

Residents of the town itself—4 has a population of 7,000—hardly were aware a visitor of note was in their midst. There was far more interest in the prospect of next Sunday's band concert in the plaza and the bi-weekly motion picture shows which do not take place when the roads are bad.

The Indian population, with their cotton pajama like trousers and soft Spanish speech, have had visitor of note among them since the conquest, after which Cortez made Cuernavaca his home. The ill-starred Carlotta and Maximilian came there to bask in its sunlight.

Now as then they have shrugged their shoulders and let be what will be, replying "Manana" to all but the simplest demands of life upon them.

With the aviator and his fiancée at Cuernavaca are her mother, Mrs. Dwight Morrow, and her sister Elizabeth. A lone correspondent remained this morning of the eight who came here yesterday in anticipation of a surprise wedding, after the colonel's flight from Texas. The others returned late yesterday to Mexico City.

There will be no surprise wedding, some close to the Morrow family vouchsafed, avowing that an announcement of the date and place would be made in due course just as the engagement announcement was made.

Opinion was that Col. Lindbergh and the Morrrows would remain here for two or three days, returning to Mexico City for the conclusion of his visit.

Mexico City, Feb. 26.—(AP)—While assurance was given from authoritative sources today that Colonel Lindbergh and Miss Morrow would not attempt to wed secretly no indication was given as to whether the marriage would be soon.

Nor did the information indicate whether the wedding would occur in Mexico or in the United States.

The four passengers mentioned in which the aviator flew here were housed this morning in the hangar at Valbuena Field ready to take him back to the United States when he chooses to go—with sufficient man aboard it for a passenger if circumstances warrant.

ORAL HYGIENE LECTURES FOR PITT SCHOOLS

Series of Talks to Begin March 4th Will Be Followed by Dental Clinic.

Dr. Earnest Branch, director of oral hygiene of the State Board of Health, will be in Pitt county one week, beginning March 4th, for the purpose of giving a series of lectures in oral hygiene in the various schools of the county, according to announcement made today from the Pitt County Department of Health.

Dr. Branch was in Greenville last week conferring with local health authorities concerning his visit. He appeared at one or two club meetings and explained the movement now on foot to better health conditions among children throughout the State.

The lectures will be illustrated with moving pictures. They will show how the health of the child may be preserved through simple methods adopted both in the home and school. Dr. Branch will appear before parent teacher organizations, banquet and civic clubs with an idea of getting the mothers and teachers interested in the plan.

The lectures will pave the way for dental clinic work to be conducted in the county schools three months this term. The clinic will be in charge of Dr. Guy Pigford, who was also in the county the latter part of last week looking over the situation here.

The County Board of Health urged the co-operation of mothers and teachers in making the lectures and clinic a success. The health of the school child is of vital consideration, it was stated, and it is necessary that mothers and teachers both lend their support to the movement if it becomes the success due it.

CHICAGO GIRL ELOPES WITH REAL COWBOY

Daughter of Gordon Thorne Weds Geo. Gillespie After Thrilling Chase.

Phoenix, Ariz., Feb. 26.—(AP)—The much used plot of fiction writers in which the pretty heiress from the effete East finally elopes with a dashing cowboy, defying conventions and parental wrath, developed into a reality here today with Miss Katherine Thorne of Chicago and George Gillespie of Castle Hot Springs, Ariz., in the lead.

Miss Thorne, daughter of Gordon Thorne, former president of Montgomery-Ward & Company, and Gillespie, who went in for cowboy life in Arizona two years after graduating from the University of Tennessee, were married here Sunday night after a breath-taking ride from Castle Hot Springs, where the Thornes are wintering.

Officers had been put on the trail of the two, who had known each other only three weeks. The attempt to stop the elopement had been made by Mr. and Mrs. Thorne, who said Katherine was only 17 years old. They requested that Gillespie be arrested on a charge of kidnaping.

The elopers dodged the officers successfully. Yesterday they interrupted their honeymoon here enough for the bride to inform newspapermen that she was of age. Her age was given as 21 on the license. No warrant for Gillespie was issued.

"We loved each other so we got married," Mrs. Gillespie told reporters. "Father and mother do not understand yet. When they do I am sure everything will be all right."

Gillespie telegraphed his mother, Mrs. George E. Gillespie, in Nashville, Tenn., that he had found "the one girl" and had married her.

Mr. and Mrs. Gillespie wanted their honeymooning today but their whereabouts could not be determined.

The cause of parental wrath was said to have been that Miss Thorne was engaged to marry Clymer S. Bower of Chicago. The engagement was announced in Chicago last summer, shortly before the family left for Arizona.

Fear Nationalists Plan More Force To Compel Allegiance

Shanghai, China, Feb. 26.—(AP)—Fear in Canton that the Nationalist government might soon attempt to compel its allegiance by force of arms is believed to be responsible for the recent disorders in Hunan.

Both in Canton and in the cities of Hankow, Wuchang and HanYang have appeared two young and ambitious military commanders who are expected to control four Southern Provinces and to put up a stiff opposition to any effort by Nanking at consolidation.

Along with the outbreak of the Shantung Revolt and scores of rumors of uprising in various localities, as well as of splits within the nationalist government itself, there is a general feeling of uneasiness in nationalist circles. Various factions in many localities are even reported to be strengthening their alignments in the event of untoward developments.

Although the nationalist government outwardly is supported by the leading military commanders, underneath exists currents of factionalism. Radical elements which have been strong opposing the government also are taking the lead in attempts at consolidation hoping to wield a strong influence at the coming Kuomintang National Congress which opens on March 15. These groups seek to control the government. If this should happen, the conservatives express belief that China is destined to renewed disorders.

Alma Rubens Has Even Chance For Recovery Today

Beverly Hills, Calif., Feb. 26.—(AP)—Physicians today gave Alma Rubens, screen star, who for several months has been striving to cure herself of Narcotic addiction, an "even chance for recovery."

After consultation at the home of Miss Rubens' mother, Mrs. Theresa Rubens, the doctors said the screen star had been at the points of death several times during the past few days.

It was revealed that, in the course of medical treatment designed to cure her of the Narcotic habit, administration of small doses of Narcotics had been terminated three days ago. The reaction in her physical condition followed. Only physicians and members of her immediate family were allowed to see her. Her husband, Richard Corbett, also a film star, was said by members of the family to be at his wife's bedside constantly.

House Adopts Substitute For MacLean School Bill; Reconsideration Is Sought

Raleigh, Feb. 26.—(AP)—Representative Alexander, Democrat of Union, today moved that the House reconsider the vote by which the Hancock-Moss-Harris substitute for the MacLean eight months school bill was adopted. His motion was seconded by Rep. Klutz, Republican of Catawba. Rep. MacLean took the floor, speaking in favor of the motion.

MacLean declared the bill had been adopted through "a flop."

Rep. Eure, Democrat of Cleveland, objected to reconsidering the vote.

On motion of Rep. Winston, Democrat of Bertie, a vote on the motion to reconsider was postponed until tomorrow.

The House adjourned shortly after 1:30 until 11 o'clock tomorrow morning.

Raleigh, Feb. 26.—(AP)—A bill authorizing the state prison to manufacture automobile license tags was introduced in the House today by Representatives Flanagan of Pitt and White of Yadkin.

Washington, Feb. 26.—(AP)—Anxious to complete the selection of his cabinet, President-elect Hoover conferred over the breakfast table today with William J. Donovan, assistant to the attorney general, who is now prominently mentioned for the post of Secretary of war.

After that conference, Donovan, who took a leading part in the Hoover campaign, declined to discuss the trend of his conversation with Mr. Hoover. After the election speculation as to Donovan's status placed him in the attorney generalship. Now however the names of William D. Mitchell, of Minnesota, solicitor general of the United States has taken a leading place in the speculation over the post. Previous opinions of political cabinet-making have given Dilas Strawn, of Chicago, the best chance for it. Mr. Mitchell is listed as a Democrat, but he has had support from several strong Republicans.

There were only a few other callers at the Hoover home today. Senator Hastings and Senator-elect Townsend, of Delaware, presented their respects. Senator Moses of New Hampshire called to introduce a constituent. Associated Justice Stone of the Supreme court and Ralph Arnold, a Republican leader of Los Angeles were other visitors.

Brands Secret Ballot Measure

Asheville, Feb. 26.—(AP)—Congressman-elect George M. Pritchard, Republican, of the tenth district, today sent a message to the Republican members of the North Carolina General Assembly branding as "unfair" and "disappointing" the proposed secret ballot law now before the state Senate.

Unable to attend the meeting of the Republican members scheduled to be held in Raleigh tonight the congressman-elect who was invited to speak, wrote Rep. Don C. Young, one of Buncombe county's legislative delegation, to express his regrets at being unable to be present and to convey the message to the Republican legislators.

"The proposed law," Pritchard said, in comment on the substitute secret ballot law, "is a keen disappointment to all of the people regardless of party affiliation. It will leave them no other alternative than to vote the Republican ticket and elect a legislature two years hence whose membership will respect their wishes by enactment of an absolutely fair election law."

Mystery Man of State To Play Benefit Show

Raleigh, Feb. 26.—(AP)—With the consent of Governor Gardner, arrangements have been made for Paul Turner, so-called "mystery man" of the state prison, to appear at a local theatre the last three days of this week for the benefit of the arctic recreation fund. In recent weeks Turner has been singing and playing the piano weekly over radio station WPTF here. He was convicted of manslaughter following an automobile accident in Hendersonville. The prisoner admits his crime from an affidavit, but declines to disclose his real name or discuss his past.

The affiliated organizations, each of which also has an independent program, include the North Carolina Association of Superintendents of Public Welfare and the family welfare societies.

Prince Acts for King at Levee

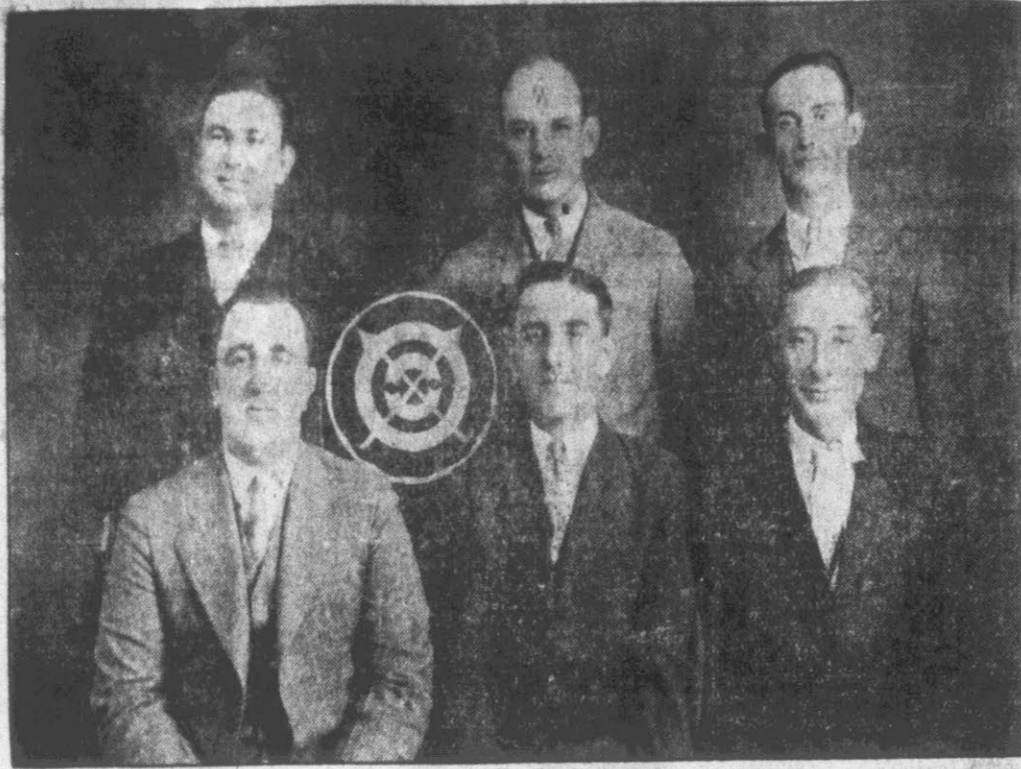

Blue Laws Have No Bearing On Corporal's Case

Omaha, Neb., Feb. 26.—(AP)—The South Carolina blue laws, like the flowers that bloom in the spring, have nothing to do with the case of Corporal William Woodbury and his enlistment in the Army, federal Judge Munger has decided.

Woodbury, court-martialed Feb. 5 for desertion and sentenced to a year's imprisonment, had sought release through habeas corpus action. He argued that his enlistment at Fort Moultrie, S. C., was on a Sunday and therefore void under the state's blue laws.

Judge Munger said the enlistment in the United States Army was no ordinary contract, being comparable to a marriage vow.

Major C. R. Williams, judge advocate for this Army corps area, argued that Fort Moultrie wasn't amendable to South Carolina laws, blue or otherwise, being under the exclusive jurisdiction of the United States government.

Woodbury deserted from Fort Moultrie Feb. 3, 1926, and was captured December 5, 1928, at Sioux City, Iowa.

Athens, Ga., Feb. 26.—(AP)—The University of Virginia, which has requested permission to send its team to the Southern Conference basketball tournament in Atlanta, probably will be unable to enter because the pairings already have been announced.

Last night's two hour session was an eventful one. Premier Mussolini read and commented on the recently signed treaty with the Vatican. He was frequently interrupted by applause.

Walter Johnson Has Idea of His Own

Washington, Feb. 26.—(AP)—Walter Johnson, manager of the Washington Senators, has ideas of his own about conditioning pitchers, and he is putting them into effect at the Tampa, Fla., training camp.

Johnson, in his day one of the best pitchers in the big leagues, has told his squad of battersmen on hand that the first thing they should do was to get their bodies into shape and that then their arms would round into condition quickly. In consequence there has been little ball tossing but an unusual amount of setting up exercises, with some running thrown in by way of diversion.

Noted Preacher Dies in New York

Bronxville, N. Y., Feb. 26.—(AP)—Dr. Newell Dwight Hillis, the third great preacher of Plymouth Congregational church of Brooklyn, successor to Henry Ward Beecher and Dr. Lyman Abbot, died yesterday after a long illness. He was 71 years old.

At the time of his death he held the title pastor emeritus, conferred upon him after his resignation of the pastorate in 1924. He had been pastor 25 years.

Henry Ward Beecher lent his eloquence to the condemnation of slavery and the defense of the union during the Civil War period.

Dr. Abbot championed the cause of Cuba from his pulpit in 1898. Dr. Hillis was active in support of the government during the World War.

New York, Feb. 26.—(AP)—One of New York's most famous clubs—the Union League—is to abandon its site at Fifth Avenue and 39th St., which it has occupied since 1881.

The club at a special meeting last night, voted by 307 to 100 to dispose of the present property and to buy a new site at Park Avenue and 37th street, where a ten story building will be erected at a cost of \$3,000,000.

The Union League club, which was organized in 1863 has a distinguished membership. President of the United States were honorary members.

Canton Experts Military Movement

Shanghai, Feb. 26.—(AP)—Reports from apparently well informed quarters in Canton today said the Canton government expects the nationalist government at Nanking soon to launch a military campaign against it.

Such a campaign would seek to force the Canton government to give Nanking the allegiance which admittedly does not now exist.

House Station Home Damaged by Flames

The home of Mrs. T. M. Moore, at House Station, was badly damaged by fire of undetermined origin late last Saturday afternoon. Damage was estimated at about \$1,500 which was partly covered by insurance. The flames were discovered on the second story, but were quickly checked by a bucket brigade composed of colored men who were congregated around a nearby store. The Greenville fire department was called out but the flames had been extinguished by the time of their arrival.

Civilian Flying Accidents

Washington, Feb. 26.—(AP)—Civilian flying accidents during the last six months of 1928 numbered 672 with 127 passengers and pilots killed. Severe injuries were sustained by pilots and minor injuries by 106 passengers and 101 pilots.

"My Thirty Years at Sea"

by CAPTAIN GEORGE FRIED

Fate arranged an enlistment for Spanish American Army service, and after that a return home to earn more money before Fried finally joined the Navy and was assigned to ship. His first struck early and savagely. He tells this story of his first experience as a sailor.

By Capt. George Fried

Johnny Fischer, my pal, and I were in New York for a while digging trenches for a street car company which was electrifying its system, eliminating the horse car. In our spare time we were always along the waterfront and once or twice were privileged to go aboard sailing ships to make a very careful inspection. This only made my yearning for the sea greater.

One day we ventured aboard a passenger ship. With muddy shoes we walked through the dining saloon just after white canvas run-

er-cleared and the seas moderated, and I could once again enjoy life on the bounding main.

In 1900, I started my real service with the Navy when I began swabbing decks, learning seamanship and gunnery and various other drills. Being a full fledged sailor or with a job's uniform, the same one which had previously inspired me, I had plenty of confidence, and naturally it wasn't long before I had my first fight.

One day while aboard the Buffalo I was bathing myself in a tub of water on the deck when another sailor passed and called me a rookie. That was an insult. All the boys watched and enjoyed the bout. I was victorious, fortunately, and afterward learned that this fellow had only enlisted two weeks prior to my entering the Navy.

When we joined the Hartford we began to appreciate the lot of a sailor working under the most trying circumstances. In tropical waters the heat was intense, and only

once in a while were we cooled by an occasional rain storm. Climbing up and down the rigging caused the skin on our feet to blister, for we were, after all, still rookies.

Returning to the deck made matters worse, for the heat caused the tar between boards to become soft and sticky, so that wherever we walked we suffered intense pain, as it was absolutely impossible to keep the tar from getting into the open wounds. Many of the fellows were laid up days at a time before their feet healed.

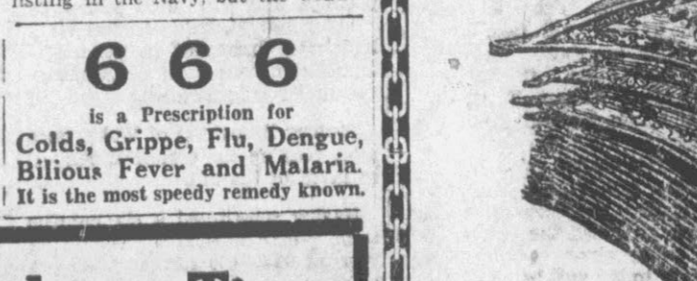
For three or four months the Hartford, which I had learned to love and consider as my own ship, remained in the tropics. We lived on salt horse, hard tack and corned

beef hash, a menu that was varied only on Saturdays by the addition of plum duff.

Plum duff is a sort of plum pudding and is highly prized by the sailor, or was in those days. I remember the old rule, "You must never steal a chipmate's plum duff in a squall." That would start many a fight. A man found guilty of taking his shipmate's most coveted tid-bit was ostracized socially, but it often happened, as you can well imagine. Not for long, though. I always found that the fellows in the Navy never held grudges very long. They were always ready to forgive their shipmates and would always uphold each other, right or wrong, in arguments or fights with outsiders.

I was on the Hartford five years, and you can readily understand that it meant home for me. On that ship I had all the experience that prepared me for my later years at sea. I actually started to sea the early part of 1900 and the Hartford was my first school.

On that ship I was a landsman, then, by study and hard work, became an ordinary seaman, later a coxswain, then quartermaster and finally chief quartermaster. In five years I progressed more than I could have dreamed of before when I played on North Pond lake back home, for the reason that a sailor with that job's wide trousers and flat hat was what I hoped to be.

I had no idea of the snappy uniform of the chief quartermaster those days. An admiral's uniform would mean nothing to me after I received that commission, but I decided to continue up the ladder.

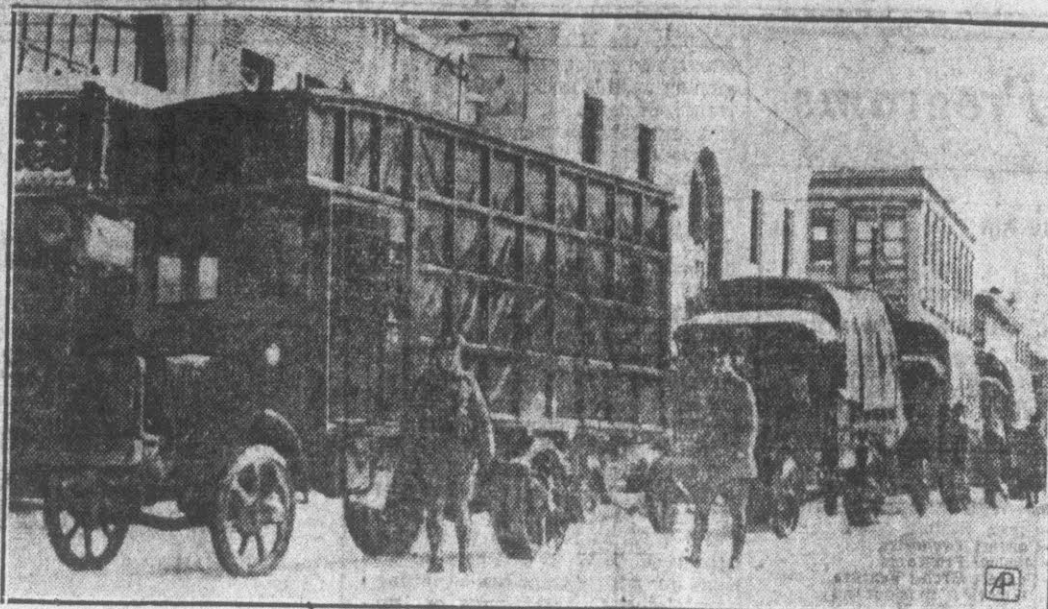

A THE DOOR OF THE WORLD COURT

or two and a half years th nations supporting the World Court have waited to the United States to re-approach its door. Now Secretary Kellogg, a fortnight before the Coolidge Administration comes to an end, makes a commendable if belated gesture for the resumption of negotiations. He asks member nations for that exchange of views which they themselves suggested in 1926. By this act he does not redeem the Coolidge Administration from its record of faint-heartedness in the matter. It will be left for Mr. Hoover to receive the foreign replies, to take steps which give us a full place on the World Court bench, and to face the die-hard criticism. But Mr. Kellogg does deserve credit for doing something to smooth Mr. Hoover's path; he does partly wipe away the record of Mr. Coolidge's surrender of the court in his speech at Kansas City.

If there has been any real justification for the failure of our government to take this action two years ago, it has never been explained to the people of the United States. Public sentiment was overwhelmingly in favor of our participation when on Jan. 27, 1926, the Senate approved our entry by a vote of 76 to 17. The Senate attached five reservations to its resolution. Member nations of the court accepted four completely and the fifth in part. Meeting at Geneva in September, 1926, twenty-four nations suggested (in Article IV. of the so-called draft protocol) a means of agreement on the fifth reservation. On Sept. 24, 1926, they filed this suggestion and asked the United States for an explanatory answer and a further exchange of views. Till now no answer has been given. The only approach to it they ever received was Mr. Coolidge's rebuff at Kansas City on Nov. 11, 1926. It was as if the Administration had seized upon this slight misunderstanding as an excuse for capitulation to the isolationists; as if Mr. Coolidge stood pat on it to avoid an encounter with Mr. Moses and Mr. Reed.

The delay is now past, however, and it is the future which interests us. Mr. Kellogg's courteous and reasonable not undoubtedly gives the incoming Hoover Administration an opportunity to enroll us among the member nations during the present year. For, as Mr. Kellogg says, little there is a dispute over terminology, "there seems to be but little difference regarding the substance" of our contentions. With Mr. Root in Geneva there is every reason to hope that an agreement satisfactory to the Hoover Administration and the Senate may be reached.—N. Y. World.

NO BETTER OFF

The substitute for the MacLean bill providing an equalization fund of six and a half million dollars and a six months school term at a glance appears to be sound, but what we want to know is how about the other two months. Already there are in existence some eight months schools in every county in the state. As we understand it, under the substitute bill the present special districts would continue their present eight months terms paying for the two additional months themselves. Unless there are provisions in the measure that would prescribe just how far the districts could go in the way of expenditures for the additional two months and just how much tax could be levied for the same, we cannot see that we will be much better off under the bill than under our present system.

We do not hesitate to venture the belief that without restrictions the additional two months in many cases would cost equally as much as the six months under state supervision. If such were the case the tax levy for the additional term would prove greater than for the six months term because there would be no state aid for the two months and just as high, or even higher, land taxes would be the result.

Guy Smith Again Heads Greenville Ball Club; Organization Perfected

G. V. Smith, prominent Greenville tobaccoist, was again elected president of the Greenville Baseball Club of the Eastern Carolina League at an organization meeting held in the city hall last night at eight o'clock. W. H. Dail was elected to the vice-presidency, and Hugh Ragdale was re-elected as secretary and treasurer.

The meeting was one of the most enthusiastic gatherings of the kind ever held in the city before. Approximately a hundred or more persons interested in Greenville's participation in the Eastern Carolina League were in attendance and pledged their support to the club in its effort to give the city the best team in history.

One of the outstanding features of the gathering was the presence of no less a person than Lester Bangs, new manager of the Tobaccoists. Bangs was called on for a speech. He admitted he was no orator, but told in a plain and interesting way of plans in connection with Greenville's activity during the coming season. He said he had hired a number of players who had established enviable reputations with the bat and in the field and he expected they would be able to render a good account of themselves at critical stages of the game when hits would count for runs.

Bangs promised to give the city the kind of baseball team it has been wanting for a long time. He pointed out, however, that it would be necessary for the club to receive both the moral and financial support of those interested in the game. His speech was made in a happy vein and immediately won the support of those who listened to it. C. B. Rowlett, secretary of the Merchants Association, acted as chairman of the meeting. J. J. Sumner was secretary. Several proposals regarding organization were presented by those interested in success of the club, and considerable time was required to work out a plan. It was decided to incorporate the organization under the name of the Greenville Baseball Club and to sell stock among the hundreds of fans throughout the city. The stock will go at \$18.00 a share. Nearly \$1,500 worth was disposed of at the meeting. A soliciting committee was named to canvass the city in order to give everybody an opportunity of becoming shareholders.

This committee was composed of J. C. Gaskin, Bill Rogers, E. S. Williams, "Deacon" Joliff, John Clark, H. H. Duncan, Tom Hollingsworth, C. L. Jones, J. B. Kittrell. The president and vice-president were empowered to appoint any other members needed to complete the committee.

An organization committee was named to arrange for incorporation, solicitation of stock and other matters dealing with preliminary formation of the club. This committee was composed of G. V. Smith, Haywood Dail and Mayor J. C. Lanier. Naturally there was a considerable amount of oratorical effort. There always is an occasion of the kind. But the effort last night was limited to just a few minutes, although several spell-binders of local fame were given an opportunity of freighting their chests of anything they believed necessary to the welfare of the club.

The first speaker of the evening was Haywood Dail, one of the greatest boosters in Greenville and Pitt county. He said there was no reason on earth why Greenville should not have the best ball team in the league.

"We have plenty fans, plenty money, and the necessary enthusiasm to put the thing across," he declared.

He said the team should not be made a one or two man proposition like it was last year. Guy Smith should not bear the brunt of financing the club as he did last year. He proposed the selling of stock and give everybody an opportunity of becoming stockholders in what he termed "the greatest ball club in history of the city."

President Smith expressed appreciation of the support given him last season. He didn't mention the fact that he dropped several thousand dollars in an attempt to produce a winning team out of a club

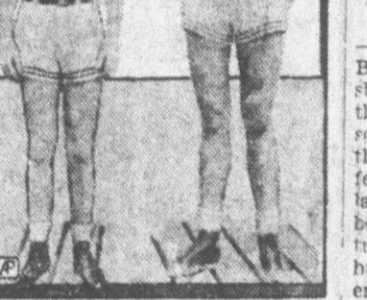

It has been possible to make a fight enthusiastic community out of a sophisticated winter resort such as this and, at the same time, draw the undoubted focus of nationwide attention on a bout that, after all, decides only whether Stribling or Sharkey is to continue as a first flight contender.

There are plenty of answers, just as there has been plenty of talk and write about outside the actual fight itself. But the most conspicuous reasons for it all are unquestionably Jack Dempsey and the ballyhoo—Dempsey, the old mauler, playing successfully at his new role of promoter; and the ballyhoo, with new words and music inspired by the balmy zephyrs of Florida's shores.

This is the south's first heavyweight fight of national interest since the palmy days of New Orleans as a fistie center, and few of those in the rathering here can recall that. This is also a major bid for fame by William Lawrence Stribling, 24-year-old Mason youth—the son of an acrobatic father and the father of an acrobatic child, who has helped enliven the training proceedings.

Stribling, because he is to fight before a southern gallery of friends, relatives and admirers, is the sentimental favorite of the house of Dixie, but Sharkey, the hard punching sailor, is the choice of most of the assembled experts to win. Yet there is a wide divergence of critical opinion not only because of so many conflicting developments in training but also because of the uncertain evidence in the records of the two fighters.

St Petersburg, Fla., Feb. 26.—(AP)—Johnny Evans, new coach of the Braves, is delighted with the general showing and especially pleased by the spirit of Percy Jones, veteran southwester acquired from the Cubs in the Hornsby deal. March sold around 20.58, May 20.40, and the new October contract at 19.82.

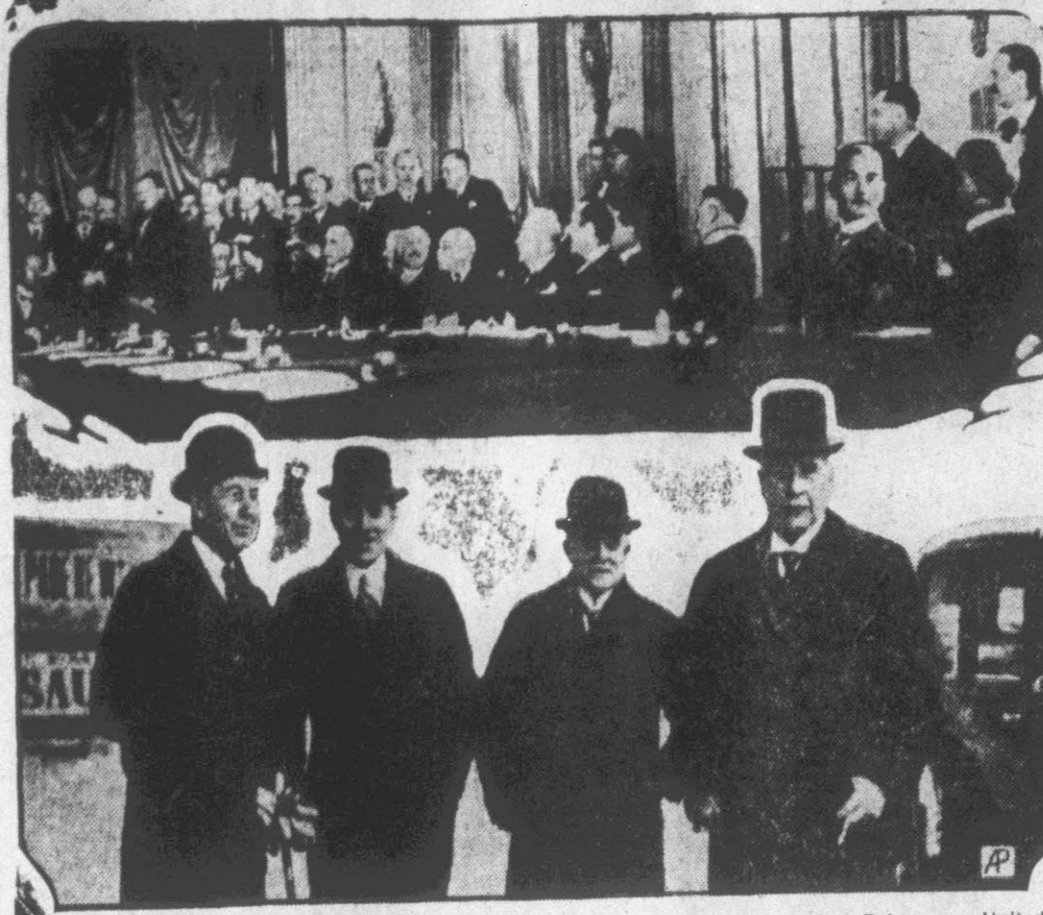

Atlanta Officer Shot to Death

Atlanta, Feb. 26.—(AP)—County officer B. L. Hughes was shot to death by an unidentified man who in turn was killed by County Officer A. A. Stovall in a three cornered pistol duel here about 3 a. m. today.

Stovall said he and Hughes had been riding up Peachtree Road, on the North side of Atlanta, when they noticed the man idling in front of a group of stores at a community center where a number of robberies had recently been reported.

They stopped their automobile, Stovall said, and Hughes walked up to the man and asked him what he was doing there at such an hour. The man told Hughes he was from Canning, Ga., Stovall said, and that he was on his way to Macon.

Before the officers could question him further, he started walking away, and when Hughes again approached him, he turned and fired, the officer falling over an embankment at the roadside.

Stovall said he then ran from the automobile and fired at the man, who fell mortally wounded.

The officer took both bodies to a mortuary, where efforts were being made to identify the stranger.

Rebels Repulsed In Mexico City

Mexico City, Feb. 26.—(AP)—El Universal today says a band of insurgent Cavalrymen yesterday penetrated guadajajara, second largest city in Mexico, as far as the Military Garrison, where they were repulsed; they fled from the city.

As the band of about 20 members approached the Garrison, guards fired upon them, other troops quickly forming. The insurgents showed little disposition to fight, and in the face of superior number left quickly.

Guaralajara is capital of the state of Jalisco, where the so-called Catholic Insurgent movement has been at its height. Activities of the bands heretofore have been confined mainly to a sort of Guerilla warfare with rarely anything so bold as an incursion into a heavily guarded city.

A sharp encounter with the Insurgents near Patzcuaro, Michoacan, also was described in El Universal. The paper said the Insurgent band, 80 in number, was that which attacked the Los Reyes-Yurecuaro passenger train February 15, killing three and wounding others. In yesterday's clash six were killed before the band retreated. Later it faced the federal troops again and two of their number were captured.

Still another encounter took place at Chilcoata, Michoacan, two Insurgents being killed.

Meanwhile the government has told Ambassador Morrow that special detachments of federal troops are making a through search of the Mountain district in Guanajuato where two Americans, J. M. Underwood and C. C. Aiesthorpe were slain last week.

The United States Ambassador, although he was without official advice from Consular Channels of the killins, went to the Mexican foreign office yesterday and made formal representations.

Merger gossip stimulated Amusement shares demand. Motion pictures rallied 4 1-2 to a new high at 27 1-2. Loews was marked up 4 points and Fox and Warner Brothers advanced a point or so. A brisk demand also developed for some of the low and medium priced oil shares.

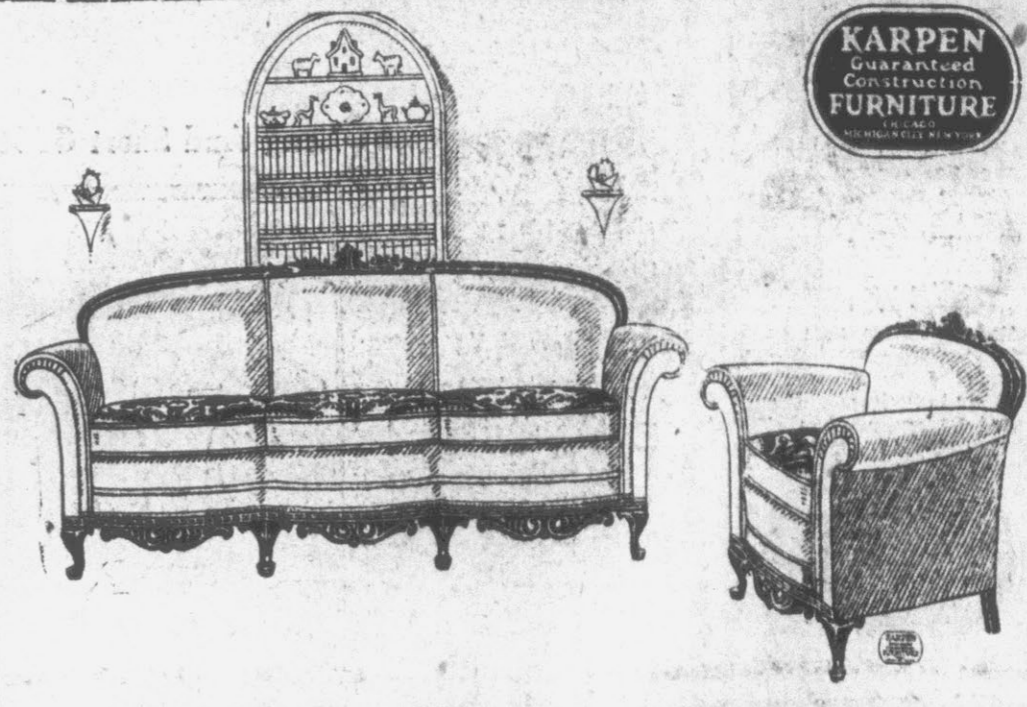
