## Government Troops Prepare For Second Attack On Jimenez

### Contradicting Federal Report Of Partial Victory, Rebels claim sweeping Victory in Fighting For Possession of Stronghold Yesterday; Rebels Reported in Full Retreat on West Coast.

Field in check by stubborn rebel resistance after a heavy day of fighting for possession of Jimenez in Chihuahua, powerful federal forces today were poised for another onslaught against the insurgent stronghold.

Contradicting federal reports of a partial victory in yesterday's battle, the rebels claimed a sweeping victory at Jimenez during which insurgent forces drove southward for a distance of twenty miles.

Along the West coast, the rebels were reported in full retreat after a disorganised battle in which they were said to have lost 100 dead 50 wounded and numerous prisoners.

For the first time since the outbreak of the revolt five weeks ago, the revolution appeared entering a decisive phase, the battle for Jimenez being the most extensive thus far reported.

For fourteen hours Monday the battle raged and late in the afternoon the federal forces failed to draw their lines for resumption of the attack today.

At that time they claimed possession of part of Jimenez with the rest of their three mile front approximately nearer the important railroad point.

No definite estimate of the casualties were available, each side stating that hundreds of the enemy had been killed.

Artillery, airplanes and machine guns were used extensively to support cavalry and infantry advances all along the line, about 10,000 federal and 5,000 rebels were reported to have participated.

Lieutenant Colonel Roberto Pierrez, noted Mexican fighter, reached the federal lines after being shot down by rebel fire Sunday. He was given a new plane to take up a search for a companion still missing.

General Calles, announcing that the attack would be renewed today reported that bridges North of Jimenez had been burned by federal detachments thus cutting off any rebel retreat.

Naco, on the border, was tense as rebel troops threatened again to open an attack against the defending federal. Rebel planes have bombed the town four times within the past two days.

General Escobar, rebel commander in chief, resumed his attack on Ambassador Morrow charging him with being the representative of "the House of Morgan."

Juarez, Chihuahua, Mexico, April 2.—(AP)—A sweeping rebel victory in the battle of Jimenez, during which the rebelling forces advanced twenty miles Southward to Corralitos, was claimed in a bulletin received by the headquarters of the revolutionists here last night.

Because General Jose Gonzalo Escobar, revolutionary commander in chief, is too busy firing a machine gun to fiddle around with a typewriter, as one of his aides put it, little else was known here of the battle which has been under way for more than 24 hours.

Escobar sent two bulletins to the rebel headquarters here early yesterday announcing he had repulsed two attacks by the federal and expressing confidence that the rebels could hold Jimenez indefinitely.

Officials of the revolution here believe that if Escobar can hold Jimenez throughout today, the federal will have to retire, to reach their base of supplies.

Word was received in Chihuahua yesterday that the federal garrison left in Torreon when General P. Elias Calles forces advanced northward in pursuit of the rebels, had revolted. Lack of wire connections with Torreon kept the details of the revolt bottled up in the town.

The battle now in process at Jimenez is probably the greatest in the history of Mexican revolutions. Troops on both sides number into the thousands and the infantry and cavalry troops on both sides are reinforced by machine guns artillery and the latest innovations in revolutions, the air squadrons.

Since the bombing of Torreon by the rebels, aerial warfare has come into great prominence. Both sides have engaged in bombing raids in the past few days, and there have been reports of air battles between federal and rebel planes in the vicinity of Jimenez.

An official bulletin received at Juarez last night said an airplane loaded with bombs had been dispatched from Chihuahua City to aid the rebel at Jimenez, and that

## LEAF FACTORY HAS INSTALLED NEW MACHINE

### Export Also to Erect Addition To Plant; Other Companies To Enlarge Plants.

The program of improvement on the Greenville tobacco market received additional impetus today with announcement of the installation of a new re-drying machine by the Export Tobacco Company. This will make three such machines now in service in the local plant of the concern. It will increase capacity to one-third more than last season. Construction work will begin in a few days on a large addition to the factory building. The site of the new structure was being cleared off today, preparatory to excavation work. It was stated this morning that similar additions were being contemplated by other companies, making it possible for the local market to handle between 85 and 90 million pounds of bright leaf next season.

Those in close touch with market activities today vouched for the statement that at least three warehouses were contemplating an increase of floor space during the summer months. Additions of sufficient size will be added to take care of the enormous increase of volume of tobacco expected on the Greenville market next season.

The Greenville tobacco market outstripped all previous records last season by selling over 61,000,000 pounds of bright leaf. The record was 10,000,000 pounds better than the previous season. The market also had the distinction of setting what is claimed to be a world's record by the sale of a million pounds of tobacco daily for a period of sixty days. It also finished up the season with the highest price average of any market in the new bright leaf belt.

This record, tobaccoists believe, will play an important part in the general increase of sales expected for next season. It is to set themselves in position to take care of the enormous volume that enlargement of warehouse and factory facilities are under way.

## Hoover Finishes First Draft Of Special Message

Washington, April 2.—(AP)—President Hoover has completed the first draft of his message to the special session of Congress, and is now engaged in revising the document. He plans to send it to the capitol by messenger for reading by the clerks of both houses, rather than deliver it in person, as has been done by some of his predecessors.

## Lindbergh On Way To Mexico

Brownsville, Texas, April 2.—(AP)—Colonel Charles A. Lindbergh took off for Mexico City at 8:45 a. m. today to visit his fiancée, Miss Anne Morrow.

The colonel said he expected to arrive in Mexico City by noon with normal flying conditions. His plane was checked over and refueled while he ate breakfast. It was believed he would make a non-stop flight to the Mexican capital.

## Southern Cross Reported Lost In Australian Bush

Sydney, N. S. W., April 2.—(AP)—Search was being made today by air and water in the Australian bush for the missing plane Southern Cross and four men. Absence of word from Captain Charles Kingsford-Smith, Charles T. Ulm and their two companions, who radioed Sunday they were coming down in a rainstorm 100 miles east of Wundah, Western Australia, led to anxiety.

The London Daily Express in a dispatch from Sydney said today "it is feared they are lost in a wild inaccessible jungle country without food."

A dispatch to the London Evening News yesterday said it was believed the aviators were safe but this was not borne out by other advices from Australia.

London, April 2.—(AP)—A dispatch to the Evening News from Melbourne, Australia, today said that anxiety for Captain Charles Kingsford-Smith and his three companions of the Southern Cross was becoming acute.

Reports that they landed safely near the Drysdale Mission station could not be confirmed and fears were expressed that the aviators were sending out their final message may have lost their way and headed toward Darwin where the heavy rain would have made a safe landing almost impossible.

## FRENCH PLAN BIG FUNERAL FOR HERRICK

### Nation Leaves Little Undone in Effort To Pay Tribute To Friend of People.

Paris, April 2.—(AP)—The French government continued today its plans for imposing funeral honors for Myron T. Herrick, United States Ambassador. Little was being left undone to pay tribute to the man who while he lived here was France's friend as well as his own country's plenipotentiary.

A number of details inseparable from the elaborate ceremonial involved remained unsettled today but the principal features of the obsequies were agreed upon. Meanwhile the body itself remained at the Embassy where a throng of admirers, both distinguished and humble, passed for a last view.

The ceremony Thursday will open with the funeral oration pronounced by Premier Raymond Poincaré himself. This will be the second time in little more than a fortnight he will have been called upon to officiate in such a capacity. A distinguished gathering at the Embassy will hear his eulogy.

After it is concluded the cortege will form outside with a guard of honor, to which the Ambassador is entitled as holder of the rarer distinction of the Grand Cross of the Legion of Honor. The guard will be followed by a considerable representation of other organizations. The cortege will proceed a short distance to the American Pro-Cathedral, where there will be a memorial service.

The body will then be placed on a special train and conveyed to the coast and taken aboard the new fast Cruiser Tourville, which will depart immediately for New York. There Parnley Herrick the Ambassador's son will await it to accompany it to Cleveland for interment.

There was a never ending stream of visitors at the Embassy all signing the book and expressing their condolence with the Embassy staff and Mrs. Parnley Herrick, the Ambassador's daughter-in-law.

Letters and telegrams arrived from all over France by the hundreds. These included messages from the Mayors and City Councils of Havre, Nancy and the rector of the University of Nancy of which Mr. Herrick was honorary doctor.

French newspapers still carried long appreciative articles of the dead Ambassador's life, details of his funeral arrangements and cables from America telling of the sorrow there.

The municipal council of Paris is expected at its next meeting to give the Ambassador's name to a street in the quarter where he lived. Paris already has streets named for Washington, Franklin, Lincoln and Wilson.

New York, April 2.—(AP)—The body of Ambassador Herrick will arrive in New York on the French Cruiser Tourville, April 12. Parnley Herrick the Ambassador's son, will meet the Cruiser. His arrival is expected to arrive the same day on the Aquitania.

Parnley Herrick, who returned from Paris last week, came here from Cleveland yesterday and was joined by his son, Parnley Herrick, Jr., a student at St. Paul's School, Concord, N. H.

"It is the desire of the family that the funeral be as simple as possible," said Mr. Herrick. He said the body immediately upon arrival would be taken to Cleveland. Until it is due he will be the guest of A. J. Drexel Paul at Radnor, Pa.

## EIGHT KILLED BY WINDSTORM OVER MID-WEST

### Several Also Injured By Blast That Swept Through Thirteen States Into Canada.

New York, April 2.—(AP)—The death toll from a furious windstorm that swept across 13 states and part of Canada, yesterday mounted to eight today. Several score persons were hurt. There was much property damage.

The storm, which reached a velocity of seventy miles an hour at some places, originated in the southwest, tearing across parts of Arkansas, Missouri, Nebraska, Iowa, Illinois, Minnesota, Wisconsin and Upper Michigan and then across Ohio into Pennsylvania, West Virginia, New York and New Jersey.

Buildings were unroofed, wires were blown down and trees uprooted. Both Lake Michigan and Lake Erie were swept by the storm and much property was damaged along the lake fronts. Waves as high as thirty-five feet dashed along the Illinois-Wisconsin shore on Lake Michigan.

At Buffalo three ships were torn from their moorings and the Lake Erie water level was six feet above normal.

One man was killed in Buffalo by a falling tree. The wind blew down a hangar at the Buffalo airport, damaging planes.

Central western New York was hard hit and cities and towns were cut off from communication by blocked highways and crippled telephone service.

In Patterson township, near Beaver Falls, Penna., a seven-year old girl was killed and fifty other children endangered when the wind blew off part of the roof of a school building. A ten year old girl lost her life in a similar happening at a school building at Newell, W. Va., and a year-old child was killed at Welch, W. Va., when a home was wrecked.

The storm cut a path four miles wide along the Delaware river in eastern Pennsylvania and New Jersey, causing one death. Boyd Titman, a Polkville, N. J., farmer, was killed in the collapse of his home. The storm was most furious in the vicinity of Portland, Pa. and Columbia, N. J., tearing houses and barns from their foundations and unroofing scores of others. Two automobiles on the Titman farm were twisted into wreckage and blown more than fifty yards.

Two persons were killed in Ohio. At Newark a man lost his life when his automobile was struck by a tree, and at Belmore a girl was blown into the path of an automobile and killed. A girl was killed in Arkansas by a falling tree.

Chicago, April 2.—(AP)—Property damage mounting into the millions and a serious new flood threat today to remind the mid-west of the rain, wind and snow storm that swept over the region Sunday and yesterday.

Heavy rains in the central and blizzard in the northern states had again swollen nearly all streams and the danger was considered acute as the tributaries brought this added burden to the Mississippi, which

## INSURGENTS BOMB AMERICAN TOWN; TERROR REIGNS

### Stock Market Reflects \$80,000,000 Increase In Report of Income Taxes

Washington, April 2.—(AP)—The rising stock markets of 1929, which caused the Federal Reserve Board a great deal of concern, are credited by the Treasury Department with an unexpected increase of \$80,000,000 in March income tax returns over the same period last year.

Collections this year, it was announced, already have reached \$595,000,000, indications are that by the end of the fiscal year, June 30, the total will be the largest since 1921, and the official estimate of the probably Treasury surplus has been raised from \$26,000,000 to \$100,000,000.

Furthermore, it was disclosed, individual income tax returns have increased to such an extent that for the first time, they exceed corporation tax collections, which came up to expectations under the reduced rate of 12 per cent. The explanation for the increased collection from individuals was that, with the stock markets rising the way they did, few deductions were made for losses, and with the maximum surtax rate cut from 40 to 20 per cent, many persons who might otherwise have held their stocks took their profits and included them in their return.

Meanwhile, the controversy over efforts of the Federal Reserve Board to curb their use of credit in stock market operations has given little evidence of abatement, although neither the board nor the governors of the twelve Federal Reserve Banks who are in session at the time but not jointly, yesterday inquired into the New York situation.

The governors are having their semi-annual conference and, although several of them dropped in on the board meeting, which also was attended by Secretary Mellon, it was announced that they had discussed only routine matters. After the board meeting, Secretary Mellon said no mention had been made of the action of Charles Mitchell of the National City Bank, during the credit crisis last Tuesday, in advancing \$25,000,000 to break the advance in the call loan rate.

That action, which drew demand for his resignation as a New York Federal Reserve Bank director, from Senator Glass, Democrat, of Virginia, a former secretary of the Treasury, was given vigorous support last night by Langborne M. Williams, senior member of the banking firm of John L. Williams and Sons, of Richmond, a brother of the late John Skelton Williams, comptroller of the currency in 1920.

In a telegram to Mr. Mitchell, he told the New York banker that "the country owes to you a debt of gratitude for your attempt to offset what many consider the vicious misconduct of the Federal Reserve Board in attempting to destroy the

large business interests of the country," and in a message to the Senator declared:

"Referring to your call on Mr. Charles Mitchell to resign from the Federal Reserve Bank at New York, I believe that it would be far more appropriate that you should resign as Senator from Virginia and let someone of broad and clear vision, like Gov. Harry Byrd, who is not drowned in self-conceit and narrow-gauge thinking, take your place in the Senate of the United States, as a real broad-gauge representative of Virginia.

"Some of the Federal Reserve governors and yourself seem to be in a conspiracy to destroy the prosperity of the country for the sake of controlling a few undesirable situations which will remedy themselves by natural laws if not interfered with by political office-holders."

## LOCAL CHURCH EXTENDS CALL TO FLEISHMAN

### Memorial Baptist Church Tenders Pastorate To Pastor Of Louisburg Church.

Rev. A. W. Fleishman, pastor of the Baptist church at Louisburg, N. C., has been extended a call by the Memorial Baptist Church of this city, it became known following a meeting of the congregation last Sunday morning. Whether or not the call will be accepted had not been determined today, but it was expected the matter in all probability would be settled next Sunday when Mr. Fleishman is scheduled to occupy the pulpit of the local church both morning and evening.

Should the Louisburg minister accept the call, he will become a successor to Rev. H. Frederick Jones, pastor of the Brantley Street Baptist Church at Baltimore, Md., who resigned last January to accept the call of the Maryland church. The local institution has been without a pastor since that time. Numbers of ministers from various cities of North Carolina and Virginia have filled the pulpit since Mr. Jones' resignation, however, and only on two or three Sundays has the church been without regular services.

Mr. Fleishman went to Louisburg from the Southside Baptist Church at Raleigh. He accepted the Raleigh call while a member of the Home Mission Board of the Southern Baptist Convention. He is a graduate of Richmond College and received his theological training at the Chicago Baptist Seminary. Prior to his entering the ministry, he served as certified public accountant.

Mr. Fleishman made his first appearance before the congregation of the church here the second Sunday in March, but two Sundays passed before action was taken to extend him a call to the pastorate.

## Man Held For Killing Mother

Bushnell, Fla., April 2.—(AP)—Richard Hamilton, 35, was arrested here today charged with the murder of his mother, Mrs. Mary Ann Arnold, 75, on a remote farm in the Hill community Sunday.

Testimony at a coroner's jury brought out the fact that Hamilton had refused his mother entrance to her own home, that she had attempted to strike him with an axe handle, and that he shot her after ordering her away.

## Ohio Man Wounded When Mexican Rebel Plane Unintentionally Drops Four Missiles in Attack Upon Federal Stronghold of Naco; Boy Also Reported Injured; Confusion And Terror Reign As People Flee From Danger Zone.

Naco, Ariz., April 2.—(AP)—The American town of Naco was bombed today, apparently unintentionally, by a rebel plane. A Mexican rebel airplane, dropped four missiles in an attack upon the federal stronghold of Naco, Sonora, on the Mexican side of the line.

Baker was attended by a physician, at the United States immigration office. He was reported to have been struck in the head by bomb fragments. There also was an unverified report that a boy was hurt during the attack, but he could not be located in the confusion which immediately followed.

Terror held sway for a few minutes in the American town as those in the danger zone ran for cover. Major Charles B. Haseltine, commanding the American troops here, declined to comment on the situation.

The total population of the two towns is approximately 3,000, about evenly divided by the international line.

Two of the four bombs fell on American soil. Many windows in the business district here were shattered. The other two bombs fell in Naco, Sonora.

The attack was a continuation of the raids started last Sunday by rebel aviators under General Fausto Topete, Governor of Sonora. Thus far 19 bombs have been dropped in three days. Up to today the casualties on the Mexican side were two killed and three or four wounded.

American infantrymen have been stationed here for several days with instructions to prevent if possible any damage on the American side of the border.

Naco is held by 1,200 federal troops under General Lucas Gomez and Augustino Olachea. Topete's attacking force, several miles south of the city, are said to number upward of 2,000.

## Probe Charges Against Snook At Atlanta Pen

Atlanta, April 2.—(AP)—The Constitution said today that special agents of the Department of Justice yesterday interviewed a number of prisoners at the Atlanta Federal Penitentiary concerning the charges that former Warden John W. Snook permitted inmates to receive money visitors while he was in charge of the institution.

The newspaper said Mrs. Mabel Walker Willebrandt, special assistant Attorney General, planned court action against the former Warden on the matter, which Snook himself has branded as "preposterous and without foundation."

The department investigators were said by the newspaper to have investigated charges that Narcotics have been available to addicts within the prison and that disease is prevalent there. In a statement last night Mr. Snook, whose resignation from his post became effective Sunday night, denied both of these charges, and again scored the "phantom" of Department of Justice agents in the institution as "concocted."

Federal officials here would not be quoted on the possibility that a Federal Grand Jury, which expected to go into session today, would take any action on the charges against the former warden.

The warden has made known however, that he has consulted attorneys in regard to the possibility of bringing action against Department of Justice officials for the alleged "falsification of government documents" in procuring the incarceration of agents in the prison as bona fide prisoners.

It became known yesterday that four assistants of the former warden had been demoted to guard duty the prison walls by order of Mrs. Willebrandt.

# BEGIN PROBE OF DEATH AT AURORA, ILL.

## Traveling Inquest Starts in "Death For Gallon" Slaying Of Mrs. DeKing.

Aurora, Ill., April 2—(AP)—A traveling inquest opened today into the death of Mrs. Lillian DeKing. The jury empaneled by Coroner Herman J. Vierke shortly after Mrs. DeKing was killed during a county dry raid at her home eight days ago, was recalled here this morning. The inquest, however, was to transfer immediately to an Elgin hospital to hear the story of Deputy Roy Smith, who shot Mrs. DeKing. From Elgin the setting was to change to Geneva where authorities were asked to provide "the largest available space" so that the jurors, and expected to attend might be accommodated.

Some testimony already has been placed before the six-man jury. It has been told that Joseph DeKing, husband of the slain woman, refused riders permission to enter the house when they appeared with a search warrant; that DeKing was knocked unconscious by a blow from Deputy Sheriff Smith's clubbed shotgun; and that Mrs. DeKing was shot as she attempted to reach the side of her fallen husband. With DeKing unconscious, Mrs. DeKing dying and the room choked with tear gas from a bomb thrown by another deputy, the 12-year-old DeKing boy, Gerald, snatched up one of the guns his father had and fired at Smith, wounding him in the leg.

These details have been presented together with the statement that the rebels found a ration of wine in the house; but the deputy sheriff's account was looked upon as of high importance in today's inquiry because of his informal statement following the shooting that he had fired in self defense, believing Mrs. DeKing was about to pick up one of her husband's pistols and shoot him.

Coroner Vierke opened the inquest with a statement promising a thorough investigation of the shooting and of the acts leading to it including the circumstances surrounding issuance of the search warrant which have been under fire from the DeKing attorneys.

"I don't care how many days it takes to get to the bottom of this affair," he said. "My purpose is to place before the jury every scrap of evidence that has a bearing. Two duties are assigned to coroner's jurists. One is to determine the cause of death; the other is to fix the responsibility. There will be no shirking the second duty."

Both State's Attorney George Carbery and a representative of the attorney general of Illinois were to attend the inquest, but neither planned any interference with the coroner's conduct of it. Carbery has been relieved of official connection with the entire inquiry, having himself filed a petition requesting that the investigation be turned over to the attorney general. The latter, however, has not indicated whether he will assume authority although he has had an assistant looking into the case for several days.

## Brings Serious Charge Against N. Y. Coast Guard

New York, April 2—(AP)—Stuyvesant Fleh, wealthy clubman and broker, has complained to Washington that his yacht was stopped last Saturday night near the Statue of Liberty by a coast guard boat whose crew pointed revolvers at him and his family and searched his craft for liquor.

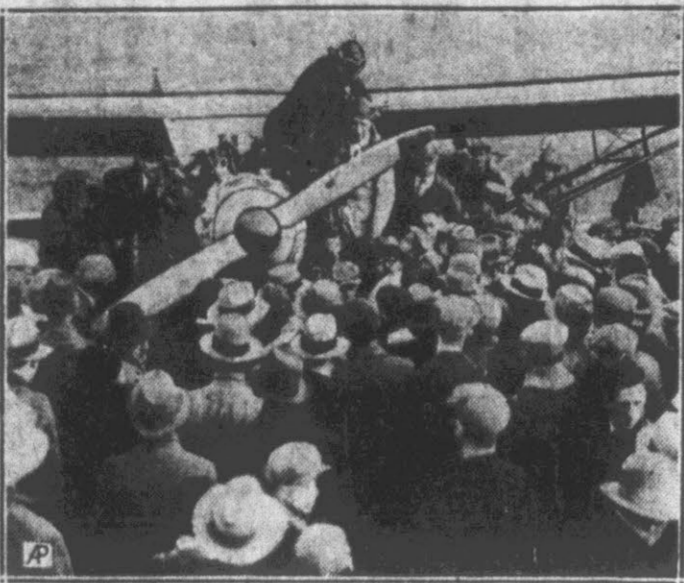
Fleh said that as he was bringing the yacht up New York Bay on the way from Wilmington, Del., where he had purchased it, he saw a coast guard boat coming toward him. He went to within 100 yards of the patrol boat, he said, and receiving no signal, pursued his course. He then turned the wheel over to Captain Larsen, an employe of the American Car and Foundry Company, from which he had purchased the yacht.

"Shortly after he had taken charge of the boat," Mr. Fleh said in his complaint, "he turned the boat directly across its course and stopped it. On asking him why he had done so, he informed me that the coast guard was shooting, whether at us or in the air I am unable to say, as we were not hit."

"The coast guard then came along side in a very choppy sea and insisted that they put a man aboard to search the boat, covering us with five or six army revolvers or revolvers of similar type. The representative who came aboard searched the boat for liquor, found none and informed us that we were very lucky that they had not turned the machine gun loose on us as they had signalled us to stop."

Fleh told newspapermen that although his wife and two young sons were present, the search was accompanied by a "frightful outburst of profanity and vulgar language."

## Revolt Breaks Out In Ranks Of White Sox

Dallas, Texas, April 2—(AP)—Revolution has broken out in the ranks of the White Sox because of the training methods and disciplinary measures enforced by Manager Lena Blackburne.

Blackburne, the rebels charged, had wounded their pride by "snapping" on their actions off the diamond. Furthermore, they said, the team was not being run right and that they were forced to play fourth rate teams on precarious diamonds without any possibility of learning any baseball.

Despite recent warning from the Chicago headquarters and his three-day benching and the loss of his captaincy for breaking a training rule, Art Shires, rookie first baseman, dictated a statement in which he gave vent to his feelings.

"I didn't want to come to this job in the first place," the Texan said. "and I didn't ask them for the captaincy. If they don't want me to play first base for them, all right, too. If they don't want me on their squad, all right again. Let them trade me or send me back to the minors. There are plenty of clubs that can use me."

Several other players, who were not as bold as Shires to give a public statement, complained they were being treated as juveniles.

Blackburne said he was running the club and that he intends to enforce the training rules.

Bill Cissell, who cost the White Sox \$123,000 in 1927, was another who openly admitted his dissatisfaction. Cissell, like Shires, was benched for breaking rules.

Raleigh, April 2—(AP)—Governor Gardner returned to his office today from his first week-end away from the Capital to resume work in crowded quarters.

The general office and waiting room in the chief executive's suite is being tented, necessitating a concentration of the office force in the one room used heretofore by the Governor as his private office. So far no arrangements have been made to provide accommodations for private conferences with the Governor. The work of remodeling will consume about five weeks.

Governor Gardner went to his home in Shelby Friday to take part in exercises at the Baptist camp there, and to get a rest after nearly three months of strenuous labor incident to taking office and dealing with the General Assembly. But, it was disclosed today, his hopes of being able to relax and forget the cares of state were not realized. His telephone was ringing almost continuously and a large number of delegations from the western part of the state took advantage of his nearness to place before him their views on public matters.

The new director and his assistant, J. S. Hargett of Trenton, held a conference this morning with Governor Gardner about the work of the department.

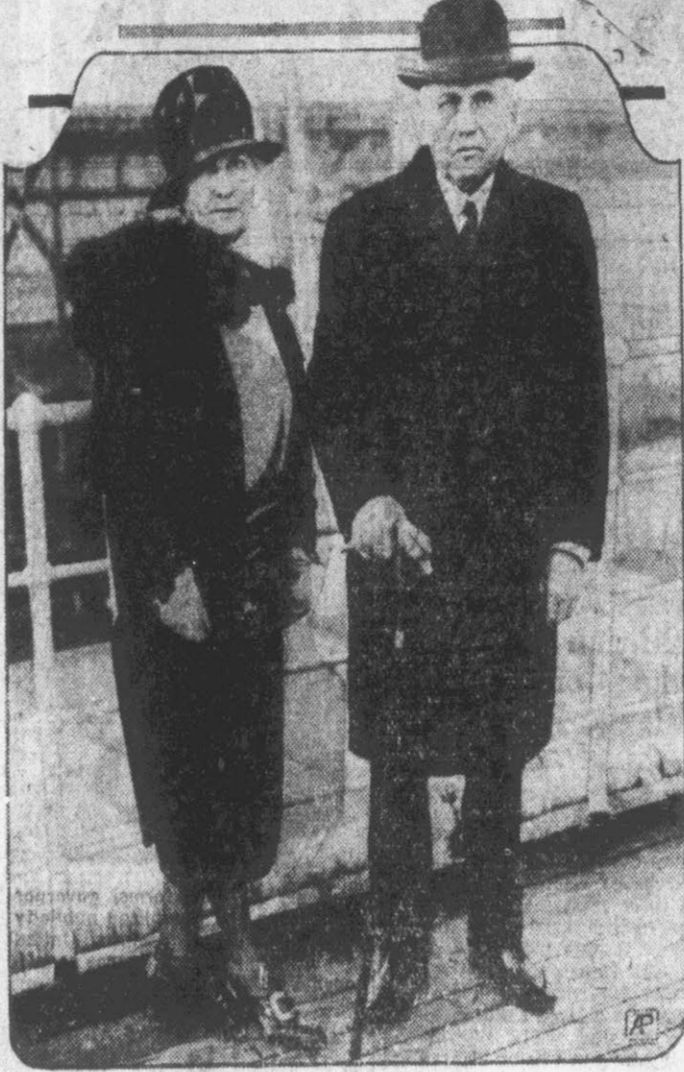
## FOREST HEADS SCRIBES AT THE WHITE HOUSE

This suggestion that comes from Pinetops is indeed a good one and if carried out would mean much to this section. They are a fine lot, those folks in the Pinetops section, and the Greenville Merchants Association and others interested in Greenville should make every effort to help these folks get this road to Greenville. A highway between this city and Pinetops would not only prove a great convenience to the people of the Pinetops section but would prove of great benefit to this city, from a business standpoint. We believe the suggestion from Pinetops is a good one for making a "Bigger and Better Greenville," and we urge our local business men to lend all the aid possible to a movement for the establishment of such a road.

SOMETHING TO THINK ABOUT "We begin this year of enlightenment with more laws to prevent crime than ever before in history, and more people breaking them," said Warden Lewis E. Lawes of Sing Sing penitentiary in a recent address before the New York Welfare Council.

"Such a condition should make all right-minded people pause and think. "There are now in prisons throughout the United States approximately 125,000 men, equal to the number of men in our country's standing army. More than 15,000,000 have been arrested and more than 5,000,000 have served jail terms. Crime is, therefore, quite general, but its solution is hampered by an antiquated system. Society brings only a small number of violators before the courts and but a small percentage, the 'small fry,' are convicted, and it must be borne in mind that certainty and celerity of arrest and punishment are outside of prevention, the most effective deterrents. "The remedy lies not in hysteria or an occasionally aroused popular resentment which at best is only temporary, but in clear-headed public opinion based on intelligent and sound reasoning, which will do much toward minimizing crime. "We can wipe out much loss and achieve splendid results through organized cooperation."

What Mr. Lawes says is substantiated by almost every criminologist and authority on crime. We do not need more laws but fewer laws, quicker and surer punishment for the transgressor, sound social education and less sentiment and more scientific understanding of the problem. Only by these means can society emerge victorious from the interminable battle with the criminal.

It is a harbinger of springtime, and all of us like the first days of this season of the year."

# ROCKY MOUNT CONFIDENT OF PLAYING BALL

While definite action had not been completed, Rocky Mount people today were confident they would be represented in the Eastern Carolina League when the circuit begins playing ball the latter part of this month.

At least this is the gist of a statement made by a member of the editorial staff of the Rocky Mount Telegram this afternoon, in reply to a query from the Reflector regarding the baseball outlook for that city.

A state of uncertainty has existed in the railroad town ever since the head of the club informed President Bramham that the city would be unable to take part in the league this season because of financial stringency. Two or three times the report gained circulation that the situation had been settled in a favorable way, but this was contradicted at later dates.

Just what way the city is planning to pour oil on the present disturbed state of affairs is not known but it is generally presumed that they are anticipating the taking over of the club by financial interest in other sections, with considerable local support. The conversation with the Rocky Mount news, however, indicated that something definite would be forthcoming within the next several hours.

In the meantime, the other five clubs of the circuit will continue daily workouts in preparation for the grueling test to come with the opening of the season April 19th. Spring practice has been continuing in all towns except Rocky Mount for the last several days, and numbers have reached the exhibition game schedule.

## Pyle Meets With Lots Of Trouble

Trenton, N. J., April 2.—(AP)—Despite his confident predictions of success, Charles C. Pyle, impresario of the trans-continental bunion derby, has found this year's race is not a bed of roses either for him or for the runners.

The grief started at the end of the second day when the Caravan of bunioners and its accompanying tent show reached here. First Trenton authorities notified Pyle that his show, counted on to bring most of the revenue for the affair, would not be permitted to give its performance. The promoter met this difficulty by moving the camp across the Delaware river to Morrisville, Pa.

Next Pyle was met by a writ of attachment which cost him, temporarily at least, possession of two of the bright red automobiles of his caravan. The writ was sued out by the Thomas Deming Company, which supplied with 1,000 chairs for the show; the amount was \$800. The company claimed Pyle did not have sufficient funds in the bank to pay for the chairs. The promoter retorted that the funds were there but the chairs were unsatisfactory and he had stopped payment on the check.

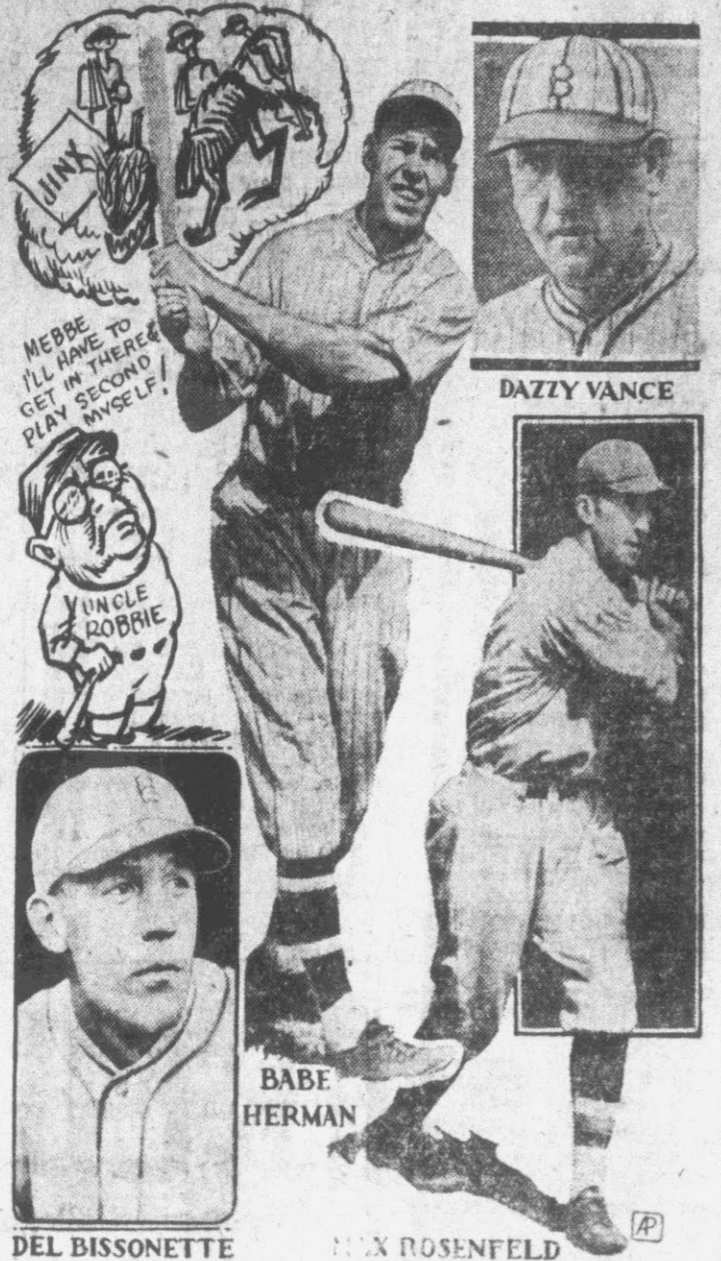

## STOCK MARKET

New York, April 2.—(AP)—Speculative confidence in the stock market appeared to have been restored today when fresh buying operations developed in the oil, public utility and steel shares. Call money returned to 12 per cent but was expected to work lower as the April 1 dividend and interest checks returned to the banks. The recent gyrations in money rates and the controversy that has developed therefrom, has had a restrictive effect on speculative operations, trading showing a further marked reaction in volume.

There were several developments in the day's business news that had a cheerful effect on sentiment. President Grace of the Bethlehem Steel Corporation, told stockholders that operations of the corporation were practically at capacity, and that the outlook for the industry was excellent. Private advices from Tulsa indicated a sharp drop in crude oil production. Francis H. Brownell, vice-president of the American Smelting & Refining Co., told stockholders that earnings in the first two months of the year were at the rate of \$9.65 a share annually as a result of the high price of copper.

Credit conditions continue tight. Time money was quoted as high as 9 per cent for the shorter maturities. Wall street derived considerable comfort from the statement of Chairman McFadden of the House banking and currency committee, that no remedial legislation was needed to correct the evils of stock speculation, and his advice to the Federal Reserve Board to leave Wall street alone and let it boil over itself rather than do things which, if continued, will put at risk the general prosperity of the country.

Reports from the Treasury Department that income tax collections will provide a surplus of \$100,000,000 or over at the end of the fiscal year also were well received.

Rumors were in circulation in Wall street today that the Outten, Fisher and other large financial interests, previously identified with the leadership of the "bull" movement, had liquidated freely of their speculative holdings. The action of today's market, however, disclosed little evidence of any extensive liquidation.

Commercial solvent ran up 1 1/4 points and Old Kentucky Curries, Incoze Cananea Copper, Gateway Steels, A. M. Byers, Electric Auto-Lite, St. Joseph Lead, Johns-Manville, Lumber, American Telephone, Montgomery Ward, National Cash Register and Commercial Credit all sold 4 to 8 1/2 points higher. Bethlehem, Vanadium and Republic, all up 3 points or more, led the advance in the steel shares. Superior Steel moved into new high ground.

Norfolk, Va., April 2.—(AP)—Fire at the Hampton Roads naval training station early today destroyed three of the old frame buildings of war-time construction and badly damaged two others before the flames were brought under control, doing a damage estimated at \$100,000.

The old frame structures, of highly inflammable material, burned like tinder and the fire had a strong start before discovery. To this, momentum for the flames was added by a brisk southerly wind.

Greenville, S. C., April 2.—(AP)—C. M. Welch of Asheville, was charged with murder in a warrant taken out here today by Sheriff Cliff R. Bramlett of Greenville county, in connection with the automobile wreck on the Buncombe road early this morning in which Mrs. Lee Walton of Pignal, or Toccoa, Ga., was killed.

The accident, which happened at about mid-night, occurred about half a mile in Greenville county, N. C., hospital, said yesterday that he remembered dozing at the steering wheel of his car and the next thing he knew the car was creeping down an embankment.

Edith Walton, little daughter of the woman who was killed, was uninjured in the wreck and escaped from the machine to summon aid.

was already nearing the tops of its levees.

Patrolmen were called back to duty as the water rose rapidly last night. A stage of 19.5 feet was recorded on the Quincy, Ill., gauge and government forecasters predicted the water would go over the 20-foot mark by tonight.

Much apprehension was apparent along the lowlands, where the residents had just completed a long siege with spring flood waters. The levees, weakened by the pressure of more than a week of the highest water in 25 years, were considered in bad shape to withstand another rise.

High winds lashed the southern end of Lake Michigan into the worst storm in years. At St. Joseph, Mich., the waves pounded the waterworks so hard that there was danger of destruction, while the city's water supply was interrupted. Summer homes along the beaches were seriously menaced.

Scores of cottages of Long Beach, a resort near Michigan City, Ind., were in danger of being washed away and parts of the city pier had already been destroyed. Trees and sea walls had also gone out.

Property damage in Chicago alone was estimated at \$1,000,000. The waves swept over the outer drive in Lincoln Park and made it necessary to close that thoroughfare. It was feared that parts of the drive might be washed away as the lake kept up its assault early today.

three more planes with bombs would be sent out today.

Information, purported to have been intercepted from federal telegraph wires, to the effect that Coquila, Ameca, and Zacualco, in the State of Jalisco had been occupied by rebel troops, was revealed at rebel headquarters.

Until General Escobar can take enough time from his machine gun to do a bit of typing, the extent of the rebel casualties in the battle of Jimenez will not be known. Reports here have placed the number of federal dead in the hundreds and made light of the rebel casualties. From Mexico City, however, has come the federal statement that the rebel death list was in hundreds, and the federals had only a few men killed.
