FORTY THREE PERSONS DIE IN TORNADO

Swifton Territory Of Arkansas Wiped Out By Terrific Wind Storm

Rescue Workers Busy Today Caring For Hundred or More Injured When Twister Sweeps Through Communities in Northern Part of State; Houses Carried Long Distance; One House Dropped Into Creek With Three Dead.

Little Rock, Ark., April 11.—(AP)—With some of the more inaccessible parts still not reached by rescue workers who centered their attention on caring for the many injured the casualty list from yesterday's tornado in North Arkansas stood at noon today at 43 known dead, probably more than a hundred injured and property damage that cannot be estimated.

The bodies were being placed in temporary morgues at Swifton, nearest the storm center and other nearby towns while the injured were being taken by the dozens to hospitals at Newport and to private homes where emergency treatment was given.

The rescue workers who struggled under the light of automobile headlights during the night to recover the dead and injured fully expected to find many more under the debris in the isolated farm settlements and homes which bad roads made it difficult to reach. A wide area of almost complete waste was left by the tornado in the Swifton section, where the greatest damage resulted. Houses were carried for long distances and in one instance one was dropped in the middle of a creek with 3 of a family of five dead.

The known dead were listed as follows:
24 in Swifton area, 8 near Parkin, 3 at Guilford, 6 at Lorado and two at Wynne, where two children also were missing.

The number of injured was so great that no accurate estimates could be obtained.

The list of dead included the following:

Riley, mother-in-law of Mrs. Ed Riley; Howard Willis, 6; Mr. and Mrs. Cleo Nicholson; Mrs. A. J. Rowlett; John Loy; Mrs. Russell Long and daughter Viney, 17, and L. E. Hugdens.

At Guilford: Miss Thelma Pierce, 30; Miss Thana Tilton, Claude Campbell and mother and child.
The missing list included two children of Charles Defries at Swifton, Jack and Ruth Defries; and a son of T. C. Bullard.

At the village of Lorado, ten miles North of Jonesboro six persons were killed.
Henry Lowthan, his wife and three children met death in the collapse of their home and Tom Adams was killed when his home was destroyed.

The Baptist and Methodist churches and the school house were leveled.

Five persons were injured North of Bono, but none fatally.

Lindbergh Bound For Washington

DR. ANDERSON AGAIN FACES LEGAL ACTION

Raleigh, April 11.—(AP)—Dr. Albert Anderson, 59 year old superintendent of the State hospital for the insane here, today was faced with the prospect of more legal difficulties.

B. B. Benson, former of the Wake county grand jury, let it be known that witnesses had been called in an investigation of reports that the hospital superintendent had illegally disposed of medical whiskey.

The late Ben R. Lacy, State Treasurer who died early this year, was named as a private patient to whom Dr. Anderson was alleged to have given liquor in violation of the Turlington act, the State enforcement law.

This investigation by the Grand jury followed closely upon the heels of Dr. Anderson's victory in the Supreme Court which recently exonerated him of two charges of working patients unlawfully, on which he was convicted by a Wake County jury last fall.

Thousands Attend Commencement Day Of Colored People

Several thousand colored people from all sections of the county attended annual commencement day exercises at the fair grounds in this city today. The occasion has been one of the outstanding events of the year for many years and the various schools vie with one another in an effort to carry off honors of the day.

Exercises got under way shortly after 11 o'clock this morning with a mammoth parade of school children. The pageant covered several blocks and was led by a high school band. Each of these schools was designated by a banner bearing its name. Every department of the county school system participated.

The Greenville schools brought up the rear of the parade. In the center of the marchers could be seen the figure of that leader of colored educators, C. M. Epps, carefully marking time for the parade. Commencement day has always held special significance for Epps, and today was no exception. He watched the several hundred marchers with pride, happy in the progress which education is making among the people of his race.

The exercises will be brought to a conclusion late this afternoon with a number of field day events. Many of the schools will compete for honors, and as always, despite overcast skies, thousands will throng the fair grounds to be in attendance.

LIQUOR SOLD ABOARD U. S. STEAMSHIPS

Leviathan Bound For Europe Today With Liquor For Sale To Its Passengers.

New York, April 11.—(AP)—The Leviathan, queen of the American Merchant Marine and for six years a prohibition ship, was enroute to Europe today with liquor for sale.

The liner was making her maiden voyage under private American ownership as the flagship of the newly organized United States Lines, Inc., and the medical liquor stores were available for beverage purposes. On the return trip and future voyages a less limited supply than that contained in the medical stores will be for sale. The liner will stock up abroad.

Joseph E. Sheedy, executive vice president of the line, said there would be no public bar in the ship but that liquors and wines would be served to passengers in their cabins and in the dining rooms and smoking rooms. Drinks will be served at meals. It will be unnecessary to purchase whole bottles.

The same policy, Sheedy said, would be put into effect aboard the other ten ships which Paul W. Chapman recently purchased from the United States Shipping Board and which will make up the United States Lines fleet.

Sheedy said the company sought no direct financial gain from the sale of liquor but deemed it necessary to offer it for sale to put the American owned vessels on an equal footing with foreign transatlantic liners.

Under the law ships are permitted to carry one quart of liquor for each five passengers and members of the crew for medical purposes. This would give the Leviathan an allowance of 700 quarts on this voyage to Europe.

For the westward trip the ship's officers were instructed to take aboard a supply of liquor sufficient to last to the twelve mile limit. There all over the medical allowance would be thrown overboard. Sheedy said he had obtained legal advice that no law would be violated by the arrangement he had ordered.

Senator Wesley L. Jones, sponsor of the Jones act, said in his opinion the line was "making a mistake" in permitting the sale of liquor.

"They oughtn't to do it," he added. "I don't know how far the law can go to stop it, but it ought to go as far as it can. An American ship is American territory. There are many people who will decline to travel on it, I am sure. If this goes into effect law-abiding citizens of various parts of the country."

Orville S. Poland, New York State counsel of the Anti-Saloon League, also predicted the United States Lines would lose business.

He also expressed the opinion the owners were transgressing the spirit of the eighteenth amendment. He said that while to the best of his knowledge the line was within the law in the sale of liquor he warned that in event an error was discovered in the decision pertaining to such sales the Anti-Saloon League would re-open the question in order to test the validity and strength of the ruling.

Boris May Have To Take Duchess For His Bride

Sofia, Bulgaria, April 11.—(AP)—Youthful King Boris, who seems bent on marrying, may have to take a grand duchess for a bride instead of a princess.

Religious obstacles today seemed destined to prevent his proposed wedding with Princess Giovanna of Italy and talk arose of a possible alliance with the Grand Duchess Kira Vladimirovitch, 19-year-old daughter of Grand Duke Cyril, recognized as head of the Romanoff family by many Russian Royalists.

Owing to the great volume of work ahead, it will be impossible for the judges to complete their work before Saturday, and the Secretary of the Association said that no information would be given out prior to the publication of the list of winners Saturday afternoon.

Much interest has been manifested in the contest the last several days and the Merchant's Association has literally been swamped with incoming mail. Many of the essays are said to be of outstanding merit and offer splendid suggestions for improvements of the city.

Prizes range all the way from \$1.00 and \$10.00. No single contestant will receive more than the latter amount. The prizes were arranged so that every school child of the city might have an opportunity of becoming a participant.

Members of the association expressed gratification at the interest manifested by students of the various schools, and like the children, are looking forward to the decision of the judges with more than ordinary interest. Other attractions were the annual dinner of the Chamber of Commerce which was served in the basement of the Methodist church by ladies of the church. Miss Myrtle Hebard, Blue's singers, Force and Andre, famous dancers, Bob Dale, comedian from New York, Roberta Lee Wynne, youthful dancer of Raleigh, and Jasper, the \$25,000 male dog, will be numbered among other attractions of the day.

Three outstanding features held the attention of hundreds of people thronging the exposition buildings yesterday. They were the annual fashion show and the presentation of junior queens. Complete Plans For Exposition At Capital City

Raleigh, April 11.—(AP)—T. B. Smith, Secretary-Manager of the State fair and the North Carolina Industrial Exposition, announced today that plans for the first State-wide Industrial Exposition to be held at the fair grounds here the week of May 13 have been completed except for minor details.

The object of this exposition, Mr. Smith said, is to give manufacturers an opportunity to show their products and at the same time to help intelligently to mirror North Carolina's industrial progress and its diversified activities. Manufacturers throughout the State will be asked to place exhibits of their products on display.

In addition to industrial displays there will be high class music with entertainment and amusement features both day and night, the manager stated. He explained that the principal distinction between the exposition and the State fair will be the fact that the former will feature industry while the fair will stress agriculture.

At the request of Governor Gardner, the Council of State has given officials of the State Fair funds for repair of the grounds and buildings.

PLOT TO KILL FEDERAL ARMY LEADER FAILS

Mexico City, April 11.—(AP)—The chief of the military garrison here today disclosed that an unsuccessful attempt had been made to bomb the special train of General Calles and assassinate him in the State of Jalisco a few days ago.

A man and a woman, the principal conspirators, are being sought and should be arrested soon, the garrison commander said, while certain residents of Torreón, Coahuila, were implicated and will be arrested also.

The plot was made with the cognizance of the rebel Generals Escobar, Manzo, Cruz, and Caraveo who sent a man named Santiago Perez and an unnamed woman to Mexico City to secure explosives which were to be sent insurgents in Jalisco who were to arrange the dynamiting of the train.

The plan was, the garrison commander said, to mine the rails at a point in Jalisco over which the former Mexican President must pass as he traveled from Chihuahua to Masatlan on the West Coast a few days ago, and blow up his train. A well organized force was to be prepared to attack him and will him in the ensuing melee if he should escape death in the blast.

Perez obtained the explosives but was unable to get them out of Mexico City. Military authorities here found them, with letters revealing the plot in his room here, and barely missed taking him and his companion. The two were said to have escaped on a train leaving the Colonia station last night.

China Grove Man Killed In Crash Of Automobiles

Salisbury, April 11.—(AP)—W. F. Walker, 57, of China Grove, was killed instantly early today in a collision between two automobiles at North Kannapolis, 14 miles from here, according to information received here.

Walker, who was riding in the back seat of a car driven by Sam Upright, also of China Grove, was killed when he was thrown from the car as it crashed with a machine driven by L. B. Laughlin of Concord. His head struck the door of the laughing machine and he died at once.

Upright was seriously injured and was rushed to a hospital here where it was said there was concern felt for his recovery.

Laughlin was uninjured except for a hurt finger.

Walker, who is survived by his widow, three children, five brothers and two sisters, was a gate keeper at the Vannon mills in Kannapolis and was on his way to work when the accident occurred.

MILL STRIKE CONTINUES IN THIS STATE

Employees of Textile Mill Idle Following Indefinite Suspension Last Night.

Pineville, N. C., April 11.—(AP)—All employees of the Chadwick-Hookins Mill No. 5 here, were idle today after the closing of the mill last night "for an indefinite period" following a strike which started Monday.

The closing of the mill last night was ordered by B. B. Gossett, president, upon recommendation of Sheriff John R. Irwin. The order followed closely upon a near-serious affair when strikers and a worker drew pistols and bloodshed was threatened.

Prompt action by Chief of Police Windell averted trouble, however. William Sroka, of New York, a member of the executive body of the National Textile Workers Union and one of the organizers of the Pineville strike, said today: "We're going to stay out until we get what we want," and comment of strikers gathered round strike headquarters expressed the same sentiment.

Sroka said that a meeting of the strike committee of ten, headed by Jess Smith, was held this morning behind closed doors. A mass meeting of the strikers is held daily at 3 o'clock in the afternoon. The demands on the Chadwick-Hookins company are approximately the same as those made by striking employees of the Lora mill of the Manville-Jencks Company at Gastonia, Sroka asserted.

The strikers today claimed that of the 175 employees in the mill here over 135 persons are members of the union local, which has been secretly in existence for more than six months, according to M. W. Lawler, assistant secretary-organizer of the local.

Lexington, April 11.—(AP)—Strikers at the Dennonham cotton mill remained idle today in continuance of the strike against a proposed wage cut and for recognition of the National Textile Workers Union.

Charles G. Wood, conciliator of the Department of Labor, held conferences here last night but left the city without making an announcement as to probable results.

No steps, as far as could be learned from mill officials, had been taken today to make formal reply to the demands made yesterday by a strikers' committee after Fred Kravin Beal, organizer for the National Textile Workers Union, had made a talk to the strikers.

The demands were: That the old scale of wages for weavers, loom fixers, carders and slanders be restored; that spinners and doffers receive a 50 per cent increase in wages; and that all speeding and doubling up of work be abolished.

Wake Voters Must Register in Person

Raleigh, April 11.—(AP)—Complaints that voters were being illegally registered for the approaching city election in Raleigh had resulted in a court order against the present commissioners and all registrars, forbidding the registration of any citizen not appearing in person.

Judge Midyette, presiding in Wake Superior Court, issued the order upon the petition of three citizens, George M. Glenn, R. C. White, and J. L. Perkins.

It was alleged by the plaintiffs that the present city commissioners, all candidates for re-election, were using the city employees to put names of voters on the books in violation of law, and that the employees were threatening with loss of their jobs for failure to register their quota.

A hearing will be held April 16 to determine whether the order shall be made permanent.

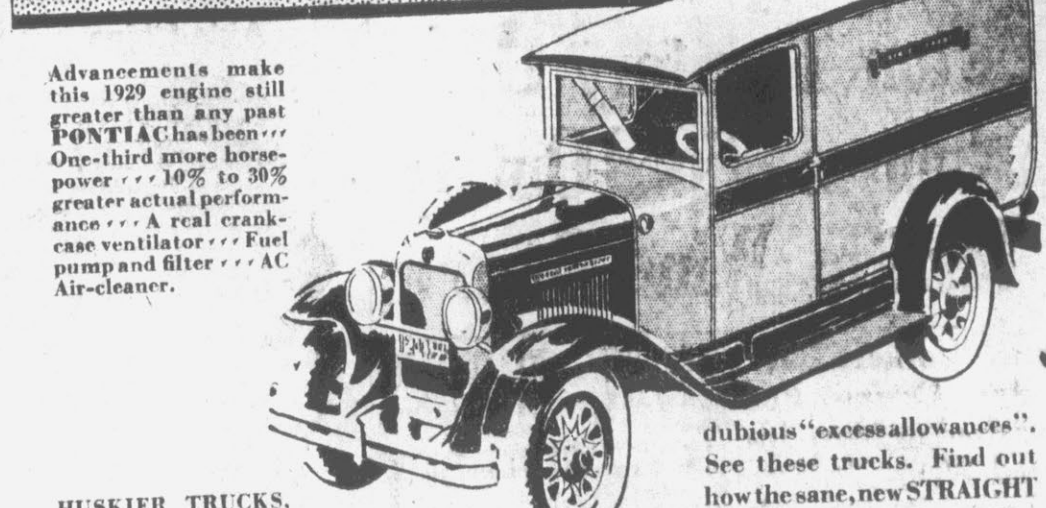

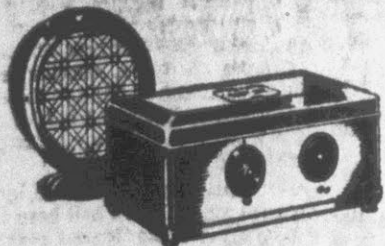

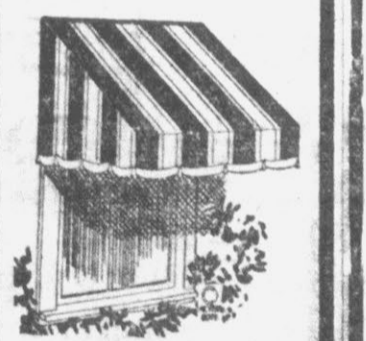

New York, April 11.—(AP)—Cotton opened steady at a decline of 1 to 13 points, with active months selling about 10 to 13 points net lower in the early trading under liquidation. There was also some local and southern selling promoted by a favorable weather map and easier Liverpool cables.

A private report estimating domestic consumption for March at 626,000 bales compared with 598,000 for February, appeared to be somewhat under expectations and might have figured in the early decline, but the volume of offerings tapered off somewhat around 19:37 for July and prices showed rallies of a few points from the lowest at the end of the first half hour.

Private cables said there had been London and local selling in Liverpool on the better weather from the South and that the turnover in cloth and yarn was unimportant with stocks accumulating.

STOCK MARKET

New York, April 11.—(AP)—Quiet accumulation of stocks continued today in anticipation of a substantial decrease in Federal Reserve brokers' loans, and a gradual easing of credit conditions.

Some new soft spots were uncovered by "bear" traders and this had a tendency to restrict bullish operations on the theory that the further development of such "air pockets" would have an unsettling effect on the general list.

Call money renewed at 9 per cent. But the supply of funds was ample, and loans were arranged as low as 8 per cent in the "outside market." There was no change in time money. Wall street expects that the peak of the spring commercial demands will be passed in a week or two and then money rates will work lower, barring a resumption of wild speculation for the advance.

Business conditions, judged by the character of the most recent earnings reports, continues favorable. The Atlantic Refining Company announced an increase in gasoline prices in its territory today, and similar advances are expected in other sections as gasoline consumption enters the period of seasonal expansion. Oil shares failed to follow up their early advance.

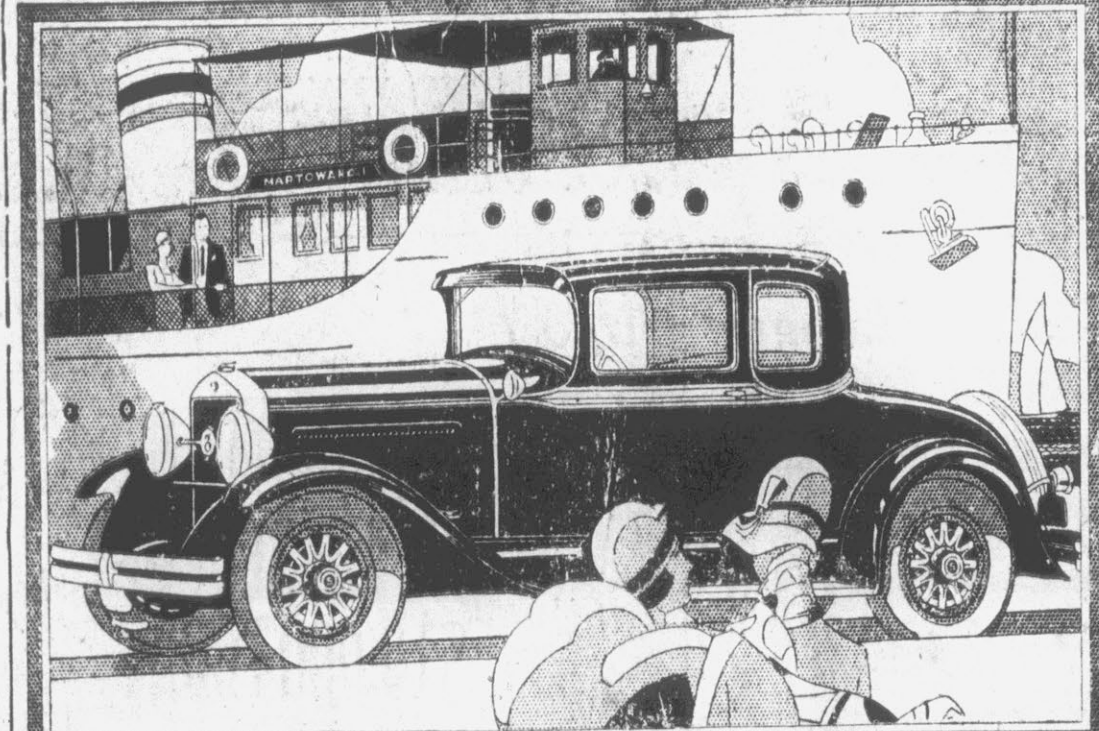
