## PROHIBIT ANY STRIKE PARADE AT GASTONIA

### City Officials Take Steps to Prevent Disorders Among Textile Workers.

Gastonia, April 20.—(AP)—While  
county and city authorities contin-  
ued a quiet investigation of the  
destruction of headquarters of the  
National Textile Workers Union  
here early Thursday, city officials  
today took steps to prevent possi-  
ble disorder by enforcing a new or-  
dinance forbidding parades without  
a permit. Strikers from the Lora-  
y cotton mill had planned a parade  
for this afternoon.

The city council in session last  
night adopted an ordinance carry-  
ing an emergency clause requiring  
written permission of the city man-  
ager before any street parade could  
be held. A certified copy of the  
ordinance was delivered to the sec-  
retary of the local union today and  
up to noon no request had been re-  
ceived for permission to conduct  
the parade. Harry Rutter, acting  
city manager said he had received  
no request for a permit and de-  
clined to say what his action  
would be were such a request made.

Today was the last of the third  
week of the strike at the Lora-  
y mill, one of the Manville-Jencks  
company, of Pawtucket, R. I. Since  
Thursday morning when a band of  
masked men invaded union head-  
quarters, just off the mill company's  
property, demolished the building  
and then wrecked the relief store  
operated by an auxiliary of the  
National union, the Lora-  
y and surrounding territory have been  
quiet. A small parade consisting  
largely of women and children was  
held yesterday afternoon but did  
not attempt to leave the mill vil-  
lage.

Reports of settlement of the  
strike at the Pinkney mill in South  
Gastonia could not be verified. The  
report was given out at temporary  
headquarters in the Worker's Inter-  
national relief store but officials of  
the company operating the mill re-  
fused to talk. The strikers asserted  
that the settlement had been on a  
compromise basis with a small in-  
crease in pay and no transfer of  
one foreman to another job. All  
strikers except four were reemploy-  
ed, these being denied employment  
because of statements they are al-  
leged to have made while the strike  
was in progress.

Civil authorities declined to com-  
ment on the investigation being  
made into the incidents of Thurs-  
day morning. Beyond saying they  
were "under way" nothing in the  
way of comment was forthcoming.

### Probe Death Of New York Lawyer

Philadelphia, April 20.—(AP)—A  
statement credited to David Stein-  
hardt, fugitive New York lawyer,  
that friends advised him to com-  
mit suicide increased interest in  
today's inquest into his death.

Facing prosecution for embezzle-  
ment of \$500,000 in bankruptcy  
case he drank poison yesterday while  
his wife and his attorney, Herman  
L. Maris, of this city, sat in an  
adjoining room at a hotel and as  
assistant United States attorney  
George Minter, of New York, was  
on, his way from the railroad sta-  
tion to take him into custody.

Steinhardt, a trustee and receiv-  
er in bankruptcy had consented  
to surrender. Several letters were  
found in his pockets and in one  
of them, addressed to his wife, he  
declared that suicide was the only  
alternative. A few days ago he  
told Maris that friends had ad-  
vised him that suicide was the only  
way out of his difficulties.

## Make Record Flight From Washington To City of Havana, Cuba

Washington, April 20.—(AP)—  
A flight from Washington to  
Cuba in what is believed to be  
a record time has been made  
by Captain Walter F. Kraus and  
Lieut. John E. Upson, of the  
staff of the chief of air corps.  
The two officers, engaged in  
a routine inspection of the air  
corps mission at Havana, left  
Washington at 4:15 a. m. on  
Thursday. They stopped at  
Charleston, S. C., at 8:36 a. m.,  
left there at 9:25, arriving at  
Miami at 2:10 p. m. They left  
the Florida city at 3:25 and ar-  
rived at Havana at 5:45 p. m.  
Their elapsed time was 13 1-2  
hours, but their flying time was  
less than 12 hours.

## REPARATIONS CONFERENCE NEAR ROCKS

### Efforts to Revive De- liberations Looked Exceedingly Dark Today.

Paris, April 20.—(AP)—Efforts to  
revive the almost dead reparations  
conference looked exceedingly dark  
today.

The conference understood to  
be willing to increase their repara-  
tions offer slightly, but they were  
frank to intimate that they saw no  
real hope of the present conference  
reaching an accord.

Dr. Hjalmar Cehacht, leader of  
the German delegation, has been  
talking with Owen D. Young and  
the Allied delegates at informal con-  
ferences on the situation. At the  
same time exploring the possibility  
of a ten year agreement. He ap-  
peared at the Hotel George V this  
morning and went into conference  
with Mr. Young, Thomas W. Lamont  
and two other reparations experts.  
He looked very grave and tired.  
The world-wide blame upon the  
Germans for wrecking the confer-  
ence, as reported in the press, or  
the Berlin cabinet's reported disap-  
approval today seemed to have soft-  
ened the German firmness. The de-  
legation, however, still asserted that  
it was composed of "independent ex-  
perts." They were neither taking  
nor asking the cabinet's instructions,  
they said, and were seeking only  
solutions which they, as experts and  
as Germans, could approve.

## Three American Women Hailed As Heroines Of Mexican Fight In Sonora

Tucson, Ariz., April 20.—(AP)—  
Three American women were hailed  
today as the heroines of the battle  
of Sasabe (Mesquite) Sonora, in  
which about 20 Mexican rebels were  
killed and wounded in an unsuccess-  
ful attempt to repulse an attack  
by 195 federal soldiers.

The women, Mrs. Arthur Hard-  
grave, wife of the former President  
of the Kansas City Chamber of  
Commerce; Mrs. A. Hardy, wife of  
a San Fernando, Ariz., physician,  
and Mrs. James H. Jones, a guest of  
Mrs. Hardy's, crossed the border into  
Sasabe after the battle yesterday  
and attended and cheered the  
wounded fighters.

Eighteen of the rebels, command-  
ed by Lieutenant Encarnacion Rojas,  
fled to American soil to escape cap-  
ture by the federals and were held  
for internment. The rebels said be-  
tween 30 and 40 of their comrades  
had been taken prisoners by the  
loyal troops.

## Slain Missionary



Rev. Herbert K. Shitt, Seventh  
Day Adventist missionary, was  
killed by brigands in southeast  
Indiana. He was born near  
Greenville, Ind. His wife, formerly  
Mrs. Thelma Chew of Anderson,  
Ind., and 8-month-old son, are in  
Indiana.

## Lutheran Church Considers Work In Florida Area

Columbia, S. C., April 20.—(AP)—  
One of the most important ques-  
tions to come before the Board of  
the American Missions of the United  
Lutheran Church of America, in  
session here today is the amount  
of aid the Lutheran church will  
give in rehabilitation of its church  
work in Florida. The sessions, which  
have been in session since Thurs-  
day ended today.

Various visiting ministers and  
laymen will preach in South Car-  
olina and neighboring North Carolina  
churches Sunday.

The linguistic work committee  
discussed last night many problems  
regarding German work in Mani-  
toba and Ontario, Canada, and  
in the United States. Satisfactory ad-  
justments were recommended by the  
committee and were presented to  
the board today. Italian work in  
Philadelphia, Erie, Pa., and Chic-  
ago, also was discussed. Permission  
of the committee was given to the  
Rev. Dan Bravin of Baltimore to  
transfer his work in relation to  
Jews to Pittsburgh.

## Believes In Economy

Washington, April 20.—(AP)—  
Postmaster General Brown and Mrs.  
Brown are in complete agreement  
on economy in the postoffice de-  
partment.

The Postmaster General has a  
habit of pocketing every pencil he  
gets his hands on. Mrs. Brown  
does them up in neat bundles and  
every few days personally brings  
them back to the department and  
leaves them with her husband's  
secretary who puts them back into  
use. The postmaster general's  
never told anything about it.

## Mystery Plane Reported Off Scotch Coast

London, April 20.—(AP)—A  
British Trawler fishing about 250  
miles West of the outer Hebrides,  
or 300 miles West of the Western  
Scotch Coast, reported an air-  
plane passed over it early today,  
flying Eastward.

The radio message was re-  
ceived by the Mullin head station  
in Ireland from the Trawler  
Shackelford at 8:23 a. m. (3:23 E.  
S. T.) it said "airplane bound  
Eastward here this morning  
at five o'clock. Position is 58.10  
North and 12.20 West."

There was no knowledge here  
of any trans-Atlantic flight in  
progress and the public was left  
guessing what the plane might  
be doing so far out in the Atlan-  
tic as to be beyond the limit to  
any ordinary trial flight.

At the air ministry it was  
stated: "We have no knowledge  
of any flight over the Atlantic.  
Neither have we received any  
news."

## PRINCE HENRY OF PRUSSIA PASSES AWAY

### Brother Of Former Kaiser of Germany Victim of Attack of Pneumonia.

Henfelmark, Germany April 20  
—(AP)—Prince Henry of Prussia,  
brother of the former Kaiser, died  
here today of pneumonia.

Prince Henry, who was widely  
known in the United States for his  
visit there in 1902 to attend the  
launching and christening of his  
brother's yacht "Meteor" at Jersey  
City, was 66 years old and had been  
in poor health for several years.

Prince Henry, who was the former  
Kaiser's only brother, had been  
suffering from laryngeal trouble for  
some months. He developed pneu-  
monia three days ago and died at  
1:30 o'clock this afternoon.

At his bedside were his wife,  
Princess Irene and his son Walde-  
mar and the latter's wife. His sec-  
ond son, Prince Sigismund, is now  
in Costa Rica.

The Associated Press was inform-  
ed by a trustworthy source early  
this year that Prince Henry was  
suffering with the same malady  
with which his father, the late  
Emperor Frederick III was stricken,  
empower of the larynx. The illness  
was reported to be in an advanced  
stage.

## RECREATION NIGHT HELD BY KIWANIS

### M. L. Wright Delivers Interesting Talk On Value of Leisure Moments.

Last night was "Recreation  
night" with the Greenville Kiwanis  
club and members of the organiza-  
tion were provided with a splendid  
program by M. L. Wright, head of  
the publicity department of Eastern  
Carolina Teachers College. Presi-  
dent Ralph Deal presided.

Besides an interesting talk dealing  
with the value of recreation which  
he delivered himself, Mr. Wright  
presented a quartet of young women  
from the Eastern Carolina  
Teachers College, who sang their  
way into the hearts of the  
Kiwanians. The first number was  
"Mighty Lak A Rose", by the late  
Frank L. Stanton, one of the most  
beloved of Southern poets. This was  
renewed in particularly good style  
and acted like a narcotic upon the  
jumpy nerves of the tired business  
and professional men. The singers  
were Missa Radcliffe, Winstead,  
Powell and Porter.

They were accompanied at the  
piano by Miss Edna Smith.

In enumerating the advantages  
of recreation, Mr. Wright carried  
his hearers back to the day of  
Adam and Eve for the starting point.  
He said their leisure moments were  
not spent profitably and this led  
to their partaking of the forbidden  
fruit. He came on further down  
the line of history mentioning such  
characters as Cleopatra, the em-  
press of the Nile. Her tragic end  
was attributed to misspent moments  
of leisure, and this, he said, was  
likewise true of the several promi-  
nent figures of history of her day  
with whom she came in contact.

The greatest problem of the pres-  
ent day, he declared, is embraced  
in the eight hours of leisure of the  
average American citizen. Occupa-  
tion of the remaining hours has  
a tendency of keeping everybody  
out of trouble, but the danger comes  
in the hours allotted to everybody  
for rest and recreation.

He advocated a playground for  
Greenville as one of the most ef-  
fective means of providing wholesome  
recreation for young people of to-  
day—the men and women of to-  
morrow. He said the playground  
should have adequate supervision,  
directed by persons who understand  
it, know how to use it to the ad-  
vantage of others.

He declared he would be glad to  
see the Kiwanis club sponsor a  
movement looking to the establish-  
ment of a public playground where  
the youth of the city might find  
sufficient amusement to occupy  
their spare moments and keep them  
away from the things that tend  
to drag them down, mentally mor-  
ally and spiritually. He said a  
wholesome way to play is just as  
necessary as jails and houses of cor-  
rection. He would spend more  
money to increase the value of leisure  
moments and in that way reduce the  
enormous sums spent for the things  
made necessary because of insuffi-  
cient provisions for clean and whole-  
some play.

W. L. Wadbee, judge of Pitt coun-  
ty court, was introduced to the club  
as a new member. Words of intro-  
duction were expressed by B. E.  
Sugg, who impressed the importance  
of the ideals of the organization in  
every day life. Judge Wadbee re-  
sponded in a very happy manner,  
assuring his hearers that he con-  
sidered it an honor to become a  
member of the body and of his  
every effort to live up to the club  
standards.

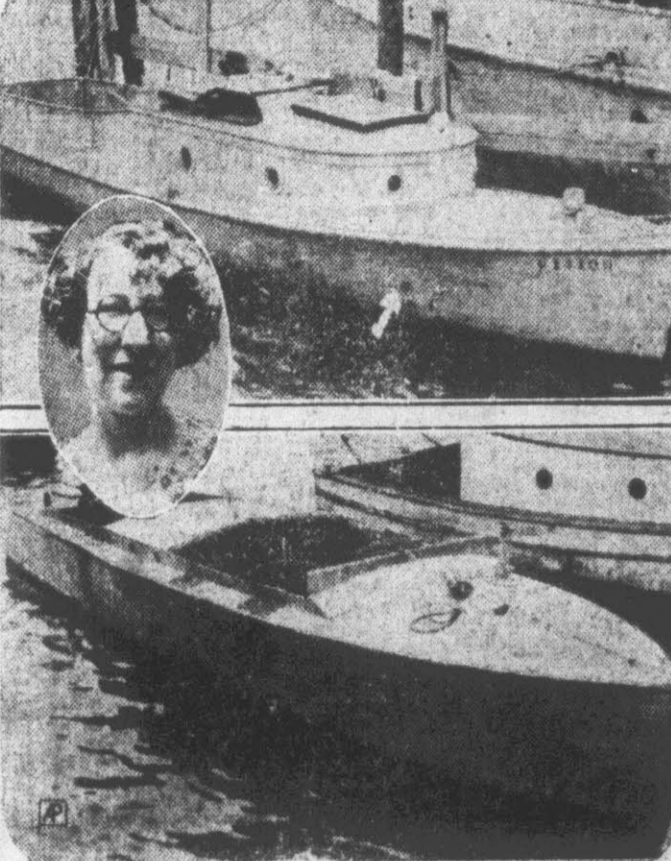
## Contract For Church To Be Let May 5th

## Soviet Receives Another Setback At Geneva Confab

Geneva, April 20.—(AP)—Maxim  
Litvinoff, Soviet vice-commissioner  
for foreign affairs, received another  
setback in the preparatory disarm-  
ament conference today and it made  
him very angry. He did not im-  
mediately fulfill expectations of  
some that he would leave the confer-  
ence, however.

## Film Concern Charged With Forming Trust

Los Angeles, April 20.—(AP)—  
Charges of independent motion pic-  
ture exhibitors that the produc-  
tion and showing of movie films was  
being controlled by a giant trust was  
being crowded little operators out of  
business, were brought into the  
open here today with the indict-  
ment of ten large producing and  
distributing companies for alleged  
conspiracy to violate the Sherman  
act.

The indictment was returned by  
a federal grand jury last night after  
it had heard the complaints of  
scores of independent motion pic-  
ture theatre operators that they  
had been driven out of the field or  
threatened with failure unless they  
submitted to the booking plans of  
the big film makers.

The officials of ten leading pro-  
ducing and distributing companies  
were named in the indictment. The  
defendant companies are West Coast  
Theatres, Inc.; Paramount-Famous-  
Lasky Corporation, Metro-Goldwyn-  
Mayer; First National Pictures, Uni-  
versal Film Exchange, United Ar-  
tists, Inc., Fox Film Corporation,  
Vitaphone, Inc., Pathe Exchange,  
Inc., and Warner Brothers.

## Decide To Incorporate Debenture Plan In Bill For Relief Of Farmers

Washington, April 20.—(AP)—  
Chairman McNary of the Senate  
Agriculture Committee, announced  
today the committee definitely had  
decided to incorporate the export  
debenture plan in the farm bill to  
be introduced Monday irrespective  
of whether President Hoover or other  
administration officials definitely  
declared against the proposal.

## GIANT LINER BRINGS OVER LIQUOR STOCK

### Leviathan Leaves Southampton With Whiskey For Sale To Passengers.

Southampton, England, April 20.  
—(AP)—The Giant Liner Leviathan  
left for New York this morning with  
a stock of liquor aboard for sale to  
passengers.

Ship's officers refused to discuss  
the quantity of liquor put aboard.  
The loading was done with the ut-  
most secrecy, officials at the pier  
refusing to give any information.  
It was learned, however, the sup-  
ply had been estimated so as to  
have little left over when the liner  
reaches the 12-mile limit where what  
is left will be thrown overboard.

The Leviathan carried 247 first  
class passengers and expected to  
pick up an equal number at Cher-  
bourg.

## MAKE EFFORT TO END STRIKE IN TENNESSEE

Elizabethtown, Tenn., April 20.—  
(AP)—Although company officials  
maintained silence, Charles G. Wood  
federal labor conciliator carried on  
today with his plan to bring about  
a settlement of the strike by 5,000  
employees of the American Bemberg  
and Glanzstoff Rayon plants.

## Probe Airplane Crash at San Diego

San Diego, Calif., April 20.—(AP)—  
An airplane crash in the air,  
which sent three naval officers and  
one enlisted man to spectacular  
deaths, was the subject of an in-  
quiry by a naval board here today.

## Charles Lloyd Under Arrest

Los Angeles, April 20.—(AP)—The  
arrest of Charles W. Lloyd, 32, who  
was wanted in Chicago in connec-  
tion with the St. Valentine's day  
massacre in which seven men were  
killed and shot to death, was dis-  
closed here early today.

Under the policy, liquor, wine,  
champagne and the like will be  
carried up to the 12-mile limit for  
private consumption of passengers.

sumed will be thrown overboard.  
When the announcement of the new  
order was made it was implied that  
on Eastward voyages passengers

Mayor Walker to  
Dictate Leader  
Of Tammany Hall

New York, April 20.—(AP)—May-  
or Walker was in a position today  
to dictate who the new leader of  
Tammany should be, as the result  
of withdrawal of Alfred E. Smith  
from conferences.

Smith, after a 20 minute confer-  
ence with the organization's com-  
mittee of seven, issued the following  
statement:

"I have been informed by the  
committee of seven that it is the  
policy of the executive committee  
is duly qualified to make that de-  
cision among themselves."

The committee of seven, composed  
of district leaders, had been ap-  
pointed to confer with the "big  
four"—Smith, Mayor Walker, Sen-  
ator Wagner and Surrogate Foley—  
on the leadership.

It was generally understood that  
Smith preferred as a successor to  
George W. O'Flaherty a representative  
of the so-called new Tammany and  
his choice was said to be Senator  
Wagner.

Withdrawal of Smith leaves dic-  
tation of the new head practically  
in the hands of Mayor Walker, who  
attained a commanding position in  
the organization by the city's vic-  
tory in maintaining a 5 cent sub-  
way fare.

Los Angeles, April 20.—(AP)—The  
arrest of Charles W. Lloyd, 32, who  
was wanted in Chicago in connec-  
tion with the St. Valentine's day  
massacre in which seven men were  
killed and shot to death, was dis-  
closed here early today.

Lloyd was held on charges of sus-  
picion of murder and violation of  
the state prohibition law. Arrested  
with him yesterday were Ben Mil-  
lrot, 29, also held on suspicion of  
murder charges, and Jack Watson,  
30, for alleged violation of the state  
dry law.

Police said Lloyd had been iden-  
tified by a photograph from Chic-  
ago as a man wanted on a federal  
warrant in connection with the St.  
Valentine's day killings. Police said  
he had a Chicago detective badge  
in his possession.

Honors King of Melody

Phinney—Abdul Kadir son of  
Turkey's late Sultan, has paid his  
respects to the man he considered  
the King of Melody. Now a mem-  
ber of an illustrious Cypriot Or-  
chestra, the ex-Prince was among the  
mourning at the funeral of En-  
riko Magyary, King of the Hun-  
garian Gypsies. Four horsemen  
with poles carried the coffin there  
with 200 bands in the procession.

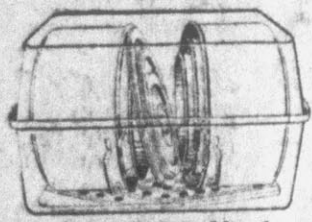
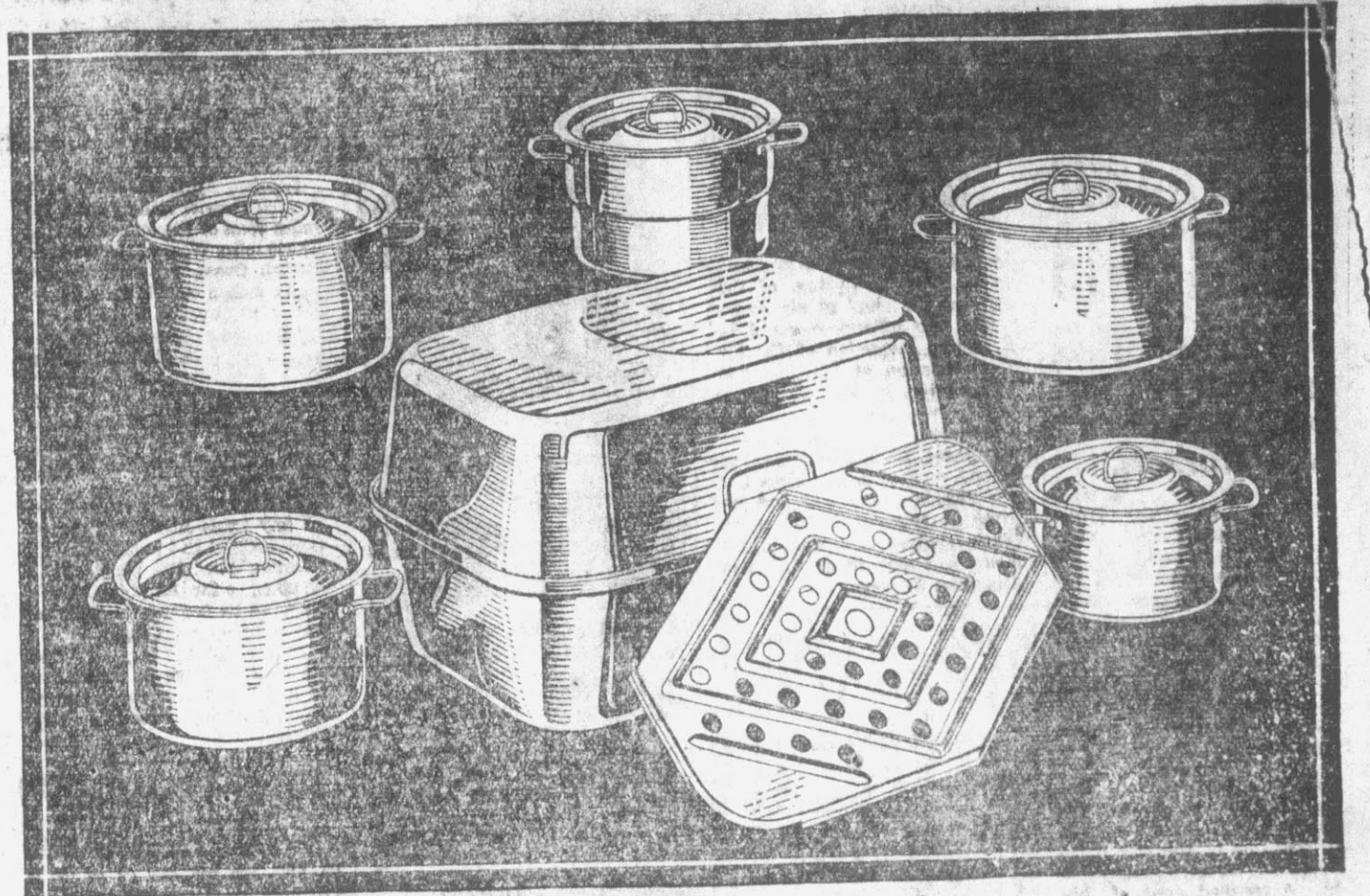

Showing how the entire set can be nested inside the large Roaster when not in use.

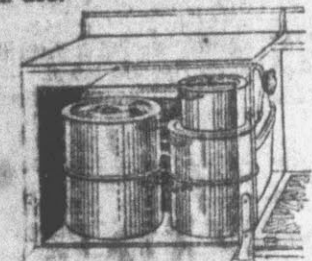
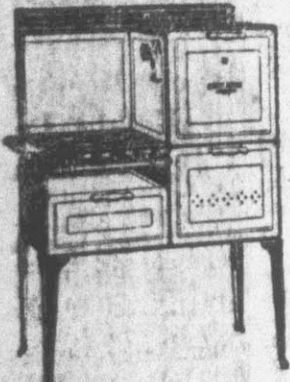

The report being circulated that a negro convict at one of the county road camps a few days ago was whipped into unconsciousness by one of the overseers is something that should have the attention of our courts. There is of course, a legal provision for corporal punishment among convicts where same is deemed necessary, but such punishment must be within reason. While convicts should be made to work and to obey orders, and at times certain degrees of punishment are necessary to bring this about, we see no justification whatever for punishment that reaches the brutal stage. Brutal punishment can serve only to instill hatred that often leads to greater crimes.

tion on the high mountain, whatever may be said of the defects of practice in our day, the ideals were different from those with which we are familiar. Might made right, and national disputes were settled by the arbitration of the sword as a regular thing.

Even the Church expected God to reward devotion by making His people world conquerors. Liberty was the property of thrones and crowns, and if it was ever given a subject or alien in any measure, however simple, it was given as a concession and not as an inalienable right.

Judaism was undoubtedly the purest and the most exalted faith of the day, but it was confined to a very small nation; and how degenerate that system and that nation had become is shown in the scathing denunciation by Jesus as recorded in Matthew, twenty-third chapter. She had few Gamaliels among her teachers and fewer Isiahs and Jeremiahs among her prophets.

This humble Nazarene, in the midst of all this, had the tenacity to denounce paganism and false Judaism alike, to reject their method and their crown.

The boldness of Jesus takes one's breath, especially when one considers the time and the circumstances. No wonder He met a crucial hour. His enemies would pursue Him unto death, and He knew it.

But the resurrection was the seal of His divinity and of the perennial power of His ideals. It stamped them as of God. It marked Him as the greatest teacher and the sublimest prophet of the world, and we join in willing response to what is recorded as the voice from heaven, "This is my beloved Son. Hear ye Him."

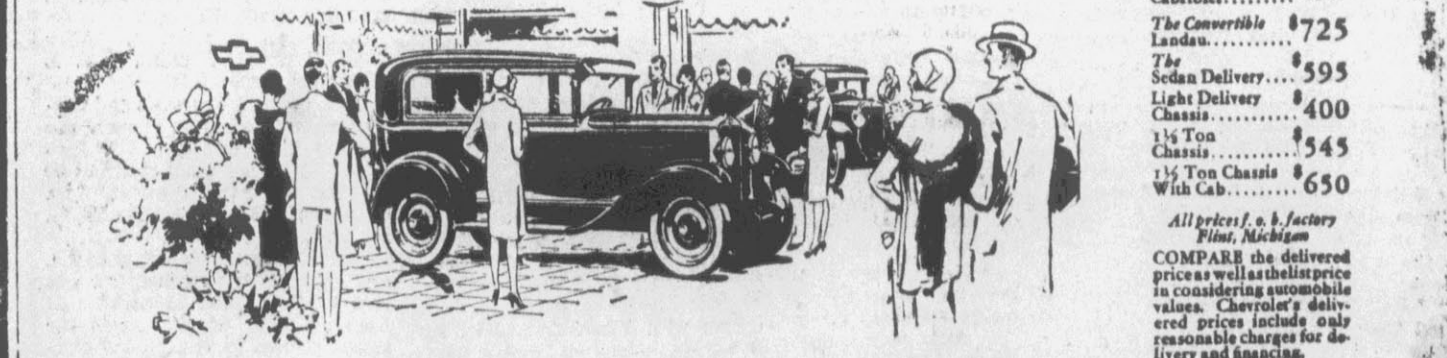

# Kinston And Greenville Play To Ten Inning Tie In League Opening Here

The curtain of the Eastern Carolina league was officially rung up in this city yesterday afternoon with Kinston and Greenville playing to a ten inning tie. The game was called on account of darkness at the expiration of that period with eight tallies checked up to the credit of each club.

Between fifteen hundred and two thousand people attended the opening game. They witnessed every brand of ball in the baseball category, yet the majority were satisfied with the fact that both Kinston and Greenville had clubs that would stand out prominently in the win column later on in the season.

The game was marked by extreme slowness at times, but brilliant bursts of speed by members of both clubs caused the frenzied spectators to forget all about the passage of time and to become careless and indifferent about how long the game lasted. All they knew was that they were watching a ball game of the unusual variety, and they were content to sit on the hard seats and wait and watch for something else of an outstanding nature.

The day started off splendidly for the opening. Greenville had provided herself with the high school band. The youngsters thirty-six in number, tooted and bowed until it seemed like their lungs would burst, but unmindful of the strain they continued to toot until it looked like the day was meant for Kinston alone. The tooting and blowing ceased at this juncture, and the young musicians were not able to get up enough courage to play again until Greenville batsmen started banging the ball against the outfield fence for extra bases.

Both of these clubs tied for the cellar position the most of last season, but only at very infrequent intervals yesterday did they exhibit any of the cellar atmosphere. Kinston started out like they meant to romp away with the game without giving the locals a peep in but Les Bangs, known in many leagues as "Shipwreck" with the willow, rallied his youngsters and caught up with the eight markers which the visitor managed to hang up to their credit in the first four sanzas of the game.

A youngster by the name of Dawson started off on the mound for Greenville. He retired in the second inning in favor of Rose with the bases loaded.

Dawson was wild, but Rose proved just as wild, and was unable to prevent the visitors from unloading the bases.

He continued wild throughout the game, and while his inability to find the plate got him in many a predicament, he managed to pull out with flashes of brilliance that set the grandstand and bleachers roaring like the combined managers of all shows in the world.

Emmons did mound duty for Kinston until Greenville started a barrage in the fifth that caused him to retire in favor of Culbreth. The change did not bring the required results, as the locals continued pounding the apple and shoved over two more runners in the eighth to tie the score. Both hurlers tightened up after that period and in the next two innings the spectators were treated to a brand of ball they had been hoping for since the end of last season.

While both clubs were credited with more than the usual number of bibles for good ball clubs, they succeeded in providing a brand of fielding that drew the admiration of their supporters. "Shipwreck" Bangs set a fine example for his followers in the sixth inning when he made a long running catch of a drive by Roper. Kinston start-stop, that looked good for three bases. Leder at short and Nolback at third, also furnished sensations by handling of difficult rounders.

The spectacular performance of Bangs, however, was not confined to fielding alone. In the third frame he drove the ball against center field fence for two bases, scoring Pasquella and Nolback a head of him. The feat seemed to remind the Tobaccoists that it required stick work to win a ball game, and with the manager's example before them, they started banging the ball with such frequency that Kinston's hopes of walking away with a sewed up game faded out of the picture completely.

Ralph Williams led the locals with the stick, getting three saeties, one a double, out of three trips to the reeber. He also fielded in a way that brought considerable commendation from the grandstand and bleachers.

The two clubs were scheduled to play here this afternoon. The beginning of next week will find the locals playing at Rocky Mount the first two days, and at Goldsboro the next two. They will return Friday to face Wilmington on home grounds.

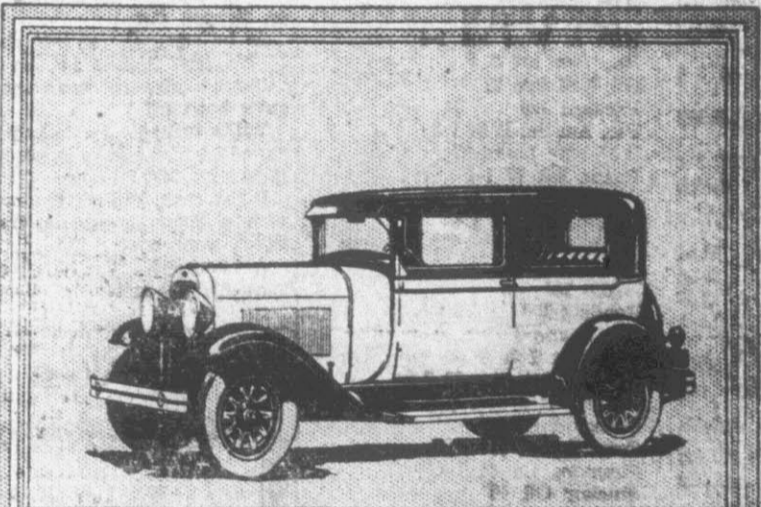
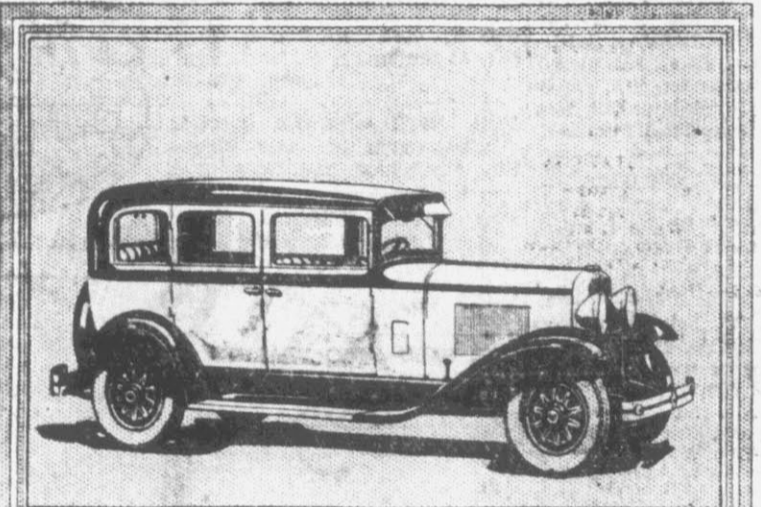
