PATRONAGE FIGHT AGAIN GETS AIRING

Hoover Followers From Georgia Demand Showdown on Visit To Washington

Washington, May 2.—(AP)—Postmaster General Brown informed complaining committee of Georgia Republicans and Democrats today that the patronage committee he has set up in Georgia to replace that organized by Horace A. Mann would stand.

While the Georgians declined to make any statement, it is understood they planned to present their views personally to President Hoover with whom they will seek and arrangement either late today or tomorrow.

Whether they will see the President as a delegation was regarded in some quarters as doubtful, although it was indicated that the President would be glad to talk with H. O. Hastings, head of delegation, who was chairman of the state wide Republican Hoover for President committee in the last campaign.

Washington, May 2.—(AP)—Invasion of the National Capital by a group of Georgia Republicans and Democrats who were prominent in the Hoover campaign last year has brought the whole southern patronage control fight into the open again.

Apparently the Georgians are here intent on obtaining a showdown as between the organization set up by H. O. Hastings, who directed the President's campaign in half a dozen southern states, and the group of party leaders here who have been designated generally through unofficially, as the administration committee on patronage control.

There is much conjecture whether the President himself will take a hand in the controversy, or whether the old Mann organization is to go down before the new machinery, which was set up under the direction of Postmaster General Brown in consultation with Walter Newton, administrative assistant to the President, and James Francis Burke, general counsel of the Republican National Committee.

After a talk late yesterday with Mr. Newton, the Georgians had an engagement today to discuss the situation with the Postmaster General. Whether they will ask for an appointment with President Hoover was believed to hinge upon the outcome of this conference.

The Georgians' force was augmented by Edward E. Coffin of Sapelo Island, Georgia, a close personal friend of the President, who, it was stated, expected to call at the White House to urge recognition of the Mann organizations. Those committees are described as having been built up around southern leaders who were in the forefront of the campaign for the Hoover-Curtis ticket.

Three of the state committees which were set up under the direction of Mr. Mann have failed to meet with the full approval of Postmaster General Brown. That in Georgia has been succeeded by committee headed by Lindsey Hopkins of Atlanta, who also was a member of the Mann organization. The one selected for Florida is being reorganized, and a new committee is being formed in South Carolina, where the group chosen by Mann was headed by Walter F. Newton, who had direction of the Hoover campaign in that state.

Three Communists Arrested Following Mexican Disorders

Mexico City, May 2.—(AP)—Three men, alleged Mexican communists, were under arrest today for investigation, after a May day demonstration in front of the American Consulate yesterday which police broke up almost as soon as it began. One of the men, Leopoldo Quiroga, was charged with shouting "death to Morrow."

"Ambassador Morrow was attacked vigorously in posters spread about the city prior to the demonstrations. "Mary early and don't join clubs" is the recipe for happiness given by Sir Walter Runciman, British millionaire.

Eight Lives Snuffed Out By Arkansas Tornadoes; Fifty Persons Injured

Little Rock, Ark., May 2.—(AP)—The second series of tornadoes in Arkansas in less than a month today had taken a total of at least nine deaths and probably 50 injured with property damage running to \$300,000.

Striking a few hours apart in both the East and West parts of the state late yesterday and last night, the tornadoes so completely demolished communication systems that full reports of the number of dead and injured and property damage were not obtainable early today.

The six known dead were at Brinkley and Wheatley, a few miles apart, in northeast Arkansas. Three of them were white persons Mrs. Edwards and two daughters, and three negroes.

More than 20 were injured in that section, about a dozen seriously. Reports from Dagnair, southwest of Brinkley, were that about 20 persons were injured there. Over in the western part of the state near the Oklahoma border, Fort Smith and vicinity had a dozen injured.

The number of dead was expected to be increased by a thorough survey of this section around Wheatley. Red Cross workers, sent in on a special Rock Island train, were on the scene.

Red Cross workers from Newport were by special train to Dagnair to ascertain the storm situation there. The Red Cross workers who went to Dagnair included Albert Evans of St. Louis, midwest director, who has been at Newport directing relief and rehabilitation work since the disastrous tornadoes of two weeks ago, which killed nearly fifty and

VANDERBURG IS ACQUITTED AT GASTONIA

Youth Found Not Guilty Of The Murder Of Five Members Of His Family.

Gastonia, May 2.—(AP)—Jake Vanderburg was out from under the shadow of the electric chair today for the first time in the four months since five mutilated bodies were found in the charred mass that had been his home.

A jury in Gaston county Superior court early last night acquitted the 17-year-old farmer boy of the murder of his parents, Mr. and Mrs. J. W. Vanderburg, his sisters, Pauline and Louise and his brother, Robert, after a little more than two hours of deliberation.

Jacob, bereft of family, said he had made no plans pending settlement of his father's estate. He spent last night in Charlotte as the guest of one of his attorneys and will be honor guest at a dinner tonight with the five members of the defense counsel as his hosts.

The youth was arrested early on the morning of December 28 after neighbors had found him seated beneath a tree watching flames consume the home over the bodies of his kinfolk.

When the dismembered remains were found laid side by side in orderly fashion at a spot where the kitchen had been, he was accused of killing them with a hatchet as they slept. A coroner's jury bound him over and a grand jury indicted him for first degree murder and first degree arson.

The arson charge was not pressed immediately after the verdict was announced last night.

HUGE SHIPMENT OF CIGARETTES IS MADE

Reidsville, May 1.—Twenty-four carloads of cigarettes, 223,000,000 individual cigarettes, left here yesterday from the plant of the American Tobacco Company under the pulling power of one of the Southern's huge locomotives.

Fifteen cars were sent south and nine of them were directed north for distribution. The local plant of the American Tobacco Company is now putting on the market daily about 71,000,000 cigarettes.

The Reidsville plant is giving steady employment to 2,300 contented persons.

Tacna-Arica Dispute Reported as Settled

Lima, Peru, May 2.—(AP)—Settlement of the long pending Tacna-Arica dispute between Chile and Peru was authoritatively stated today to have been completed.

It was expected that formal announcement of the settlement would be made within the next two days from Washington.

MRS. TOWNSEND GETS JUDGMENT FOR \$17,000

Farmville Woman Wins Suit For Alienation Of Husband's Affections.

Mrs. C. R. Townsend of Farmville, was awarded \$17,000 compensatory and punitive damages by a jury sitting in the special civil term of Pitt county Superior court in the city yesterday afternoon. Mrs. Townsend was suing J. C. Holderby, Murril Holderby and Mrs. Lily Holderby for \$35,000 for wrongfully and maliciously alienating the affections of her husband and causing him to separate from her. The jury was out about one hour.

Immediately following announcement of the jury's decision the defendants filed notice of appeal to Supreme court.

The decision of the jury brought to an end one of the hardest fought legal battles of the kind ever before staged in the local courtroom. The case was taken up shortly after court convened last Monday morning. Argument for the plaintiff was completed by 3:30 the noon hour yesterday. Both the plaintiff and defendants were represented by an array of legal counsel of some of the strongest law firms in this part of the state.

Mrs. Townsend charged that the Holderbys caused the separation with her husband about five years ago while he was confined in a hospital for some nervous disorder. The defendants, on the other hand, maintained that they had nothing to do with the alienation of affections and that the estrangement actually existed before the time that they were alleged to have used their influence with Townsend.

The jury in reaching the total amount of the damage suit divided payment among the defendants as follows: J. C. Holderby, \$7,500 compensatory and \$1,000 punitive damages; Murril Holderby, \$5,000 compensatory and \$750.00 punitive; Mrs. Lily Holderby, \$2,500 compensatory and \$250.00 punitive damages.

J. C. Holderby is the step-father-in-law of Mrs. Townsend. The jury was composed of the following men: T. E. Gray, J. E. Wainwright, W. M. Norville, J. P. H. A. Bost, V. E. Wells, P. H. Cassey, A. S. Jenkins, Calvin Jones, P. H. Nobles, J. L. Horne and Saul Haddock.

Senator Wagner Proposes Corporation in Place Of Agencies Provided By Old Bill

Washington, May 2.—(AP)—Substitution of a single powerful government operated corporation for the commodity stabilization agencies provided for in the farm relief bill was proposed today by Senator Wagner, Democrat, New York, as a means of controlling surplus crops.

Describing the bill in its present form as a "mockery" and a "dressed up scheme" to satisfy campaign slogans, he claimed an interest in farm legislation as a representative of a state which produces crops valued at \$200,000,000 a year and is the largest consuming and tax paying commonwealth in the country.

If stabilization is the intention of the administration, he argued, it should be frankly faced with a direct plan of execution and not through complex machinery and red tape.

He contended the debenture plan was not workable and that the Norris amendment providing for reduction of rates whenever over-production is threatened in an affected crop did not improve it.

Asserting that many farm leaders themselves admit that the farmers will not join co-operatives he declared the whole farm relief plan embodied in the pending bill is bound to fail because it intends to set up stabilization corporations upon the co-operative structure.

"Now if we are going to pay for stabilization," he said, "let us see that we secure effective stabilization, not a mockery.

"With that object in view, the major change proposed in my amendment is the elimination of all the commodity stabilization corporations and the creation in lieu thereof of one single powerful corporation to engage in all of the surplus crop control operations that the bill contemplates. Its capital of about \$50,000,000 will be contributed and owned by the government. Its board of directors will be the members of the farm board."

"The amendment places responsibility for the success or failure of the stabilization work where it belongs—on the administration. The administration bill permits idle boasting of success if there be any, and the shifting of blame elsewhere in case of failure."

Valiant Yorks Havana—There are two valiant fighters named York whose services have been recognized by the United States. Major August York, uncle of the sergeant of the World War, has been pensioned for his work in the American army in the Spanish War. At its conclusion he joined the Cuban army and rose to chief of the signal corps.

Liner Collides With Freighter In N. Y. Harbor

New York, May 2.—(AP)—The Spanish liner Cristobal Colon and the freighter River Orontes collided off the quarantine station at Rosebank, Staten Island, this afternoon.

Due to the heavy haze hanging over the lower harbor, marine observers on the shore could not immediately ascertain the extent of the damage.

The Cristobal Colon was bound for Corunna, Spain, while the freighter was arriving after a voyage from Oran, Algeria.

Radio advices from the River Orontes said her No. 4 hold was full of water and that she was settling after. Her captain was putting her into shallow water.

BEGINS PROBE OF RUM STORY AT RALEIGH

Federal Officer Investigates Reported Curb Whiskey Market in Capital City.

Raleigh, May 2.—(AP)—P. M. Caudle, deputy federal prohibition administrator, was in Raleigh today but he was uncommunicative about the curb selling of liquor here which local police admit they have been unable to stop.

Federal assistance in breaking up the illicit trade was asked by Chief J. Winder Bryan, of the city department, who announced he had written Caudle a letter requesting aid.

Although the federal officer was silent about his plans with regard to the reported open selling of whiskey by rum runners from their automobiles, he was emphatic in showing resentment at a news story in the local afternoon paper, which carried a headline as follows: "Machine gun is federal threat against daring bootleggers of Raleigh."

"There is absolutely no foundation for that statement and its implications," he asserted vigorously. "We are not supplied with machine guns," he added, "and our men are not allowed to do any shooting except in self defense."

The administrator said the story had been published without any communication with him.

"I am not sure what he thought about the reported condition here," Mr. Caudle replied that it was not his policy to say anything publicly about such things.

"My policy is, and always has been, to go to the assistance of local officials any time help is needed in clearing up a bad situation. Further, the co-operation of the local officials is always appreciated."

Both local newspapers today printed reports that from six to eight rum-laden automobiles did business here yesterday and last night regardless of police precautions.

The sections of the city reputed to be favored for the curb trade were popular late yesterday with motorists who parked, apparently awaiting a possible meeting between the patrolling police cars and some of the "daring bootleggers."

ILLINOIS AND MISSOURI HIT BY SNOWSTORM

Temperatures Tumble To Below Freezing in Storms of Blizzard Proportions.

St. Louis, May 2.—(AP)—A heavy snowstorm of near blizzard proportions struck St. Louis and portions of Missouri and Illinois today, demoralizing traffic, disrupting telephone communications and sending the temperature tumbling below freezing. More than three inches of snow had fallen here before 8 o'clock this morning.

Seven Persons Killed In Berlin May Day Disorder; Situation Normal Today

Berlin, May 2.—(AP)—Clashes between police and Communists in yesterday's riotous May Day celebration in Berlin resulted in heavy casualties, seven Communists being killed, and 80 civilians and 30 policemen injured.

The casualties were probably greater as the figures given out by the police today did not include many Communists who were taken to their homes by comrades after being injured in the fighting.

In all there were 900 arrests, of whom 725 were released after an examination and their names registered.

Berlin, May 2.—(AP)—This capital today counted the cost of a night of rioting which culminated in May Day demonstrations yesterday. Eight persons were dead, some of them policemen, 78 were seriously injured, and hundreds of others suffering from bruises and minor injuries. More than 600 Communists were under arrest.

The principal rioting occurred after dark in the working class quarter of Berlin where Communists in an effort to enforce their "conquer the streets" slogan for May Day erected barricades in the main thoroughfare of the Pankestrasse and its side streets.

More than 3,000 workmen ranged themselves behind these barricades and held them against 500 policemen who charged with their nightsticks. The police eventually realized their force was too weak and opened fire on the rioters. It was not, however, until armored cars were brought up that the barricades were finally forced.

There was promiscuous firing for several hours between the two groups with snipers of both picking off opponents from behind windows of buildings in the neighborhood. Those Communists who did not have guns picked up paving blocks, bottles and rocks and used them to good effect. It was not until after 11 p. m. that the police were able to subdue them, and the surrounding houses were cleared.

There was fighting also in the eastern and southeastern parts of the city where light systems broke down and added to the terror of the populace. The conflict did not assume the seriousness of that in the northern section.

THINK EDGE WILL BE NEW AMBASSADOR

Washington Sees New Jersey Senator As Successor To Late Myron Herrick.

Washington, May 2.—(AP)—Diplomatic Washington seems to be convinced that Senator Walter E. Edge of New Jersey, is the most likely choice for appointment as ambassador to France to succeed the late Myron T. Herrick. A similar opinion is entertained in Capitol Hill, particularly among the close friends of the senator.

Authentic information now is that President Hoover has no intention of making a selection for some months, or until after the extra session of Congress. This is regarded as lending further color to the reports that the senior senator from New Jersey will go to Paris.

Naturally Senator Edge is maintaining silence and it is known that he already is laying his plans and strengthening his organization for the senatorial primary contest next June when the Republicans of his state will nominate a candidate for his seat.

Other gossip in diplomatic and congressional circles is that Jacob Gould Schurman will remain at Berlin and that L. S. Swenson will be retained at his present post in Norway, where he has served since 1921. Some of the other diplomatic representatives to Europe, including Hugh Gibson, ambassador to Belgium, also will be continued in their present places, although some transfers to Latin-America are anticipated.

There is, of course, much conjecture as to the successor of the veteran Henry P. Fletcher, ambassador to Rome, who desires to return to his native country after diplomatic service of more than half a century. Thus far, few names have been suggested.

If any changes in the Latin-American field have been definitely decided upon, this fact has not yet become generally known. Several of the diplomatic representatives in the southern republics will go forward with their work, but when the re-assignments and reorganizations are completed, there will be new American representatives in a number of the Latin-American capitals.

Roy T. Davis is returning to Costa Rica as minister, but his friends are hopeful that he will be promoted to a more important post in recognition of what they regard as his splendid service at San Jose. There are suggestions that he may succeed Alexander P. Moore as ambassador to Peru.

SEE DELAY OF FINAL ACTION ON FARM BILL

Administration Leaders Believe Measure Will Be Postponed Until Next Session.

Washington, May 2.—(AP)—The mass of amendments offered to the farm relief bill in the Senate has forced administration leaders to conclude that final action on the measure will have to be postponed until next week.

Senator McNary of Oregon, chairman of the agriculture committee, is hopeful that the Senate will vote on the export debenture section tomorrow, but even this seems impossible in view of the large number of senators who have indicated a desire to discuss the proposal.

A Saturday session may be called to get the export debenture contest out of the way before the end of the week and if this aim is successful, the measure as a whole is likely to reach a vote Monday or Tuesday.

Although the amendment of Senator Watson of Indiana, the Republican leader, to eliminate the debenture plan has caused the greatest discussion, considerable debate is expected also upon a number of the dozen or so changes advocated by other senators. Some of these may be accepted or rejected without argument, however.

After the debenture plan has been disposed of, the Senate will be asked by Chairman McNary to comply with a request of fruit and vegetable associations that their products be excluded from operation of the farm relief machinery to be set up by the bill. They asked and obtained similar exemption from operation of the equalization fee in the old McNary-Haugen bill.

Senator McNary also has an amendment providing that no money would be loaned by the proposed farm board for the construction of storage and warehousing facilities unless the board was convinced that existing facilities were inadequate. This provision is included in the House bill.

Senator Brookhart, Republican of Iowa, intends to call up an amendment his own providing a huge subsidy for the direct buying by the government of surplus crops but there is no indication that this proposal will be accepted.

Another amendment that seems certain to be voted down is that of Senator Harris, Democrat, Georgia, for the operation of Muscle Shoals under lease from the secretary of war to the Air Nitrates Corporation and the American Dynamite Company. In this category, also is placed the amendment of Senator Copeland, Democrat, New York, to substitute the equalization fee for the export debenture plan.

Senator Thomas, Democrat, Oklahoma, has offered several amendments designed to curb the power of the President with respect to the functioning of the farm board.

WEATHER BUREAU SENDS OUT STORM WARNING

Washington, May 2.—(AP)—The weather bureau today announced the following storm warning: Southwest storm warnings ordered 12 noon Jacksonville to Virginia Capes and at 4 p. m., north of Virginia Capes to New London, Conn., disturbance of marked intensity over Ohio Valley moving Northeastward will be attended by south and southwest winds probably becoming strong, shifting to west and north west and reaching gale force tonight.

Plan To Settle Reparations Issue Within Few Hours

Paris, May 2.—(AP)—The fate of the conference of experts on reparations, seeking to effect a settlement of German's ponderous post-war debt problem, should be known definitely today or tomorrow.

If Dr. Hjalmar Schacht, German spokesman, returning to Paris from Berlin today, maintains the same attitude which made failure of the conference imminent almost two weeks ago, the experts will have only to quickly finish their final report and go home.

If, on the other hand, his stay at Berlin was regarded today, however, as extremely doubtful, information from Berlin was that Dr. Schacht would make a new proposal, but there was little indication it would be anything like satisfactory to the allied nations.

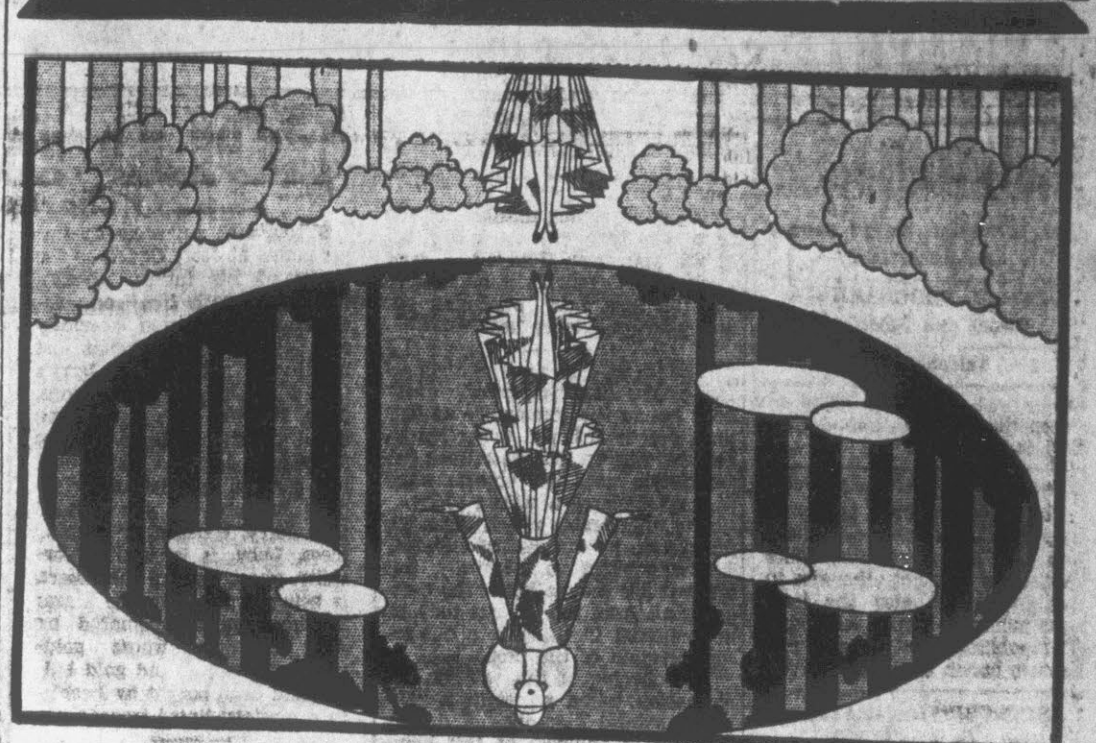

# STILL PROBE GANG MURDER AT CHICAGO

## Authorities Make Effort To Ascertain Who Bought Guns From Thompson.

Chicago, May 2.—(AP)—Authorities today were feeling their way through a mass of stories and names—real and fictitious—to a possible solution of the massacre of seven gangsters last February 14.

The process of elimination was decided upon early today as the best means of discovering the persons to whom Frank V. Thompson, machine gun broker, sold weapons prior to the massacre.

Thompson and Peter Von Frantz, who has admitted to authori-

ties that he sold several machine guns to Thompson, were questioned until long past midnight. So important were their statements considered that Coroner Herman N. Bundesen was roused from sleep at midnight and called to police headquarters, where the questioning took place. Burt Massey, vice-president of the Palolive Company, a member of the coroner's jury, also appeared at the questioning, as did Thompson's attorney.

John Stege, deputy police commissioner in charge of detectives, declared Thompson had given several names of persons who he had sold the machine gun, but that the names were found to be fictitious.

"We're going to 'pump' Thompson until he runs out of fake names," Stege explained. "We're checking up on each name as he gives them, and will keep up this process of elimination until only real names are left. Then we'll probably know what we want to know."

Coroner Bundesen was non-committal when he left police headquarters several hours later.

"All I say is that we're getting closer to the solution each day," he declared. "We have learned much this morning—and expect to learn more later in the day."

## Heads Of Oldest Reigning Houses Meet At Tokyo

Tokyo, May 2.—(AP)—The head of the oldest reigning house in the world extended such a welcome to the scion of the second oldest today as Japan has not known in a decade.

Emperor Hirohito met Prince Henry of England, Duke of Gloucester, at the railway station as he arrived from Yokohama on his mission to bestow the Order of the Garter on the Japanese ruler.

The emperor grasped the hand of the English prince and chatted with him for a moment after he had descended from the coach to the station platform. Then he watched smilingly as Crown Prince Chichibu left with him in a brilliant procession to the Kasumigasaki palace, which is to be his temporary residence.

At the entrance the Princess Chichibu, acting as the empress's

hostess on behalf of the empress who expects soon to become a mother for the third time, greeted the royal guest. The princess wore a smart European afternoon frock. The duke rode in a six horse open carriage, with red and gold decorations, from the station to the palace. Prince Chichibu, who had met him at Yokohama where he debar-

ked from H. M. S. Suffolk, was seated alongside of him.

Both wore full dress uniforms, the English prince that of the Tenth Hussars and Prince Chichibu of the Third Regiment. As they were driven up the street both smiled and saluted in acknowledgement of the applause from the multitudes.
