

GREENVILLE WINS OVER SCOTS, 7-0

Greenville made it an even split by blanking Fayetteville in the final game of the series at the Fair Grounds here yesterday afternoon. The score was 7 to 0. The local club showed an entire reversal of form over the day before and handled the ball in a way that constantly brought prolonged cheering from the hundreds in the grandstand and bleachers.

There were many high spots in the game from the Greenville point of view, but the most memorable probably came in the eighth frame when Nalbock, shortstop, slammed the ball against the fence for two bases, scoring three runs. This was decidedly the longest drive of the game and produced the most runs of any single inning.

The contest had all the earmarks of a pitchers' battle between Wilda and Rose in early stages, but in the fourth inning Greenville began hammering Wilda in a decidedly effective way and sent two runners over the pan. From then on until the eighth frame, the Highlanders tightened up and declined to yield anything in the way of runs. In the fatal eighth, however, the Tobaccoists' artillery began booming more decisively than any other time of the week and when the bombardment of the Scot's offering had ended the game had been put on ice.

Fayetteville was decidedly out of luck in the way of getting men on base. The official record gave them credit with only three left on the baselines. At no time during the game did they seriously threaten to break the goose eggs which the Greenville heaver caused them to leave behind each inning.

Pasquella, Clemmons and Edmonds lead with the stick for the Tobaccoists, each being credited with two hits out of four trips to the rubber. The visitors secured four hits and the locals nine. It was the first game the locals had played since the dismissal of Manager Bangs. President Guy Smith directed the activities of the club and Ralph Williams acted as field captain. This management will continue until a permanent manager has been secured, it was stated.

The locals left this afternoon for Kinston where they will take on the Eagles for a two-game series.

Atlanta, May 24.—(AP)—Up and down the Southern Conference the boys are going into huddles to devise ways and means of dealing with the Duke Blue Devils.

Clarence Mitchell renowned as the only left hand spitballer in captivity, gave further proof yesterday that this is not his only claim to fame. The Brooklyn cast-off, always supreme in a crisis, pitched the Cardinals to a 6 to 3 decision over the Cubs at St. Louis in the season's first semi-critical series, and thereby lifted his team into the lead over its Chicago opponent by a margin of half a game.
The veteran Mitchell surrendered eleven hits to the enemy, as against only nine collected by the Cardinals off the Messrs. Blake, Bush and Nehf, but they still pay off runs. Right handed swingers though they are, the Bruins found it impossible to locate Mr. Mitchell's teasers when a hit would have meant a ball game.

Burleigh Grimes pitched for the Pirates against Cincinnati yesterday. This simple assertion is rapidly becoming synonymous with a statement to the effect that the Pirates won, which they did yesterday by 6 to 3. The Buccaners thus enabled their big spitballer to enter his seventh successive victory into his credit column at the expense of Eppa Jetha Rixey.

The Phillies and the Robins were idle yesterday, and the Giants defeated the Braves by 11 to 4.
The day's campaign in the American League met with the full approval of Mr. Cornelius McGillicuddy, even though the Yankees defeated the Red Sox 7 to 6 at Boston. Mr. McGillicuddy, the while, was engaged in the pleasant task of taking two from the Senators, each by a score of 9 to 8. The Browns only got an even break at Cleveland, winning by 7 to 5 after the Indians had nosed out a 5 to 4 decision in the 12th inning opener.

Plan To Mobilize Business In Wartime

Washington, May 24.—(AP)—The War Department is preparing for early submission to Congress of a bill to mobilize industry in wartime on the same basis that manpower is conscripted.

Secretary Good says the measure is expected to be among the first legislative matters to come before Congress at its regular session in December. The bill probably will cover all phases of finance and commerce.

The secretary has already sent to Congress a bill to authorize the President to conscript the manpower of the nation for immediate military service upon a declaration of war.

The national defense act places upon the War Department the responsibility of preparing plans for the mobilization of industries in war time and the proposed legislation would authorize their actual draft by the President.

COLLEGE TO BEGIN FINALS NEXT WEEK

Commencement Will Begin Friday, May 31st, With Music Department Recital.

Finals will begin at East Carolina Teachers College next week. Commencement exercises will begin on Friday night the 31st, with a recital by the music department.

MIMIC WAR CONTINUES

Forces Continue To Advance Along The Ohio Front Today In Sham Battles.

Columbus, Ohio, May 24.—(AP)—The invasion of the attacking Blue army in the mimic warfare along the Ohio front today swept on toward this city, the capital of the Red state, with indications that it would fall into the hands of the enemy by tomorrow.

When the Blues capture Columbus the mock fighting of the Red and Blue states, into which the United States army air and ground forces have been divided, will be at an end. The fall of Columbus is a foregone conclusion for the Blues are far superior in numbers, even though matched in skill by the defending Reds.

Thousands of Blue troops, some of them real, but most of them imaginary, were stretched out along Darby creek not far from Columbus today making a big push against the Red's main line of resistance, which gradually was weakening. Not long after daylight today Blue bombers and attack ships and fast pursuit planes got into action with the ground forces for the biggest movement of the maneuvers. All the strength of the Blue army was brown against the outnumbered Reds, whose line was cut to pieces.

The maneuvers will formally come to an end at noon tomorrow when the army aviators, who have been using imaginary bombs and ammunition, the last ten days will demonstrate what they can do with the real thing. Forty-five airplanes equipped for battle with real ammunition will turn bombs and machine gun fire on convoys of wagons and thousands of cardboard soldiers at Wright Field tomorrow in the final demonstration of the maneuvers.

THREE KILLED IN GUN FIGHT

Negro Robber Shot Down After Killing Attorney And Detective In Florida.

St. Petersburg, Fla., May 24.—(AP)—Herman Merrill, 80-year-old attorney, a detective and a negro burglar were killed in a gun battle here early today.

Detective Wayne Barry and Mr. Merrill were victims of the negro's gun while the negro was killed by Detective Patrick, who had been with Barry near the Merrill home when they heard the shot which mortally wounded the aged attorney. Mr. Merrill died in a hospital shortly after the shooting.

Hearing a noise, Mr. Merrill took his revolver and went to investigate. The marauder fired upon Merrill before he had a chance to use his own gun.
