## SEES EFFORT TO CURTAIL SCHOOL WORK

### President of National Education Association Says Legislatures Not Interested

Atlanta, July 1.—(AP)—A charge that there were organized movements afoot in most state legislatures to curtail public education today was before the National Education Association convention, gathered here for its first formal meeting.

The thrust was made by Dr. Uel W. Lampkin, president of the association in an address to summer students of the University of Georgia at Athens, Ga.

Declaring that only one of the state legislatures which have met in the last 12 months had shown any interest in public education, Dr. Lampkin said the attitude of lawmakers generally indicated a backward swing which ultimately would lead to "deplorable conditions." He urged all teachers to fight the plans of the enemies of educational progress.

Dr. Augustus O. Thomas, Maine state commissioner of education and president of the World Federations of Education Associations, addressing a Second Baptist church audience here, declared that women have written the most brilliant page in history since college doors were opened to them hardly a generation ago. Since then, he said, women have advanced from non-property owning citizens to holders in their own names of 42 per cent of the national wealth.

But, he said, education's coal was far from mineralization. He pointed out that but one and one-half per cent of the public and private income was spent for education, while crime costs accounted for nearly nine per cent. The more spent on education, he said, meant that much less was expended to detect, apprehend and punish criminals.

At the 1,200 delegates of the representative assembly, the association's governing body, were called today to organize and nominate candidates for the office of president of the association.

The only two names known to be before them were those of Miss Ruth Pyrtle, principal of Bancroft high school, Lincoln, Neb., and Miss Effie McGregor, principal of John Burroughs school, Minneapolis, Minn. It was understood that their nominations will be made public today for election later, while at the same time was made known that Miss Florence Hale, state supervisor of rural schools in Maine, had withdrawn her name until 1931. It is customary to name a man and a woman as president on alternate years.

The morning and evening sessions today were devoted to general sessions and the first representative assembly, while the afternoon was to be taken up in departmental meetings and councils of allied organizations.

William F. Russell, dean of Teachers College, Columbia University, New York, in an address prepared for delivery this morning, declared that the United States "found itself" in danger of bureaucracy shaping the education of its children if it yields to the pressure being made to bring about federal control of schools. He said physical equipment and financial aid should be provided by federal and state educational authorities, "with attached strings."

Asheboro, July 1.—(AP)—Three persons were in jail here today on charges of driving an automobile while intoxicated and a fourth was in a hospital as the result of an automobile accident near here yesterday.

Gurney Trogen, I. M. Allred and Nora Brady were held in jail. Mrs. Robert Brady was in a local hospital with injuries physicians said might prove fatal. Her husband was also slightly injured in the accident.

The accident occurred when Trogen and Miss Brady, accompanied by Allred and the Robert Bradys, started to South Carolina where they said they intended to marry. Their car struck a truck driven by W. H. Wooten of Winston-Salem. Both vehicles were badly damaged.

## 25 DROWNED IN U. S. OVER THE WEEK-END

### Two Triple Drownings Also Reported In Districts Of Ontario.

(By the Associated Press.) At least 25 persons were drowned over the week-end in widely scattered sections of eastern and southern United States and eastern Canada.

There were two triple drownings in Ontario. Three women were trapped in an automobile which plunged through a bridge railing at Brewster Mill. Eight men were thrown into the water near Midland when their boat listed sharply. Five were rescued.

Three members of a picnic party lost their lives in Choccolocco creek, near Armstrong, Ala., when their boat capsized. At Chatham, Ont., an automobile plunged from a ferry into the Eydenham river, drowning the two occupants. A bather was seized with cramps and drowned in the same city.

Swimming and bathing accounted for a number of single drownings. A Washington girl lost her life in the South river, near Annapolis, Md., her two companions were rescued. A boy swimming in a stone quarry near York, Pa., was drowned. Another youth near Bolton Landing, N. Y., drowned when attacked by cramps. A third is believed to have been overcome by a heart attack while diving in Lake Congamond near Suffield, Conn. Two men drowned while far out from shore at West Paterson, N. J.

## President Plans To Complete Farm Board Personnel

Washington, July 1.—(AP)—President Hoover hopes to complete by the end of this week the selection of virtually all of the men who, as members of the Federal Farm Board, will be entrusted with the task of bringing prosperity to agriculture.

Proceeding with great deliberation in view of the importance he attaches to the board's undertakings he has filled three of its eight places and has offered one to a business man and two to farm leaders, one of whom, however, is expected to decline.

Cotton is to be represented by Carl Williams of Oklahoma; tobacco by James C. Stone of Kentucky, and livestock by C. B. Denman of Missouri. These three definitely have accepted appointment.

Those who have been offered appointments are Alexander H. Leggett of Chicago, who would represent general business; W. S. Moscrip of Minneapolis, chose to speak for the dairying industry, and Chas. C. Teague of California, identified with fruit growing co-operatives. Teague is quoted in press dispatches as saying private business will prevent him from serving.

On the assumption that the place offered Teague will be filled by another representative of the fruit growers, two places on the board remain to be filled from other industries.

### Joseph Stewart Dead.

## PLAN ANOTHER RAILWAY LINE FOR THE EAST

### Application Of Trunk Line For Wabash Carried Before I. C. Commission.

Washington, July 1.—(AP)—Formation of a new railway trunk line in the east is planned by the Wabash Railroad.

An application for the establishment of the new system was brought to Washington today by representatives of the Wabash for the consideration of the Interstate Commerce Commission.

It asks authority to acquire control by lease or stock purchase of five others. Trackage rights over several systems also are sought.

If approved by the commission, the plan would mean the establishment of a fifth eastern trunk line with western terminals at Chicago, St. Louis, Kansas City, Omaha and Des Moines and eastern terminals at New York, Philadelphia and Baltimore.

The four trunk lines now in operation are the Pennsylvania, New York Central, Baltimore and Ohio and the Chesapeake and Ohio. The latter two have filed merger plans of their own with the commission which have been opposed by the Wabash.

Lines which the Wabash seeks to control are the Lehigh Valley, Pittsburgh and West Virginia, Wheeling and Lake Erie, Western Maryland, Lehigh and New England, Akron, Canton and Youngstown, The Elgin, Joliet and Eastern, The Toledo, Peoria and Western, and the Chicago and Illinois Midland.

A one-sixth interest is sought in the Montour Railroad Company, The Monongahela Connecting Railroad Company, Union Railroad Company of Pittsburgh, and the Newburgh and South Shore Railway Company, together with a one-seventh interest in the Toledo Terminal Railroad Company.

"The Wabash is the only carrier whose rails extend from Kansas City, Omaha, and Des Moines into the heart of eastern territory," the application said.

"There is need for direct passenger service between the Atlantic seaboard and the territory west of the Mississippi river, avoiding unnecessary inconvenience to the traveling public in being required to change trains at junction points."

"The acquisition by the Wabash of a direct route from the western territory to New York, over which route through passenger and freight service would be operated without transfer at any junction. The public is entitled to this service and will receive it if the Wabash is placed in a position to render it."

A sixth trunk line was suggested. "It is practicable, the application said, to create a sixth system within the eastern group consisting primarily of the Delaware, Lackawanna and Western, the New York, Chicago and St. Louis, and certain other carriers, including the Detroit Toledo and Ironton and the Virginian."

## Home Brew Tax Brings \$15,000 To Tennessee

Nashville, Tenn., July 1.—(AP)—The first month's revenue from a tax levied on malt extract for the avowed purpose of making the home brew industry pay, has divided the state of Tennessee \$15,000.

Experts in the state department of financial and taxation who said their data showed virtually all of the malt extract sold went into "home brew," today made public figures showing the sale of 300,000 pounds of malt extract in June. This was the first month of the new law's operation.

Thus the state obtained \$15,000 revenue for approximately 2,000,000 twelve ounce bottles of "home made beer." The General Assembly passed a bill at its last session placing a tax of five cents a pound on malt extract, on the basis of evidence submitted to the legislature that practically all the extract was bought by "home brew makers." Advocates urged passage to "make the home brew industry bear its share of the tax burden."

### Small Fire On Liner

New York, July 1.—(AP)—A small fire broke out on the Hamburg-American liner Deutschland shortly after her arrival today at quarantine from European ports. The blaze was extinguished in ten minutes.

The fire, of uncertain origin, spread up a metal ventilator shaft and damaged two cabins. The flames shot out to the deck before the liner's firefighting force subdued them. The liner later was docked without incident.

## Wilmer Stultz And Two Companions Killed When Plane Crashes In N. Y.

Roosevelt Field, N. Y., July 1.—(AP)—Wilmer Stultz, Amelia Earhart's trans-Atlantic pilot, and two companions were killed today in the crash of a plane Stultz was stunt flying between here and Mineola.

The two men with Stultz were identified as Patrick Costiluchi of Roslyn, and Charles Harwood of Mineola, his personal friends.

The two men with Stultz were instantly killed as the plane went into a tailspin at an altitude of about 300 feet and crashed. Stultz died as he reached the Nassau county hospital in Mineola.

It was the fourth fatal airplane crash at the Long Island fields within the past few days. In the first, Francis Phillips, son of the late John Phillips, Queens' former pipe magnate, was the victim. Next was the death of a pilot and Miss Viola Gray being killed and Miss Viola Gray critically injured. A few hours after that an army plane at Mitchell Field caught fire in the air and Corporal Elmer Barry was fatally injured, Lieut. Maxwell Ballou being severely burned.

Stultz was originally the pilot of Mrs. Frances Wilson Grayson's trans-Atlantic plane Dawn, but left her employ before that ill-fated flight was actually begun. Later she was employed by Charles A. Levine, first trans-Atlantic airplane passenger, and made a non-stop flight to Havana with Levine and Miss Mabel Ball as passengers.

When Miss Ball decided to make a trans-Atlantic flight Stultz was selected as the pilot but later transferred to the Earhart expedition. Stultz was born in Williamsburg, Pa., 29 years ago. He was married.

## NEW BRITISH PARLIAMENT ON TUESDAY

### Lawmakers To Get Busy With Reading Of Message From Throne At Noon.

London, July 1.—(AP)—The new British Parliament, with a plurality of Labor members, will open formally at noon tomorrow with reading of the speech from the throne. The speech is expected to be the longest in the history of Parliament. It also will be the first ever framed by a Labor government.

Although King George will be in London, his ill health will preclude his attendance, so there will be no state ceremony. The speech of the monarch, which is written by his ministry, headed by Premier Ramsay MacDonald, will be read at a combined session in the House of Lords by the new lord chancellor, Lord John Sankey.

It was believed today the foremost place in the speech would be given the question of peace and disarmament, with particular reference to the recent conference of Ambassadors Daves and the premier and an expression of satisfaction at the attitude of the United States on disarmament and British relations with America.

The speech probably will lay out a program of work for a period of about 13 months, with unemployment, reorganization of the mining industry, investigation of the cotton and steel industries, housing and possible electoral reform among the others items which probably will be covered.

Last week's parliamentary activities consisted principally of swearing in the new members and reelection of Captain E. A. Fitzroy as speaker of the house.

## Announce Merger Grape Companies

San Francisco, July 1.—(AP)—Merger of seven large California grape products companies under the name of the Fruit Industries, Inc., a \$30,000,000 enterprise, is announced here by Secondo Guasti, Jr., head of the Italian Vineyard Company at Guasti, San Bernardino county.

A world-wide distribution of grape products is planned by the new concern which will have offices in this city, Los Angeles, New Orleans, Chicago and New York.

The merging firms are Garratt & Company, California Wine Association, Colonial Grape Products Company, Community Grape Corporation, Di Giorgio Fruit Corporation and National Products Company.

## PUBLIC DEBT LOWER THAN IN 10 YEARS

### Government Entered Its New Fiscal Year Today With \$185,000,000 Surplus.

Washington, July 1.—(AP)—The government entered its new fiscal year today with the public debt cut to the lowest figure since the world war and \$61,000,000 on hand to reduce it still further.

Largely because of the widespread prosperity and more specifically the profits made by individual income tax payers in the "exceedingly active and constantly rising security market," the Treasury announced, total receipts in the last fiscal year were \$185,000,000 greater than expenditures, as compared with a surplus of \$37,000,000 estimated in the budget.

By applying to the public debt of the year's surplus with \$549,000,000 from the sinking fund and other debt requirements which are chargeable against ordinary receipts, the total debt was brought down to \$16,931,000,000 from \$18,604,000,000 a year ago. The remainder of the 1929 surplus is to be applied to the public debt in the near future.

Total receipts for the year were placed at \$4,033,000,000, about nine million dollars less than was collected in the fiscal year 1928, while expenditures amounted to \$3,848,000,000, an increase of \$204,000,000. Interest payments totaled \$978,000,000, a reduction of \$54,000,000 in the year.

"Income tax receipts," the Treasury announced, "aggregated \$2,330,000,000 as against \$2,174,000,000 in 1928, or an increase of \$156,000,000. The receipts from the current corporation income tax were somewhat lower than during the previous fiscal year owing to a reduction in the corporation income tax rate from 13.12 per cent to 12 per cent, but practically all of the loss occasioned by the reduced rate was made up by the increased income reported by corporations, due to increased prosperity. Back tax collections likewise showed a falling off, somewhat greater than was anticipated."

"On the other hand, there was a remarkable increase amounting to about \$220,000,000 in receipts from the current individual income tax. Until returns have been analyzed, it is impossible to assign definite reasons for this abnormal increase, but generally speaking, it was unquestionably due to widespread prosperity, the cumulative results of the reduction of surtax rates to a more reasonable point, and more specifically to increased income realized on sale of capital assets, due in the main, to an exceedingly active and constantly rising security market."

Customs duties, including the tonnage tax, brought in \$200,000,000 as compared with \$268,000,000 in 1928. Miscellaneous internal revenue receipts declined \$14,000,000 to \$697,000,000.

The rise in the expenditures total was accounted for chiefly by increases of \$105,000,000 in postal expenditures, including \$52,000,000 back pay to railroads for transporting the mails; of \$42,000,000 in internal revenue refunds; \$30,000,000 for flood control and relief; \$20,000,000 for the civil service retirement fund. The difference between 1928 and 1929 expenditures was brought down somewhat by the \$54,000,000 decrease in interest payments and the fact that the total for the former year included \$50,000,000 for war claims.

## REV. ROBT. HOLE DIES AT SHELBY

Shelby, N. C., July 1.—(AP)—The Rev. Robert M. Hoyle, 79, for 59 years a member of the Western North Carolina Conference of the Methodist Episcopal Church, South, died here early today at the home of his son, Caleb. He was superannuated after having served in a dozen or more churches and as president of five districts of the conference.

## Drv Units Keep Close Watch On Canadian Border

Windsor, Ont., July 1.—(Canadian Press)—A man sat fishing from a boat out from one of the down river docks. He did not catch any fish but he seemed to be a patient chap. In fact, he was so patient that the boys at the neighboring liquor wharves became suspicious. They talked with a police officer who later drifted past in another launch.

"How are they biting?" he asked the patient fisherman. "Not so good," responded the fisherman. "I wouldn't think so," exclaimed the officer, as he yanked the other's rod out of the water and found the line was minus a hook. A search of the strange fisherman revealed a book containing numbers and names of suspected rum craft, numbers of auto licenses, both American and Canadian, and the telephone numbers of Detroit prohibition units.

"Just another undercover man for the American feds," sighed the constable, making his report. "We won't bother them as long as they stay on public highways and waterways."

## WIFE SLAYER ON TRIAL AT CHESTER, S. C.

### Special Venire Regarded as Necessary As Court Swings Into Action Today.

Chester, S. C., July 1.—(AP)—The jury that will try Rafe F. King, of Shelby, N. C., on the charge of having murdered his wife, Faye Wilson King, Sharon, S. C., French teacher, was completed shortly after 1 o'clock this afternoon. Only 40 minutes were required for the selection.

Chester, S. C., July 1.—(AP)—With a prayer by the Rev. James H. Yarborough, retired Baptist minister, that "justice and mercy be done" the Chester County Criminal Court opened here today to try Rafe King, on the charge of slaying his wife, Faye Wilson King, French teacher.

King is accused of having slain his wife at their home in Sharon, York county, on January 25 last. Her body was found in an outhouse after King had notified neighbors that she had failed to return from the Sharon High school where she taught French. There were acid burns on her mouth and cuts and bruises about the head and at first it was held that she had committed suicide. Later investigation, however, resulted in the murder charge.

A venire of 36 men was called this morning from which to pick the jury, but it was regarded as likely that a special venire would be necessary.

Circuit Judge J. K. Henry, who is presiding, called for prayer before the case was called. The minister prayed that God might "direct the court, the judge, the attorneys and the jurors and may mercy and justice be done."

The first matter of business was reading of the appointment of Harry Hines as solicitor to succeed J. Kyle Glenn, who has been made a federal judge. Witnesses to appear before the grand jury in other cases also were called.

After a half hour King took his seat at counsel table. His aged parents, Mr. and Mrs. W. P. King, of Shelby, N. C., were in court but did not sit with him.

After handing out eight bills of indictment to the jury, Judge Henry said: "We have Mr. Sollelhorst?" "I see only one case on the docket." The solicitor explained there were others but that there hardly would be time to take them up.

The judge then announced the case of Rafe King and Solicitor Hines said the state was ready. Thomas F. McDow, of York, announced ready for the defense.

Although court adjourned for 15 minutes to allow the clerk to conduct a sale, it was 40 minutes before it reconvened. The judge then excused W. E. Craik, Chester man, factor, who pleaded business and who agreed to pay \$25 to procure some one in his place.

## Jasper Hoell and H. L. Joyner Killed When They Came In Contact With Live Wire Under Bridge From Morehead City To Atlantic Beach; Funeral Services Here This Afternoon.

Jasper Hoell, 31, and H. L. Joyner, 33, both of this city, were electrocuted about 11:30 Saturday night while out fishing by coming in contact with a live electric light wire under the bridge leading from Morehead City to Atlantic Beach, about one hundred feet from the draw on the beach side.

Funeral services for the victims of the tragedy were conducted this afternoon. The body of H. L. Joyner, which was recovered from the sound this morning about 9:30 o'clock was brought to Greenville this afternoon by motor hearse. Funeral services were conducted at the family burying ground a few miles from the home of Mr. Joyner's father, this afternoon at 3 o'clock.

Funeral services for Jasper Hoell were conducted from his late home on Tenth street this afternoon at 3 o'clock by Rev. R. J. Bamber, pastor of Eighth Street Church of Christ. Burial followed in Greenwood cemetery.

Active pallbearers were: E. J. Edwards, W. A. Soberg, L. H. Boyling, Dick Garrett, Knott Proctor, Jack Spain, Jack Edwards and Jack Harper.

Honorary: Dick Gorman, G. V. Smith, B. B. Suggs, Claud Brown, George Clapp, Tom Gorman, G. T. Hicks, S. A. Horton, Gilbert Paul, Charlie Smith, Whit Smith and W. M. Harris.

It is alleged the wire in the cable that caused the death of the two men had burned, probably as a result of lightning. This had been temporarily repaired with bare wire. It was said the public had been warned of the spot with danger signals and a red light. The two men, who were in a row boat, tied up to a stake about 25 feet from the bridge. One of them when attempting to cast his line, fishing for sheepshead under the bridge, caught it over the wire. He overbalanced his line, pulling the boat to the bridge and in attempting to disentangle it he grabbed the uninsulated wire, his partner caught him to pull him back from the wire, making a double contact and killing both men instantly. In falling, they caused the boat to capsize and the third occupant, F. A. Ellis, of Grimesland, fell into the water was compelled to swim for his life. On reaching the bridge he gave the alarm. The coast guard was notified and the crew from Fort Macon and from patrol boat 232 responded instantly.

Captain Goodwin, of Fort Macon, conducted the search which continued until 4 o'clock Sunday morning at which time the tide changed and search was suspended until 8 o'clock. The body of Jasper Hoell was found about 150 yards from the scene of the tragedy about 12:30 Sunday. Search was continued for Joyner but this proved fruitless until this morning about 8:30.

Both of the dead men married with families. Joyner is survived by a wife and one child, and his mother and father. Mr. and Mrs. Luther Joyner, of this county.

Besides his wife and two children, Juanita and Martha, Jasper Hoell is survived by his mother, Mrs. W. M. Hoell, of Vanceboro, and a sister, Mrs. J. R. Gladson, of Chicod.

Both men were members of the tobacco industry of this city. Hoell had been employed by Gorman's warehouse for about four years and Joyner was an auctioneer, having been employed by various warehouses in this and other tobacco centers during the last several years.

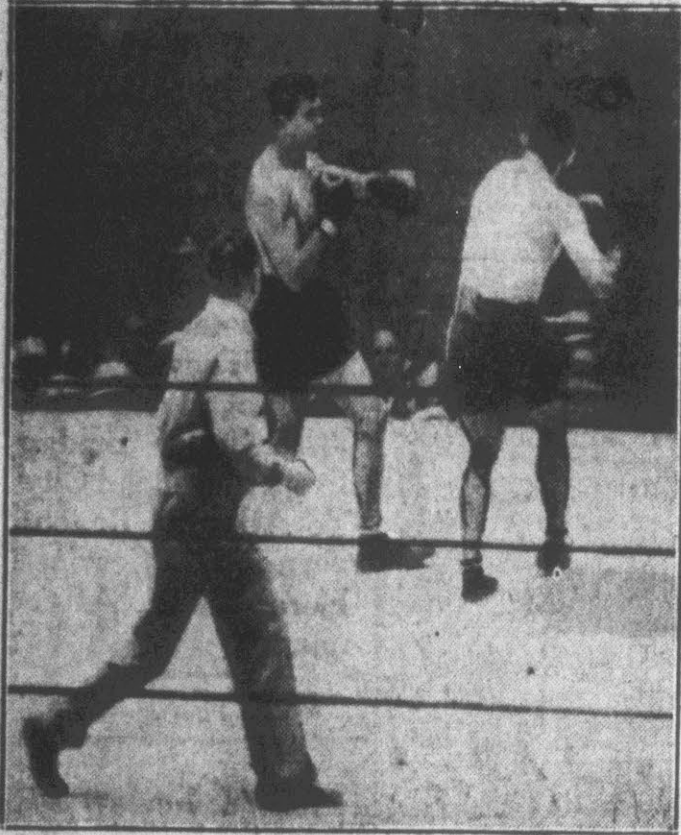
## Lindy Takes First Flight In Glider

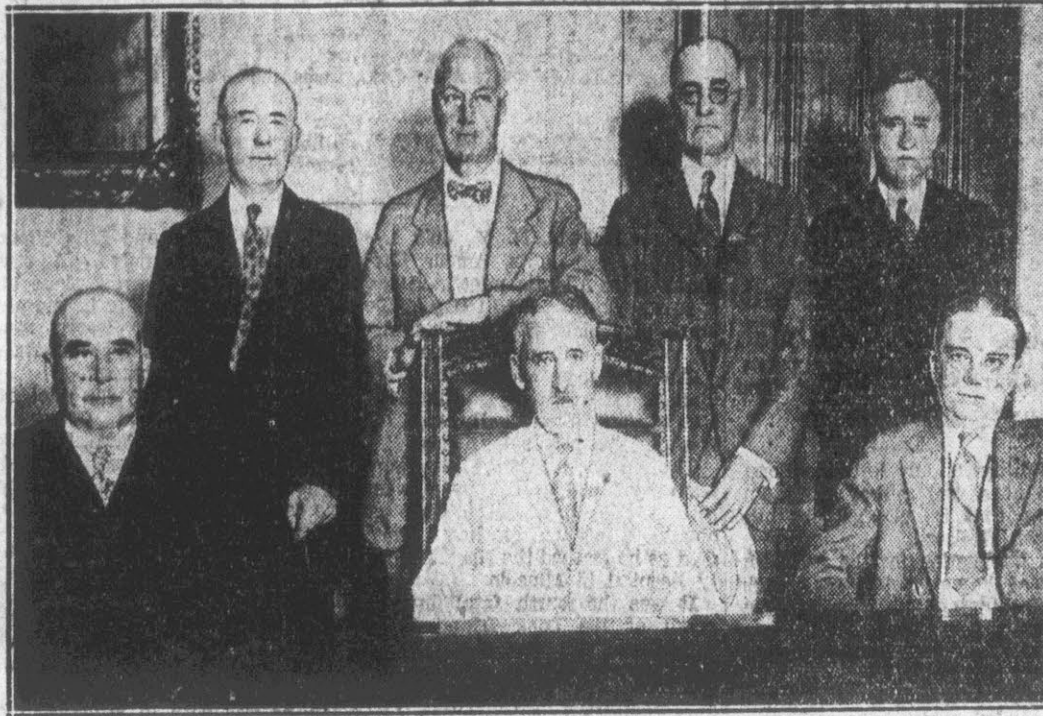

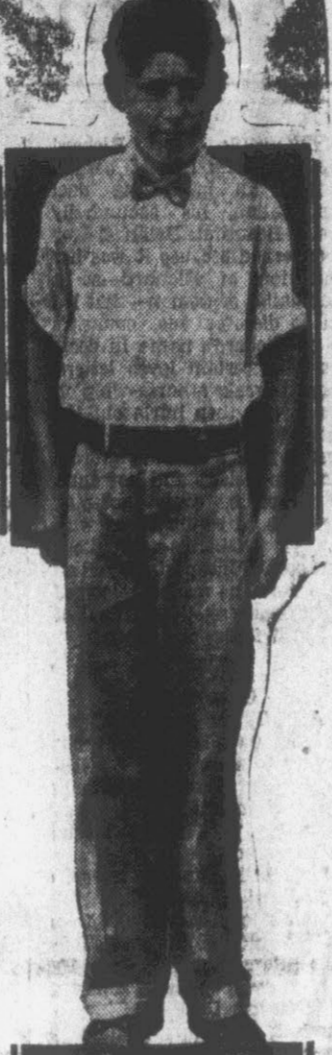

# BOBBY JONES CLAIMS MORE GOLF HONORS

By BRIAN BELL (Associated Press Sports Writer) Mamaroneck, N. Y., July 1.—(AP)—Robert T. Jones, Jr., started back home to his Atlanta law office today with the open golf championship cup he won in a play-off for the title.

The southern city today is the golf capital of the United States, for Bobby's third victory in the open comes when the amateur championship cup is paying a visit of a year to the clubhouse of the East Lake Club, country home of the Atlanta Athletic Club, for the fourth time.

In winning his third championship, the great Jones played golf only as he can play it. "I saw it, but I still don't believe it," said a golfer of fair ability after the king of amateurs had defeated Al Espinosa, a clever professional, by 23 strokes in a 36-hole play-off over the trap-footed west course of the Winged Foot Golf Club.

In the closing round of the play Saturday, Bobby "blew" the title by taking two sevens on par four holes. He used up his stock of sevens then and there. He had two strokes in the play-off, one as a result of a two-stroke penalty, but to offset these black marks were 20 fours, nine threes, four fives and one two.

Never has a championship been decided by such a one-sided score. Jones' margin of victory was 23 strokes, a 36-hole total of 141 to 164 for Espinosa. The courageous Chicago professional went down-but he never quit. He began to slip early in the day and grew steadily worse but he never lost his smile and there was no suggestion of anything but sincere admiration for a great golfer as he wrung Bobby's hand in congratulation at the 36th green.

He never did get going and could not "break" 80. He had a bad round of 84 in the morning, taking 45 "blows" as the pros call strokes, one the second nine. In the afternoon his best was an even 80.

The amateur champion, after a wobbly start, going three strokes over par on the first three holes, hit his stride. After a wild six on the par four first hole, his consistent flux during the championship, he slipped over par again at the short third to take four. Thereafter his slips were few and far between. Out in 37 one over par, in spite of his starting six, he clipped a stroke from par coming home to score 72, an exacting par figure for a great golf course which permits no liberties. The 35 for the home coming journey was even more remarkable in that it included a six at the 15th hole, where his tee shot came to rest under a brush, and he had to take it out with a penalty of two strokes.

The real Jones brand of golf was displayed in the afternoon when he held par even for the first nine holes and then drove the executive old man to cover in a complete rout with 33 on the second nine, all threes and fours—three threes and six fours. If Al had not removed himself from active competition in the morning when he was 12 strokes in arrears, he would have been "fired to death" in the afternoon.

It was not easy sailing for Bobby. Not all his shots were straight down the middle. He was in traps on three holes during the day and on 12 holes his ball found rough. Compared to the plight of the unfortunate Espinosa, whose woods and irons consistently refused to behave, the amateur's troubles were inconsequential: the Chicago star visiting traps on 11 holes and found himself in the rough on 29 holes.

Jones now has won nine national championships in the United States and Great Britain. Besides these, he has won American open triumphs. He has won the U. S. amateur crown four times and the British open twice, all within seven years.

## STOCK MARKET

New York, July 1.—(AP)—Stiffening of call money rates checked the resumption of the upward price movement in today's stock market. Bullish operations started off at a brisk pace, with a number of the public utility, electrical equipment and railroad shares pushing into new ground. But reactionary tendencies developed when call money became scarce and the rate was boosted.

Call money renewed unchanged at 10 per cent and advanced to 12 around mid-day, with indication that the rate would work higher within the next day or two. Upwards of \$60,000,000 in loans were called during the morning. Time money turned easier, some 30 days loans being arranged as low as 7-1/2 per cent.

There was little in today's news to influence the price movement. Greens Canada Copper ran up more than 6 points on the announcement that Anaconda directors had made an offer of exchange of Anaconda for Greens Canada and Andes copper stocks. Anaconda turned heavy after the announcement.

Investment bills were in brisk demand and held their gains fairly well through the mid-day reaction in the general industrial list. A. C. St. Louis, San Francisco, Peru, Marquette, C. & O. Chesapeake Corporation, Union Pacific and Norfolk & Western all moved into new high ground, the gains ranging from 1 to 5 points.

General Electric ran up 10 points to a new high of 334 3/4 but dropped back later to around 327. Air Reduction and Columbian Carbon each were marked up more than 9 points to new high records at 159 3/8 and 204 3/4 respectively. Westinghouse Electric common and preferred, and Allied Chemical also moved into new high ground. U. S. Steel sold as high as 192 3/4 and then dropped back below 190, but fresh buying support was supplied and the stock rebounded in the early afternoon.
