BEGIN BATTLE FOR LIFE OF WIFE KILLER

Judge Henry Overrules Motion For Verdict of Not Guilty in Rafe King Case

Chester, S. C., July 5.—(AP)—Efforts to obtain a directed verdict of "not guilty," for Rafe King, on trial for the murder of his wife Faye Wilson King, failed today, when Judge John K. Henry overruled a motion of counsel for the defense.

The state having rested its case yesterday, the defense today began the battle for King's life. Attorney Thomas F. McDow announced that the defense wanted to make a motion, but that he was unable to do so, since the state was planning to bring in an additional chemist's report. Solicitor Hines said he would not get the report in time and it was then that Attorney McDow introduced this motion:

"The defendant moves for a directed verdict of not guilty, on the ground (1), that there is not sufficient evidence to warrant the submission of the case to the jury; (2), because all of the evidence presented by the state, even if admitted to be true, is not sufficient to prove the defendant guilty; (3), that all of the evidence of the case being circumstantial, a verdict of not guilty should be directed for the reason that the state has failed to prove any one of its numerous theories as set out in the indictment; (4), on the ground that the state has utterly failed to prove any motive, or that the defendant was in any way concerned with or aided in the death of Mrs. Faye Wilson King."

When Judge Henry overruled the motion, the defense proceeded, and Tom Moss, sister of King, was first witness to take the stand. She testified that on the night Mrs. King was killed, she was in the kitchen and saw King go to the closet and take out a suit of clothes, later discovered in the attic, and on which human blood spots were found. She said she did not give it to King because it was his wedding suit, and she felt he would not want to wear it. She testified further that the clothing, including the vest and shirt, were found on the trunk in King's room. The brown suit she got for him to wear was introduced in evidence by the defense.

A letter alleged to have been written by Mrs. Faye Wilson King on the morning of her death and addressed to King's mother, was introduced into the evidence and read. The letter, said King being sick but said they wanted to come visit her as soon as possible. A letter to a Shelby bank, saying King would come to the bank in a few days was introduced. It was signed by King.

Colonel Arthur L. Gaston took the witness on cross-examination. He asked her if she remembered asking one of the neighbors, if she thought Faye killed herself or if she thought Rafe killed her. Mrs. Moss said she did not remember King saying anything to her about the insurance policies, when Colonel Gaston asked her if she didn't say to King that he could get the policies later. She said she did mention something about the doctor's bill. She said she had no idea how the policies got to Shelby, since King did not return to the home.

Mrs. Moss testified that she missed the "wedding suit" when she was helping her brother pack up several weeks after his wife's death. She admitted she said nothing about it. Colonel Gaston asked if Sheriff Quinn was not present when she was packing and she said he was.

"And you said nothing about the missing suit?" Colonel Gaston inquired. Colonel Gaston then asked if Mrs. Moss on the night of Mrs. King's death didn't ask Clyde Reagan, of Charlotte, Mrs. King's brother-in-law, if he thought King did it. She said she didn't recall.

There was a stir in the courtroom, and Judge Henry ruled that the question and answer be stricken from the records. On re-direct examination, Judge B. T. Pais, of Shelby, asked about the day Mrs. King was heard by neighbors crying. Mrs. Moss previously had testified on cross-examination she did not know about Mrs. King crying. Judge Pais' question as to a subsequent conversation between King and his wife was not allowed. Judge Pais then asked Mrs. Moss to examine King's clothes, which had been placed in evidence and see if the name was on any of them except the one found in the attic. She replied in the negative.

Dr. E. A. Houser, of Shelby, was the next witness. He testified he made an examination of Mrs. King and found she had syphilis. Mrs. King then resigned her position in the Shelby schools, this was in February, 1928, the physician said he gave her treatments. Dr. Houser

ONE FATALLY INJURED IN CAR STRIKE

Two Suffer Minor Injuries In Hand-to-Hand Fighting At New Orleans.

New Orleans, July 5.—(AP)—A hail of bricks greeted the first street car to be operated in New Orleans since the carmen's strike started last Tuesday and after 20 minutes of operation it was returned to the barn.

The car was manned by imported operators and were guarded by a squad of police armed with sawed-off shotguns and pistols. Strikers and their sympathizers hurled bricks at the car as it went through Canal street but no serious injuries were reported.

New Orleans, July 5.—(AP)—After a night of force hand to hand gang fighting between striking union street carmen and strike breakers in which one man was probably fatally shot and more than two hundred slightly hurt, New Orleans public service inaugurated the operation of street cars on eight designated lines today with strike breaker crews under protection of police men accompanied each car taken out of the barns while heavy details were assigned to the car barns where the strike breakers are housed in an effort to prevent further outbreaks of open warfare between the strikers and several hundred street operators brought into New Orleans last night.

FRANCE FACES CABINET CRISIS ON DEBT ISSUE

Storm Of Resentment At Settlement With America Reported At Paris.

Paris, July 5.—(AP)—The government's viewpoint on the question of ratification of the Mellon-Berenger debt accord received another jolt when the foreign affairs committee of the Chamber demanded that reservations should be incorporated in the text of the ratification bill.

By the vote, which was thirteen against twelve with nine absentees, the foreign affairs committee joined the finance committee which yesterday voted to include the safeguard reservations in ratifications.

Paris, July 5.—(AP)—A storm of resentment at the debt settlement with America today whipped the French ship of state dangerously near a cabinet crisis. There was conjecture whether the helmsman, Premier Poincare, would survive the blow and his cabinet intact, and at the same time ratify the Mellon-Berenger debt accord in a manner suitable to the United States.

The newest complication striking at ratification of the debt accord developed yesterday in the finance committee of the Chamber of Deputies, when by a vote of 17 to 16, with 11 abstaining, it decided to recommend to the chamber that reservations be included in the measure ratifying the agreement. These reservations were the old ones, providing that France will not pay America if Germany defaults on the reparations payments to France. They remain had had M. Pledier, the committee's reporter, introduce a resolution seeking separation of the reservations and the ratification measure. It was this resolution which was defeated, the report immediately resigning.

It, at a further meeting of the committee today, the premier is unable to obtain his point he may feel it necessary to resign, an action which members of the "left" would certainly use to have more of their number included in a new cabinet. M. Poincare's adherents saw in the entire play nothing more than a desire to use every pretext to overthrow the "Armistice Day cabinet" for the premier into retirement or at best compel him a leftist ministry.

Installation of the newly elected officers and selection of the 1930 meeting place will occupy the attention of the publishers at the final meeting tomorrow morning. Action on several resolutions and general discussion of problems peculiar to the profession will also be made at this time. Officers are to be chosen this afternoon.

Administration Changes Regarded As Favorable To Reduction of Navies

Washington, July 5.—(AP)—Administration changes in Japan, Great Britain and the United States—the three leading naval powers—are regarded in official and diplomatic circles here as having brought to the fore viewpoints favorable to naval reductions.

Since President Hoover was inaugurated, March 4, the United States has taken the leadership in pressing not only for a world-wide policy of naval limitation, but for reduction in fighting fleets, no matter how drastic. In connection with this development, Prime Minister MacDonald of England, promptly initiated conversations with Ambassador Daves looking toward a basis of agreement on the naval question between the two major naval powers.

Former Premier Tanaka of Japan, officially informed the American government that Japan would be phoe-heartedly favorable to any steps which might lead to some solution of the naval problem, and the Liberal government of Premier Yuko Hamaguchi, who has just taken office, is expected by diplomatic and official circles to play an active part in any disarmament negotiations.

ONE CASUALTY MARKS FOURTH IN THIS STATE

Observance Of Independence Day Unusually Orderly; Oratory Predominates.

(By the Associated Press.) There was oratory, but little else to make July 4 of 1929 a memorable day in North Carolina. Not a single death from fireworks was reported, automobile accidents were without fatalities, and a lone drowning made up the holiday's casualty list.

J. D. Chinness, 15, of Wadesboro, was drowned in a creek near there while swimming. He was on a picnic with members of the North Wadesboro Baptist Church.

For the most part residents of the state seemed to spend the day in mountain retreats or at seashore resorts. Crowds swarmed the coastal beaches while the lure of cool mountain shadows drew other thousands.

However, the day did not pass without formal observance in most of the larger cities. A native son, Joseph M. Dixon of Montana, assistant Secretary of the Interior, former governor of that state and a former United States Senator, came home to aid in the annual celebration at Guilford battlefield.

As principal speaker of the occasion, Mr. Dixon traced the course of early American history and found the turning point in the war for independence at the battlefield where he spoke of when the men of Nathaniel Greene halted the onrush of Lord Cornwallis' red coats. The assistant Secretary of the Interior is a native of Alamance county and a graduate of Guilford College.

South Carolina Woodmen of the World joined hands with North Carolina members of the fraternal order in celebration of the day at Concord. Some 25,000 took part in a parade and heard patriotic addresses.

The state capital's only formal observance of the day was at North Carolina State College, where State Senator J. M. Broughton addressed summer school students.

Upholding the fame of early American leaders, Senator Broughton said "Gossip novels" attacking their character would deprive them no whit of honor in the history of the nation.

Hundred Fifty-nine Deaths Reported From Various Causes Throughout Nation; Automobile Fatalities Greater Than Last Year; Fireworks Play Minor Part In Casualties.

Chicago, July 5.—(AP)—America surrendered 159 lives to the observance of its 153rd birthday anniversary yesterday. The Fourth of July death toll this year was 46 under 1928, the reduction being attributable chiefly to the decrease in the number of deaths from drowning and from the heat. In only one division did the 1929 fatalities exceed last year's, and that was in automobile accidents with 70 this year as compared with 64 last.

BIG CHICAGO PLANE STILL IN AIR TODAY

'Untin' Bowler Reported On The Go In Hudson Straits District.

Ottawa, Ont., July 5.—(AP)—The "Untin" Bowler, the Sikorsky amphibian manned by Parker Cramer, Bob Gast, co-pilot and Robert Woods, aviation editor of the Chicago Tribune, was in the air at 9:37 o'clock this morning, said a message received here from the federal wireless station at Port Burwell, on the Hudson Straits.

Says Wilmer Stultz Was "Very Drunk" At Time Of Death

Mincola, N. Y., July 5.—(AP)—The report of Dr. Alexander O. Goettler, who made a chemical analysis of the vital organs of Wilmer Stultz, trans-Atlantic flier who was killed with two passengers in an airplane accident last Monday, declares "the man was very drunk at the time of his death."

Automobile fatalities, on the other hand, bounded upward from 54 last year to 80. Nearly one-third of the country's total toll was taken by the middle-west. The middle Atlantic states which last year led the country with 48, had 30 less yesterday, although more than half the deaths from fireworks in the country occurred in that section. The west and the mountain states had the smallest death lists, each section reporting three.

Temperatures generally were lower throughout the country yesterday than was the case July 4, 1928, when 12 deaths resulted from heat alone. So far as reports to the Associated Press showed, there was only one death yesterday from heat, and that was in Chicago.

Last year airplane accidents took four lives, whereas yesterday only one death occurred from this cause. A year ago, too, there were three deaths in automobile races. The only death from that cause reported this year was at Pompano, Fla., where a driver was killed after he had crossed the finish line in third place of a 10-mile dirt track race.

Stricter laws regulating the sale and use of fireworks was credited with keeping the number of deaths and injuries from this cause down. In Michigan, particularly, enforcement of a new state fireworks law was reported as most effective.

Chicago ordinances prevent the sale of fireworks, but convenient suburbs provided all types of cannon crackers with the result that the Fourth here was unusually noisy. Hundreds of persons were injured, but no deaths occurred.

Another Liquor Shipment Nabbed

Jacksonville, Fla., July 5.—(AP)—A colony of artists of the camouflage school has established itself at Malabar, Fla., and its work is attracting attention from the officials. Two weeks ago the critics, in the person of state and federal officers, seized a carload of liquor camouflaged as peppers, consigned from Malabar to a New Jersey point. Yesterday federal agents contacted a carload of contraband disguised as lumber enroute from Malabar to Philadelphia.

Meanwhile Helen, standing before the largest mirror in her bedroom, stared at the reflection of her loveliness with troubled eyes, vexed, surprised, wondering:

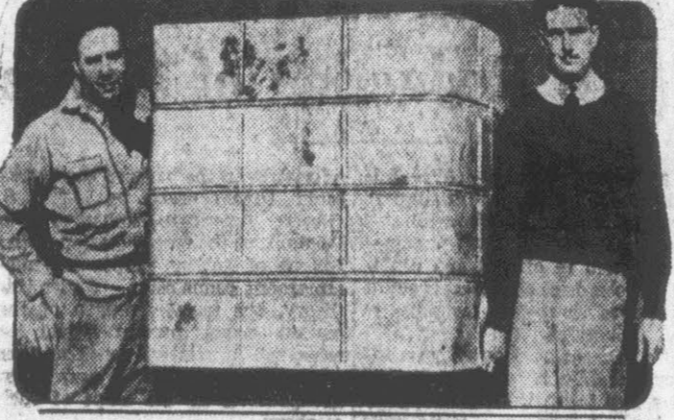
"Could it indeed be true?—Prophetous!"

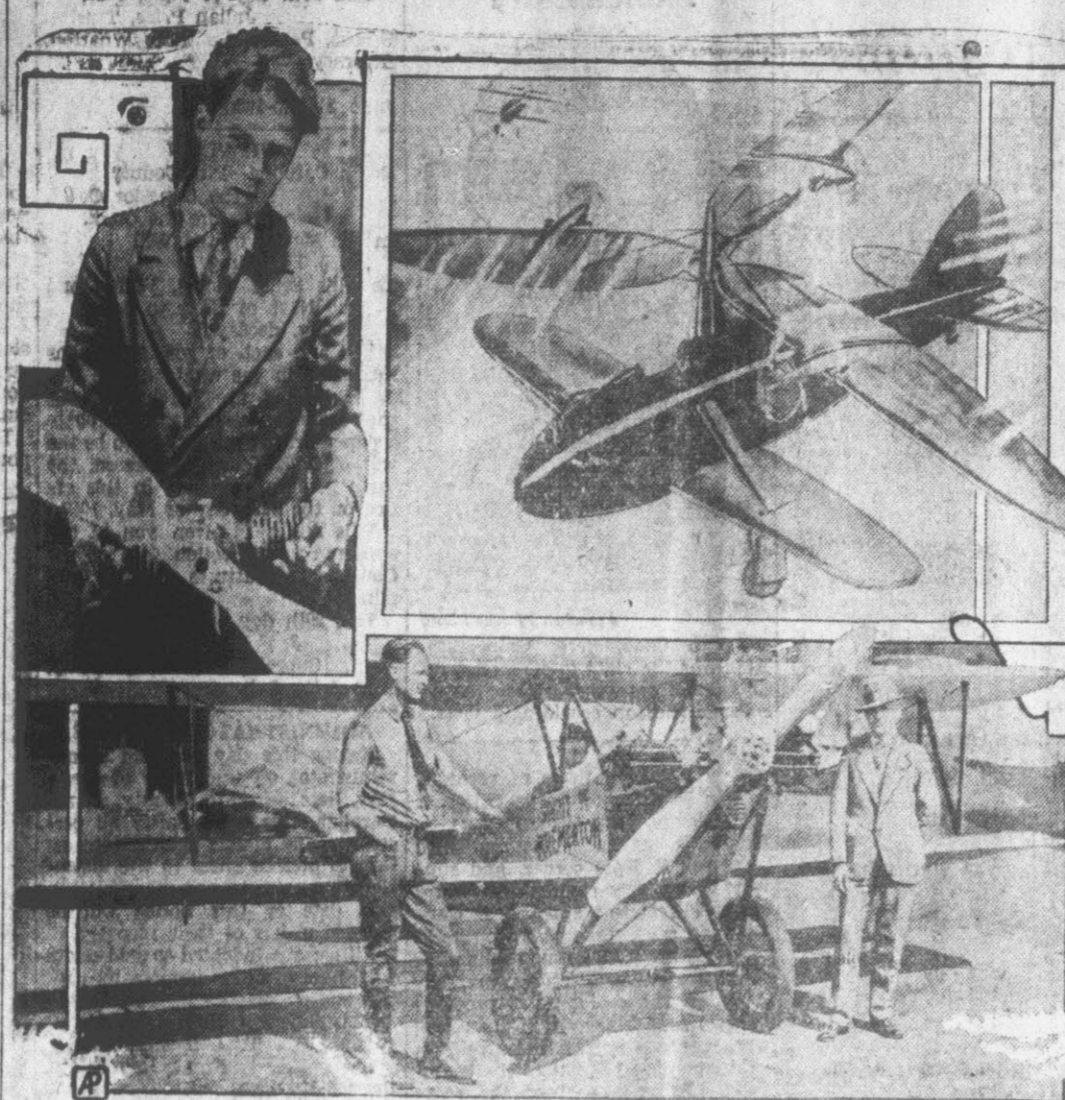

Maple Leaf Furnishes Ideal For New Plane



Russell Jamieson (left) has invented a two-cylinder aviation motor which is without valves and has only four moving parts. New York, (AP)—With the world thoroughly air-minded, the talk now is not so much of "can we fly" as of "how we do fly." Over the land inventors are sitting up nights devising unusual craft which are expected to revolutionize the aviation industry.

For instance, down in San Antonio, Tex., two inventors are working on the idea of the falling maple leaf and the rain drop.

George S. Harris and Lewis L. Leonard noticed that when a maple leaf fell, it rotated slowly. Whereupon they set to work on a five-winged gyro plane, calculated never to spin or dive but to float down gently should its three motors fail.

Three of the wings are set on a vertical shaft above the fuselage, similar to the rotating wings of the auto-gyro. Two wings, equipped with allersons to maintain lateral stability, are fixed, and set at right angles to the fuselage.

The plane's power plant consists of three two-cylinder air-cooled engines placed near the center of each of the rotating wings. The inventors claim the ship will fly as well with one engine as with three because their weights are balanced.

The shape of the rain drop was studied for the design of the fuselage.

Up at Bremerton, Wash., a 24-year-old machinist, Monte C. Opsata, studied aviation from books. He took a flight and the plane crashed.

Although he never had flown, Opsata, who is a machinist, believed he could construct a better craft than the one which fell. He began in the basement of his home and after more than a year of spare time produced a small biplane that has been successful in test flights. It cost less than \$500. Most of the parts were made at home with a pocket knife or bought at a local hardware store. The motor and wheels were obtained out of town.

The plane has a wing spread of 20 feet, a single seat, and is powered by a two-cylinder 30-horsepower motor. Opsata hand carved the propeller from a piece of Douglas fir.

A small aviation motor which will revolutionize the production of light engines is the dream of Russell Jamieson, race driver and automotive engineer of Dayton, Ohio.

Jamieson has developed two small motors, one of two cylinders and one of four, both of which are without valves, and each having but

four moving parts. One of the motors, weighing but seven pounds, including a 32-inch steel propeller, has developed four and a half horsepower.

Pamieson claims for his four-cylinder motor that it is one of the few motors lighter in pounds than the number of horse-power units it is capable of developing. The motor weighs 40 pounds, and is said to have developed 50-horsepower at 7,200 revolutions per minute.

The two-cylinder motor, attached to a glider, kept the device in the air for four hours. The same motor attached outboard to a motor boat with the propeller clear of the water, drove the craft at a speed of 47.71 miles per hour.

STOCK MARKET

New York, July 5.—(AP)—Resumption of vigorous bull operations after the holiday in today's stock market encountered rather heavy profit-taking, but a wide assortment of important industrial and rail stocks were sent into new high territory.

The market opened with a heavy accumulation of buying orders, resulting from the sudden breaking of the call money rate on Wednesday, and the strength of American shares on the London market yesterday.

Call money renewed at 7 per cent, and although there was some calling of loans early in the session, replacement funds were easily found. Traders were inclined to move cautiously, however, on the theory that the technical position of the market had been weakened by the prolonged upturn.

There was little in the day's news to effect the price movement. Although the news coming to hand was generally favorable, several more satisfactory June sales reports and the taking of \$5,000,000 in London by the Irving Trust Company.

Merger rumors were again rife, indicating a possible combination of United Aircraft and Sikorsky, Inc., and Steel and Republic, and a combination of the National Gas Properties of Columbia Gas and Electric and Cities Service. It also was reported that Texas Corp., Phillips Petroleum, and Skelly Oil were forming a company to pipe natural gas to Chicago.

A feature of the day's trading was a jump of more than 3 points in U. S. Steel, which carried it to the 200 mark for the first time, but the gain failed to hold. Auburn Auto was again a spectacular performer, shooting up more than 24 points to a new peak, then losing most of its gain.

Such shares as General Electric, Westinghouse Manufacturing, Underwood Elliott Fisher, Norfolk and Western, Union Pacific and New York Central rose about 4 to 7 points to new peaks, and Western Union and DuPont made wide gains. Oils and food shares were well supported. Atlantic Refining and Fleischmann reaching new high ground.

Otis Elevator, however, tumbled 3 points, Commercial Solvents 4, and American Telephone, American Water Works, Columbian Carbon, American Power and Light, Pere Marquette and Davidson Chemcan 2 to nearly 3 points.
