BRITISH SUBMARINES COLLIDE; ONE SINKS

Entire Crew Of H-47 Believed Dead After Collision In Channel

INTENSE HEAT CAUSES SEVEN DEATHS TODAY
Numerous Prostrations Also Reported In The East And Mid-West Sections.

Undersea Craft Hit by Submarine L-12, a Larger Vessel, and Sank So Quick That Only Two Of Crew Of 23 Were Saved; Larger Boat Lost One Man And One Injured; Dock Yard Tugs Go To Scene Of Disaster With Salvage Gear.

London, July 9.—(AP)—The First Lord of the Admiralty announced in the House of Commons this afternoon that no hope could be entertained for the remainder of the crew of the submarine H-47 being rescued alive.

The First Lord added that the salvage of the H-47 in deep water was most improbable. The best diving apparatus available had been dispatched to the scene.

London, July 9.—(AP)—The British H-47 with 21 of her crew believed dead or trapped within her today was sunk in 270 feet of water in St. George's Channel off the Pembroke coast to the west of Fishguard.

The undersea craft was struck by the submarine L-12, a larger vessel, and sank so quickly that only two of her normal crew of 23 were saved.

Details of the circumstances under which the disaster took place and how badly the submarine was smashed when she went down were lacking in first announcements by the Admiralty.

It appeared, however, that the H-47 sank in about 270 feet of water, or nearly three times that in which the American submarine S-4 sank in 1927 and considerably deeper than that to which the S-51 sank in 1925. Salvage operations at such a depth would be exceedingly difficult.

The Admiralty statement said that the H-47 sank after a collision with the L-12 this morning about 22 miles to the northward of Small Lighthouse and about 20 miles west from Fishguard.

Beyond the details of the two men rescued from the stricken ship and the two aboard the L-12 involved, one being missing the other critically injured, the Admiralty had no further report.

Arrangements were being made with all dispatch to attempt salvage of the H-47 despite the depth of the water in which it sank.

FIVE LIVES CLAIMED IN AIR MISHAPS

Two Army Fliers Burned To Death In Plane Crash At Colon, Panama.

(By the Associated Press.)
Five persons were killed yesterday in three airplane crashes. At Colon, Panama Canal Zone, Lieut. Henry F. Sessions, of Georgia, and Lieut. William H. Bleakley, of New York, were burned to death in the fall of their army plane at Port Clayton Field. The men were engaged in a routine training flight.

At Montreal, Quebec, Captain E. A. Golds, chief instructor of the Montreal Light Aeroplane Club, and C. H. Dowd, of Montreal, were killed when their plane fell and burst into flames.

Thomas M. Gurley, an air mail pilot on the New York-to-Washington route, plunged several hundred feet to his death at Berlin, N. J., when a plane he was flying on his day-off caught fire. Gurley was a resident of Philadelphia and had flown to Pine Valley, N. J., to visit friends.

RUM EXPORTS FROM CANADA ON DECREASE

Increased Border Patrol Cuts Down Shipments 357,155 Gallons During Year.

Washington, July 9.—(AP)—A drastic lowering in the exportation of alcoholic beverages from Canada to the United States through the port of Windsor last month as compared to June, 1928, was announced today by the treasury which figured a decrease of 357,155 gallons.

The statistics prepared for the treasury by the Canadian collector of national revenue at Ottawa show that in June, 1929, after the establishment of an increased border patrol only 112,878 gallons were exported to points in the United States, while the figures for June, 1928, show that 470,033 gallons of alcoholic beverages were exported.

The treasury attributed the decrease to the effectiveness of the border patrol established to stop the smuggling of liquor from Canadian points between Lakes Erie and Huron into adjacent American territory.

The statement issued by the treasury said: "The following is a comparative statement of reports from Canada to the United States of alcoholic beverages through the port of Windsor for the month of June, 1928, and June, 1929:

Customs Officials Seize \$1,000,000 Worth Opium From Chinese Vice Consul

San Francisco, July 9.—(AP)—Eleven pieces of baggage brought from China to San Francisco to Mrs. Susie Ying Kao, daughter of the Chinese minister to Cuba and wife of the Chinese vice-consul here, disgorged a fortune in opium when opened late yesterday by customs officials.

The baggage which was seized last Friday as the result of reports received from representatives in China of the United States Treasury Department, was opened upon instructions from Washington that Mrs. Kao was not entitled to diplomatic privileges.

Customs officers opened trunks suitcases in the presence of Mr. and Mrs. Kao and their attorneys, who protested that the act was a violation of a Chinese-American treaty. Mrs. Kao was not detained.

The value of the opium was fixed by customs officers at \$1,000,000. Three other trunks said to contain only personal property of the diplomat's wife were not opened, but were held by customs agents pending further instructions from the Treasury Department.

Mrs. Kao declared the opium was not her property and that she had not known the trunks contained the drug. She said she had been persuaded by "wealthy and influential friends in China" to bring the 11 pieces of baggage into San Francisco under diplomatic status and believed that they had contained presents for friends in this country.

Pathfinder Believed To Be Well On Way Across Atlantic Ocean Today

New York, July 9.—(AP)—Up to 3 p. m. today, about 30 hours after the departure of the monoplane Pathfinder from Old Orchard, Me., on a 4,232 mile flight to Rome on a new world record, should be nearing the Spanish coast.

Clear weather and favoring winds were ahead of the airmen, who presumably were flying high out of the range of trans-Atlantic ships.

New York, July 9.—(AP)—Aided by following winds, the monoplane Pathfinder, carrying Roger Q. Williams and Captain Lewis A. Yancey was presumed today to be well out over the Atlantic on its way to Rome.

WATSON URGES MORE SPEED ON TARIFF ISSUE

Senator From Indiana Would Have Everything Ready For Action.

Washington, July 9.—(AP)—Speeding up of the tariff bill work by the Senate finance committee to insure its preparation for the Senate by the time the recess ends August 19, is demanded by Senator Watson, of Indiana, the Republican leader.

His move is seen as the first step in an administration effort to wind up the tariff contest before the regular session opens in December.

Chairman Smoot, of the committee, has been apprehensive of late that the bill wouldn't be ready by August 19.

President Hoover wants this highly controversial legislation out of the way and on the statute books before the biennial Congressional campaigns begin next spring. The Republicans want to keep the impending tariff struggle in the Senate out of that campaign, if possible.

Democrats have given informal assurance that they would cooperate to see that the tariff bill is acted upon during the extra session. But the Republican independents who are organizing in opposition to the House measure have given no indication that they are in a hurry to see the legislation enacted.

The Senate tariff contest is more than a month away but there are many predictions already of stormy days and perhaps lengthy debate.

Advocates of the export debenture principle of farm relief who lost out in the agricultural legislation are determined to put their plan into the tariff bill, and this issue alone may result in several weeks of dispute.

Altogether the outlook is dubious and Senator Watson, the administration pilot in the Senate, is getting out the whip to apply with the spurs in the drive to get the issue settled before December.

Meanwhile, the finance committee is going ahead with its hearings preparatory to closing the doors next week for the actual rewriting of the House measure.

Even before this work is begun, rumors are floating about the Senate corridors of the prospective form of revision to be made in the House bill. Some of the rumors say that the Republican administration group which controls the finance committee is going to wipe out the increases ordered by the House in the tariffs on building materials, including shingles, brick, cedar, maple and brick lumber, and cement.

But these are only rumors, so far.

DAIRYING IS DISCUSSED AT ROTARY CLUB

A. C. Kimbrey, Of State Extension Department, Principal Speaker.

Dairying in Pitt county was the subject of discussion at the regular weekly meeting of the Greenville Rotary club last night. The chief speaker of the occasion was A. C. Kimbrey, representing the North Carolina Extension Department.

The session was presided over by F. C. Harding, newly elected president, and other new officers were in charge of their respective positions.

Mr. Kimbrey was introduced by E. F. Arnold, director of the Pitt County Farm Department, who explained the movement now on foot to increase interest in dairying in Pitt county. The objective of the Department of Agriculture at this time, Mr. Arnold said, was to show the farmer the advantage of dairying so that the industry might become general over the county during the next several years.

Mr. Kimbrey spoke on the subject of "The Value of a Cow on Each Farm in the County," and brought out many facts of interest in this connection. He showed the progress which other communities had made under influence of the dairy industry and could see no reason why a similar condition should not be obtained in Pitt county.

He told of the registered bull sale to be conducted in the county in the near future with a view of producing pure bred stock in future years. He urged the farmer to give this sale more than passing interest and arrange for the purchase of one of the animals. The sale is to be conducted with the financial assistance of local banks and the Greenville Merchants Association.

KING CASE TO REACH JURY LATE TODAY

Arguments Before Jury In Case of Wife Murderer Completed At Noon Hour.

Chester, S. C., July 9.—(AP)—Arguments before the jury, which began the evidence in the case of Rafe King on trial for the murder of his wife, Faye Wilson King ended at 12:50 today, when Colonel Arthur L. Gaston, of Chester, finished speaking.

Judge Henry immediately announced that court would adjourn until 3 o'clock, at which time it would re-convene, and he would deliver his charge to the jury.

Adjournment until 3 o'clock will make it certain that the jury will not render a verdict until late this afternoon, or tonight.

Crowds were on hand again this morning to hear the closing arguments in the case. Court opened at 9:30.

King entered at 9:15, sleek and smiling and was greeted by his father, W. Pink King, of Shelby, who has been ill and unable to attend. King's mother also is ill and has been unable to be present several days.

After Congressman Clyde B. Hays opened his arguments at 9:35 declaring he had come to the "last word for father and son."

He said he wanted to submit his propositions:

(1) That the State of South Carolina had not established the fact that Rafe King had murdered his wife. (2) That the State of South Carolina had not established the fact that she had not committed suicide. (3) That the State of South Carolina had not proved King is not innocent.

Mr. Hoey argued that the relations between King and his wife were the best. "When did Rafe King decide to kill his wife?"

In answer to the question, he declared that there was an evidence that there was had feeling. Mr. Hoey also said King was ill at the time.

He took the state's theory that she was choked, arguing that if she had been choked with a cord there would have been more marks on her throat.

"Why did he do it?" They can't show that King in his 38 years has ever been guilty of the least bit of violence. They say on the stand that he was angered because she had contracted a loathsome disease. Then they say that since she had contracted the disease she turned on him. The State isn't consistent.

The insurance policies were discussed, Mr. Hoey pointing out that these could not implicate King. King had his policy made payable to his wife, Mr. Hoey said. "Ah," said he, "she was his rose of Sharon, his lily of the valley."

Mr. Hoey reviewed the evidence of happiness during the afternoon and night of Mrs. King's death.

Colonel Arthur L. Gaston, of Chester, began the closing argument at 11:35. He declared that King had been given the fullest trial ever accorded a man in South Carolina.

"I say that these circumstances point conclusively to his guilt that there is no reasonable doubt that King killed his wife," said the attorney.

Colonel Gaston then began reconstruction of his theory of the crime, declaring, "There is only one living human being who can contradict what I am going to say."

He described King, "approaching her with the death gleam of his eyes."

The attorney demonstrated how the woman might have fallen to her knees and then to the floor.

"There's only one man who knows I'm telling the truth."

The attorney then laid out his clothing on the floor and declared she could not have made her underwear bloody without getting her dress bloody also.

"As he carried her out, how hand rested on his shoulders and his bloody hand made this mark on her underclothes."

He later said: "They never have shown how her body was moved."

"She became his victim in his own embraces as his wife and she became his victim as a corpse in his own home," shouted Colonel Gaston.

"He committed one crime when he married her, he committed another when he married her."

PEASANTS IN SWAY TODAY IN RUMANIA

Government Appears To Have Weathered Projected Military Movement.

Vienna, July 9.—(AP)—The peasant government of Rumania, headed by Juliu Maniu, premier, appeared today to have weathered successfully a projected military coup d'etat, and to be entrenched more firmly than ever at Bucharest.

As a result of strict censorship, only direct advice obtainable, was contained in an official government communique, which said:

"Some civil agitators, known for a long time to the authorities as men without scruple or worth, organized a ridiculous plot against the form of the state, without causing the least disorder."

The head conspirator is former Colonel August Stojka. They could achieve nothing except the adhesion of two officers, Captain Cambra and Lieutenant Georgescu. Some factory workmen also joined the plotters. All are arrested.

"Investigations are being continued. All sensational reports of disorders are without foundation and perfect quiet reigns in the country. Order is secured in all particular and the army is as ever at its post."

Other reports, notably those received from travelers arriving here from the Rumanian capital were more disquieting, but even they indicated the government had the situation well in hand. There was some conjecture as to a possible connection of former Crown Prince Carol with the plot. Paris reports said he was preparing to leave that city for Bled, Jugoslavia, where he would see his son, the boy King Michael, while in other quarters there were reports he was expected at Valdes, Southern Slavia, to see his mother, Queen Marie.

The version of the affair generally accepted here was that a well bolstered plot existed to overthrow the Maniu government, reinstating the Liberal regime, which it ousted, or a military dictatorship. The government learned of the plot some time back, but refrained from making arrests until the conspirators were ready to strike, and all were obtainable.

On Saturday night the authorities arrested General Brosteanu, commander of one of the frontier armies, and about 40 others, including a number of civilian officials who were said to have handed arms and ammunition to the rebels from the arsenal.

VACANCIES TO BE FILLED FARM BOARD

President Expects To Fill Positions By Meeting Called For Next Monday.

Washington, July 9.—(AP)—Only two vacancies remained today in the membership of the Federal Farm Board, and President Hoover expects to have these filled in time for the appointees to attend the first meeting Monday.

At least one of these vacancies is to be filled with a man experienced in the production and marketing of wheat, which is likely to be the first commodity which the board will attempt to stabilize through employment of part or all of the \$150,000,000 already made available out of its \$500,000,000 revolving fund.

The other vacancy may also go to a representative of this grain division of agriculture, but the President has experienced considerable difficulty in making a selection in that field and is known to have desired, in the beginning at any rate, to have a banker on the board. If, as has been suggested, he has abandoned the idea of including a financier in the membership, it is regarded as most likely that he will attempt to give either wheat or cotton a second spokesman.

The appointive membership was brought up to six with the acceptance of the place as representative of the dairy industry by William F. Schilling of Northfield, Minn., president of the Twin City Milk Producers Association. W. S. Moscrip, secretary and treasurer of that organization, was offered the appointment but declined.

General business is represented in the membership by Alexander H. Legge, president of the International

DO WE WANT A
RIGHTEOUS CITY?

The ministers have
launched a campaign in this
city against immorality, vice
and crime, but just how far
they will get with it depends
entirely upon the attitude of
our citizens. Of course, talk-
ing against these evils might
help some to create senti-
ment against them that will
help to an extent in cleaning
up our community but so far
the matter has been men-
tioned only in a general way
with no definite plan of ac-
tion in view. If we are to rid
our city of evil several things
are necessary.

Probably the first in this
list should come the home-
life of the community and
the attitude of the parents,
for without the proper in-
fluences the younger genera-
tion cannot be expected to
develop into the kind of citi-
zens they should be. If par-
ents want their children to
grow into the right kind of
men and women, and to be
sure all parents desire this,
they must first set the ex-
ample with their own daily
lives. Given the proper
training in the home and ad-
vised against the pitfalls of
life, the chances are far
more favorable for a child
following righteous paths
than is the case when par-
ents by their own lives breed
within their offsprings a
spirit of disobedience and
lawlessness.

The next step in cleaning
up our city should be a di-
rect and ruthless campaign
against violators of the law.
Such a fight is not one for
the ministers, the police offi-
cers or the press alone. It
is one that every respectable
citizen should have a part in
if it is to succeed. Calling a
spade a spade, hewing to
the line and letting the chips
fall where they may is the
only way that we can ac-
complish a clean-up. If our
ministers and our citizens
are aware of violations of
the law here, it is their duty
to point out the specific cas-
es, aid in the apprehension
of the offenders and then be
willing to go into court and
aid in prosecuting them.

Expressions of regret that
immorality and crime are prevalent
in our community without
backing up our expressions
by definite action to rid our
community of these evils is
getting us nowhere. We ven-
ure the assertion that there
has been gambling on our
city streets today, that many
citizens do not approve of it,
we have knowledge that it has
occurred. Now how many of
these citizens have made
complaint to the police in-
stead of the gambling being
stopped? Our an-

swer is: "None;" and so it
is with other things that are
happening here. Our people
see them and know about
them but none seem willing
to make an effort to stop
them. Yet when some girl
falls as a result of a wild
drinking party or when
some other tragedy results
from whiskey drinking,
gambling and lax morals,
these same people who did
not lift their hands to pre-
vent such things are the first
to lift their voices to bemoan
the fact that our country has
gone to the dogs.

If we are in earnest about
deploring existing conditions,
here let's face the situation
like real men and women
and clean up our communi-
ty. If we are not willing to
do this, then let's quit be-
moaning the fact that these
things occur. If the majori-
ty of our people want a
good town it is possible to
make it such, but it will take
determined action rather
than mealy-mouth talk and
soft-pedal tactics.

"COLORED" TEA AT THE
WHITE HOUSE

In "capri blue chiffon,
hose of moonlight gray and
shoes of snakeskin," the
negro wife of the negro con-
gressman from Chicago tripped
across the White House
lawn and took tea with the
wife of the President of the
United States.

Under the "gay tea tents
and awnings" and to the
music of a "service band,"
some 50 wives of Congress-
men were guests of Mrs.
Hoover—including the dark
skin in snakeskin.

The White House state-
ment on the incident says
that it is the purpose of Mrs.
Hoover to have the wife of
every member of Congress
received at a White House
function, in groups of 50,
"the guests selected from the
official list in alphabeti-
cal order," and "no names
whatever omitted." So, we
are forced to believe, about
49 white wives of white
Congressmen, alphabetically
allotted to Wednesday's party,
found themselves asso-
ciated with the negro wife
of the negro Congressman—
doubtless to the great dis-
comfiture of most of them.

We are wondering how
many of this "group" were
the wives of Congressmen
from the South—or, to go
further, of erstwhile "Hoov-
er Democrats," who osten-
sible and conveniently re-
fused to believe the fully
substantiated statement of
the late campaign that Mr.
Hoover had set aside the
Woodrow Wilson order seg-
regating whites and blacks
in the Department of Com-
merce.

Not since Theodore Roose-
velt provoked a nationwide
furore by having Booker T.
Washington as a White
House table-mate had this
situation arisen in official
Washington—until now.

It may be asked, how
could Mrs. Hoover, enter-
taining all the congressional
wives, avoid the dusky De-
Priest? The congressional
wives themselves succeeded
in doing so. They have a
Congressional Club which,
up to the advent of the De-
Priest, had given member-
ship automatically to all
wives of members. When the
cloud from Chicago darkened
the club horizon, the by-
laws were promptly amend-
ed to require that, hence-
forth, applicants for mem-
bership must be vouched for
and introduced by other

the warehouses of that district.

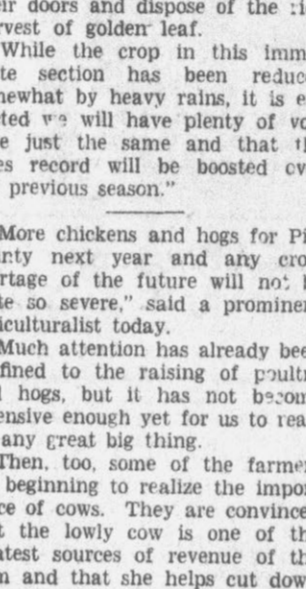

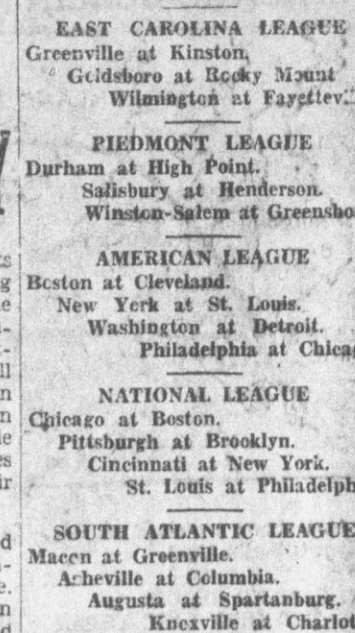

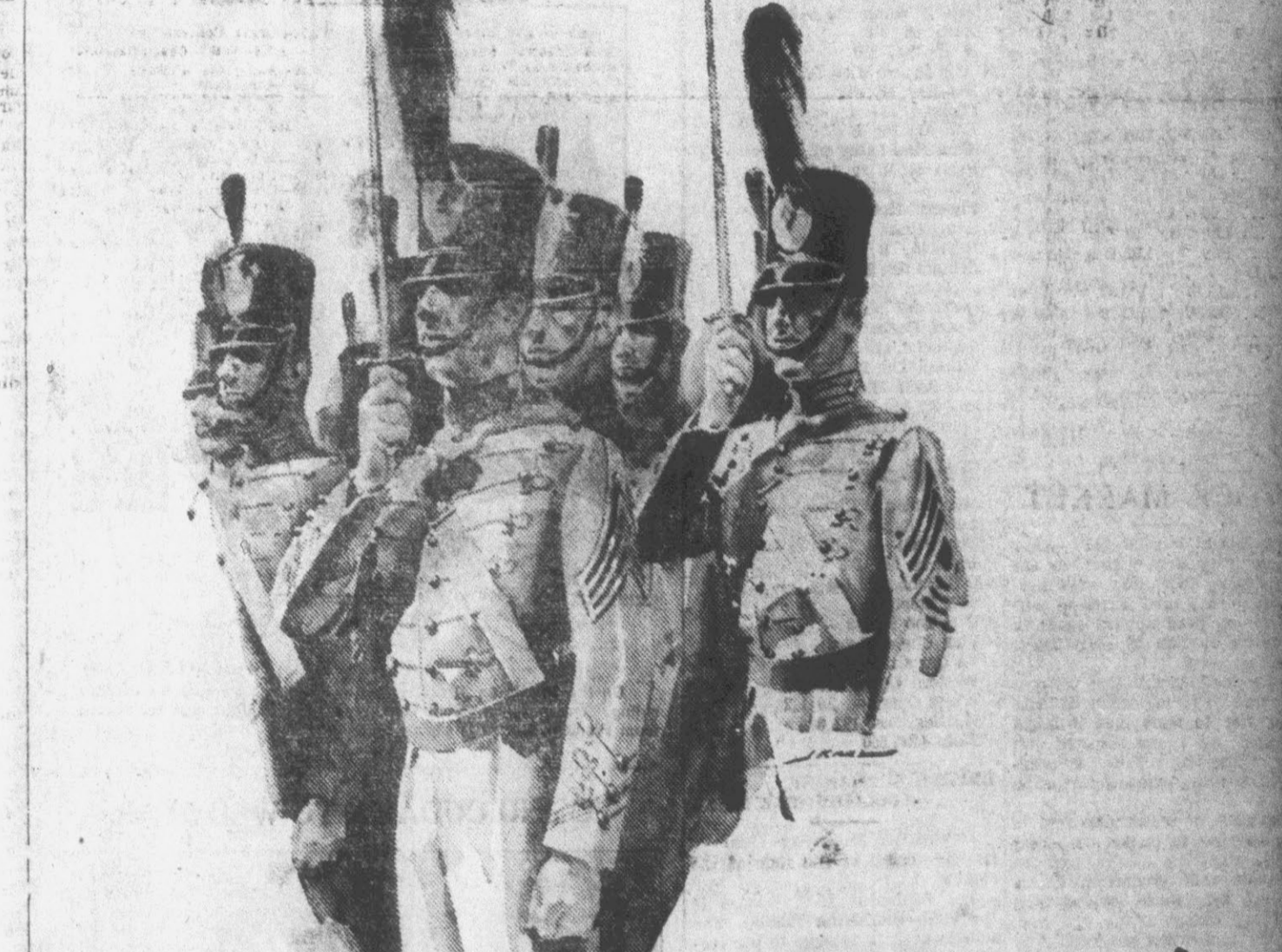

STOCK MARKET

New York, July 9.—(AP)—After moving irregularly higher in the early trading today, the stock market ran into a brief flurry of selling only to head upward again in aggressive fashion by early afternoon.

Call money held firm at 9 per cent and there was some calling of loans living rise to fears that it might be higher, but it was rumored that some of the larger banks were endeavoring to prevent any further increase.

The wave of selling appeared to have been set in motion by a bear fight against the motors, based on indications that production during the last half would decline from the heavy output of the first half.

An important item in the day was the automobile chamber of commerce's figures on production during the first six months of the year. While output reached a new high record at 3,390,000 units, 36 per cent of the total was supplied by the two largest low-priced producers, so that the dollar value showed a much smaller gain than unit output.

The American iron and steel institutes estimated of June input production was regarded as highly favorable, showing operations maintained at 99.56 per cent of rated capacity, a negligible decline from 99.59 per cent of May. The news also included an increase of 10 per cent in American Telephone's operating income.

American Telephone mounted a 5 points to a record price at 174 on the five months income figures, although for May, the last month reported income fell off slightly. So-called hot weather stocks, such as Coca-Cola and Borax, were also well bought, the two reaching new high ground.

Philadelphia Co. jumped 15 points to touch for the first time, and International Business Machines, LaSalle Railroad, Missouri Pacific preferred and Nider Packing preferred, were among other issues reaching new tops. American Marine and Foundry rose nearly 9 points, and Gene Cananea, Standard Gas and American Radiator well bought.

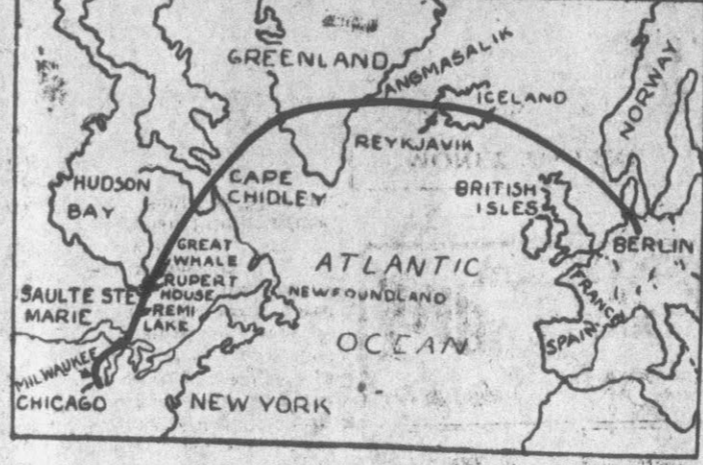

Cannon's corner, thence a southerly course with said Cannon's line 167 feet to a stake, West Haven Realty's line, thence an easterly course 70 feet to a stake, J. S. Ross corner, thence a northerly course with said Ross line 167 feet to the beginning. Being a part of the same lands conveyed by Fernando Harris and wife to J. I. Griffin, Book K-6, page 74, at that time called Harris' town, and the same land conveyed by J. A. Griffin and wife, J. I. Griffin, to J. R.
