ELEVEN GIRLS DIE IN WRECK AUTOMOBILE

Several Others Injured As Truck Plunges Into Abyss In Honduras.

Tegucigalpa, Honduras, July 16.—(AP)—Laughing happy at the end of a day of picnicking, eleven Honduran high school girls yesterday went to their death as the truck in which they were riding crashed a thousand feet into an abyss near here, a few miles from here.

Several of 22 others injured are near death. The driver, Luis Medina also was killed outright. Salvador Corleto, Minister of Public Works, himself was seriously injured in attempting to reach the bottom of the abyss to aid in extricating the bodies from the wreckage.

The girls had been to a spot not far distant for a box lunch, dancing and native games. After a day spent in fun making they piled onto the truck for the trip back to Tegucigalpa. The truck left the road and started its plunge almost before those on it realized what was happening.

It was not known exactly what caused the tragedy, but it was thought that the driver's attention may have been distracted momentarily at a dangerous spot in the road by the laughter of the girls on the seats behind him.

The tragedy overwhelmed the capital with grief. Many of the girls were from well known families. All theatres and concerts were suspended and national mourning will be declared for the funeral day.

Negro Slayer Arrested Today At Montgomery

Montgomery, Ala., July 16.—(AP)—An enforcement officer today arrested Lester Bouyer, alias "Red" Harris, 38 years old negro, in connection with the slaying last Wednesday night of Jack Hines, a merchant near Eufaula, Ala.

Bouyer was captured by state officers E. Potter Smith and S. E. Tramm at the home of a negro woman, Susie Perkins, less than a mile from Spelzinger Prison, state penitentiary, where he recently completed an eight year term for burglary. He was brought immediately to Kilby prison here for safe keeping.

The officers said Bouyer fits the description given of Hines' assailant by Miss Bertha Clark of Eufaula, who was a witness of the merchant's death and herself was attacked and seriously wounded by the slayer.

Bouyer admitted he was in the Eufaula vicinity the night of the slaying, they say, but denied any knowledge of the crime.

ENTIRE FAMILY HELD IN DEATH OF W. E. ALLEN

Camden, Tenn., July 16.—(AP)—The entire household of W. E. Allen, whose body was found July 1, three hundred yards from his home, was under arrest today in connection with his death.

Allen, 19, a son, and his wife, Bertha Brewer, 13, the elder Allen's niece, were committed to jail yesterday in default of bond fixed after their arrest as accessories after the fact. They later were removed to Paris for safe-keeping.

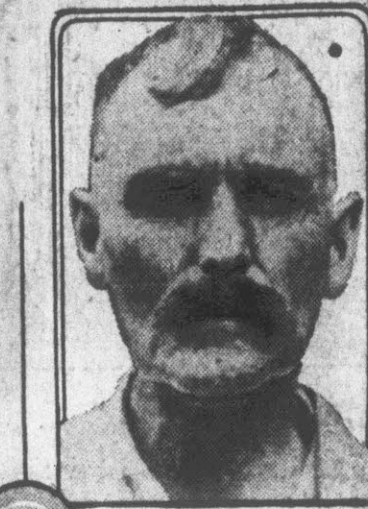

Maine Governor Scores Confinement of People In Prison of Nation

New London, Conn., July 16.—(AP)—Governor William T. Gardner of Maine described of normal human beings without employment as "barbarous punishment" in an address before the Governor's conference today.

Speaking of the crime session which opened the conference, Governor Gardner, urged his colleagues to advocate a policy of productive employment for inmates of prisons of their states.

He emphasized the need of such employment to help prisoners to retain or develop a healthy attitude toward life and pointed out the advantages of industrial training and experience of ex-convicts after their release.

"But," he said, "any task may be laborious, unless it is productive, it cannot be dignified with the term 'labor.' If we are to give prisoners employment, we must make them producers and it must be concerned that to some extent somewhere they must come into competition with free men and women who are or might be laborers in the same field.

The problem is to keep such competition at a minimum and free labor has the right to expect such protection as may be consistent with successful operation of prisons.

Governor Gardner warned against a provincial attitude in states toward prison products and said the problem should be regarded nationally.

The keynote speaker was Governor Franklin D. Roosevelt of New York who had as his topic "Co-operation of Governors on crime problems."

Governor George H. Dern, of Utah, executive chairman of the conference, called an executive session before the opening meeting for action on an invitation to Michael H. Cahill of New York City former president of the New York state bar association and a prominent member of the bar, to speak on "Interstate Exchange of Witnesses."

The opening program called for and address of welcome by Governor John H. Trumbull of Connecticut, the host, and a reply by Governor Henry S. Caulfield of Missouri.

Following Governor Roosevelt on the program was Governor William Tudor Gardner of Maine, on "Employment of Prisoners" and Governor O. Max Gardner, of North Carolina on "Youthful Criminals."

Late this afternoon the Governors will go on an inspection tour of the submarine base here, and will go from the base to Fishers Island for a buffet supper.

The session on taxation and aviation will be held tomorrow and the closing session on Thursday will be devoted to Government. Governor Albert C. Ritchie of Maryland, will preside tomorrow and Governor Clyde M. Reed of Kansas the next day.

NEW YORK MAN FOUND DEAD IN CAR IN VIRGINIA

Unidentified Youth Escapes After Being Taken From Car Where Dead Man Was Found.

Roanoke, Va., July 16.—(AP)—A body identified by police as that of E. H. Abbott of New York City, with a bullet wound in the side was found here today at the steering wheel of a new automobile shortly after the machine had come to a halt in a shallow ditch. An unidentified young man said to have been a companion of Mr. Abbott, crawled out of the machine and disappeared after being taken to a hotel here, police said.

Passing motorists came upon the car soon after it entered the ditch to find the elderly man dead. A young man emerged. At the request of the youth he was carried to a hotel here, where the motorists say he told them he lived. Police have not been able to find him since he entered the hotel. Papers among the personal effects of the dead man bears the name of E. H. Abbott, of 77 Irving Place, New York City. The automobile has West Virginia license tag 185675. The automobile registration card gave the address as White Sulphur Springs, W. Va.

An official bulletin issued by the physicians this morning said: "His Majesty the King passed a good night. Both general and local conditions are satisfactory."

Russians Pushing Troops Towards Siberian Border; Armored Trains On Duty

Despite the expressed belief in China that no further serious consequences may be expected from the recent seizure of the Chinese eastern railway, considerable tension was reported to have developed in Moscow.

International circles in Paris, London and Tokyo have expressed doubt as to the developments of any hostilities, but there were rumors of troop movements along the super-Manchurian border.

Mass demonstrations against the "Chinese fascists" were held in Moscow during the night and the press published unofficial warnings that Russia would oppose violations of her rights.

A three day ultimatum reported to have been sent to China by Russia demanding a conference to clear up the situation expired today, but delay in its transmission caused belief that this time limit would be extended.

Censored dispatches from Harbin indicated Russian troops movements toward the Siberian border, while Chinese advices from Peking reported that Russian troops had crossed the border last week and destroyed a Chinese ship on the Black river. These later advices were not confirmed.

Peking, China, July 16.—(AP)—A censored telegram today from the Associated Press correspondent at Harbin, Manchuria, indicated Russian troop movements toward the Siberian border were already under way.

The censor deleted eight words, presumably at the beginning of the first sentence which as received said: "Through troops Siberia de-activating trains."

The rest of the message read: "The railway's (Chinese Eastern) traffic from Pogradnaya to Vladivostok entirely stopped, since Saturday, possibly owing to floods. The Chinese Monday took over the Chinese Eastern Land department. The Chinese official newspaper, Kungpao, claims to know authoritatively that Serebrieff is coming to apologize to the Chinese government."

M. Serebrieff is a member of the Press Probe of Lobbying at Capital.

Senator Carraway Would Investigate Condition Prevailing At Washington.

Washington, July 16.—(AP) Plans to press for an investigation of lobbying at the capital as soon as the Senate meets again, August 19, are being made by Senator Carraway, Democrat, Arkansas.

Although not aimed primary at such groups, he says, the investigation he desires would go into the prohibition amendment, the anti-Saloon League, the American Federation of Labor, the National Association of Manufacturers and a number of others.

The "corridors of the capitol are swarming with tariff lobbyists," he declares, and hundreds of representatives of various groups are "grafting upon their supporters" and "selling senators behind their backs."

He wants to know what the activities of lobbying associations and lobbyists are, the sources and amounts of their revenues, their expenditures and the purposes of such expenditures, and what effort they put forth to affect legislation.

Poincare Scores Victory On Debt

Paris, July 16.—(AP)—The Poincare government was victorious in its first clash with opposition on the question of ratification of the debt accords today, receiving 304 votes against 239 on a question of confidence.

The Senator, who recently had the District of Columbia bill to prepare a statement showing how many diplomats had been accused of violating the traffic regulations, said he would ask the Senate to recommend such procedure to the state department.

The report of the police showed that 34 diplomats and attaches had been stopped and warned of traffic regulations in 11 years, none being arrested because of their diplomatic immunity. The offense for which they were halted ranged from minor infractions of the rules to driving while intoxicated and the list included several of Ambassadorial and Ministerial rank.

BODY OF DEAD FLIER REACHES HORTA, AZORES

Eye Witness Gives Graphic Account Of Fateful Trans-Atlantic Air Race.

Horta, Azores, July 16.—(AP)—The Polish schoolship Iskra carrying Major Casimir Kubala and the body of his trans-Atlantic companion, Major Ludwik Idzikowski, arrived in Horta from the island of Graciosa shortly afternoon today.

Major Casimir Kubala, vainly injured himself, tried in vain to rescue his comrade, Major Ludwik Idzikowski, from their burning plane, the Marshal Pilsudski, when it crashed in Graciosa Island Saturday night in ending a trans-Atlantic venture.

The first complete account of the disastrous termination of the two Polish fliers' brilliant attempt to fly from Le Bourget to New York, was given to the Associated Press today by an eye-witness, one of those who sought to save the lives of both airmen.

His narrative revealed that both Kubala and Idzikowski were found strapped inside their plane, which was upside down in a corn field, near the village of Santa Cruz. Idzikowski's legs appeared to be broken and so planned to be broken and so planned to be broken and so planned to be broken.

Those attempting the rescue believed he was already dead when finally the advancing flames made them desist. Kubala, who had become slightly dazed with fumes from the gasoline tank, which had been opened to permit dumping, attempted to rush into the cabin, a virtual cauldron of flame for one last effort, but the crowd held him back.

Major Idzikowski's body was not removed from the plane until day-break Sunday. A military guard standing by all night, ceremonious funeral was given Sunday afternoon at 3 p. m. the entire island civilian and military population following the coffin to a special yard.

The Polish training ship Iskra arrived at Santa Cruz at 5 p. m. Sunday and the body was withdrawn from the vault and placed aboard Iskra for transportation to Poland. It was taken en route to the island's little church for a final requiem, the coffin covered with Polish and Portuguese flags.

Commission Recommends Sanitary Improvements In City and the County

D. R. Markham, division manager, and J. D. Huges, sanitary engineer, of the North Carolina Child Welfare Commission, are in Greenville this week in connection with a campaign to improve the sanitary conditions among the industrial plants of the city and county. They are assisted by K. T. Futrell, director of the Pitt County Welfare Department.

An inspection of the sanitary condition of the various plants of the county was made by the state department last October, and the representatives have returned to the county this week to make recommendations for improvements which they deem necessary for the protection of the health of the thousands of people who visit the city from time to time during the year.

They expressed appreciation of the splendid spirit of co-operation accorded them by the industrial in-

terests here, especially in the tobacco field, where most of the improvements are being made. Both warehousemen and factories have shown a keen interest in the movement to protect the health of their employees and patrons, and improvements are under way that will practically revolutionize the health protection features of the industry.

The campaign affects all industries where workers are employed, and the findings of members of the commission last October have resulted in a program that is expected not only to safeguard the health of the workers but to protect the countless thousands of visitors who come here during the tobacco season and other parts of the year.

The commission representatives will be in the county three days this week and during that time will be assisted in their work by the director of the county welfare department.

A painful, gasping sob.

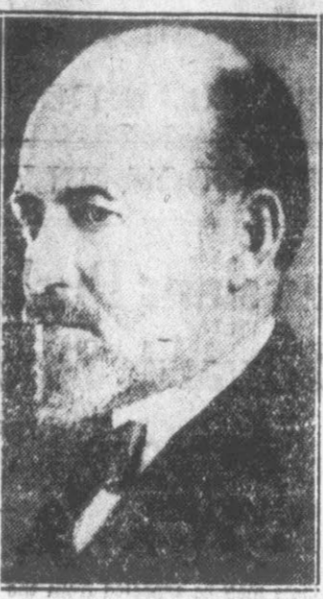
"Helen . . . forget, as I do—for I am thy friend now as ever . . . And, moreover, killing is sometimes justifiable and therefore no murder."

It was pointed out that Williams never had registered such remarkable times as did Wykoff in the final Olympic trials at Boston.

The Philadelphia Athletics, besides the prospect of winning their first American League pennant since 1914, also have a good chance to boast the leading batsman and pitcher of the circuit for the first time in many moons.

Lefty Bob Grove is well out in front of the pitching parade, enjoying his greatest year so far, while young Jimmy Foss is making a gallant fight for hitting honors. Foss is being closely pressed by Heinie Manush who lost out to Goose Goslin by barely a percentage point last year, but Al Simmons and Mickey Cochrane, two other hard-hitting Mackmen, are in the contending group.

Grove was the most effective pitcher in the American League in 1928 when he had an earned run percentage of .251, but not since Chief Charles Albert Bender led the list in 1919-11 has one of Mack's twirlers been at the top on the won-and-lost percentage basis.

It is necessary to go way back to 1901, when Napoleon Lajoie was with the Athletics, to find any member of the white elephants heading the batting array. Detroit has had a strangle-hold on this feature of individual prowess and is not yet out of the running with Harry Heilmann making his customary odd-year bid.

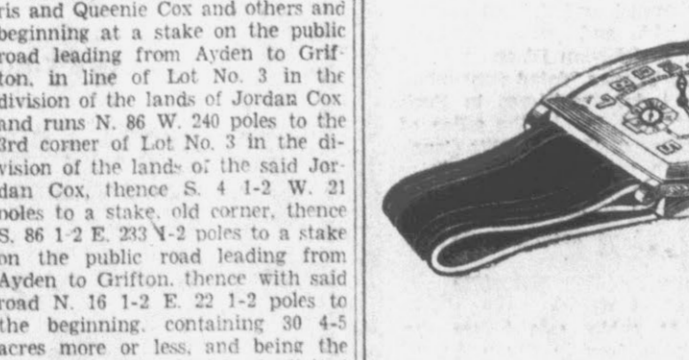

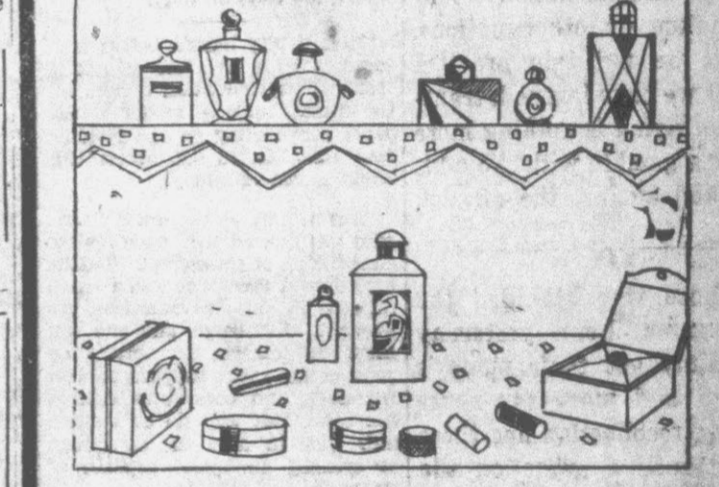

ABOUT TOWN

Greenville people will extend a cordial welcome to Dr. Ham, of South Carolina, who was recently elected to the office of director of the Pitt County department of health," said a citizen today.

"Dr. Ham has seen considerable experience in the public health field and comes to Pitt county fully capable of carrying out the great program of work outlined for this section. The importance of Pitt county in public health work is set forth in a graphic way in the national survey of health conditions completed some time ago under the supervision of the United States Health Association. It was the important part which the county had played in health work that won the survey for it.

"Dr. Ham will find the public ready to co-operate with him in his work and it is hoped his administration will be the great success it should be."

"If J. Pluvius, mythological god of rain, should close his sluice gates a few days, Greenville probably would be able to add a few more victories to her string at the top of the standing of clubs today," commented a citizen today.

"Old Jup has tricked us out of two games since the opening of the second half, but from all appearance he means to let Wilmington and Greenville have a look-in on the series scheduled for this city yesterday and today.

"Some of the other clubs are getting rained out also, and maybe we shall be able to maintain that coveted leadership until the ruler of the flood gates gets ready to take a few days off duty."

"It is a pity human beings must sacrifice their lives for something from which civilization derives little benefit," said a reader of this paper commenting on the fatal air race that started out across the Atlantic last Saturday.

"But as long as the world stands men will risk all they have for the glorification of themselves. Had the race been a success it would have resulted in little advancement for aviation. Lindbergh and the few others that followed him across the great ocean wastes supplied all data necessary, and those who attempt the same feat now do so because they wish to have the distinction of crossing the great expanse of water and nothing more.

"It is true such a race as that started by the French and Polish fliers would have been interesting. It would have furnished columns of reading matter for the citizens of the world, but after it was all over where was the benefit—except in a personal way. Such dangers should be avoided except in instances of aviation development. Human life is too precious to sacrifice in such way and something must be done to put a restraint upon these contemplating flights other than for purposes of aerial development."

"I believe Greenville is one of the most orderly towns in state," declared a business man today, speaking of the small number of cases handled by the mayor's court during the week.

"Some other towns of similar size have just twice as many offenses as we do. People here either have too much to do or are not quite as criminally inclined as those of the other towns.

"This is a matter of which the entire citizenship should be proud and one that should play an important part in the moral development of the city in years to come."

"No insect is quite as active in Greenville at this time as the mosquito, and the city is having one of the worst battles in years from the invading insect," said a citizen today, commenting on the unprecedented number of mosquitoes reported from various parts of town.

"The long spell of wet weather is largely responsible for the visit of the music-making insect, and as soon as this condition improves it is probable the mosquito will not be quite so active. It is hoped so that there is nothing in the world that is as disastrous to sleep as the nocturnal songs and stings of the winged visitors. They send everybody to cover and provoke more expletives from the sleepy citizen than any thing imaginable."

"Better days are coming—and they are not far away," confidently declared a prominent business man responding to a complaint about the stringency of money which has been felt in this section the last few months.

"Money should begin getting easier the first of August and from then on everybody will feel more like providing themselves with the things they have been doing without so long.

"This is nothing more than the usual summer period of depression. It may be slightly more acute than the last three or four years, but we still have the same resources and the same possibilities, therefore, it may be seen that there is no immediate cause for alarm.

"By the first of September the average business man will have forgotten all about the lean times of the present. He will have all the business he can handle, and to add to this his collections will be about as normal as they always were. Cheer up, old man, every cloud has a silver lining, and this cloud will pass just like all others."

Sailors and Greenies Battled To 15-Inning Scoreless Tie Monday

In one of the most spectacular diamond battles seen here this season, Greenville and Wilmington fought to a fifteen-inning scoreless tie at the Fair Grounds here yesterday afternoon, the game being called on account of darkness at the expiration of the fifteenth frame. It was the first game of the series between the winners of the first half and the leaders of the second half, and furnished sensations enough to put it in a class with the championship series about two months off.

The game was played under lead, en skies that threatened to give rain that never came, and inning after inning rolled by with the spectators expecting the next minute to bring a torrential downpour and suspension of play. The diamond was wet and the ball at times slippery, but the two clubs played with a skill that would have done credit to a fair day and a bunch of veteran players. It was one of those rare games that come infrequently during a lifetime, and the faithful supporters in the grandstand and bleachers literally shivered under the sting of a wind that was anything but seasonable.

In three innings short of the ordinary two games, the contest did not come to an end until the guardian of day had rung down the curtain of night and the shrill sound of crickets and frogs drifted in from the soggy ground around the ball park. It was a day the few loyal hearts that attended the game will not soon forget, and it will go down in local history as one of the outstanding fights in the annals of the Eastern Carolina League.

The invincible Skelton did the mound work for Greenville. His twisters were never more puzzling than they were on this occasion. For fifteen long, grueling innings, backed by matchless support of his teammates, the big moundsman held the hard-hitting Sailors scoreless. Unable to collect more than three hits, the visitors found it impossible to get a runner further than second base. They managed to reach that position and fate, it seemed, had already decreed that they should die there. And die they did as bravely as any lot of ball

players that ever fought upon this diamond before.

Emmons appeared on the firing line for the Sailors. He was the same old trickster, shooting the sphere over the plate in such baffling way that the Tobaccosis found it impossible to hit when one lone hit would have broken up the most sensational game in years. The Greenies sent runners to the third corner three different times, but always Emmons lightened up and positively refused to yield the hit that would have spelled victory to his adversaries and defeat for himself and teammates.

Skelton had the better of the battle in the matter of hits and bases gained by the runners, but from the standpoint of runs, both were on equal terms. Both pitched winning ball until it seemed that it was impossible for human endurance to continue any longer. But they continued to fight, continued to match the might of their arms against the dynamic bats of their teammates, and at the expiration of the fifteen innings when nature unrolled the curtain of night, the arm registered a clear victory over the might of the bat.

Ralph Williams, former second-sacker of the Greenville club, furnished the fielding features of the day for the Sailors. He fielded 21 chances as cleanly as it was possible for the ball to be fielded, and enabled his teammates to come out of the fray with only one single bobble chalked up against them. Nalbook, field captain and shortstop of the Greenville club, drew second place for fielding honors, accepting seventeen chances and playing every one of them in a way that drew unrestrained applause from the grandstand.

The picking of Sammy Carson, Greenville catcher, was also one of the outstanding features of the game. On his toes during every play, Carson held the visitors close to bases, and succeeded in catching them napping at different times.

Fans who had been going out to the ball park game after game since the opening of the season hoping to see one really outstanding game, had this ambition more than gratified in the fifteen inning contest yesterday. They saw more

than the one game—they saw the usual nine innings go by—and then six extra innings tacked to it without a runner hardly more than threatening the home plate.

The game furnished many moments of thrill that caused the spectators to catch their breath and sit in a tense, strained position until the crucial moment had passed without either side gaining any distinct advantage in the way of run-getting. It was one of those kind of games many a fan has paid 75 cents into the baseball coffers to see for a period of several years without actually ever seeing it, and one that will furnish conversation for days to come.

The two clubs will conclude the series on the local diamond this afternoon, with Greenville still in possession of first place and the Sailors trying hard to rid themselves of the tenomy of the basement atmosphere.

CARDINAL DOWNFALL PUZZLING

Here and there on the pages of baseball history are recorded the dramatic collapse of powerful baseball machines, but the fall of the St. Louis Cardinals, National League champions in 1928, threatens to go down in the books as one of the strangest and most unexpected of all reversals.

For two months the Cards were in the thick of the pennant chase. Then they fell apart. There have been a number of explanations for the collapse of the champions but most of the responsibility can be traced back to a veteran pitching staff that cracked wide open at a time when Billy Wouthworth had to up-and-coming youngsters capable of stepping into the breach.

On June 15 of the current campaign the Cards had compiled a record of 34 victories and 19 losses, a percentage of close to .650. Since that date they have lost 23 games and won only six for a season's record of 40 victories and 42 defeats a percentage of less than .500.

Thus in the short space of a month the St. Louis club has dropped from a position as leading contender for the championship into a dog-fight with Brooklyn to stay out of the second division.

Southworth's crew lost ground to the dodgers yesterday, bowing to the New York Giants, 7 to 2, while the Robins were turning back the Cincinnati Reds 4 to 2. This left the Robins only a game and a half out of the first division.

The second place Chicago Cubs shaved a half game off of Pittsburgh's lead by downing the Phillies in both ends of a double bill, 9 to 6 and 7 to 6. Chuck Klein hit his 24th 25th and 26th home runs during the double bill to assume major league leadership in this department. Hack Wilson got his 23rd homer in the first game.

An error by George Sisler enabled the Pirates to beat the Boston Braves, 5 to 4 in 11 innings and stretch their winning streak to eight in a row. Comorosky scored the winning run when Sisler muffed Clarks fly back of first base. The victory left the Pirates leading the Cubs by two and a half games.

The Yankees picked up half a game on the Athletics by defeating Detroit 7 to 6 while the A's were splitting a double bill with Cleveland.

Babe Ruth's 20th homer of the year in the ninth inning gave the Yanks their win at Detroit. Sloppy fielding spoiled Roy Sheridan's debut as a starting pitcher and he was relieved by Freddy Heimach who received credit for the victory.

Cleveland slugged Ethmer, Rommel and Yerkes to take the first game of their double bill with the A's, 3 to 5, but George Earnshaw stopped the Indians cold in the second which the Athletics won 4 to 0. Earnshaw gave seven scattered hits and fanned six men.

Ed Walsh outpitched Fred Marberry as the Chicago White Sox beat Washington, 4 to 2, and the Boston hurlers for 16 hits to down the Red Sox, 10 to 3.

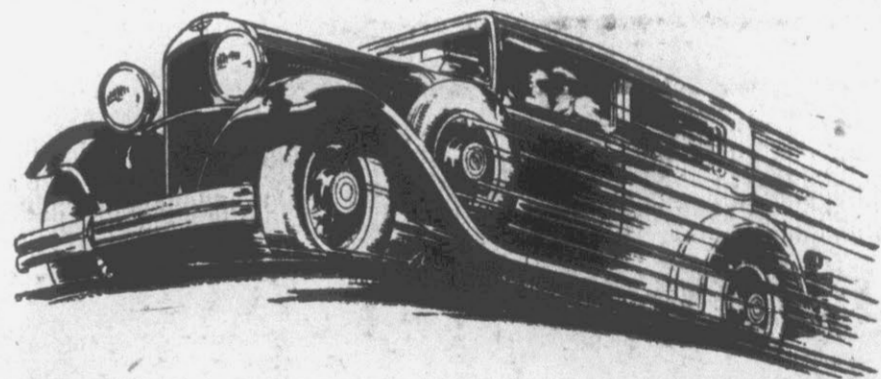

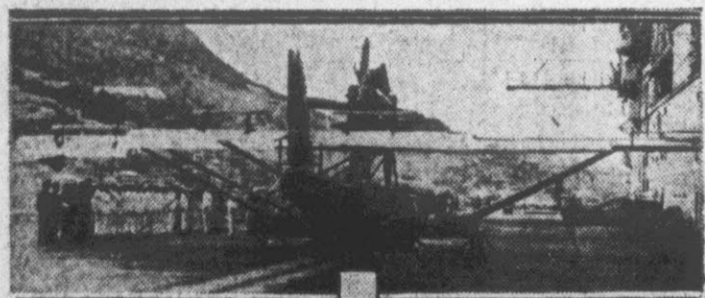
