## SAYS BRITAIN SHOULD SCRAP SEVERAL SHIPS

### Senator Borah Thinks This Would Be Better Than Having U. S. To Build More.

Washington, Aug. 2.—(AP)—The many who have expressed their views on means of attaining parity between all branches of the British and American navies, Chairman Borah of the Senate foreign relations committee apparently would rather see British scrapping of ships than American building of a combination of the two.

"Great Britain will follow our example at the Washington conference and sink some of her ships and thus come to parity," he suggests. "It will not only save the taxpayer but reduce the incentive to build for huge armaments are all right, but if we have to build up to parity, it vastly increases the burdens of the taxpayer and augments incentive to war."

His statement, issued 24 hours after a White House luncheon at which he and President Hoover discussed the general naval situation and, presumably, the British-American parity agreement reached in London by Prime Minister MacDonald and Ambassador Dawes, revived curiosity as to the chief executive's opinions as to various means of attaining the goal. No indication was given, however, that the Idaho Senator, who usually expressed his own ideas in his statements, might be reflecting those of the President as well.

Mr. Hoover, himself, meanwhile, seems to have said all he intends to say on that subject, for the time being, at least, in his letter to Paul V. McNutt, commander of the American Legion, who, protesting against the suspension of construction of three cruisers, suggested continued cruiser building by the United States or extended cruiser scrapping by Great Britain, or a combination of these methods.

That the President replied that the problems presented "are far more intricate and far more difficult than can be solved by the simple formula which you suggest," and expressed confidence that the Legion would be "sympathetic with principles of parity by negotiating and by reduction and limitation of armament instead of competitive building."

Senator Borah described as "very discouraging news" dispatches from London to the effect that Great Britain will not reduce its cruisers, holding that "if parity were used to justify the building of huge armaments, it would become a menace instead of a security."

## Steals Painting Through Joke And Lands In Prison

Madrid, Aug. 2.—(AP)—In the historical town of Escorial, Backey J. Dee, of Chicago, today still was confined in jail as a result of what he claims was a thoughtless and ill-advised prank in taking from a wall of "The Little Palace of the Prince," which is a royal palace, a valuable porcelain plaque of ancient design which is a part of national treasures of Escorial.

The incident occurred last Wednesday when Dee and his wife among a party of 25 tourists visited the palace. Dee at first visited only "It is all a mistake. I have done nothing."

Later he said that after drinking some, he visited the palace with a group of friends and thought it would be a joke to pretend to take as a souvenir one of the porcelain plaques. He said he did not realize the value of the piece.

Then he became alarmed and tried to hide the plaque when he saw guards considered his action a serious offense. Within half an hour after the plaque had been taken it was found by guards and restored to its place on the palace wall.

Dee at first was granted considerable liberties in the Escorial jail but yesterday was placed "incommunicado." The people of the town seem to show no feeling against the American tourist. They laugh and say the joke seems to be rather upon him.

## ROBIN FLIERS ARE FETED AT SAINT LOUIS

## Jackson And O'Brine To Demonstrate Refueling Methods At Chicago.

St. Louis, Aug. 2.—(AP)—Leaving this morning for Chicago where they will demonstrate refueling methods used during the 420 hour flight of the St. Louis Robin which made them champion endurance fliers last night when they received checks of \$420 each, equivalent to \$1 and hour for the time they spent aloft. It was their final official appearance. They played "ball" for the crowd attending the St. Louis Cardinal-Brooklyn Robin game, with Jackson pitching and O'Brine catching and also received life time gold passes to the Cardinals' games. Their other appearance was acclaimed by a crowd estimated at 175,000 when they paraded over seven miles of city streets.

At Chicago the fliers will attend a luncheon and with their regular refueling crew will stage a demonstration above Lake Michigan. From Chicago they will go to Kansas City for another demonstration on Saturday and Sunday when Farfax airport is to be dedicated.

The Curtiss flying service announced after the departure of the planes that the endurance flight champions and their refueling crew would visit twelve other cities on a tour to demonstrate refueling in flight.

Tentative dates for the fliers' appearance include the following: Memphis, Tenn., August 5 and 6; Nashville, Tenn., August 7 (noon); Louisville, Ky., August 7 and (evening) and 8.

## MAN SHOOTS WARD THEN KILLS SELF

Elizabeth, Tenn., Aug. 2.—(AP)—John Burnette, 27, prominent Elizabeth attorney, accidentally seriously wounded his 17-year-old ward, Virginia Amaral, last night and after calling a physician, killed himself.

Mrs. Burnette, a bride of three months, told officers her husband was teaching her how to load a pistol and the weapon discharged, wounding Miss Amaral, who was standing nearby.

Burnette ran for a doctor. While the doctor was examining Miss Amaral, Burnette picked up the pistol, walked to the front porch and shot himself near the heart.

He then returned to his bride and ward, told them "Goodbye" and slumped across a bed.

## MANY ARRESTS IN RUM RAIDS IN OHIO TOWN

### Half Hundred Speakeasies Demolished by Federal Officers Last Night.

Youngstown, Ohio, Aug. 2.—(AP)—Liquor raids exceeding in proportions any ever seen by federal prohibition agents in Ohio cleaned out the "Steel Town" of Campbell last night and early today. Fifty enforcement officers demolished half a hundred speakeasies, arrested the proprietors, and dumped gallons of whiskey and beer into gutters.

All the raids were on places where under cover agents already had made purchases, raiders said. Among the prisoners was a man booked as John Vansuch, former safety director of Campbell. The agents said several former politicians also were included among the prisoners.

Campbell, a suburb of Youngstown, described by agents as "the wettest spot in Ohio," is populated principally by workers in the steel mills. Hundreds of these collected in the streets as the raids went on, and at one place more than 500 gathered about the agents, beating and booing. Emergency squads of federal men were summoned and there was no serious outbreak.

The first onslaught was at three o'clock yesterday afternoon, and from that hour until early this morning, the raids continued. Those arrested with confessions made in their places, were conveyed into a special court hall of the usual federal building, where agents searched the evils, while the prisoners were questioned by Paul Hanson, regional Treasury Department investigator.

## GEORGIA LEAF BRINGS FAIRLY GOOD PRICES

## Local Tobaccoist Writes of Conditions Prevailing On Cairo Market.

"Tobacco is selling good, but nothing extra," according to a communication received in this city today by R. V. Keel, of the Farmers Warehouse, from R. O. Harris, bookkeeper of the Farmers Warehouse, who is on the market at Cairo, Ga.

"We are making a pretty good average, but we are selling some real good tobacco," the communication continued. "I can not see any big difference in the price according to the grades. For instance—the Export is paying around \$15.00 for D, \$17.50 for O and \$20.00 for H. R. A. T. Co. and L. & M. are pretty strong. The A. T. Co. is getting around 25 to 30 per cent. R. J. R. started off real strong but has weakened lots, especially after the A. T. Co. opened up."

"So far I have not seen any real fancy tobacco, but I understand that the Imperial and L. & M. are paying up to \$45.00 on some of the larger markets. We have not had any real common tobacco, that is, tobacco selling lower than 7 cents. Most of this crop seems to be good smoking tobacco and practically every basket sells at from 15 to 25 cents."

## Scores Injured When Communists Meet In Boston

Boston, Aug. 2.—(AP)—Communist observance of a day devoted to the Third International to anti-war demonstrations ended in disorder here last night. A squad of noleemen, using clubs, were called out to disperse 1,000 sympathizers and curious who had gathered to hear speakers from a street corner soap box. Eight persons were arrested and scores were said to have been injured.

Superintendent of Police Michael H. Crowley, personally led the charge. One thousand police were utilized over the city to prevent further disorders.

## NEGRO HELD FOR MURDERING HIS WIFE

Buffalo, N. Y., Aug. 2.—(AP)—Albert Mills, alias Frank Jackson, negro, 43, was being held for Jasper county Ala., authorities here today on a charge of murder, first degree.

Police say he confessed to shooting his wife to death five years ago in a Townley, Ala., dance hall.

## Big Zeppelin Reported Speeding Rapidly Over Atlantic Toward U. S.

(By The Associate Press) The huge air liner Graf Zeppelin was hitting a rapid clip as she sped across the Atlantic on her second voyage to the United States today.

This morning she was reported to the radio station at Casablanca, Morocco, that she was 600 miles west of Gibraltar.

She was headed toward the Azores but it was not certain whether she would pass over them or would skirt them on a northwesterly course. The last previous report was at two o'clock this morning when the dirigible reported her position about 265 miles west of Gibraltar, and said the weather conditions were "good."

In covering this leg of her flight the Graf was speeding along at an average of from 65 to 70 miles an hour.

The Zeppelin encountered strong head winds over France and parts of the Mediterranean, but began to pick up speed in accordance with Dr. Hugo Eckener's expectations as soon as she reached the Atlantic.

The air liner at 7:30 A. M. had more than 3,000 miles to cover before reaching Lakehurst. If she could maintain a speed of 60 to 65 miles an hour, it would take her about 50 more hours of flying or a total of about 85 hours. This would bring her into Lakehurst about 9:30 A. M. Eastern Standard Time Sunday.

Dr. Eckener hoped to make the trip in from 80 to 85 hours.

## FORT MADISON YOUTH WINS IN EDISON TEST

## Wilbur Huston Wins In Competition For Choice Of Protege Of Famous Inventor.

West Orange, N. J., Aug. 2.—(AP)—Wilbur B. Huston, of Fort Madison, Wash., was named winner today of the Thomas A. Edison competition for choice of a protege and follower in the footsteps of the inventor.

The forty-nine boy contestants—one from each state and the District of Columbia—were lined up on the lawn of the Edison home in Llewellyn Park as the announcement was made by Dr. S. W. Stratton, president of the Massachusetts Institute of Technology, who was chairman of the committee of judges. Dr. Stratton was high in his praise of the boys, who yesterday participated in a grueling examination on subjects ranging from morals and ethics to science.

## Captain Hawks In Air Again

Atlanta, Ga., Aug. 2.—(AP)—Captain Frank Hawks, trans-Continental flier, piloting the Pathfinder plane of the annual Ford reliability air tour, took off from Candier Field today at 9:45 a. m. for Murfreesboro, Tenn. He was undecided whether he would stop at Nashville or continue to Cincinnati.

Captain Hawks and Ray Collins, manager of the tour, are inspecting airports to be used by the flying excursion next month.

## FARM BOARD TO INQUIRE ABOUT LAND

### Problem Of Utilization To Be Next Big Issue Before Federal Commission.

Washington, Aug. 2.—(AP)—As soon as some pressing tasks have been disposed of, the Federal Farm Board intends to inquire carefully into the whole problem of land utilization, condemnation and reforestation.

This field of study is regarded by the board as holding an important key to the solution of agriculture's difficulties, but just what will result from its inquiry can hardly be forecast.

The board realizes that, despite diligent study already given by experts, the questions involved are still unsettled. A great many of the scientists of the Department of Agriculture, upon whose knowledge the board is expected to lean, believe, however, that the problem will resolve itself into a plan for specialized growing of certain crops on the soils best suited to them and the setting aside of the poorer areas for the more easily adaptable branches of farming and horticulture.

Almost any program the board might adopt, if it reaches any decision at all, will require many years to put into effect. The angle of the problem most susceptible to controversy is held to be that of justice to farmers whose lands would be selected for new and sometimes apparently less profitable crops. This proposition alone is regarded as making it certain that a final solution will take some time since education is believed to be the best way of approaching it.

Reclamation and irrigation projects are likely to be affected vitally by the board's study. Many responsible officials of the agricultural department are ready to recommend cessation of all further undertakings of this kind. Whether the board will be willing to go so far is questionable, but some recommendation on this aspect of the general situation is considered likely.

One important phase of the study will concern itself with reforestation.

## Rotes Not To Attend Meeting In Pajamas

Raleigh, Aug. 2.—(AP)—The Rotary club of Warsaw will not attend its weekly meeting Friday night in Pajamas as had been announced according to a special dispatch to the Raleigh Times from Warsaw this afternoon.

The Warsaw Rotarians announced several days ago that they would adopt the pajama fad and appear in slumber garments this week at their meeting. In answer to the announcement came protests from Eugene Newsome, of Durham, President of Rotary International and Henry Dwire of Winston-Salem, district Rotary organizer, asking that the club not do such a thing.

The Warsaw Rotarians today dispatched the following reply to Mr. Newsome and Mr. Dwire: "Joke s on you. Membership this club" polled majority do not know what pajamas are. Only one pair owned by club members, these home made of cutting with feet and head protector. Members mentioned by press reports sleep in underclothing and top shirts summer and winter."

## Prisoner Stabbed At State Prison

Raleigh, Aug. 2.—(AP)—W. H. Goodrich, Henderson federal prisoner serving a six months sentence in the Wake county jail on a whiskey charge, today attacked and severely cut Lester Jones of Princeton, another federal prisoner.

Goodrich, according to information from jail authorities, had been the subject of considerable jibing by the other prisoners and this morning became angered at something said to him by Jones.

Jones was cut six times, one severe slash on the neck barely missing the jugular vein it was said at the hospital. Jones was expected to recover unless complications developed.

Goodrich, who had been in the prison since July 15, was a trusty. He was serving 6 months and Jones had a three months sentence on the same charge.

## Taxicab Service Inaugurated Here

## YOUTH KILLS TWO AND THEN SHOOTS SELF

## Norristown Young Man In Critical Condition After Killing His Sweetheart And Friend.

Norristown, Pa., Aug. 2.—(AP)—A 23-year-old boy—a pistol clutched in his right hand—stood in front of his girl's home here last night and waited for her to return from an automobile ride with his best friend. Their car stopped at the curb and the youth, Earl Oberholzer, stepped up. Four shots rang out and the couple slumped—both dead. Oberholzer then turned the gun on himself. Physicians today did not expect him to live.

Edith Bosford and William E. Ingram were the two killed. Each was 20 years old. Oberholzer and Miss Bosford had been going together for three years. They were employed by the same reed. Ingram had been going with firm. Last Wednesday they quarreled the girl only since that time.

A note found in Oberholzer's pocket told the story: "I read: 'I couldn't stand to be without her after we had been together three years. In which time she treated me pretty mean. I thought I would wake her up by going with some one else. When she found this out she threw me over, which I can't stand, so I will take her away always.'"

The two youths had been friends of long standing. Recently Ingram purchased a new automobile, and let Oberholzer have his old one. Previous to last Wednesday, Oberholzer frequently had taken Miss Bosford to ride in it. They had planned to be married.

## SUGAR TARIFF PLAN IS MADE PUBLIC TODAY

## Chairman Smoot Says Sliding Scale Would Provide For Normal And Depressed Eras.

Washington, Aug. 2.—A sliding scale sugar tariff plan ranging from one cent a pound at the time market prices are high to three cents a pound when the market is depressed was made public today by Chairman Smoot of the Senate finance committee.

Smoot will offer the proposal as a substitute for the flat rate of 3 cents a pound placed on sugar in the House tariff bill.

Hearings will be held next week at which time the substitute will be considered by the committee.

Under the sliding scale, the present rate of 2.20 on sugar would apply when sugar is selling in New York at six cents a pound which is about the present price.

Cuba would receive the same 20 per cent preferential under the sliding scale as it now enjoys when the flat rates on sugar are applied.

## ONE KILLED IN RIOT AT FORT LEAVENWORTH

### Four Others Injured When Prisoners Protest Against Food And Drinking Water

United States Penitentiary, Leavenworth, Kans., Aug. 2.—(AP)—A fresh outbreak among convicts was reported here today following yesterday's mutiny in which one prisoner was killed and three wounded. The trouble today was reported to have started when a large group of convicts refused food at breakfast and hurled plates, cups and saucers about the mess hall.

United States Penitentiary, Leavenworth, Kan., Aug. 2.—(AP)—One convict was killed, four others were shot, three dangerously, and several were slightly injured in a riot at the prison here yesterday. It took more than a half-day to restore order.

Mike Martinez, a Mexican, who had served one year of a 30-year term, was shot to death, and another prisoner's leg was so badly mangled by gunshot that amputation was necessary. Three more were in the hospital with severe gunshot wounds and several others were injured slightly.

Guards with machine guns mounted on the prison walls prevented any escapes during the disturbance. There were numerous reports as to the cause of the outbreak but prison officials declined to confirm or deny any of them. One report said the riot, which broke out in the mess hall at noon, was a protest against prison grade food and the absence of ice in drinking water.

Another said the prisoners, who had been permitted to read newspaper accounts of riots in eastern prisons, had yielded to the suggestion. A third report laid to heated narcotic addicts. The temperature was 100.3 degrees when the riot started with the hurling of food and porcelain dishes shortly after 2:00 of the 2,500 prisoners in the institution entered the mess hall. Captain P. J. Kearny, in command of the hall pleaded with the rioters to return to their cells but another demonstration was staged and the convicts, armed with knives and forks and pieces of broken furniture, flocked into the jail yard.

Armed guards then charged the inmates and fired a volley of shots. Several prisoners fell and the others went to their cells.

Inside the cell houses, the riot began in earnest, as the convicts, tempered with triplets locks on the cell doors and propped down cell doors and shattered windows.

The riot extended in the afternoon and the last disturbance was said to have taken place in the middle of the mess hall as the evening meal as the prisoners "milling about." The leaders were taken into custody and all the convicts sent to their cells.

None of the prisoners had firearms during the disturbances and none of the prison officials was injured.

## Gangster Killed By Lone Gunman At Philadelphia

Philadelphia, Aug. 2.—(AP)—"Big Arthur" Callen, 38, who escaped gangsters' bullets several times through the use of an armored automobile, was shot to death early today by a lone gunman at Parkside and Memorial avenues.

Six "dum-dum" bullets were found in Callen's body. He was shot by a man who pursued him along Memorial avenue. After firing twice, the gunman followed Callen firing several more shots as the wounded man fell against a door in the rear of his apartment house.

As the gunman opened fire again Callen struggled to his feet, leaped a three-foot iron spiked fence, and fell to the ground. Jumping the fence the gunman reloaded and sent another hall of bullets at Callen.

The killer then walked to a parked automobile a short distance away and was whisked away by an accomplice.

Callen at first was identified as "A. Harry Gilbert," an alias under which he lived at the apartment house. His real identity was revealed by fingerprint experts from the detective bureau.

Although arrested many times, Callen never was convicted. He always protested he was "out of the racket."

MAN DROWNED IN FOND NEAR ROCKY MOUNT

Rocky Mount, Aug. 2.—(AP)—Robert Anderson, 28 was drowned in Nobles pond near here last night when a boat in which he was riding struck a stump and threw him into the water. The body had not been recovered today.

Anderson is survived by his mother Mrs. J. R. Anderson and five brothers all of Rocky Mount.

# LOCALS DROP FINAL GAME TO KILTIES

Greenville lost the final game of the series with Fayetteville here yesterday afternoon by the score of 4 to 2. It gave the Highlanders two out of the three game schedule for this city and caused Greenville to drop four and-a-half games behind Rocky Mount for the leadership in the standing of clubs.

Like the final game of the double-header the day before, the game yesterday provided a greater variety of the national sport than any single game witnessed on the diamond here in many months. Both clubs made enough errors to last them two weeks, but the Highlanders were more fortunate than Greenville in this respect as they got by without their bobbles proving so costly. Greenville on the other hand saw three bobbles, one behind the other, feature largely in the run-getting, and were unable to overcome the wild playing which occurred in the eighth frame and enabled the visitors to send two runners across the rubber to gain a one-run lead.

The locals started off like they meant to cop the final game of the series and for six consecutive innings Fayetteville batsmen were turned back without scoring. In the seventh, however, they sent a runner over the rubber, tying the single run which Greenville chalked up in the sixth and continued rallying in the eighth and ninth for three more markers.

Greenville rallied in the ninth and seriously threatened to tie the score, but the required hit was lacking and only one runner succeeded in reaching home. Crump and Hiller were the main offenders in the way of committing costly errors with men on the paths, Crump being credited with as many as three and Hiller one. Each of the errors were the nicest kind of grounders and rolled through the legs of the first and second basemen to let the followers of "Resty" Walters gain extra advantages on the paths.

Coming at critical stages, the errors brought groans of impatience from the grandstand and bleachers, the majority of whom had settled back to see Greenville take a pitchers' battle between Fitzpatrick and Withrow. And while they saw the mound battle continue until the eighth frame when the Greenville moundman was relieved by Anders it was not the kind of deal that brought them victory. Fitzpatrick pitched good ball until the eighth frame when everything seemed to blow up and he couldn't locate the plate. It was at this juncture that Anders was called to the mound, but luck didn't desert the Kilties and they managed to score another counter in the ninth to win the game.

Young Greenville center gardner, again starred in his territory, pulling down a couple of drives which might easily have gone for extra bases had a fielder less fleet footed been on the job. Frisbie made good of three or four difficult chances at short stop and enabled the Highlanders to turn Greenville hits into easy outs.

Greenville scored seven hits off Withrow's delivery, while her two hurlers yielded up six.

"All Greenville will join the  
Library Commission in expressing  
appreciation of the gift of \$50,000  
by Mr. Harper D. Sheppard, of Han-  
over, Pa., for erection of a mem-  
orial library in this city," declared  
a citizen today, reading the resolu-  
tions of the Library Commission  
carried in the columns of this paper  
yesterday.

"The building will not only be a  
memorial to Mr. Sheppard's father  
as requested but will also fill a long  
felt need of Greenville and com-  
munity. The city has been casting  
about for years attempting to pro-  
vide a library in keeping with prog-  
ress of the locality, but somehow  
this could not be done until Mr.  
Sheppard came along and gave so  
liberally that we shall be able to  
provide a library that should take  
care of the public demands for  
years to come.

"Mr. Sheppard is to be congrat-  
ulated upon his liberality and is as-  
sured of the gratitude of the people  
of the community who will derive  
direct benefit from his generosity."

Referring to persons operating  
automobiles while under the influ-  
ence of liquor, to reckless driving  
and speed restrictions, the revised  
edition of North Carolina Motor  
Vehicle Laws, has the following to  
say:

"It shall be unlawful and punish-  
able as provided in section 59 of  
this act for any person whether  
licensed or not who is an habitual  
user of narcotic drugs or any per-  
son who is under the influence of  
intoxicating liquor or narcotic  
drugs to drive any vehicle upon the  
highway within this state.

"Any person who drives any ve-  
hicles upon a highway carelessly  
and heedlessly in willful or wanton  
disregard of the rights or safety of  
others, or without due caution and  
circumspection and at a speed or  
in a manner so as to endanger or  
be likely to endanger any person or  
property, shall be guilty of reckless  
driving and upon conviction shall  
be punished as provided in section  
sixty of this act.

"Any person driving a vehicle on  
a highway shall drive the same at  
a careful and prudent speed not  
greater than is reasonable and  
proper, having due regard to the  
traffic, surface and width of the  
highway and of any other condi-  
tions then existing, and no person  
shall drive any vehicle upon a high-  
way at such a speed as to endanger  
the life, limb or property of any  
person and in no event at a rate  
of speed greater than forty-five  
miles per hour."

nity while you are away.

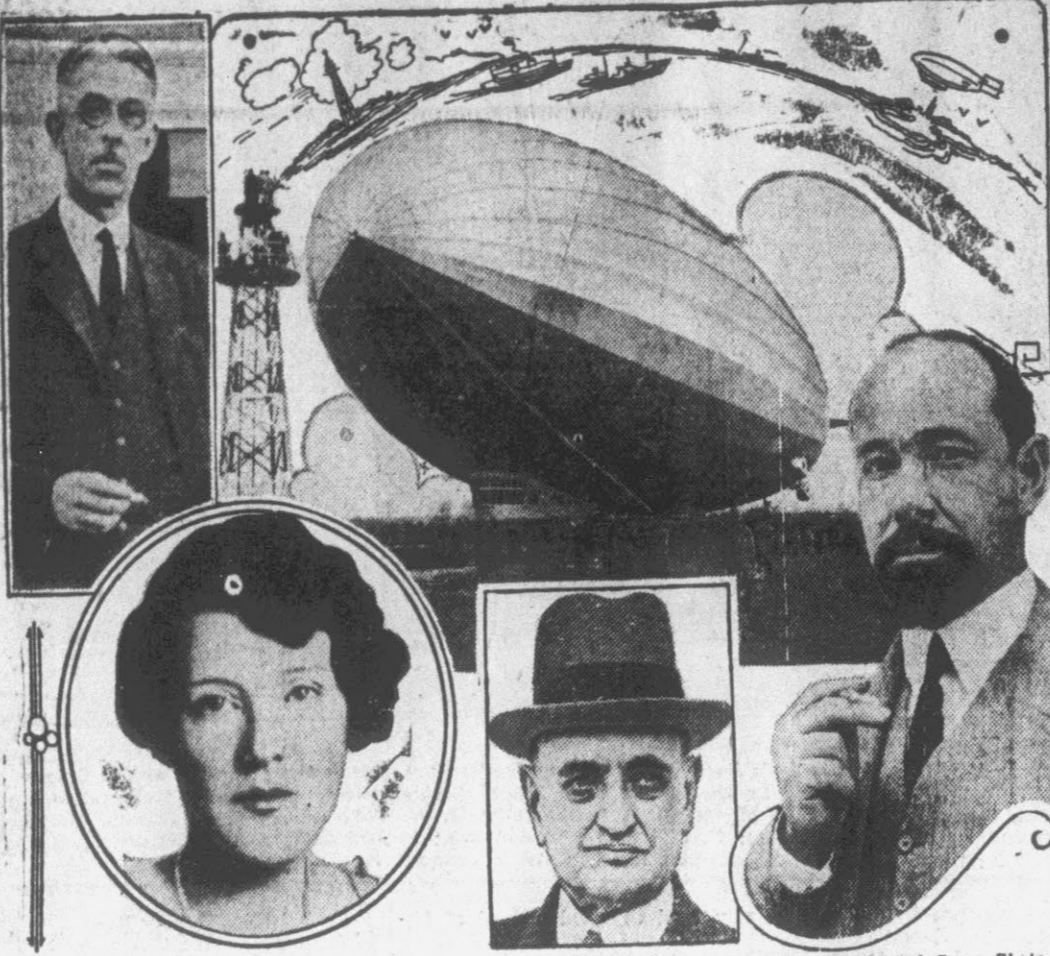
"Why not let us send you the

boys come out with colors flying."

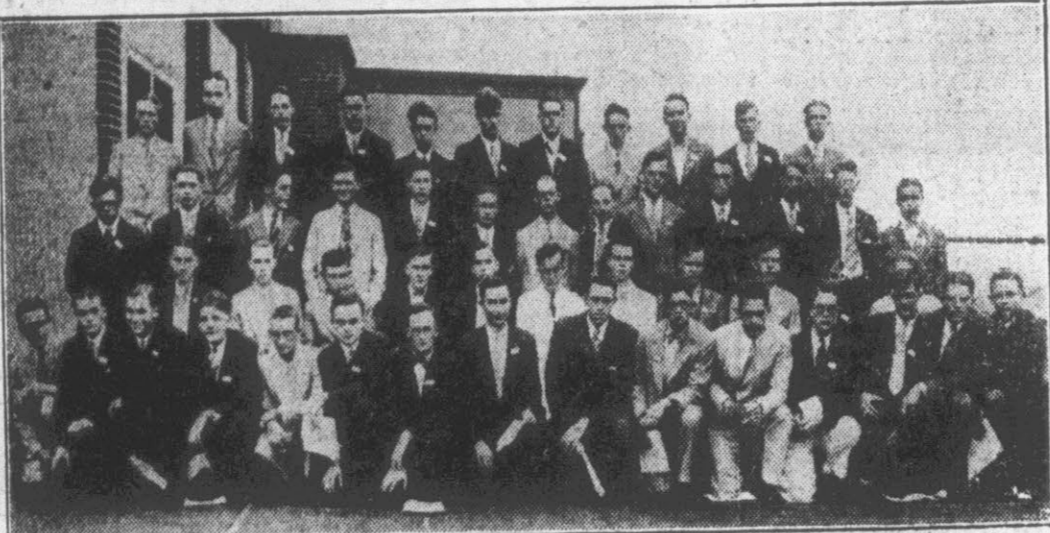

Lavarre Trial  
Set For Aug. 22

Augusta, Aug. 2.—(AP)—The suit  
of Harold S. Hall against William  
Lavarre, seeking operating control  
of the Augusta Chronicle and three  
South Carolina newspapers has  
been set for hearing at Macon, Ga.,  
on August 22.

Judge Bascom S. Deaver took this  
action in the United States District  
Court yesterday.  
Lavarre's attorneys succeeded in  
getting the transfer from state to  
federal courts on the contention  
that the defendant was not a resi-  
dent of Georgia and that the Uni-  
ted States courts should take juris-  
diction. An order transferring the  
case to federal court was signed  
recently by Judge Franklin of the  
Richmond Superior Court.

A motion was filed by Lavarre's  
attorneys yesterday asking that Hall  
be cited to show cause why the re-  
ceivership and injunction granted  
in the state courts should not be  
dissolved. This, along with other  
causes pending in the case, will be  
heard at Macon.

LEGAL NOTICE

The following rules and regula-  
tions were adopted by the Board  
of Conservation and Development  
at its meeting at Morehead City on  
July 8th and 9th, and are now the  
law governing these features and  
parts of "Inland Fisheries" to which  
they refer and to the extent ex-  
pressed:  
It shall be unlawful for any fish-  
erman to use more than one pole  
while fishing in "Inland Waters"  
of North Carolina.  
It shall be unlawful to fish with  
trot lines in "Inland Waters" of  
North Carolina.  
It shall be lawful to net for  
minnows to be used or sold for bait  
with nets not to exceed eight feet  
in length and two and one-half  
feet in depth and with a mesh not  
to exceed one-fourth inch; no sport  
fish of any size to be taken. All  
such netting as well as the tanks  
in which minnows are kept to be  
subject to frequent inspection by  
Wardens; Provided, that in the  
State Lakes, if found advisable, special  
permits may be issued to use  
larger nets. Provided further, that  
this ruling does not apply to waters  
which have been, or may be, stock-  
ed with minnows as a public health  
measure.

It shall be unlawful to fish by  
any method in Pigeon River from  
the Champion Fibre Company Dam  
in Canton to Sheffields Dam for a  
period of two years beginning Sep-  
tember 1, 1929.

It shall be unlawful to fish by  
any method in either prong of Cur-  
tis Creek in McDowell county for a  
period of two years, beginning Sep-  
tember 1, 1929.

It shall be unlawful to fish by  
any method in Reems Creek and its  
tributary, South Fork, in Buncombe  
county, for a period of three years,  
beginning September 1, 1929.

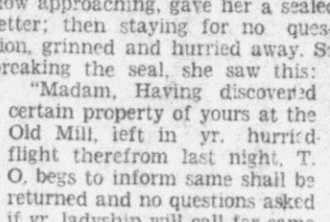

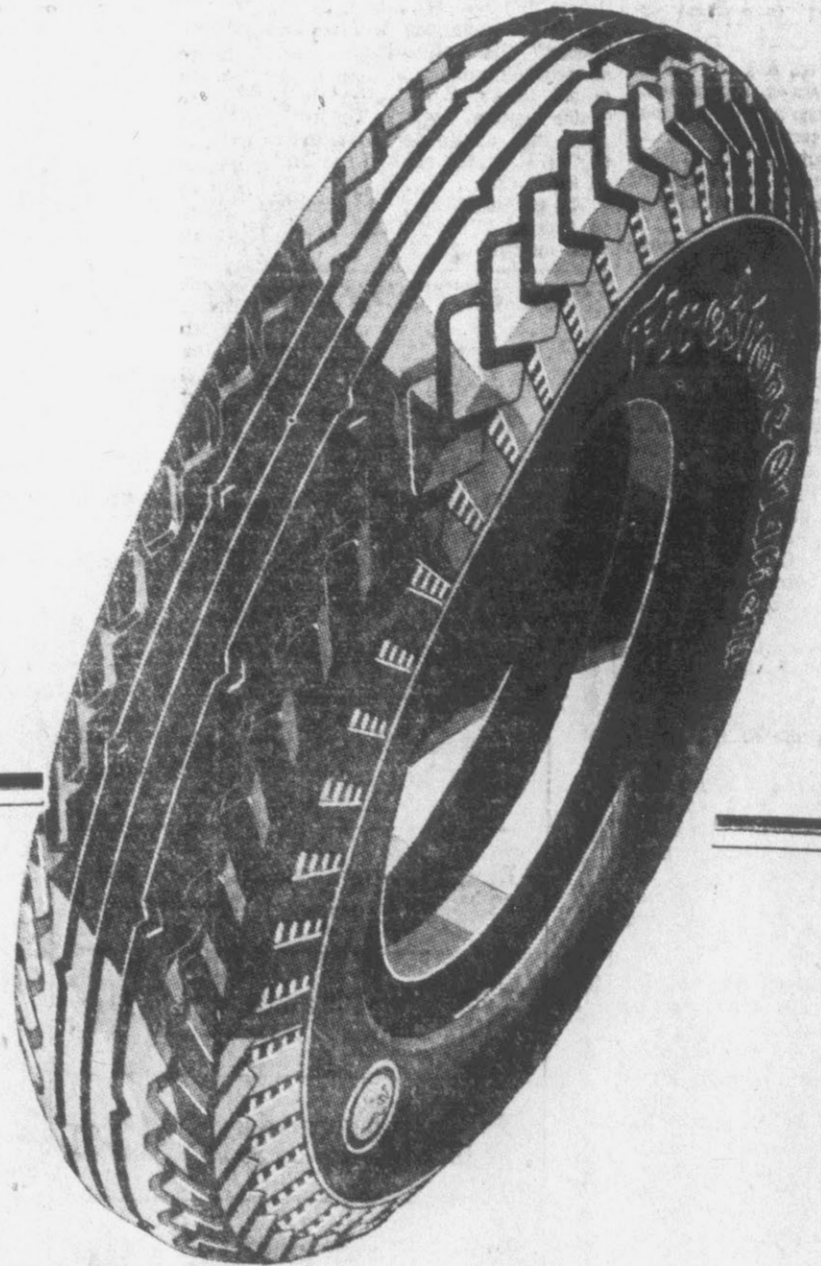
