THREE KILLED IN ACCIDENTS ON N. C. ROADS

Three Lives Snuffed Out in Automobile Mishaps in Various Parts of State.

(By The Associated Press) Three persons were killed in an automobile accident on North Carolina highways yesterday. Jim Johnson, 55, died in a Winston-Salem hospital from injuries received in the collision of an ambulance and a small roadster near Raleigh. His nephew, Curney Johnson, was cut and bruised in the roadster, was cut and bruised. Carey E. Boehm, driver of the ambulance, was uninjured. He had started to Moores Springs to bring a patient to Winston-Salem when the accident occurred. The Johnsons lived at Cycle, Yadkin county. A collision of two automobiles near Randolph caused the death of Hugh Harwell, 18-year-old Greensboro boy. He was driving a car that collided with that of Mrs. Kemp Alexander, of Asheboro. H. C. Heath and M. J. Foster, of Greensboro, passengers with Harwell, were injured slightly as was Mrs. S. B. Steadman, who was riding with Mrs. Alexander. David, young son of Mrs. Eledman, was injured seriously. Annie O'Brian, 1 year old Beaufort girl, was killed near Morehead City when a car driven by Arnold Webb, 18, of Youkers, N. Y., overturned. Miss O'Brian was a passenger with Webb. Both were pinned beneath the car when it overturned. Rescuers found Miss O'Brian dead. Webb was taken to a hospital at Morehead City. His injuries are believed serious. Mildred Ham, 13 months old daughter of Mr. and Mrs. J. R. Ham, of Mooresville, was run over in front of her home by an automobile, and died soon after in the Lawrence hospital.

Autopsy On Theora Hix Assailed in Court Today

Courtroom, Columbus, Ohio, Aug. 10.—(AP)—The autopsy performed by Coroner Joseph Murphy on the body of Theora M. Hix was assailed as incomplete by the defense today in the trial of Dr. James H. Snook for the girl's murder. The assault was made in the form of testimony relating to six narcotics that Dr. Snook had testified were taken at various intervals either by himself or Miss Hix. Dr. Clayton S. Smith, professor of pharmacology and physiology at Ohio State, under questioning of John J. Seidel, one of Dr. Snook's attorneys, described the nature and effect of the narcotics. The state objected to the detailed testimony charging that no evidence had been introduced to show that either Dr. Snook or Miss Hix had been in the habit of using any of the narcotics regularly. BANDITS KILL ONE IN TRAIN HOLDUP IN ILL.

Three Gunmen Kill Train Guard and Escape With \$4,000 Cash.

Chicago, Aug. 10.—(AP)—Three gunmen took possession of an Illinois Central Electric suburban train last night, shot and killed a guard, stole \$4,000 from a railroad collector, and escaped in an automobile after forcing the motorman to stop at a seldom used station.

The bandit slayer was partially identified as "Wee Willis" Dooey, desperado already sought for several other murders and numerous robberies.

The slain guard was Delbert Sudds who was with Jerry Garey, the collector.

Sudds and Garey boarded the train at the Randolph street terminal after collecting the day's receipts from Outlying stations.

Two of the bandits entered the train a minute later and took seats opposite them in the front part of the train. The third bandit entered the train at Roosevelt road, took a seat in the rear car.

As the train passed 3rd street, the bandit partially identified as Dooey used a handkerchief over the lower part of his face, drew a pistol and stepped across the aisle toward Garey. His companion drew two guns and threw the passengers into confusion. Dooey was in progress.

Seeing the bandit's weapon aimed at Garey, he drew his own pistol, but was shot before he could bring the gun into his position.

Passengers in the front car, startled by the shot, jumped from their seats and turned to witness the commotion. They were confronted by the bandit band who stood in the doorway, holding two pistols.

One of the other robbers hurried from the rear car to the motorman's seat, pressed a pistol to the motorman's back, and ordered him to stop the train at 2nd street. There the trio dived from the cars, ran across a foot bridge to the street, and sped away in an automobile.

Investigators at one train crew were taken to the bureau of Identification to look over pictures of known criminals. After hearing the description of the man who aided Dooey, Chief of Detectives John Egan said they talked closely with

COURSE OF ZEPPELIN'S FLIGHT

Graf Zeppelin Reaches Home Port on First Leg Of Flight Around World

Friedrichshafen, Germany, Aug. 10.—(AP)—The Graf Zeppelin giant German dirigible, arrived over its home hanger at 12:41 p. m. mid European time (6:41 a. m. E. S. T.) after a trans-Atlantic crossing from New York.

The giant dirigible slowly circled above the Zeppelin works while a thousand spectators gathered in the rain below and the ground crew stood by to receive it. Crowds hurried from Friedrichshafen toward the Zeppelin plant to welcome the big ship.

The huge ship made the crossing in just 55 hours and 24 minutes having picked up speed as she approached the coast of Europe.

The Zeppelin touched earth at exactly three minutes after one o'clock and was turned around with her nose pointing north.

The motors were stopped two minutes later and the landing crew began the task of pulling the Graf into the hangar field beyond the Zeppelin plant. The fence was lined with enthusiastic spectators.

It was Dr. Eckep's 61st birthday and the amazing arrival of the Graf Zeppelin so long before the time that she had been expected made the informal birthday celebration aboard the ship just before she landed all the more enthusiastic.

The Graf's time of 55 hours and 24 minutes on her eastward voyage was about 40 hours better than her westward journey to Lakehurst and 13 hours and 22 minutes better than her last voyage from Lakehurst to Friedrichshafen in October, 1928.

The Graf covered approximately 4,200 miles in the 55 hours and 24 minutes that she was in the air. This covering the entire distance at an average of 75 miles. A brilliant performance in the opinion of aviation experts.

RICH THEATRE OWNER IS HELD ON BAD CHARGE

Alexander Pantages Suspected of Assault On 16 year old Dancer at Los Angeles.

Los Angeles, Aug. 10.—(AP)—Alexander Pantages, millionaire vaudeville theatre operator, was in a city jail here today, charged with suspicion of committing a statutory offense against Eunice Pringle, 16-year-old dancer and daughter of a Los Angeles physician.

Miss Pringle, who graduated from high school last year, the youngest in her class, and entered the University of Southern California, was placed in the custody of juvenile authorities after she told the police Pantages had attacked her.

Pantages was taken into custody yesterday when the girl ran out of his office screaming, her clothes disarranged. W. C. Hale, who was in the hall, said Miss Pringle fell fainting into his arms as she rushed out of the theatre magnate's office. Other witnesses declared the clothing of both Pantages and the girl was torn and disarranged. Several persons reported hearing the girl's screams emanating from Pantages' office.

The theatre magnate denied the girl's charges and hinted it was a "frameup." He told police he had booked Miss Pringle two weeks ago for a dancing act, but that she had proved a failure. He said she had frequented his office for two days, beginning for another chance.

Pantages declared Miss Pringle asked him for an interview yesterday afternoon. After a preliminary conversation, he said, she leaned close to him and said, "I'll make you take my act." Pantages escorted the girl then pushed him into another room and ran down the hall.

Chief of Detectives A. F. Taylor, said Pantages told him Miss Pringle, realizing she was not to be employed, forcibly removed his coat and then tried to tear the remainder of his clothing into a state of disarray.

Two Wounded When Catholics Clash

Mexico City, Aug. 10.—(AP)—Disturbances to El Universal today from Acapulco, state of Mexico, said two persons were wounded and nine arrested yesterday in a clash between Roman Catholics and Mexican National or Schismatic Catholics.

After the alcalde (mayor) handed over the town's principal church to Roman Catholics, symbolizing end of the church-state conflict, Roman Catholics locked themselves in the church. The Schismatic Catholics attacked the church and broke in the door.

The fight which ensued was quelled only when the passenger train arrived from Vera Cruz and its military escort brought out to restore order. Two women were among those arrested.

Clark Brothers and Partners to go to Atlanta as Result of Bank Crash.

New York, Aug. 10.—(AP)—The three brothers and their partners were under sentence to prison today for wrecking the Clark brothers private bank which closed its doors with liabilities approximating \$5,300,000.

The bankers, all of whom pleaded guilty, were sentenced yesterday by Federal Judge Harry B. Anderson, of Tennessee, and General Sessions Judge Cornelius F. Gallus, sitting in a joint court. The defendants were under both state and federal indictments.

BEGIN PLAN TO STOP STRIKE IN GREAT BRITAIN

Prime Minister MacDonald Moved Today to end Idleness of Million Workers.

Edinburgh, Scotland, Aug. 10.—(AP)—Prime Minister Ramsay MacDonald moved dramatically today to bring about settlement of the Lancashire Cotton Industry stoppage which is causing idleness of nearly a million workers and 1,500 factories.

Leaving Lossiemouth, his native village, by airplane without announcing his destination nor the purpose of the flight, the prime minister reached Edinburgh at noon and immediately went into conference with eight representatives of the cotton mill employers' negotiating committee and Sir Horace Wilson, permanent secretary of the Ministry of labor.

Wilson has been in conversation with parties to the dispute in Lancashire for several days. He and the employers' representatives left Manchester hurriedly this morning as MacDonald left Lossiemouth by plane.

Their meeting with the prime minister here was watched closely as promising some immediate developments towards settlement of England's most costly industrial dispute since the general strike of 1926.

Chicago, Aug. 10.—(AP)—A warrant charging assault and battery on a 60 year old Spanish-American war veteran has been sworn out against federal prohibition agent Willard Mogland who had just returned to the dry force after a 60 day suspension for alleged improper arrest.

John Randecker, aged restaurant proprietor, charged that during a raid on his establishment the dry agent struck him twice in the face as he was pouring a pitcher of denatured alcohol into a sink. He exhibited a blackened eye and bruised nose as proof of his assertions.

Three other dry agents who accompanied Mogland in the raid admitted there had been a struggle but denied Mogland had hit the veteran. Mogland did not appear at the hearing and he was being sought today on the warrant.

Randecker was held on \$1,000 bond to the federal grand jury for selling liquor.

SOLDIERS OFF FOR TRAINING AT FORT BRAGG

First Detachment Left Today and Remainder Will Follow Tomorrow Morning.

An advance detachment of the local unit of the 113th Field Artillery of the North Carolina National Guardsmen left this morning about 9 o'clock on trucks for Fort Bragg, where they are scheduled to go into annual encampment tomorrow.

The remainder of the troops will make the trip by train, leaving here tomorrow morning shortly after 9 o'clock and arriving at Camp Bragg in time to report for active duty.

The detachment this morning was composed of two trucks and about six men. The trucks carried paraphernalia of the cooking department and will make the trip by easy stages, arriving at camp in time, however, to have everything in readiness for serving the remainder of the detachment when they arrive.

Mayor J. C. Lanier, who is also captain of the Greenville artillerymen, said that the total strength of his unit at Camp Bragg would be fifty-seven men and three officers. They are expected to make a splendid appearance on the field as result of grueling training continuing over a period of a month or more.

During the past week the men have drilled daily at the army on Fifth street, and they were reported to be in excellent trim at the final drill last night. While the company is slightly under normal strength, its members have seen enough service to know what is expected of them and when they get on the parade grounds they are expected to make a favorable showing against the hundreds of more seasoned veterans who will be in attendance from other sections of the state.

The encampment will continue for a period of two weeks during which time the thousands of National Guardsmen will be put through strenuous military tactics.

The local soldiers distinguished themselves the past two years and officers were recognizing as much if not more recognition this year because of the hard drilling and training which the youngsters have been subjected to the past few months, and especially the past month, when they put in extra time to get in fine fettle.

Reparation Conference Again Upset By Demands Of British Chancellor

The Hague, Aug. 10.—(AP)—A slight recovery of confidence in conference circles today when general discussion of the Young plan was resumed without incident was again upset before the end of today's vital meeting of the financial committee by the intervention of Philip Snowden, British chancellor of the exchequer.

He declared that he had placed his case before the conference and could not wait much longer for a decision.

"I don't want to spend the rest of my days at the Hague," he declared. "We must come to grips on the question at issue. My resolution is still before the committee and I cannot permit delay in action upon it much longer."

The financial committee meeting this morning was first devoted to a general discussion. W. Graham, president of the board of trade, stating that the system of deliveries in kind had affected British trade and caused unemployment. The British wanted them abolished or limited to the shortest possible time.

Henri Cheron, French delegate, gave a great number of figures which he held proved that Great Britain was getting more out of the Young plan than the Dawes plan. Chancellor Snowden expressed surprise at discussion of the reparations sums, since the morning was to have been devoted to the question of deliveries in kind. He said he would refute every figure and every statement the French minister made but that he could not wait much longer for action on his resolution regarding the revision of the Young plan.

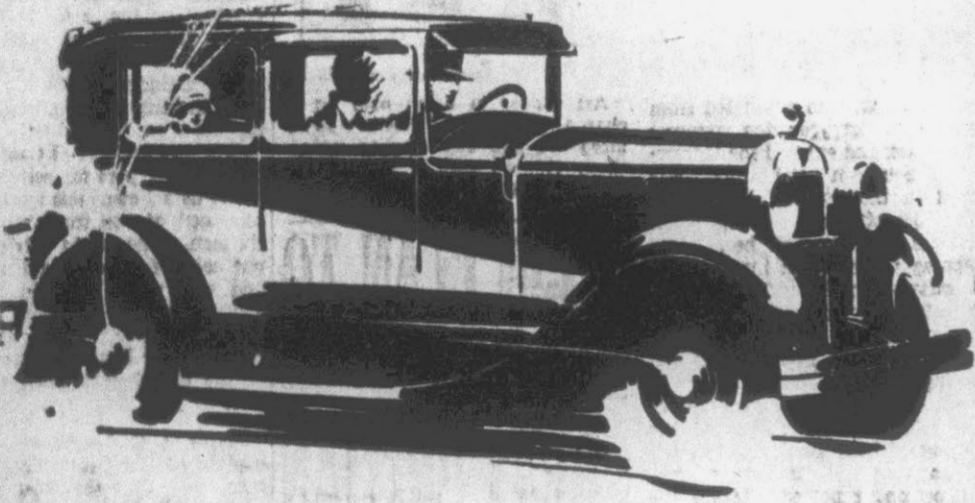

New Health Officer Takes Charge Here

Dr. Clem Ham, of Georgetown, S. C., arrived in Greenville this week where he assumed active duties as director of the Pitt County Department of Health. Dr. Ham was elected to this position at a meeting of the County Board of Health several weeks ago and came to Greenville as soon as he could complete his business in South Carolina.

Dr. Ham was graduated from the Medical College in South Carolina in 1926. He served his senior internship in a local hospital of that state and did two years of special work prior to his graduation. He later went to Alabama and pursued a course under the International Health Board and the Rockefeller Foundation.

Lindbergh were included in the list of unofficial guests, with Mr. and Mrs. Jeremiah Milbank, of New York; Mrs. Hyde, Mrs. Cumming and her son, Hugh, Jr., William Allen White, of Emporia, Kansas, Mark Sullivan of Washington, and Mr. and Mrs. Herbert Hoover, Jr., Walter Newton, administrative assistant to the President, and Lieut. Commander Joel T. Boone, his personal physician, rounded out the party.

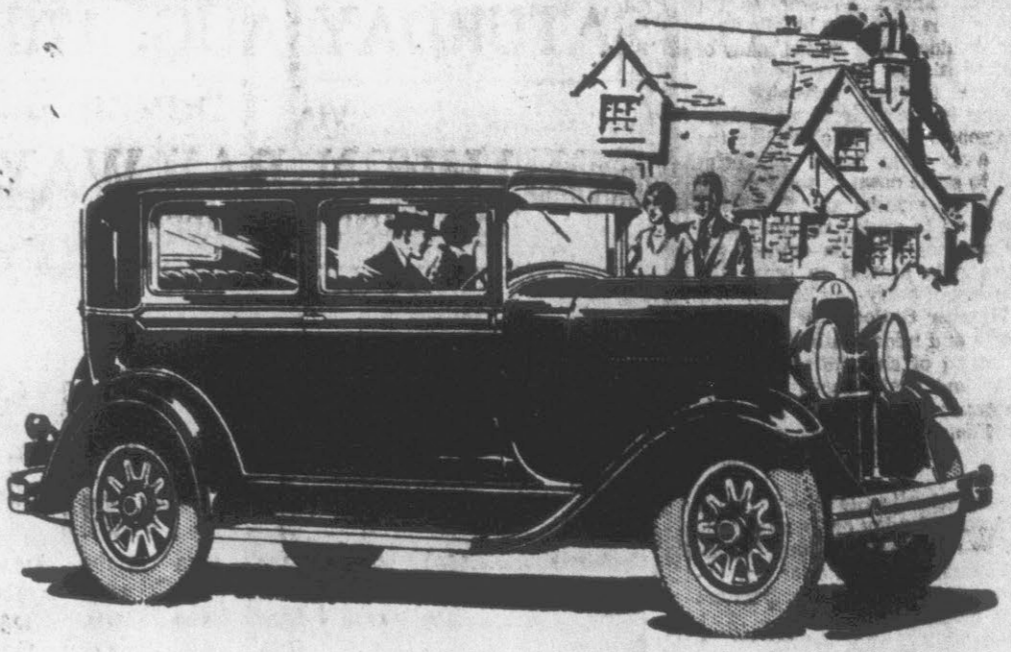

The boys are in splendid fettle for the campment of North Carolina National Guardsmen at Camp Bragg, said an officer of the local unit today.

While numbers of units have already gone to camp, the Greenville unit will not get away until Sunday morning. The boys have been in active training for several days now and should be in position to show other units what it is all about.

The Greenville contingent established an enviable reputation while in camp last year and although we have considerable raw material this time we believe they have been sufficiently drilled to be able to make a favorable showing when they go on inspection.

The boys will be out of the city ten days, and during that time they will get enough sun tan and hard work to last them the remainder of the year. But they like it. The life of the army is something of a diversion from every day existence and in a way cause the lover of home life to more fully appreciate home when he returns.

With the aldermen accepting the Evans Street school property as a gift from the school board as a site for the Sheppard Memorial Library, it looks as if members of the building committee have clear sailing before them now, mentioned a citizen today referring to the meeting of the city fathers last Thursday night when they accepted the site and promised to provide for it

as far as it is legally possible to do so.
The aldermen had previously asked the school board to donate the site to the city for the purpose of the school trustees did so after determining that it would at first be necessary to have the action ratified by the State Legislature which meets two years hence. But the legalizing of the action will not hinder the building of the library. The money has already been paid to the order of the building committee of the library and it is probable the structure will get under way as soon as preliminary plans can be completed.
"Greenville is proud of the \$50,000 structure it is to receive through the generosity of a former native of Pitt county, and the entire citizenry thanks him and members of the board of trustees of the city schools who made the Evans Street site possible by giving it to the city.
"In making the gift, the school board is absolutely giving away a piece of property for which they might realize at least \$35,000, but they feel justified in making the gift realizing that it is to be devoted to the interest of the education of the masses.
"The sooner the library is completed the better Greenville people will like it and it is to be hoped the building committee will lose no time in completing this long felt need."

"It is no small thing for a city to cut its tax rate ten cents on the \$100 valuation, but that's what Greenville has done and the majority of the people are proud of it," said a citizen today.

"This cut was made possible through the taxation of property that had gone unlisted for years and a reduction of bond interest and sinking fund."

"The school board also contributed five cents of the reduction through slicing of teacher's salaries and trimming down of the maintenance fund."

"Along with all this the board announced that property valuation had been decreased in a number of instances, giving relief to those who believed that their valuations were out of proportion to those on similar properties."

"To live up to this reduction, the board realizes that it is going to have to practice strict economy and has already started out in that direction by paring expenses in every way possible. The public is proud of the business-like way the board has started out with its new budget and will watch the venture with more than passing interest."

"Greenville Rotarians and Kiwanians ought to be able to stay at home and enjoy home life after having visited the Bayview resort this week," said a club member today.

Chicago, Aug. 10.—(AP)—Jimmy Foxx' batting average suffered slightly last week, but not enough to break his lease on the American league leadership. Figures released today and including Wednesday's game, give the Philadelphia first baseman a mark of .367, a loss of three points. A new threat of Foxx' reign appeared in the person of his teammate, Al Simmons. The Athletics' outfielder added 16 points to his average to pass Heine Manush of St. Louis, with a mark of .378, nine points behind the leader. Manush dropped five points to .368.

The name of George Herman Ruth occupied a familiar position in the last of statistics—at the top of the home run column. The Babe cracked out four homers during the week to steal the lead from Lou Gehrig, with a total of 23. Following Foxx, Simmons and Manush were: Fonseca, Cleveland, .367; Lasser, New York, .363; Combs, New York, .361; Hellmann, Detroit, .360; Ruth, New York, .354; Fothergill, .351; K. Williams, Boston, .350.

Bob Grove, the Athletics' south-paw ace, had passed a profitless week, engaging in three games with-out winning or losing. He remained in the lead, however, with a record of 17 victories and two defeats. George Earnshaw, Connie Mack's best right hander, won two games for a mark of 18 victories and five defeats. Rube Walberg's work for the week produced one defeat, leaving his record at 16 won and six lost. Tom Zachary of New York won his only start and brought his record to seven straight triumphs.

CUBS HOLDING THEIR OWN IN THE NATIONAL

(By The Associated Press) Just how to overtake a ball team which piles up an impressive lead then refuses to lose more than the minimum number of games is a problem which the greatest minds of baseball never have been able to solve. 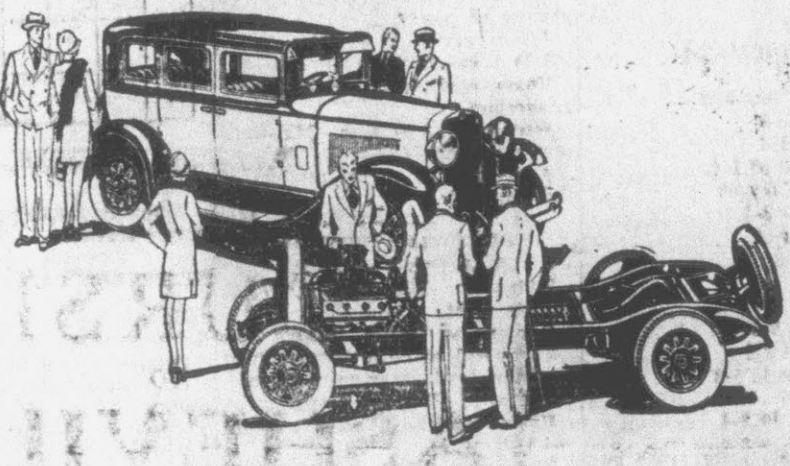

STOCK MARKET

New York, Aug. 9.—(AP)—The stock market today retrieved part of the ground lost in yesterday's sweeping reaction, which is estimated to have wiped out between two and five billion dollars in the quoted values of all listed securities. Recoveries today averaged about 2 points in the active issues, as against average declines of about 5 points yesterday. Trading showed a marked falling off in volume, total sales in the first half hour running around 333,000 shares, or a million less than in the same period yesterday.

Railroad shares took a prominent part in the rally with buying influenced by the publication of record-breaking earnings in the first six months by the class 1 carriers. Net income in that period totaled \$563,247,000, an increase of \$101,192,000, or 21 per cent above the same period last year.

Atchison was the leader of the rail group, climbing nearly 9 points above yesterday's final quotation. Delaware and Hudson rallied 7 points, Union Pacific 6, New York Central and Southern Pacific 3 each, and at least a dozen others moved up 1 to 2 1-2 points.

Contrary to general expectations, there was little distress selling today as a result of the margin calls sent out yesterday. Midland Steel preferred dropped 5 points and Houston Oil sank 1 1-2 to a new low at 68 1-2. Commercial investment Trust ran up 6 points. Elkhart Gas, National Biscuit, Brooklyn Union Gas, Newport Co., and Worthington Pump sold 3 to 4 points higher.

The closing was strong. Total sales approximated 1,200,000 shares.

NOTED WRITER PASSES AWAY

H. C. Witwer Dies At Los Angeles, but Death Remains Mystery.

Los Angeles, Cal., Aug. 10.—(AP)—The death of H. C. Witwer, humorist and writer, here yesterday morning was made known late last night, but the cause of his demise remained a mystery to the outside world. He was 39 years old and had been ill for several months. Announcement of the author's death also disclosed that Mrs. Witwer had collapsed and was under the care of a physician, and that his mother, Mrs. Margaret L. Nannery, was rushing here from New York unaware that her son had succumbed. News of the deaths was said to have been withheld because of Mrs. Nannery's age-weakened condition.

Inquires at the Witwer home as to the cause of the author's death failed to elicit an answer. The death certificate had not been signed by the attending physician.

Born in Athens, Pa., Witwer attended St. Joseph's college in Philadelphia. He was married in 1912 to Sonia Schragin of Yonkers, N. Y., while he was a reporter for the New York American. Subsequently he joined the staff of the Brooklyn Daily Eagle. He was a war correspondent for Collier's Weekly in 1917.

Witwer was known chiefly for his humorous and prize fight stories. He wrote nearly 400 magazine stories and a syndicated series of "Classics in slang."

The writer came to California three years ago, fighting to regain lost health. Friends said it had appeared for a while that he was recovering but that he suffered a relapse about three months ago.

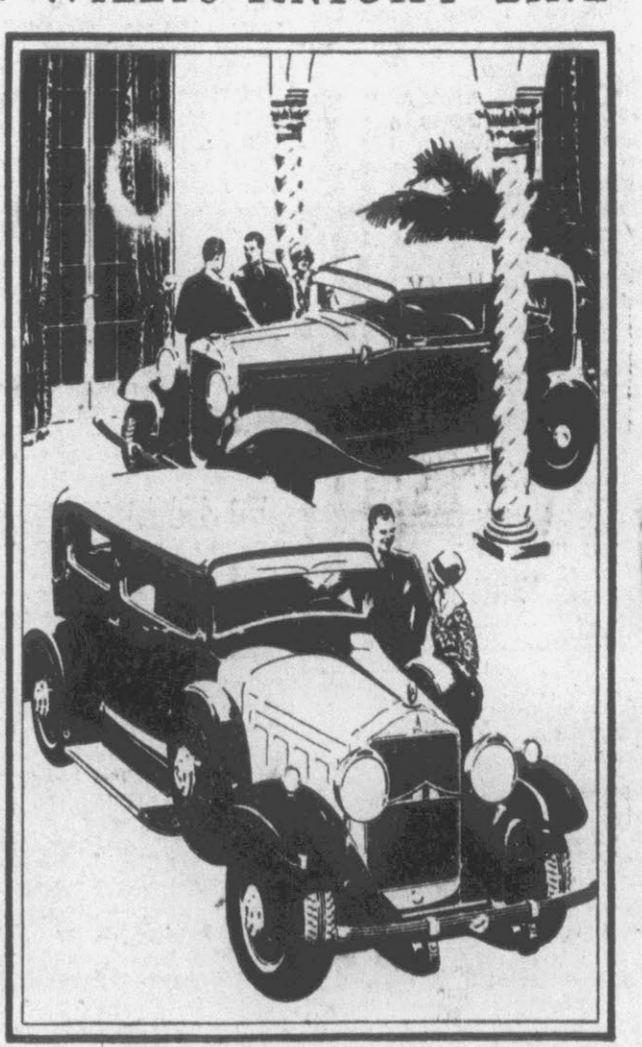
