## BOOZE PLANE IS CAPTURED IN ONTARIO

### Liquor Airports Reported Along Lonely Stretches of Canadian Shores.

Windsor, Ont., Aug. 27.—(AP)—The use of airplanes to smuggle liquor across the border was revealed today in the capture of a Michigan pilot and his machine.

Authorities said they had learned that a dozen "air ports" scattered along the lonely stretches of the Canadian shore of the Detroit river had been used by airplane run runners who switched their landing from one field to another to avoid customs and farm folk.

The airplane run running industry has not been confined to any one combine, customs men said. Adding that outfits have been flying out of Essex county with liquor shipments for American destinations.

One of the airplanes has been identified as a visitor from Wisconsin, indicating the extensive ramifications of the smugglers of the Great Lakes region.

Ray Baumgartner, 27, of Plymouth, Mich., was the pilot arrested by a royal Canadian mounted police officer two local constables and two members of the Canadian customs service at Windsor.

The pilot was captured down river near the Lassale export docks the officers hid near the isolated field. A truck loaded with 33 bags of whiskey drove up shortly before the airplane swept across the Detroit river and glided to rest a few yards from the officers in ambush. The officers arrested the smuggler after three bags of contraband had been stowed in the plane.

Washington, Aug. 27.—(AP)—Reports in Canada that a dozen airplanes scattered along the Canadian side of the border were bases for smuggling liquor into the United States were discounted today by Assistant Secretary Lowman.

"We have had reports in the last year that two or three airplanes have been used to smuggle liquor into the United States from Canada," Lowman said, "but investigation resulted in no proof of the reports except in one case along the northern border where our men captured a plane loaded with liquor."

"We also have captured several airplanes carrying liquor into the United States in Florida which came from the Bahamas. Our increased forces along the Canadian border would be apt to spot any airplanes that crossed as easily as they do run runners who use boats and automobiles."

## Bomb Wrecks Chicago Store

Chicago, Aug. 27.—(AP)—A bomb today destroyed a retail store partially owned by Sellag G. Graham, Republican leader and private secretary of Lawrence F. King, former president of the Chicago sanitary district who twice during the past year has been target of bombings. Police viewed the bombing as a possible attack upon King's political leadership. He is the recognized Republican chief of the Mayor Simpson faction in the 12th ward. Sellag Graham is president of the 12th ward regular Republican club and a state Republican central committeeman.

## Sleeping Sickness Claims Many Lives In Southern Japan

Tokyo, Aug. 27.—(AP)—Widespread sleeping sickness with a high mortality rate was reported today from the southwestern prefectures. Some were known 202 cases with 100 deaths from the disease, which is believed the result of the severe typhoid fever. Okayama was the hardest hit with 113 cases and ten deaths.

## WHOLE TIME JURY BEGINS ACTION HERE

### First Permanent Grand Jury Began Work in Criminal Court Yesterday.

Pitt county's whole time grand jury began action for the first time in the criminal session of Pitt county Superior court which convened in this city yesterday. The jury will serve for a period of six months, after which other jurors will be selected to take their place.

The six months' jury is the result of an act passed by the last session of the State Legislature, authorizing the county to adopt the permanent jury plan. The same plan is being used in numbers of other counties with splendid results, it is said.

The first jury is headed by M. D. Yelverton, well known business man of Fountain and whose long residence in the county qualifies him in assisting in the handling of the various problems to come before the jury from time to time.

Other members of the jury are substantial business men and farmers from various parts of the county. They will be subject to the call of the court at any time during the six months period and are not subject to call for petty jury service.

## Severe Restrictions Of State Evidence Marks Gastonia Strike Trial

Charlotte, Aug. 27.—(AP)—Severe restriction of state evidence in the trial of sixteen Gastonia cotton mill leaders accused of murder of O. P. Aderholt, Gastonia chief of police, was indicated today by Judge M. V. Barnhill in Superior court in overruling a defense motion to require the state to amend its bill of particulars.

While deputy sheriff were summoning 200 special veniremen from which efforts are expected to start tomorrow to select a jury, Judge Barnhill, holding a special term of court to try the cases, held a one-hour session to hear arguments of the defense seeking an amended bill of particulars from the state.

## NEGRO BANDIT SENTENCED TO COUNTY ROADS

### Accomplice in Lang's Cross Roads Robbery Also Sent to Roads.

A negro bandit by the name of Ruben Hicks, charged with holding up and robbing a filling station at Lang's Cross Roads, between this city and Farmville, and seriously injuring the operator, Joe Tripp, was sentenced to four years on the roads yesterday by Judge Gardland Midyette, of Jackson, who is presiding over the one week's term of Pitt county Superior court, for the trial of criminal cases, which convened in this city yesterday morning. Walter Brimage, charged with being an accomplice in the crime, was sent to the roads for a period of six months.

Three other defendants involved in charges of robbery and larceny were sentenced to the road during the day, but the sentencing of the filling station bandit was probably the most outstanding feature of the days session.

The lang's Cross Roads robbery occurred about a month ago. The filling station is situated just around the sharp bend in the highway leading from this city to Farmville and keeps open both day and night. The negro was alleged to have appeared at the station early one morning, knocked the operator unconscious with a cart road and then obtained an amount of cash estimated at \$20.00 and escaped to the Farmville community.

As soon as the case was reported to the authorities at Farmville they started an investigation which resulted in the capture of Hicks within a few hours after the crime had been committed. He was found in company with Brimage, but did not have the money taken from the filling station. Brimage was searched and the money was found in his possession. Hicks was identified by the filling station operator as the man that actually committed the crime, and the prisoner was brought to the county jail in this city and held for action of criminal court.

The robbery was one of the most sensational and brutal reported in this section in years, and the case attracted more than passing interest when it came up for hearing yesterday.

Three negro youths, charged with breaking in and robbing Ehrhardt's Drug Store in this city about three months ago, paid for their crime yesterday when Judge Midyette sentenced them to eighteen months each on the roads. They were Wilber Banks, Jack Sparkman and Nick Hines. The youthful robbers succeeded in carrying off a considerable amount of goods from the drug store, but police soon rounded them up with most of the goods being recovered.

E. D. Porter, charged with larceny and forgery, drew 12 months on the roads.

Ance Andrews, charged with operating an automobile while drunk, was sent out to the roads to do four months service.

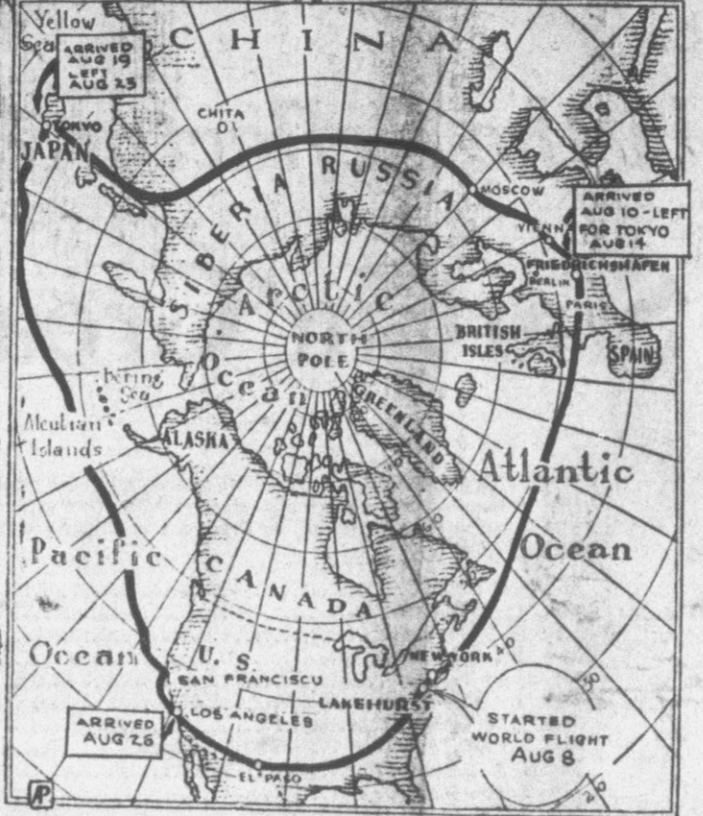

## Over Hundred Jews Die In Warfare With Arabs; New Disorder Reported

Jerusalem, Aug. 27.—(AP)—Jewish dead in four days of bitter race warfare with Arabs Muslims today numbered more than 100, of whom 15 were Americans, students at the Rabbinical college at Hebron Arab dead were assumed to be as numerous. Hundreds suffered from wounds.

Southern Palestine momentarily seemed quiet but new fierce outbreaks between the Islamic tribesmen and Jews were reported from northwestern Palestine, particularly in the vicinity of Haifa.

There were recurring attacks at both Tel Aviv, all Jewish city, and nearby Jaffa (Joppa), where British police fired on a crowd attacking the government offices, killing five Arabs and wounding several.

The government began to disarm the Jews but it was understood the Arabs continued to obtain arms from Trans-Jordania. The Arabs are equipped with machine guns, armored cars, and airplanes.

Policing in Jerusalem largely has devolved upon a force of 600 British volunteers who are patrolling the streets to maintain order. With appearance of British bayonets in the Holy City the situation became somewhat easier, although hundreds of Jews still are in hiding, afraid to appear on the streets.

The bodies of 27 Jews buried last night in a second common grave, similar to the first tomb dug in the side of the Mount of Olives for the bodies of 16 others. One of the six victims of the fighting at Tel Aviv was said to be the son of the noted Jewish philanthropist, Isaac Leib Goldberg.

## ECKENER SAYS OCEAN TRAVEL NOW FEASIBLE

### Commander of Zepelin Says Passenger Service Around World not Difficult.

Los Angeles, Aug. 27.—(AP)—Dr. Hugo Eckener, Graf Zeppelin commander, who found his stay in Los Angeles too busy and too short to grant extended interviews to newspapermen, just before his departure for the dirigible for Lakehurst early today, dictated a discussion of the practical and commercial aspect of cruises such as that being completed by the Zeppelin. Commander Eckener based his statement on questions submitted to him.

"Trans-Pacific travel is entirely feasible with Zeppelin airships," Dr. Eckener said, "but such ships designed for regular commercial service should be larger and faster than the Graf Zeppelin."

"The maintenance of regular passenger service by Zeppelin airships around the world presents no technical difficulties, but would necessitate the establishment of complete ground support for the airships, such as hangars, masts and fuel supplies."

Dr. Eckener referred to the time made so far by the Graf Zeppelin as "satisfactory" but predicted it would be better by "newer, stronger, faster ships."

"Increase in carrying capacity," he said, "and increase speed to allow selection of weather to maximum advantage," were improvements suggested by the flight.

"This project successfully completed," Eckener concluded, "I believe the time is ripe for commercial exploitation of trans-oceanic transport by Zeppelin ships."

## Plan to Broadcast Zeppelin Arrival

New York, Aug. 27.—(AP)—The National broadcasting company today announced that arrangements were being made to broadcast a description of the arrival of the Graf Zeppelin at Lakehurst, N. J., at the end of its trip around the world.

The description of the arrival together with talks by officers and passengers of the airship will be transmitted through a nation-wide hook-up. The broadcasting company said.

## Zepp Off On Last Lap Of Cruise Around The World; Damages Tail In Take-off

Los Angeles, Aug. 27.—(AP)—The globe-circling dirigible Graf Zeppelin came within a few feet of encountering potentially serious trouble but escaped with only slight damage here early today as its tail scraped a high tension electric line shortly after the takeoff for Lakehurst, N. J., on the last lap of its round the world flight.

The big ship containing thousands of cubic feet of hydrogen a high inflammable gas, scraped the electric line as it fought to gain altitude immediately after the takeoff at municipal airport at 12:14 a. m. Pacific coast time.

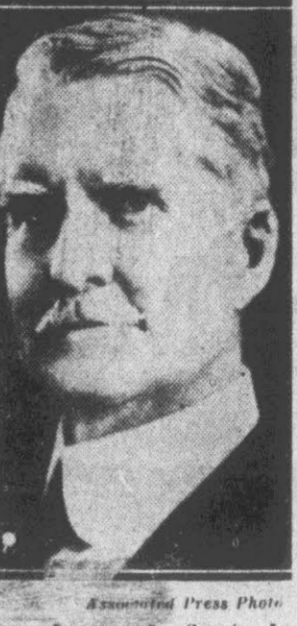
First word of the accident reached here about two hours later when the radio corporation of America intercepted a message from the air liner saying the damage had been slight and that it would not interfere with the trip.

Field workers here realized almost immediately the dirigible was having trouble in gaining altitude. As the ship soared over the edge of the field a large quantity of canned food was dumped overboard to lighten the load.

Dr. Hugo Eckener, commander of the airship, anticipated the problem of gaining altitude before the ship started and took only 52 persons aboard for the trans-continental trip. On the flight across the Pacific the liner carried 60 persons.

## RULES OFFICE MEMORANDA IS NOT RELEVANT

### Judge Deaver Passes Opinion in Hall-Lavarrre Case at Macon, Georgia.

Macon, Ga., Aug. 27.—(AP)—Federal Judge Bascom S. Deaver today ruled that "inter-office memoranda" of the International Paper company was not relevant in the Hall-Lavarrre newspaper suit.

Head, of the International Paper company, testified today at the resumption of the hearing before Federal Judge Bascom S. Deaver.

Harold Hall is suing for equal operating control with William Lavarrre of the Augusta (Ga.) Chronicle, the Columbia (S. C.) record and the Journal which were bought for \$870,000 advanced by the International Paper company.

Counsel for Lavarrre had taken head over the list of papers which the International Paper Co. had helped to finance and had asked him if he had correspondence up within two days of this trial relative to sale of the four papers under discussion.

Replying in the affirmative, Head said he had received letters from Park about the matter. He brought out that the letters were preliminary only.

## STOCK MARKET

New York, Aug. 27.—(AP)—Call money advanced from 7 to 9 per cent today and the stock market ran into a heavy storm of selling, early gains of 1 to 15 points were cut down, or wiped out, and by early afternoon many of the recent leaders were selling 1 to 6 points below yesterday's final quotations. In the early outburst of buying, more than 20 issues, including half a dozen rails, were lifted to new high records.

Wall street apparently was surprised at the abrupt advance in the call rates as reports had been current for several days that the heavy month-end settlements would cause little disturbance to the money market, but that a pinch was likely around September 15th because of federal income tax payments and government financing.

Outside of the credit situation, most of the day's news was favorable. Directors of the New Haven Railroad raised the annual dividend from \$4 to \$5, and Vick Chemical new stock was placed on a \$2.50 annual basis, equivalent to \$5 on the old stock, which paid \$4. The first 27 railroads to report their July earnings showed a gain of nearly 28 per cent in net over the same month last year as against a gain of only 7 per cent in gross.

Today's reaction was not a surprise to most observers as the market has been going upward almost perpendicularly since the break which followed the raising of the New York Federal Reserve discount rate on August 8. While new soft spots have been cropping out day after day, most of the high grade industrial and railroad shares have been soaring to new high records. Today's list included Austin Nichols, Allied Chemical, Columbia Carbon, American Water Works, National Dairy Products, American International, R. H. Macy and Air Reduction. Among the rails, Pennsylvania "Nickel Plate," Lackawanna, St. Paul preferred, and Hocking Valley moved into new high ground, the last named adding 30 points to its 40-point gain of yesterday. In the early afternoon reaction, American Telephone dropped 5 1-2 points, Auburn Auto 5, Johns Man-
