

CLEVELAND TO WELCOME TWO BIG AIRLINERS

Thousands Gather to Witness Arrival of Zeppelin and Los Angeles.

Cleveland, Ohio, Aug. 28.—(AP)—Thousands of spectators at the National air races turned from the fleet craft of army, navy and derby to the larger and more awesome liners of the skies today as the courses of the two great dirigibles, Graf Zeppelin and Los Angeles, converged above Cleveland airport.

The Los Angeles, largest of the United States navy's fleet of lighter-than-air craft, was ordered from the base at Lakehurst, N. J., for arrival here in mid-afternoon. The Graf Zeppelin, beating its way eastward on the fourth and last lap of a flight around the world, was awaited some time later.

A mast erected under the direction of navy fliers has been built on the airport overnight. The Graf Zeppelin will await the return of the Los Angeles there tomorrow when orders of navy officers call for the ship's return.

A reception outdaring any yet seen at the races was planned for the arrival of the two giant craft. Airplanes of navy detachments which have maneuvered and stunted through the course of three days, as bombers, pursuit ships and scout planes of army air forces here for the races, combined for a greeting to the Los Angeles, with smaller blimps of the Goodyear Tire and Rubber company, four of them appearing here during the events.

Order Strict Enforcement of Highway Laws

Wilmington, Del., Aug. 28.—(AP)—State highway patrolmen all over the state have been instructed by Captain Charles D. Farmer to more strictly enforce all highway laws and to issue warrants for cases of violation of light regulations and reckless driving.

The order to tighten up on motorists throughout the state was issued, Captain Farmer said, in an effort to lessen the number of automobile accidents occurring throughout the state with a resultant large number of fatalities.

For almost two full months now the patrolmen have been warning motorists of law violations and warrants have been issued in only a few instances. Effective at once, however, all patrolmen have been instructed to strictly enforce all regulations with especial attention being paid to the violations of light and driving regulations.

Continue Search For Two Entombed Men at Penn. Mine

Wilkes-Barre, Pa., Aug. 28.—(AP)—Rescue crews today were penetrating the wrecked interior of number 8 shaft of No. 9 Colliery, Penn.sylvania Coal company, of Hughes town, near here, in search of two entombed men, Martin Golden, of Honesdale, and Joseph Pupper, of Pottsville.

Little hope was held that they would be found alive.

One man was killed and about 200 other injured in a "squeeze" yesterday. Work of reaching the two trapped men was temporarily halted last night when crew leaders found it necessary to abandon the search because of the aftermath settling of the squeeze area.

Man and Woman Appeal Here On Assault Charge

Mrs. Mary Prey, operator of the Coffee Shop, an eating establishment on Dickinson Avenue, near Five Points, was fined \$100 and cost in a special session of Mayor's court yesterday, after being convicted of two charges of assault on Mrs. J. B. Gurkin, a Coffee Shop waitress. Stanley Tripp, held in connection with the same case, was fined \$10 and cost. Both defendants pled not guilty of appeal to the next session of County court.

Mrs. Prey was charged with assaulting Mrs. Gurkin at the Coffee Shop and then again in the Prey home. In the first assault she is alleged to have struck the waitress and then locked her in a closet with Tripp.

Graf Zeppelin Draws Near End Of Cruise Around The World

Kansas City, Aug. 28.—(AP)—Heading straight for Chicago after passing over Kansas City this morning, the German Graf Zeppelin pursued a northeasterly course across Missouri and was approaching the Mississippi river shortly before noon.

Kansas City, Aug. 28.—(AP)—Slipping through the clouds in a grim attempt to retrieve time lost during the night over the rugged, storm-infested mountain area of western Texas, the Graf Zeppelin was speeding toward Kansas City from the southwest today on the last lap of its round the world cruise.

Strong head winds, which apparently prevailed at all heights, still prevented the big silver snip from equalling the high speed at which it crossed the Pacific from Tokyo to Los Angeles, but the 40 to 50 miles an hour at which the sullen waste country of the Sierra Diablo and Guadalupe mountains was traversed had been increased to approximately 60 miles an hour over Oklahoma and Kansas.

The direct line which Dr. Hugo Eckener, commander of the craft, adopted after reaching the Texas Panhandle late last night showed he intended to waste no time in reaching Cleveland, where he promised to maneuver over the city as part of the national air exposition program before proceeding to Lakehurst, N. J., terminus of the flight.

Dr. Eckener radioed officials of the air exposition yesterday that his ship would reach Cleveland about noon today, but adverse winds and tropical storms, encountered early last night, retarded progress to such an extent that it appeared the ship would not be able to reach Ohio until late evening.

According to the original schedule of the northern route selected by Dr. Eckener, the dirigible will fly from here to St. Louis, then to Chicago, from which place it will make a bee line for Cleveland and Lakehurst.

Encountering its first storm after leaving Los Angeles at 2:14 a. m. yesterday, an electrical disturbance between San Diego, Calif., and Yuma, Arizona, the big ship nosed down the eastern ridges of the Rocky mountains, once more victorious over the elements. In mid-afternoon the dirigible passed over the continental divide of the Rockies, then, bucking headwinds, zoomed over Arizona and New Mexico, arriving at El Paso at 5:13 a. m.

After hovering over the west Texas city for fifteen minutes the Graf dropped across the international boundary line into Mexico. A few minutes later it reverted to its

FOWL THIEVES GIVEN TERMS ON THE ROADS

Two Other Defendants Sent to Road in Criminal Court Here Yesterday.

The wheels of justice revolved rapidly again in the criminal term of Pitt county Superior court yesterday and three defendants appearing on charges of larceny and assault with a deadly weapon found their way to the county roads. As on the previous day when several defendants were given varying sentences to the road, Judge Midyette dealt severely with each case, and as a consequence the county road force will have much new material for the next several months.

Ed Judd and Herman Mason, colored, of Greenville, were sentenced to twelve months each on the roads after being convicted of a charge of stealing chickens.

Judging from the evidence introduced, the negroes had gone into the chicken stealing business on the wholesale plan, and were rounded up by the police just when business was at its peak. They were charged with the larceny of thirty or more chickens from the home of Mrs. Baum and at least a half dozen from the barnyard of L. C. Powell, local tobacco auctioneer.

The thefts were reported to the police and in a short time the thieves were jailed and chicken-raisers in various neighborhoods of the city were able to rest more comfortably at night, and especially without the fear of getting up some morning to find that their barnyard had been cleaned out during the night.

John Slade, colored, charged with shooting another negro by the name of John Hodges, was sentenced to eight months on the county roads. Allen Oobb, colored, found guilty of the larceny of a car from Robert Haddock, of the Swift Creek community, drew a total of three years on the roads.

The jury recommended mercy in the case of J. J. Carson, charged with selling liquor, and the defendant was given a six months' suspended sentence to the roads. Charged with driving an automobile while drunk, Sam Newsom, colored, paid a fine of \$50.00 and cost and had his license revoked for a period of 90 days.

SEN. TYSON BURIED TODAY

Distinguished Pitt County Laid to Rest at Knoxville, Tennessee.

Knoxville, Tenn., Aug. 28.—(AP)—Back among the hills of east Tennessee, scene of his battles to overcome the handicap of scant advantages of youth, Senator L. D. Tyson statesman, soldier, lawyer and capitalist, today finds his final resting place.

Former comrades in the army, where in youth he patterned his career after his father who fought in the gray line in the war between the states, had charge of the funeral, and burial was prepared at the old Gray Cemetery where he some of Tennessee's famous dead.

The soldiers who fought with Tyson as a young officer in the Spanish American war and in the world war in which he gained the rank of Brigadier General, and was decorated for meritorious service fell in line to escort the body to the grave.

Inc Cream Sales Increase in U. S.

Washington, Aug. 28.—(AP)—America's addiction to ice cream is increasing annually and last year 348,048,000 gallons were consumed in this country.

The bureau of agricultural economics, in making public the statistics, estimated the per capita ice cream consumption in 1928 at 2.90 gallons. Ten years ago, in 1919, enough ice cream was sold to have supplied each inhabitant with 2.90 gallons, while in 1910 the consumption was only one third what it was last year. Per capita estimates for 1910 were 1.04 gallons.

WILL OPPOSE THE REMOVAL A. C. L. TRAINS

Citizens to Ask Commission not to Permit Taking off of Two Trains.

The Corporation Commission will be asked not to permit the Atlantic Coast Line Railroad to discontinue passenger trains 52 and 53 operating between Weldon and Kinston, according to a decision reached at a meeting conducted in this city yesterday.

The meeting was attended by representatives from Ayden, Scotland Neck, Winterville, and Greenville, who drafted resolutions declaring that the removal of these trains would greatly impair transportation to the sections served by the two trains.

The Eastern Carolina Chamber of Commerce, represented at the meeting by Secretary N. G. Bartlett was instructed to compile data from the various towns and to have this ready when the railroad's petition comes up for consideration before the Corporation Commission. The date of the hearing has not yet been determined.

It was the sense of the meeting that the express and mail service in and out of the various towns along the Coast Line railroad served by these two trains would be materially affected. The hardest blow would be dealt hosiery mills located along the line. It was stated that virtually 85 per cent of the output of these mills was shipped by express.

Merchants stated that their express service would be considerably handicapped but they were unable to say off hand how much it would mean to them in the course of a year.

J. J. White, president of the Greenville Merchants Association, served as president and N. G. Bartlett acted as secretary. The following resolution was unanimously adopted.

Whereas there is a movement on foot by the Atlantic Coast Line Railroad to take off and discontinue the operation of train Nos. 52 and 53 running daily except Sundays;

And whereas the cities of Greenville, Scotland Neck, Winterville, and Ayden, situated on this line and served by it, in a mass meeting at Greenville, N. C., August 27, 1929, after a thorough discussion of the service now being rendered by said trains, arrived at the conclusion that the removal of these trains would result in much inconvenience to the patrons in its mail, express and passenger service;

Now therefore be it resolved by the citizens of the towns represented at the above meeting, that every effort be used to retain the present service being rendered by the Atlantic Coast Line in the operation of its trains Nos. 52 and 53, and that the Corporation Commission of N. C., be requested to set a date for the hearing of the petition filed by the said railroad seeking to remove said trains.

And that due notice be given all towns situated along the Atlantic Coast Line railroad which would be effected by the removal of said trains, to the end that they may use such efforts as they deem advisable to retain the present service.

And that the Eastern Carolina Chamber of Commerce, Inc., be requested to gather data from the individuals located in the towns along the said line with reference to the service now being rendered by said line, so that such information and data may be presented at the hearing before the Corporation Commission.

The above resolutions adopted on motion of Ennis Bryan and duly seconded by C. Heber Forbes this the 27th day of August 1929.

THREE JURORS SELECTED IN STRIKE TRIAL

Thirty-nine Talesmen Examined During Morning Session of Court Today.

Charlotte, N. C., Aug. 28.—(AP)—Three jurors had been tentatively selected in the trial of 16 Lory cotton mill strikers, and officials of the National Textile Workers Union and affiliated organizations accused of murder, of O. F. Adersholt when recess for lunch was taken in Superior court here today.

The three chosen were S. L. Caldwell, farmer, Mockelburg county; J. O. McCoy, Charlotte, structural steel worker and Zeb Morris, Jr., Matthews, N. C., farmer.

Thirteen men and three women are charged with murder growing out of the fatal wounding of Adersholt, who was Chief of police of Gastonia, in a strikers tent colony the night of June 7.

Thirty-nine talesmen were examined during the three hour morning session. The third, fourth and nineteenth were accepted.

The state used 8 peremptory challenges and the defense ten, 18 being excluded for cause.

Farmville Market Ready for Opening

Farmville, N. C., Aug. 28.—(AP)—The four warehouses and three tobacco factories of Farmville are all in readiness for the opening of the heart of the bright belt of Eastern Carolina and has four paved highways leading into the town from each direction. Each warehouse is equipped with a good sales force and splendid auctioneers. Two sets of buyers will represent the various large tobacco companies. The Farmville market has made wonderful progress in the past few years and it is believed that this year will be a banner year for Farmville.

Heavy Fighting Continues Between Jews and Arabs

New Uprising Threatened

Jerusalem, Aug. 28.—(AP)—British troops have occupied most of the Jewish colonies in Southern Palestine, but there are said to be grave threats of danger in the north, where the colonies are undefended against a rumored Bedouin advance from Transjordan.

British troops everywhere were said to be taking strong measure against Arabs who proved unruly. Airplanes were used to fight off an Arab attack on the Jewish colony of Bethgalim, where many Arabs were killed, desultory fighting continued in Haifa.

Cairo, Egypt, Aug. 28.—(AP)—Uncensored telephonic advices to the Jewish Telegraph agency at 1 a. m. today said fighting between Jews and Arabs continued in much of Palestine, with the smaller colonies bearing the brunt of Moslem attacks.

"A day of heavy fighting with many new casualties and one dead passed in Haifa, northwestern Palestine," it was said. "In the evening quiet prevailed." In the afternoon British Marines fired on both Jews and Arabs in quelling a Moslem attack on the Jewish quarter. Two barracks were destroyed by flames, with no one to extinguish them.

Jerusalem was described as in grave danger, with 2,000 armed men, including Druse tribesmen, marching on the city. Three Jewish houses in the old quarter were set afire. The Jewish Colony, Montev, near Jerusalem, was in flames at the time of the telephone call.

A part of the Colony Tel Joseph was burnt down yesterday. Meier Shifeya, a steelman maintained by the Junior Hadassah, American young women's Zionist organization, sent an urgent appeal to the American consular for help. A military detachment was dispatched there shortly afterwards.

Isaac Ben Zvi, leader of the Jewish Defense Corps, in a telephone message, said the Defense Corps was being disarmed and arrested. He added refugees arriving from Tel Aviv, all Jewish Colony near Jaffa, reported a lack of bread and other foodstuffs.

Ben Zvi expressed the opinion that the Palestine government alone was responsible for the riot of the last five days.

"We are certain that if the Palestine government had sent to patrol the Arab demonstrations on Friday at the same number of police it sent to patrol the Jewish demonstration on Thursday order would have maintained in the Holy City," he said.

Wind Causes Postponement Of Marathon

Toronto, Ont., Aug. 28.—(AP)—A chilling wind from the north has caused postponement of the fourth annual Wrigley Marathon swim for 24 hours and perhaps more.

The swim, scheduled for today, was postponed until tomorrow when a cold wind sent the temperature of the water in Lake Ontario down to 54 degrees yesterday, four degrees below the required minimum of 58 degrees.

Officials were hopeful the weather would change for the better but official forecasts were not favorable.

Crosses Ocean To Marry

Charleston, S. C.—Agatha Gavinski, who came from Germany by steamship for the purpose, is to be married tomorrow to Paul Mueller, who crossed the Atlantic alone in an 18-foot sailboat. The mayor will give the bride away. The German consul will be best man. Shortly thereafter Paul intends to sail back to Germany in a small boat alone.

SAYS GERMANY CANNOT MEET YOUNG PLAN

Dr. Stresemann Declares Nation Cannot Make Sacrifices Demanded of Her.

The Hague, Aug. 28.—(AP)—Dr. Gustav Stresemann, German foreign minister, told the five creditor powers today that Germany could not make the sacrifice demanded of her in the agreement on the Young plan reached last night.

The foreign minister announced the German position at a meeting this morning to consider the agreement reached last night giving to Great Britain between 70 and 80 per cent of the demands set forth by Philip Snowden, British chancellor of the exchequer.

This agreement was tentative. Germany's acquiescence being necessary since it involves Germany's surrender of its share in the surplus of the Dawes plan payments between April and September of this year over the payments called for in the Young plan.

The chief of the Reich's delegation said the Germans in Paris had gone to the limit of the country's possibilities when they accepted the schedule of annuities under the Young plan. They were now asked to make another sacrifice in order to facilitate an accord among the creditors to the distribution of reparations money which after all does not concern the German government.

He set up a definite claim to a share in the surplus of the Dawes plan payments over the Young annuities from April to September.

In the face of this new check to the progress of the conference and what had promised a complete agreement by compromise, it was decided that the German and creditor experts go over the same ground while the negotiators look a second time at the agreement.

Despite the apparent setback, the general feeling was that an agreement would be reached with Germany at the expense of some concessions and there was some talk of a full session tomorrow to wind up the conference.

Goldboro Man Elected Head of American Legion

Raleigh, Aug. 28.—(AP)—Colonel George K. Freeman, of Goldboro, will head the North Carolina department of the American Legion during the coming year, while Mrs. R. S. McGeechy, of Kinston, will head the Legion auxiliary.

Col. Freeman defeated Col. Hodge A. Newell, of Henderson, for commander in the Legion's election at its closing session of its annual convention yesterday. Mrs. McGeechy was unopposed.

Begin Action To Acquire Land For The National Park

Asheville, N. C., Aug. 28.—(AP)—The North Carolina Park Commission today instituted condemnation proceedings in Buncombe county Superior court to acquire for the Great Smoky Mountains National Park the 32,512.11 acre tract owned in Swain and Haywood counties by the Ravensford Lumber company.

Accompanying the condemnation petition was a temporary restraining order prohibiting the lumber company from further cutting of timber on the lands under condemnation. A hearing on the petition was held Sept. 10.

The land placed under condemnation today includes some of the wildest and most rugged portions of the Great Smoky Mountains. Generally, the tract lies under Mt. Ocoyot and extends east of Hughes Ridge along Bunches Creek, Straight Fork, and Ravenfork in Swain county, and along Cataloochee Creek in the Balsams in Haywood county. The tract runs from the crest of the Smokies at the North Carolina-Tennessee line to Ravensford Lottices on the Ocoona Lufly River, where it adjoins the Cherokee Indian reservation.

The condemnation proceedings against the Ravensford Lumber Co., lands makes a total of 71,000 acres which the Park commission now has under condemnation for the North Carolina side of the Park. At a meeting on the commission some weeks ago it was reported that 39,000 acres were under condemnation.

Besides the 71,000 acres under condemnation, the commission has actually acquired or placed under option with actual purchase only a matter of form 58,000 acres of land for the Great Smoky Mountains National Park.

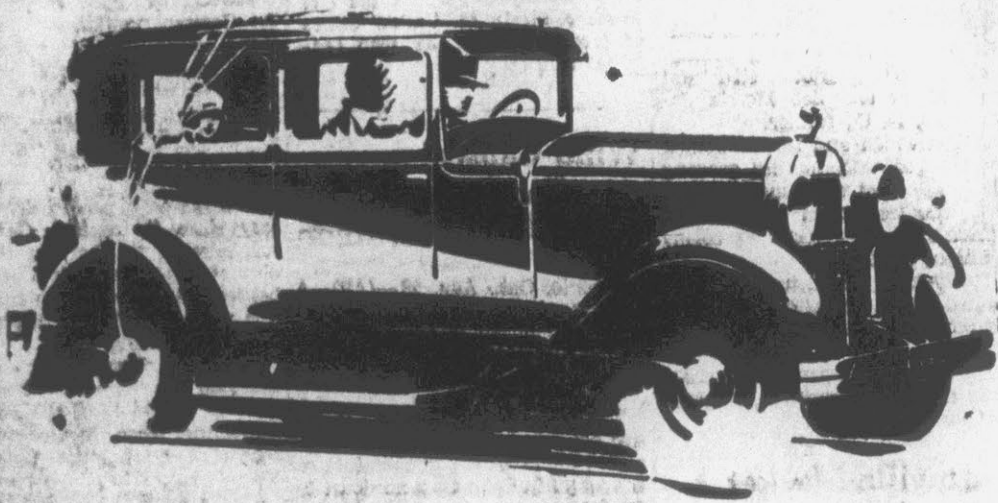

NIGHT WORK OF COTTON CAUSES CURIOSITY

Washington, Aug. 28.—(AP).—Curiosity over developments in the disarmament negotiations in progress in England was intensified today by the lack of information to account for the long night labors of undersecretary cotton and a corps of stenographers at the State Department.

Cotton, who drafts the administration's instructions to Ambassador Daves for his guidance in the discussions with Prime Minister MacDonald, cancelled his evening engagements and secluded himself with extra assistants in his office after a three-hour conference at which President Hoover discussed the situation with stat and navy department officials.

That conference was described in well informed circles as having "no special importance," but no inkling was given as to what took place, and cotton declined to give any hint as to the nature of the task which kept him busy far into the night.

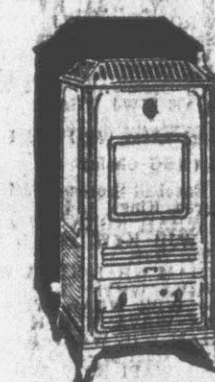

THE TRAGIC RECORD

As another summer draws toward its close the news-
papers are crowded with re-
ports of devastating fires. A
dropped cigar or cigarette,
a campfire incompletely ex-
tinguished—such little care-
less things as these have re-
sulted in the destruction of
magnificent forests, great
factories and thousands of
homes.

The most tragic part of it
all is that the waste is en-
tirely unnecessary. It is a
matter of moments only to
properly put out a fire or
step on a burning cigar stub,
or properly inspect a build-
ing for possible risks. Yet
when these small tasks are
left undone the result may
be a conflagration that
wrecks the work of years.

A little care and a little
knowledge and a little en-
ergy on the part of our citizens
would reduce our fire loss to
a minimum. The fact that
losses have been decreasing
slowly, for two years, is
hopeful but inconclusive.
Our fire record remains a
national disgrace, a black
blot on our efficiency and
prosperity.

Insurance and fire-resist-
ant construction of buildings
and fire patrols in our parks
and forests, are necessary
protections. But valuable as
they are, they can never be
a substitute for individual
"fire carefulness." And we
pay each year for our care-
lessness with close to half a
billion dollars, beside the in-
estimable loss in business
and in human lives.

DODGING THE ISSUE

The automobile has
brought much pleasure to
the American people. But it
has also brought one of our
most serious problems. Every
year thousands of people are
killed and maimed in auto-
mobile accidents of various
sorts. The majority of the
casualties result from care-
lessness and incompetence.
There are few unavoidable
accidents.

It would seem a simple
matter to enforce adequate
driving laws, and when tried,
it has proven that this re-
duces the accident rate. It
would seem equally simple
to withhold operating licens-
es from persons too ignorant
or too incompetent to drive
a car with ordinary ability.

But we are a careless peo-
ple in many ways. And our
lack of safety consciousness
causes untold waste in lives
and property. Until we fol-
low the obvious course and
teach prevention, modernize
traffic laws and bar the reck-
less and incompetent from
the highways, the toll of
automobile deaths will
mount.

day.

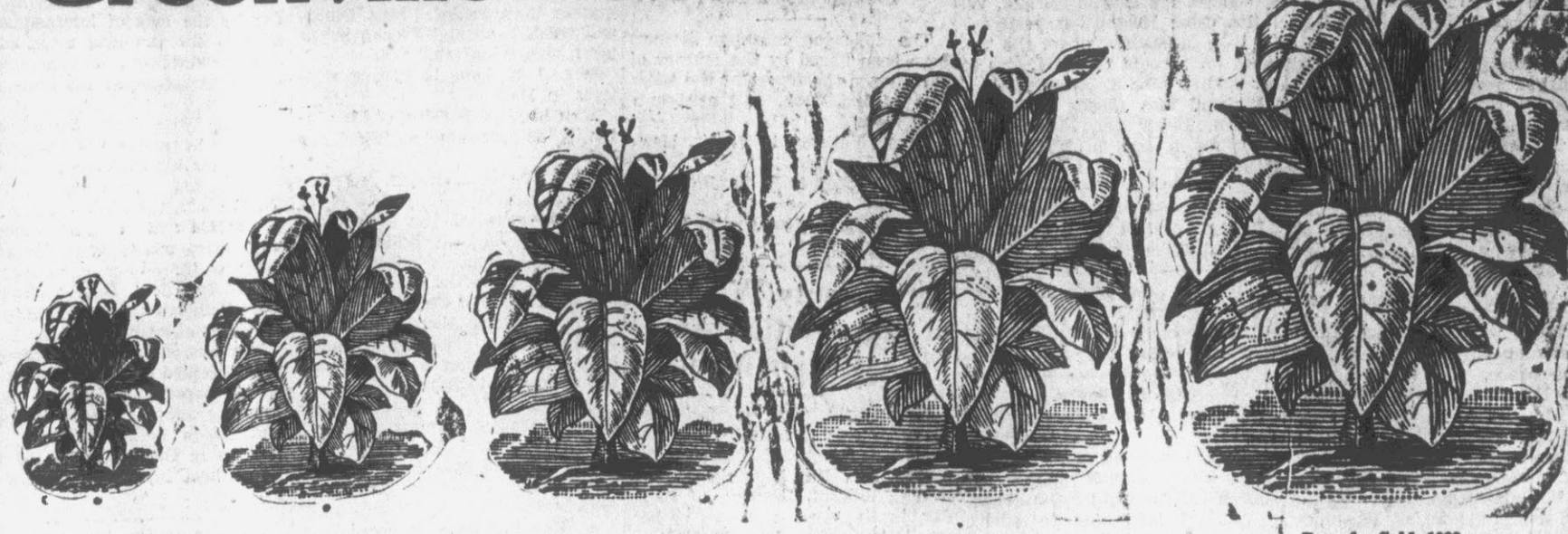
"Not that the paper isn't newsy

CUBS GAIN TIGHT HOLD ON THE TOP

(By The Associated Press)
The Cubs of 1929 are not going to win 116 ball games, but nevertheless they retain a chance to equal or improve upon another feat performed by their illustrious predecessors of 23 years ago.

The Cubs of the late Frank LeRoy Chance in 1906 not only won 116 victories, but rested 90 games ahead of the runner-up Giants at the finish. The mark, second only to Pittsburgh's 27 and one-half game victory over Brooklyn in 1902, remains in danger before the rush of Joe McCarthy's fast-flying team.

After cutting the Reds again yesterday by 4 to 1, the Pirates fell before the Phillies by 7 to 4, the Cubs rested 14 and one-half games to the good, no other team in the National League has enjoyed such a lead at this stage of the race since the earlier Cubs of Chance ran wild in 1906; no other team in the league has had such an edge at any point along the trail since John McGraw's 1912 champions piled up a large early margin only to see it wither.

A continuation through the stretch of the results of the last five weeks could give the Cubs an ultimate lead of 20 games or more, and most likely would land them in the 700 class, achieved by no National League winner since the Pirates of 1909 reached 724 with 110 victories. The Cubs need 26 out of 35 to gain 108 triumphs and 701.

The triumph of the Phillies was the second major league victory of young Harry Smythe, the Asheville, N. C., southpaw, who made his first start. His earlier winning effort also was at the expense of the Pirates on their recent and longer visit to Baker Bowl. The Phils crowded all of their seven runs into one inning, the seventh.

George William Pipgras entertained 20,000 Yankee clients and gave Cornelius McGillicuddy an uncomfortable afternoon by holding the Athletics to three hits yesterday as the champions nosed out the lead 2 to 0. Pipgras made it off to pitch a no-hit game, allowing no safeties until the eighth when Simmons and Miller singled. Conchrons tripped in the ninth, but died trying for a homer.

Babe Ruth retired after striking in the first inning. He was wearing from a heavy cold in his muscles, but expected to take their fling today.

Washington and Boston, star performers at the recent invasion by the Seaboard, 8 of the American league harkway at each other for fourteen runs, with the Senators finally ring by 5 to 4.

Only four games were played in major leagues yesterday, and by the same number, two in the Pittsburgh double-headers, were on the schedule today.

There appeared to be buying on expectations of a bullish weekly weather report while there was some selling on private reports of light showers in the Texas plains. The offerings, however, were well enough absorbed to give the market a generally steady tone and prices worked up to 18.91 for December and 19.19 for March by the end of the first half hour or about 3 to 6 points net higher. There was evidently a feeling that the showers reported in Texas had been inadequate to relieve droughty conditions.

Private cables said continental liquidation had been absorbed by local buying and trade calling in the Liverpool market and reported a broadening demand from the home trade for cotton cloths but said India was quiet on account of the native holidays.

STOCK MARKET

New York, Aug. 28.—(AP)—The stock market apparently recovered from its money scare today when aggressive bullish demonstrations were conducted in the rails and specialties. Little progress was made by such groups as the oils, motors, steels and equipments, and there were a few points of weakness. Pool operations provided the backbone for the advance, although several of the large commission houses reported an increasing odd lot business from small traders and investors.

The high rate of business and industrial activity was stressed by operators for the advance as the basis for their campaign. Considerable emphasis was laid on the steady increase in freight car loadings which is construed as an indication that a large volume of goods is moving into consumption. There has been a slight seasonal falling off in steel output but the rate is still well above what it was a year ago.

Today's dispatches from the Hague, indicating that the Germans had balked on the allied agreement on reparations, were somewhat of a disappointment, although bankers privately expressed the opinion that the difficulties would be straightened out and the Young plan saved. There was little change in credit conditions, call money renewing at 9 per cent with indications that the rate would be maintained.

New York Central assumed the leadership of the rail group by climbing 9 points to a new top at 250. Aitchison, climbed almost as much to a new high at 292 3/4. Pere Marquette soared 17 1/2 points to a record top at 236 on a small turnover. Union Pacific, Norfolk and Western, Nashville, Chattanooga and St. Louis, Lackawanna and Pennsylvania, were among the dozen or so other issues to move into new high ground, the gains ranging from 2 to 6 points.

MARK TIME IN STUDY OF TARIFF BILL

Democrats Pause For Day While Republicans Prepare to Make Issue Public.

Washington, Aug. 28.—(AP)—Democrats of the Senate finance committee marked time today in their study of the tariff bill while its Republican framers made ready to put their case before the public, first in the form of the test of the measure itself and then, tomorrow or Friday, with the majority report they are preparing to present next Wednesday to the Senate.

After two meetings this week, the minority group of committee members decided to wait until tomorrow to continue their deliberations, they have, thus far, considered only a few amendments, but experts they have employed to assist in the study will be ready to report tomorrow and then are expected to make more progress in that direction thereafter.

The question whether a minority report on the bill will be presented to the Senate remains to be decided. The decision has been deferred, Senator Simmons of North Carolina, ranking Democrat on the committee, explained, to give the minority group an opportunity first to examine the majority report.

The preliminary Democratic attack on the measure, meanwhile, is continuing. Representative Mary T. Norton, of New Jersey, in a statement issued by the Democratic National committee emphasizing the women's interests, contends that it "strikes viciously" at her household and personal expenditures and would have a particularly adverse effect on the 8,500,000 feminine wage earners, "who must keep well dressed in order to keep their jobs."

"Every one of these women" very many of whom are finding it difficult to live now, she holds, "will have to pay an increase of from 10 to 75 per cent on their shoes, stockings, dresses, coats, hats, underwear, toilet articles—in fact, upon everything that goes to make a woman comfortable."

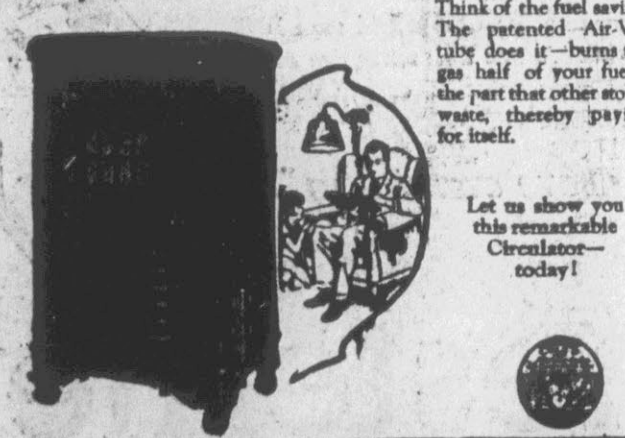
